(57) **CLAIM**

The ornamental design for a hamburger grill basket, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a hamburger grill basket showing my new design;

FIG. 2 is a left side elevation view thereof, the right side being a mirror image;

FIG. 3 is a front end elevation view thereof;

FIG. 4 is a rear end elevation view thereof;

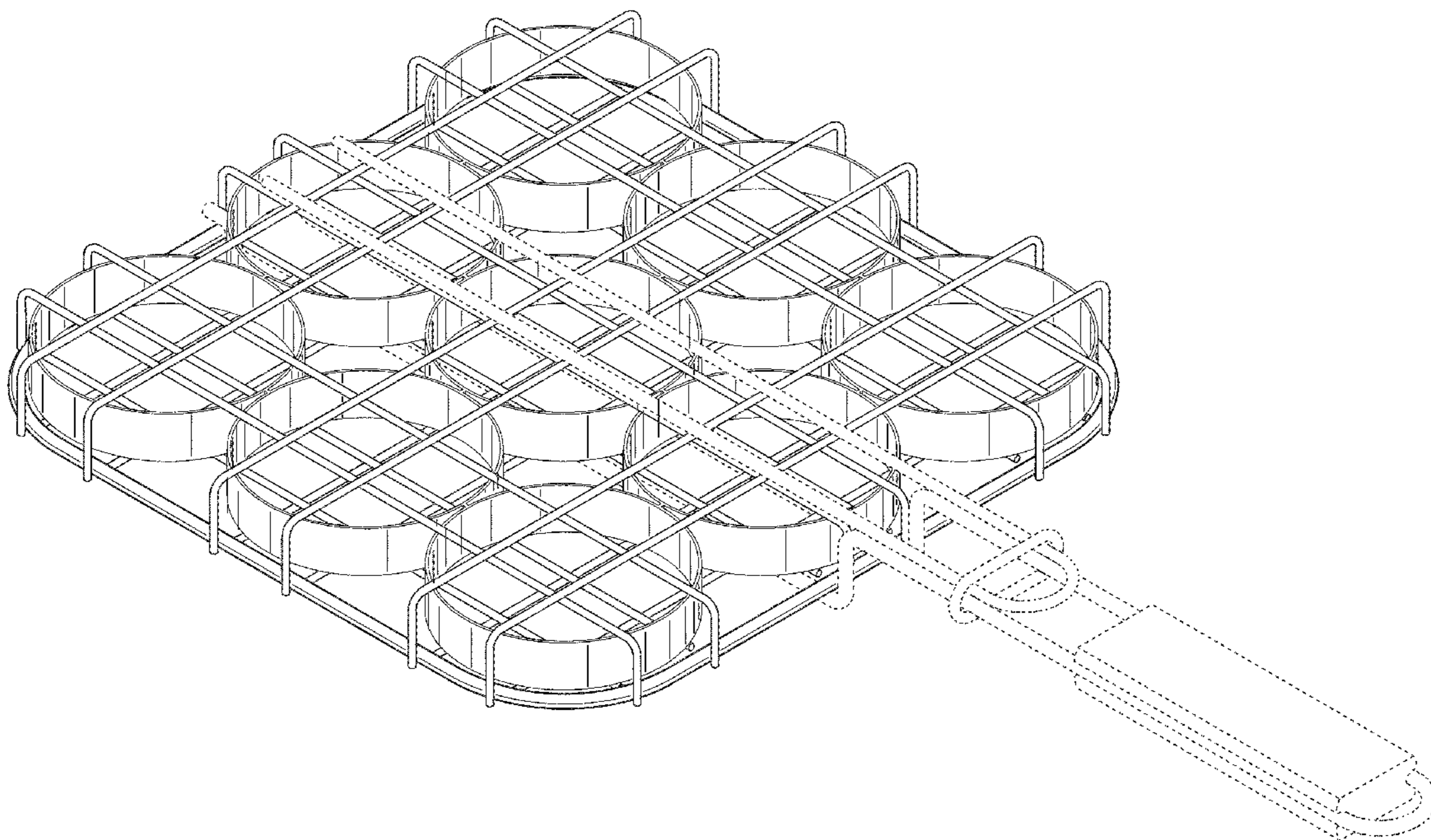
FIG. 5 is a top plan view thereof;

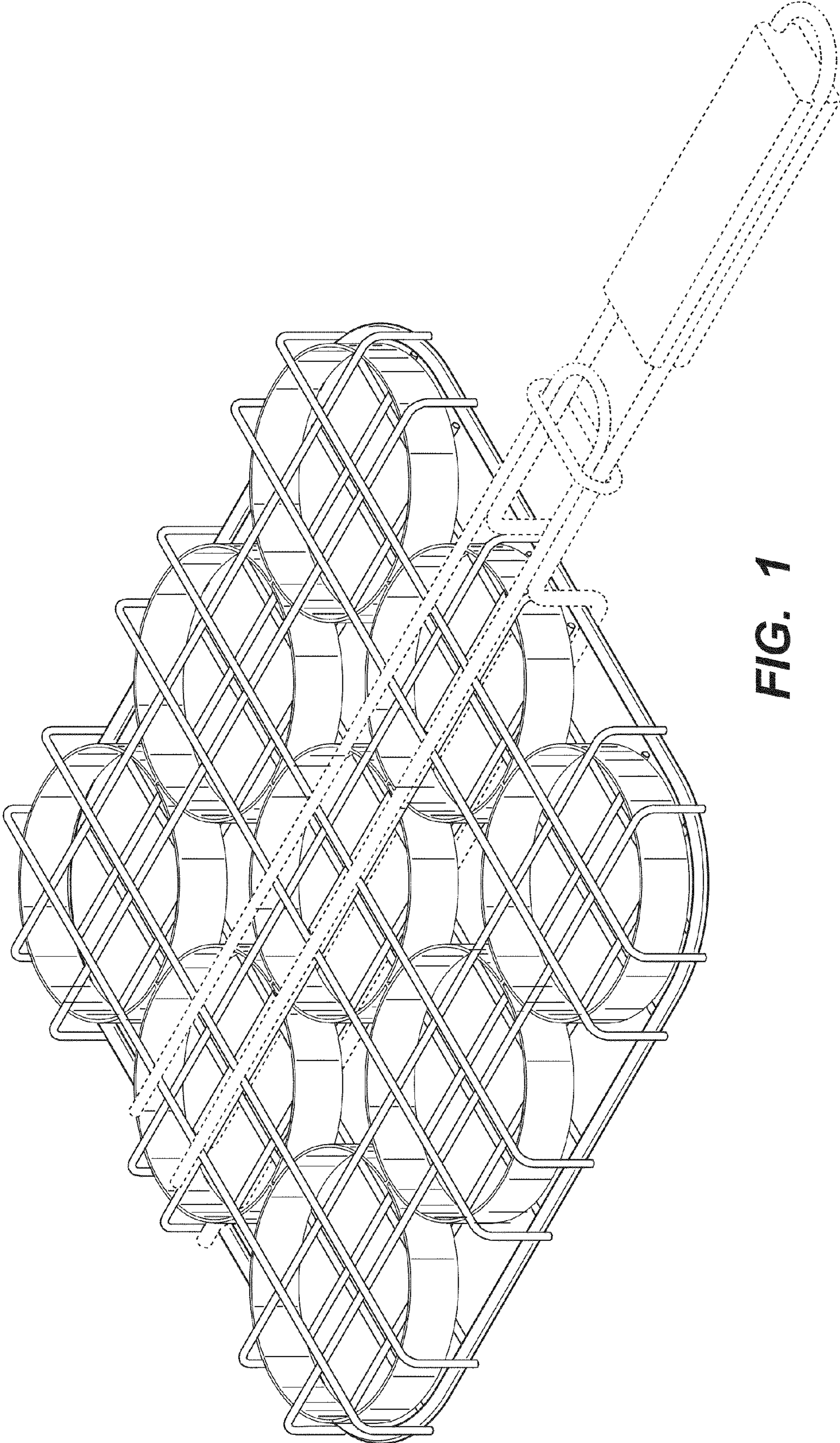

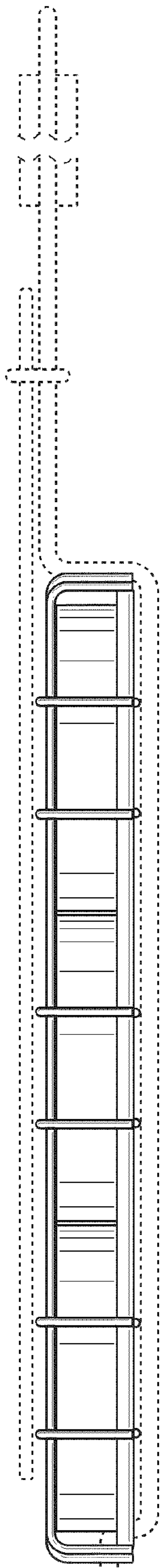

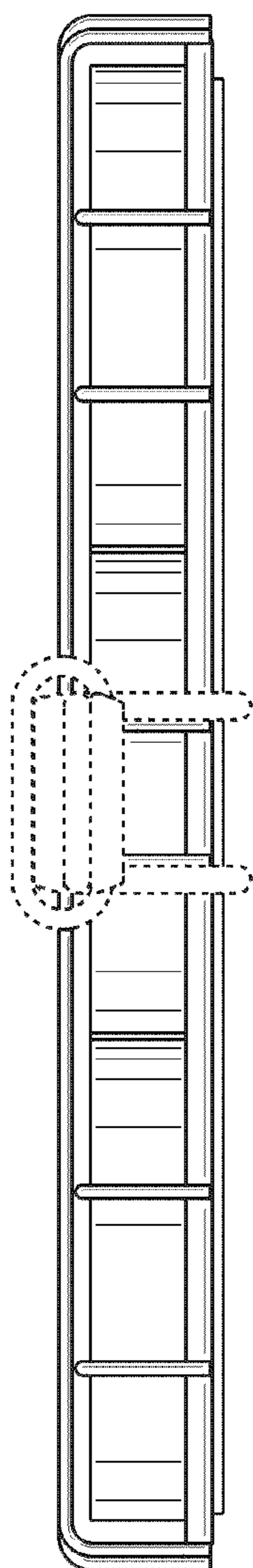

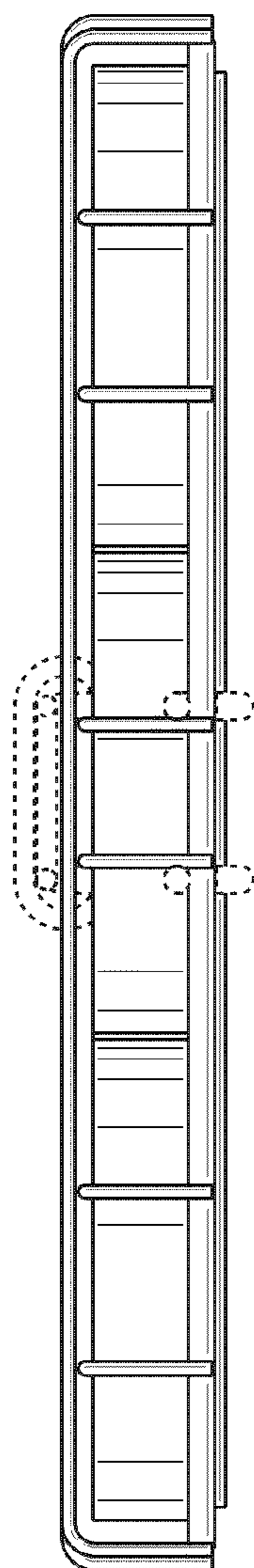

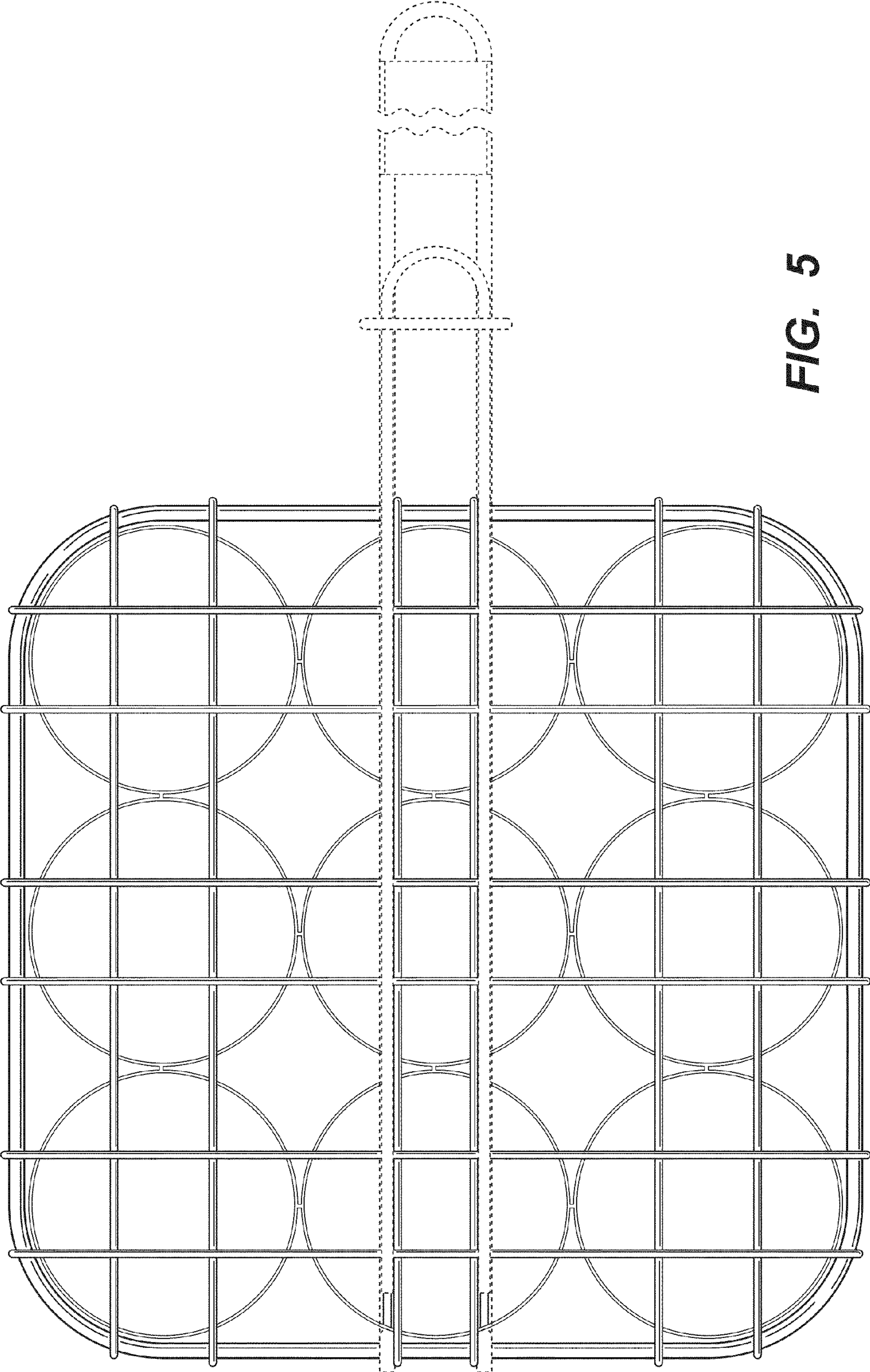

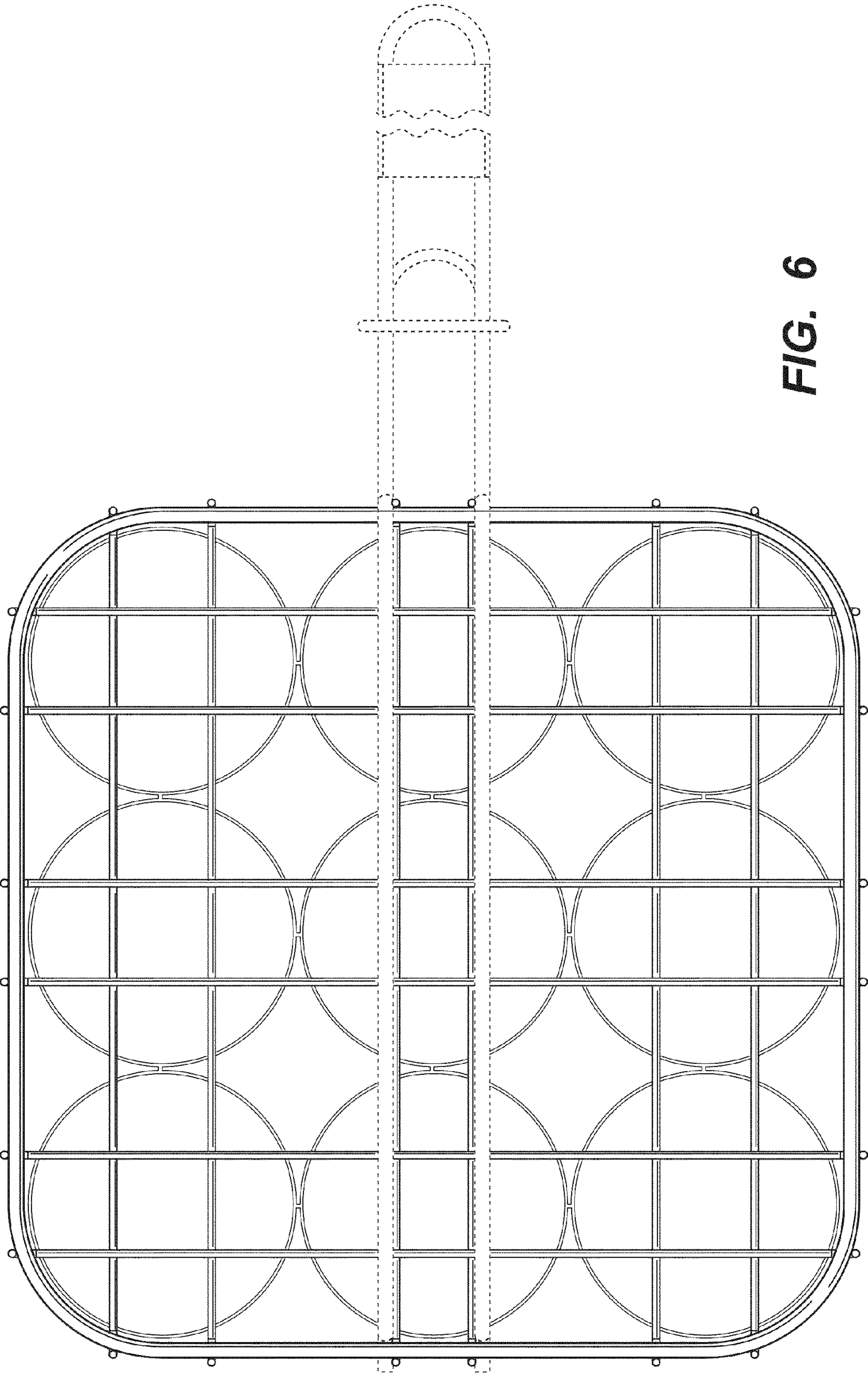

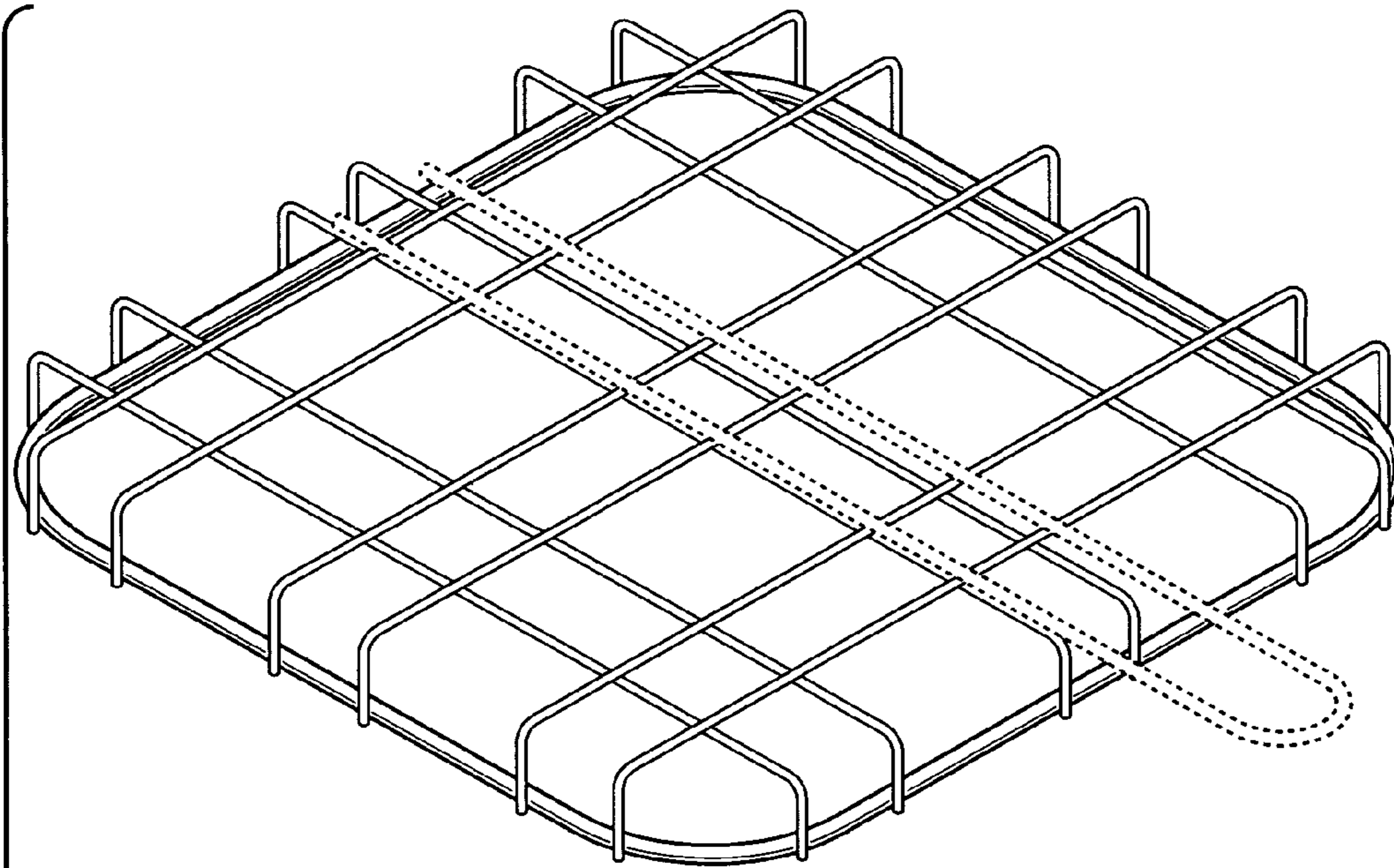
