FIG. 2 is a rear elevation thereof;

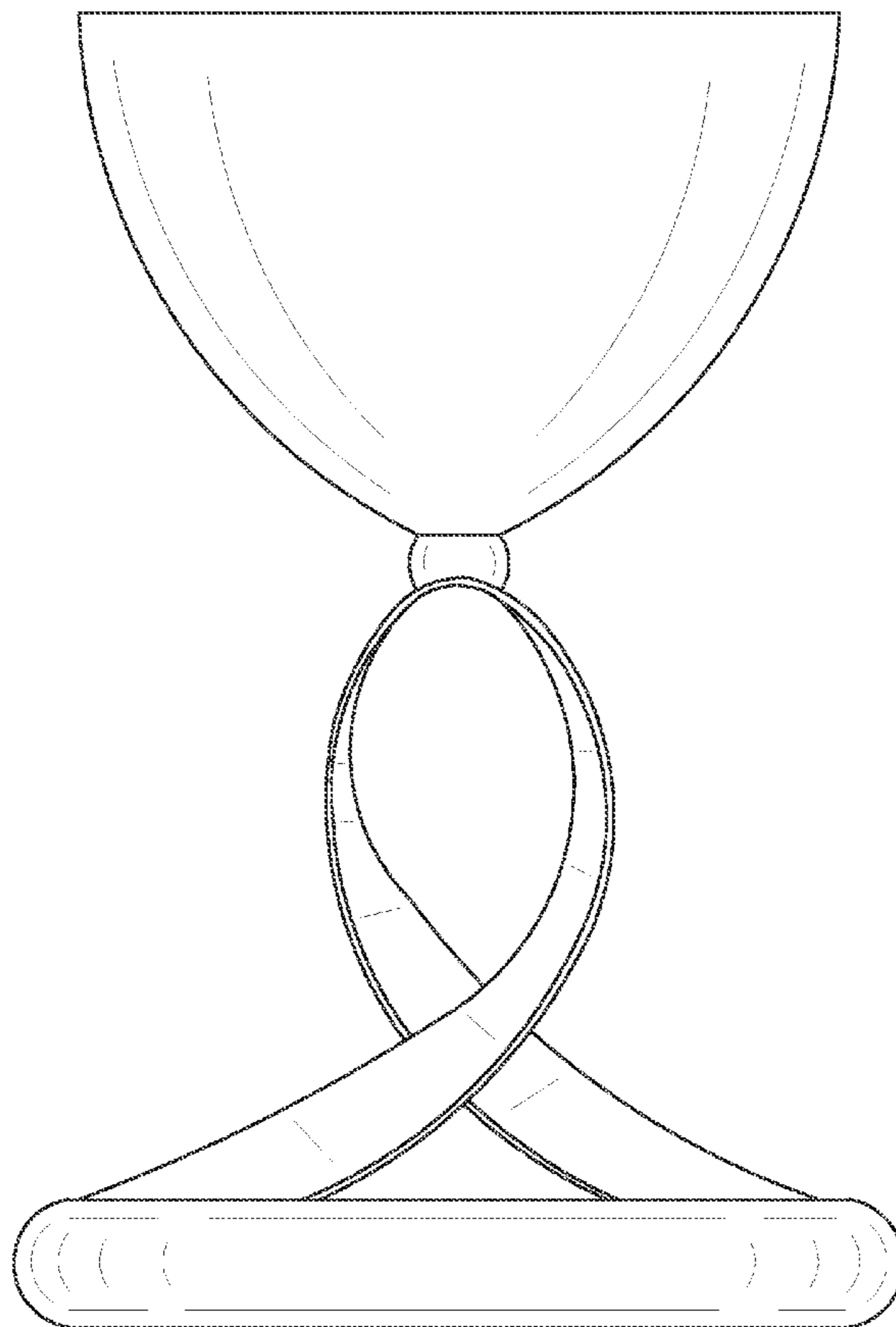
FIG. 3 is a left side elevation thereof;

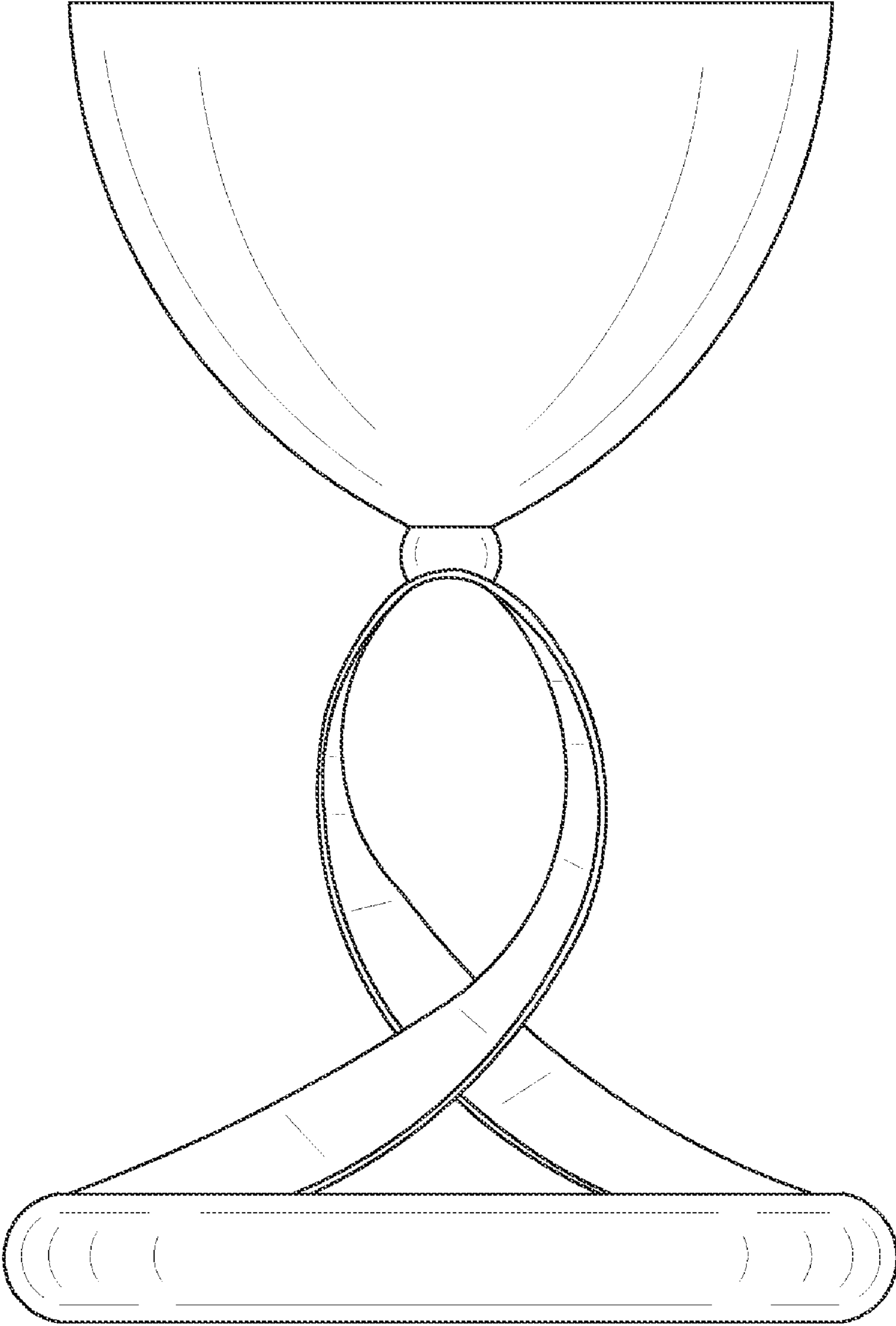

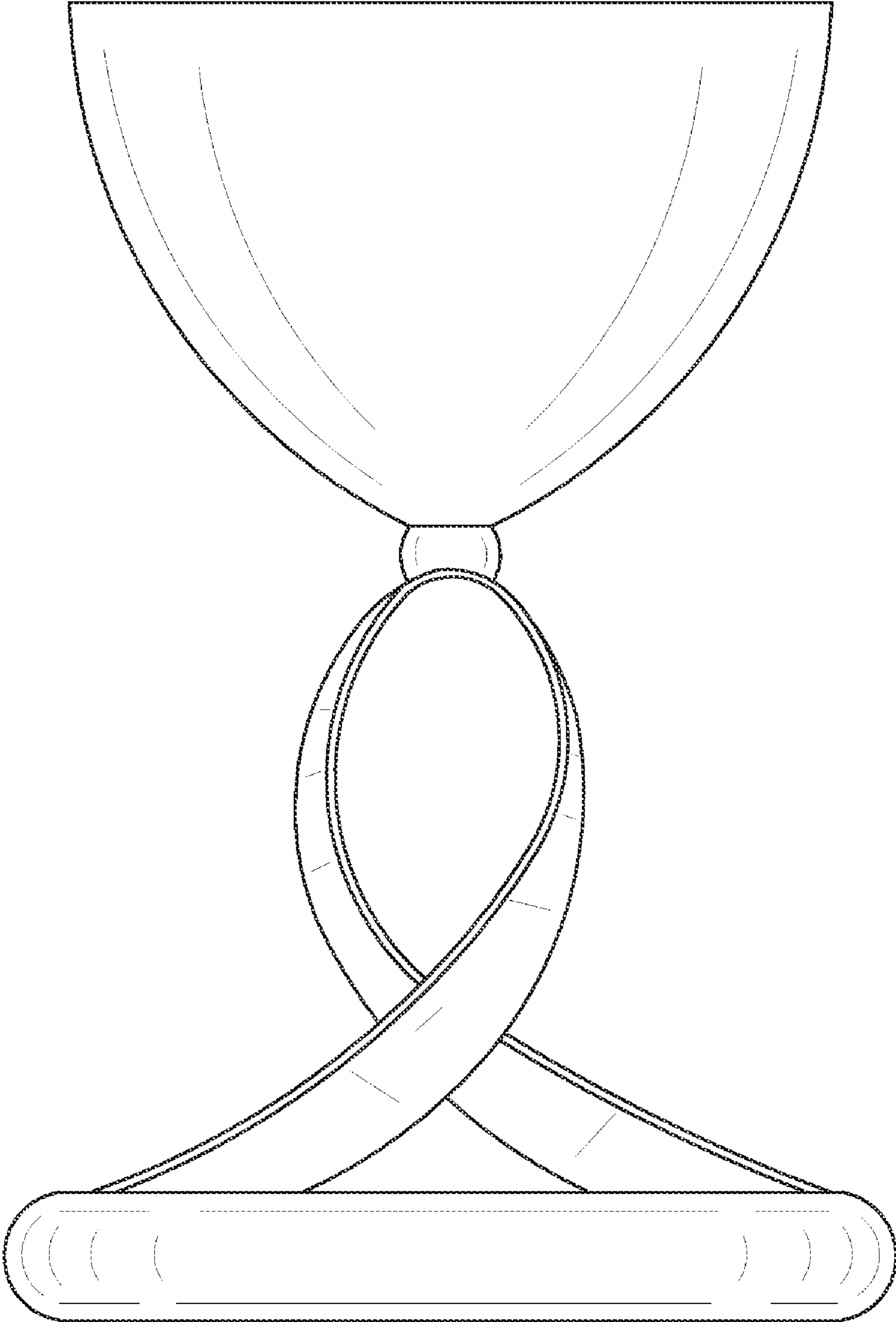

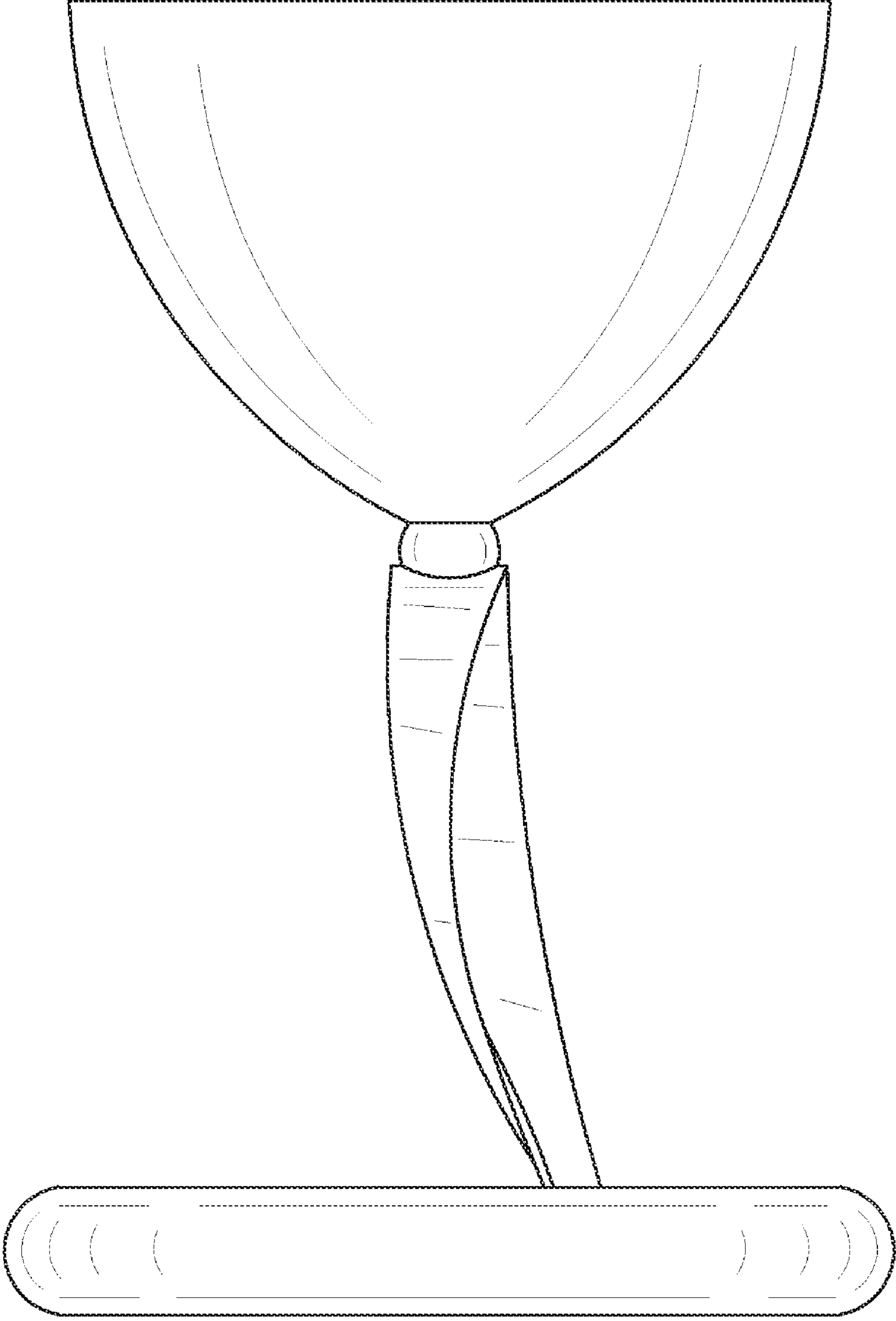

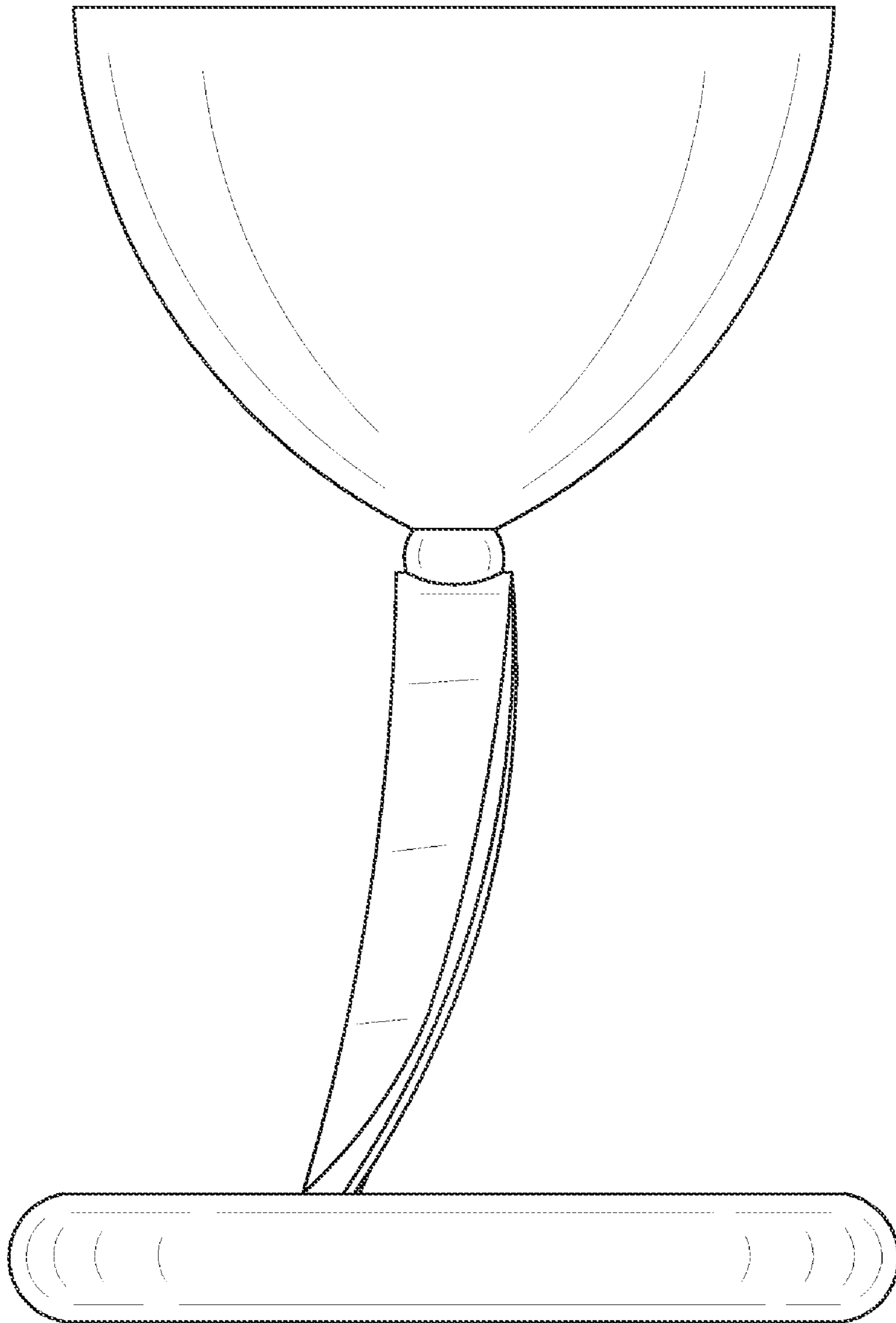

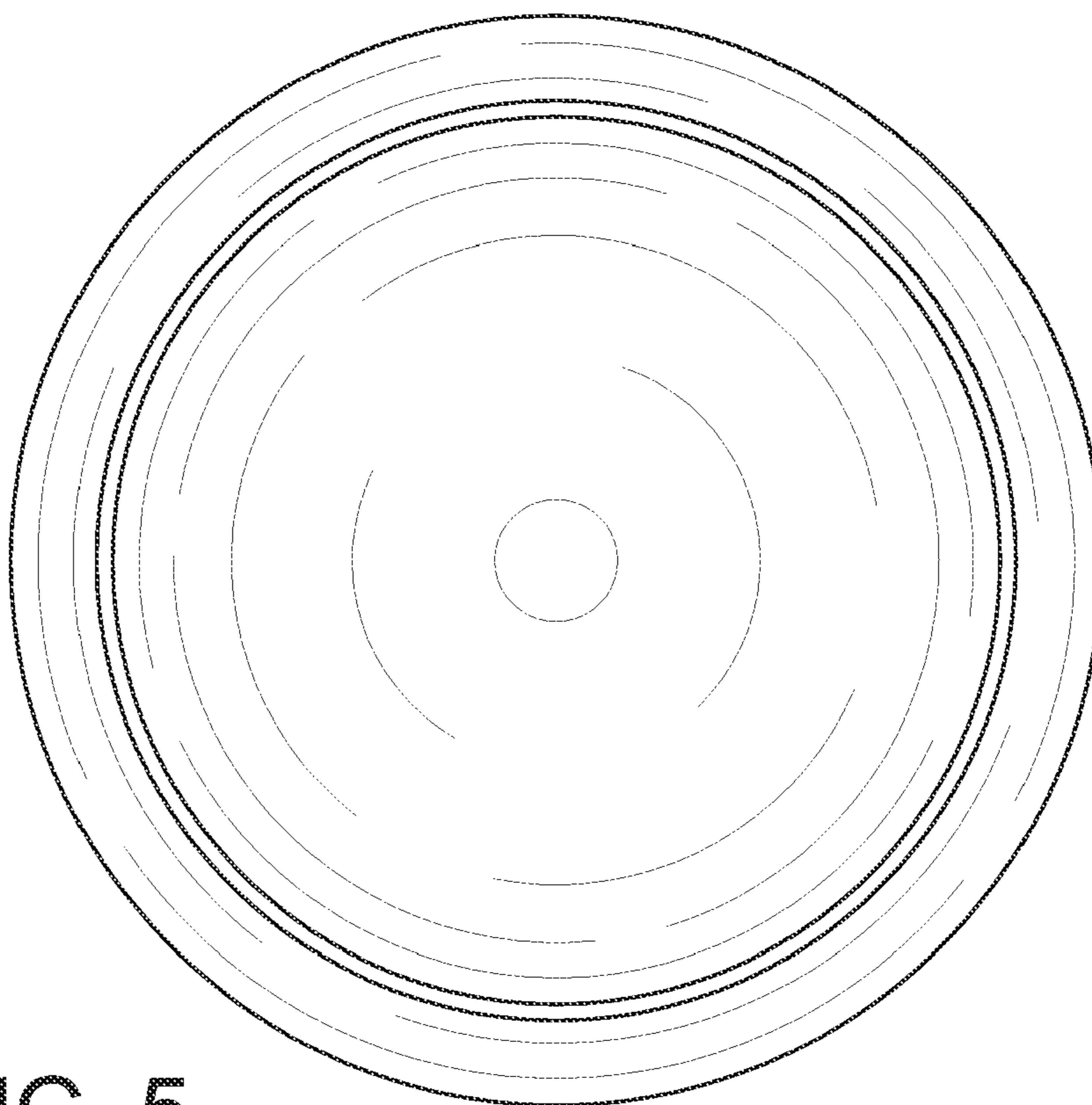

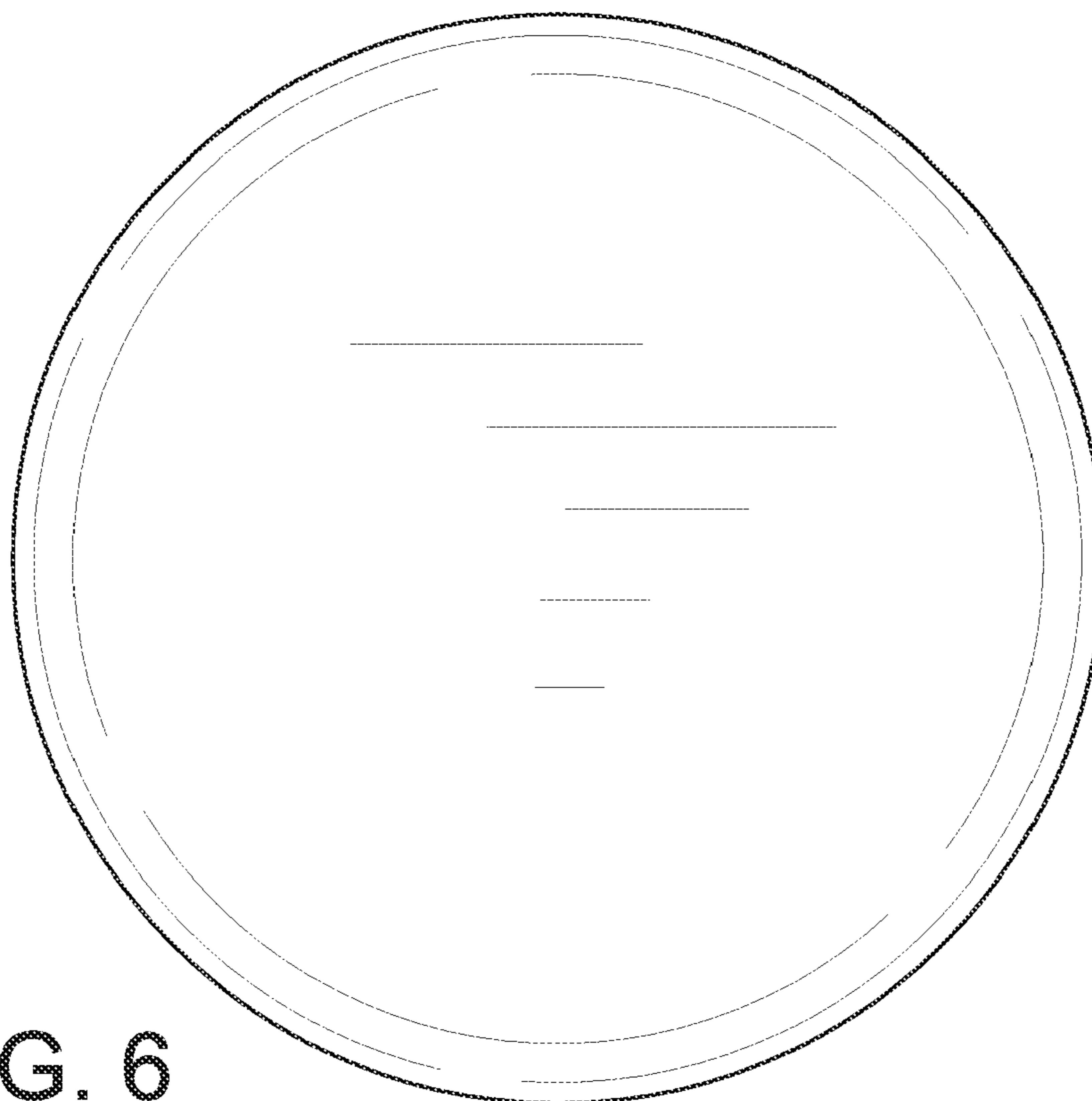
