(57) **CLAIM**

The ornamental design for a metal fixing clip, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a metal fixing clip showing my new design;

FIG. 2 is a back view thereof;

FIG. 3 is a top view thereof;

FIG. 4 is a bottom view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is a left side view thereto;

FIG. 7 is a front, right perspective view thereof; and,

FIG. 8 is a reference view showing an example of the metal fixing clip that is in use at a corner of a wall.

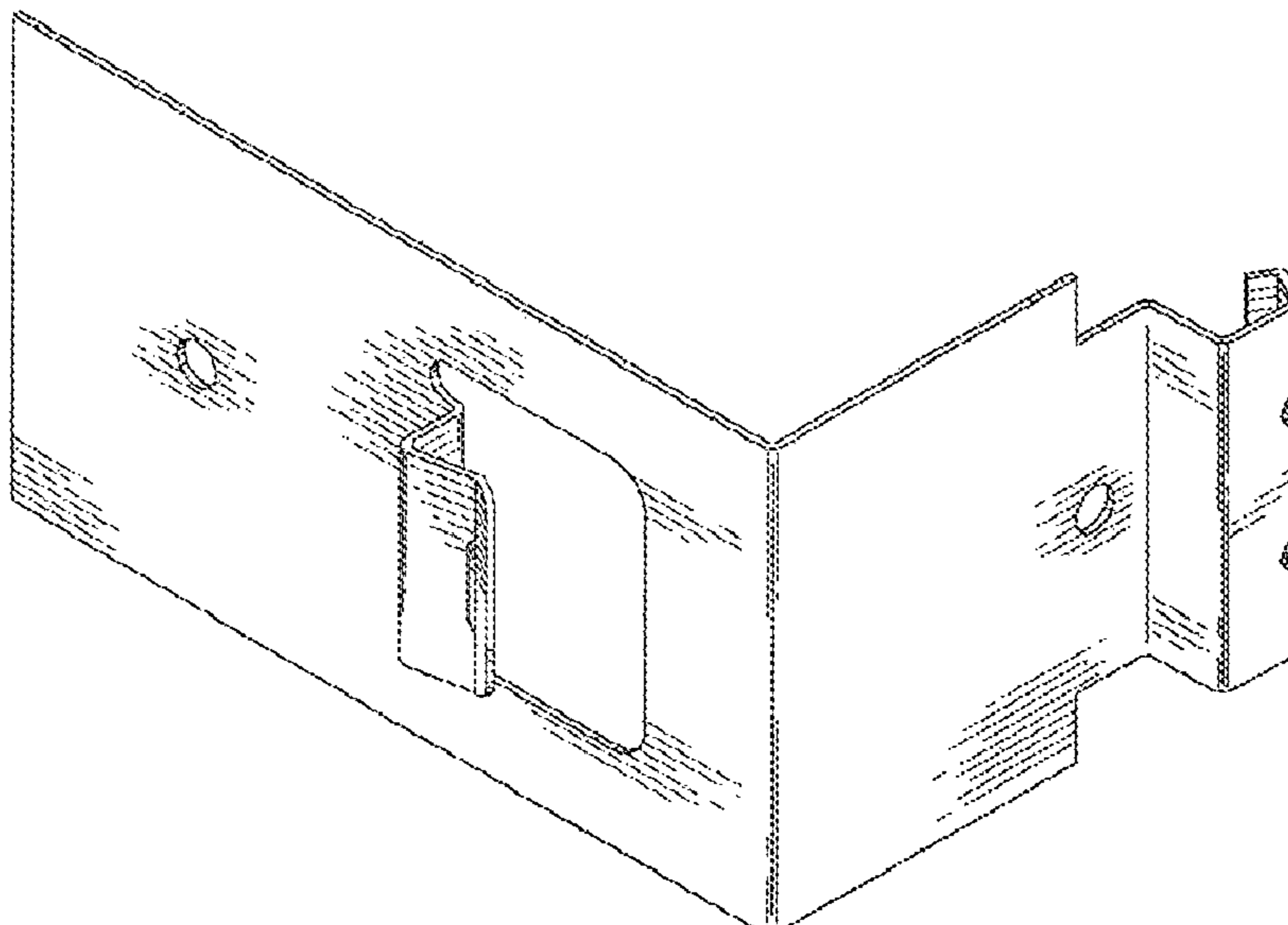

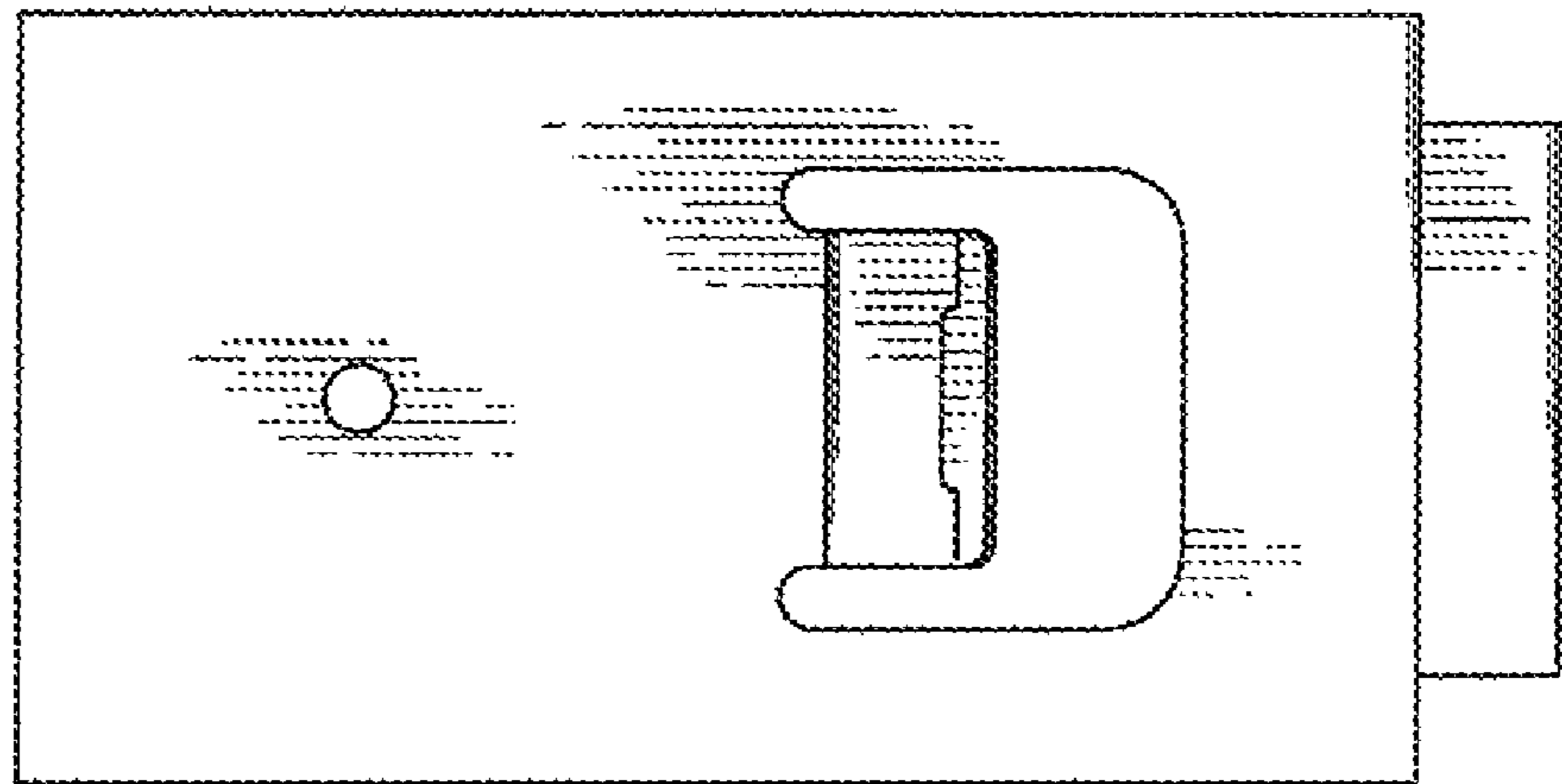

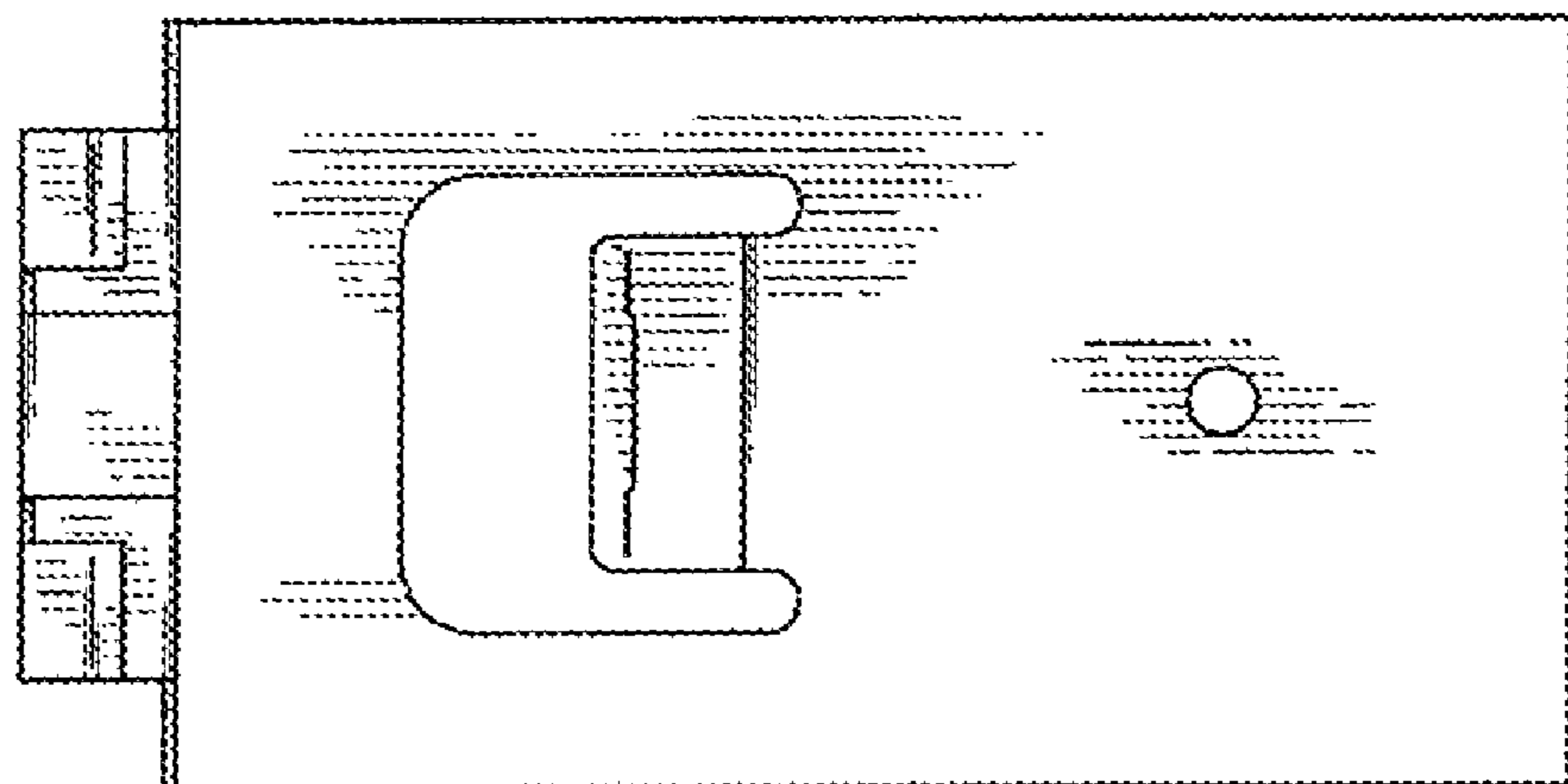

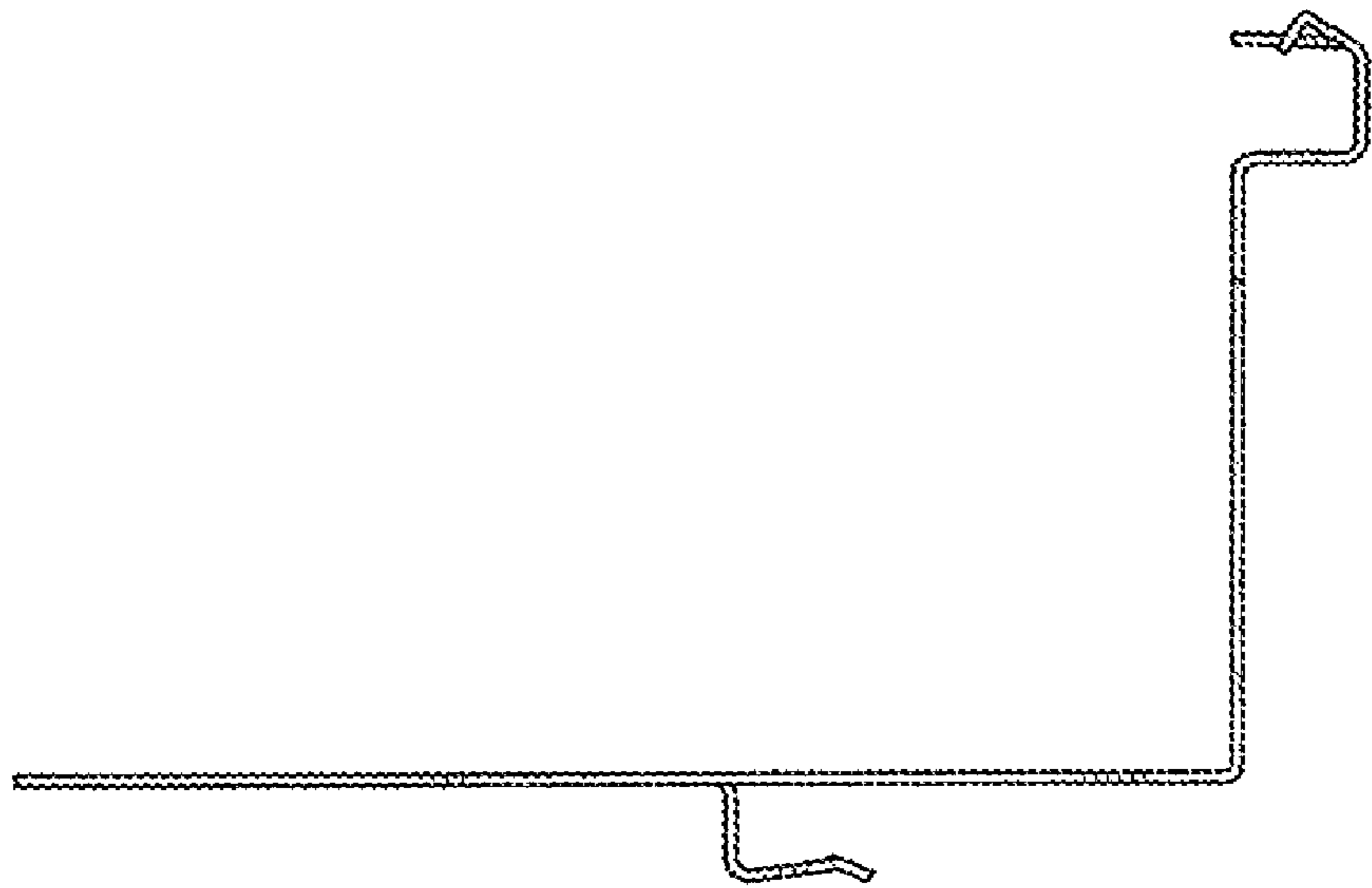

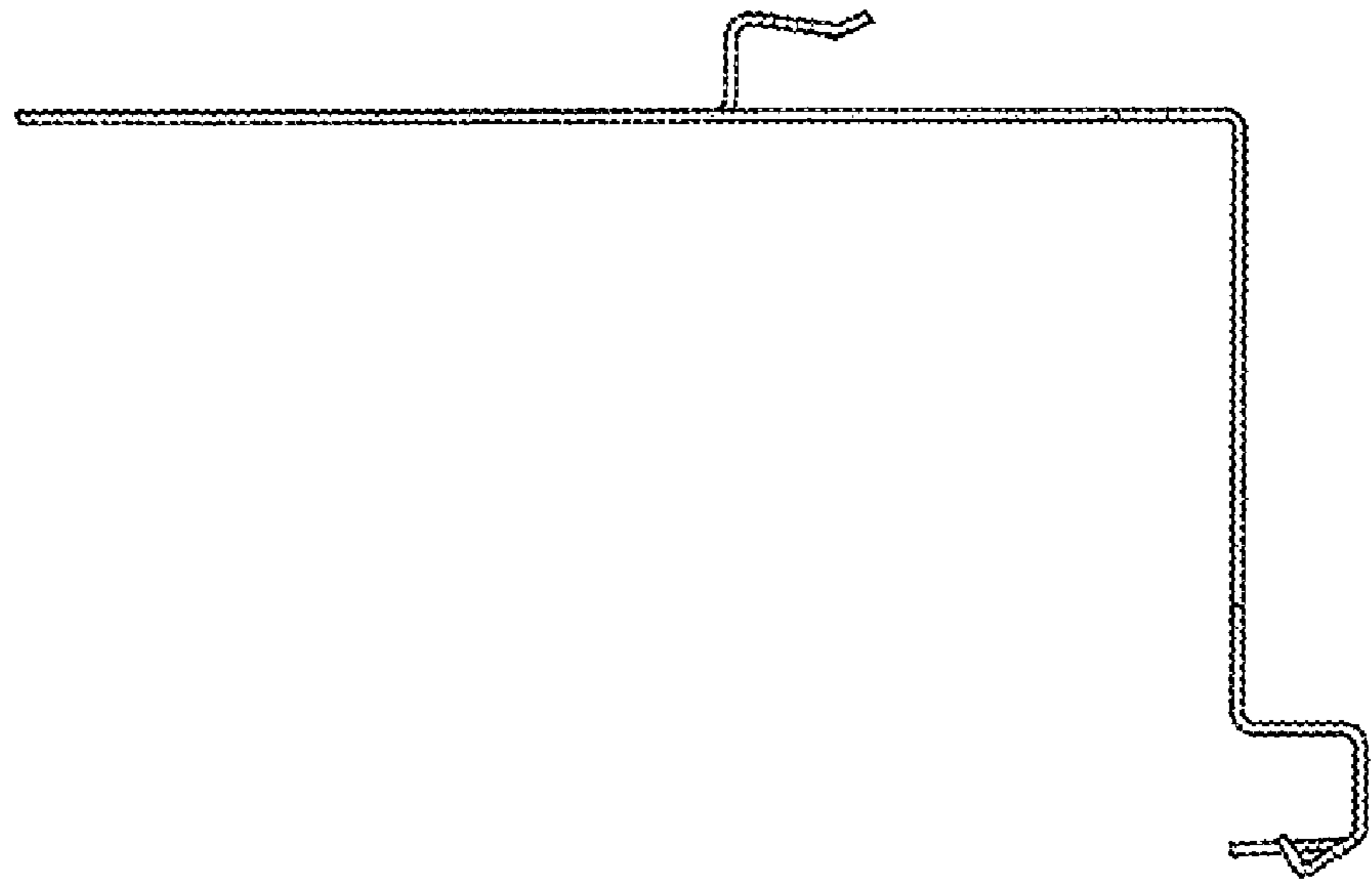

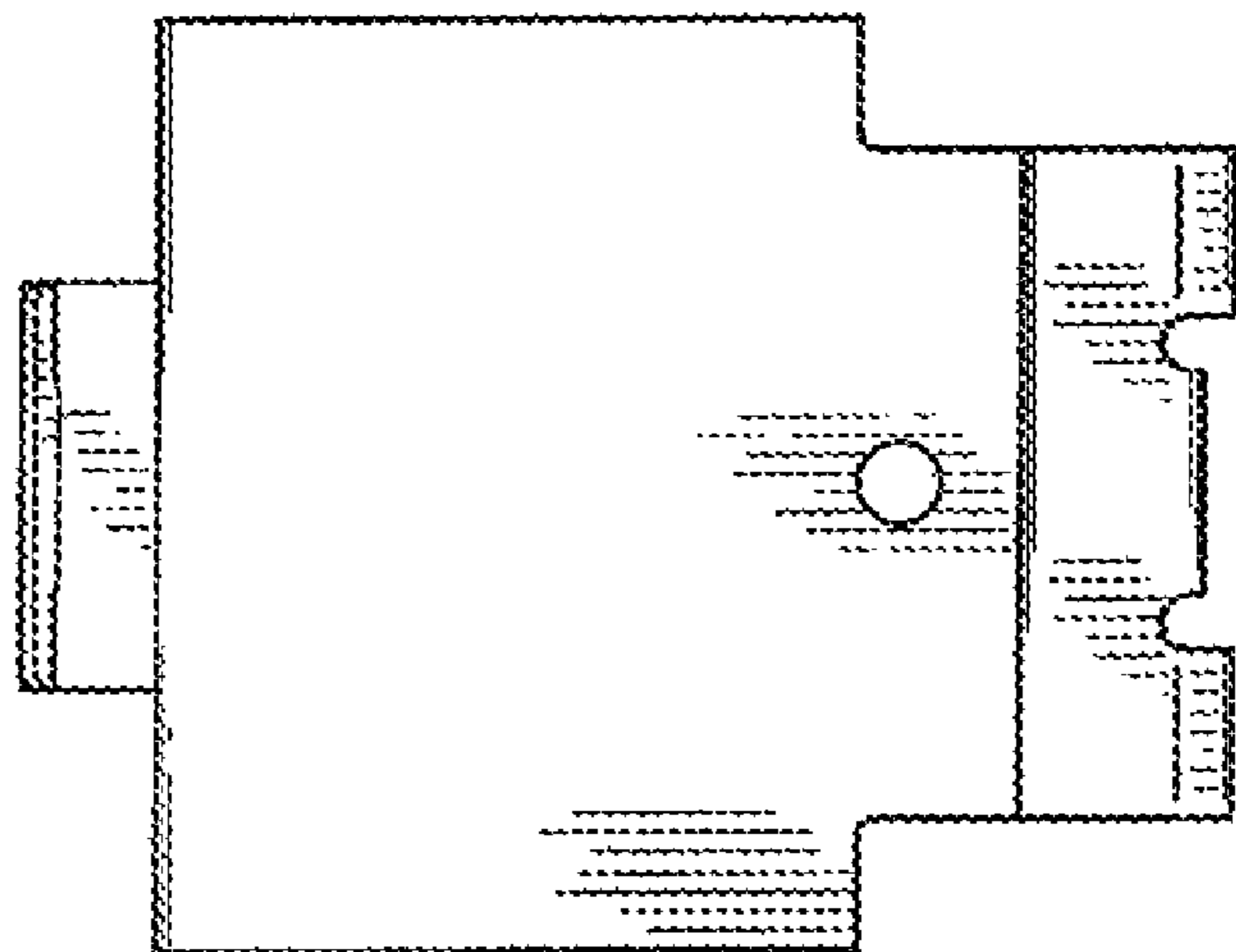

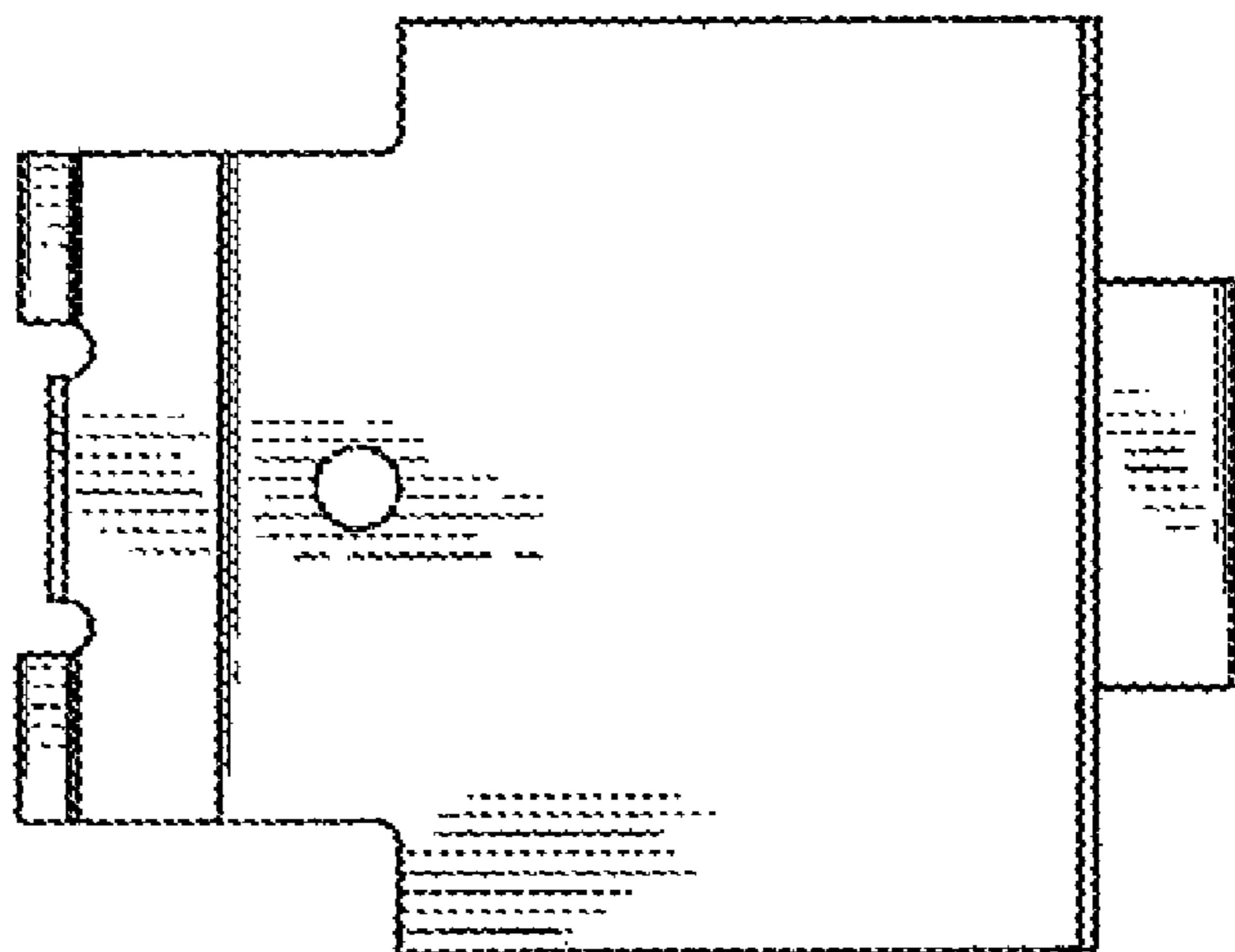

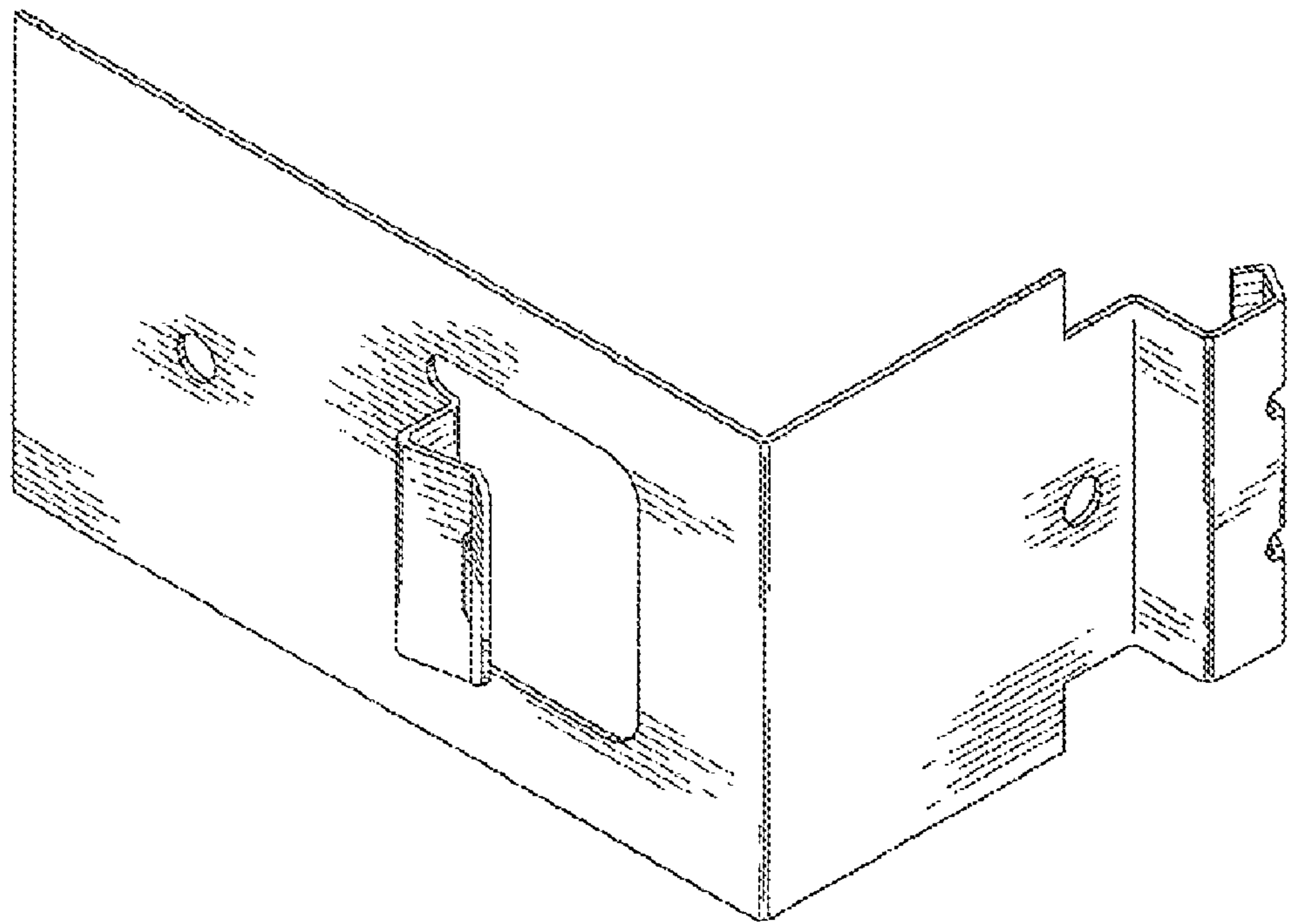
