(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front top left perspective view of a first embodiment of a bottle, showing our new design;

FIG. 2 is a front elevational view thereof, the rear view being identical;

FIG. 3 is a right side elevational view thereof, the left side being identical;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a front top left perspective view of a second embodiment of a bottle, showing our new design;

FIG. 7 is a front elevational view of the second embodiment, the rear elevational view being identical;

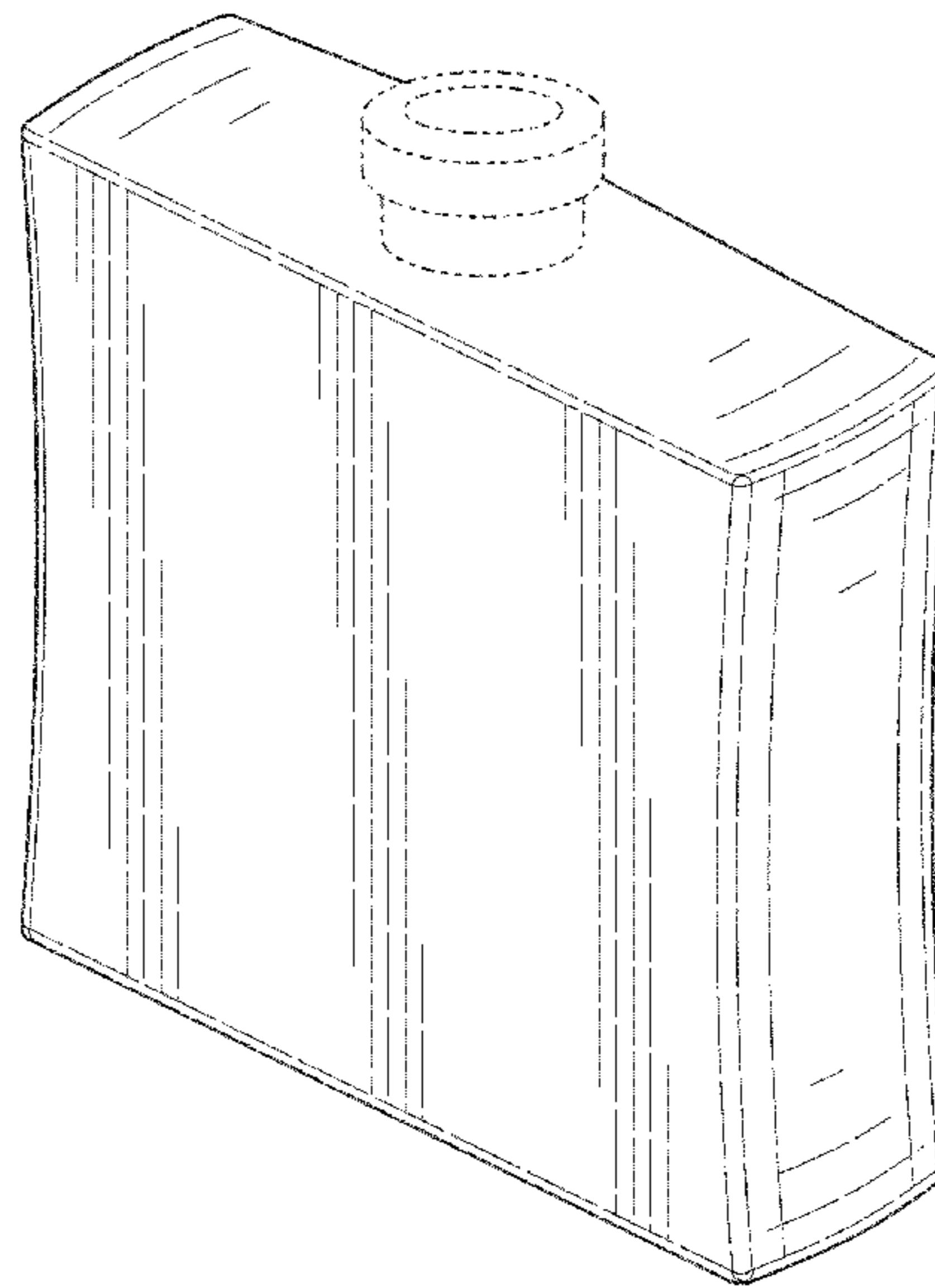
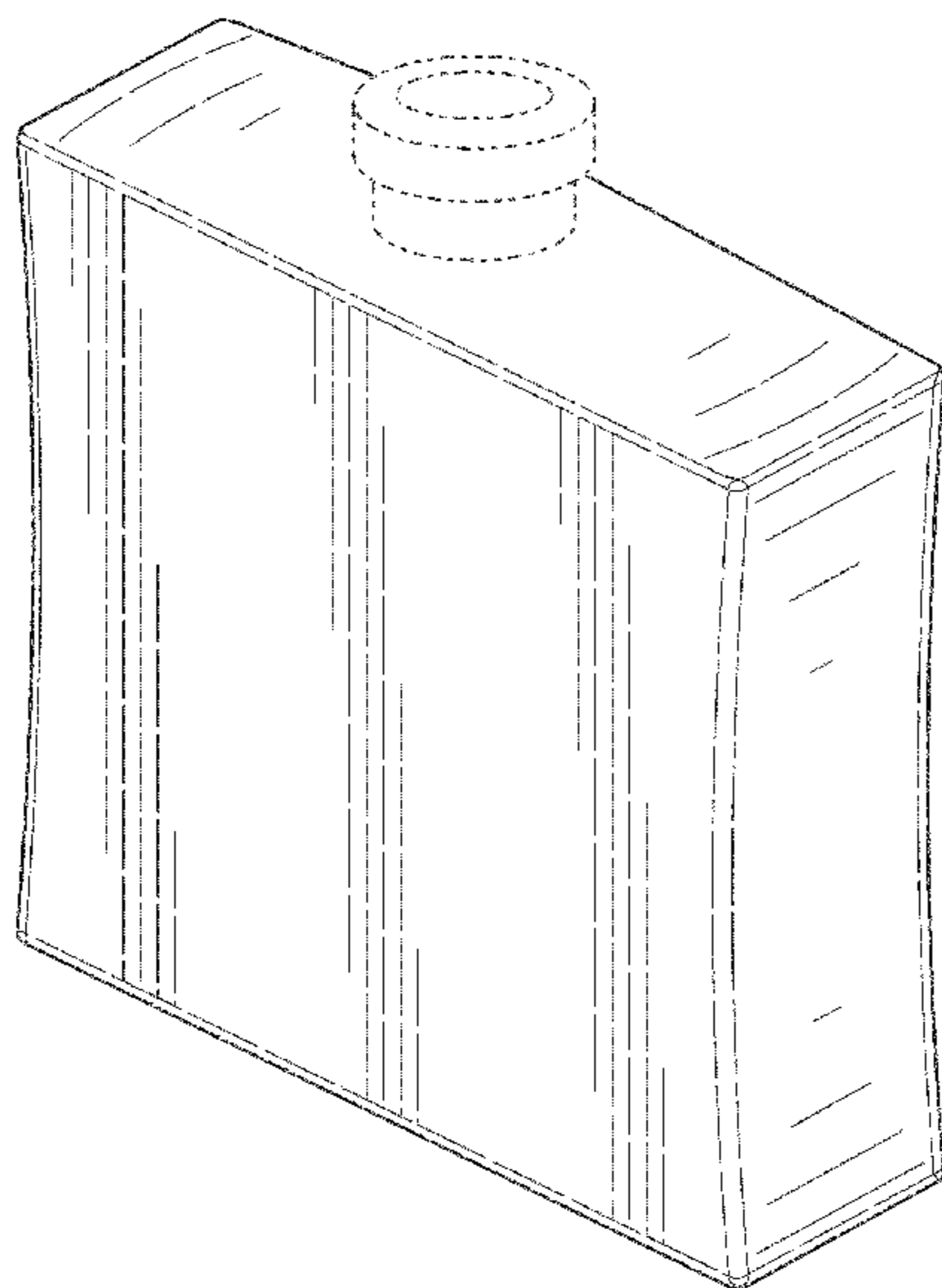
FIG. 8 is a right side elevational view of the second embodiment, the left view being identical;

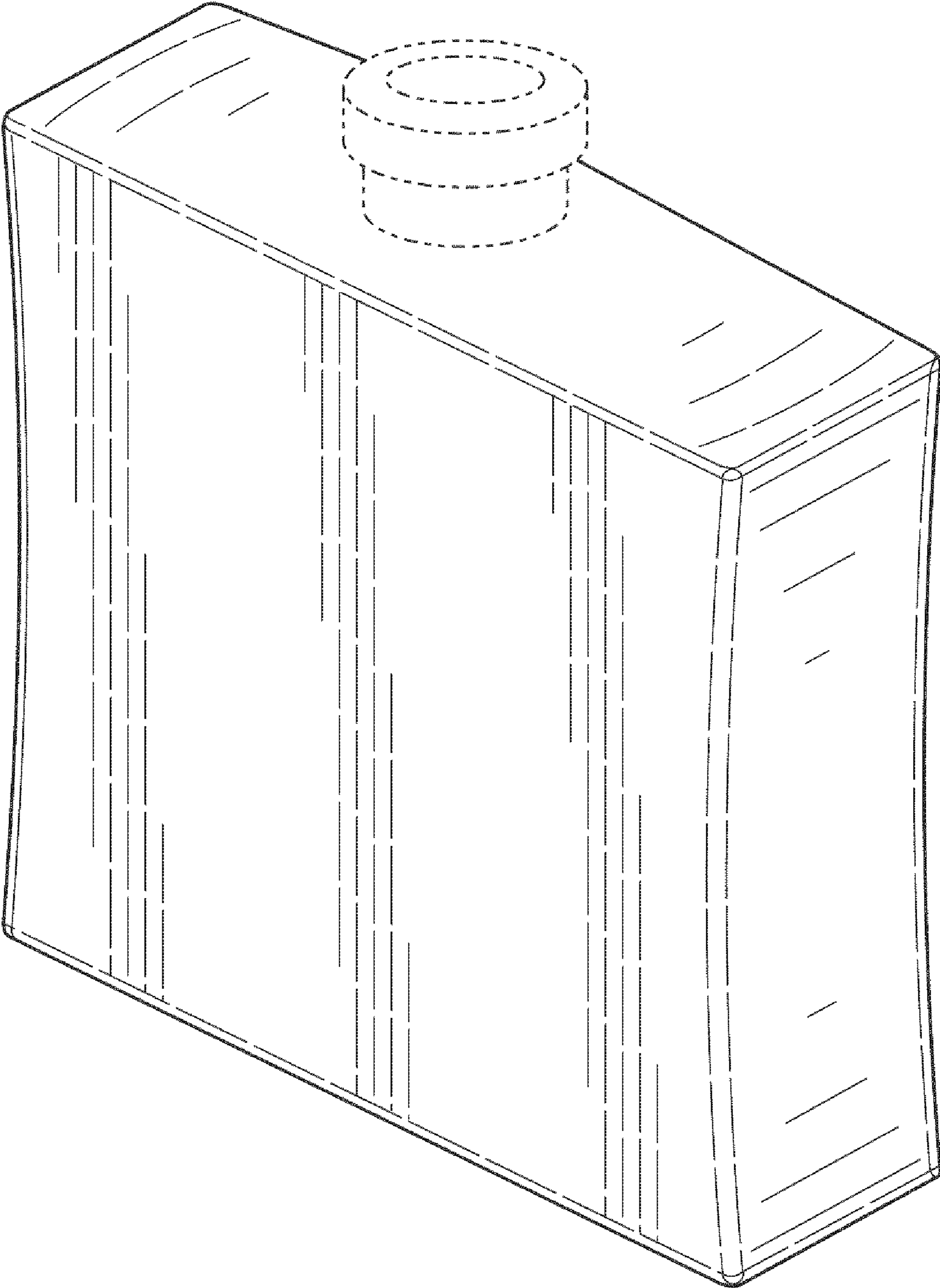

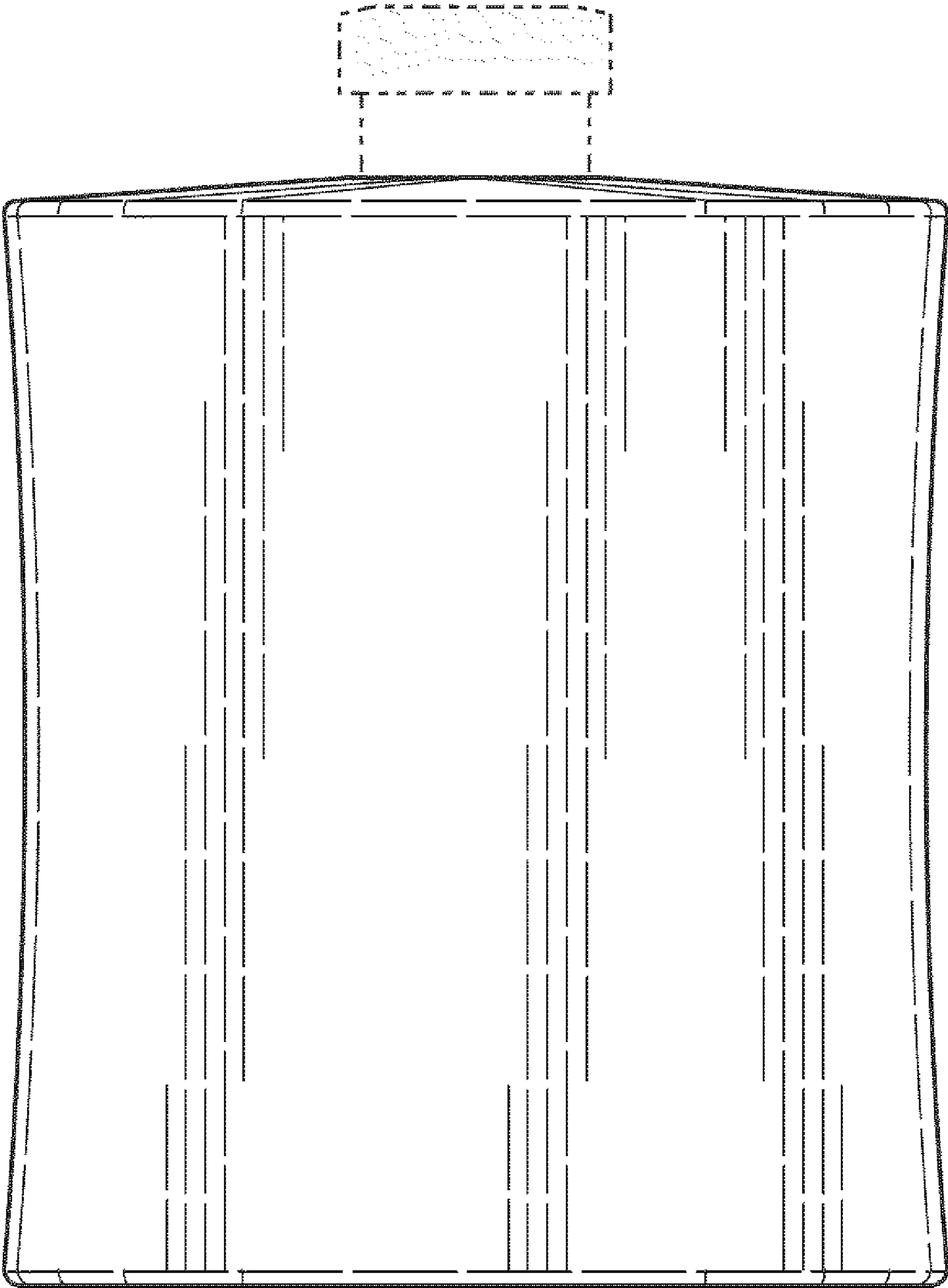

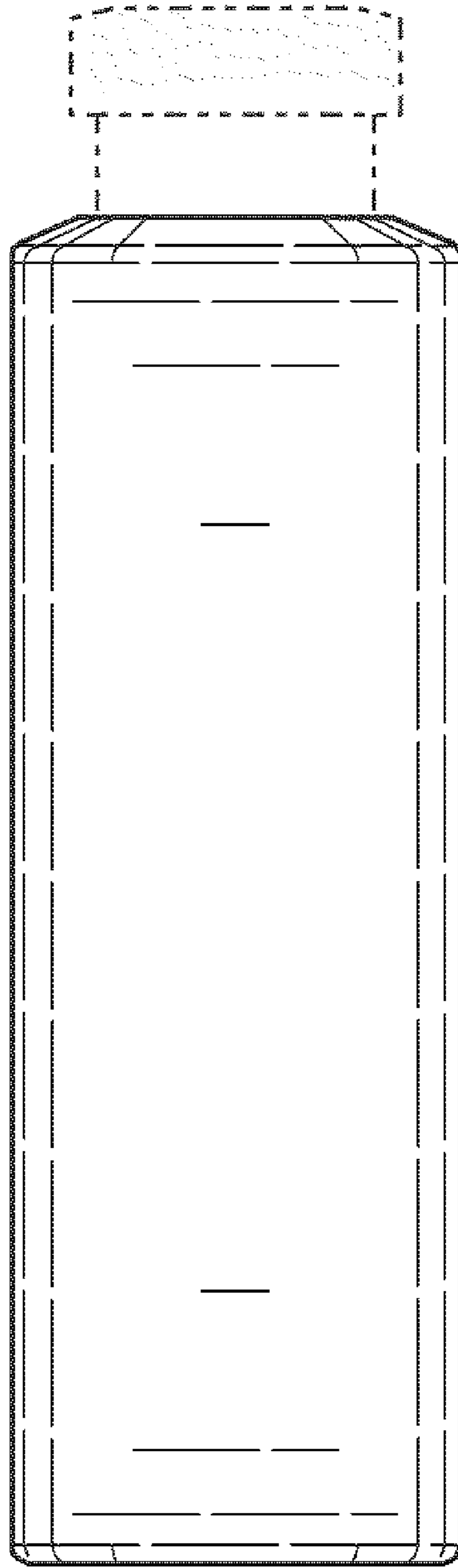

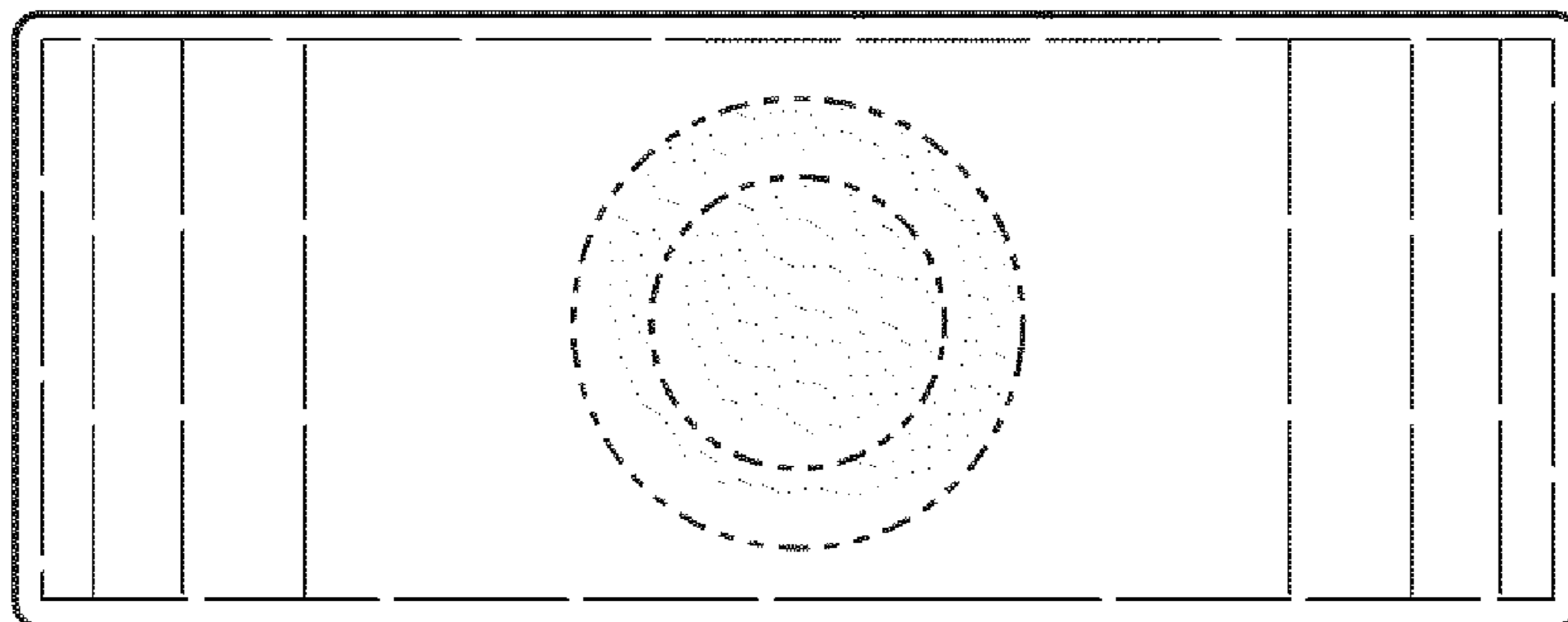

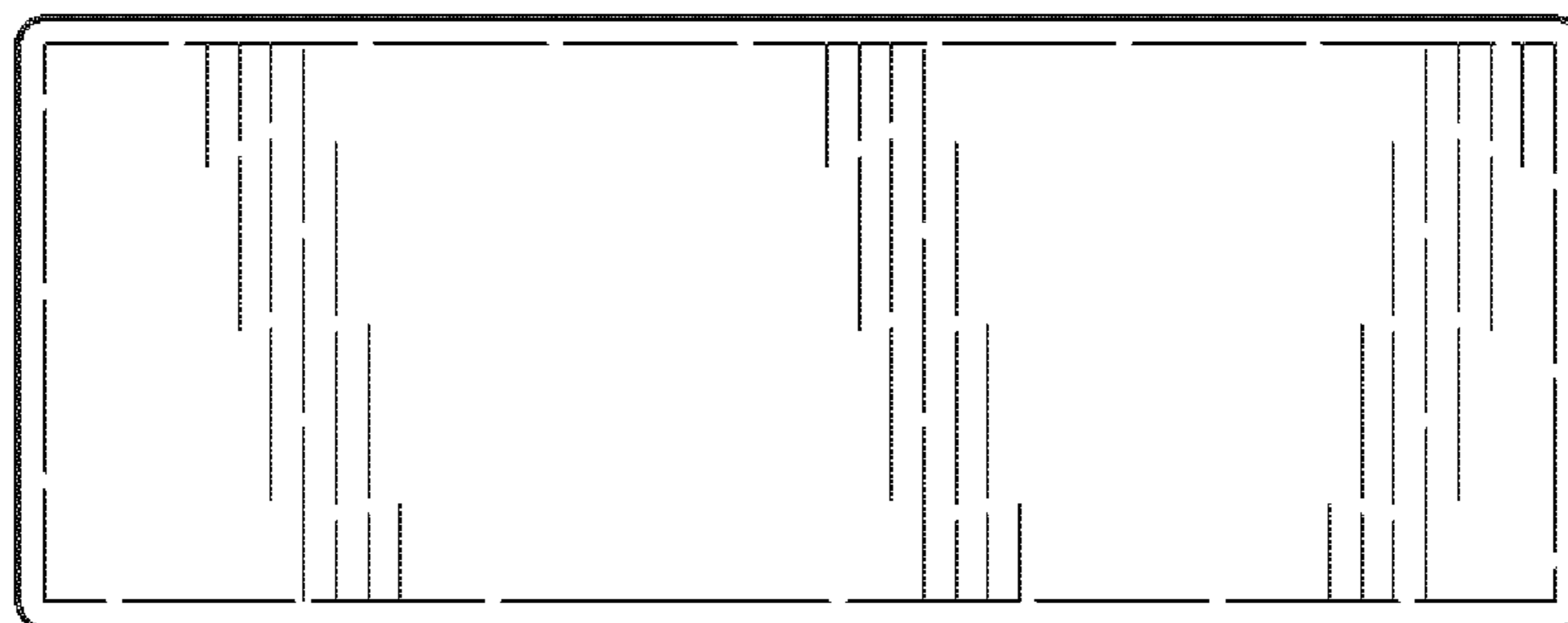

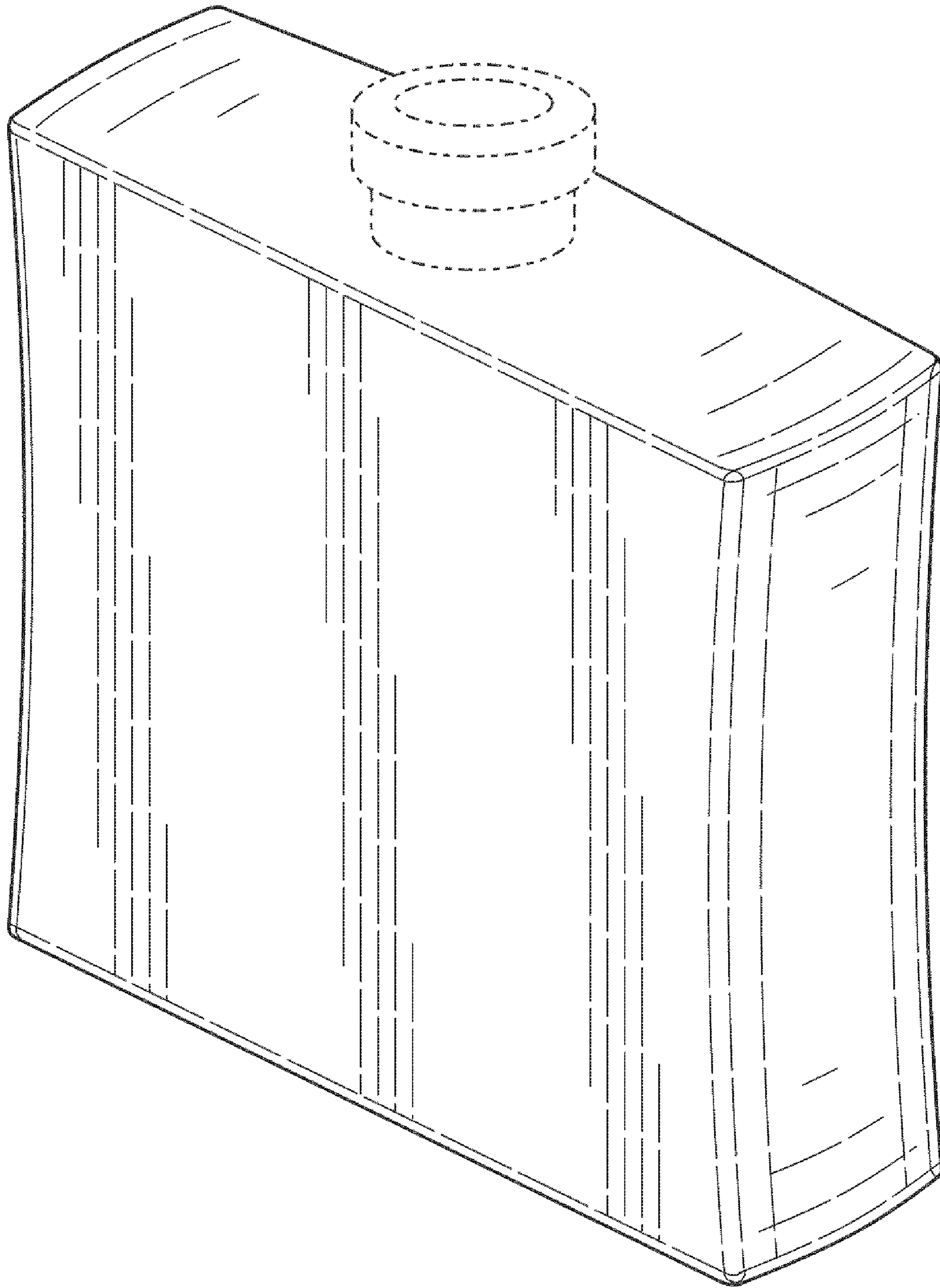

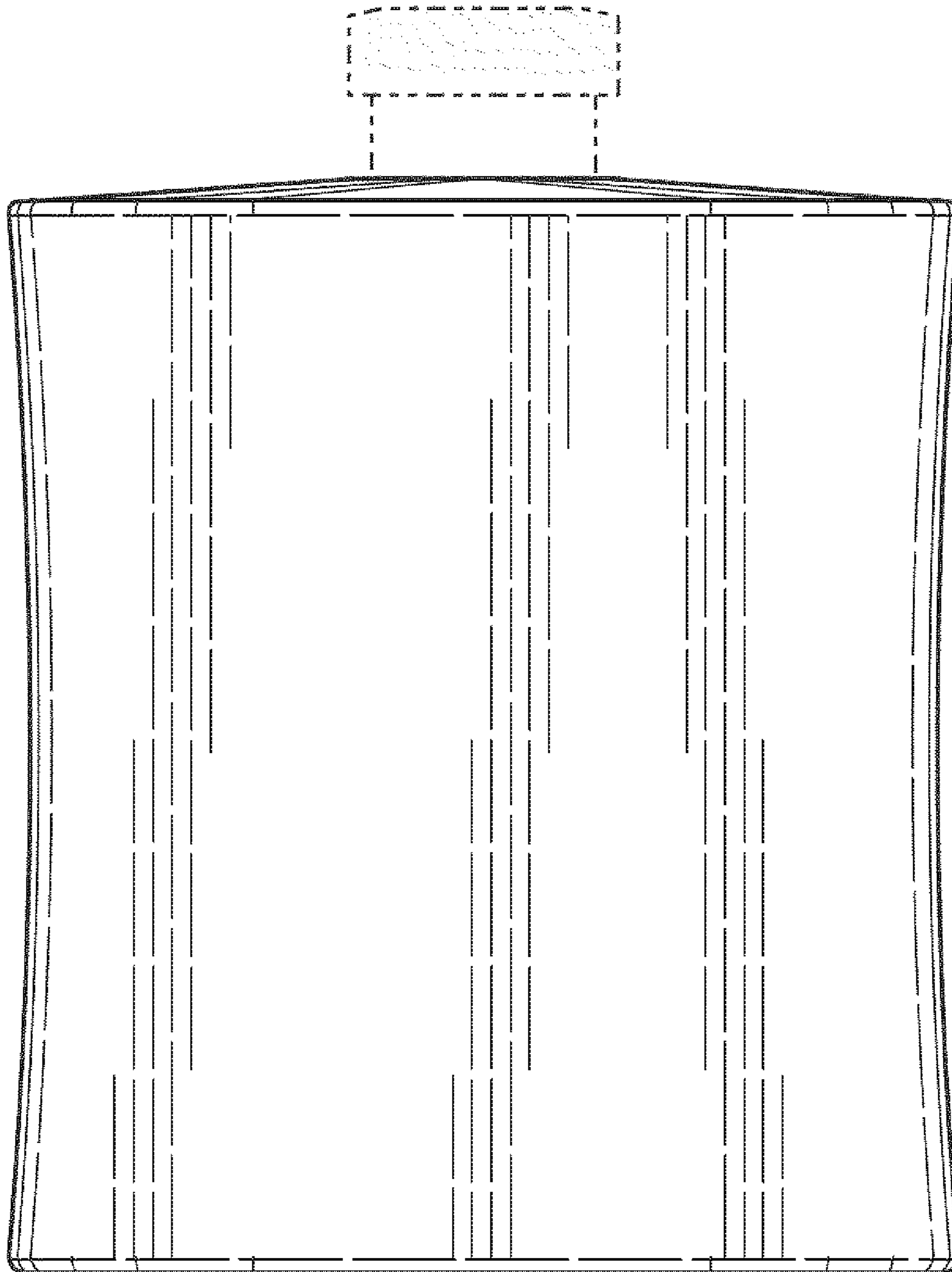

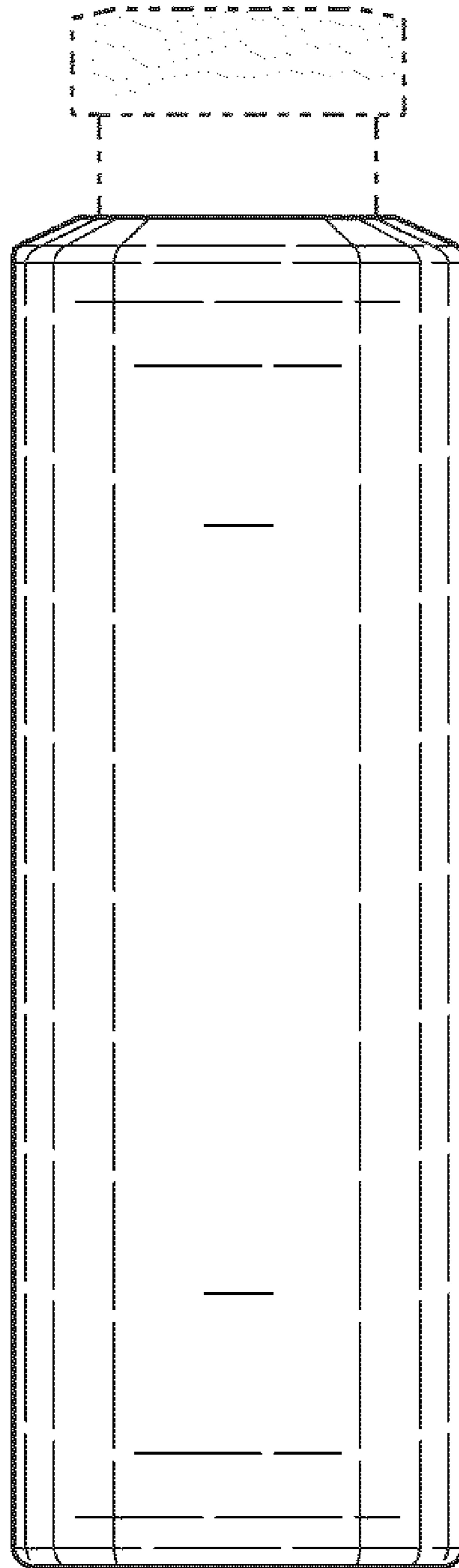

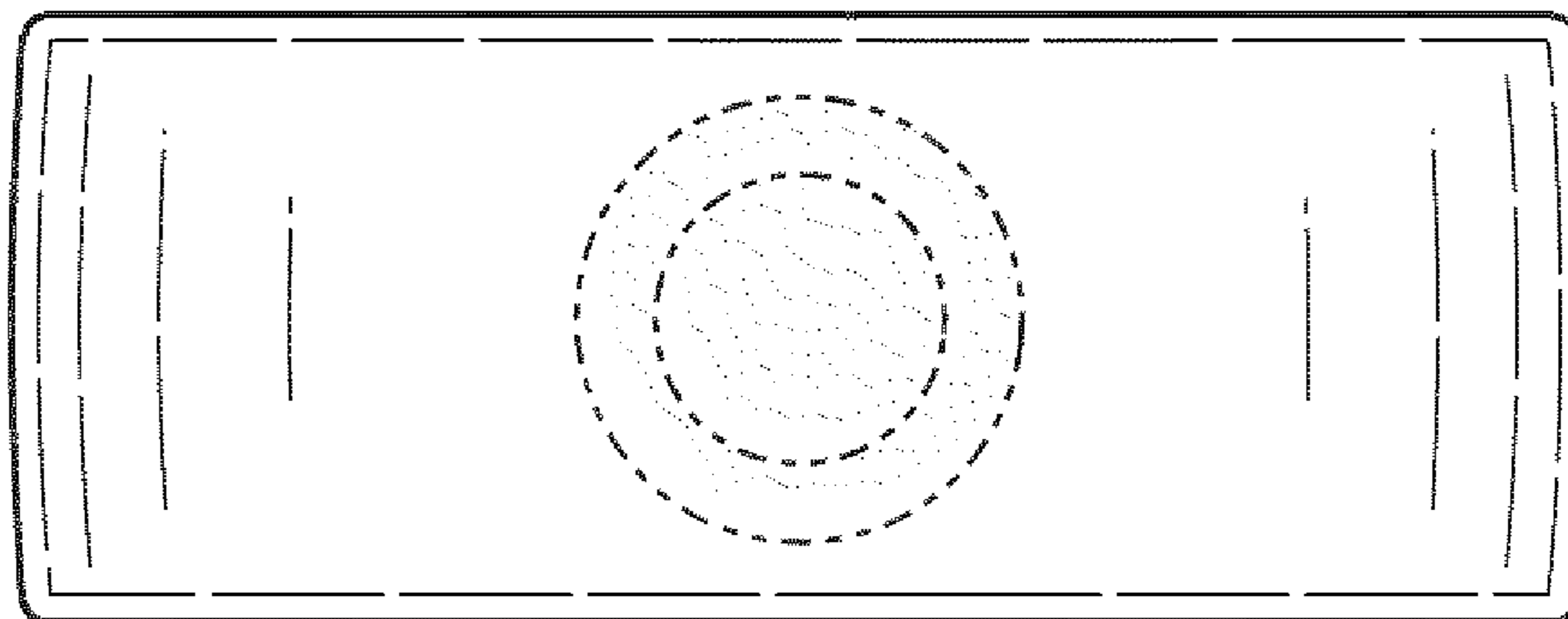

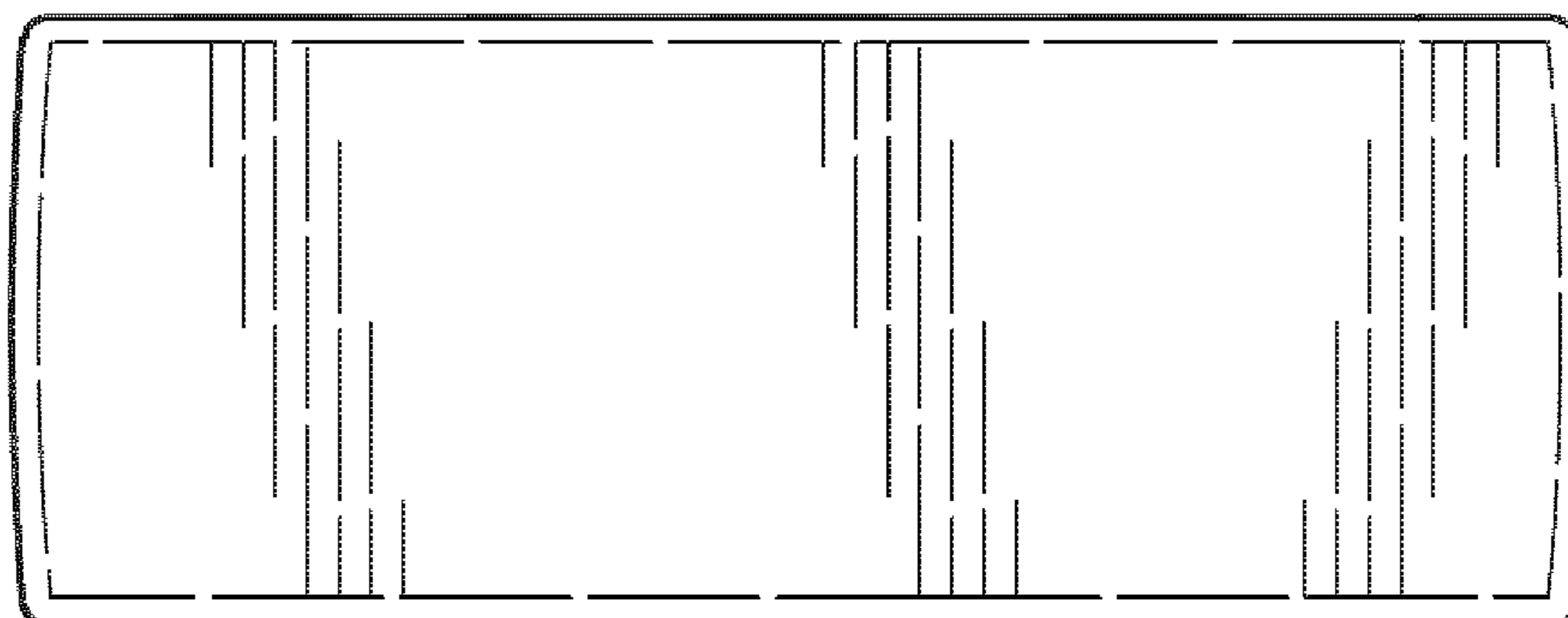
