DESCRIPTION

FIG. 1 is a perspective view of a container according to a first embodiment of the present invention.

FIG. 2 is a front view of the container of FIG. 1.

FIG. 3 is a rear view of the container of FIG. 1.

FIG. 4 is a right-side view of the container of FIG. 1.

FIG. 11 is a right-side view of the container of FIG. 8.

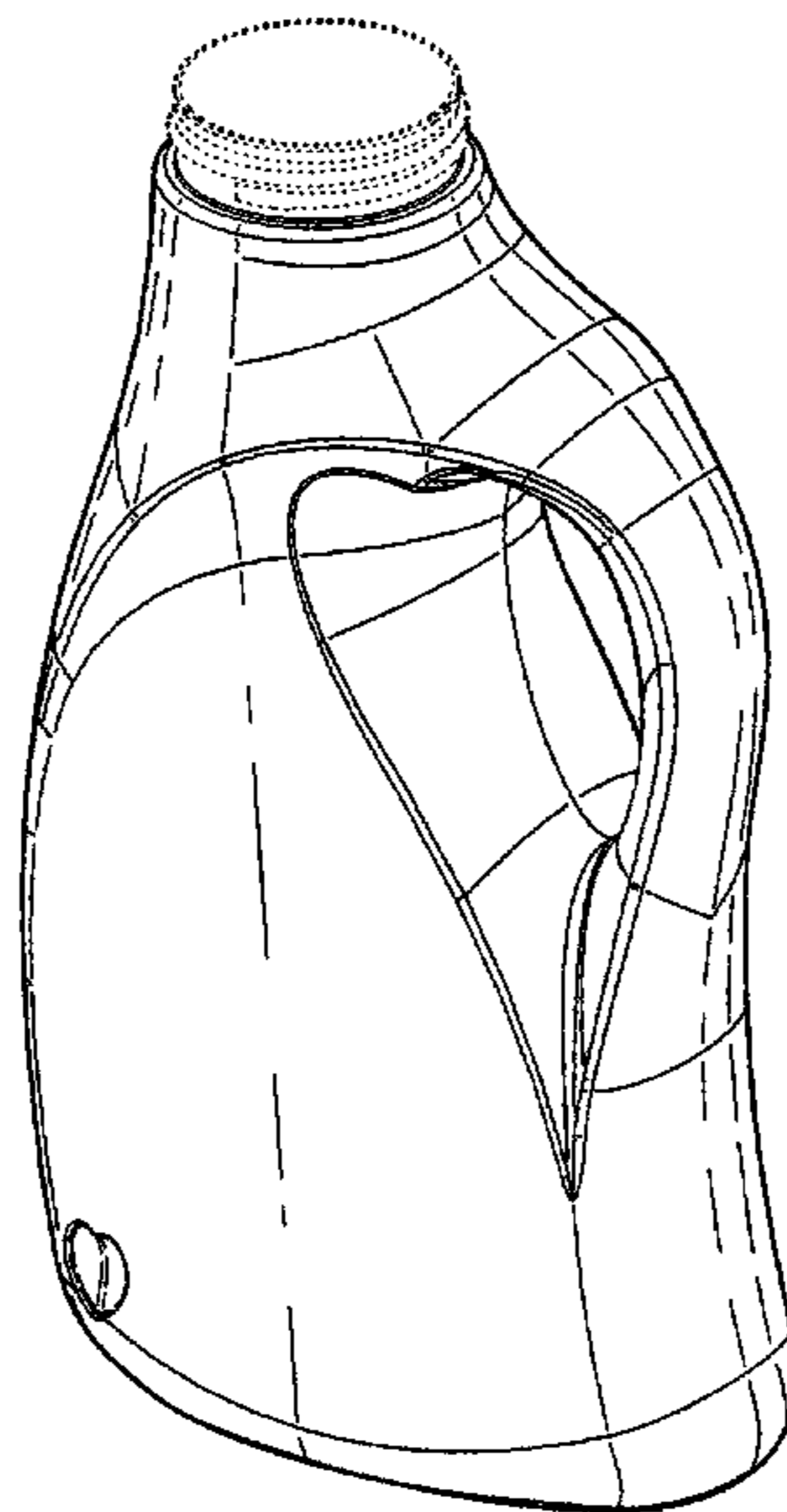
FIG. 12 is a left-side view of the container of FIG. 8.

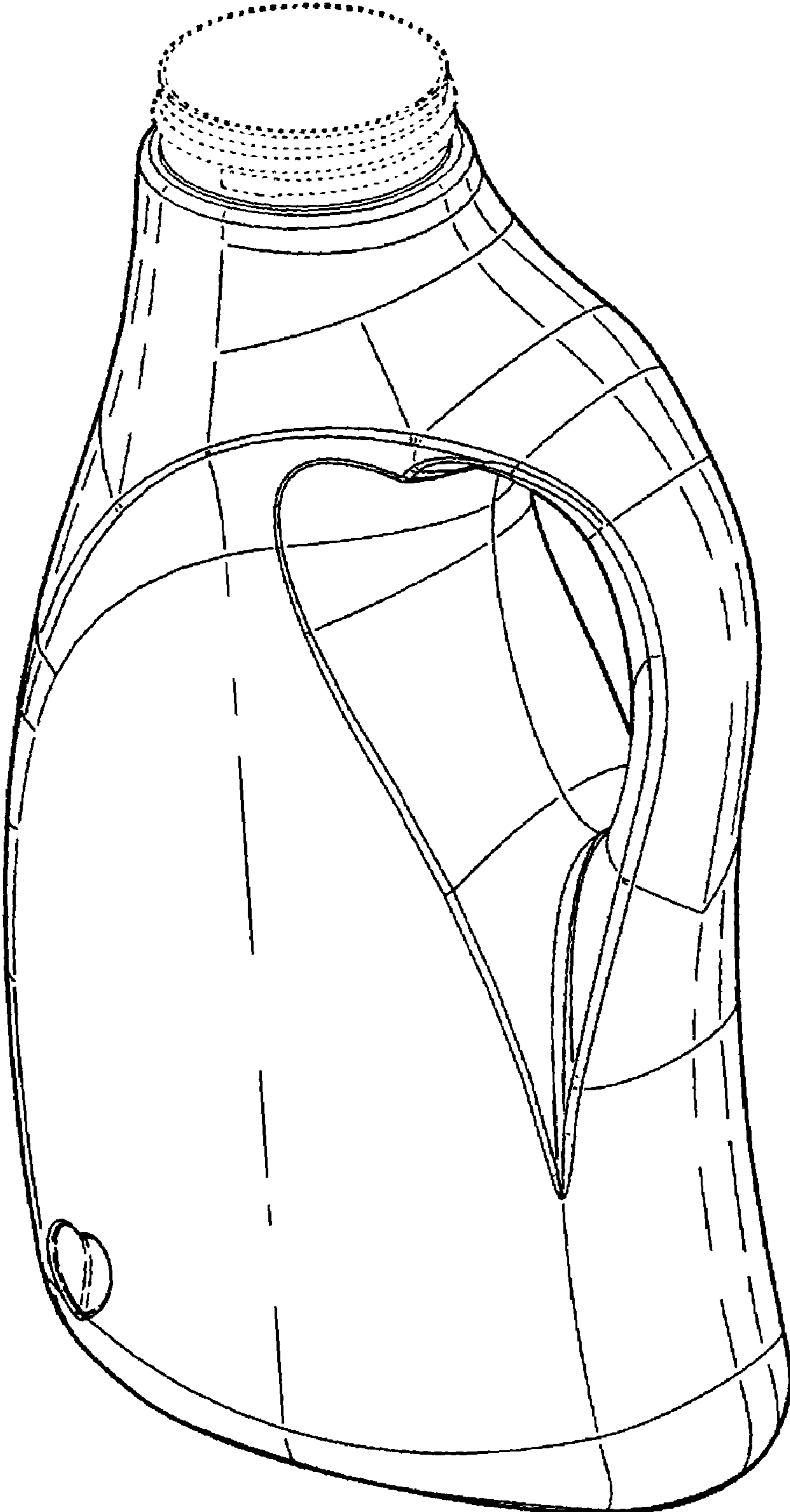

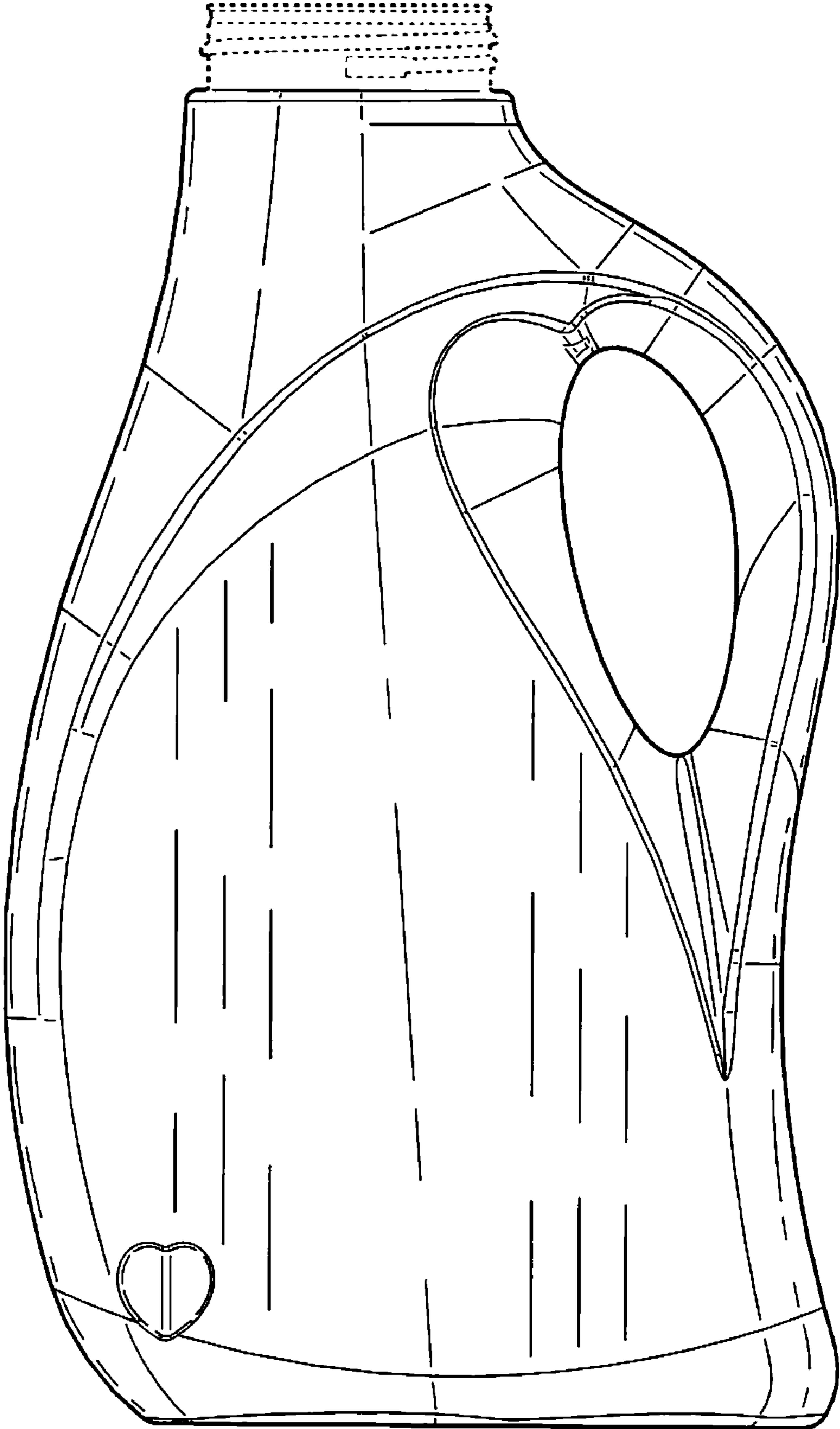

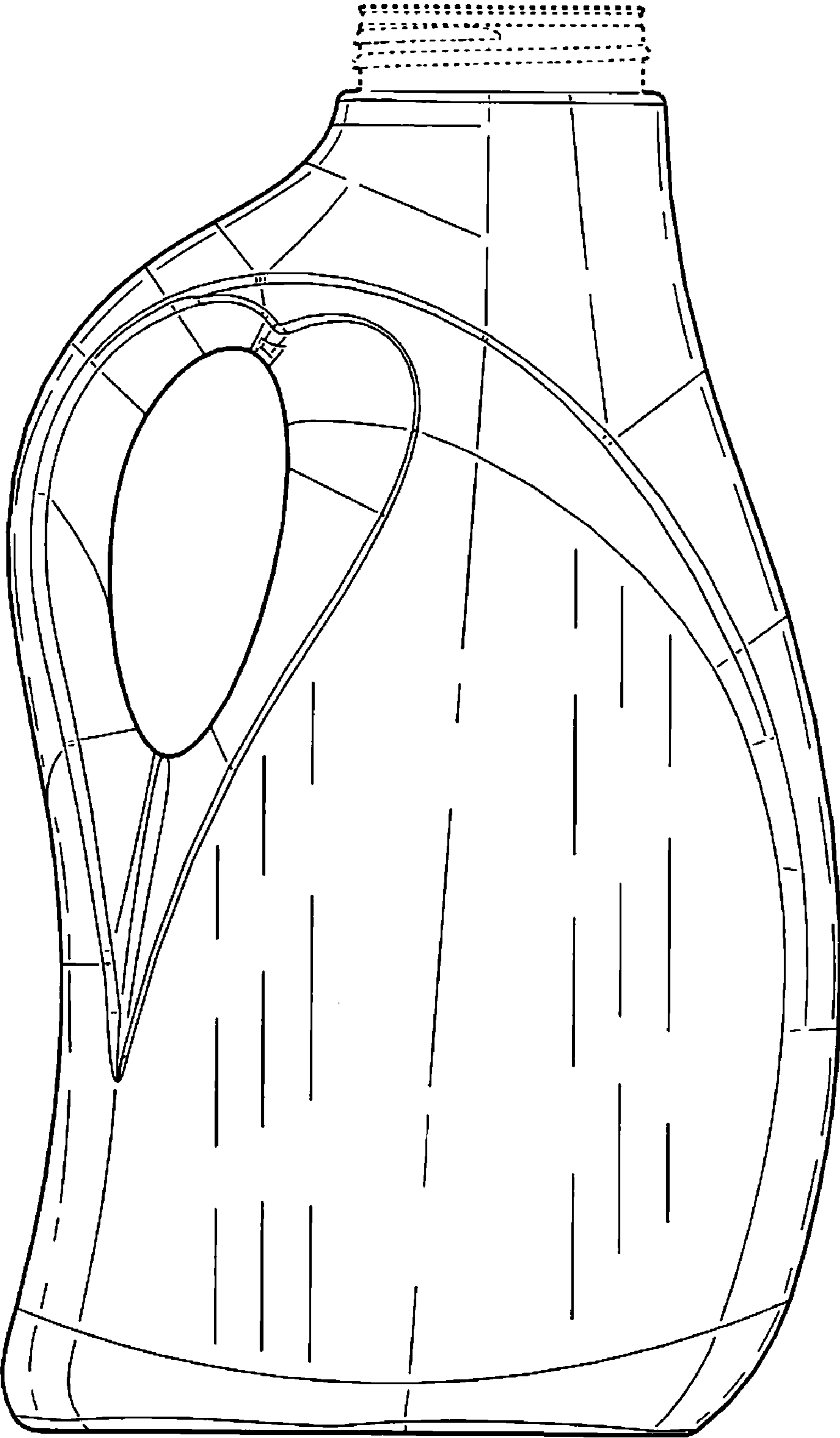

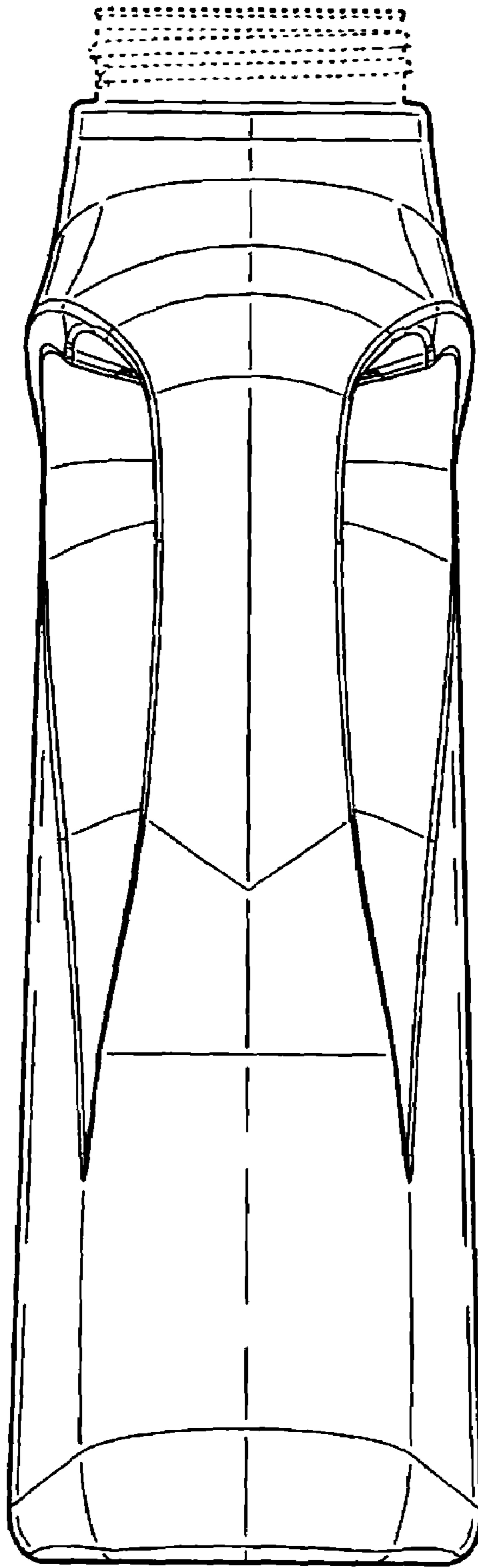

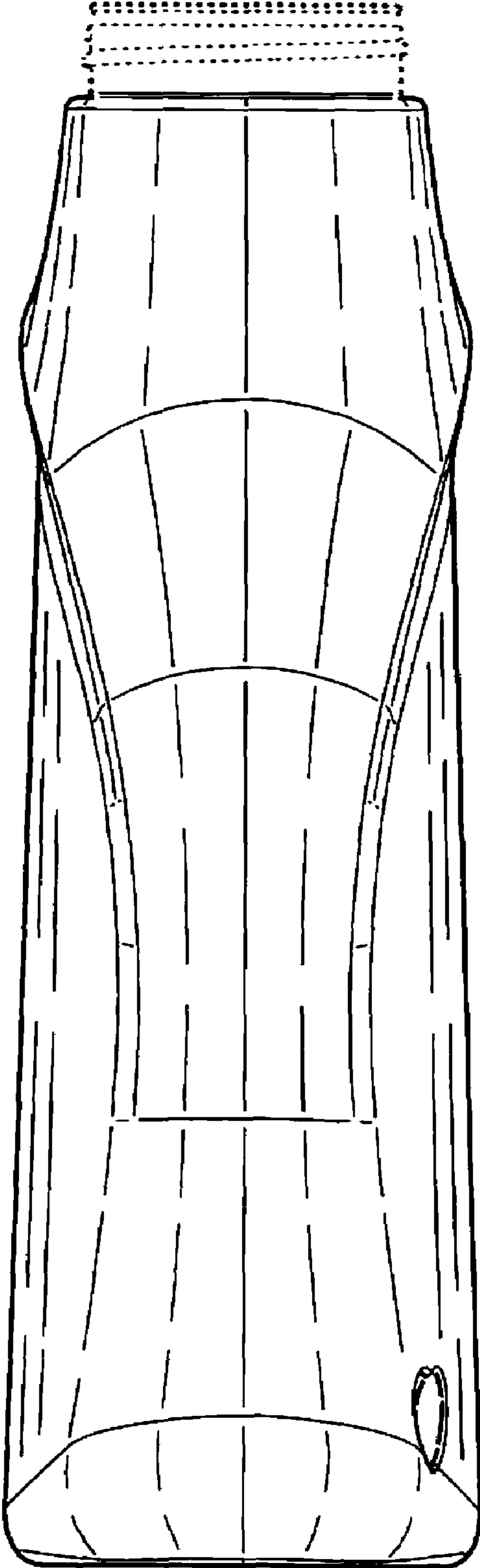

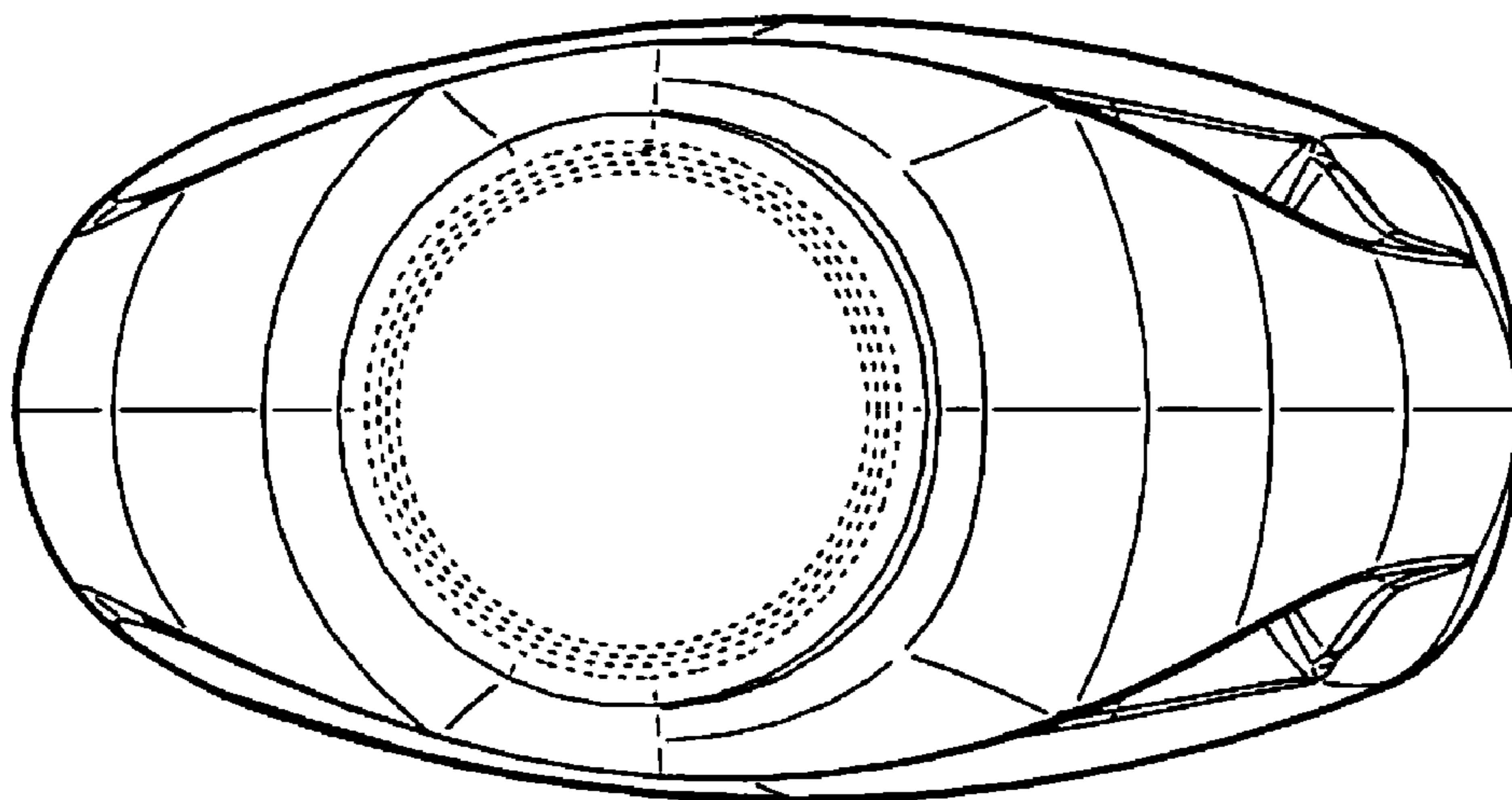

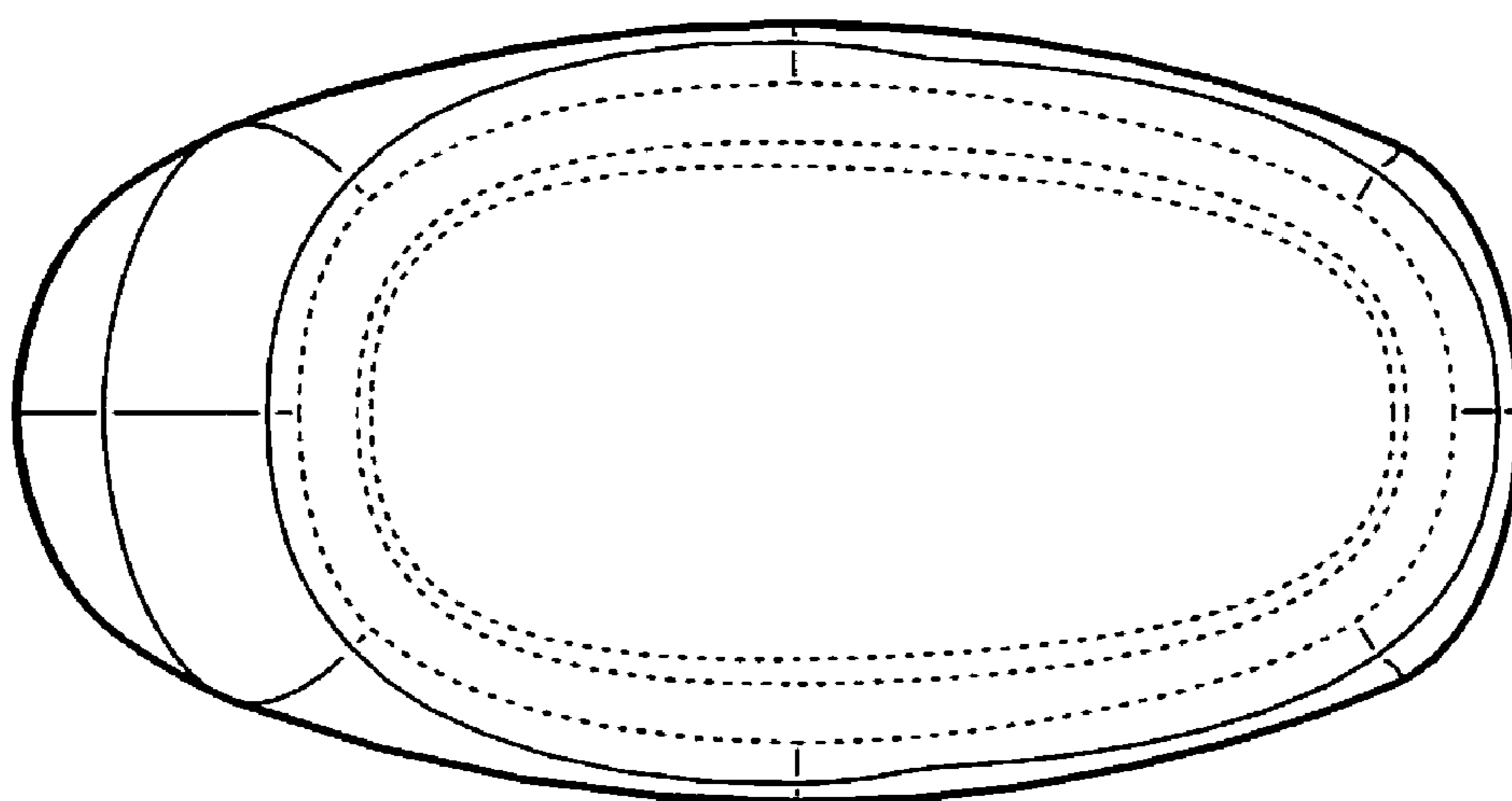

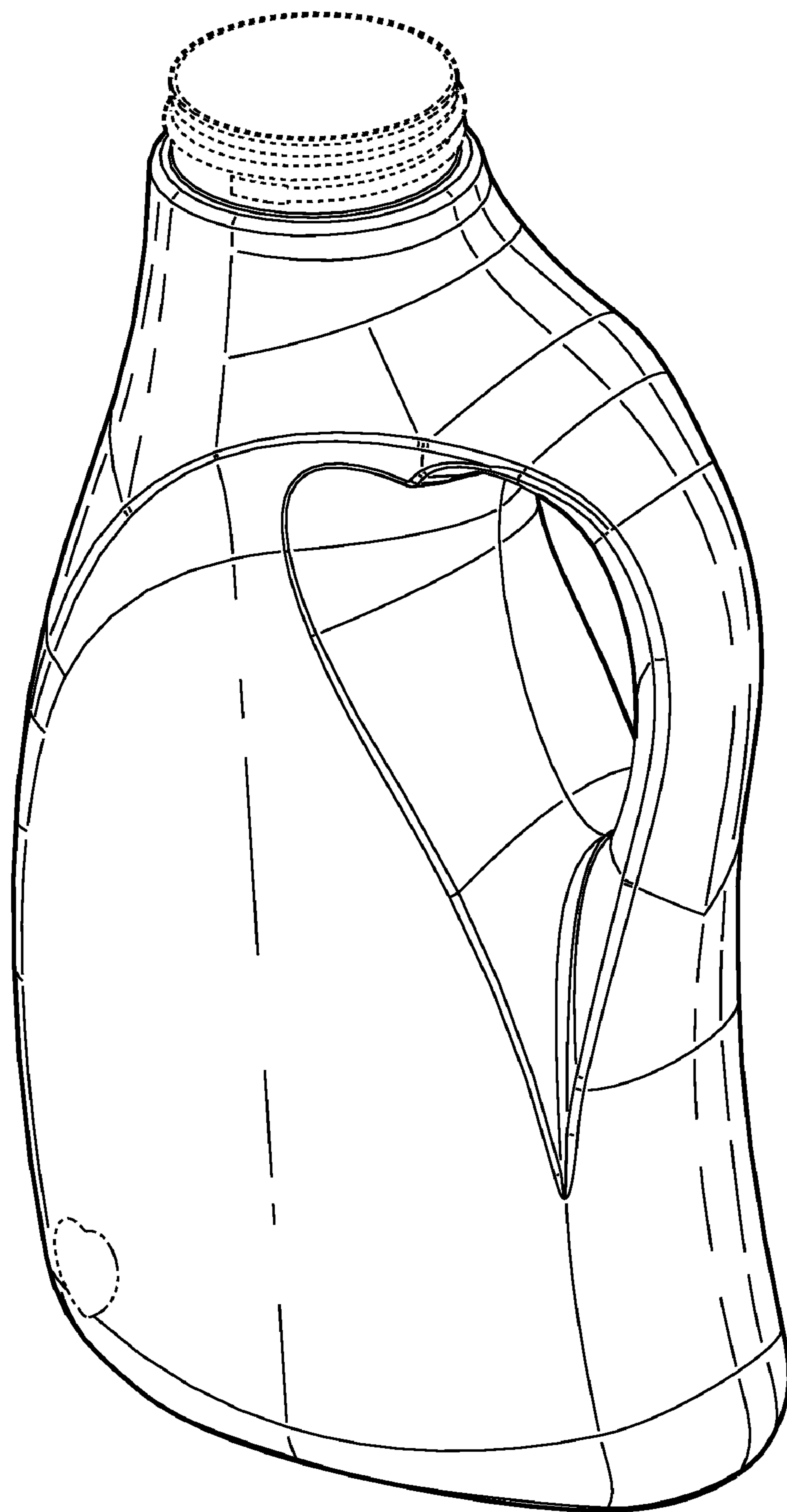

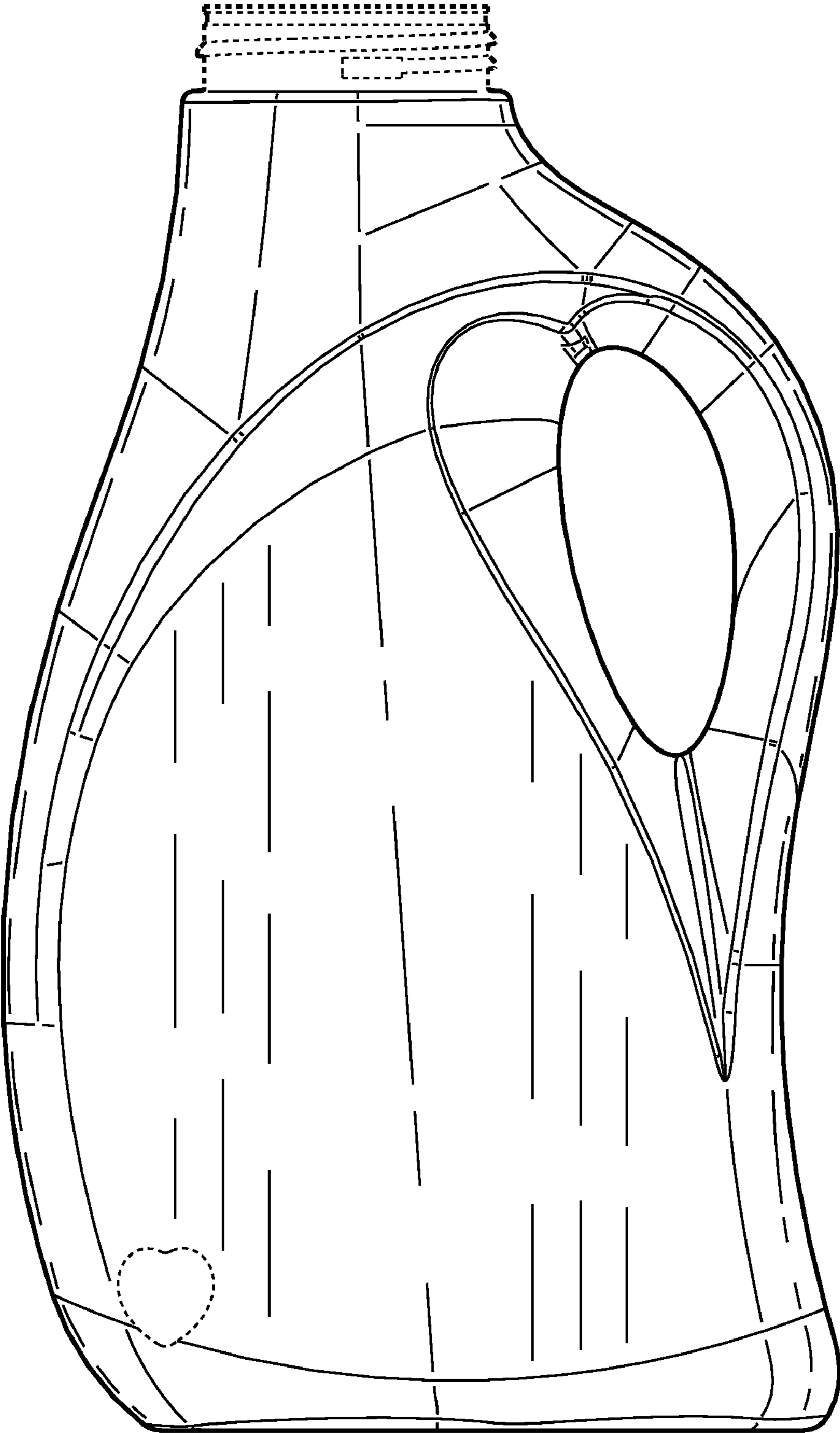

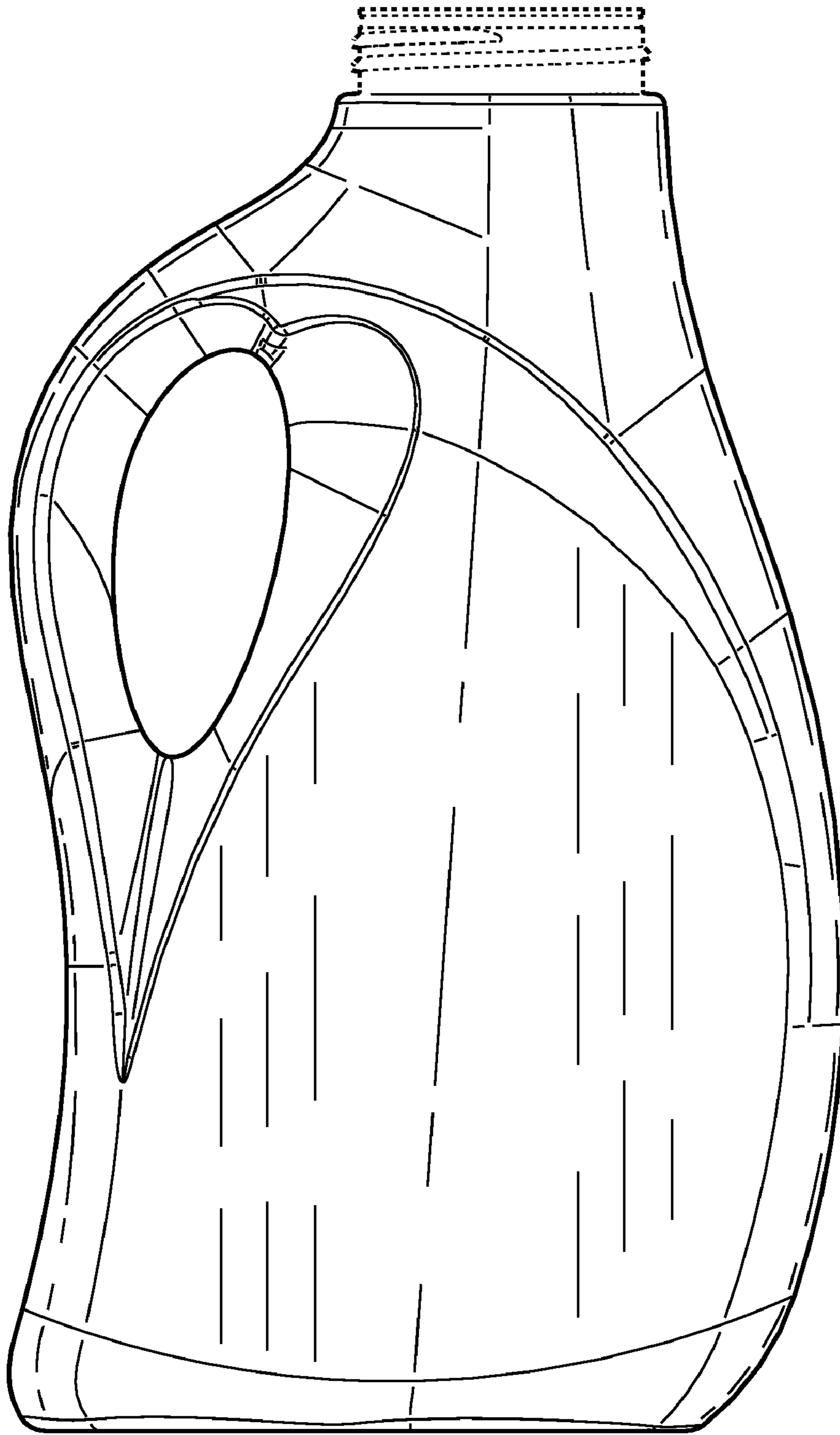

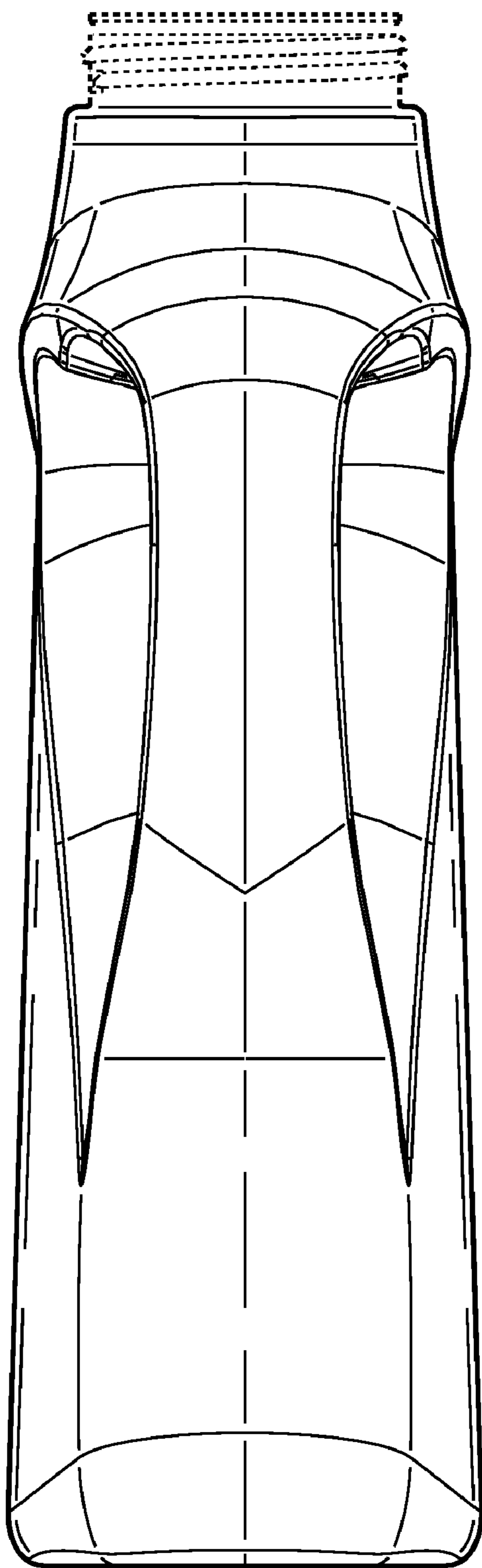

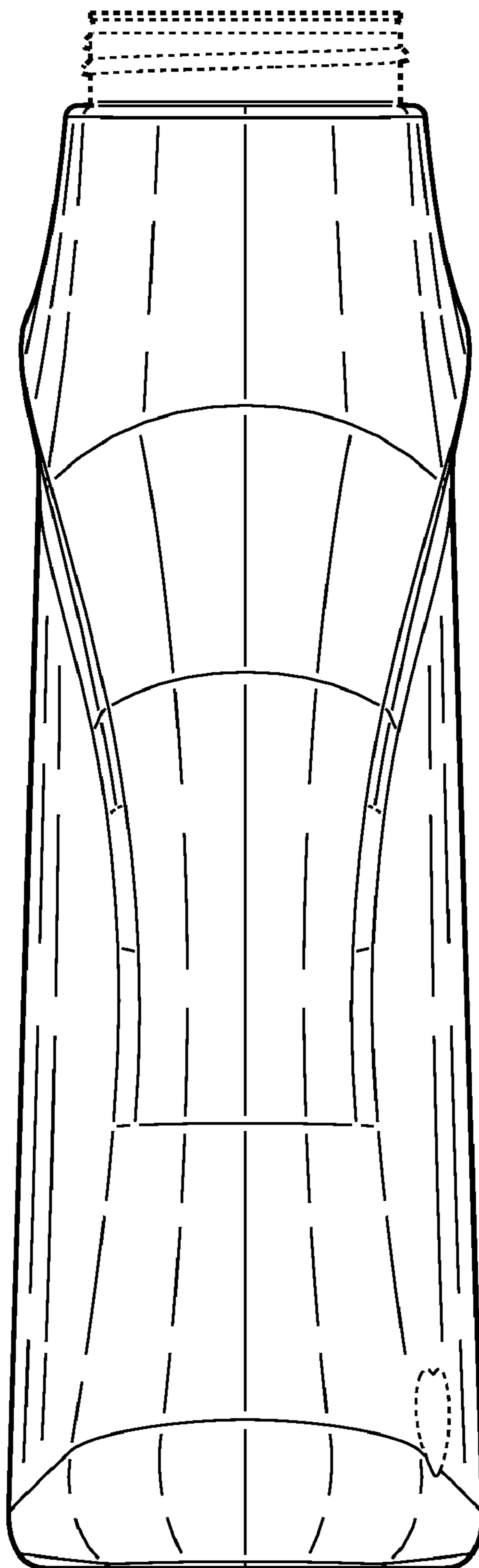

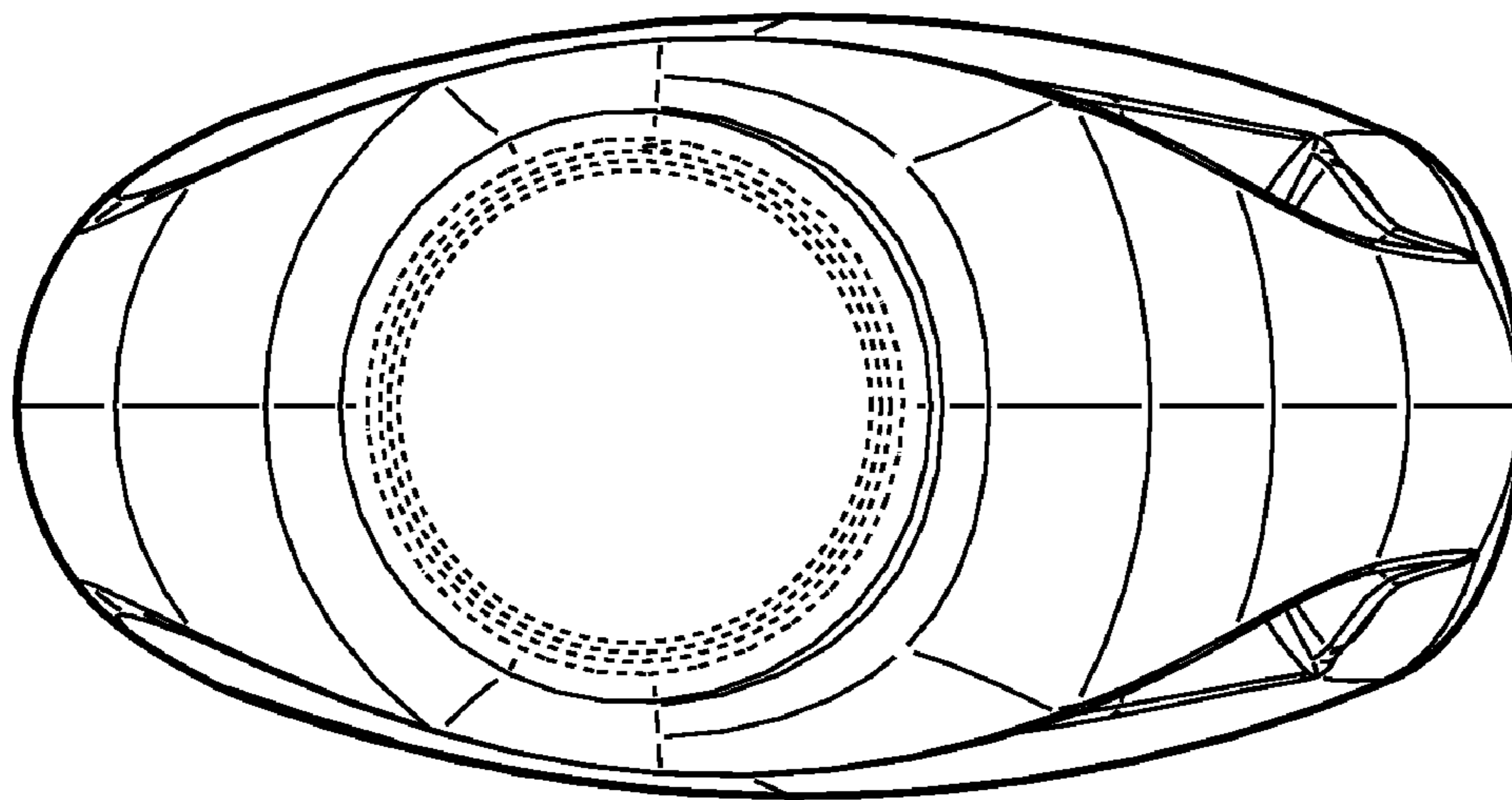

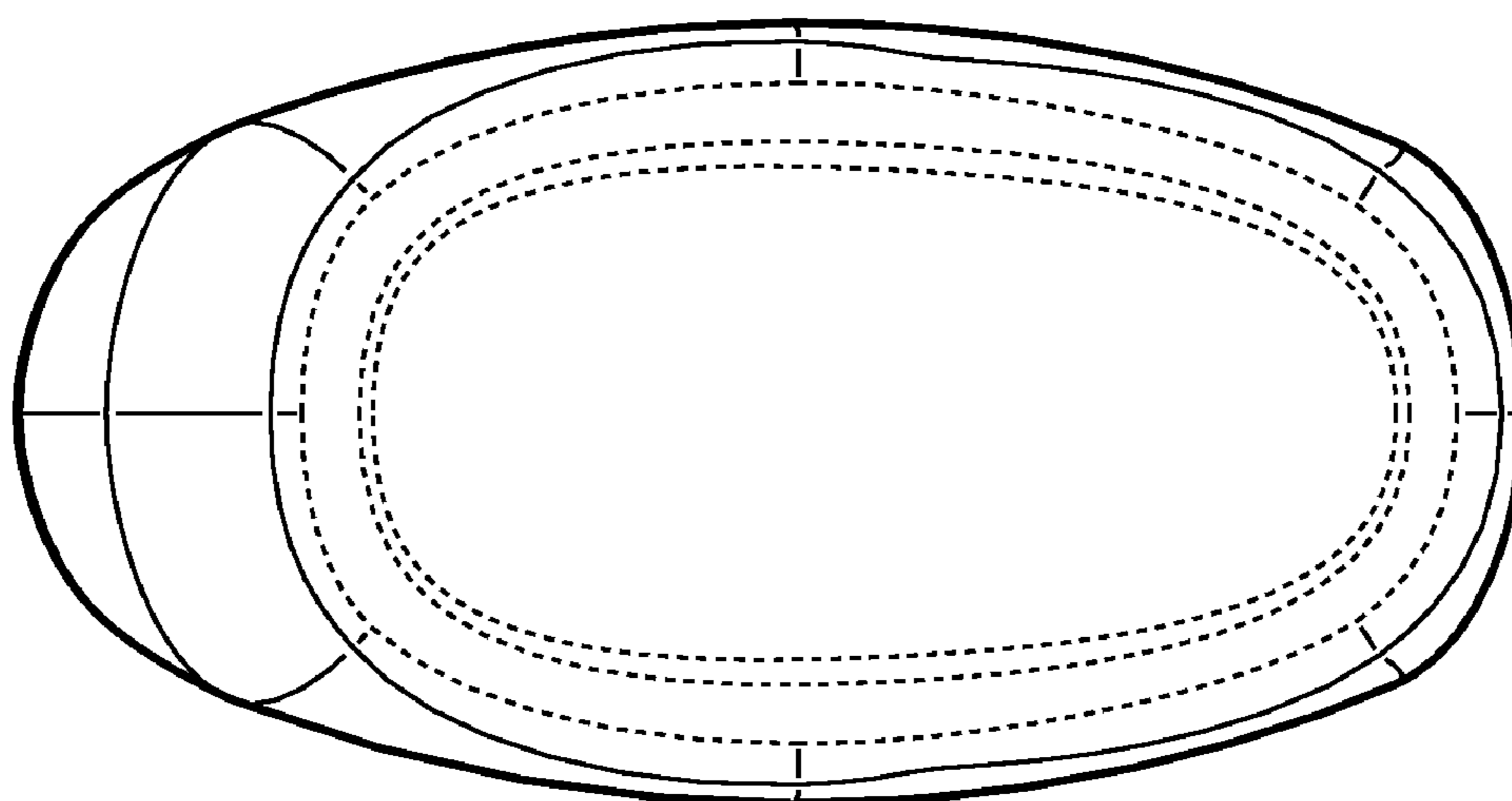
