The ornamental design for a pneumatic tire, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a pneumatic tire according to our new design, it being understood that the tire pattern repeats circumferentially about the outer circumference.

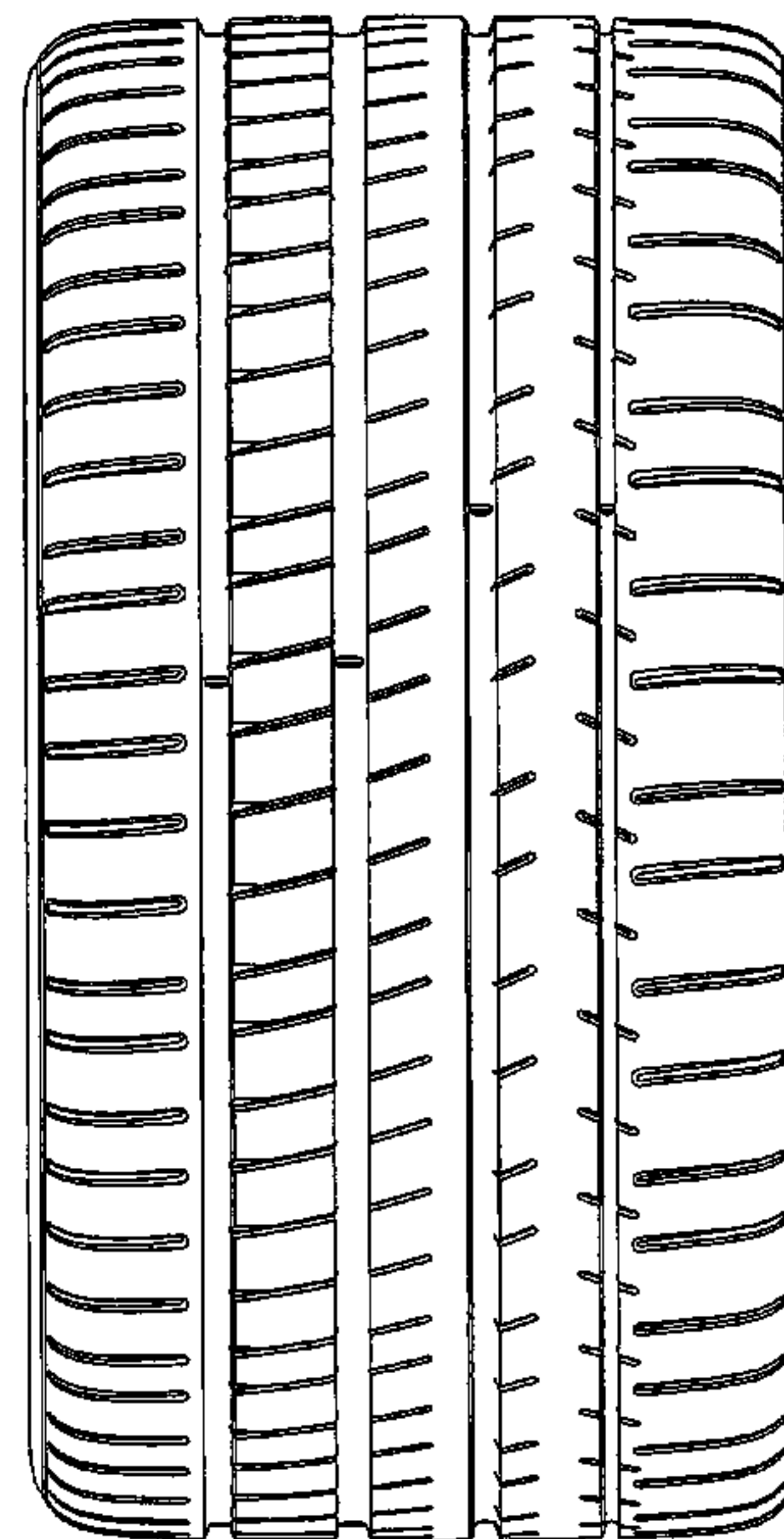
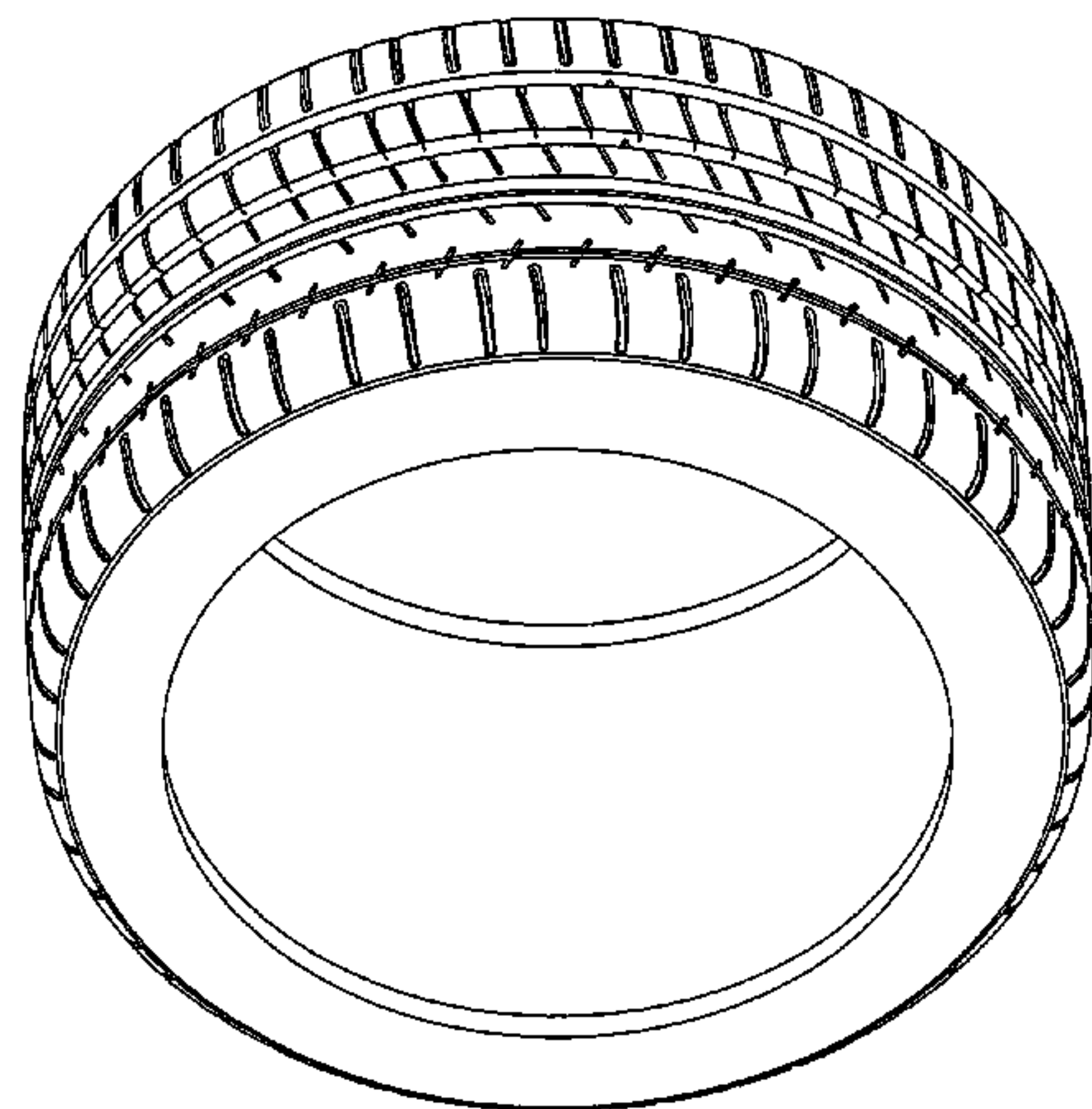
FIG. 2 is a front elevational view thereof.

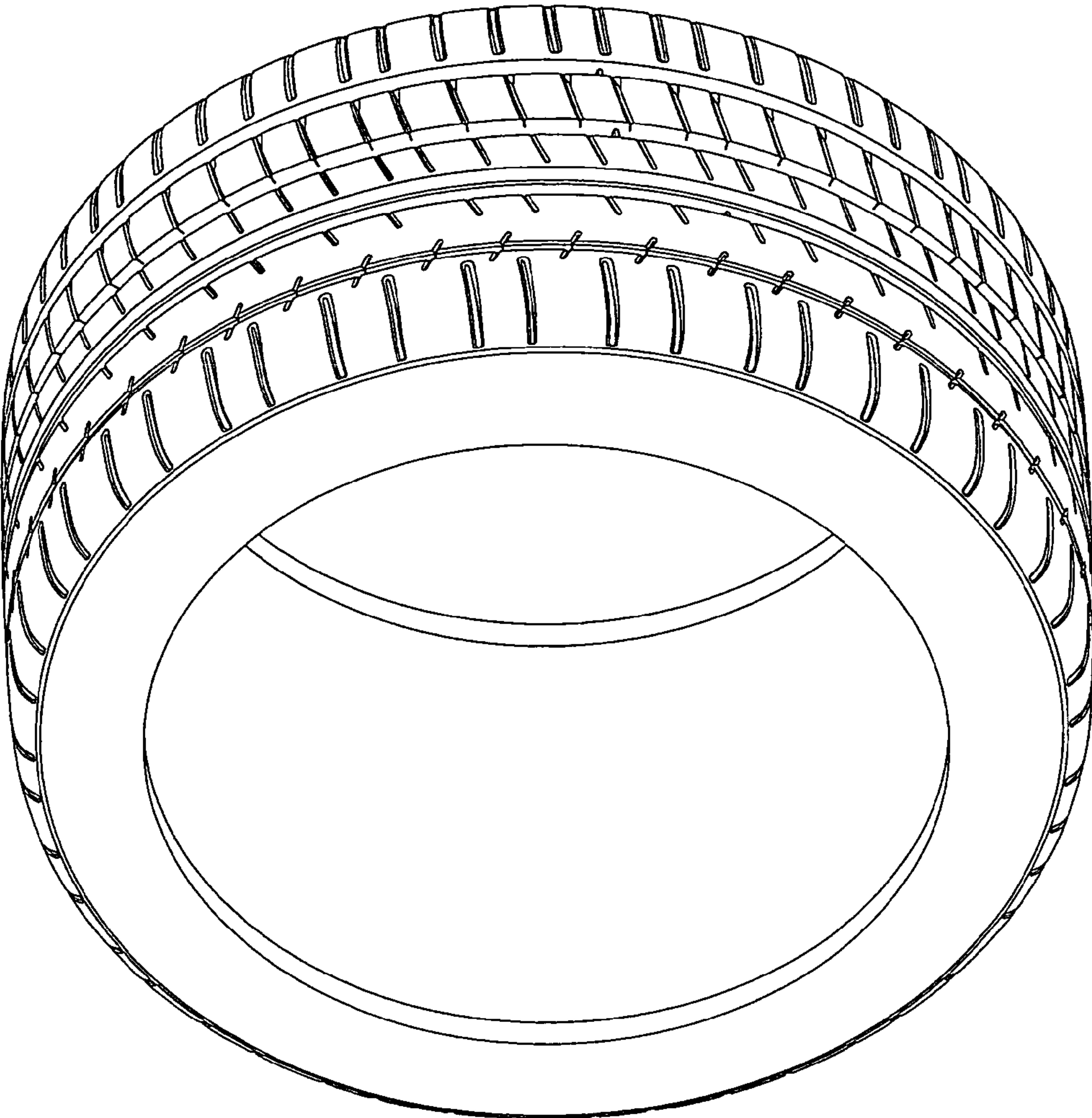

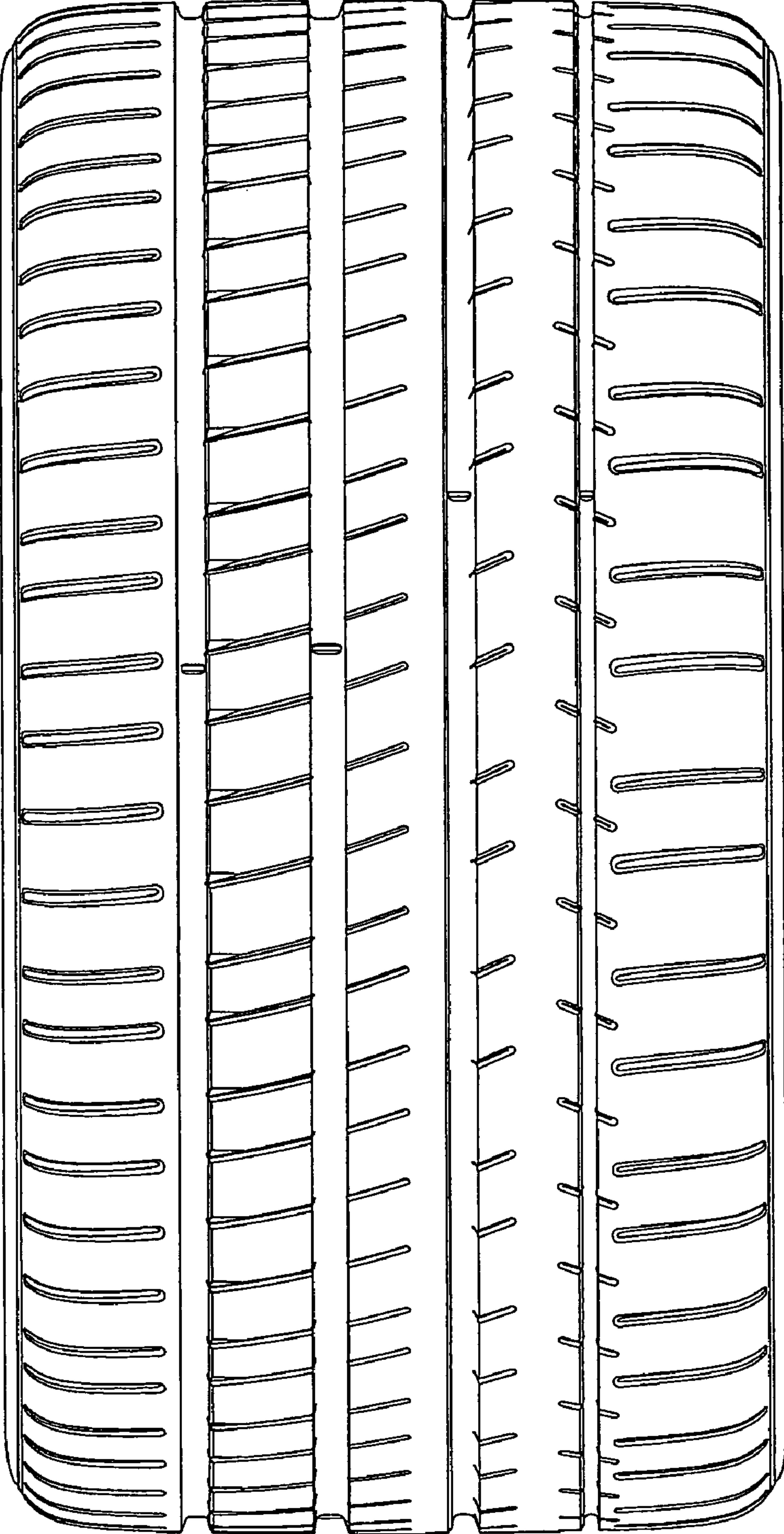

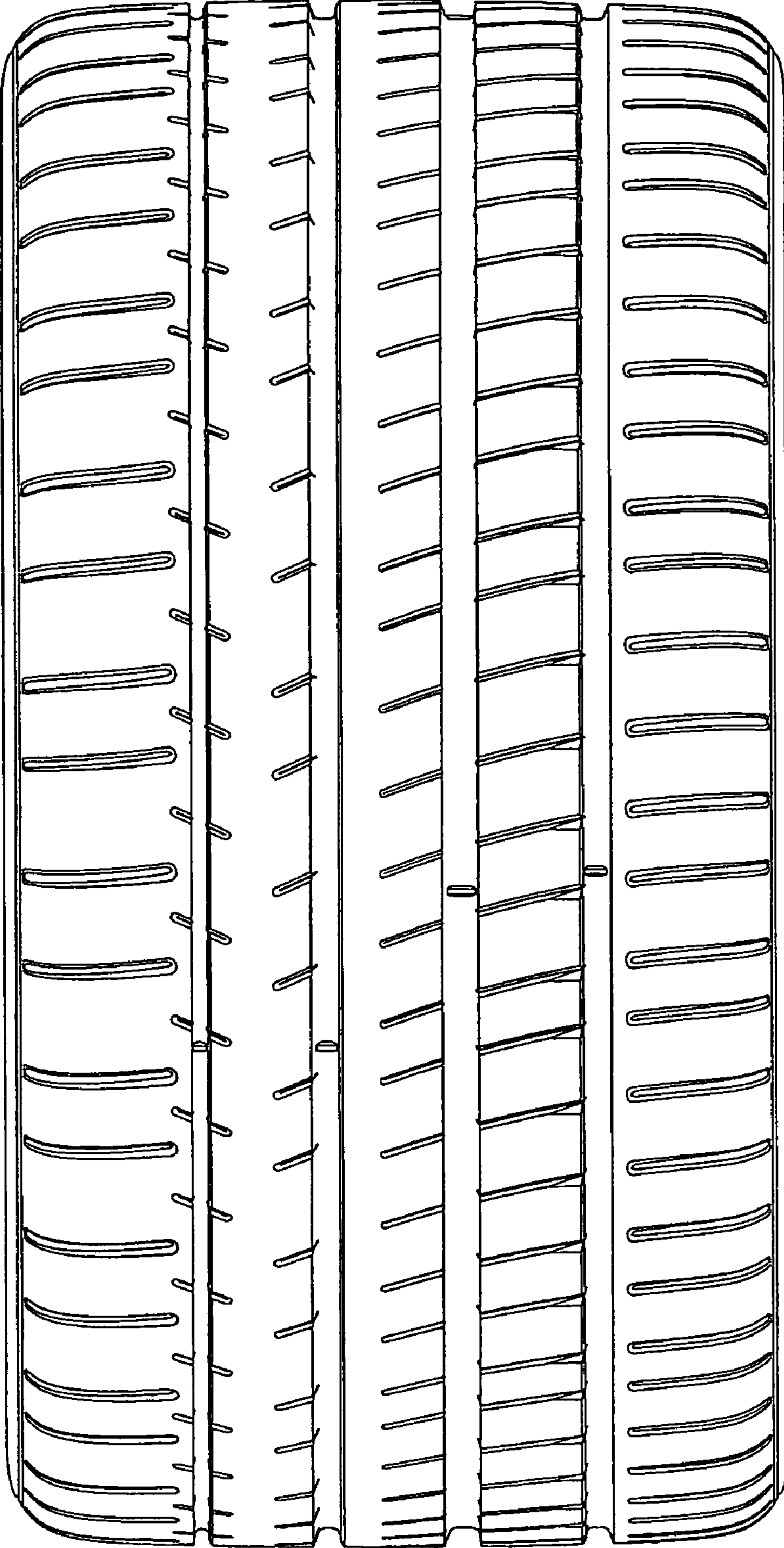

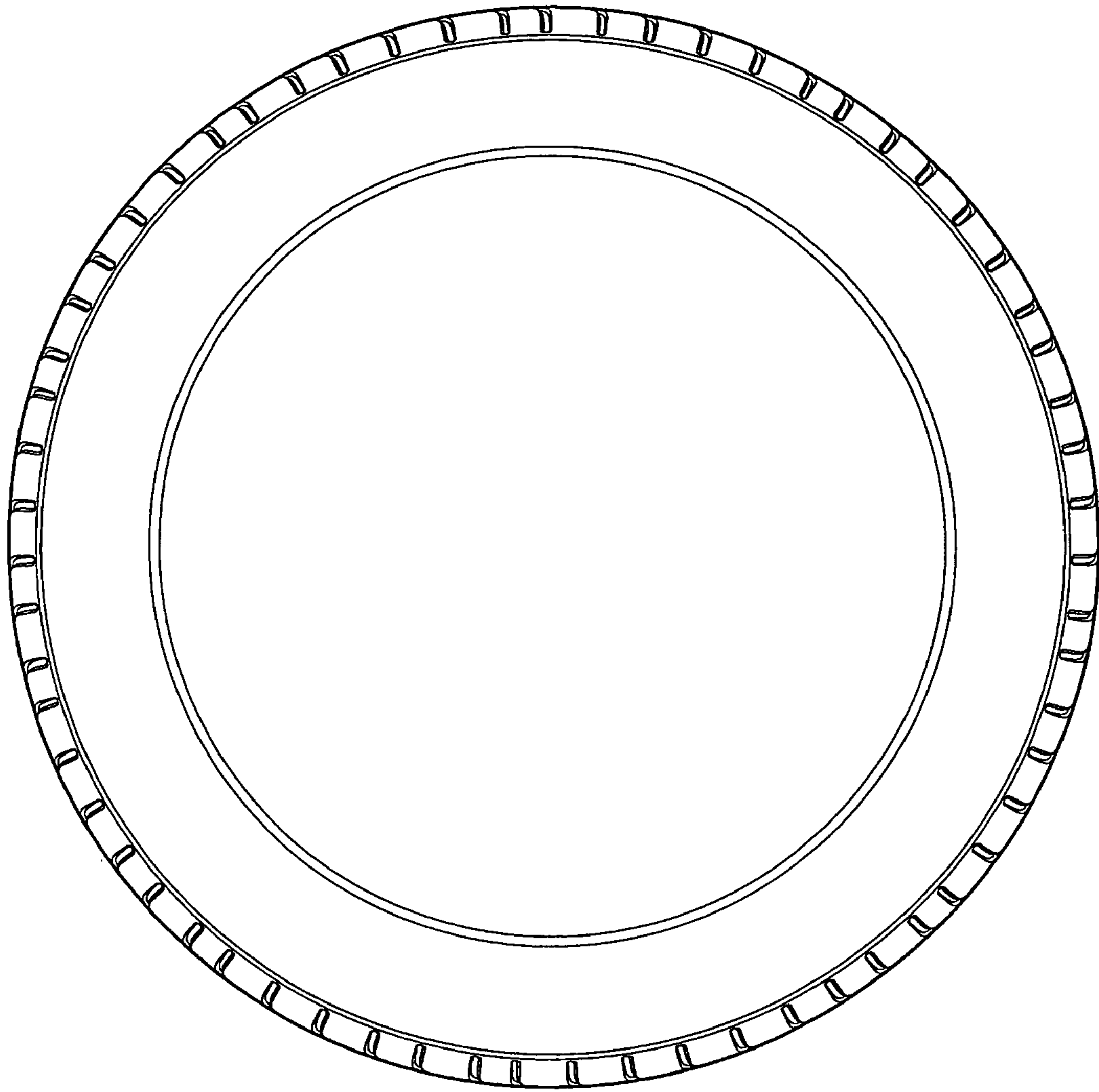

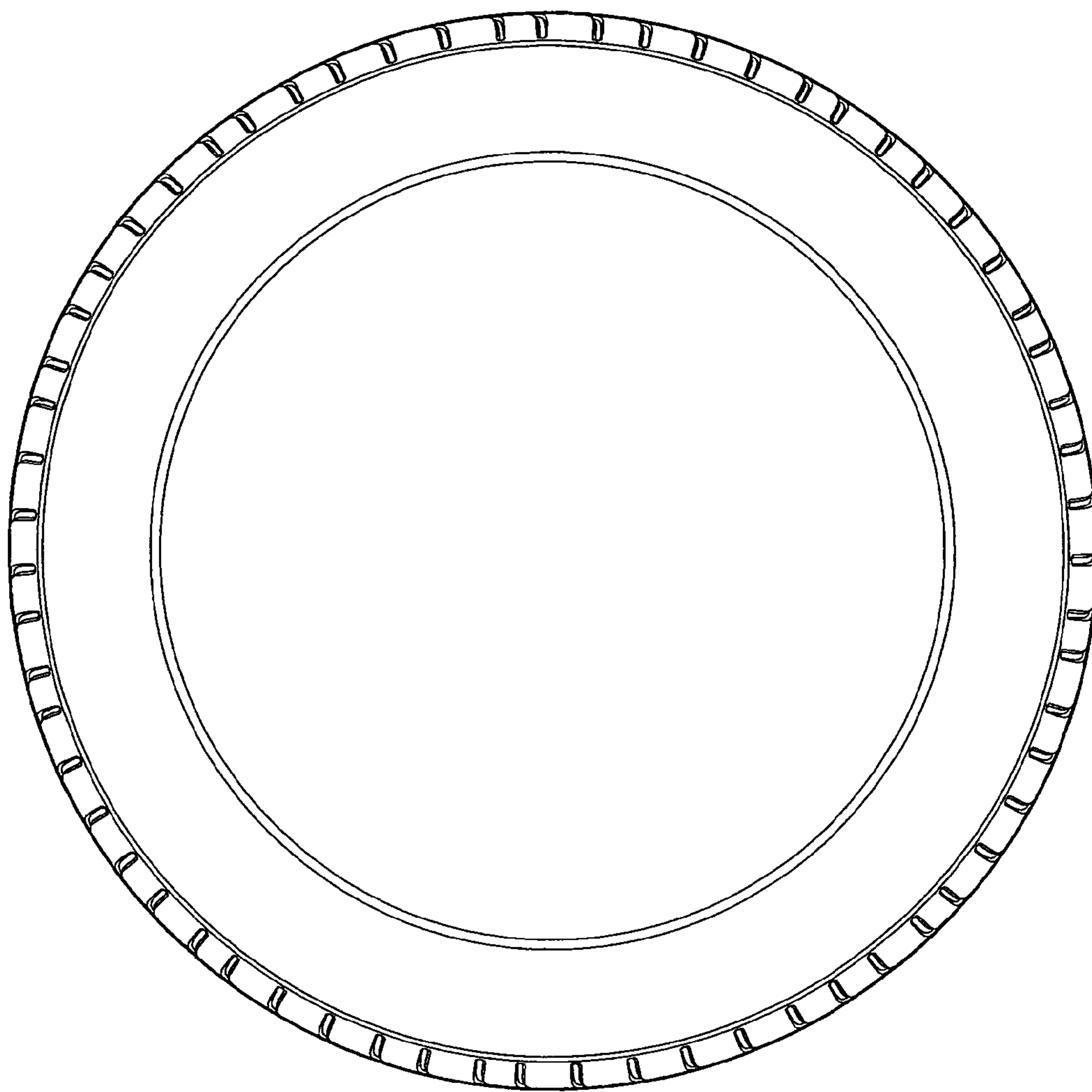
