is open when used.

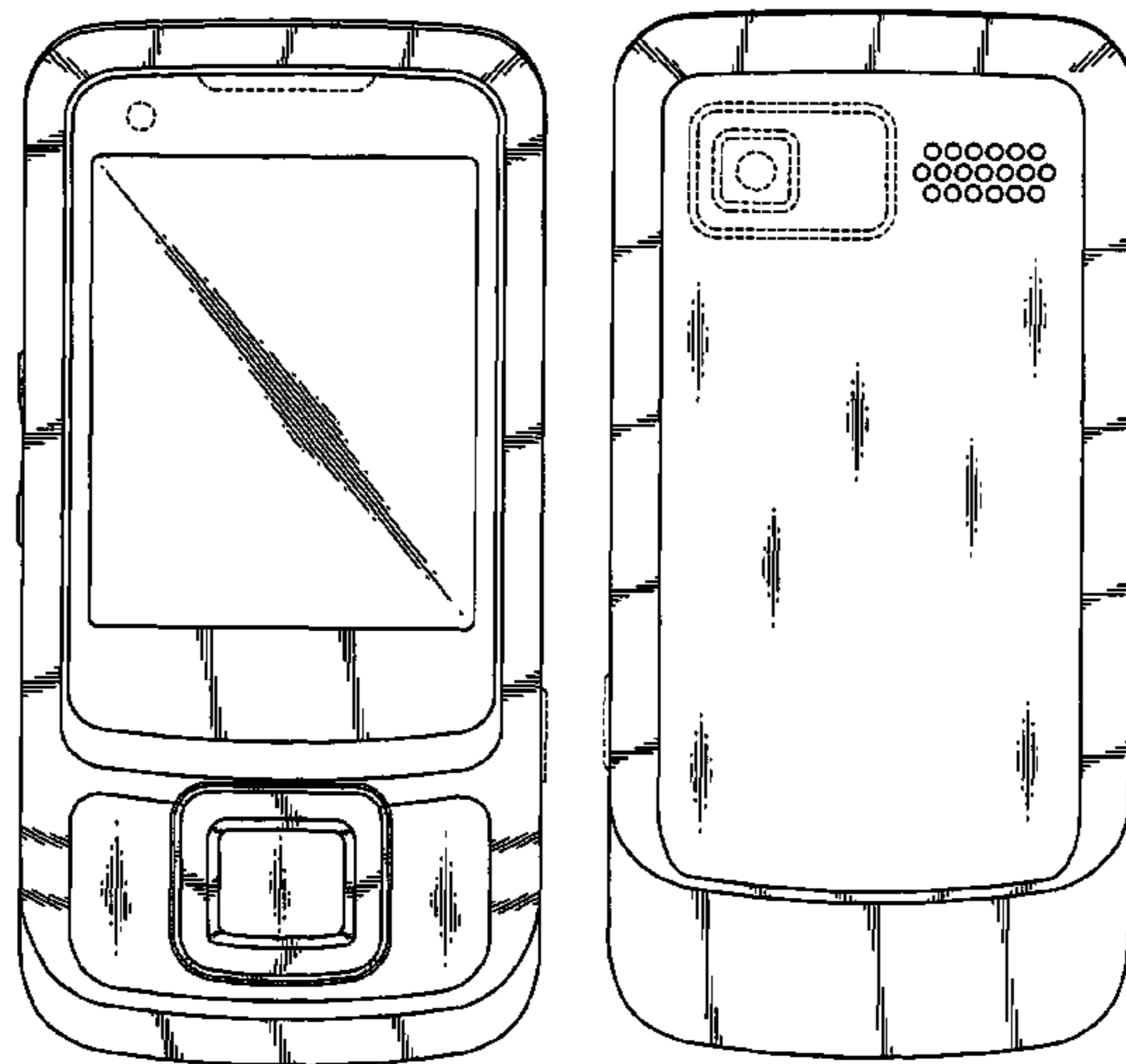
The broken lines immediately adjacent the shaded areas rep-

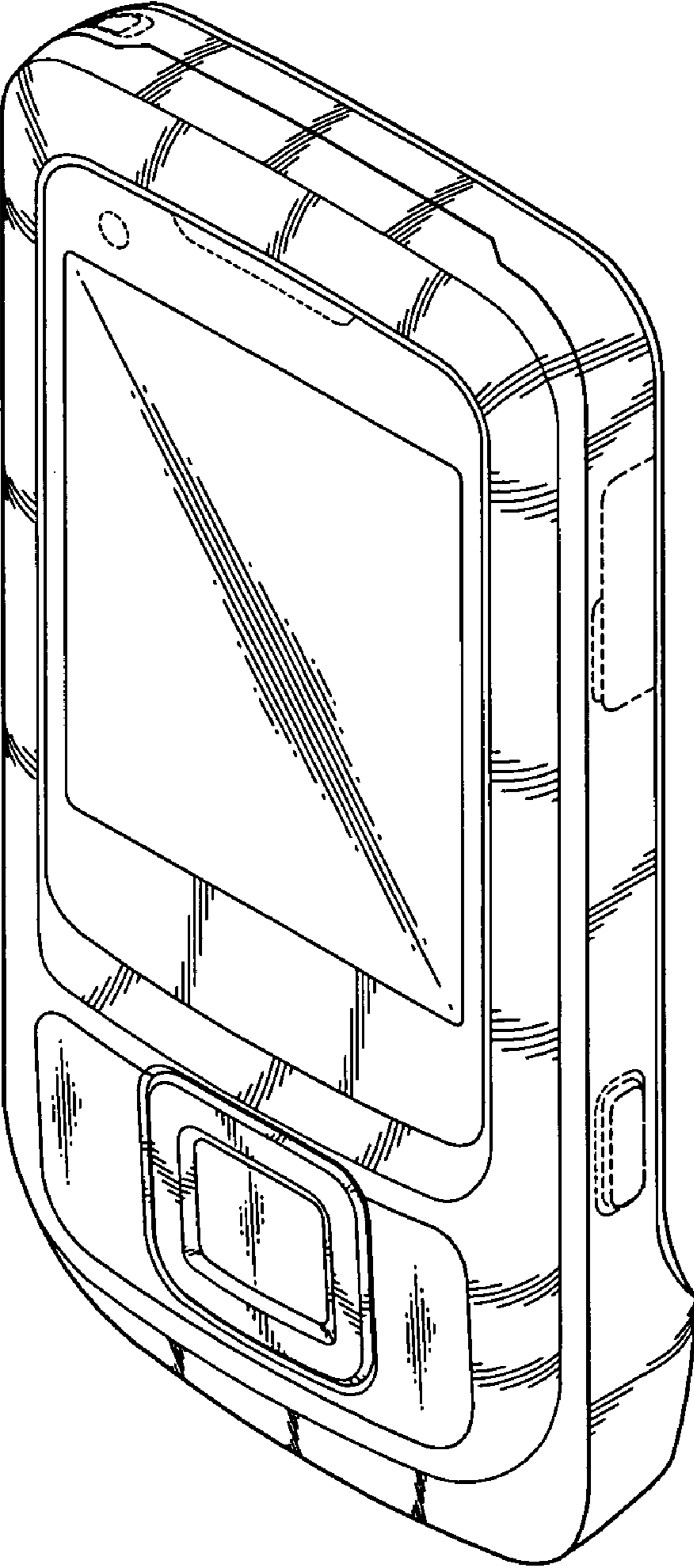

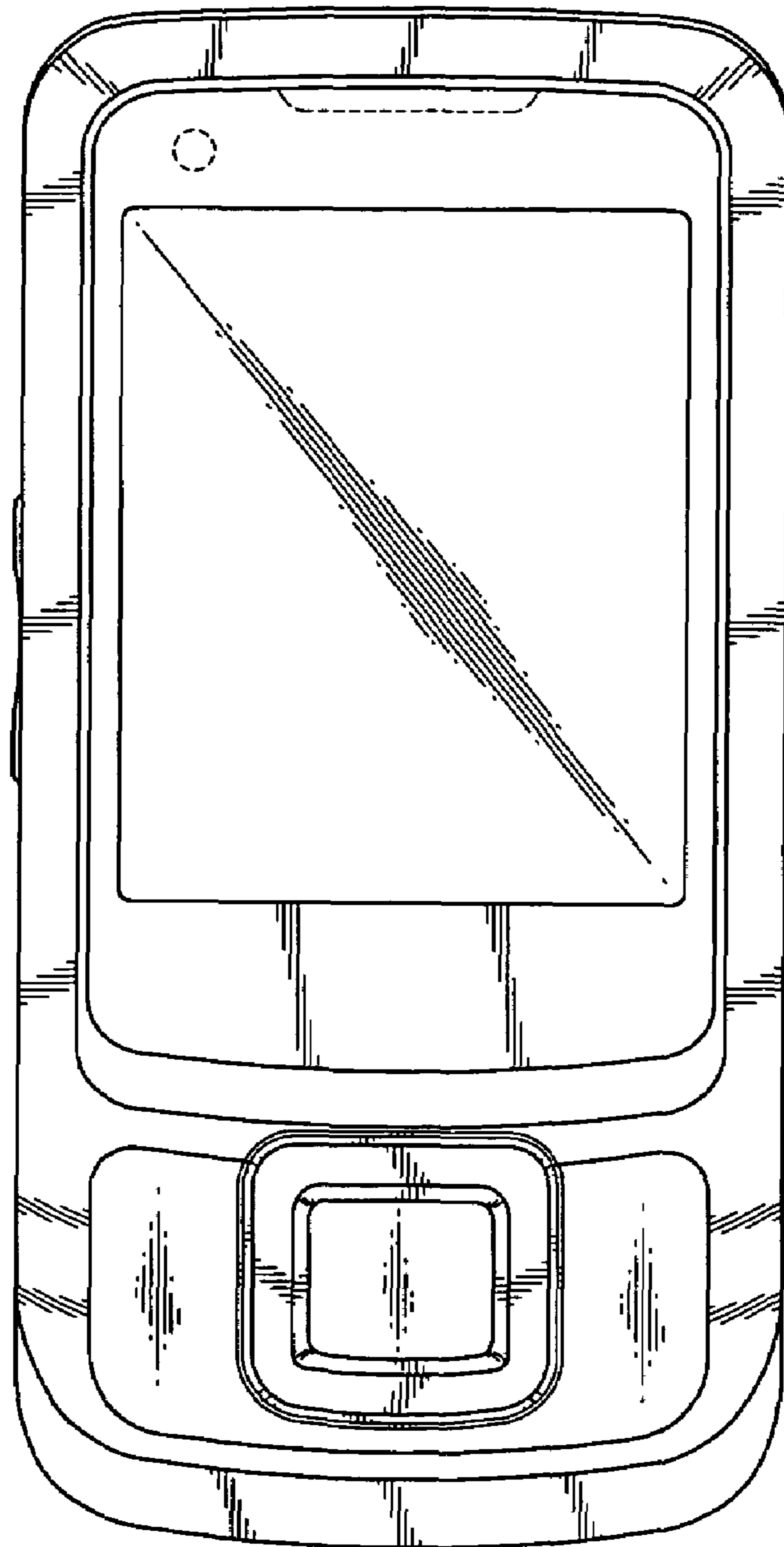

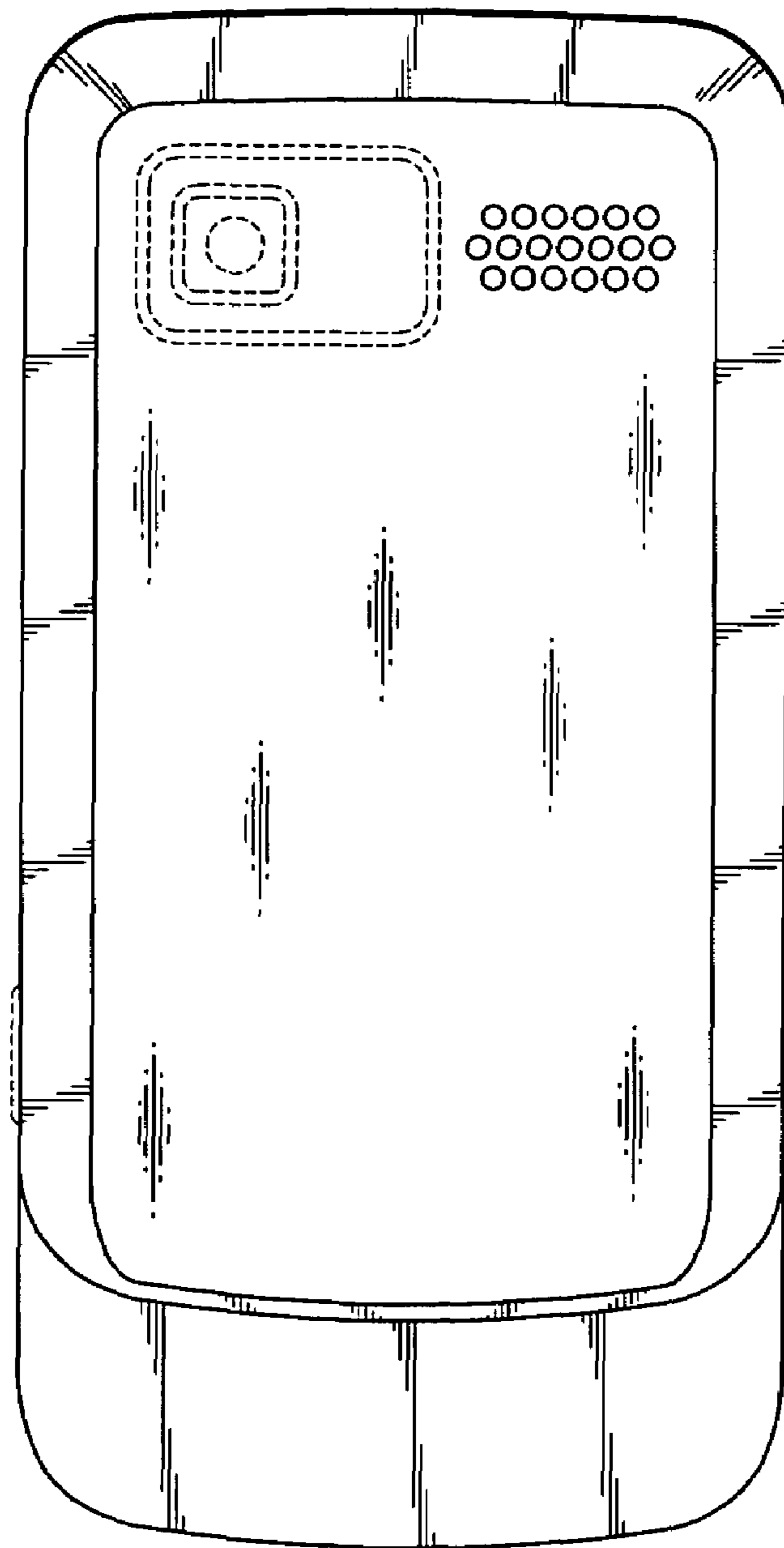

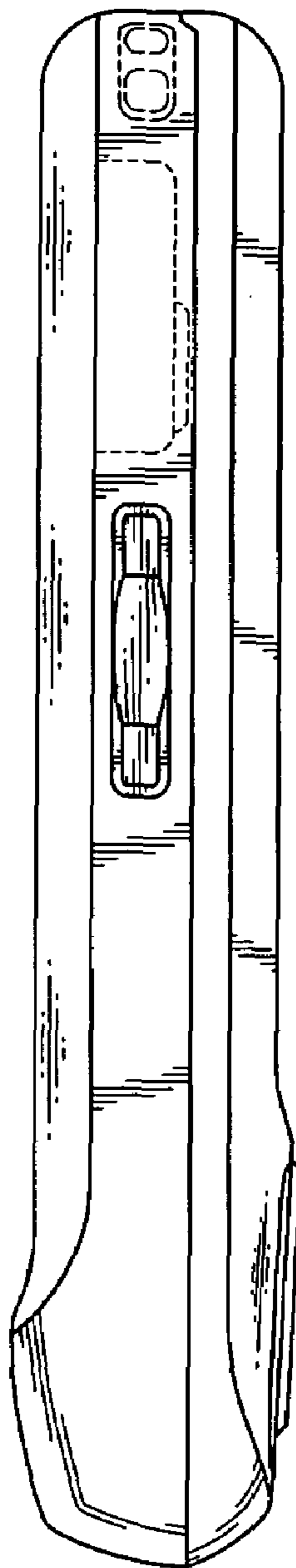

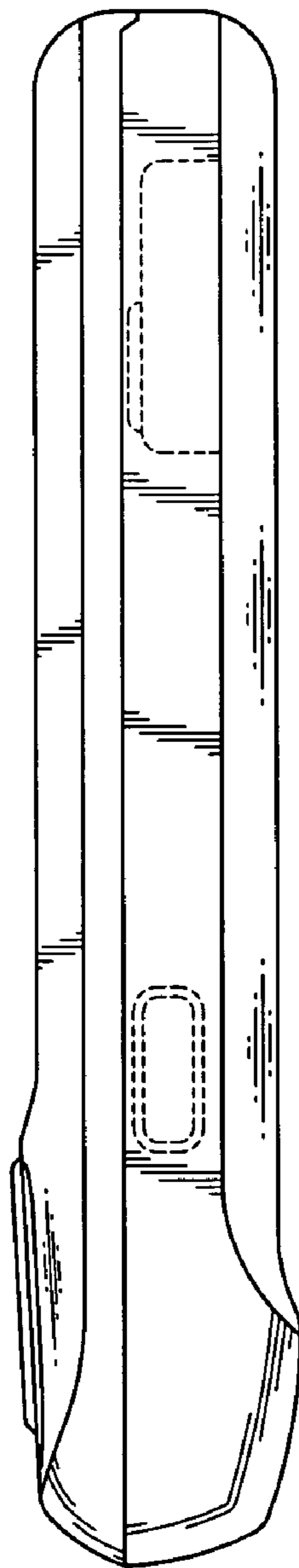

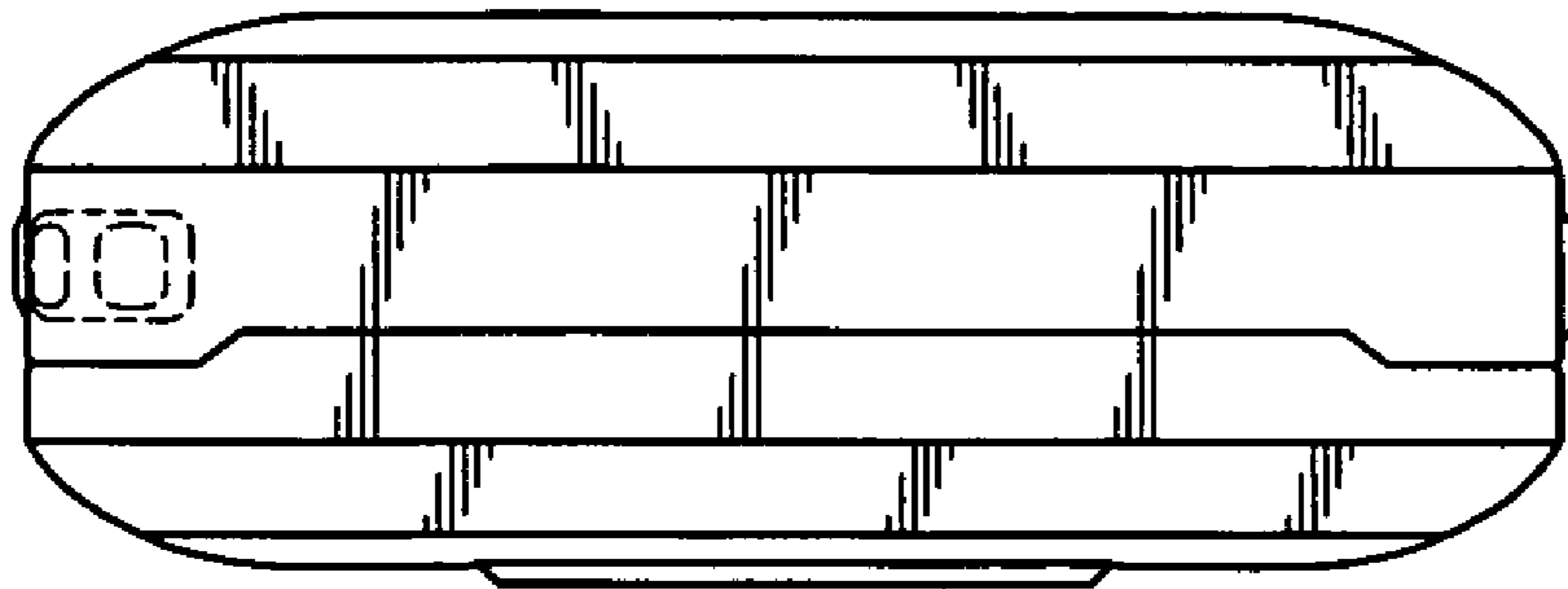

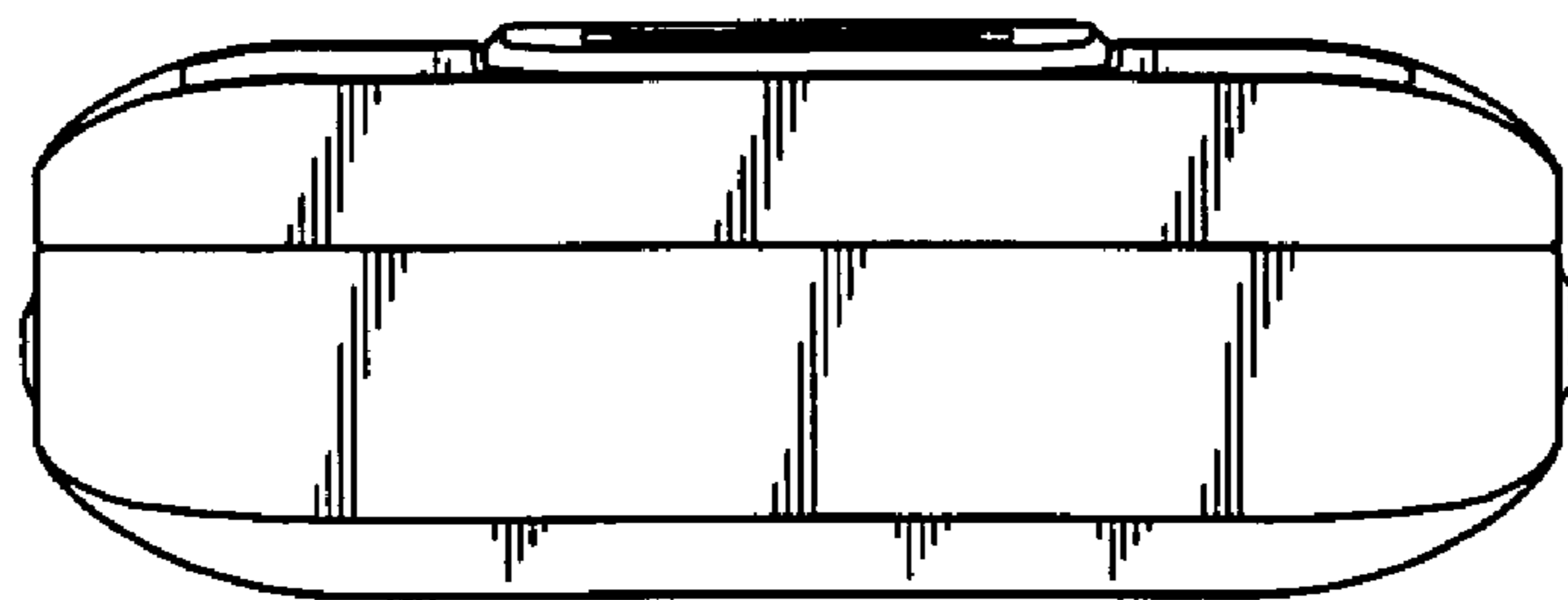

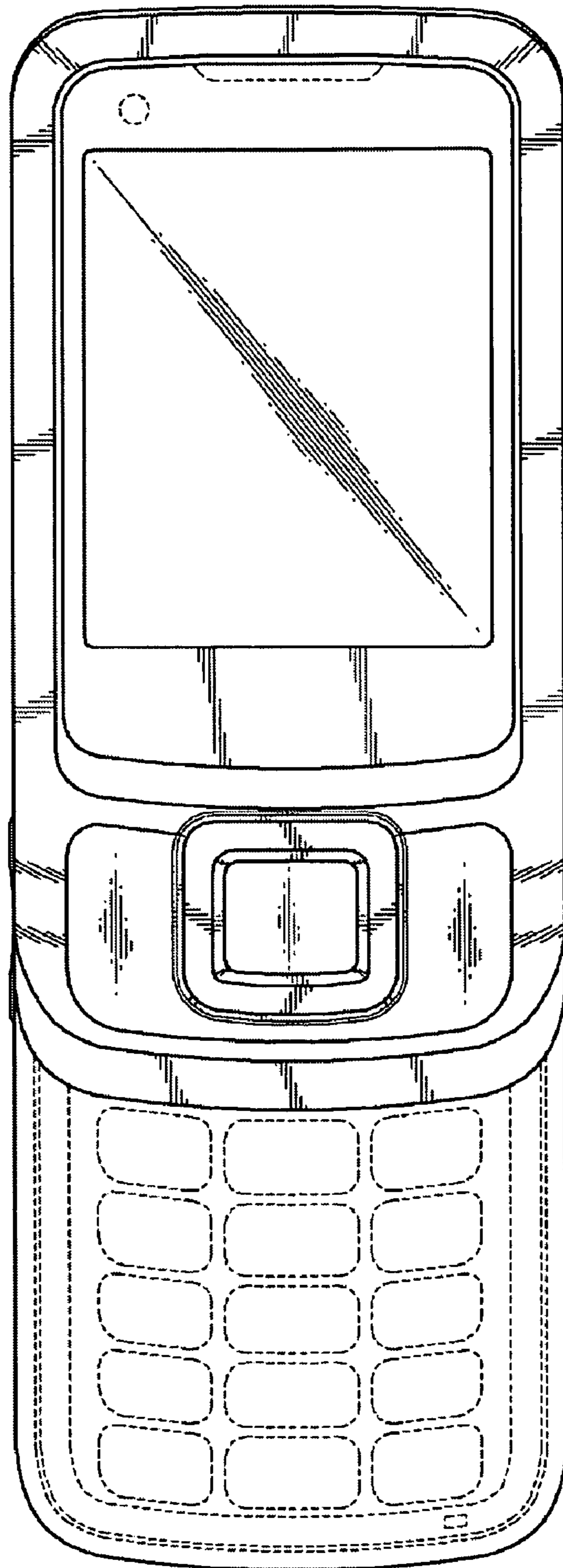
