The ornamental design for a mobile telephone, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side and bottom perspective view of a mobile telephone showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 10 is a rear elevational view thereof;

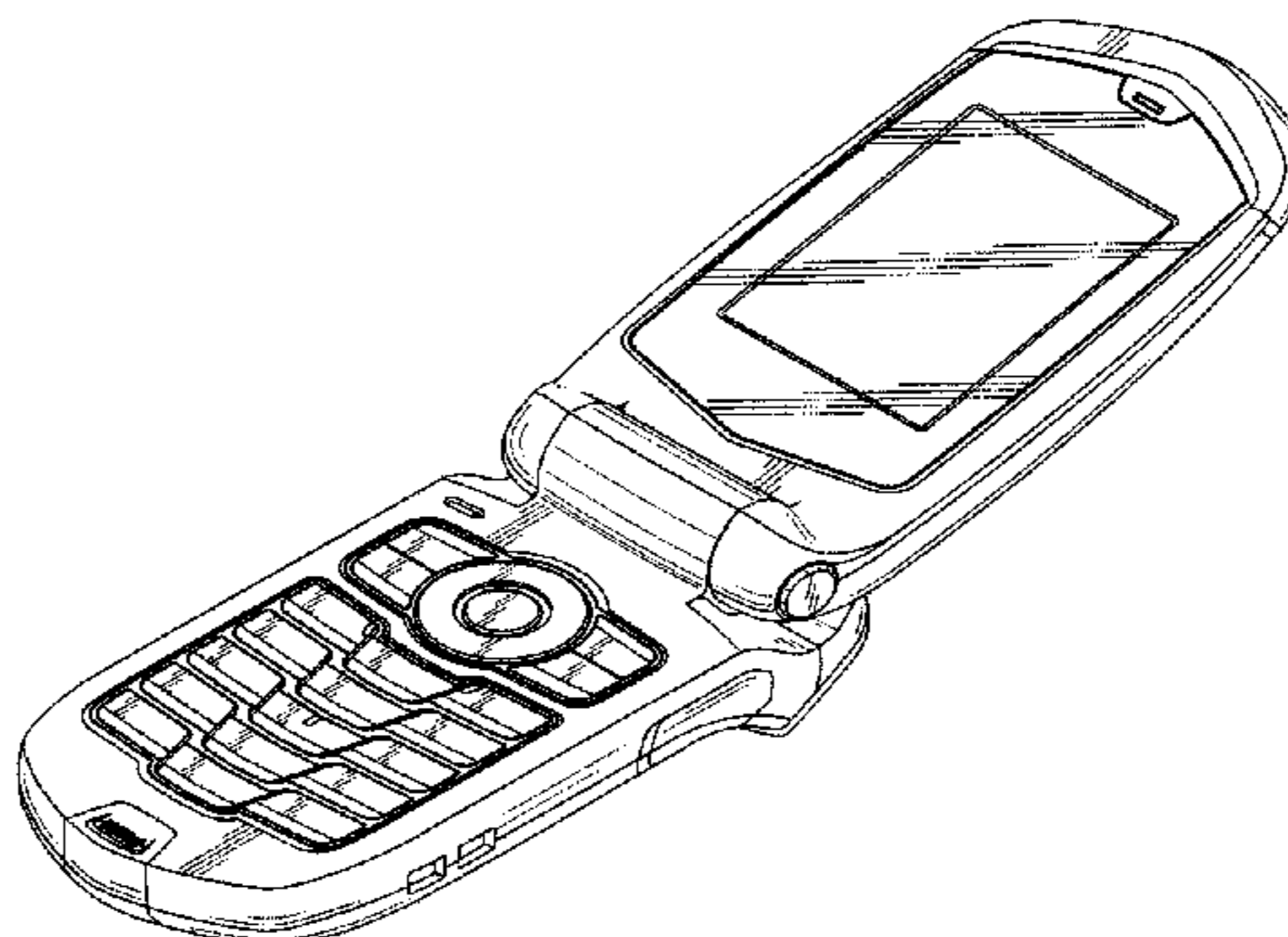
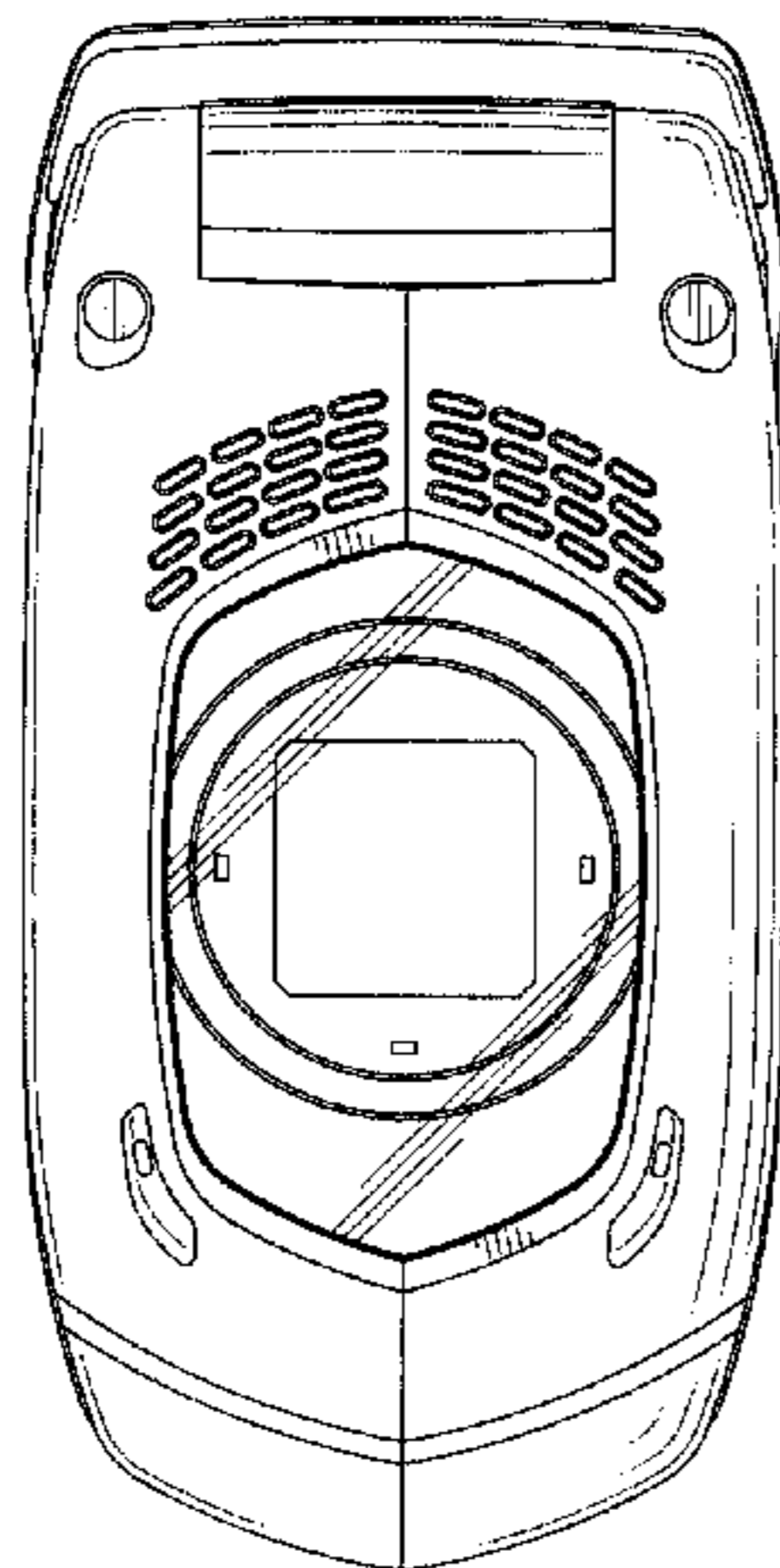
FIG. 11 is a left side view thereof;

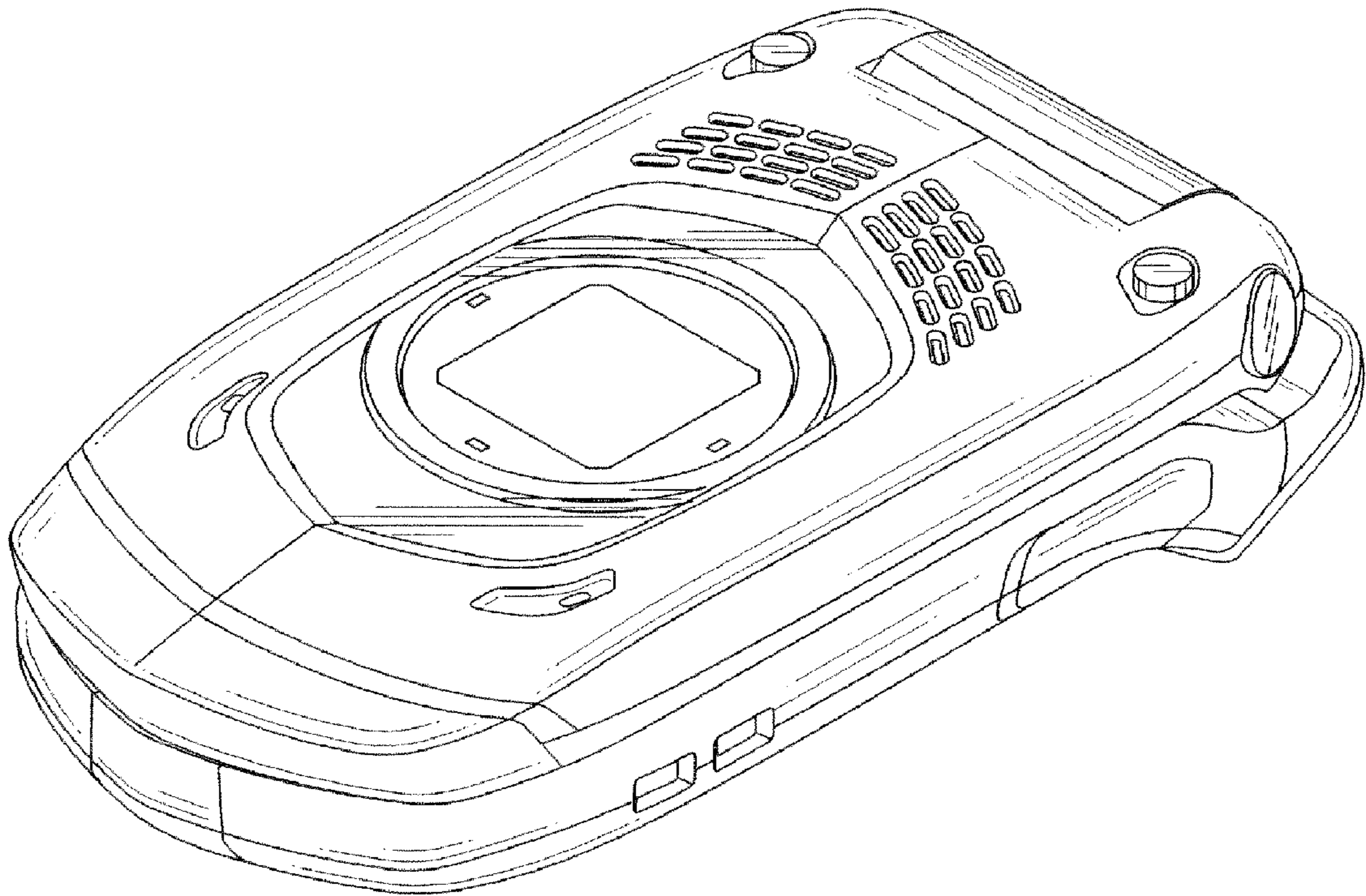

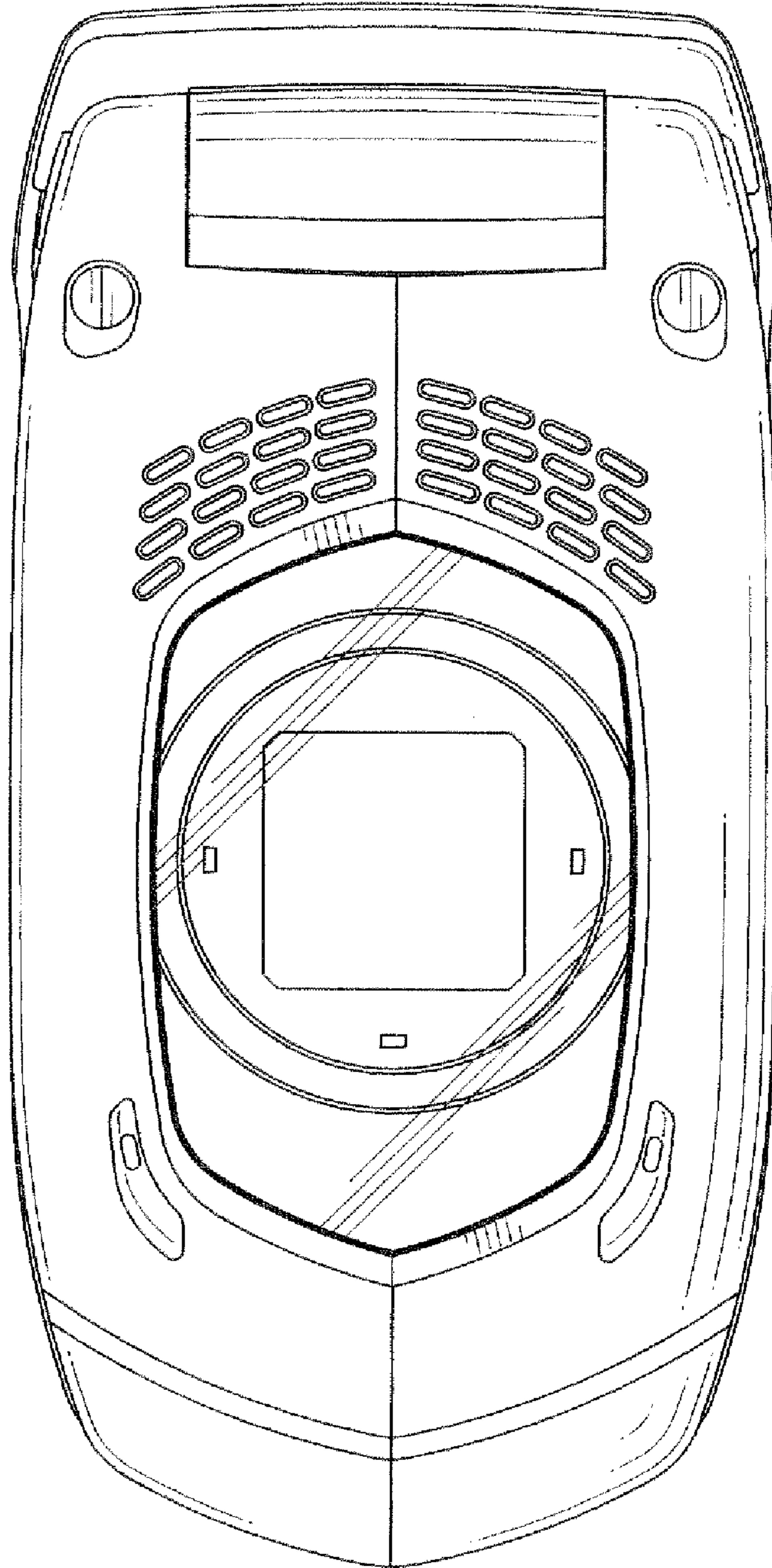

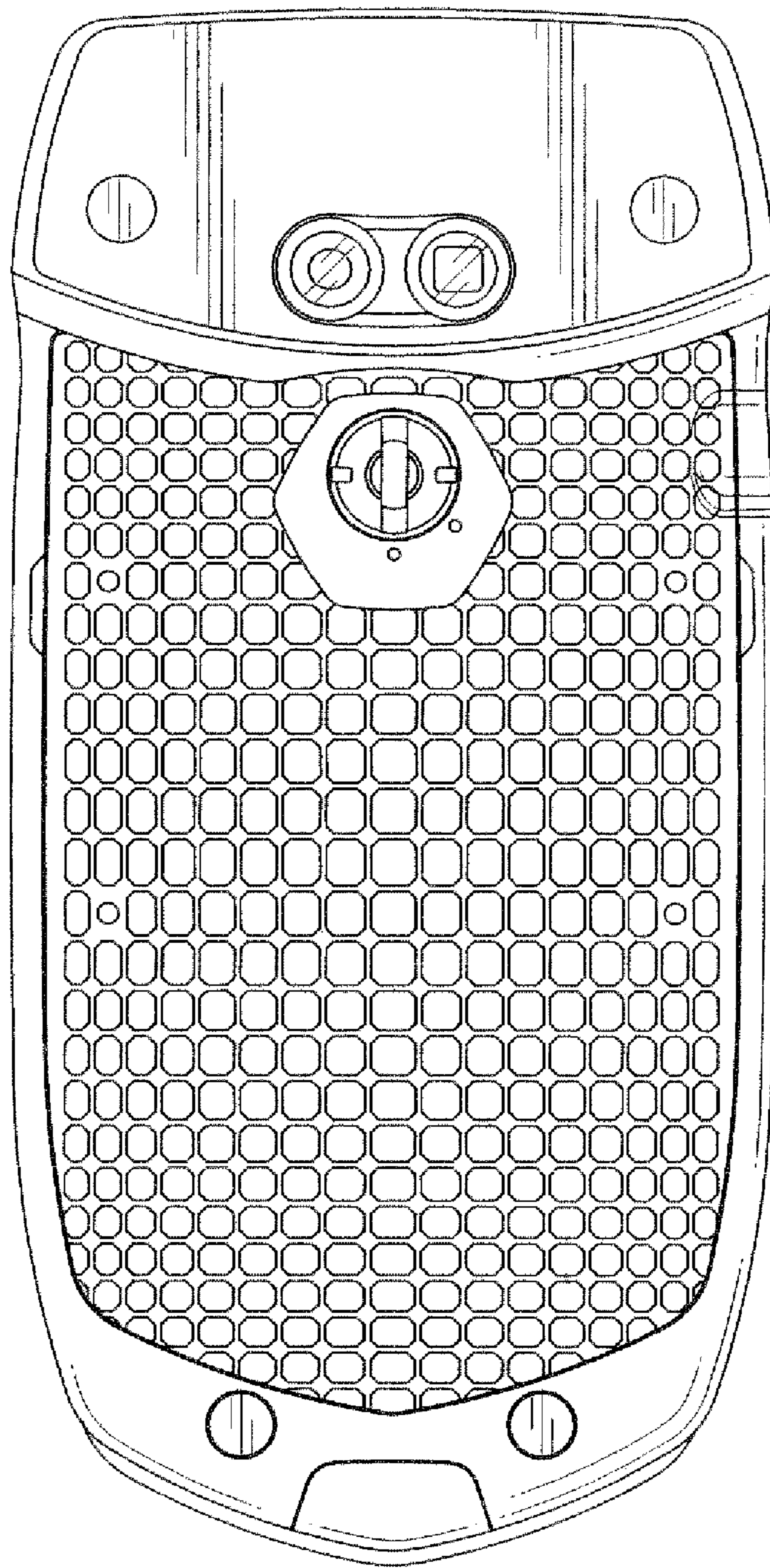

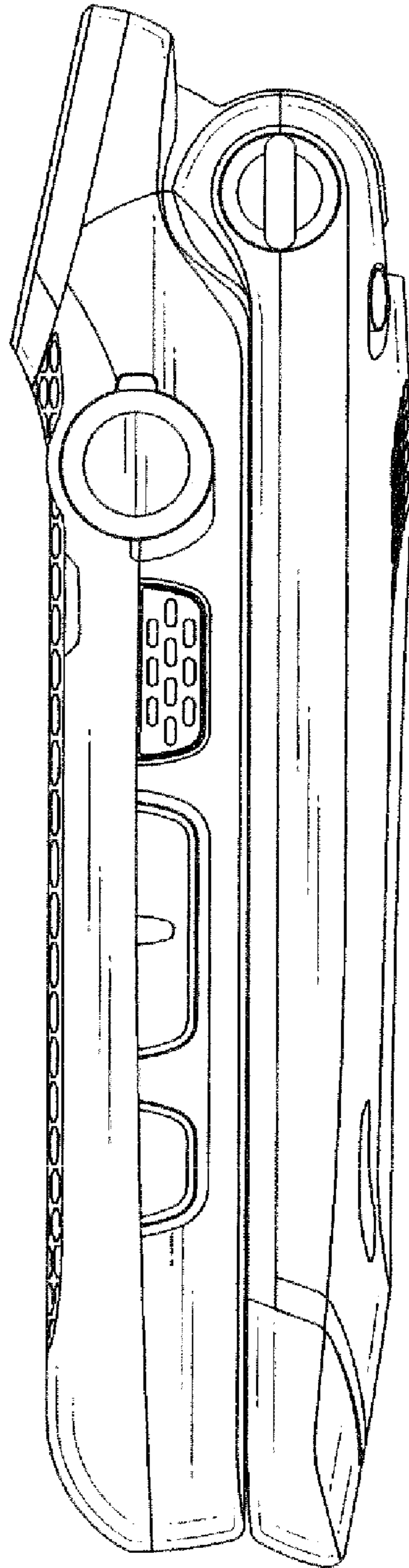

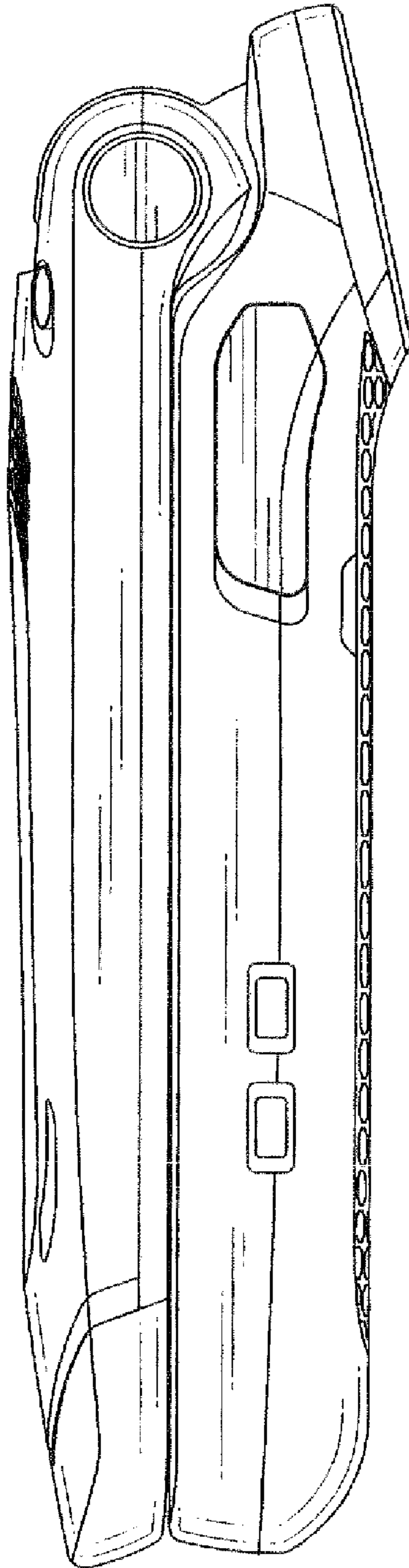

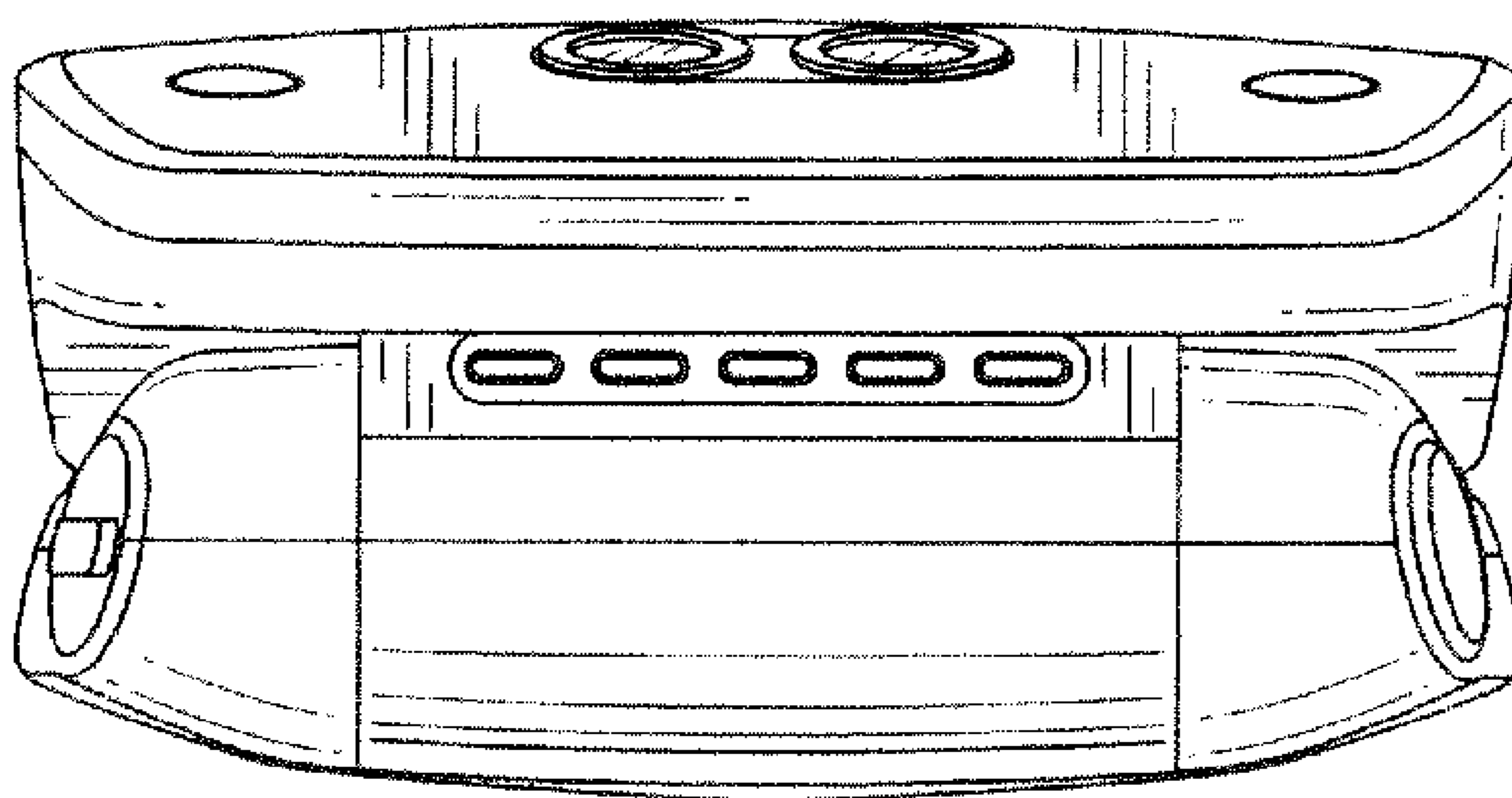

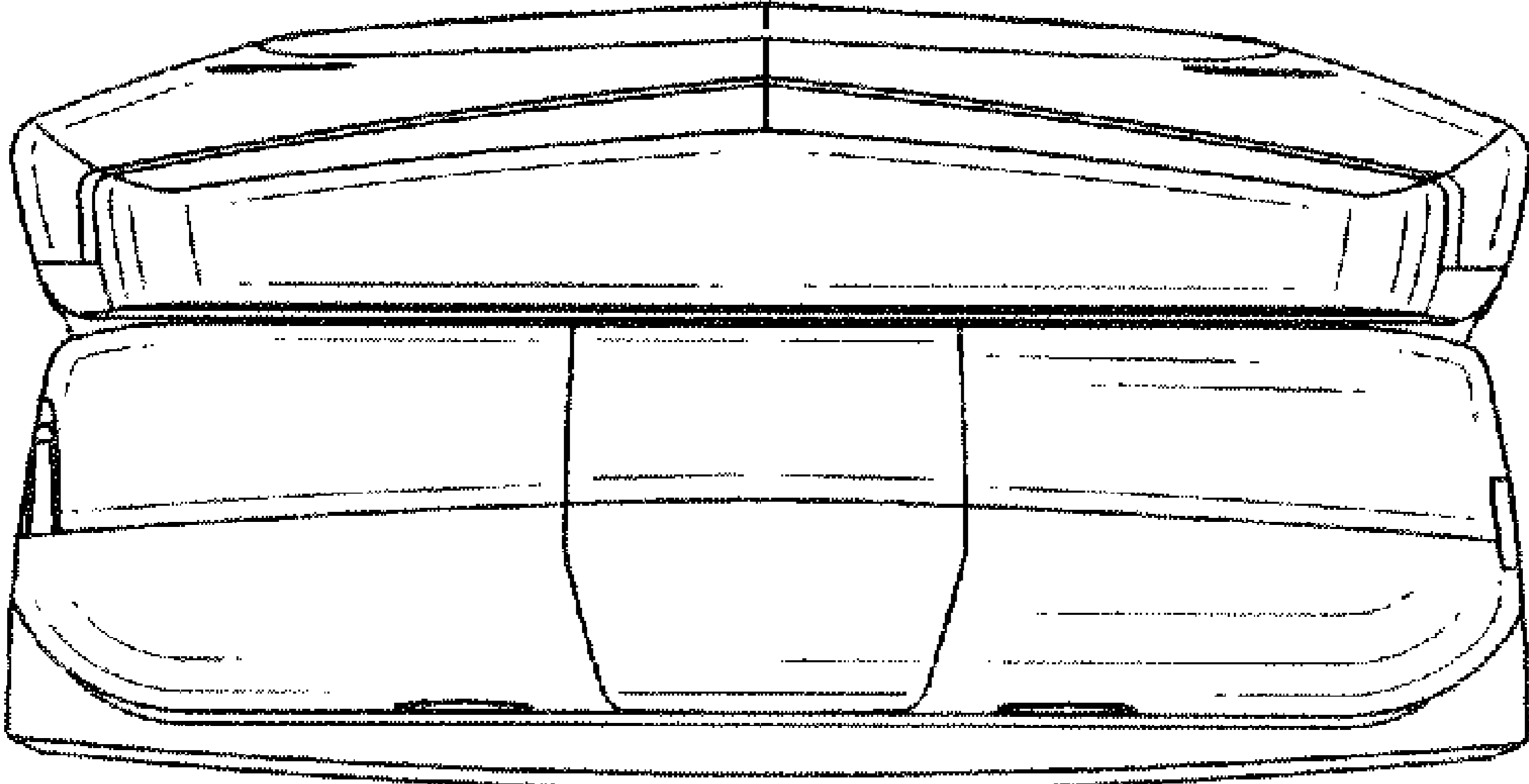

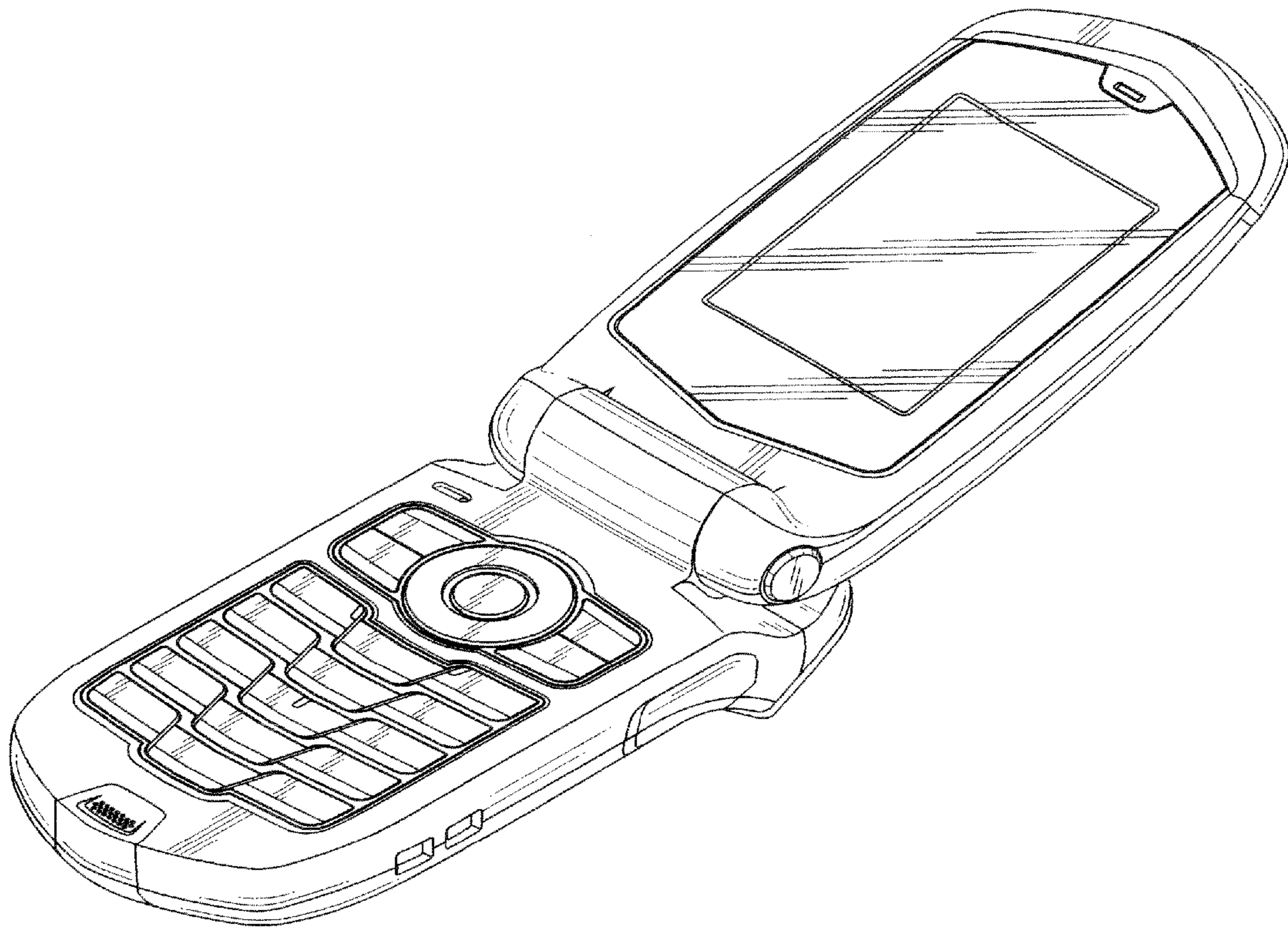

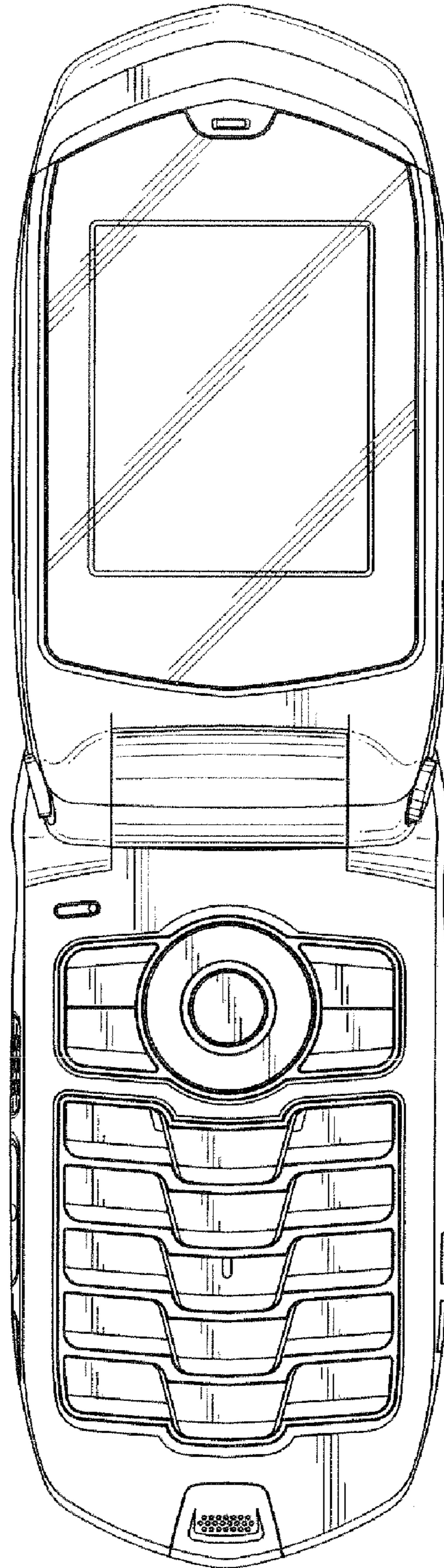

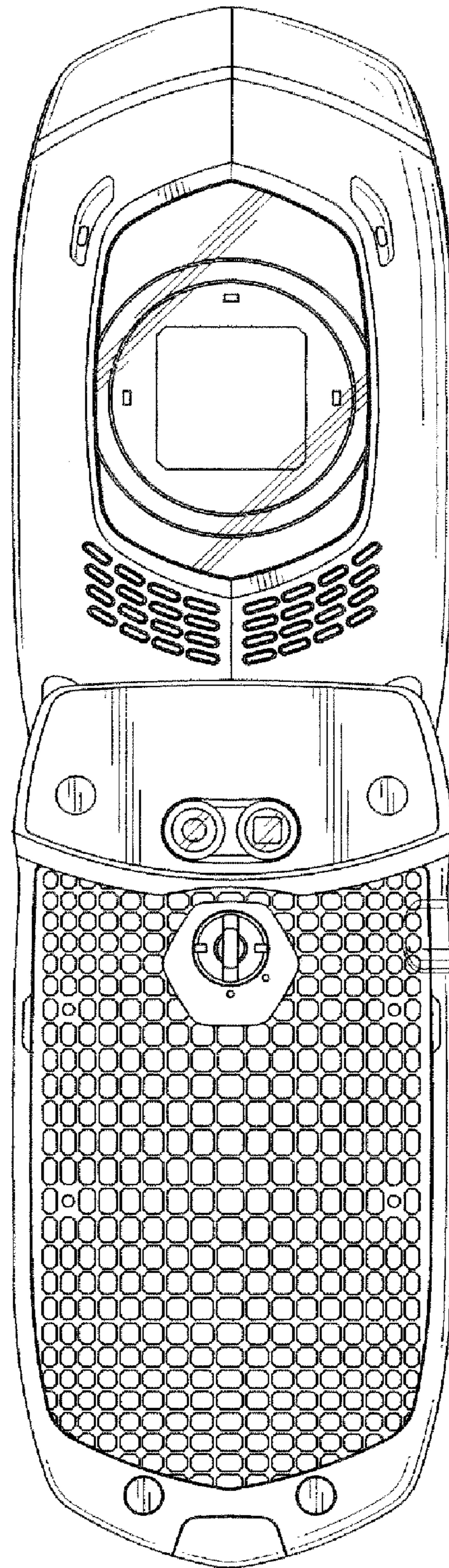

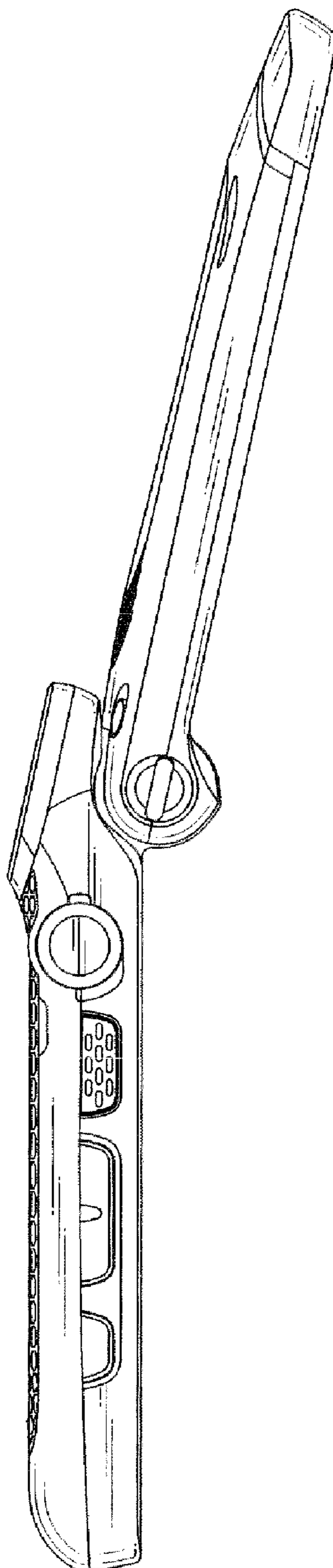

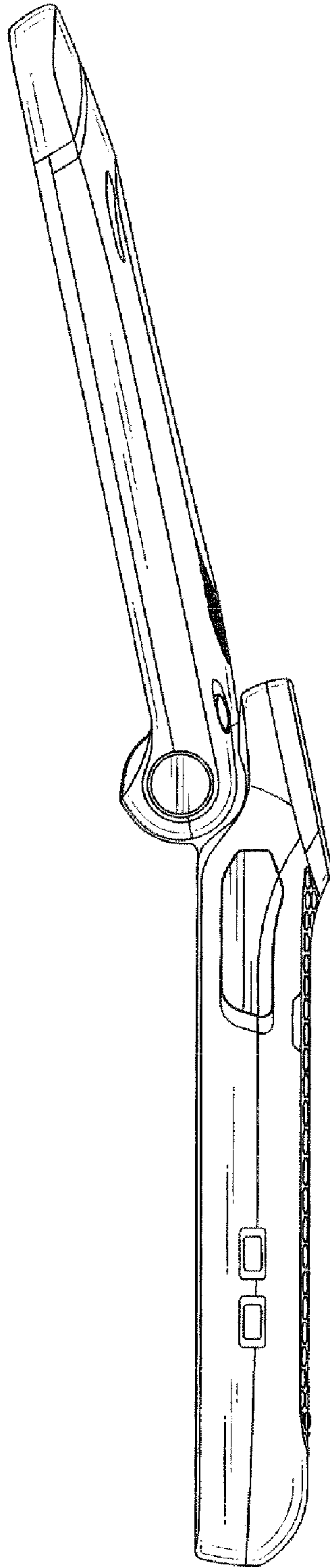

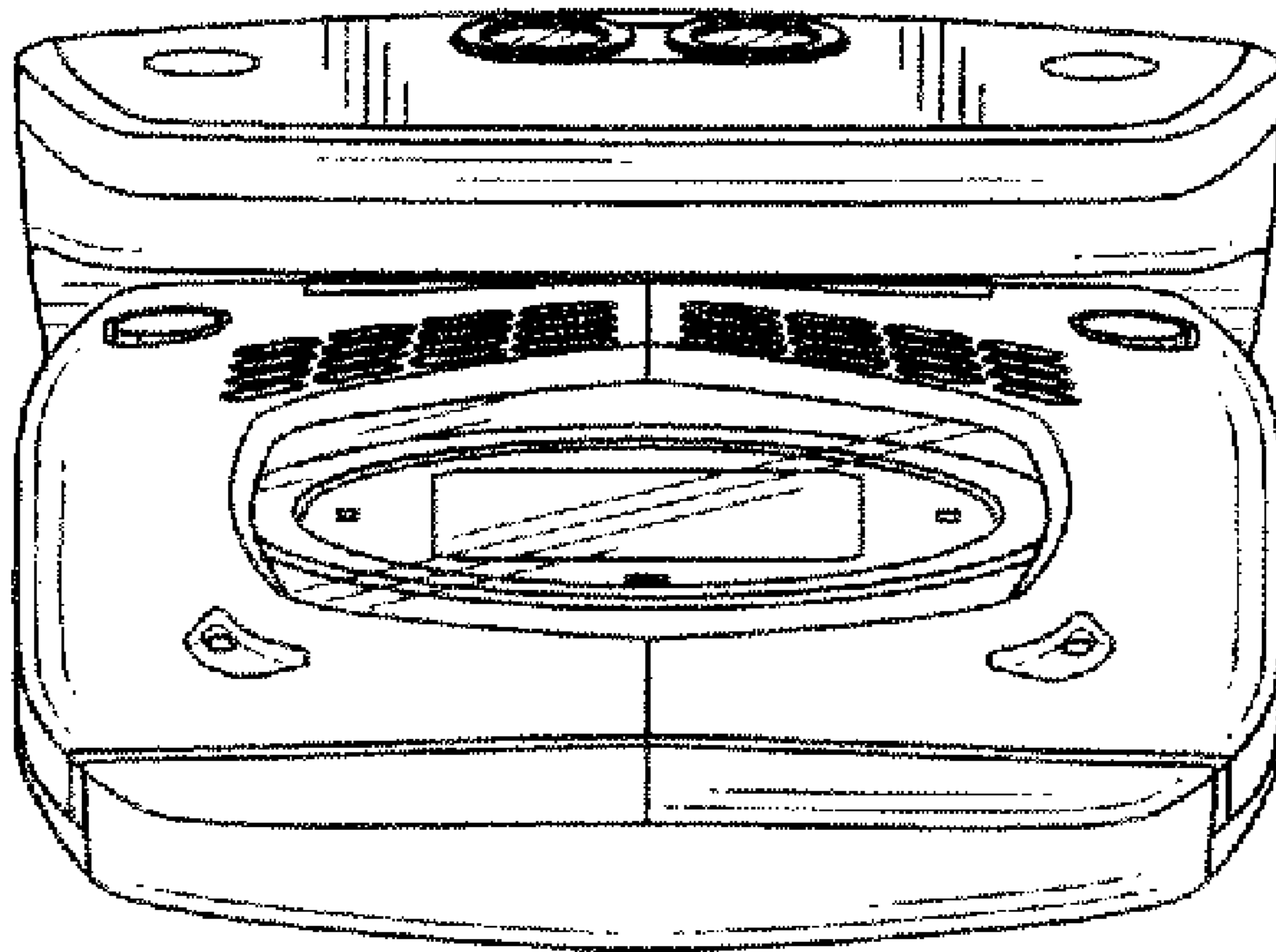

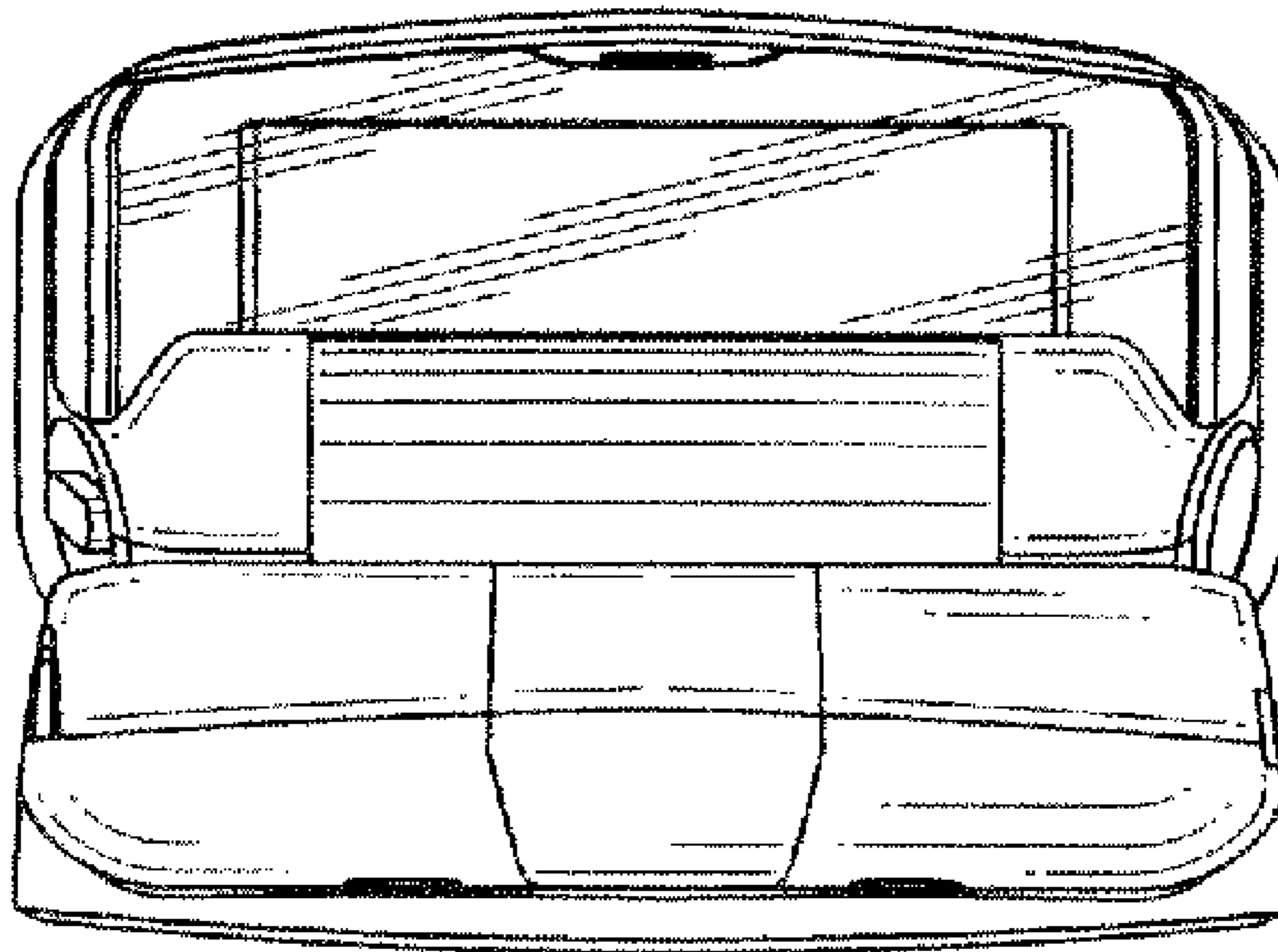
