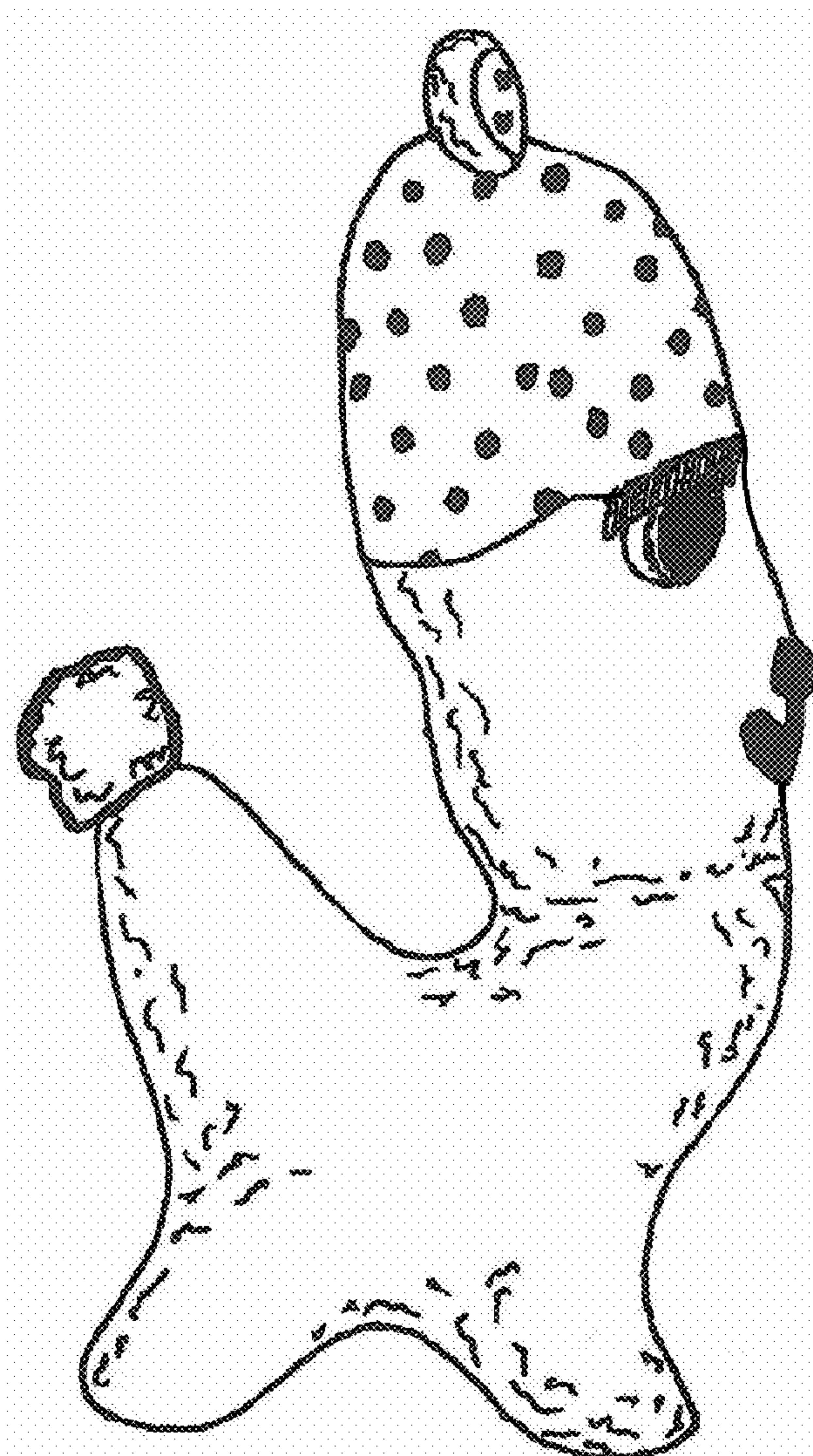
DESCRIPTION

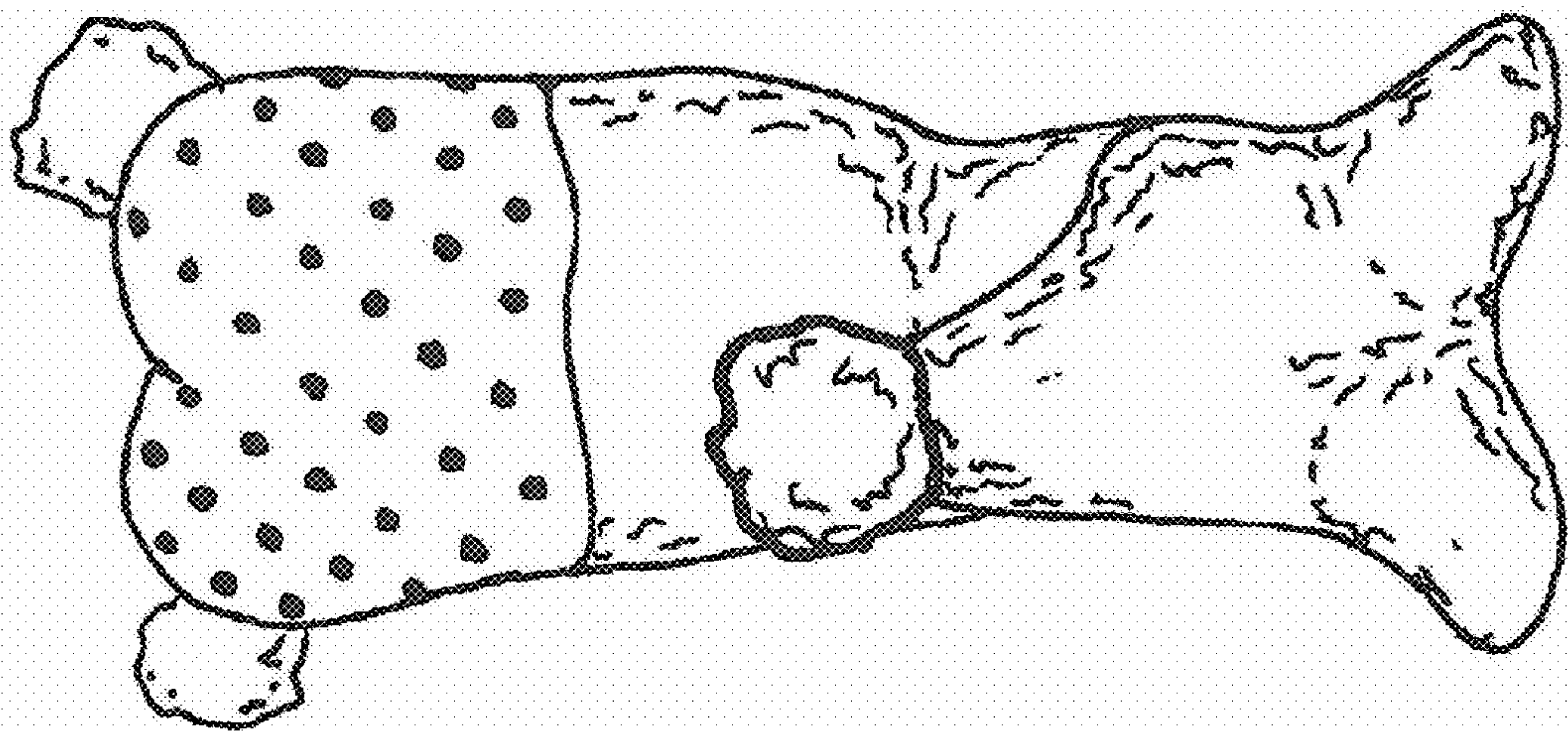

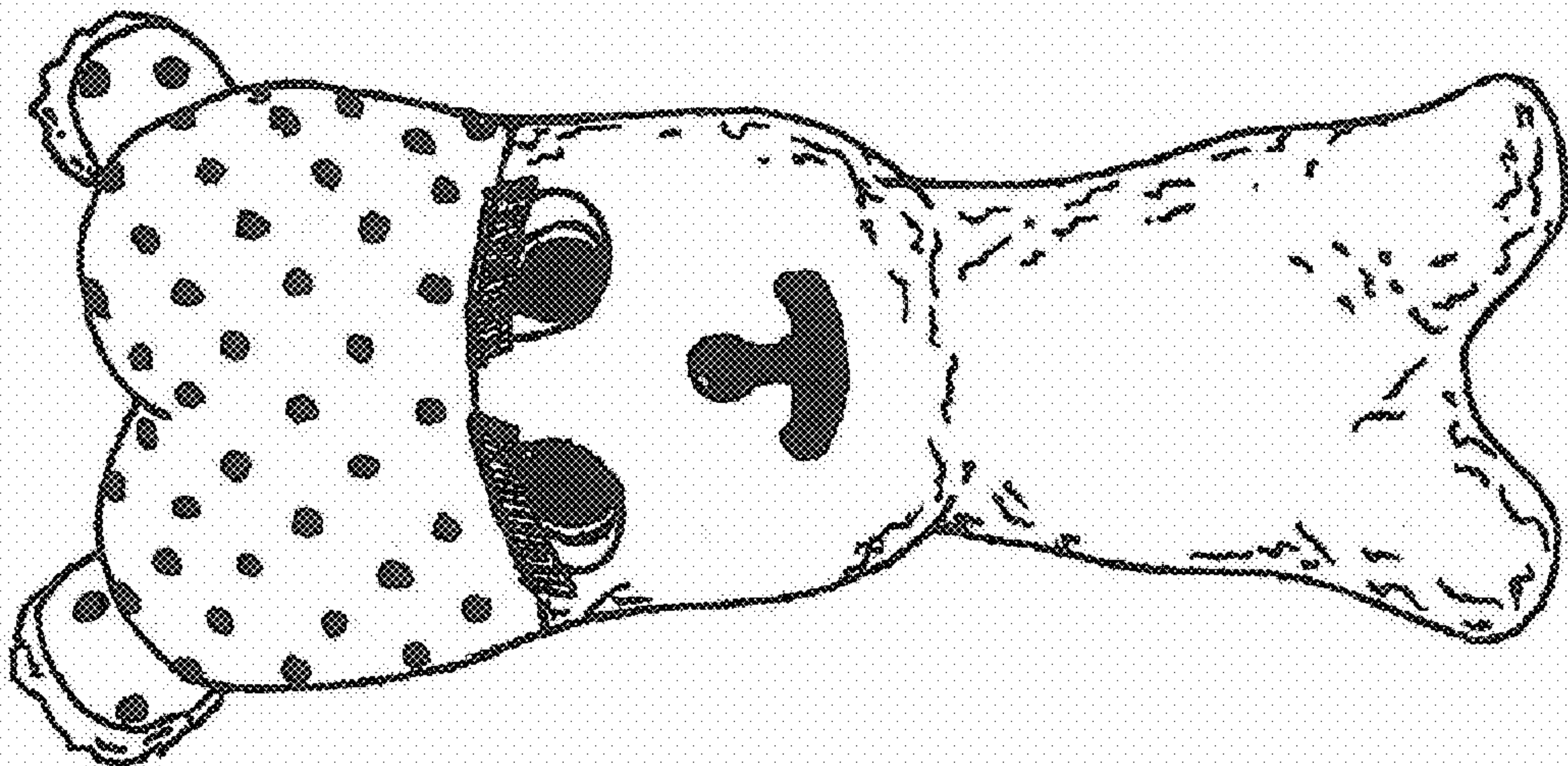

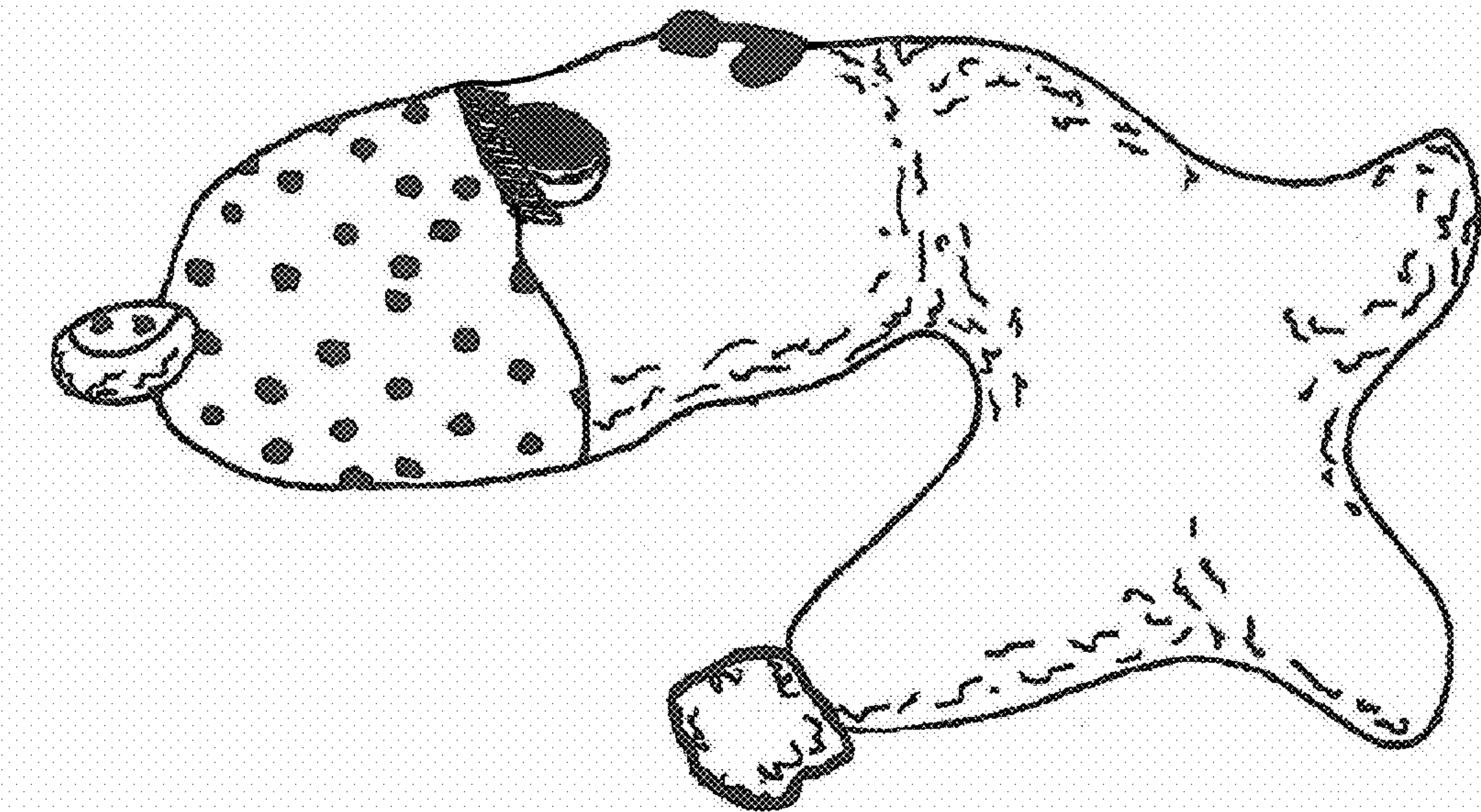

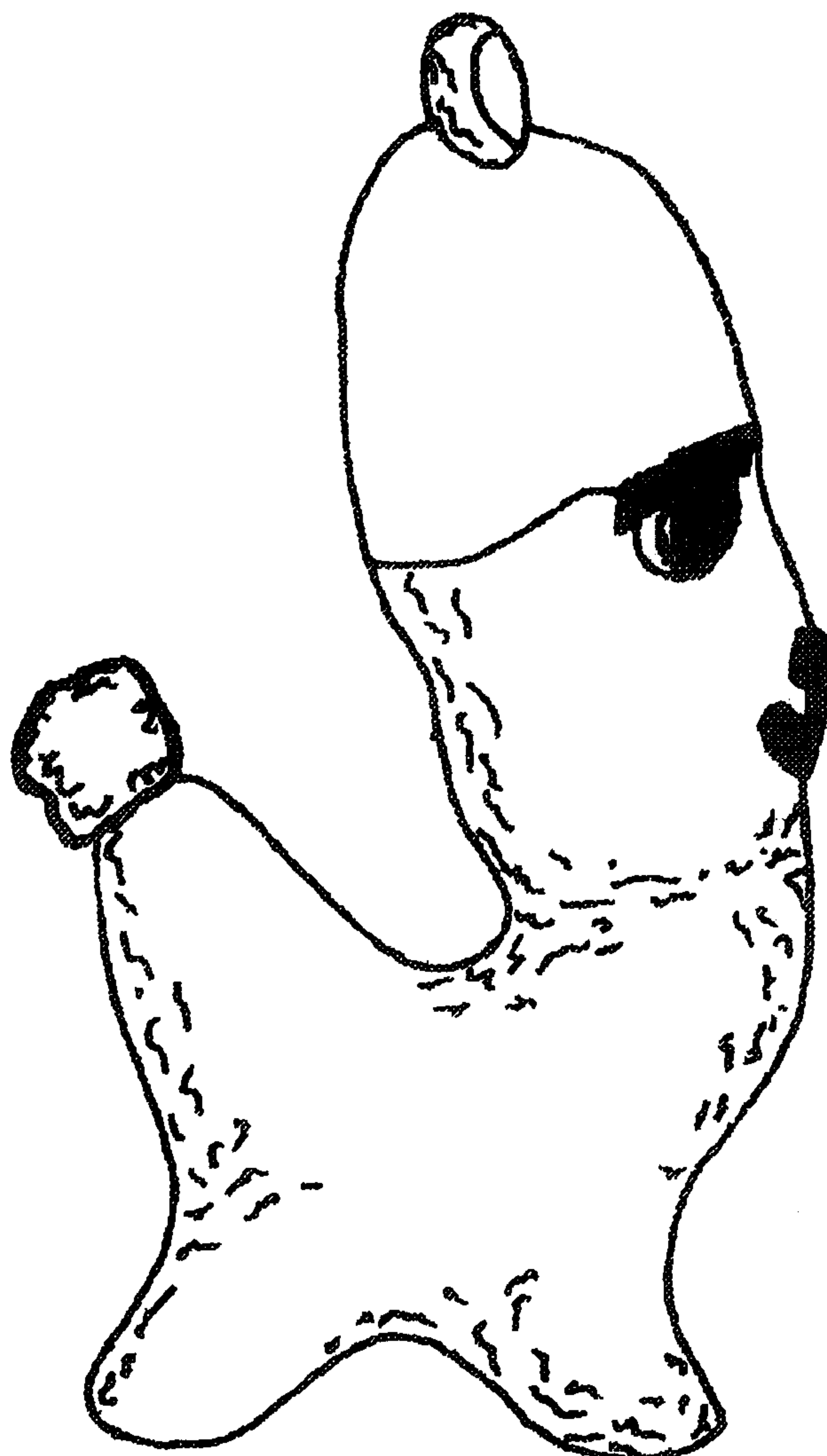

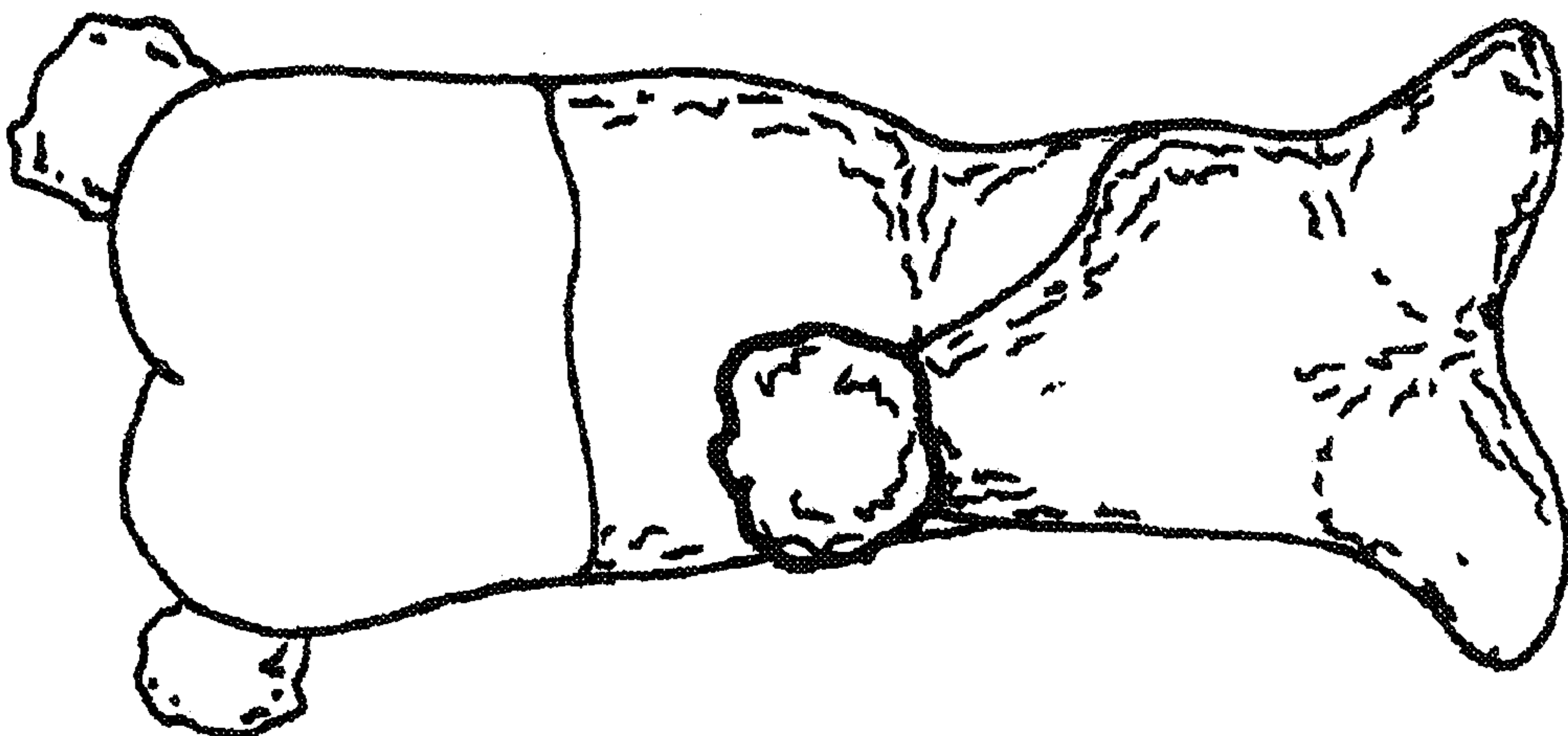

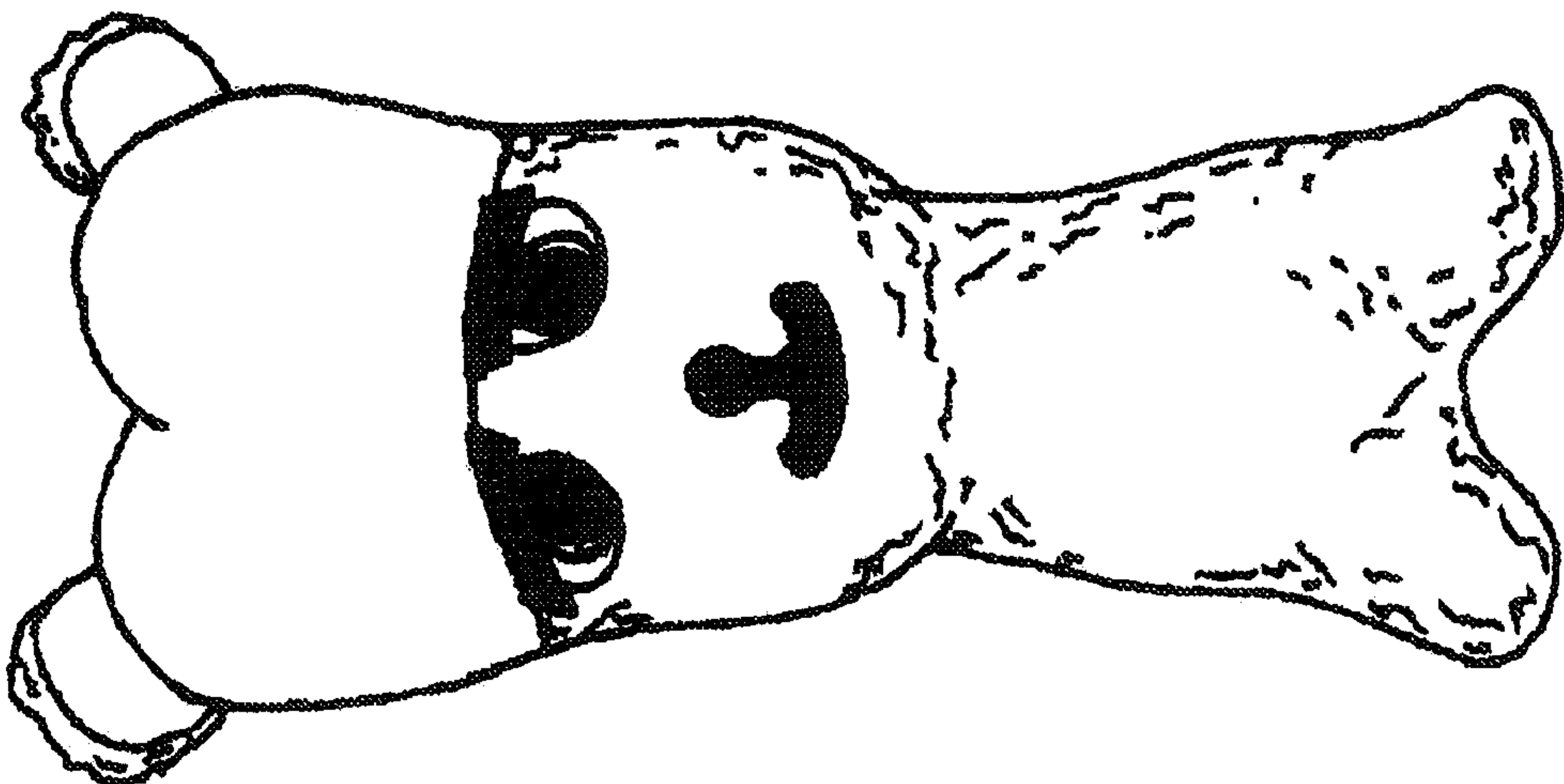

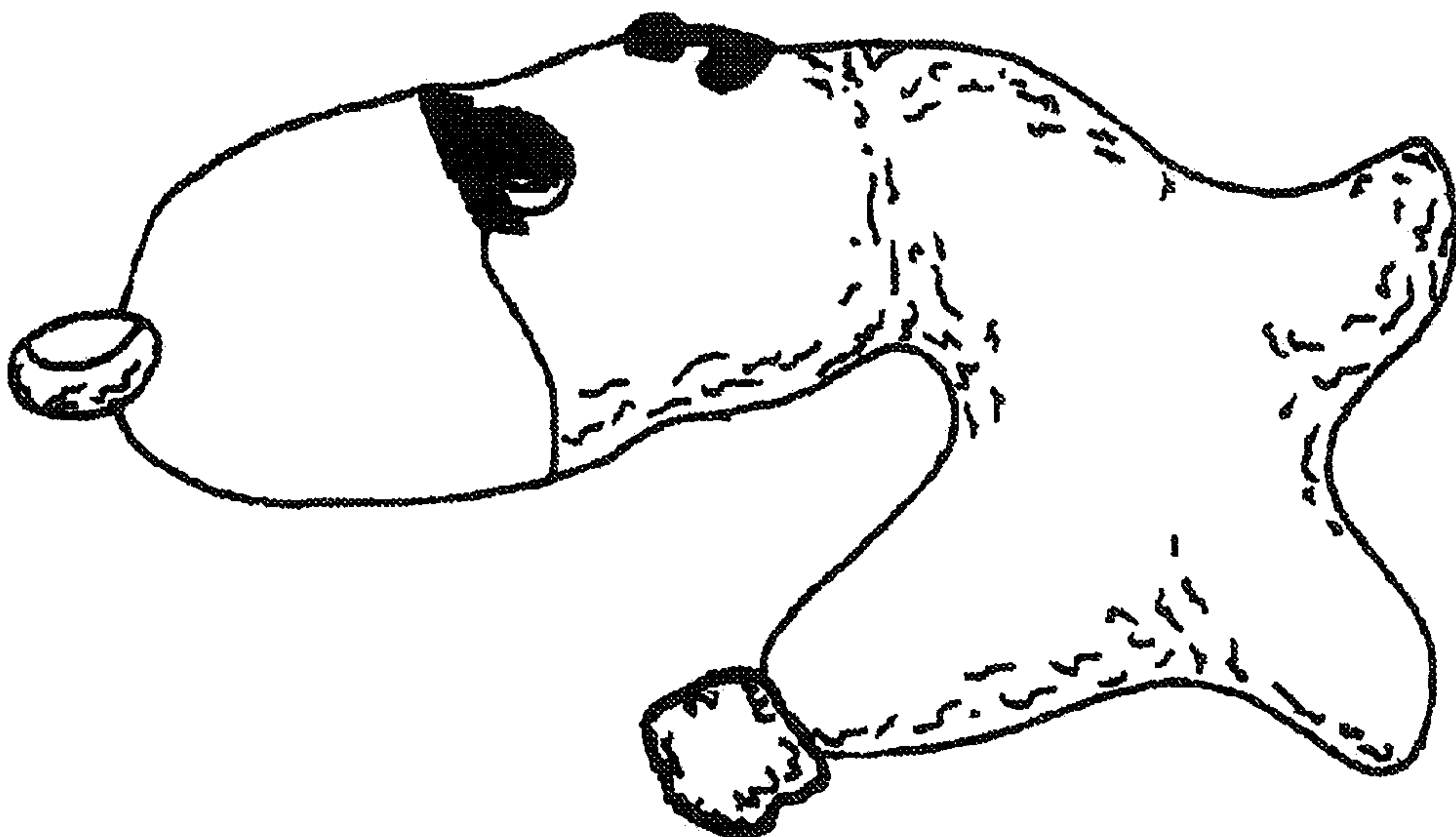
