(57) **CLAIM**

I claim the ornamental design for a split-face block, as shown and described.

DESCRIPTION

FIG. 1 is an elevation view of the front of a split-face block of the present invention.

FIG. 2 is an elevation view of the back of the block shown in FIG. 1.

FIG. 3 is a plan view of the top of the block shown in FIG. 1, the bottom plan view being a mirror image thereof.

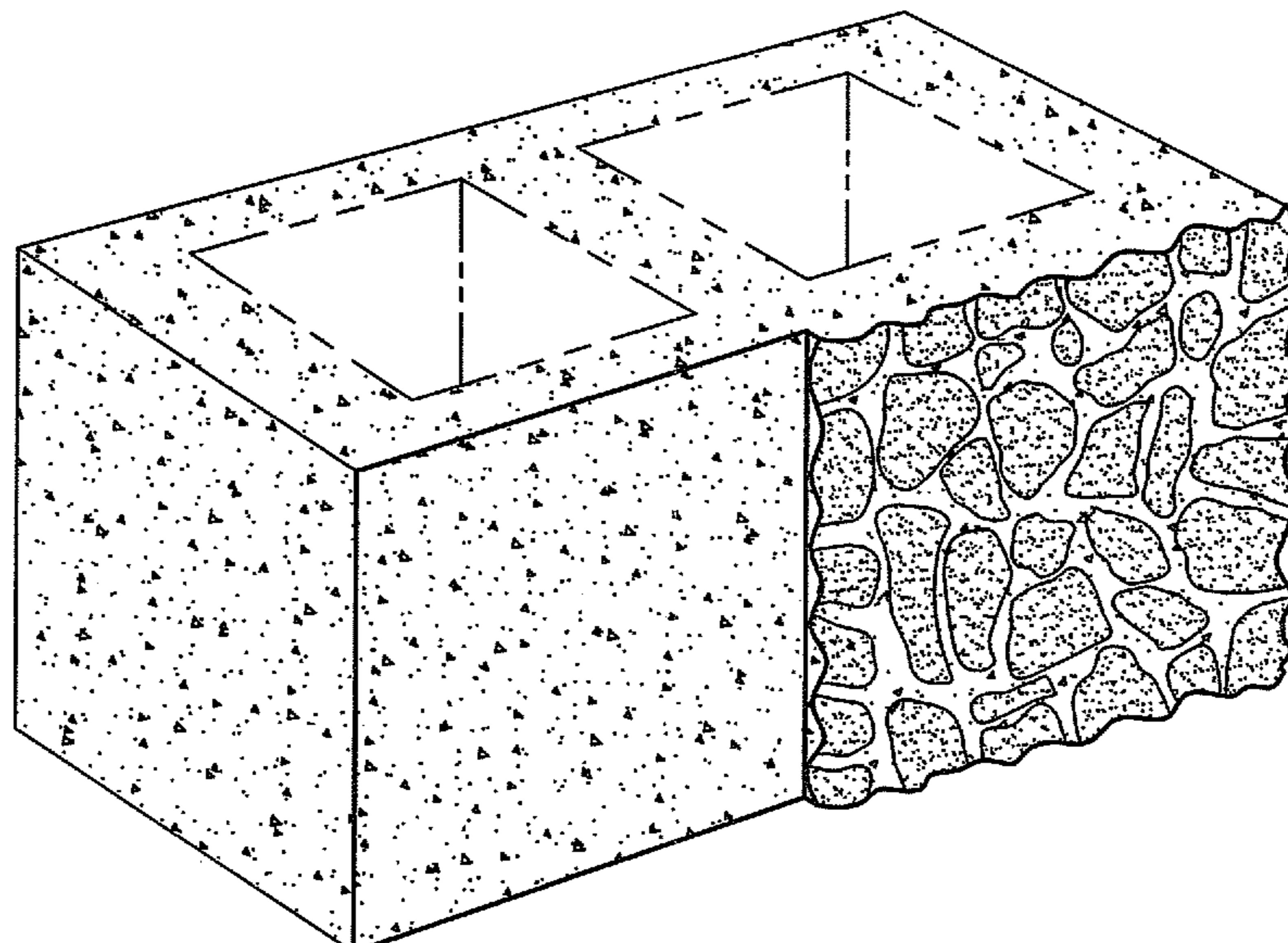
FIG. 4 is an elevation view of the right side of the block shown in FIG. 1.

FIG. 5 is an elevation view of the left side of the block shown in FIG. 1; and,

FIG. 6 is a perspective view of the front, top and left side of the block shown in FIG. 1.

The broken lines in the drawings represent the boundaries of the claim and form no part of the claimed design.

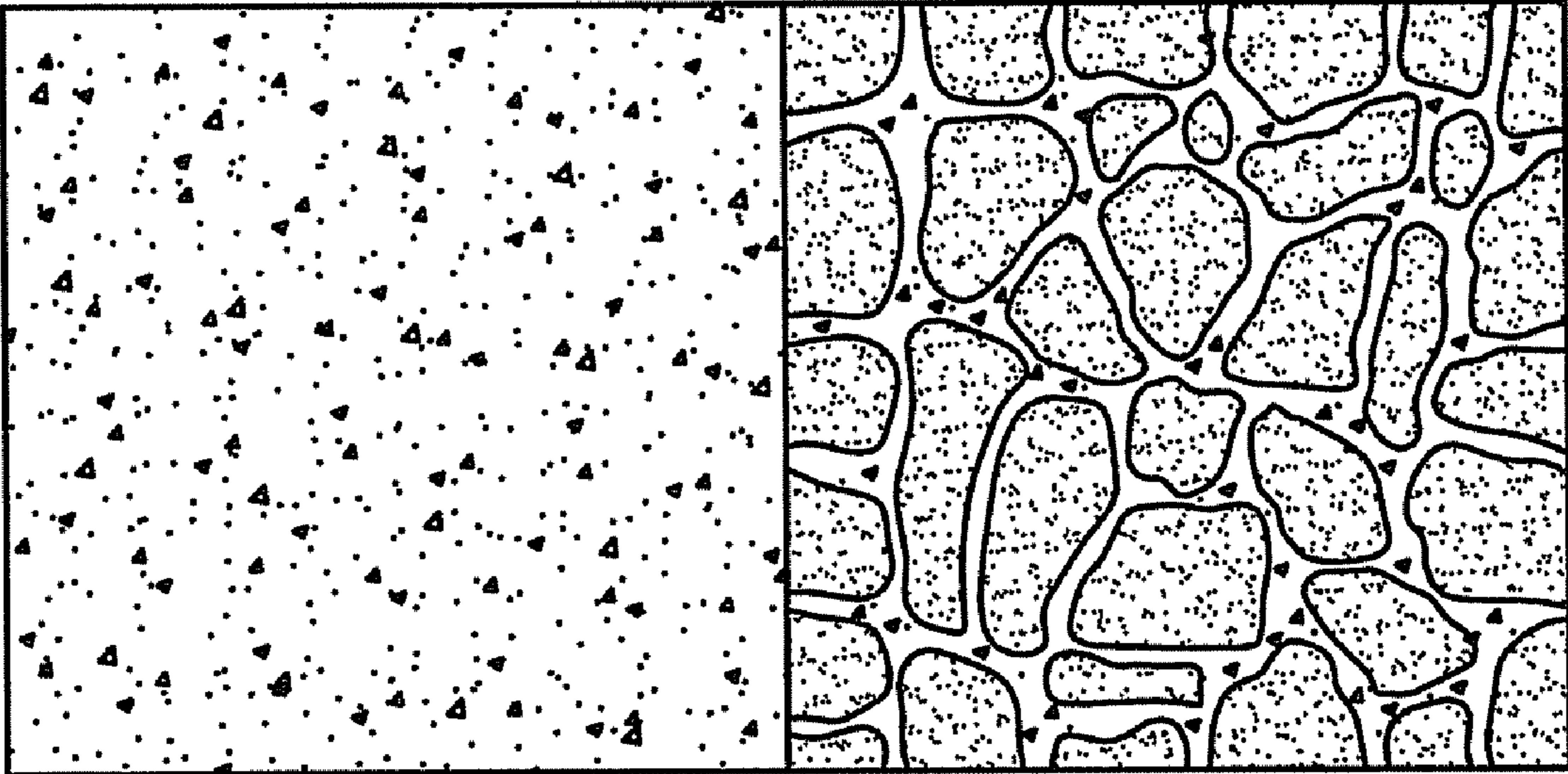

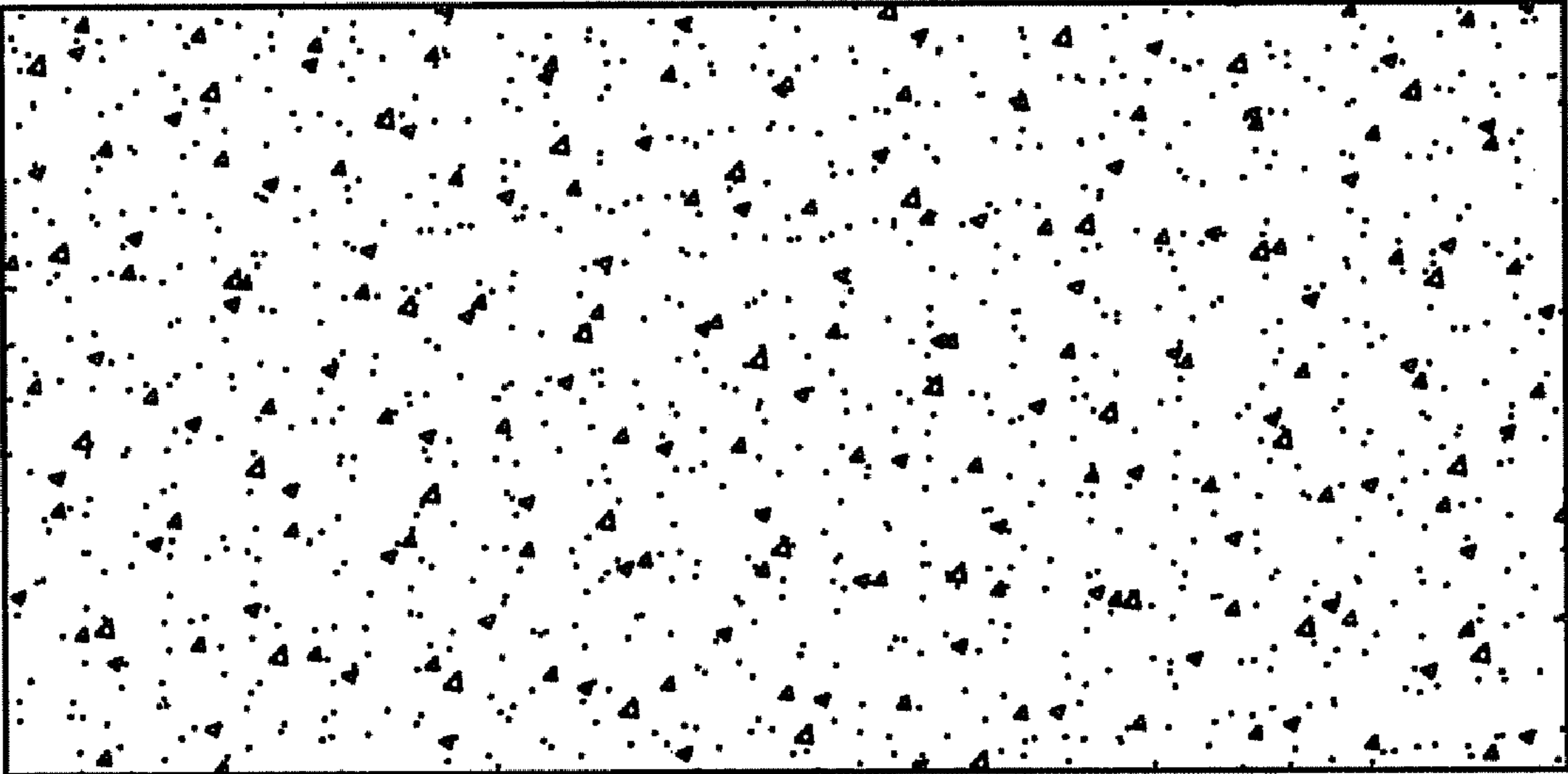

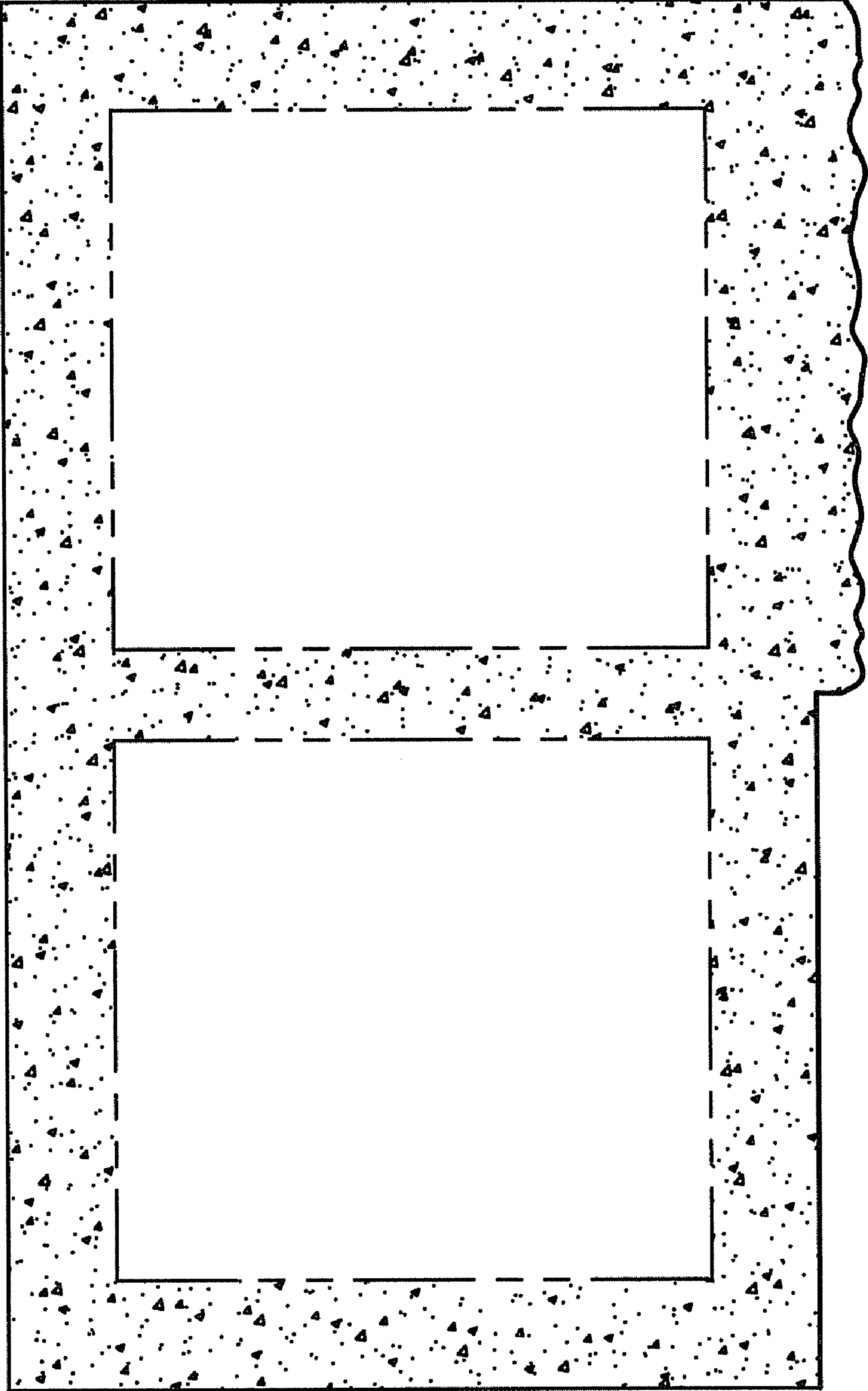

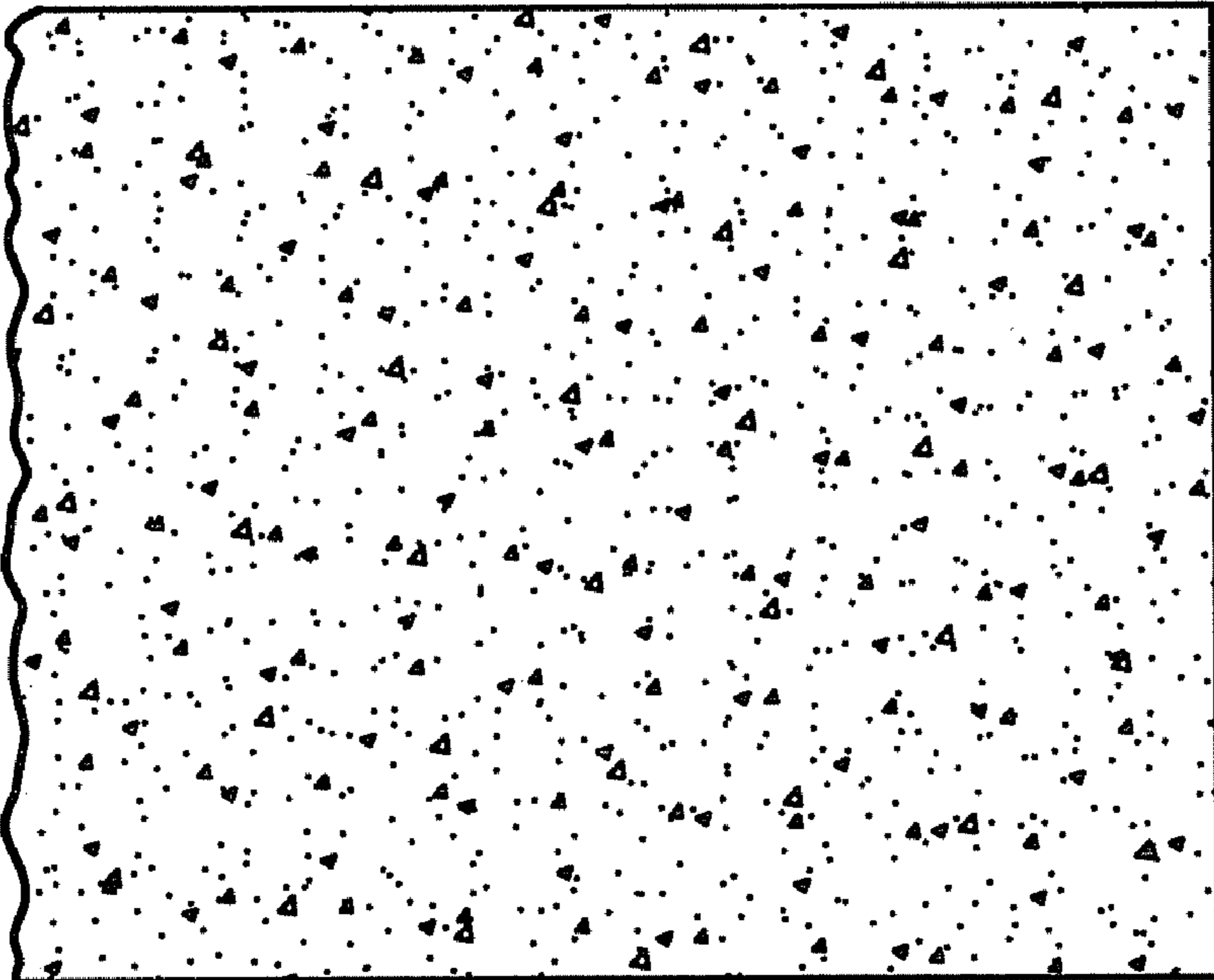

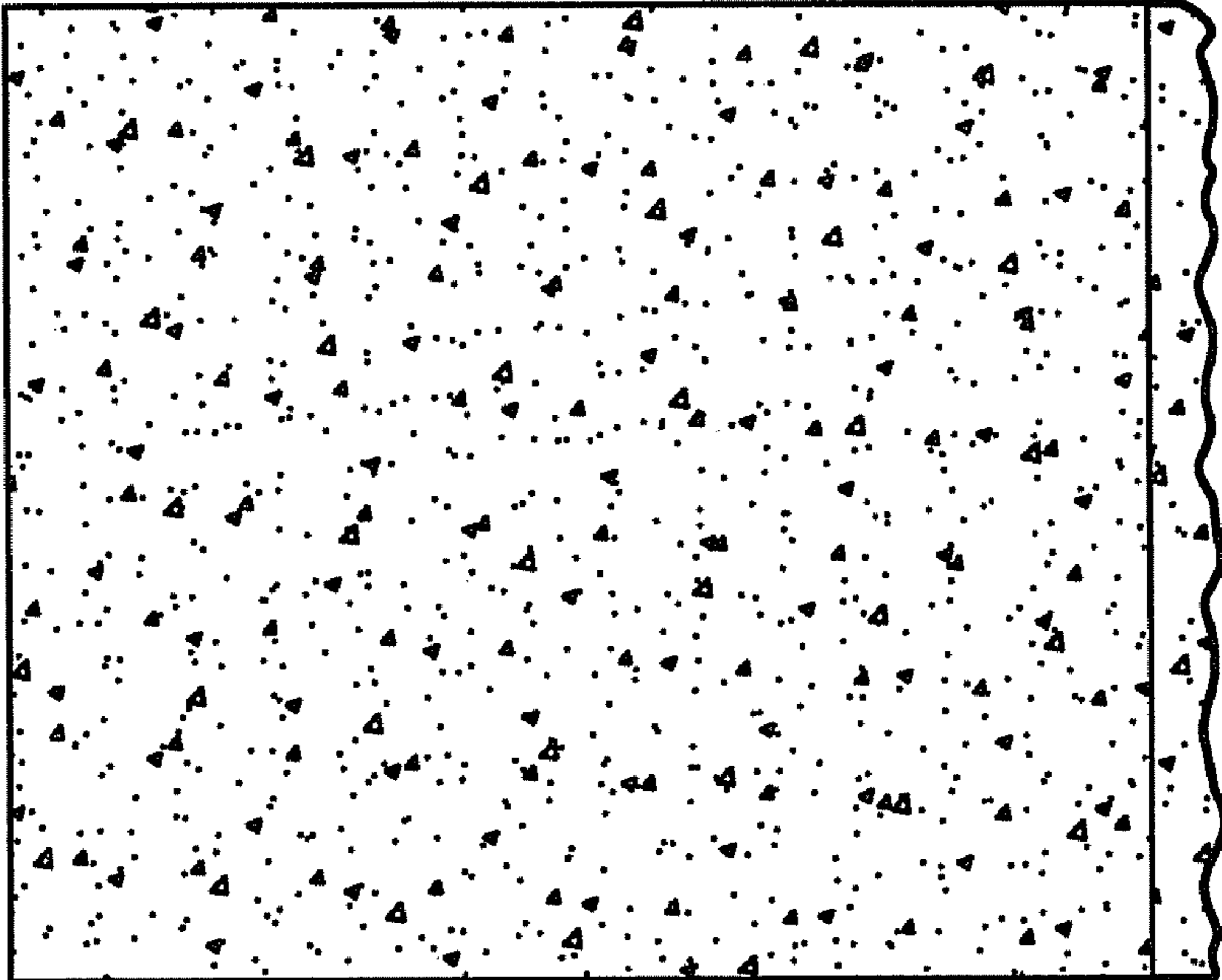

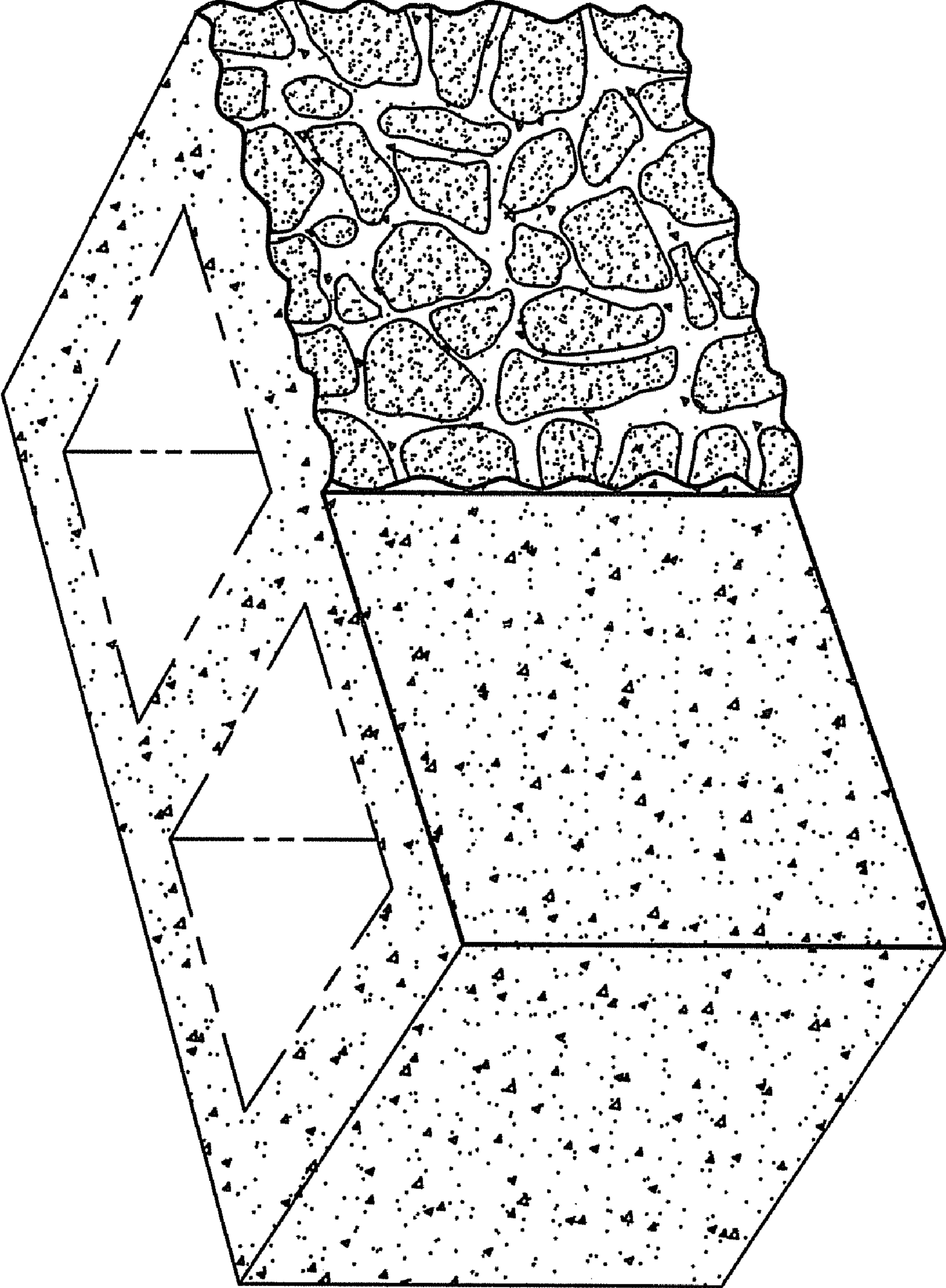
