frosting and wave design of the present invention.

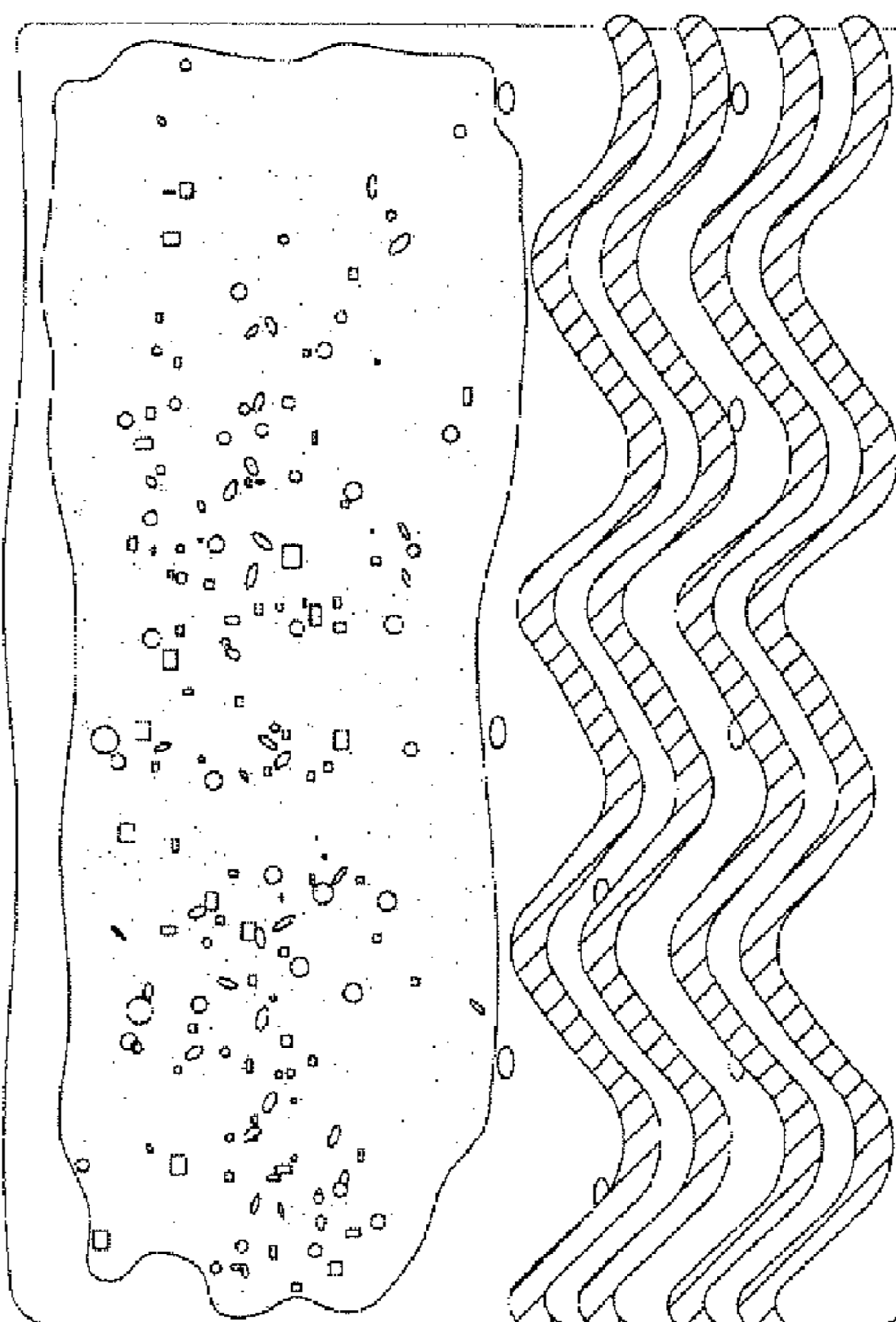
FIG. 2 is a first side view of the food product with sprinkle,

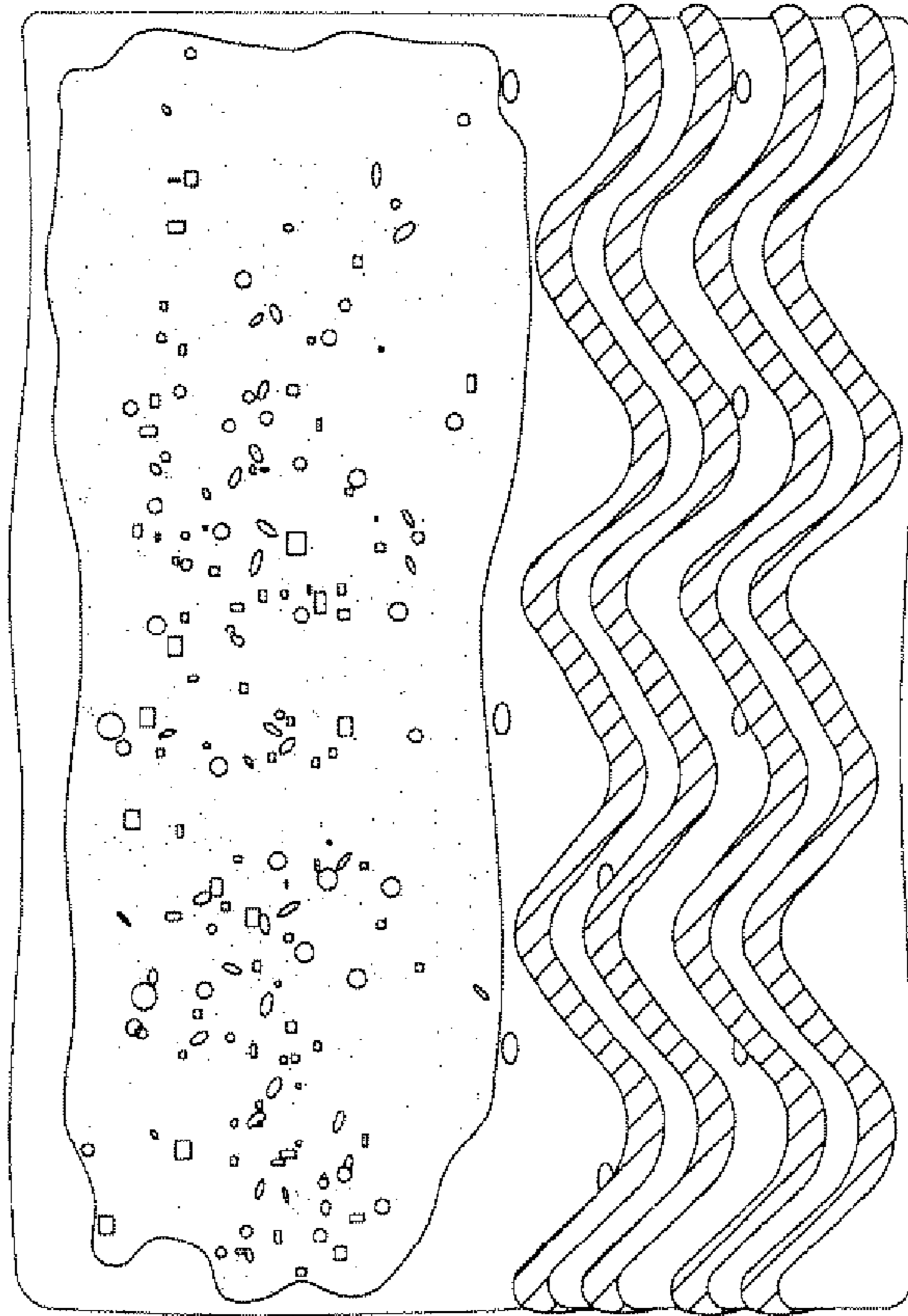

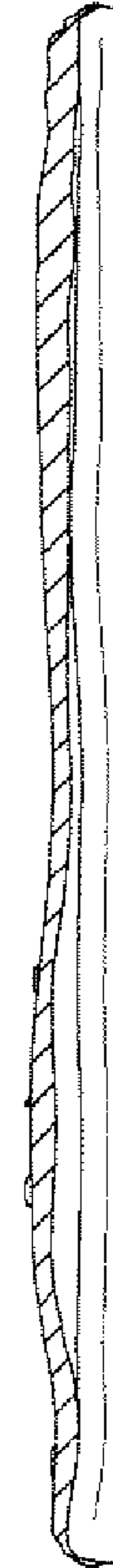

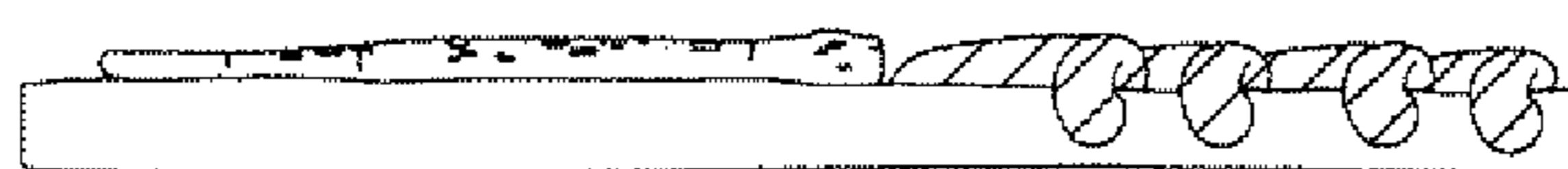
