FIG. 1; and,

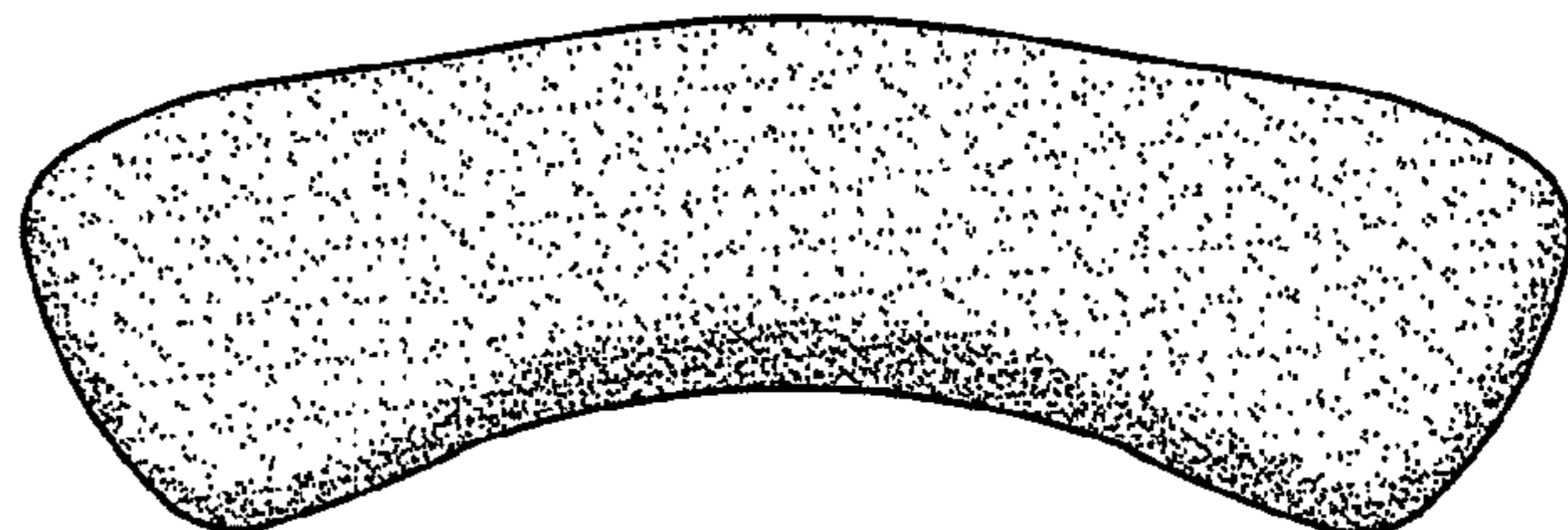
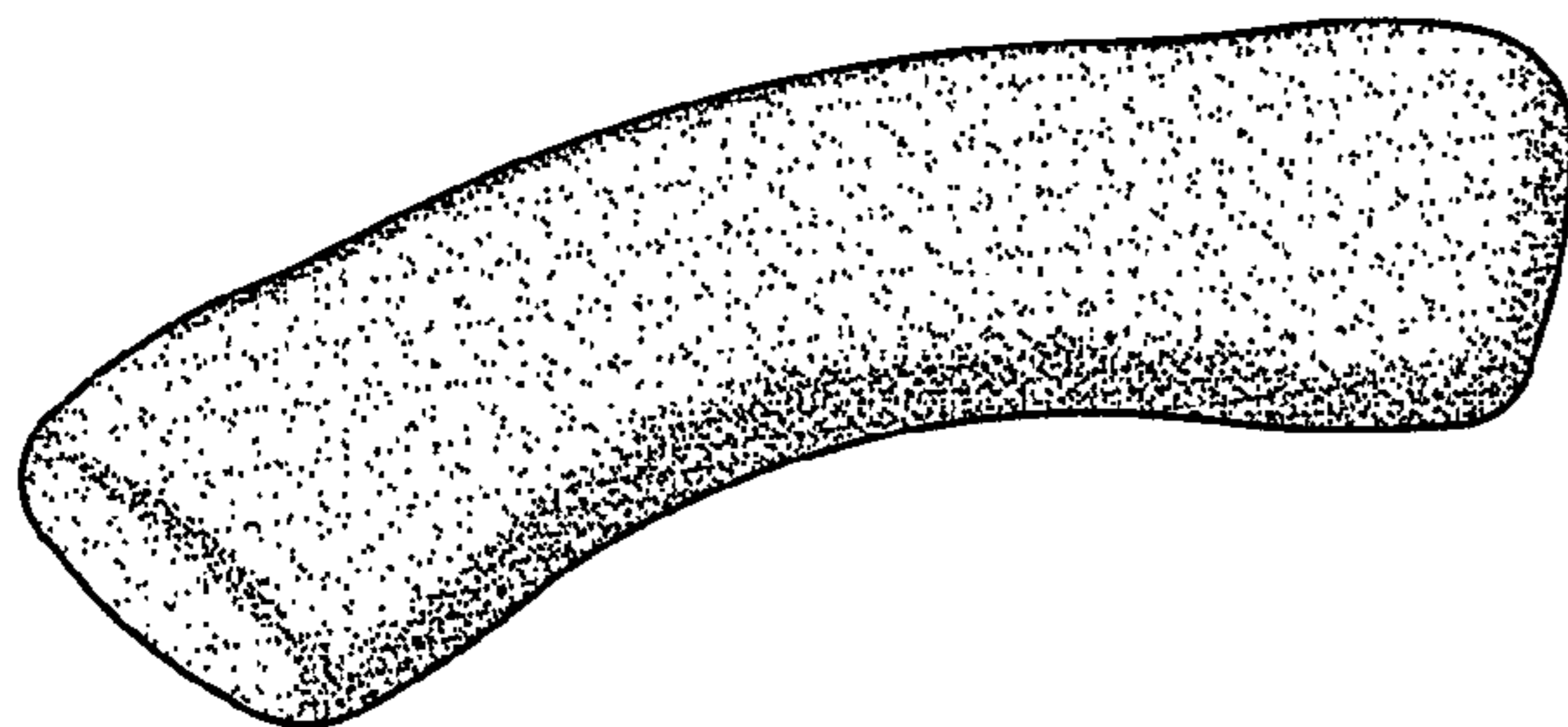
FIG. 7 is a left end elevational view of the curved cracker of

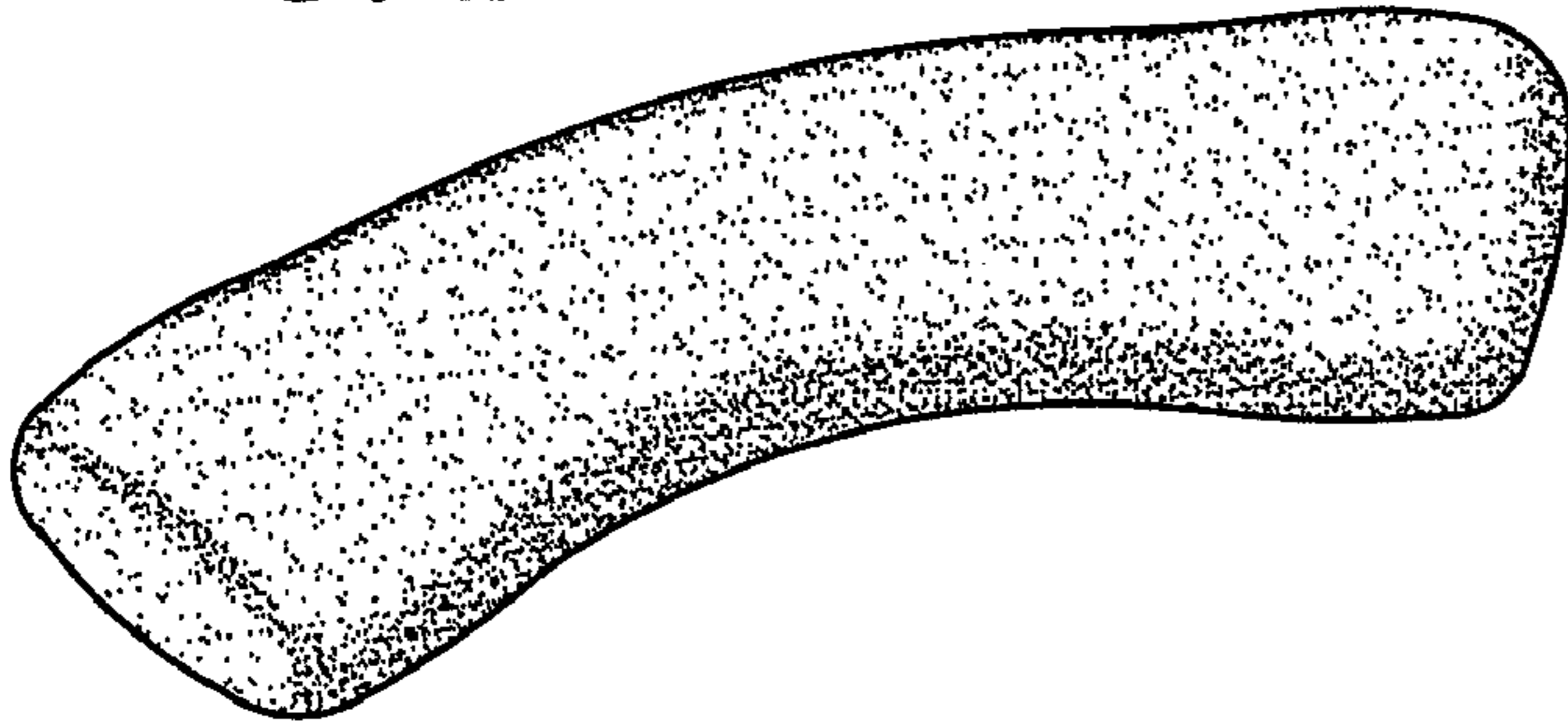

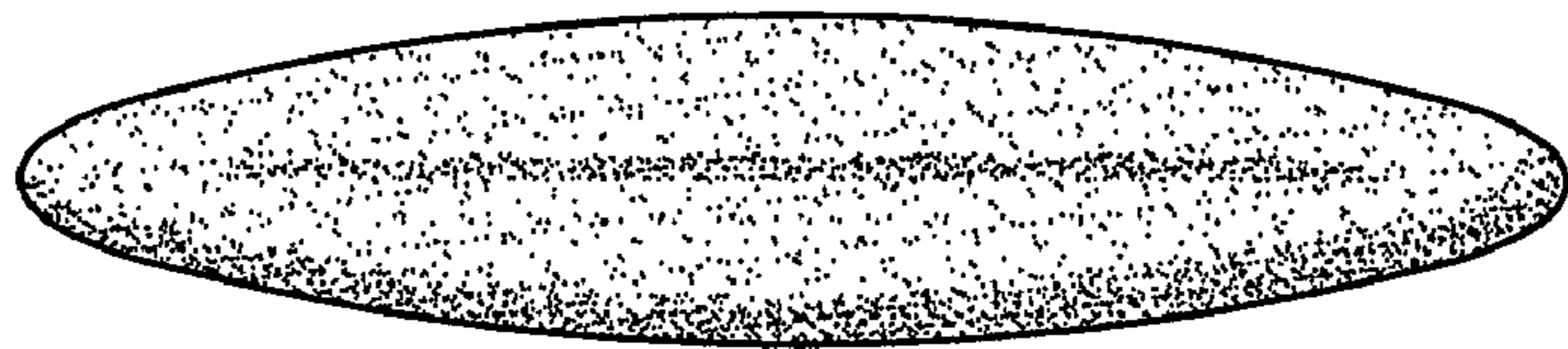

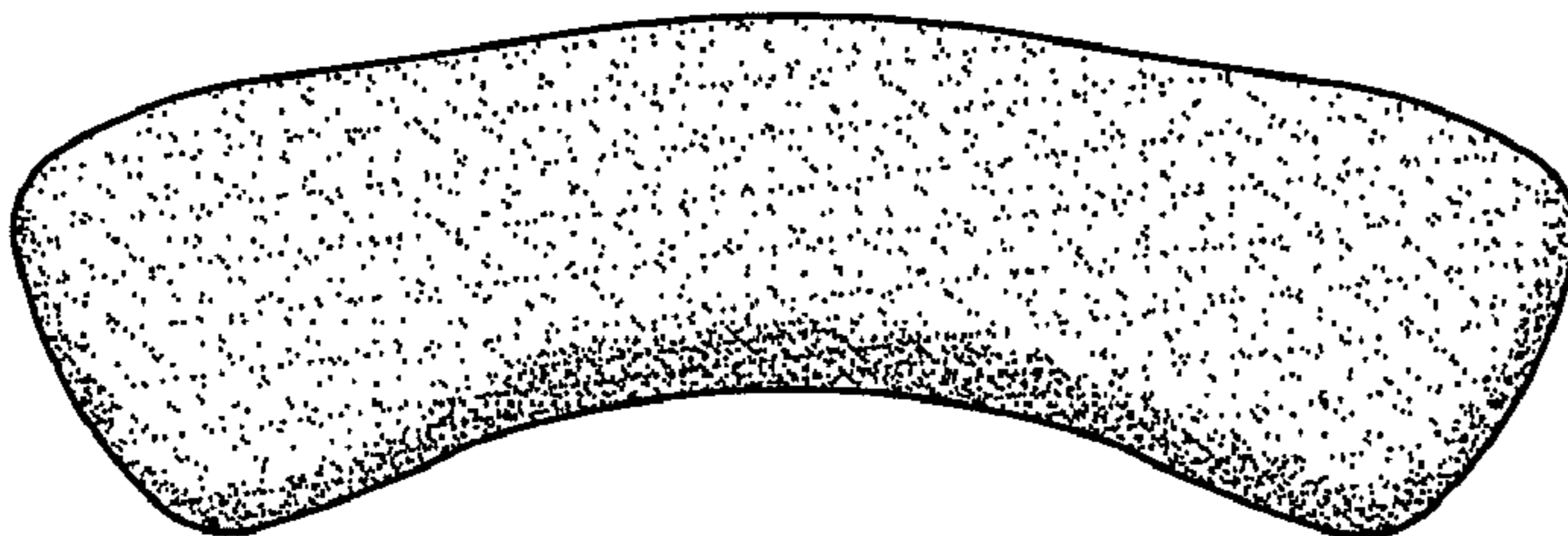

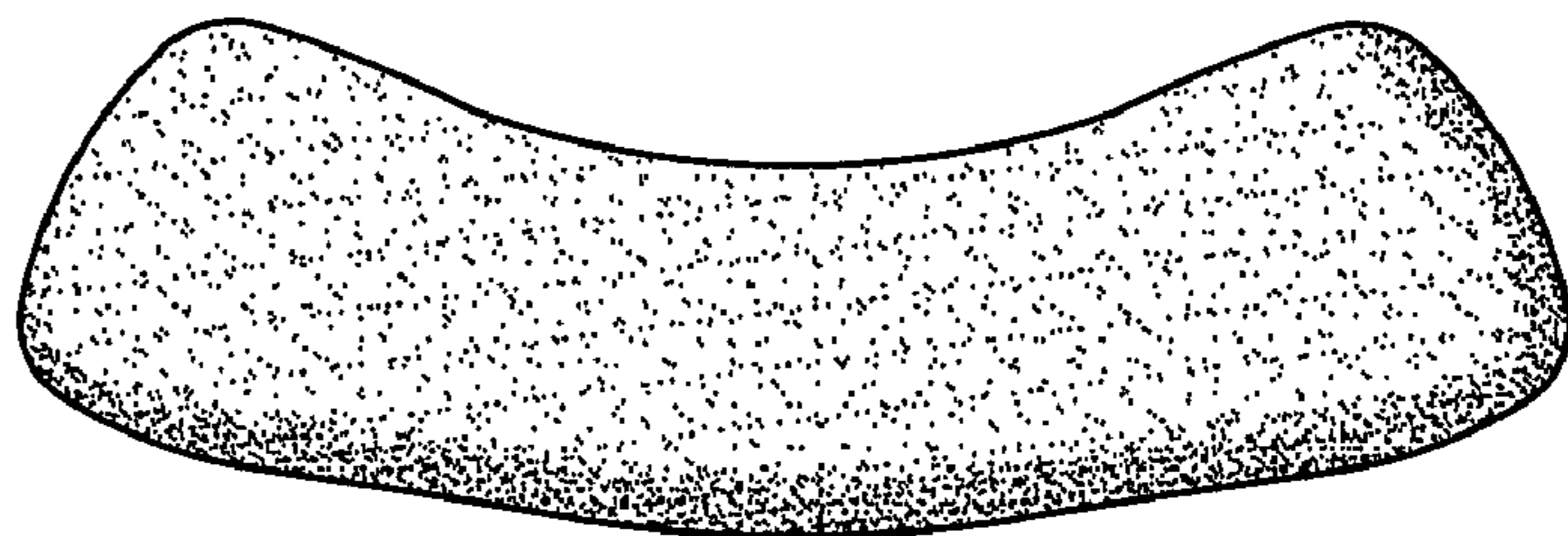

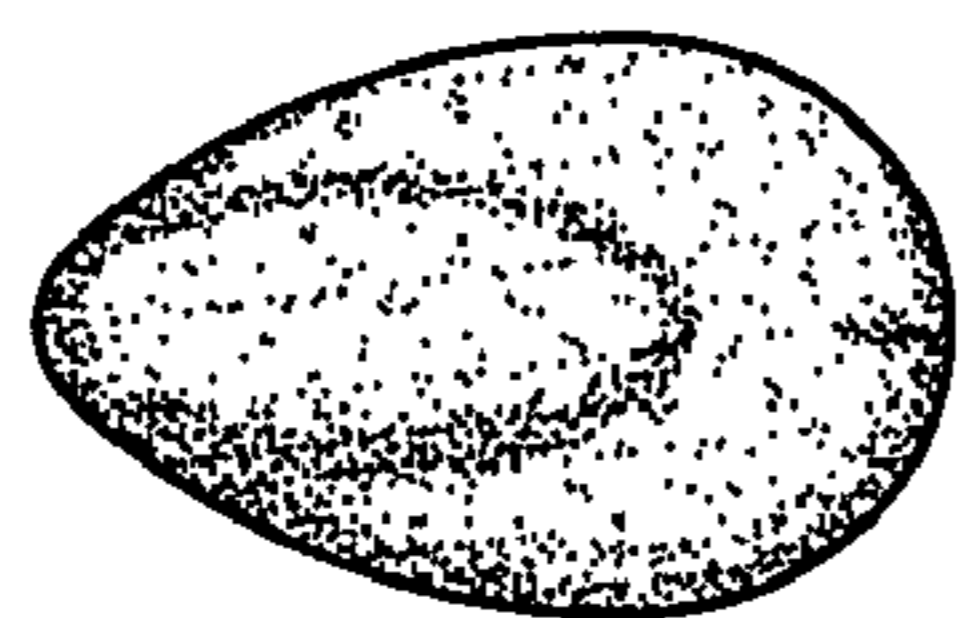

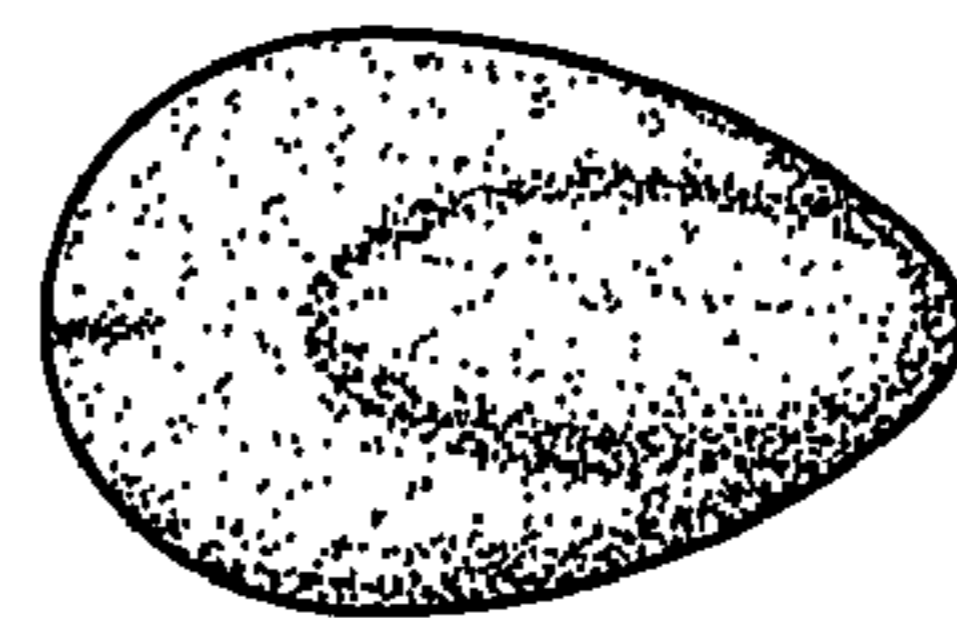
