(57) **CLAIM**

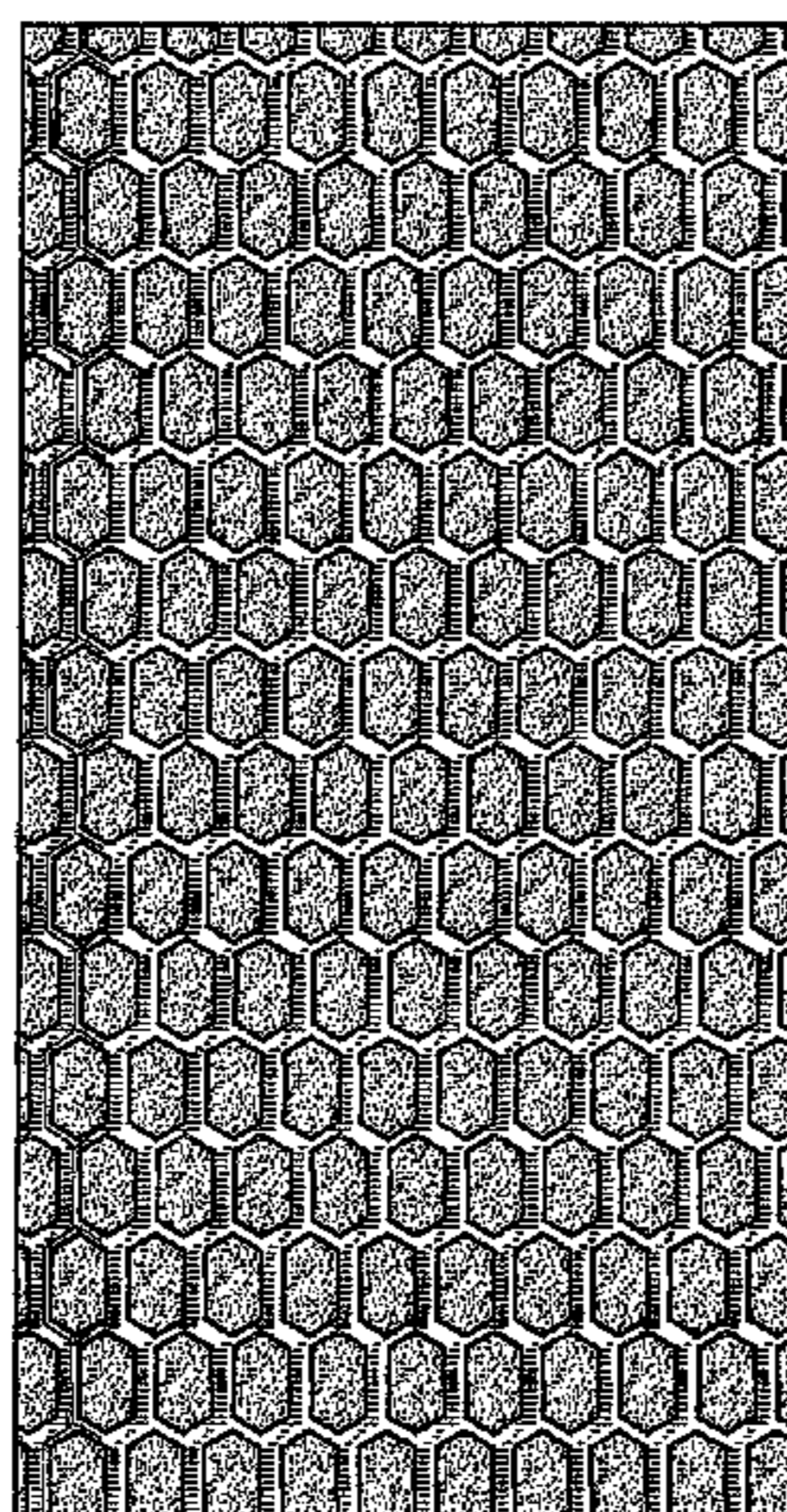
The ornamental design for a nonwoven fabric, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a nonwoven fabric; and, FIG. 2 is a fragmentary perspective view of the nonwoven fabric of FIG. 1.

The drawings show a nonwoven fabric having no specific length or width, with a pattern that repeats uniformly throughout the surface of the fabric. The broken lines in the drawing represent unclaimed portions of the design. The bottom surface of the nonwoven fabric forms no part of the claimed design.

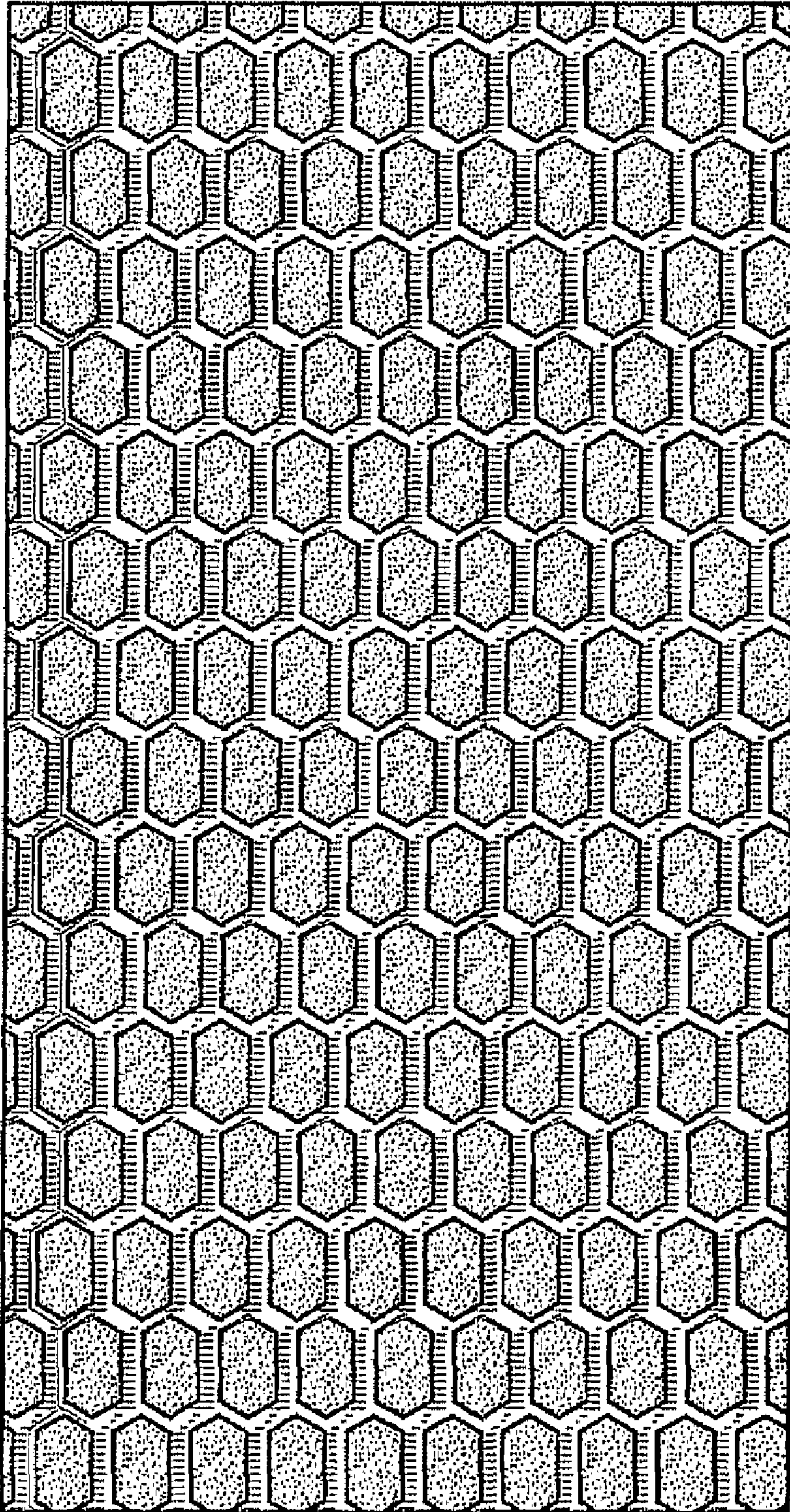

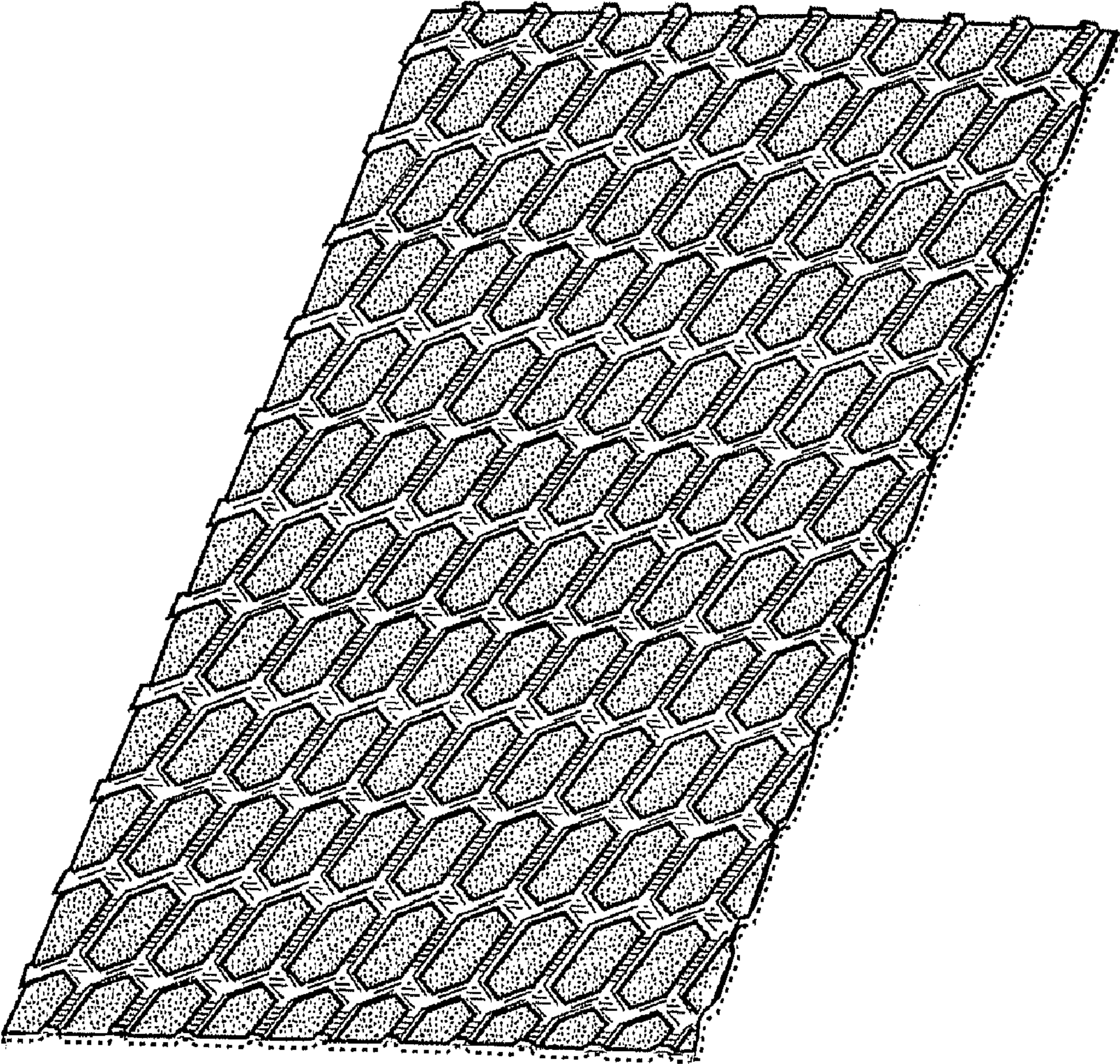
