**DESCRIPTION**

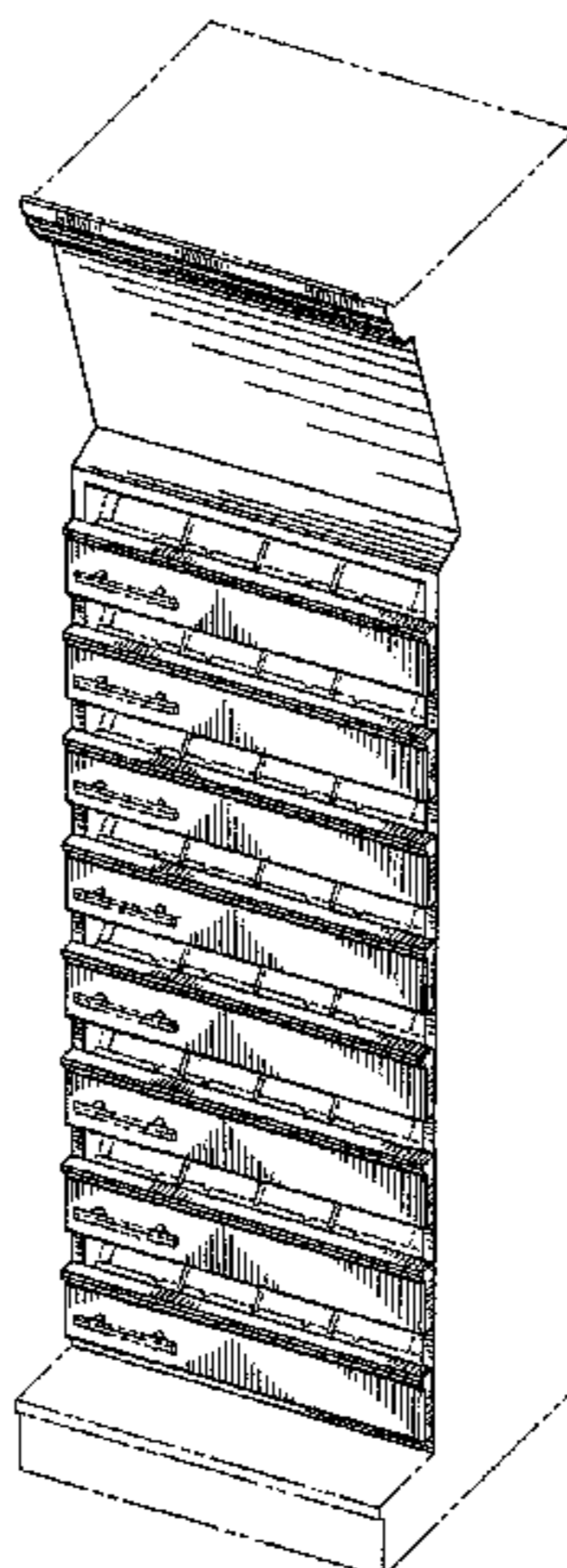
FIG. 1 is a perspective view of a front panel of a merchandise display of the present claimed design;

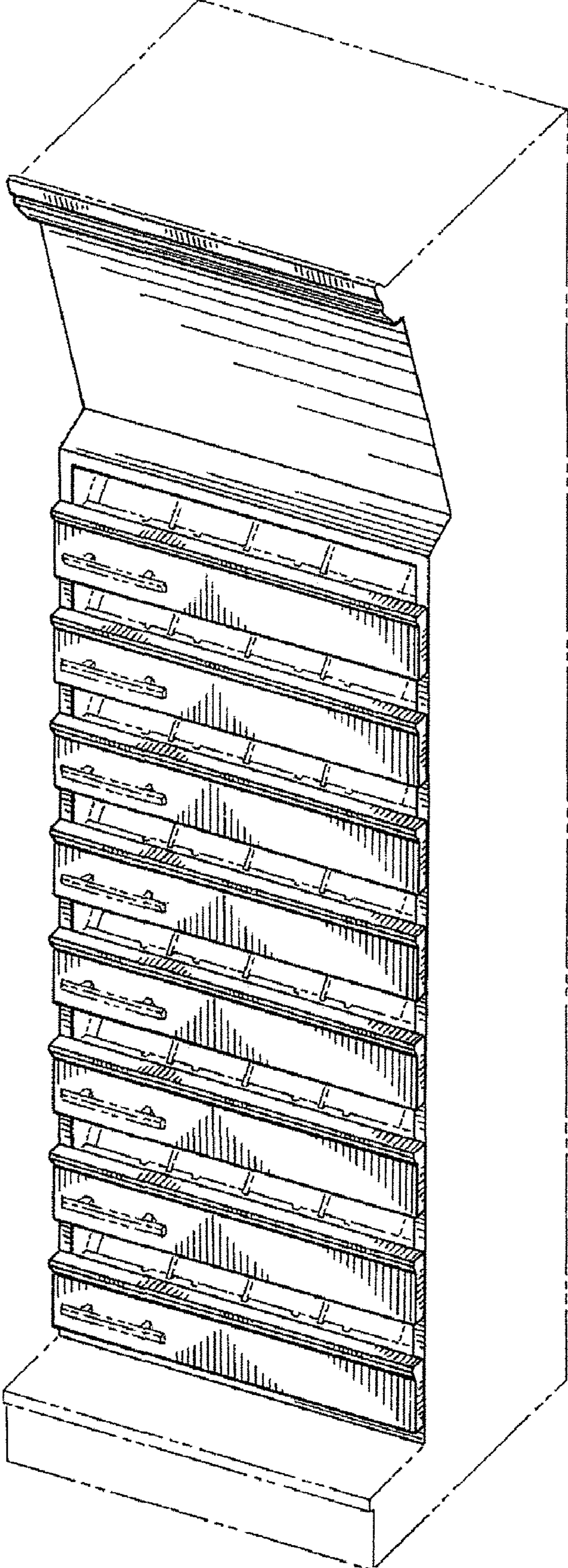

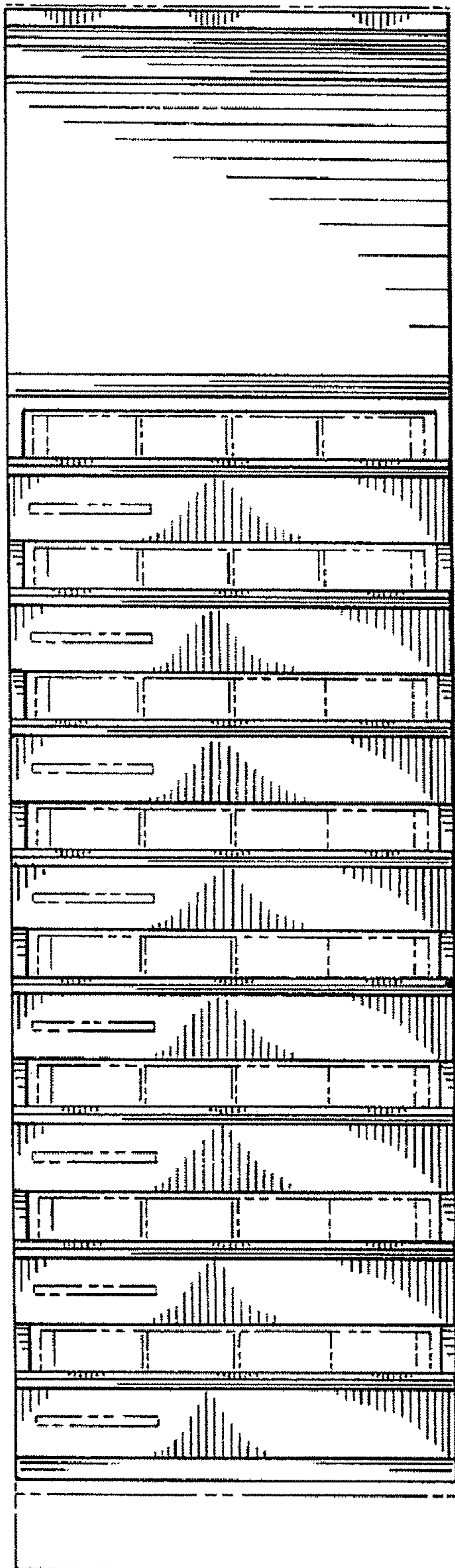
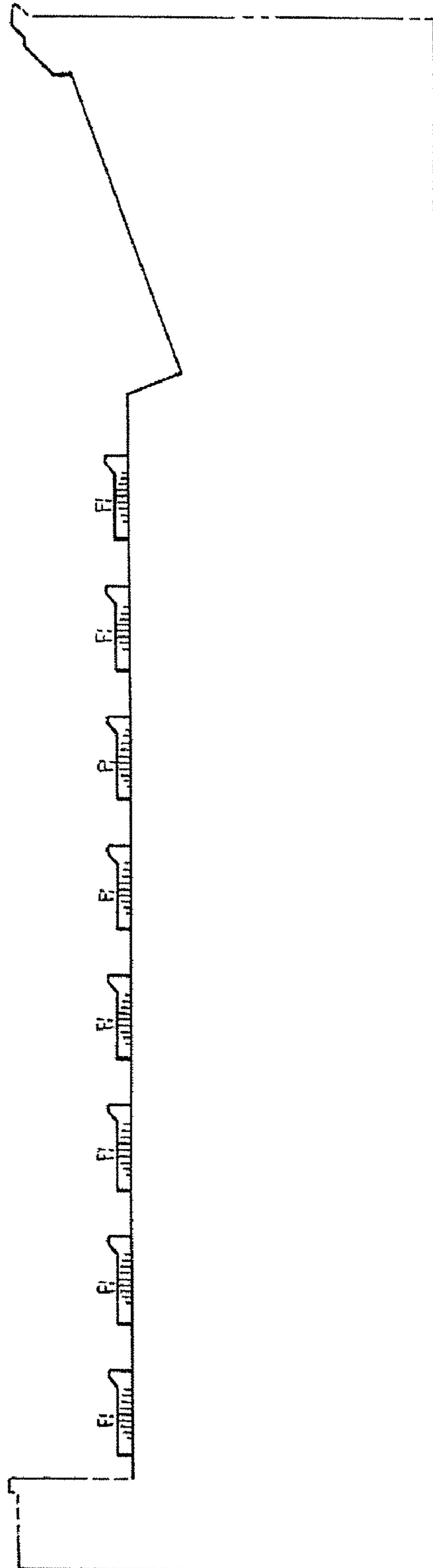
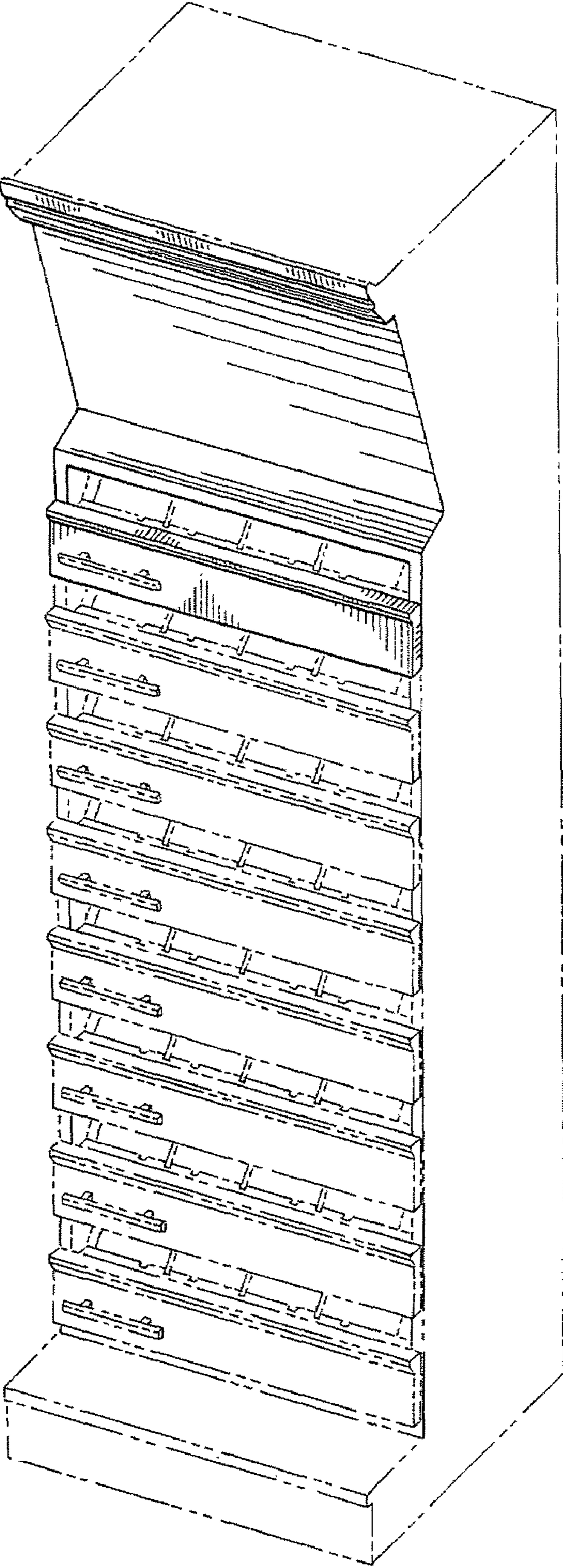


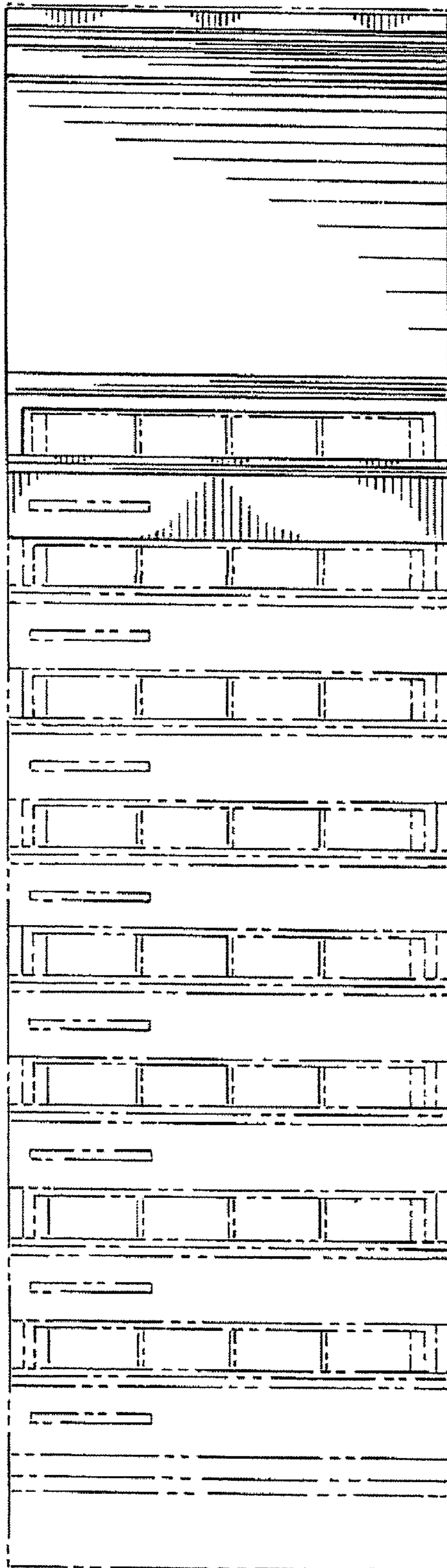
