FIG. 3 is a top plan view of the football shaped bottle opener;

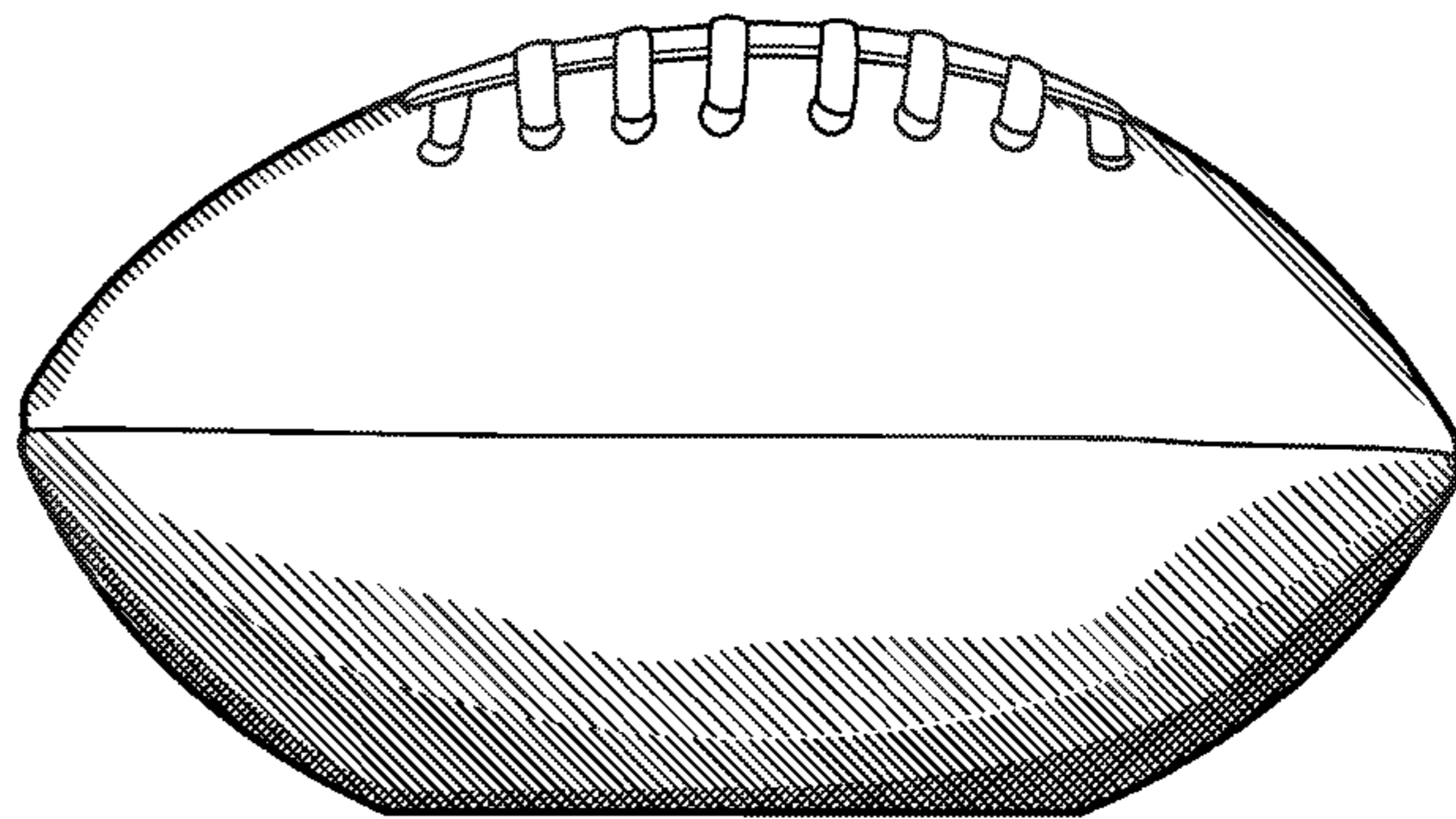
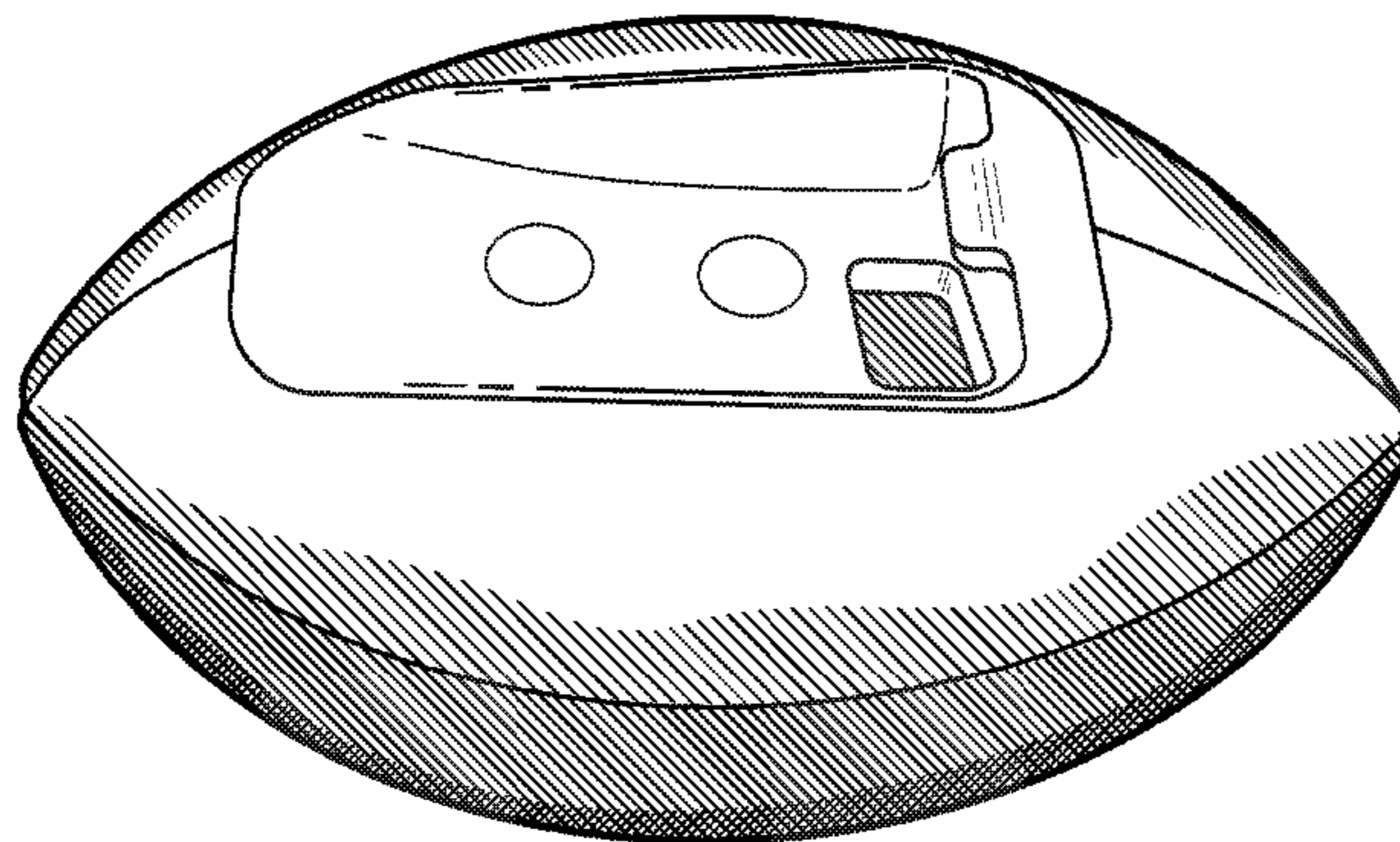
FIG. 4 is a right side view of the football shaped bottle opener;

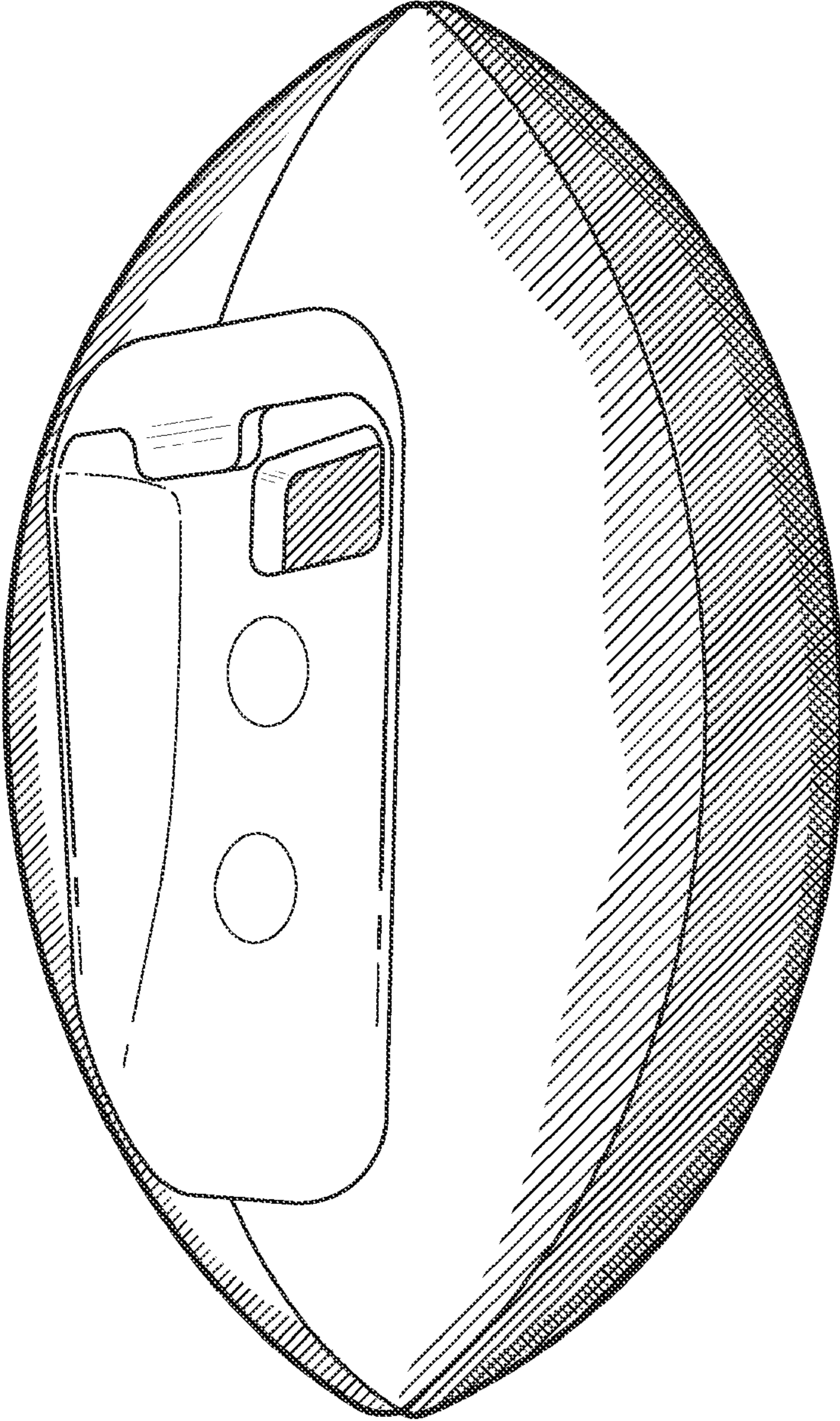

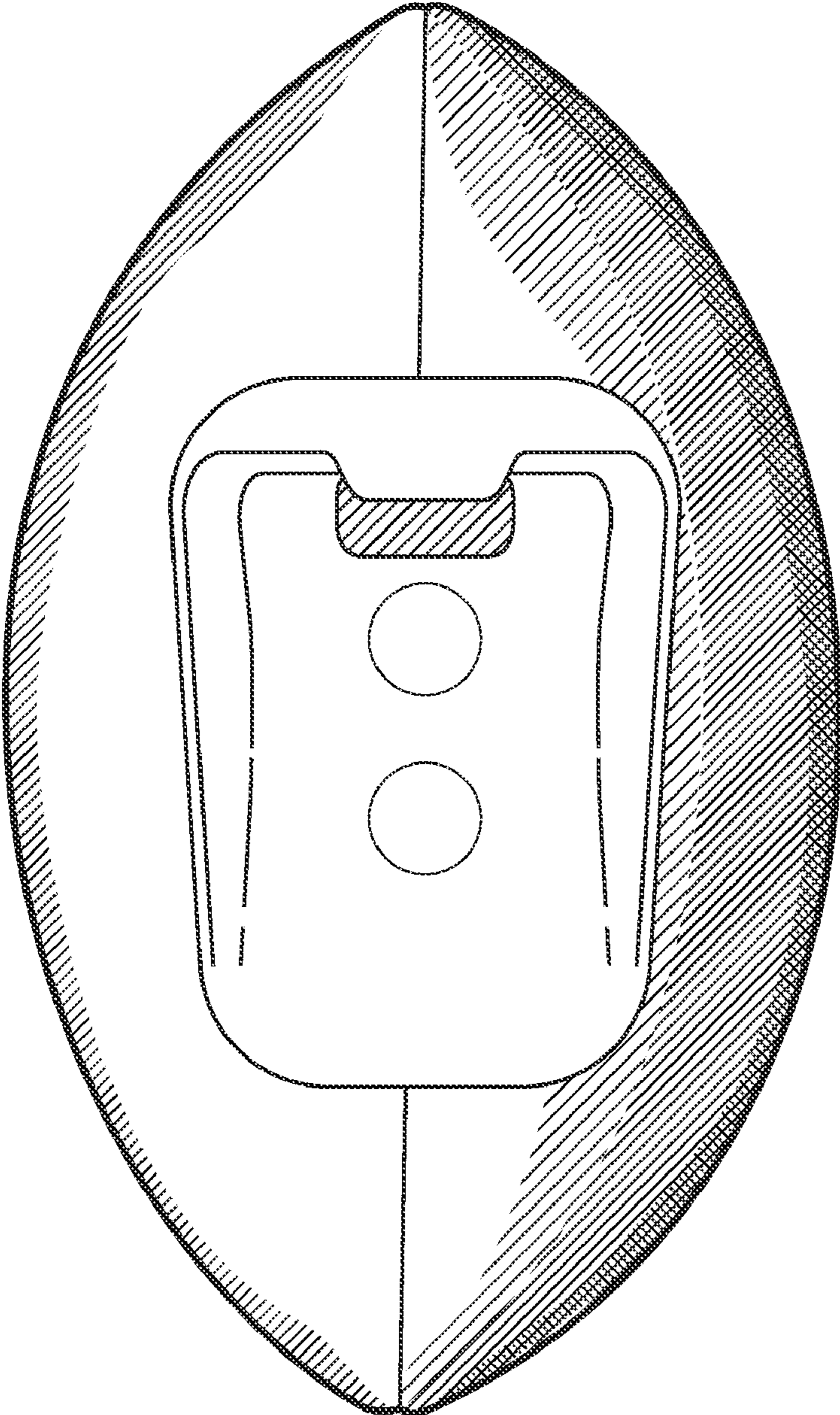

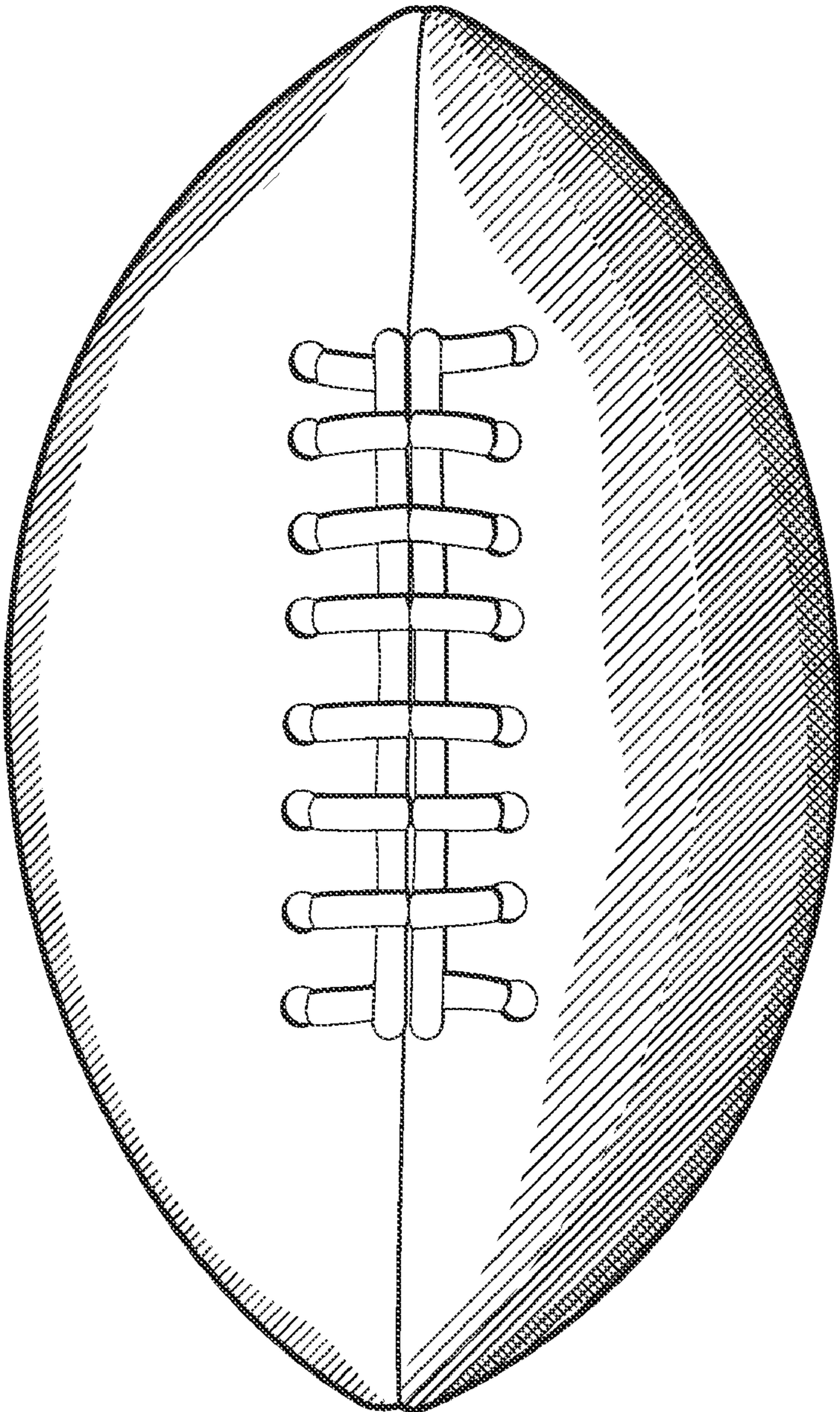

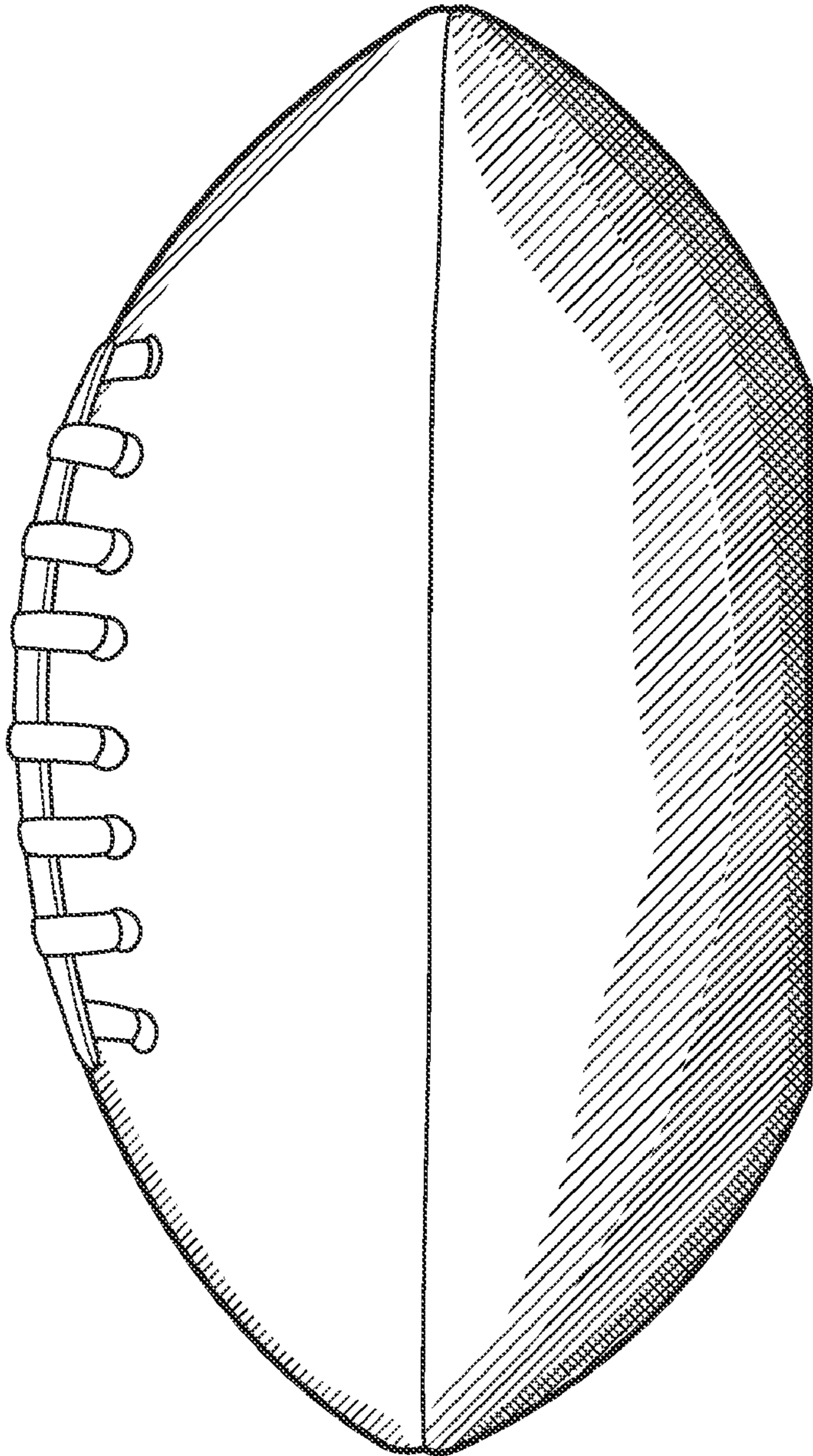

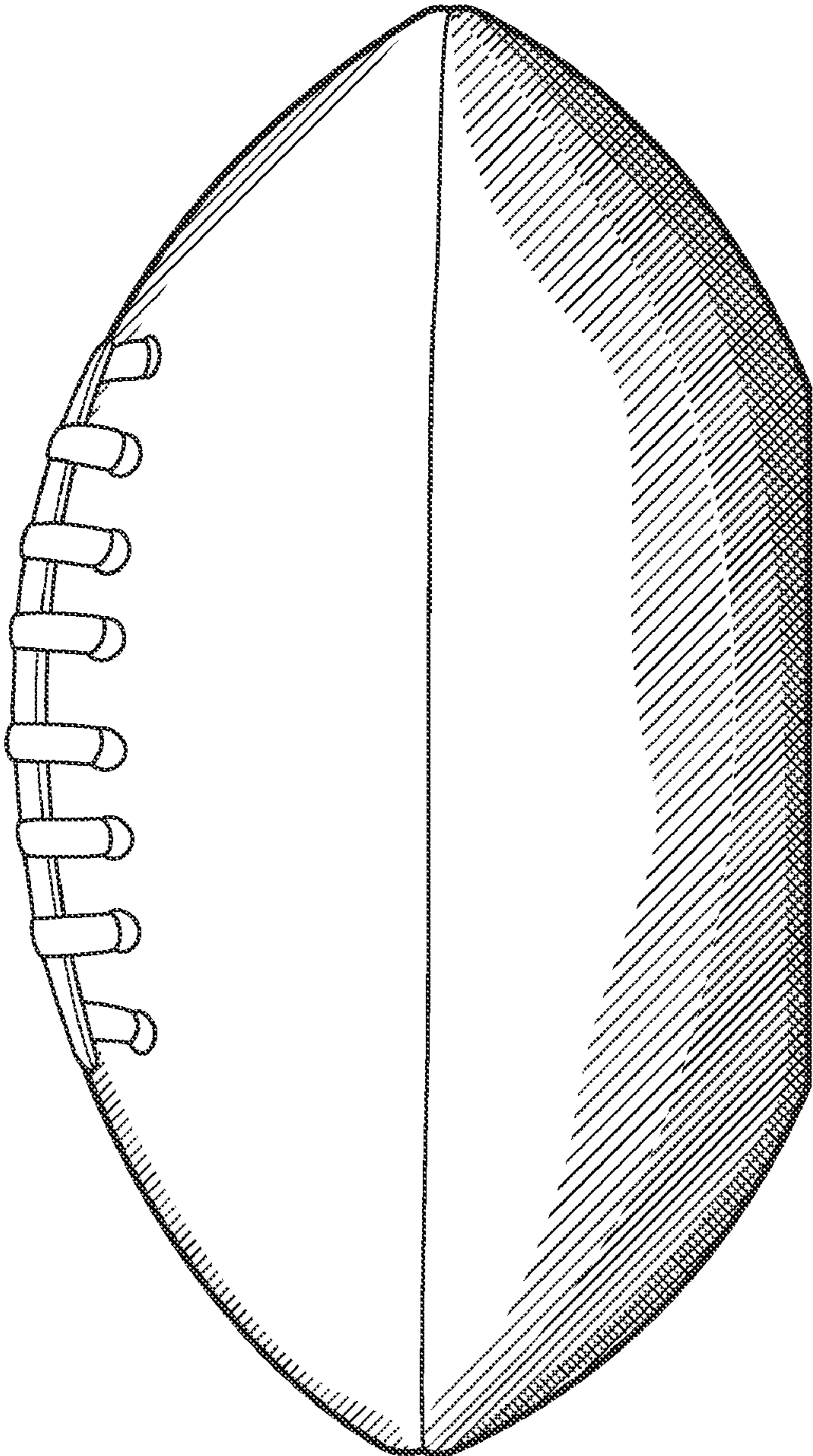

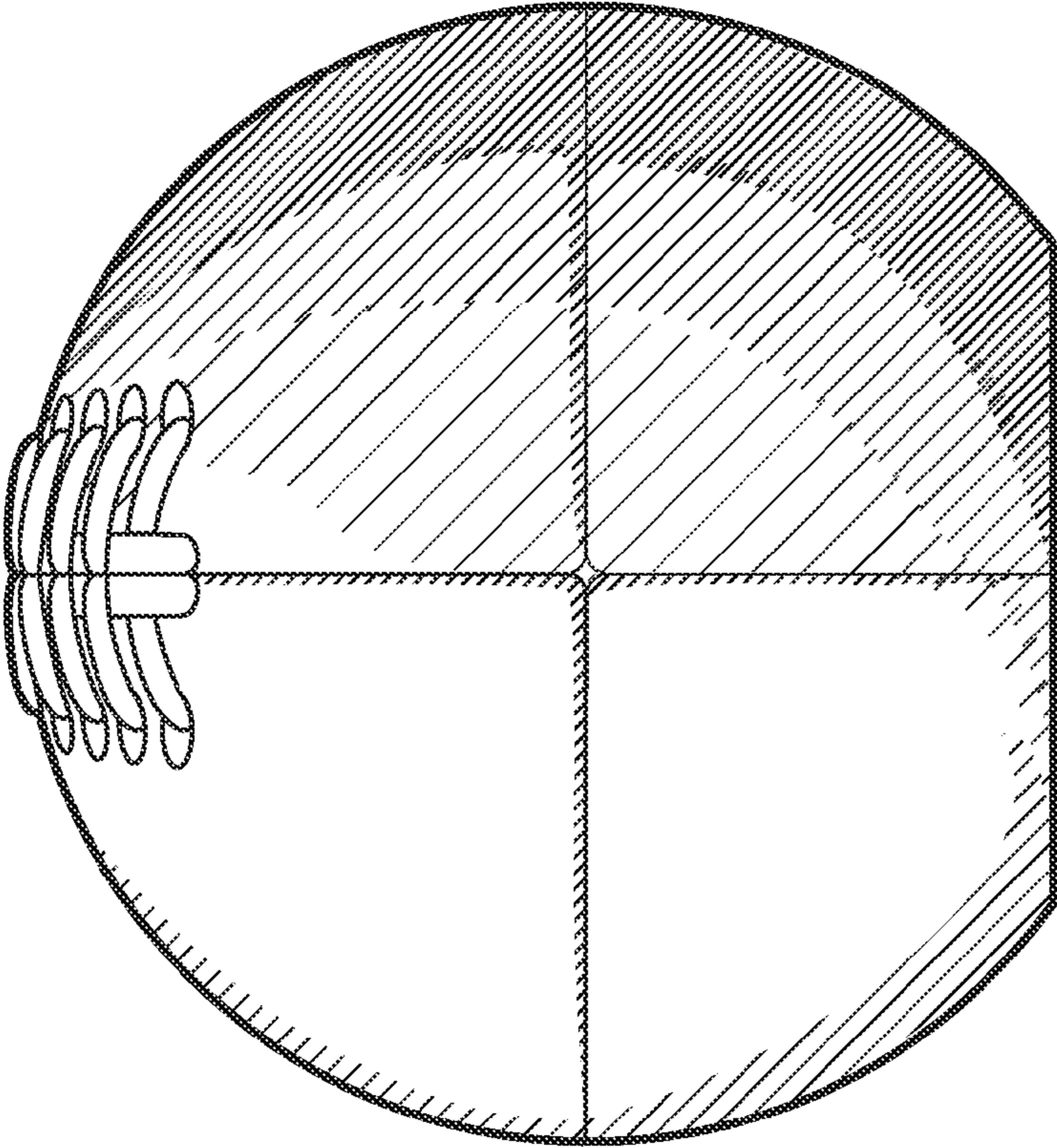

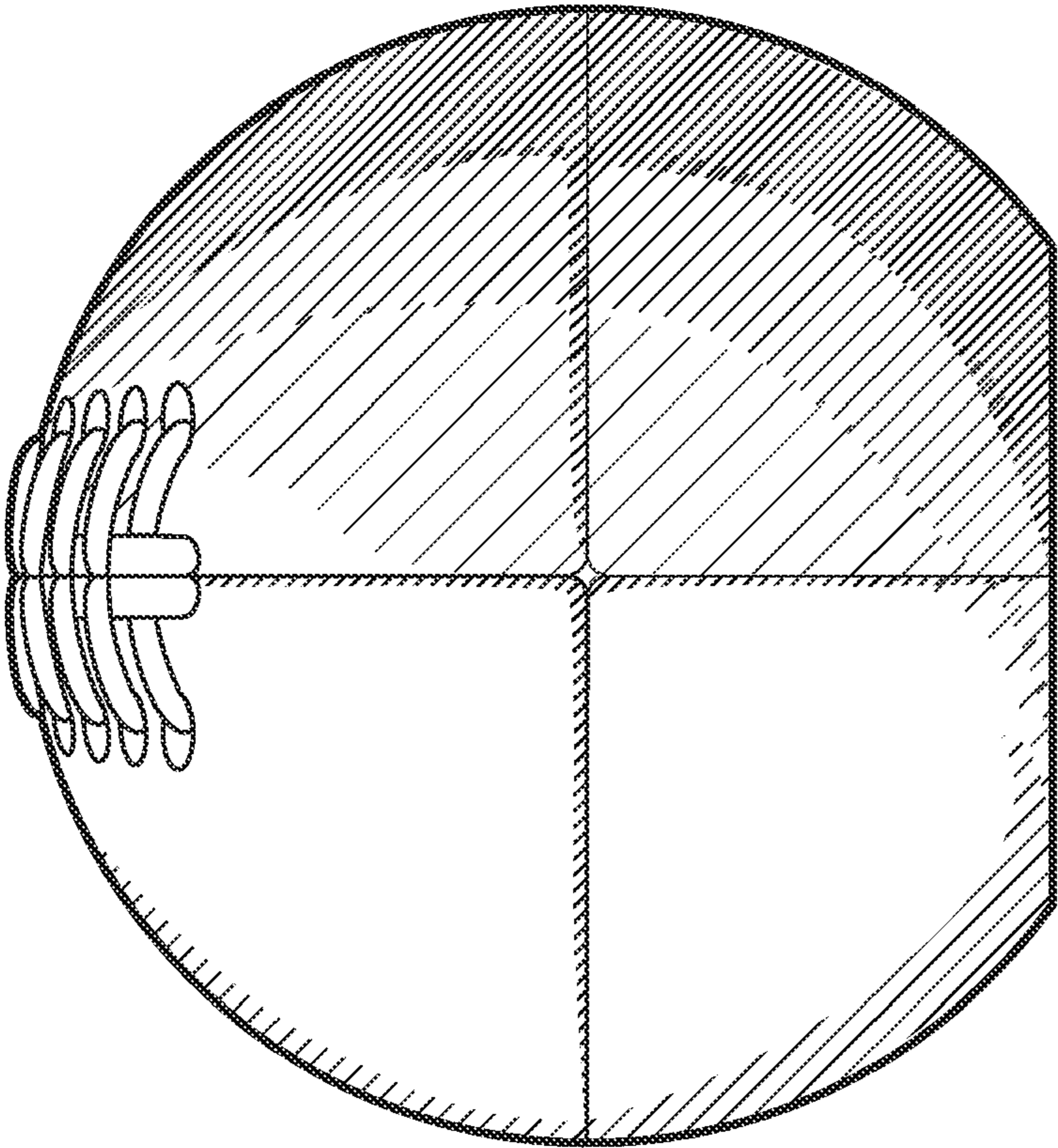
