(57) **CLAIM**

I claim the ornamental design for a light emitting semiconductor, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a light emitting semiconductor device according to my new design;

FIG. 2 is a front view of the same device;

FIG. 3 is a rear view of the same device;

FIG. 4 is a top plan view of the same device;

FIG. 5 is a bottom view of the same device;

FIG. 6 is a right side view of the same device;

FIG. 7 is a left side view of the same device;

FIG. 8 is a sectional view of the same device taken along lines 8—8 in FIG. 2;

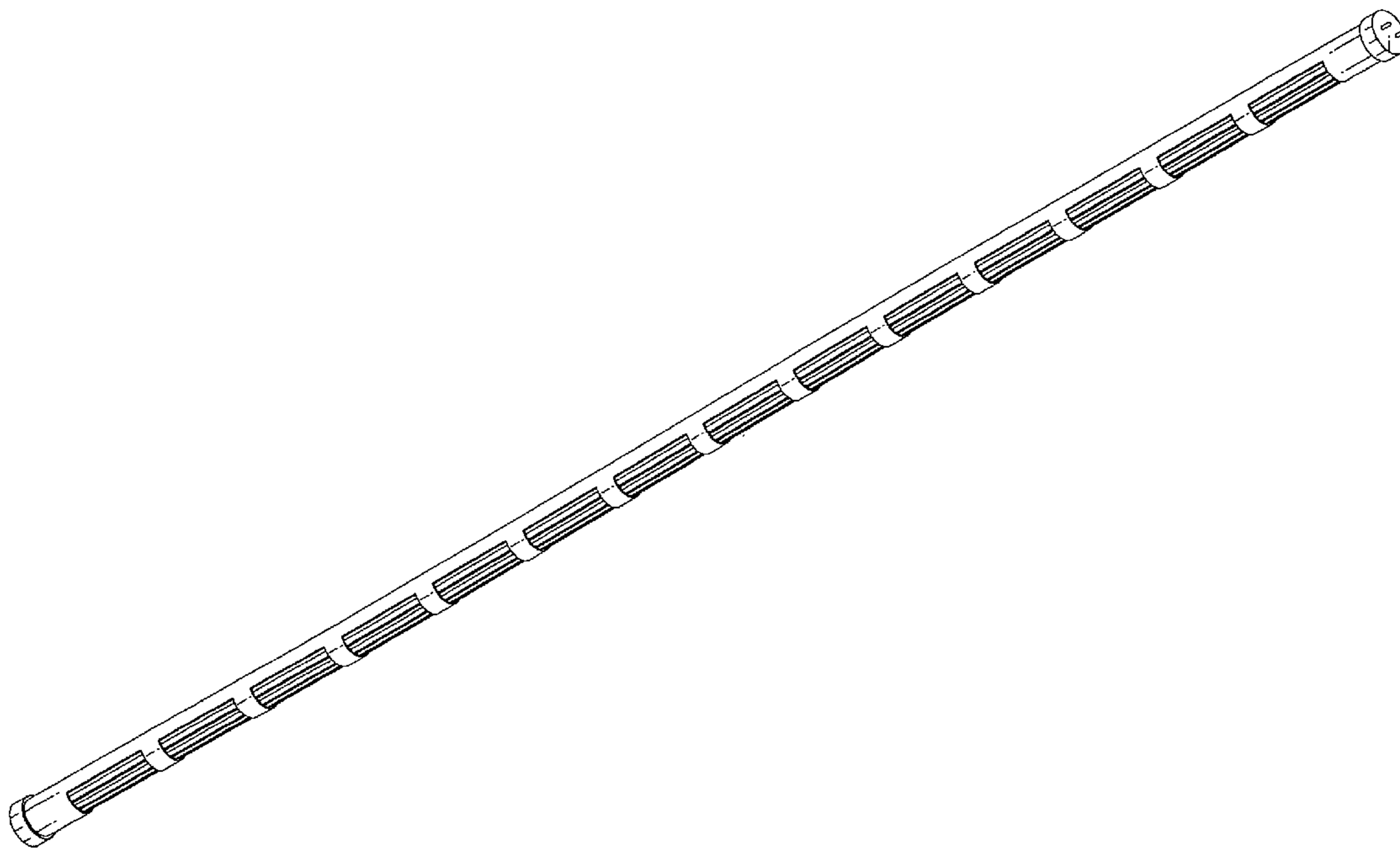
FIG. 9 is a sectional view of the same device taken along lines 9—9 in FIG. 2;

FIG. 10 is an enlarged sectional view of the same device taken along lines 8—8 in FIG. 2;

FIG. 11 is an enlarged sectional view of the same device taken along lines 9—9 in FIG. 2; and,

FIG. 12 is an enlarged partial view showing the left end of the same device indicated by lines 12—12 in FIG. 5.

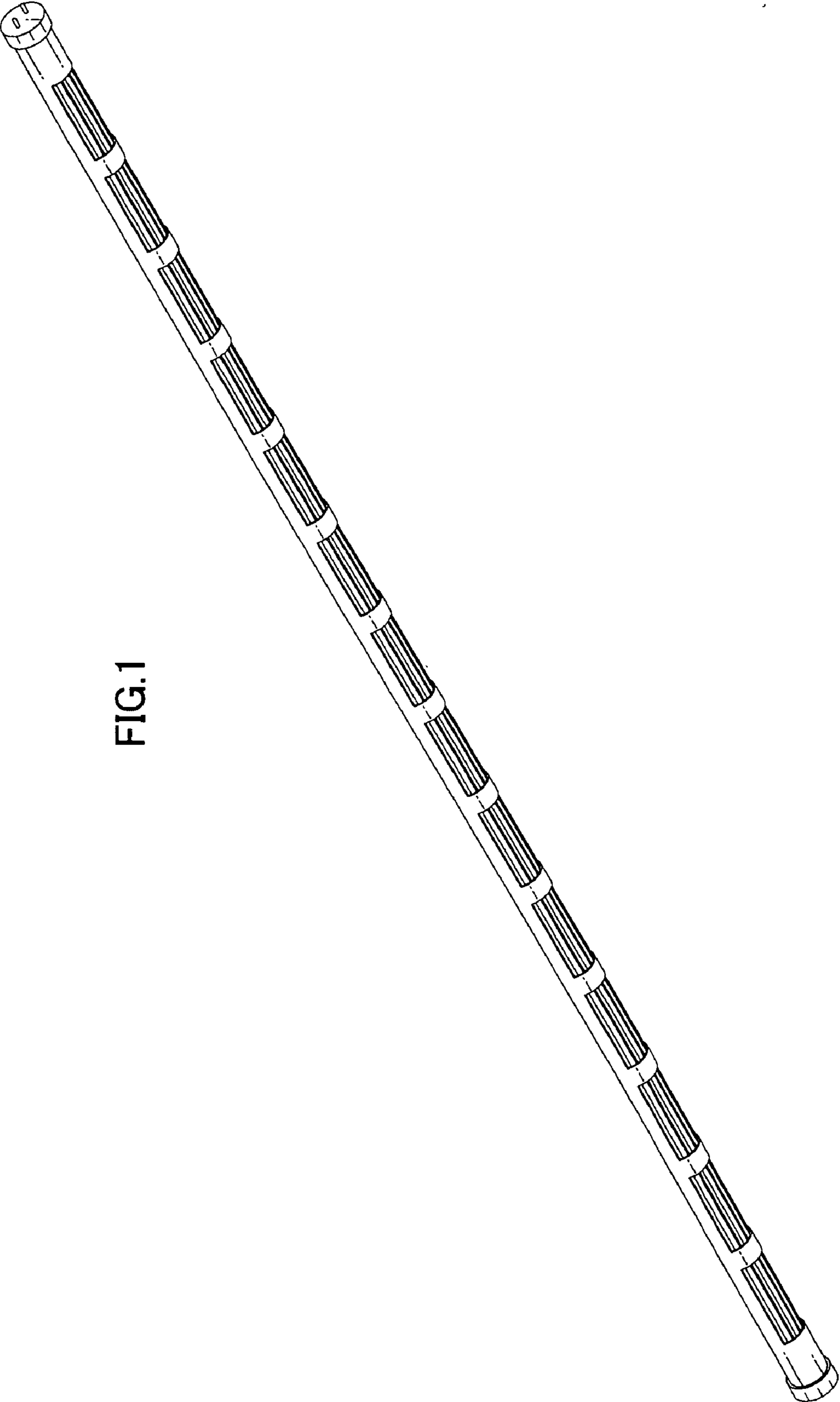
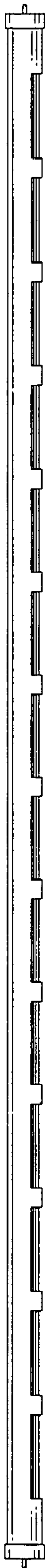

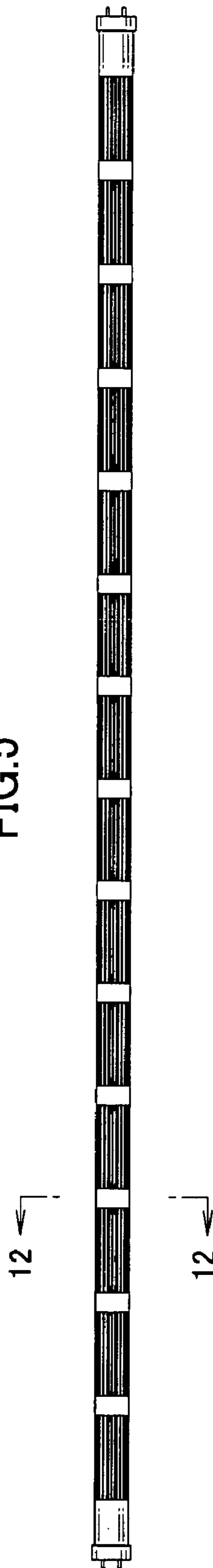

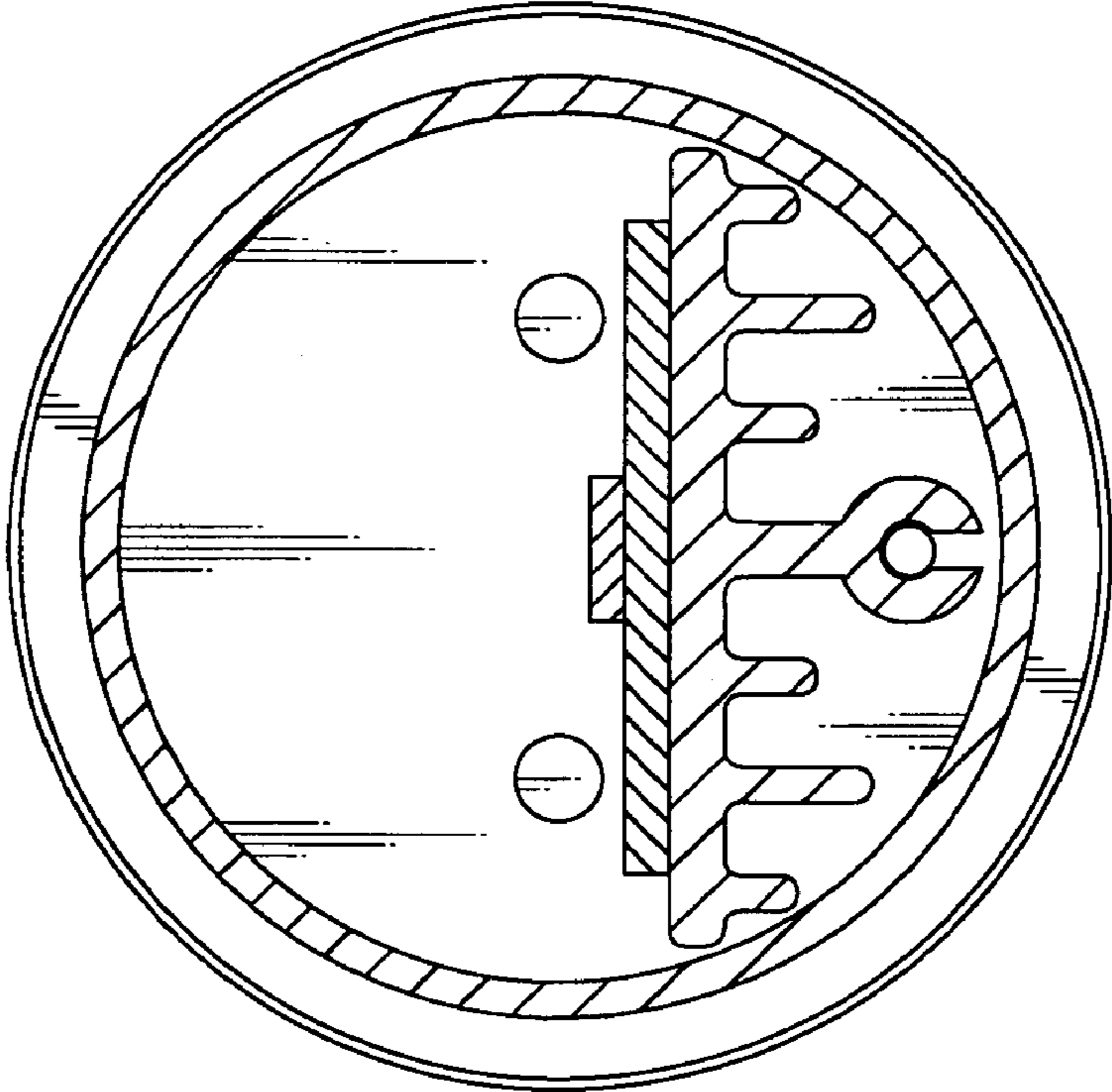

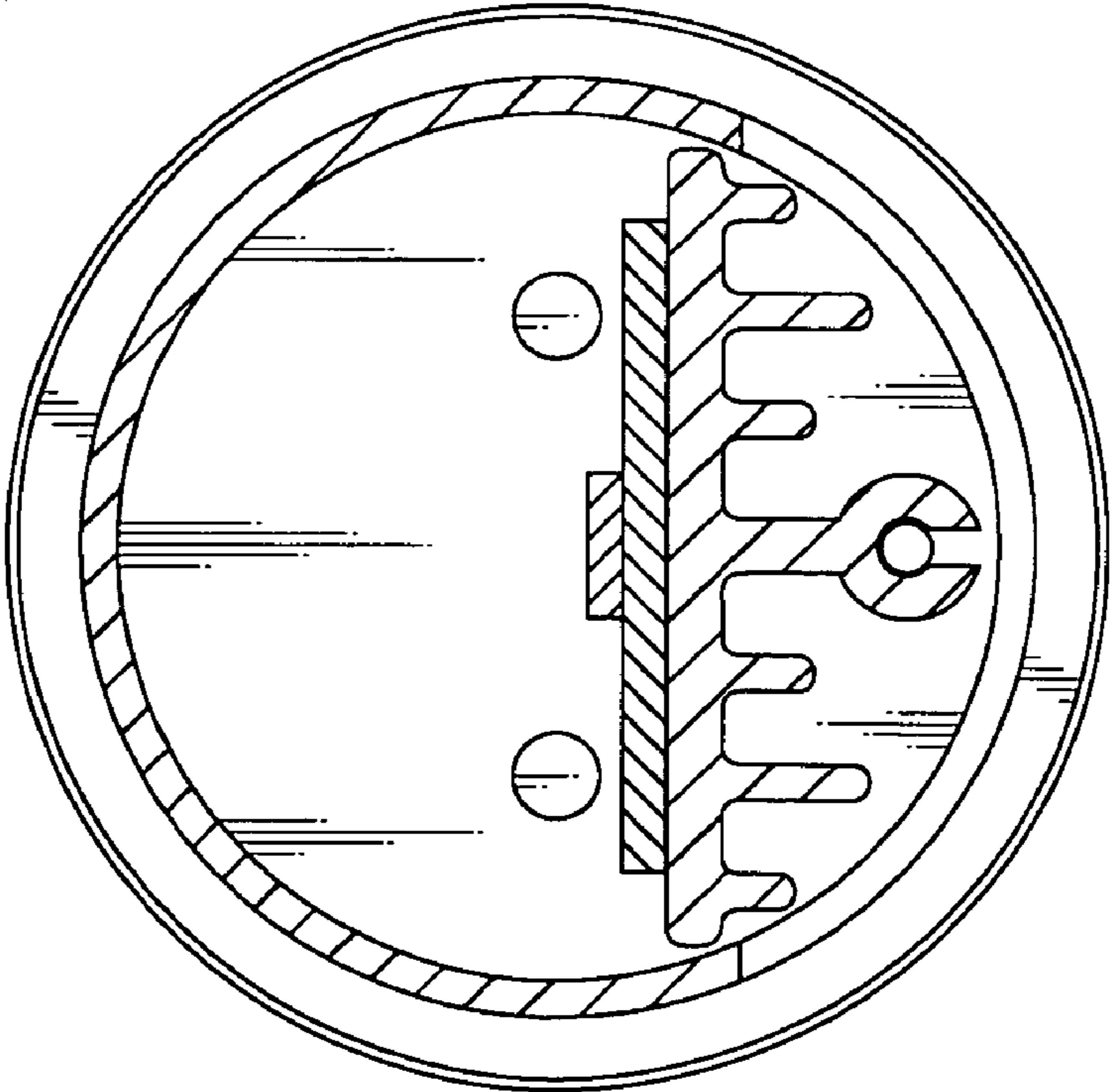
