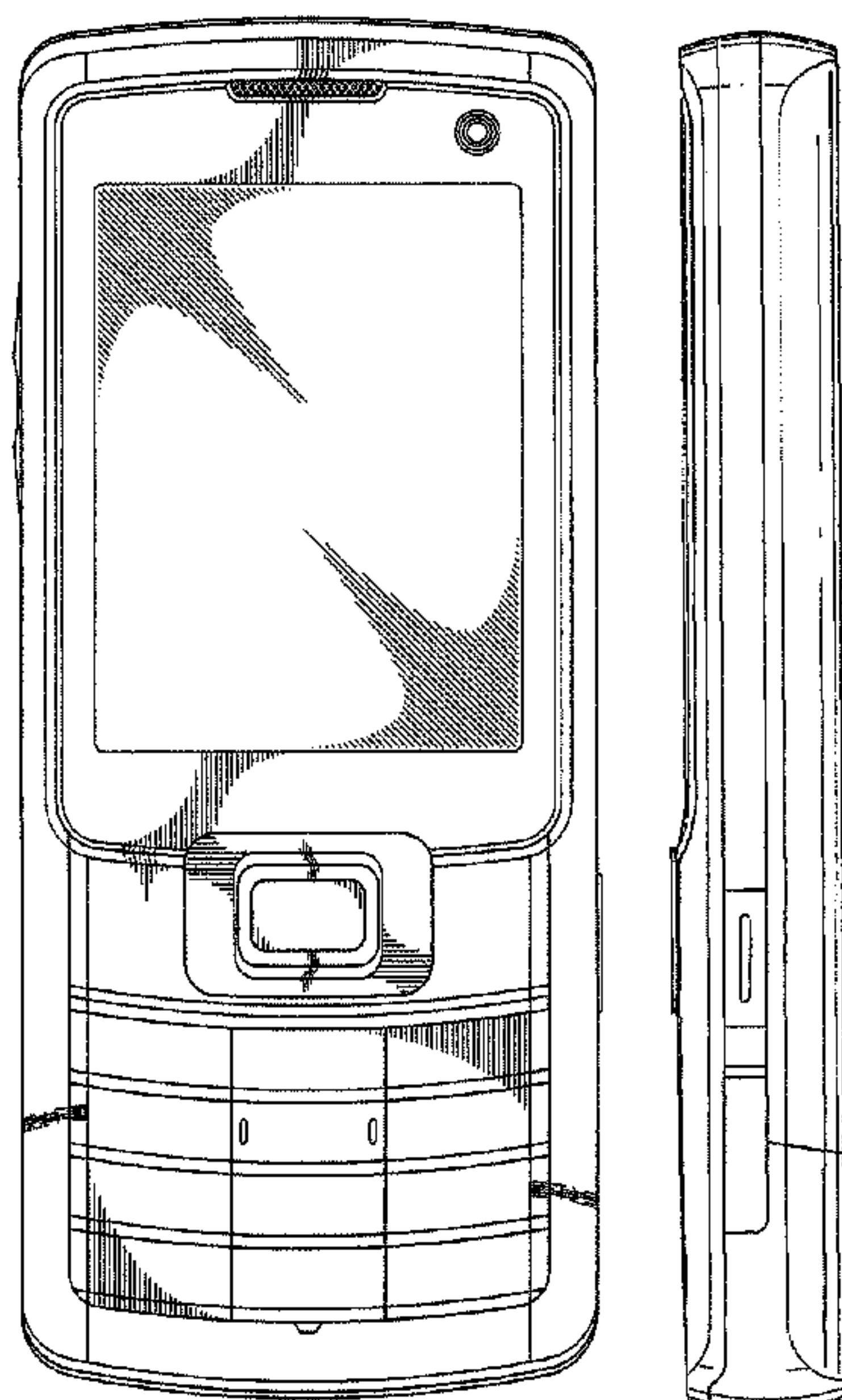
CLAIM

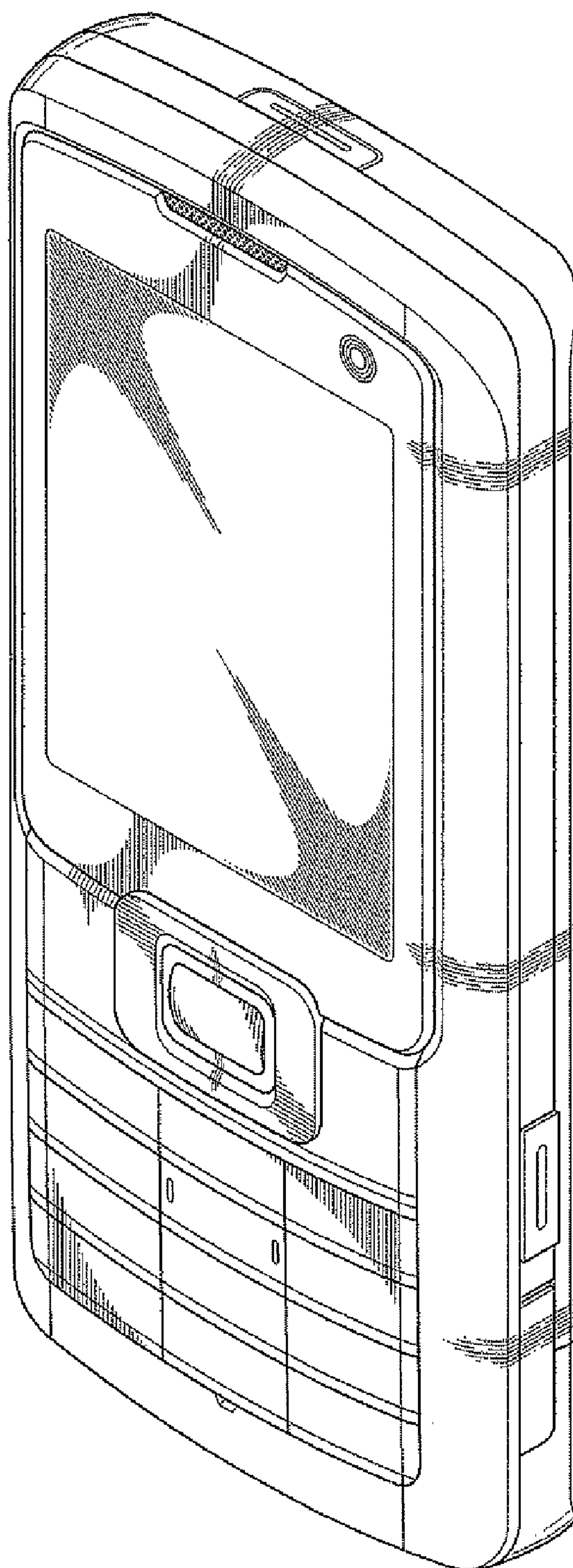

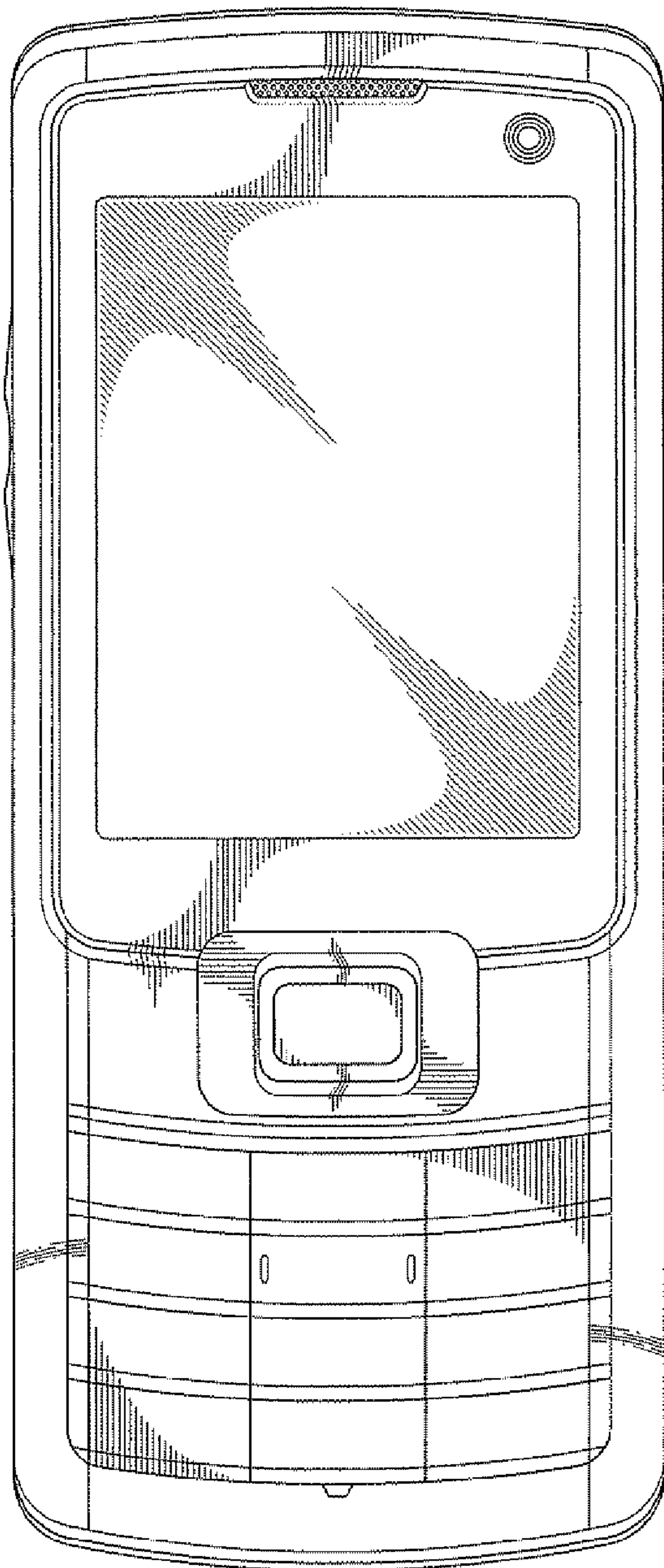

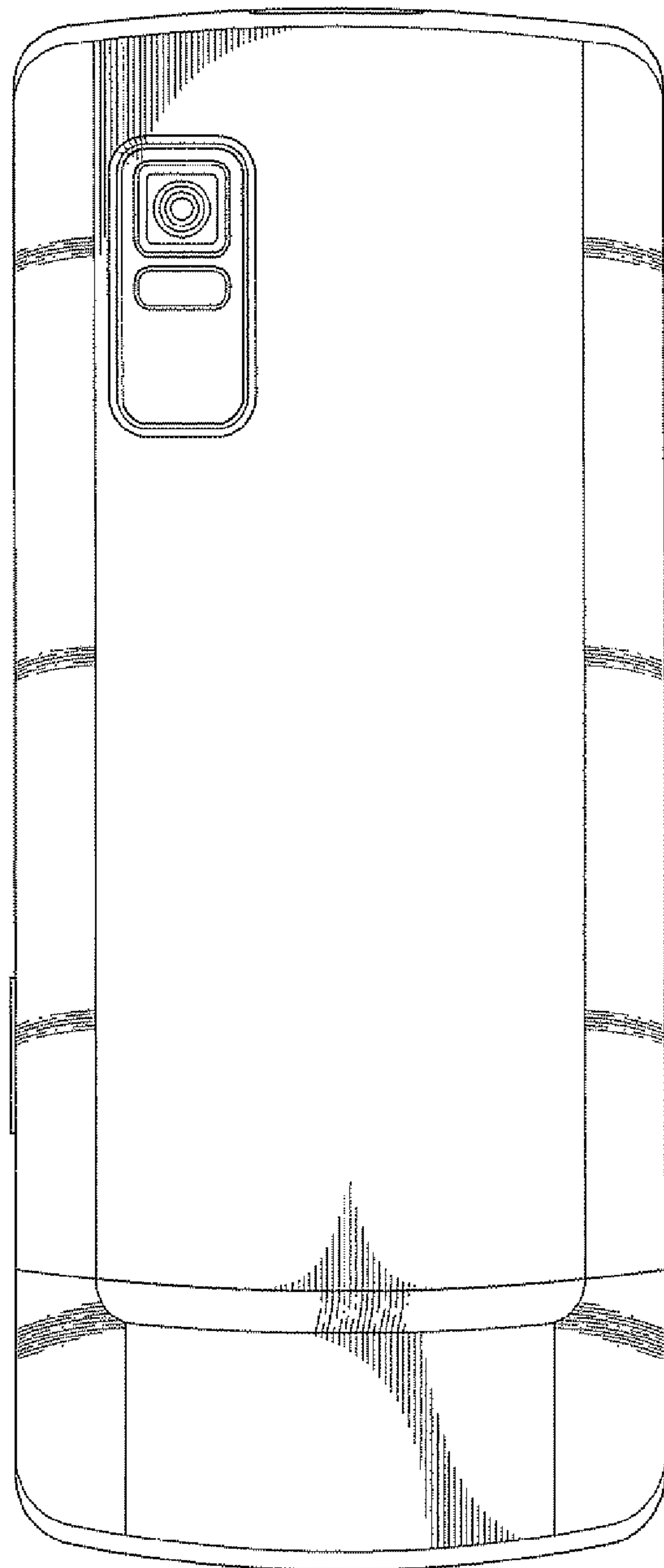

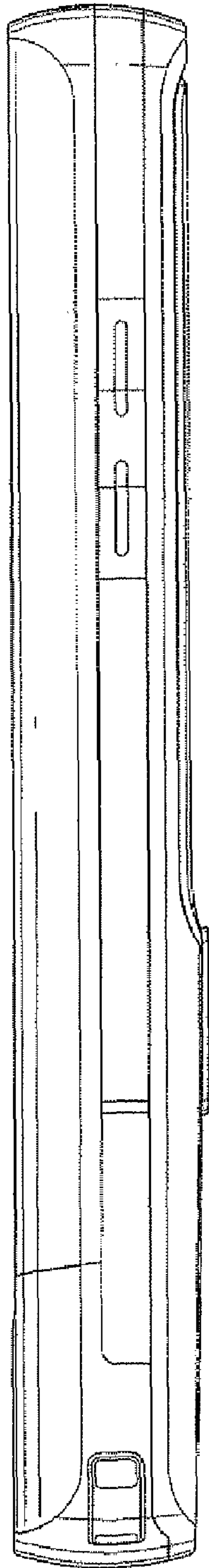

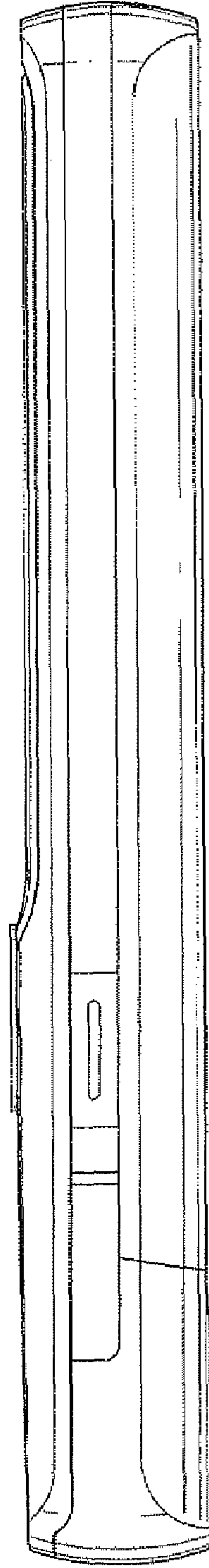

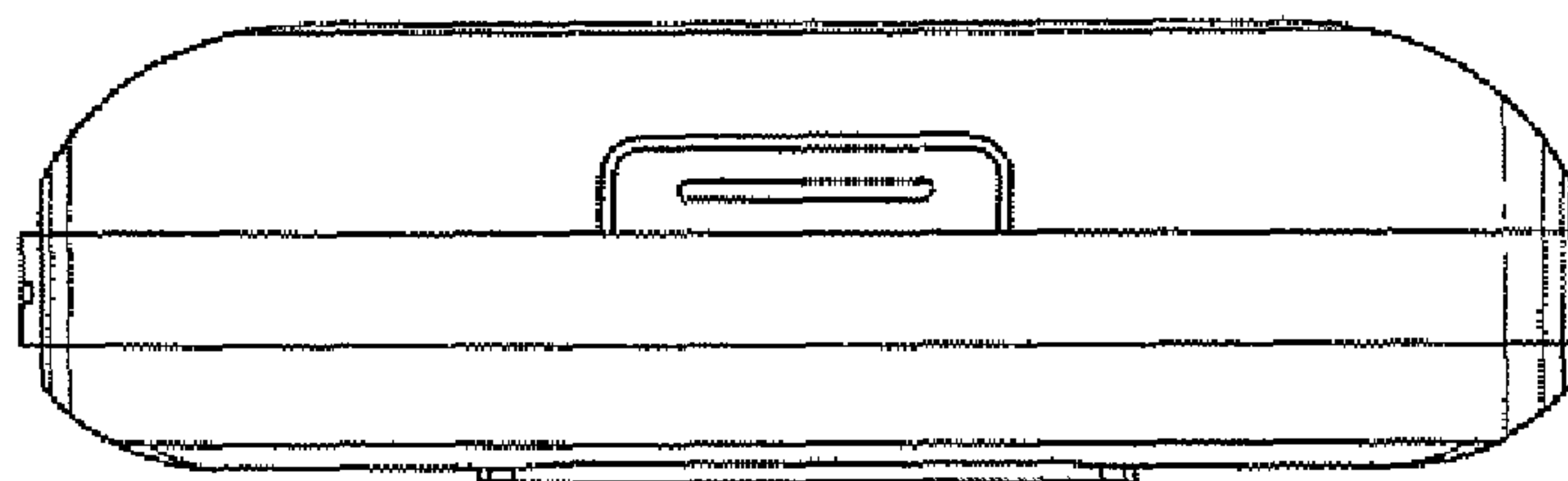
