(57) **CLAIM**

The ornamental design for a TV tent for kids, as shown and described.

**DESCRIPTION**

The purpose of this toy-tent is to educate children on possible TV (and non-TV) careers as well as encourage creativeness.

FIG. 1 is a front outside view of a TV tent for kids showing my new design;

FIG. 2 is a right outside view of the flap door closed;

FIG. 3 is a right outside view of the flap door rolled up and tied;

FIG. 17 is a close-up front view of the VCR tape—DVD insert;

FIG. 18 is a perspective front left view with the flap door rolled up and tied;

FIG. 19 is a perspective front left view with the flap door closed;

FIG. 20 is a perspective front right view with the flap door rolled up and tied;

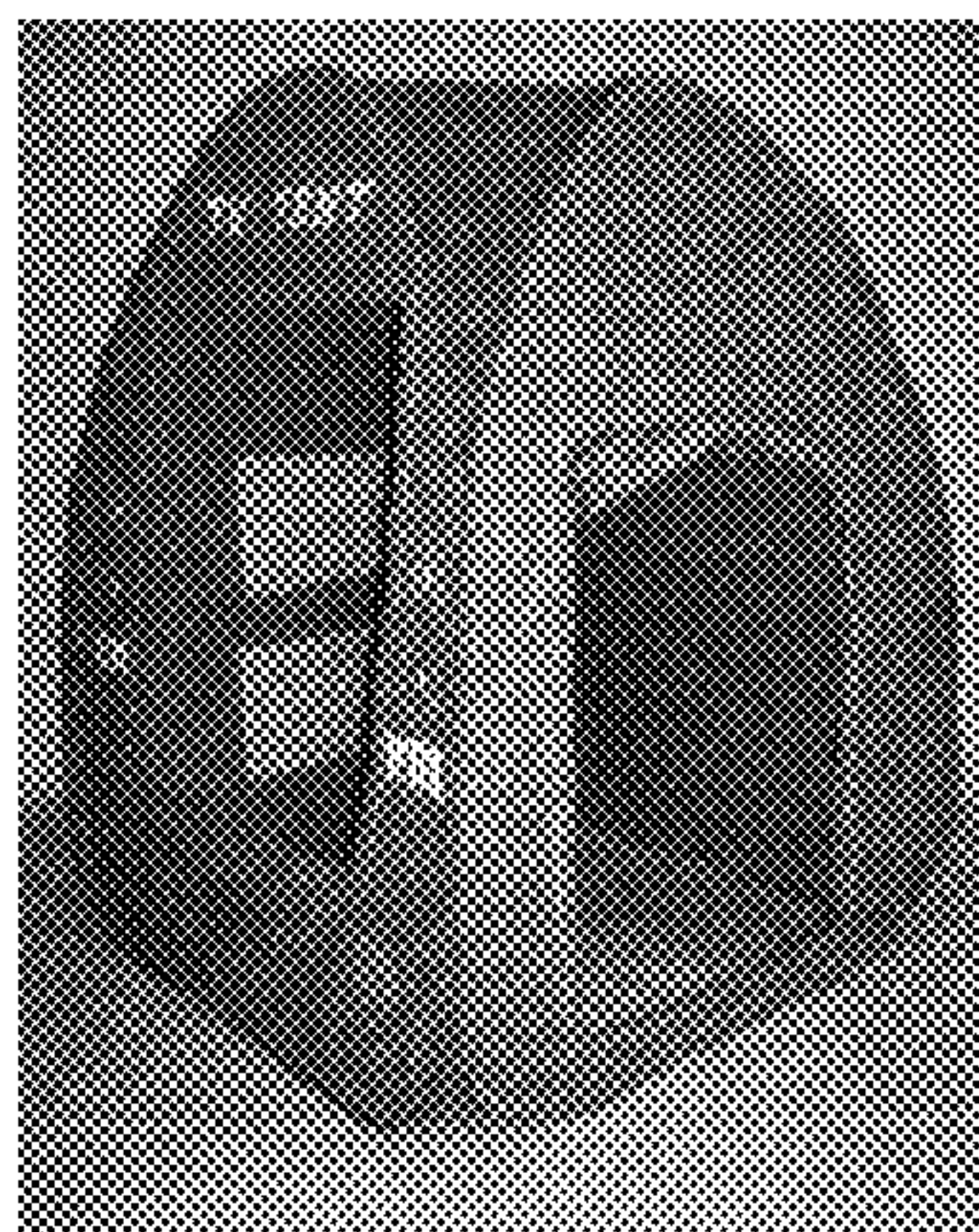
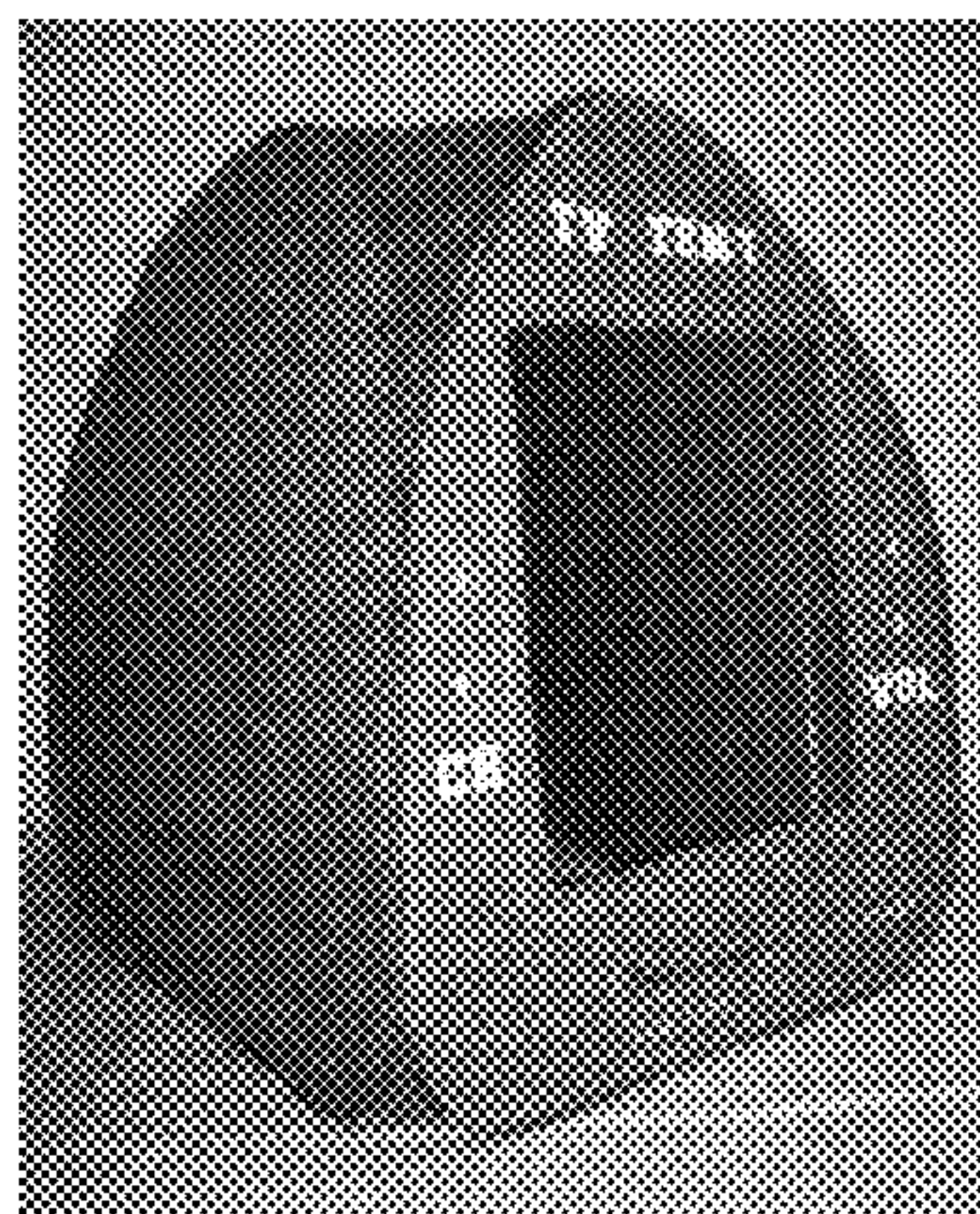
FIG. 21 is a perspective front right view with the flap door closed;

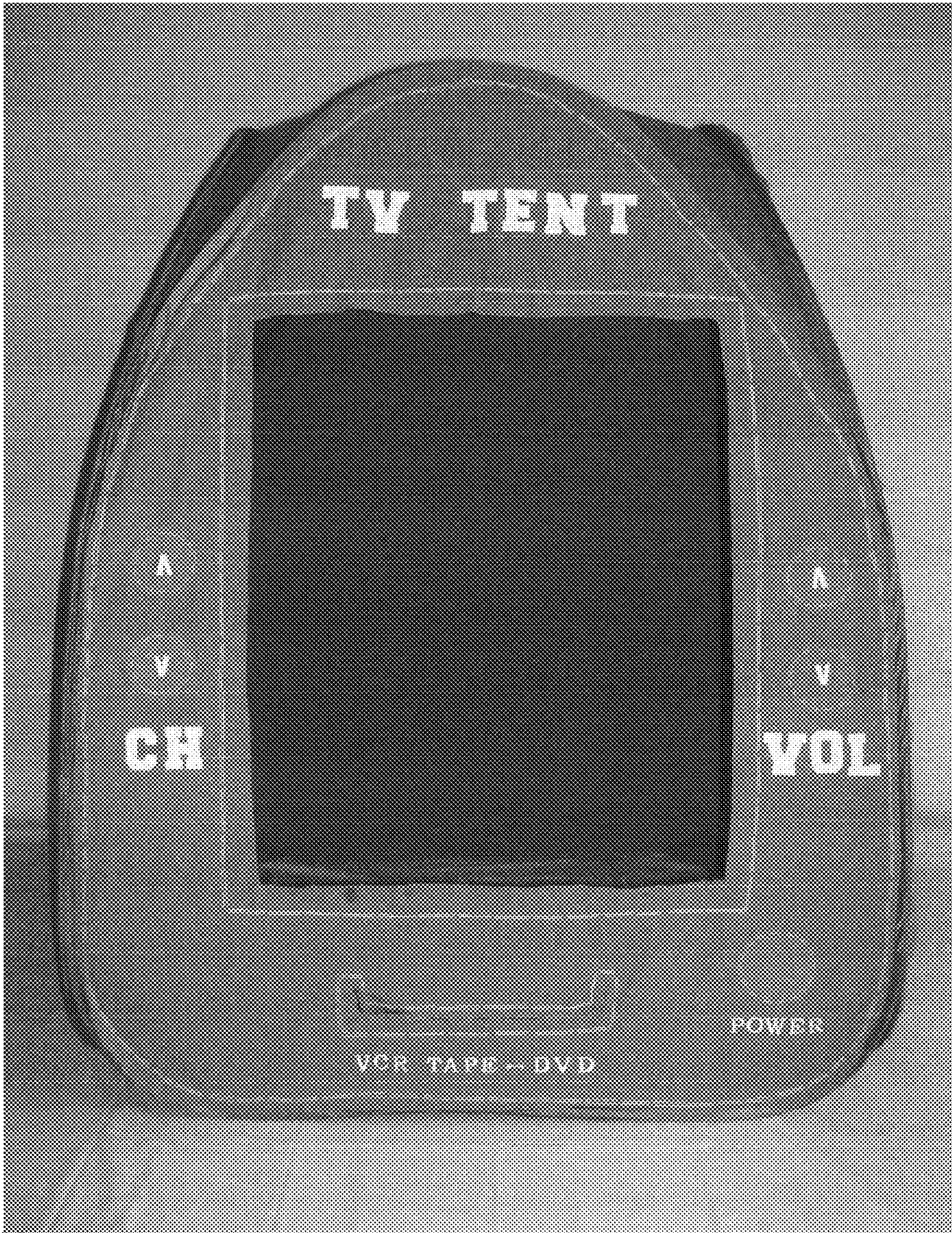

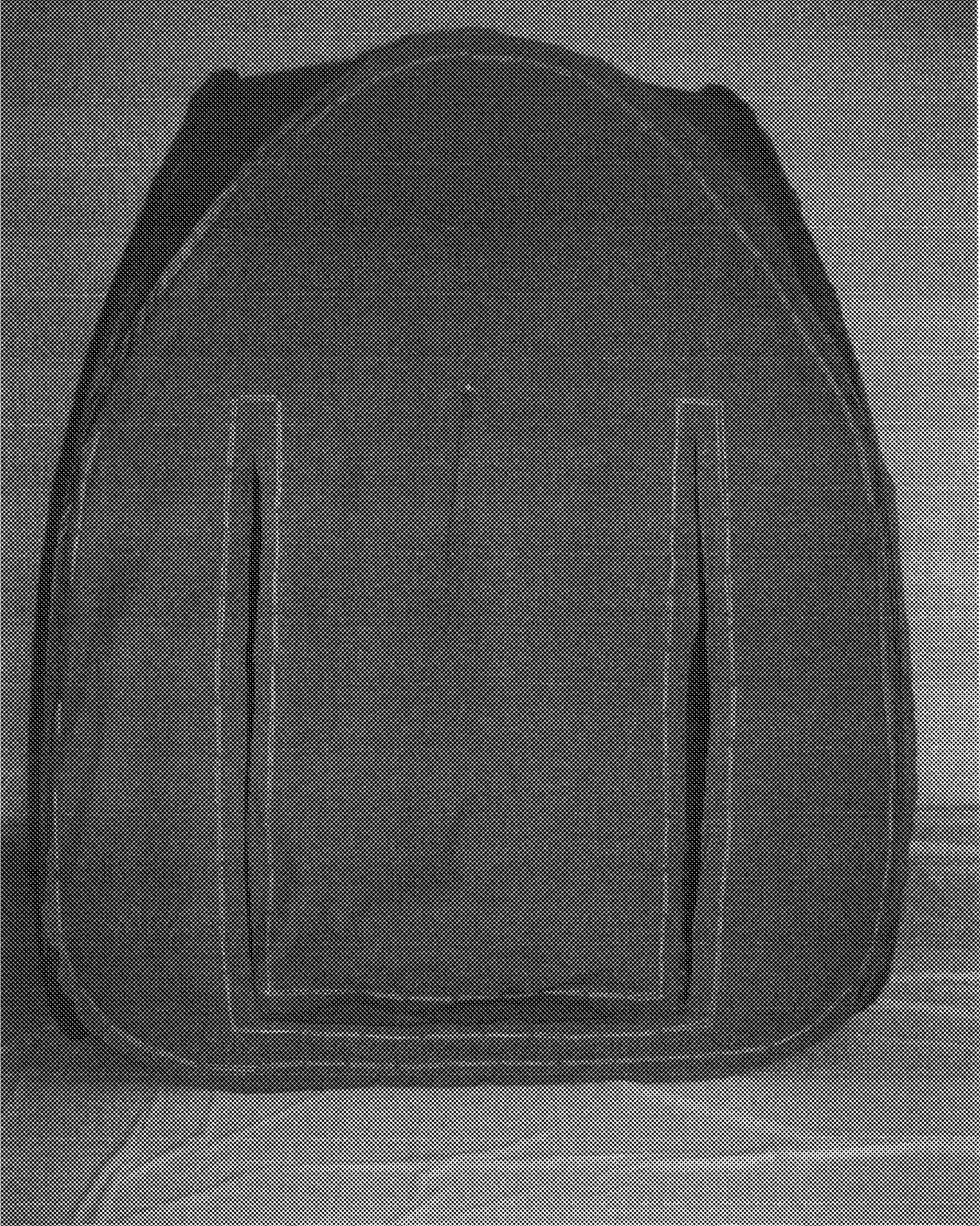

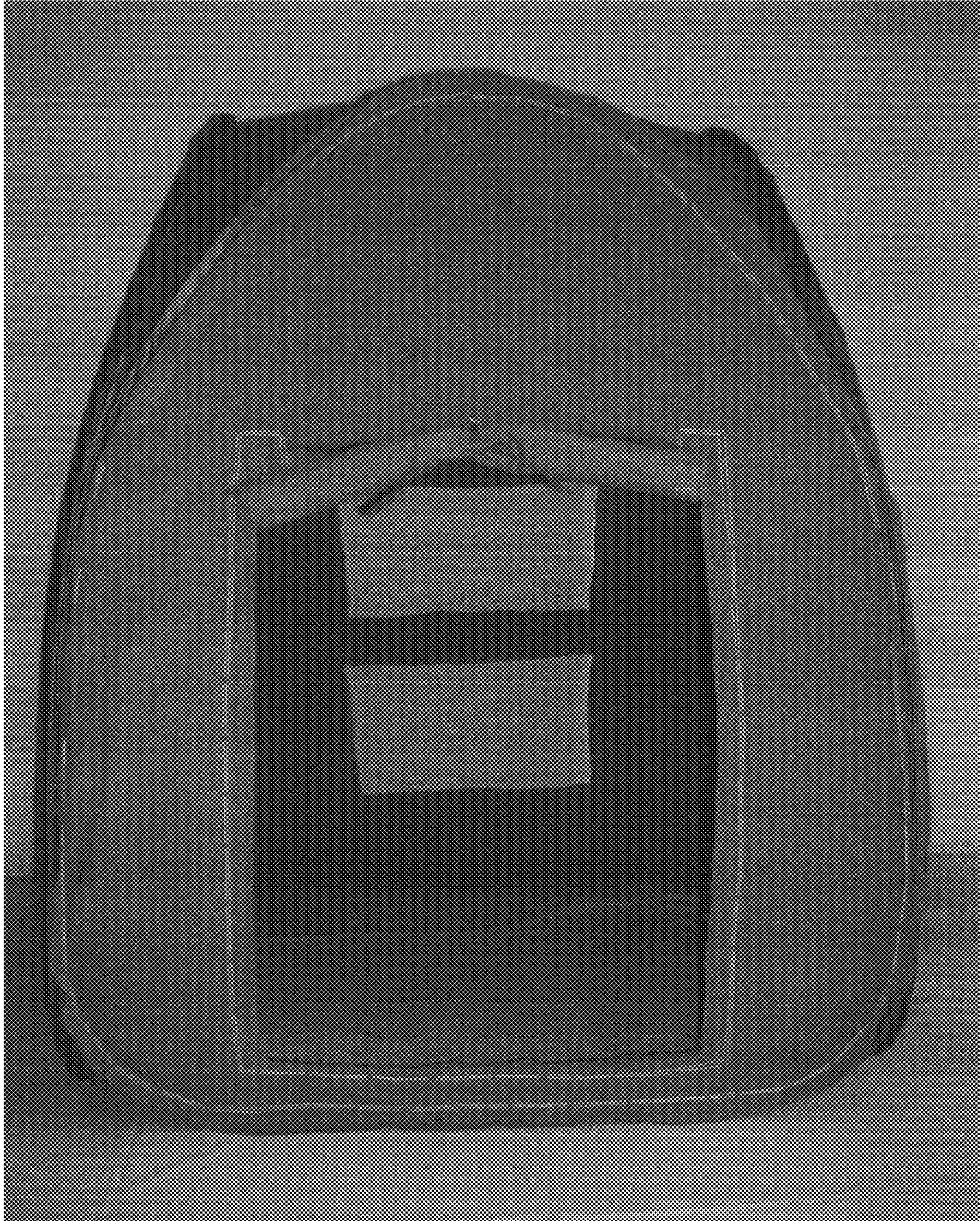

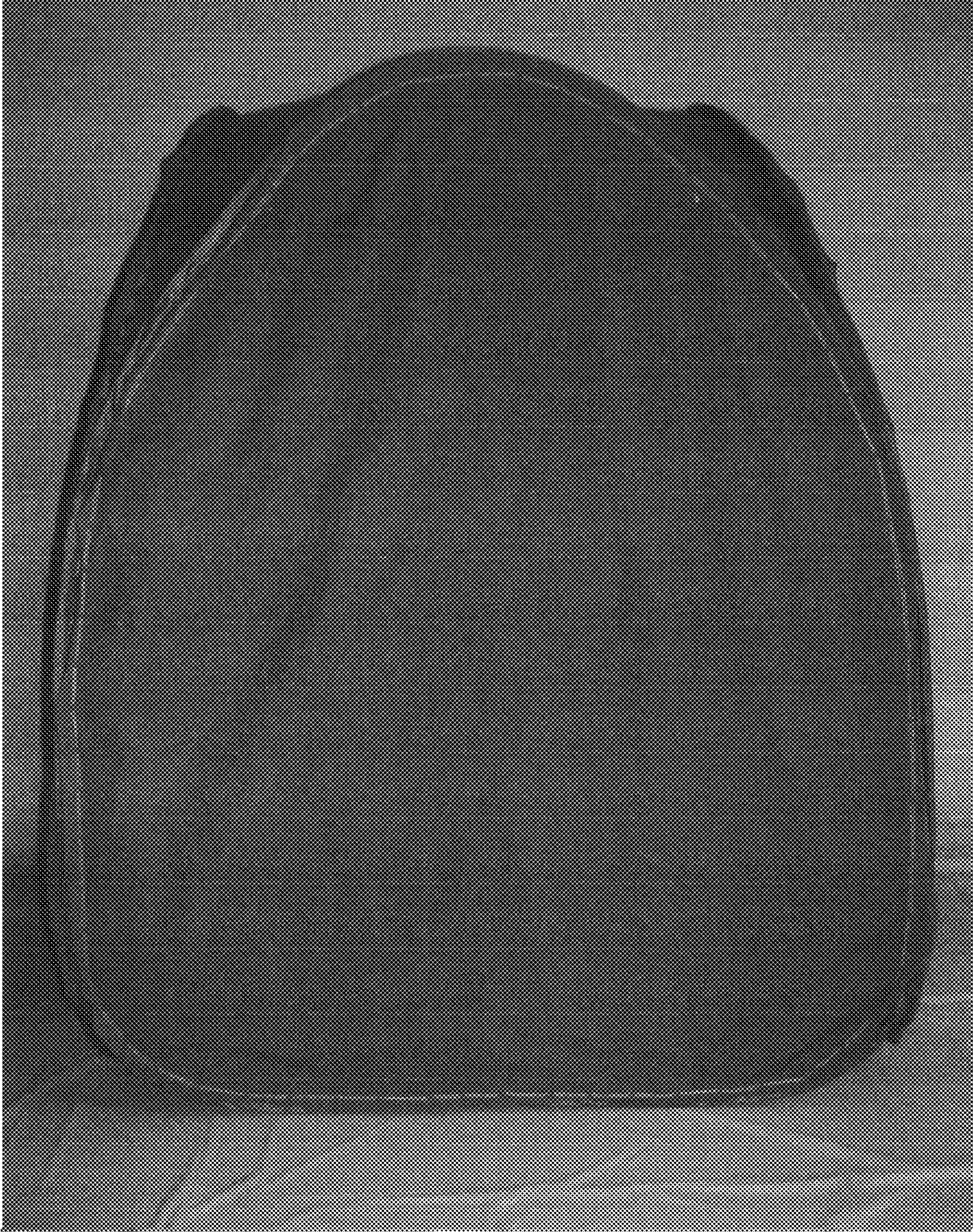

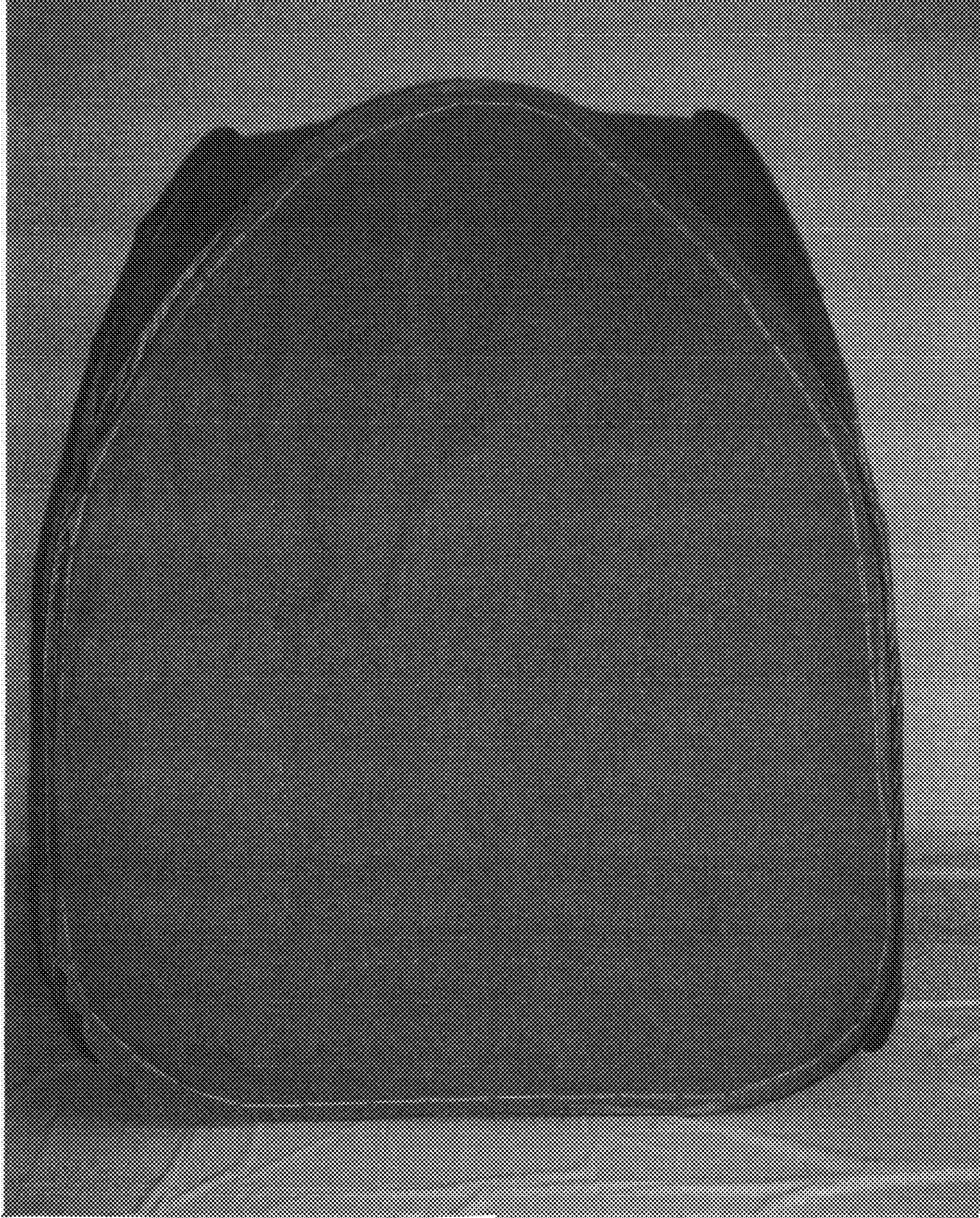

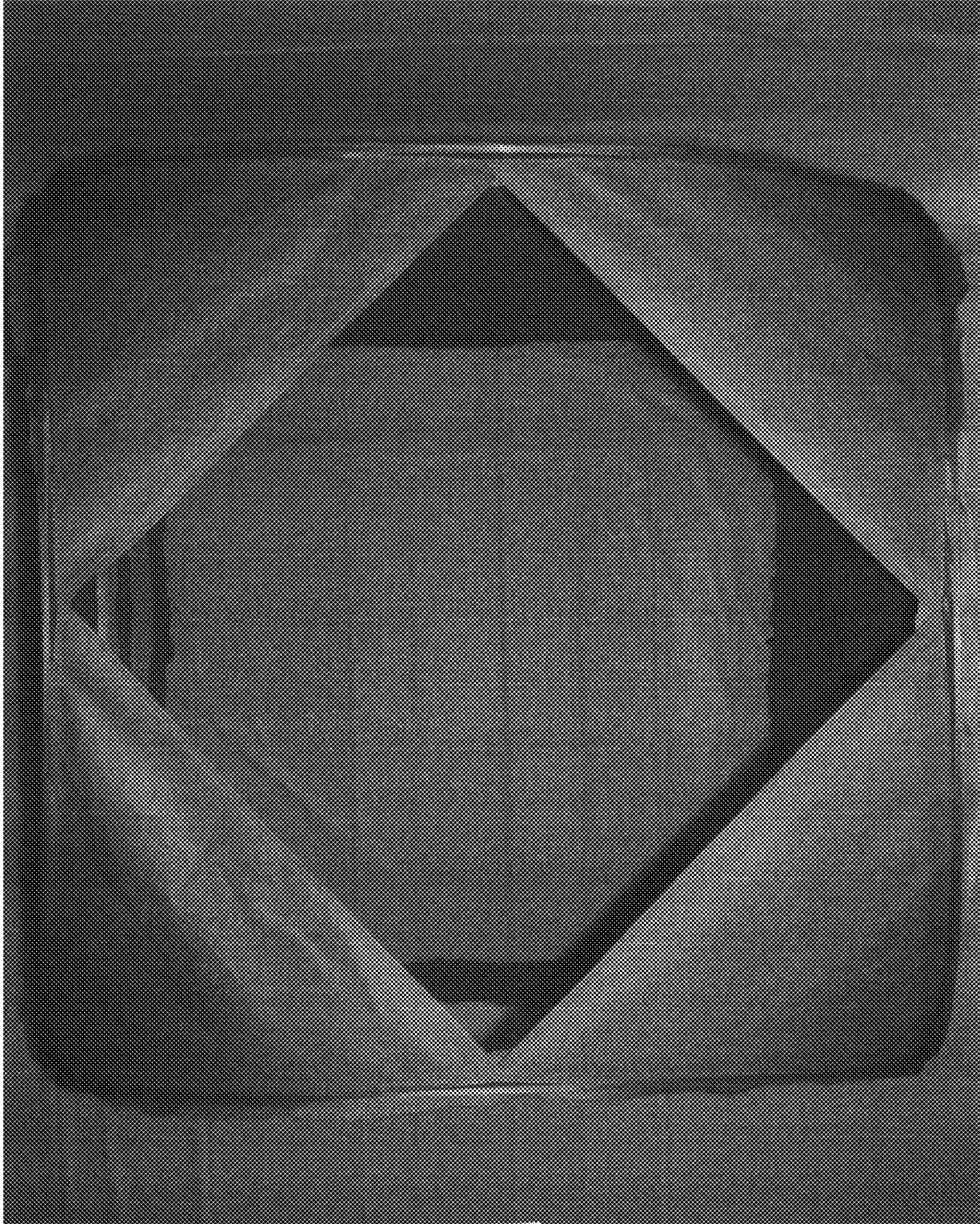

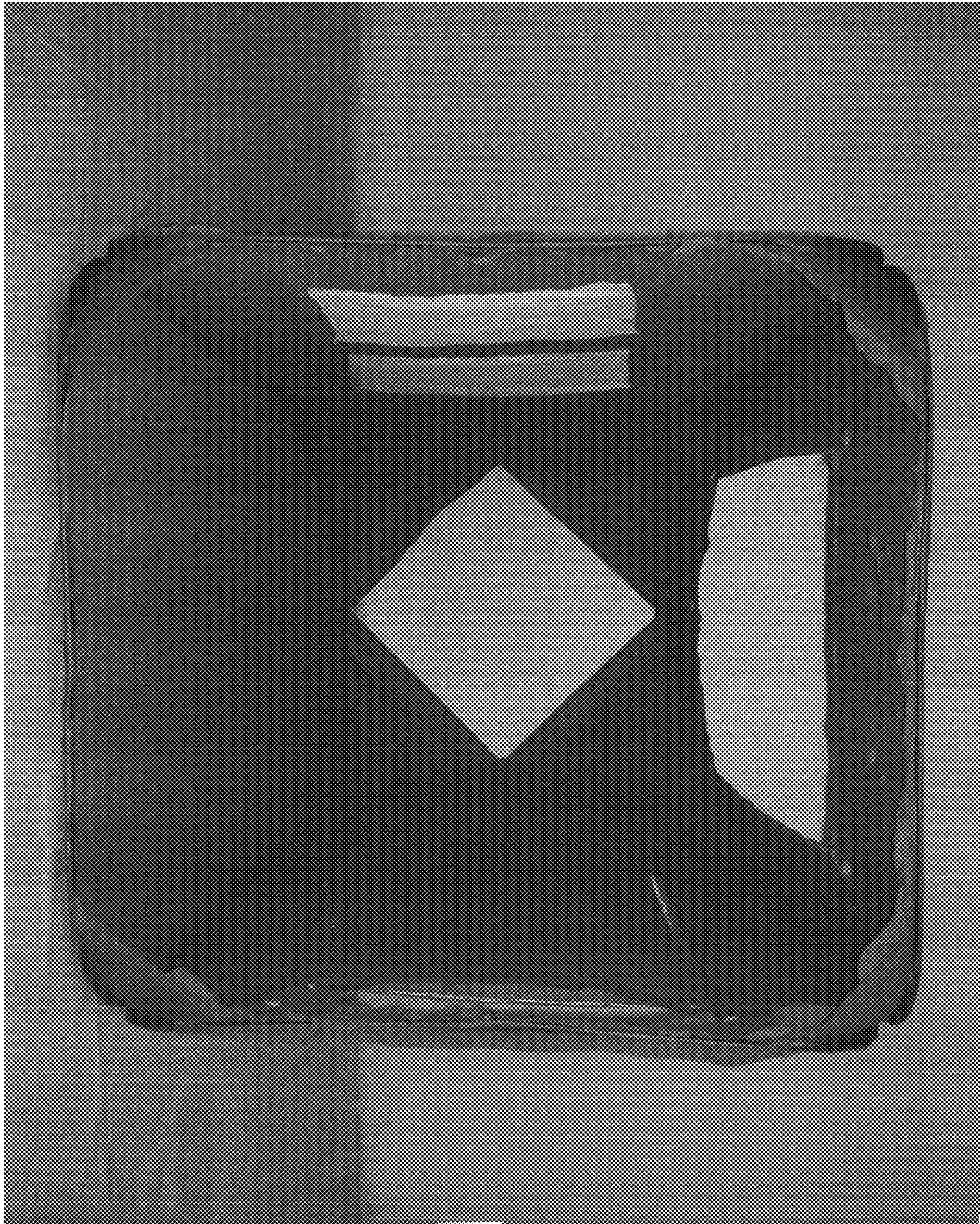

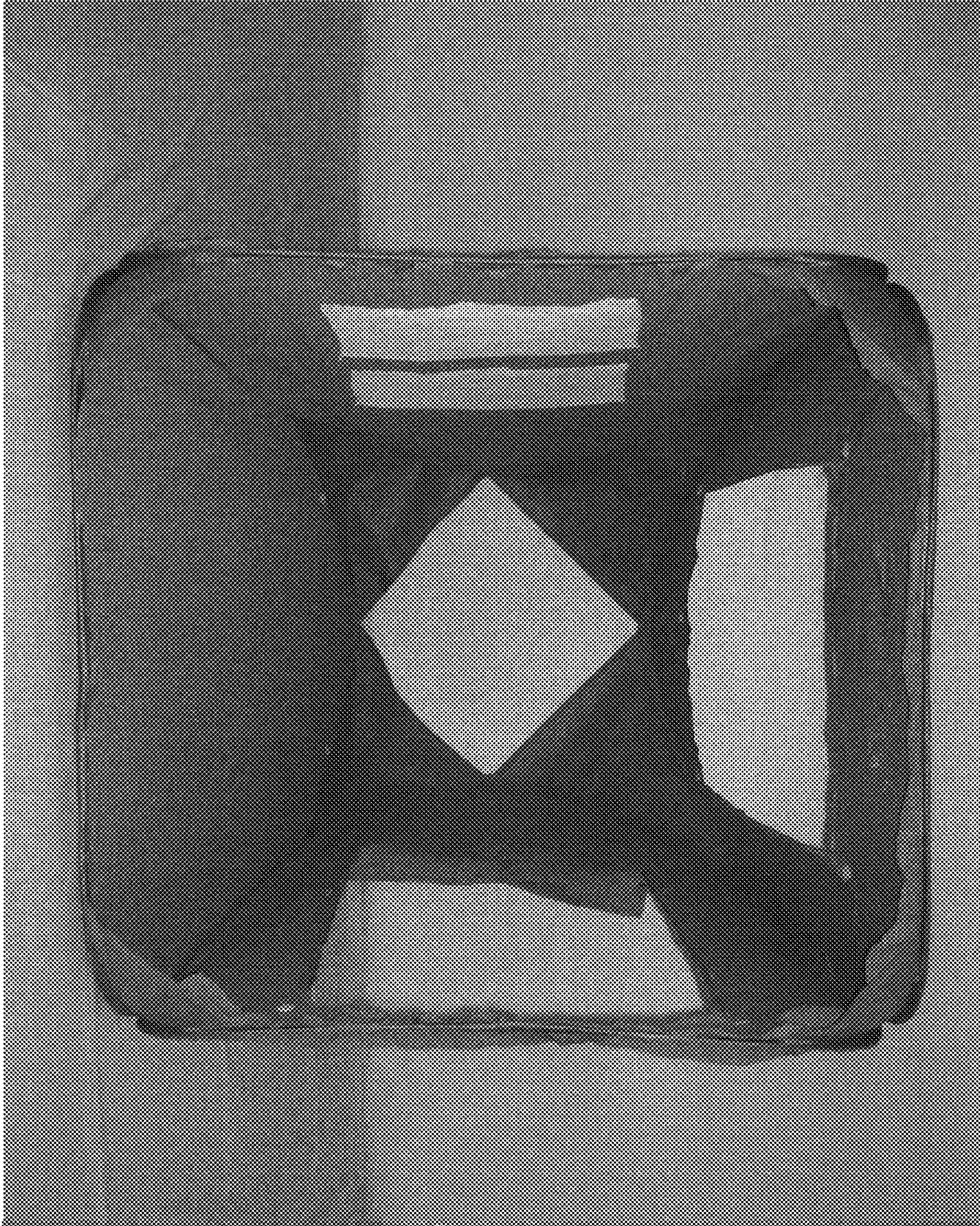

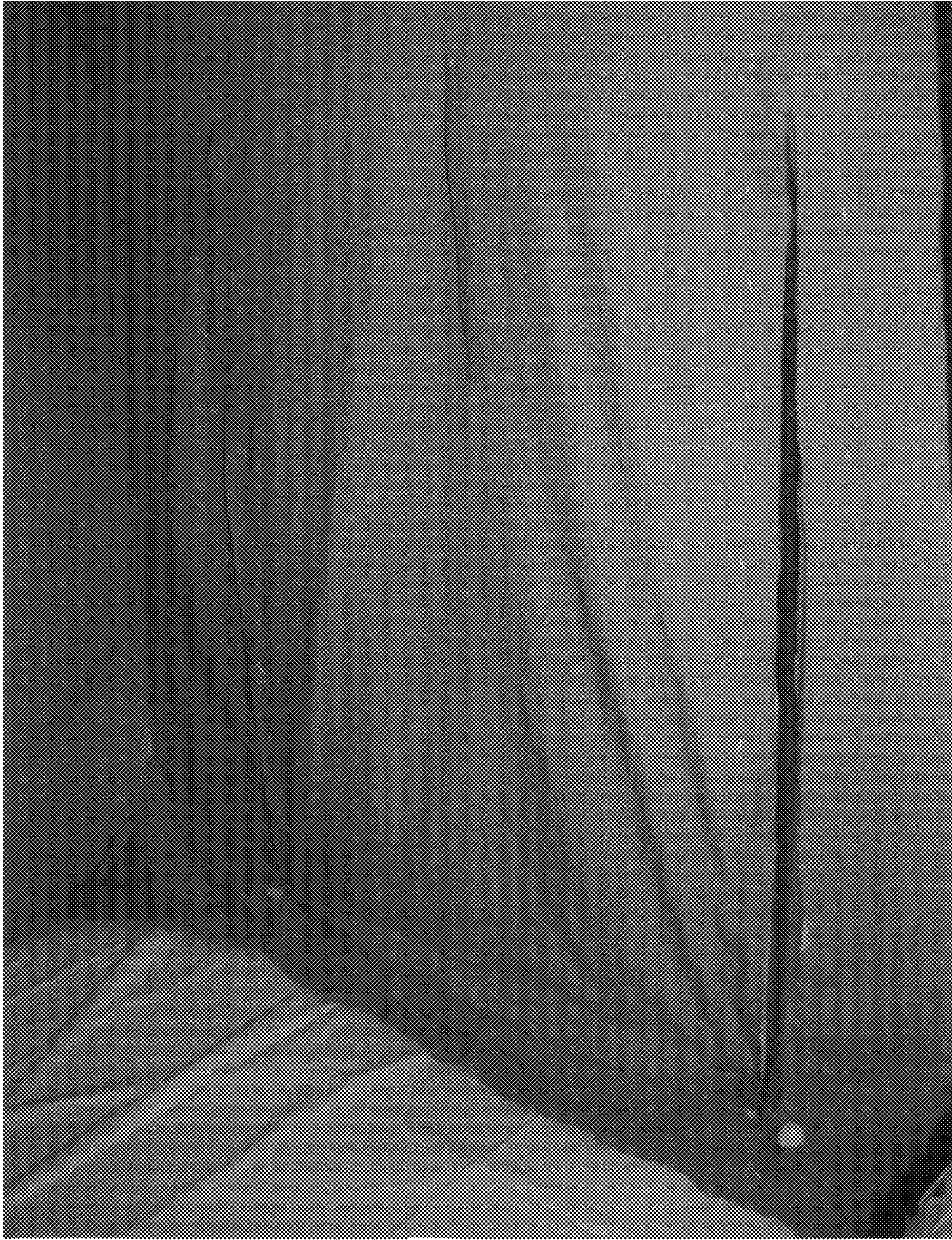

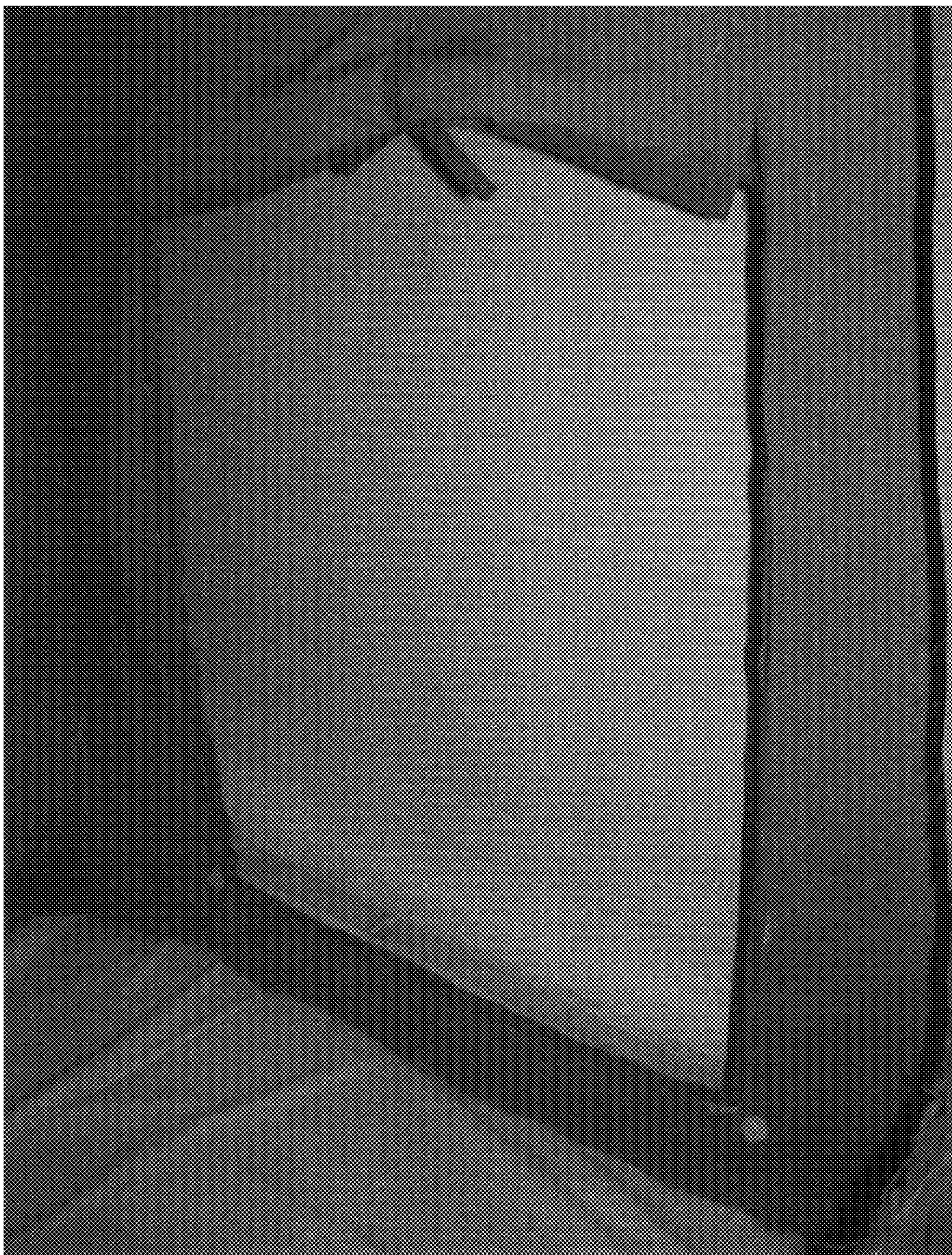

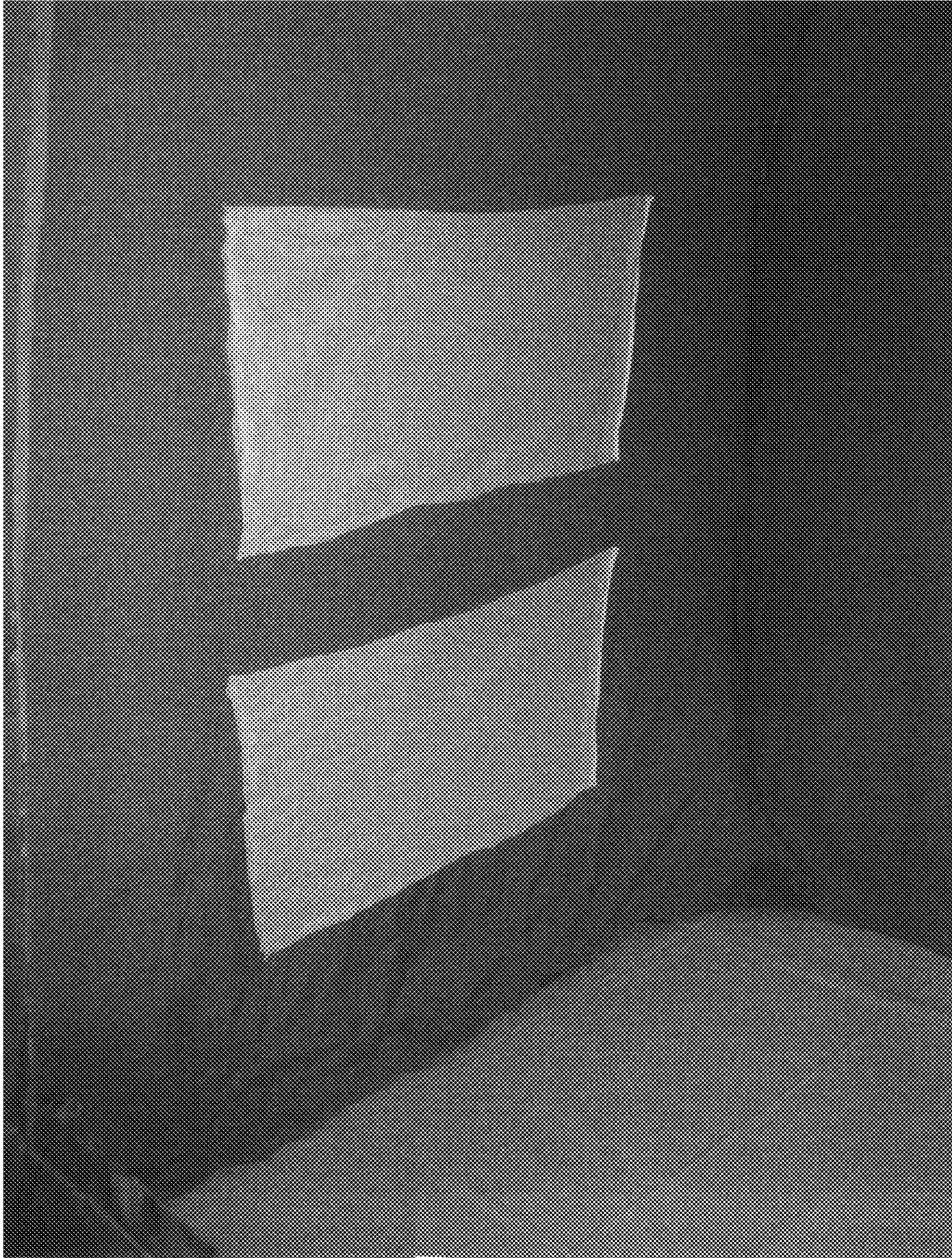

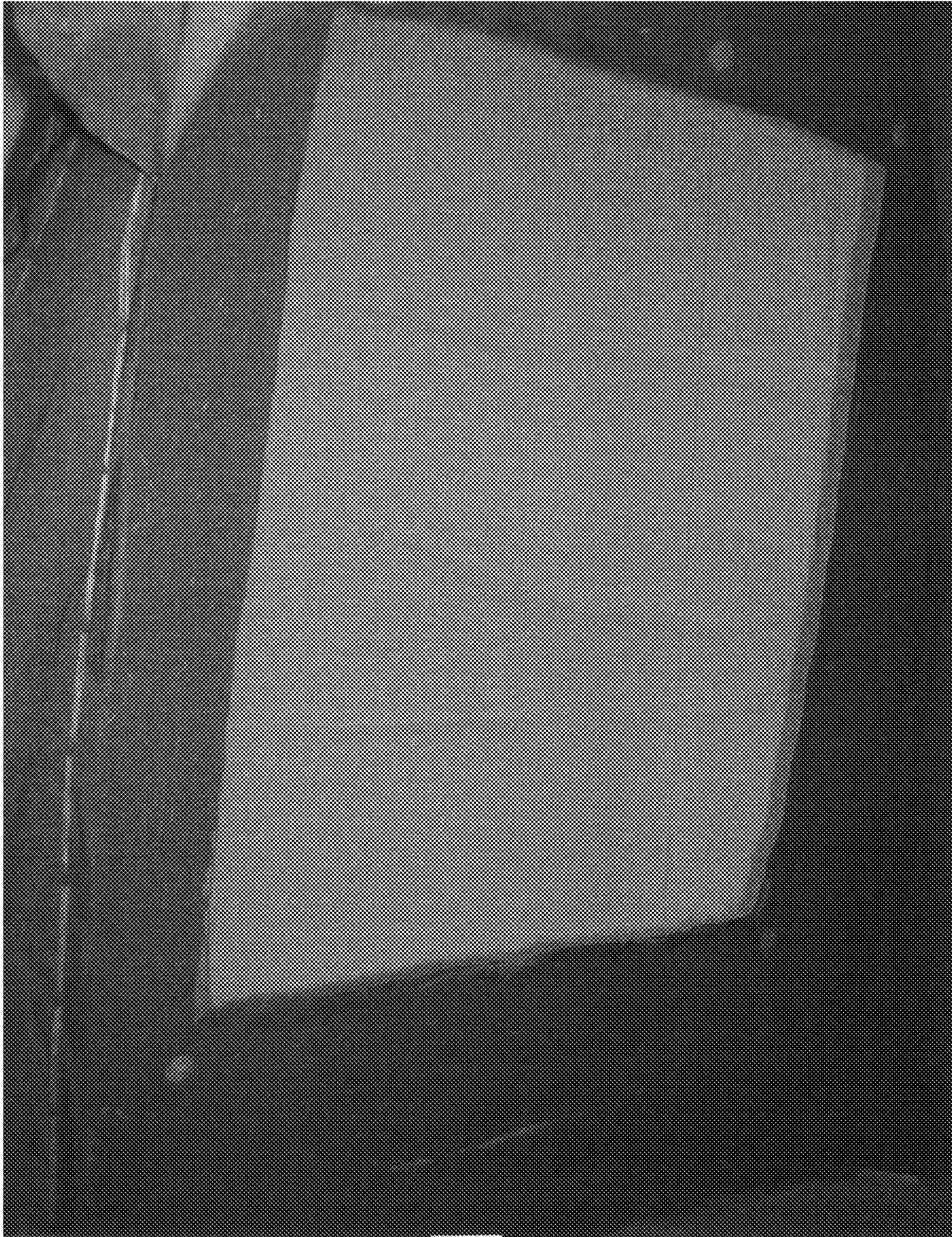

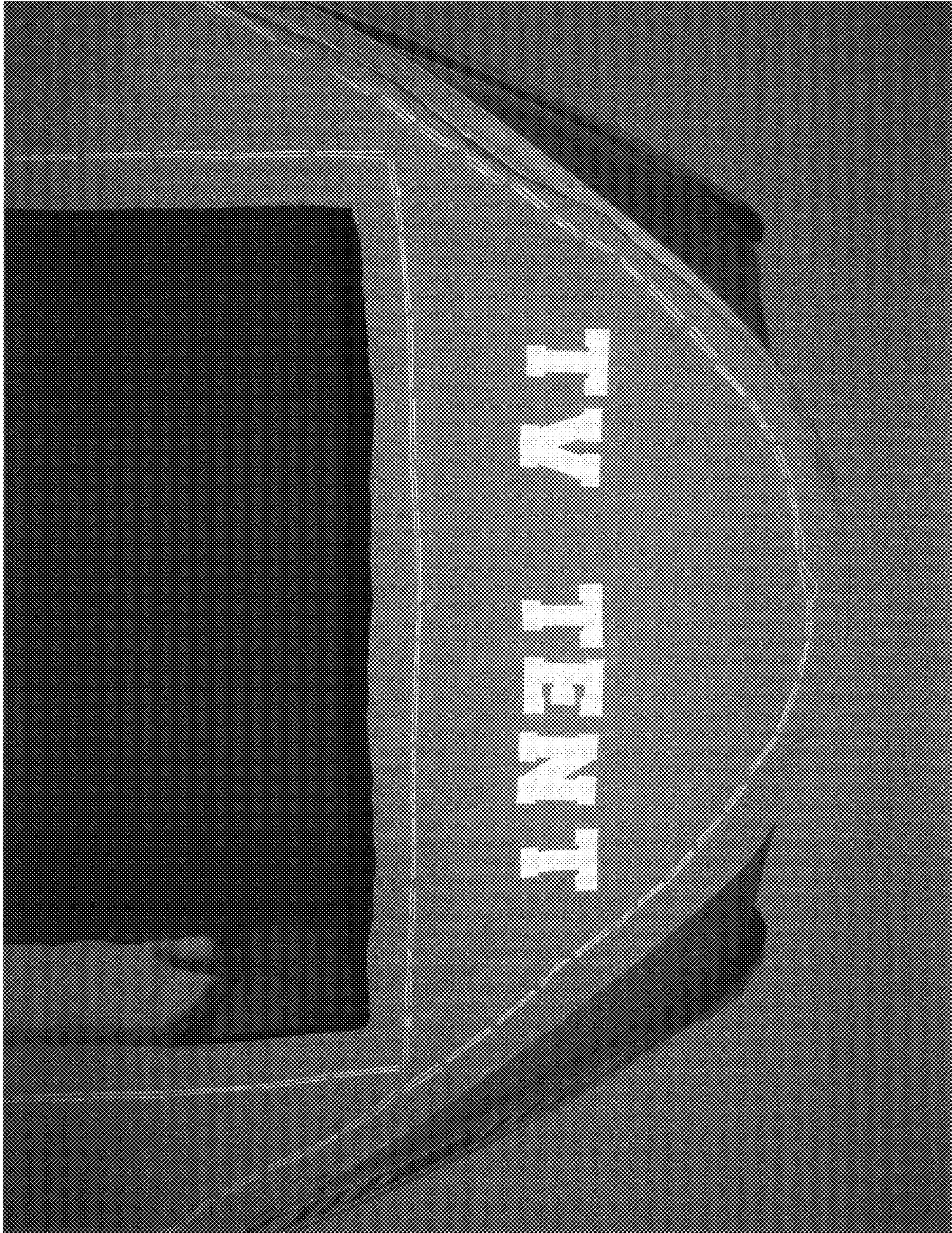

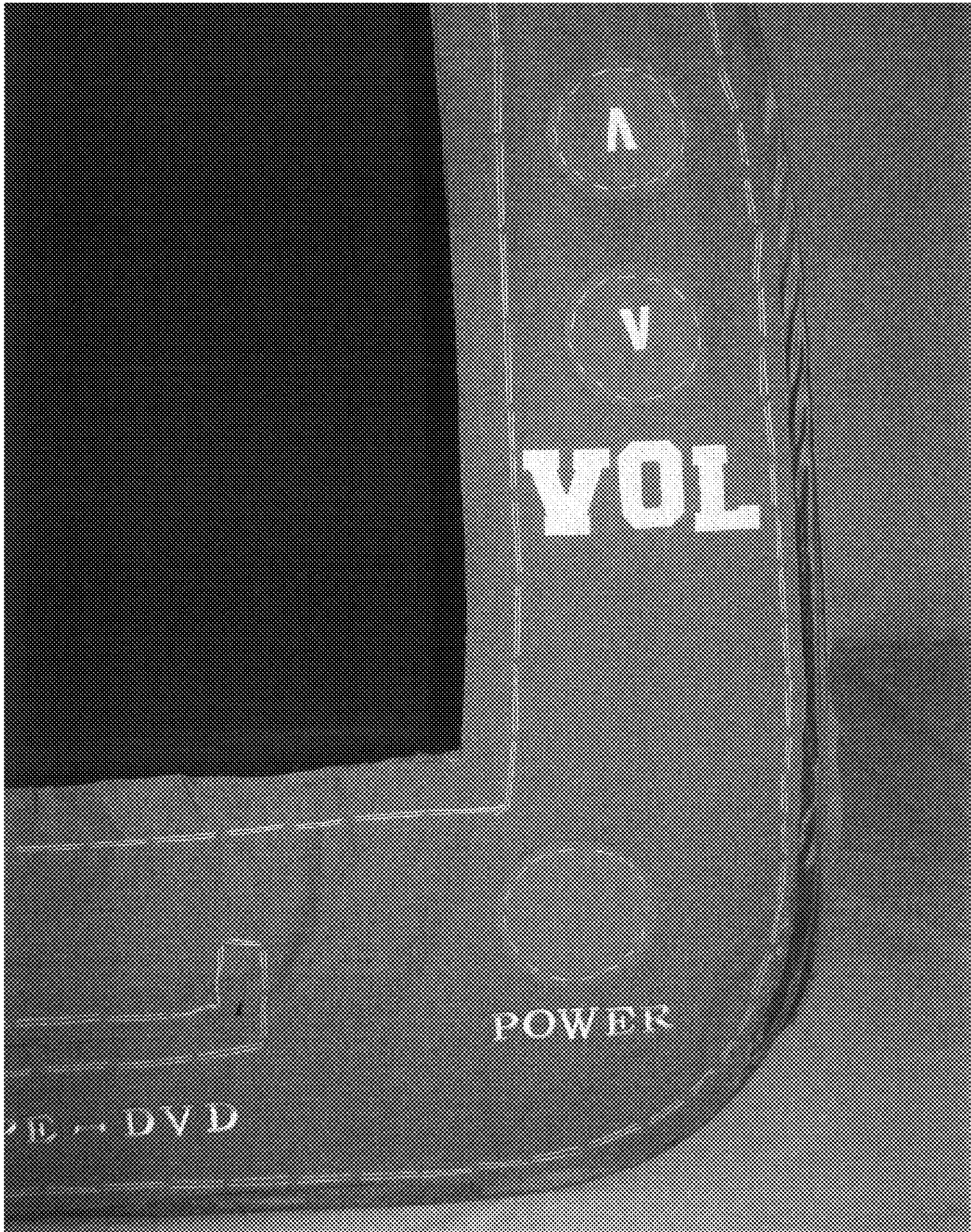

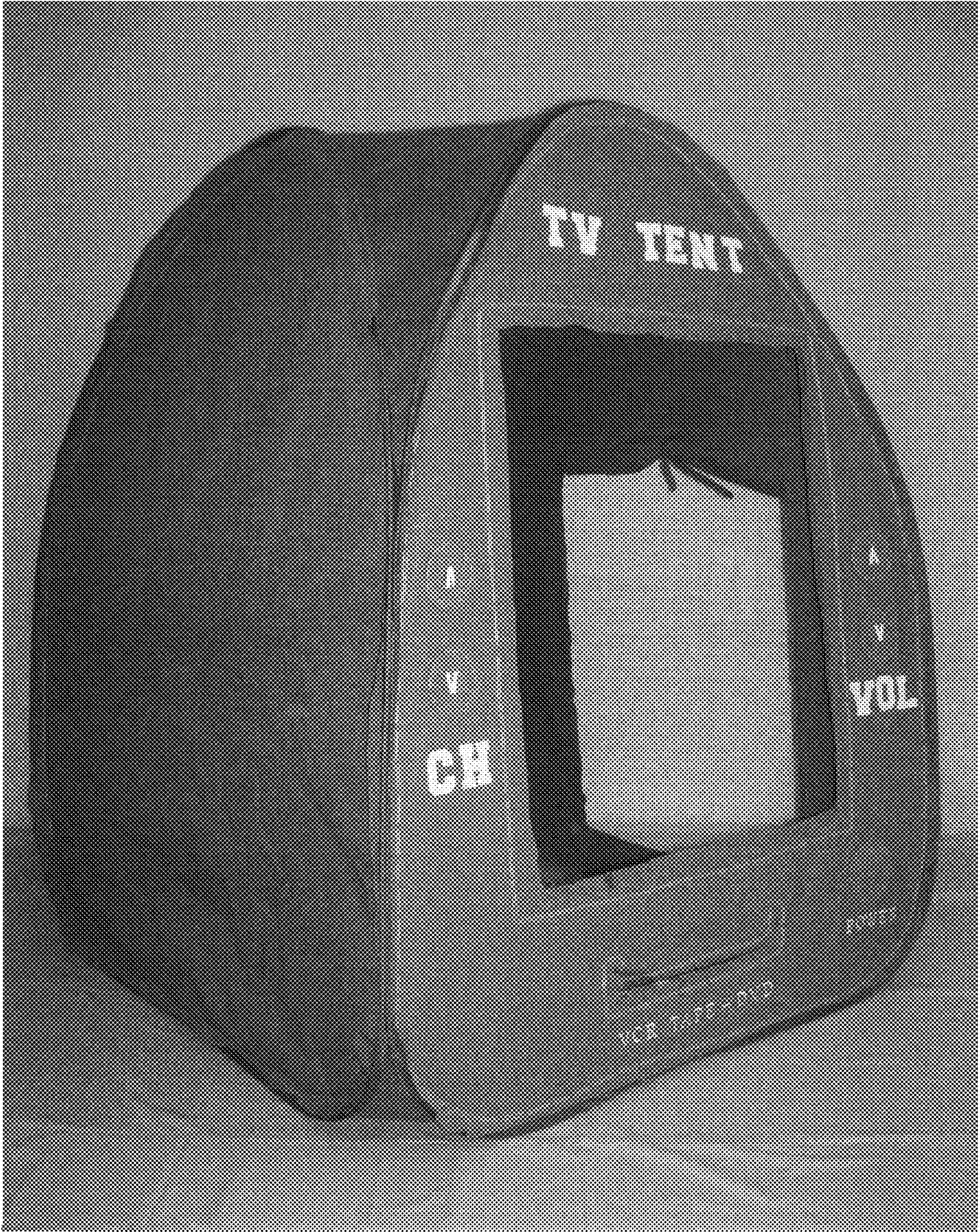

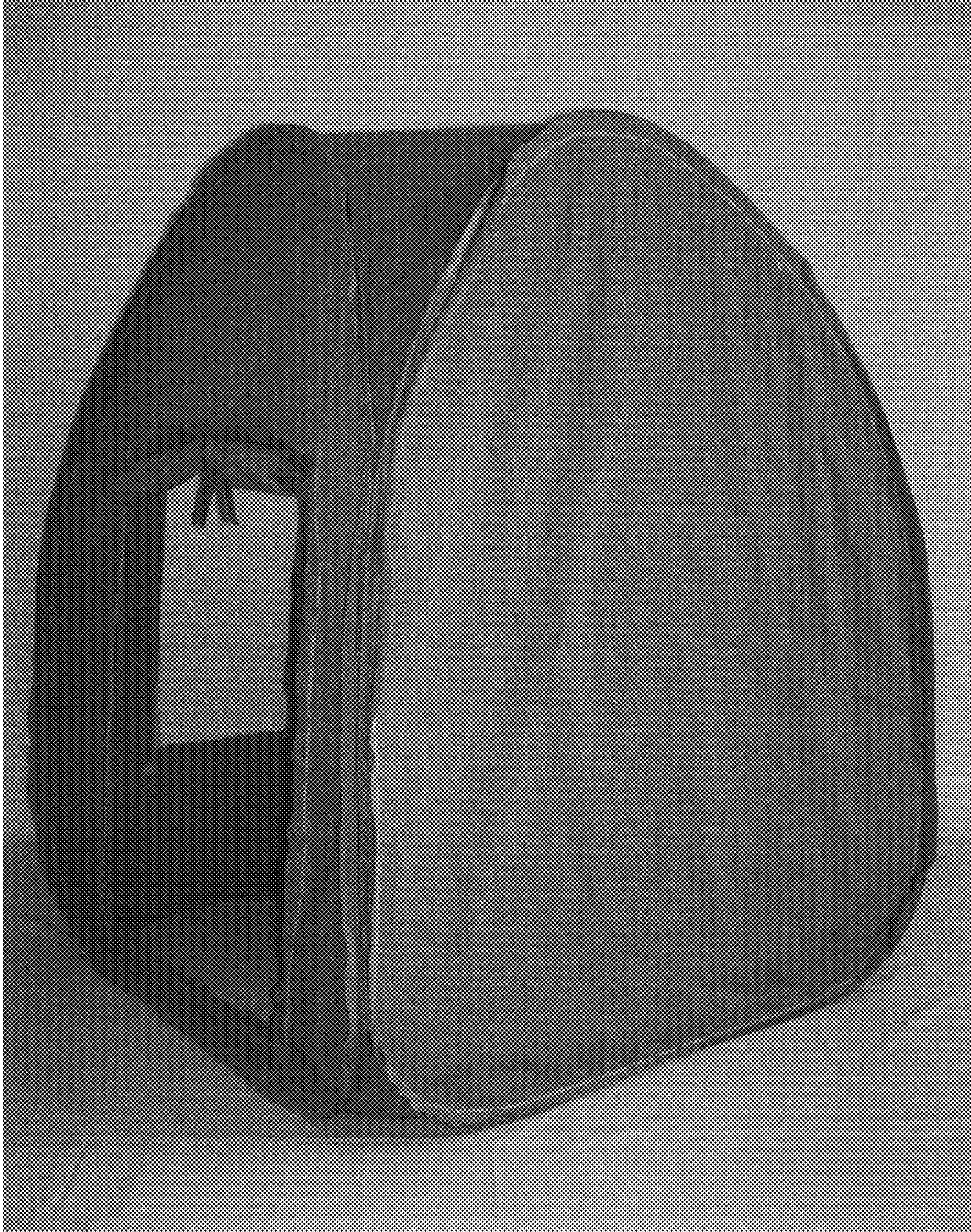

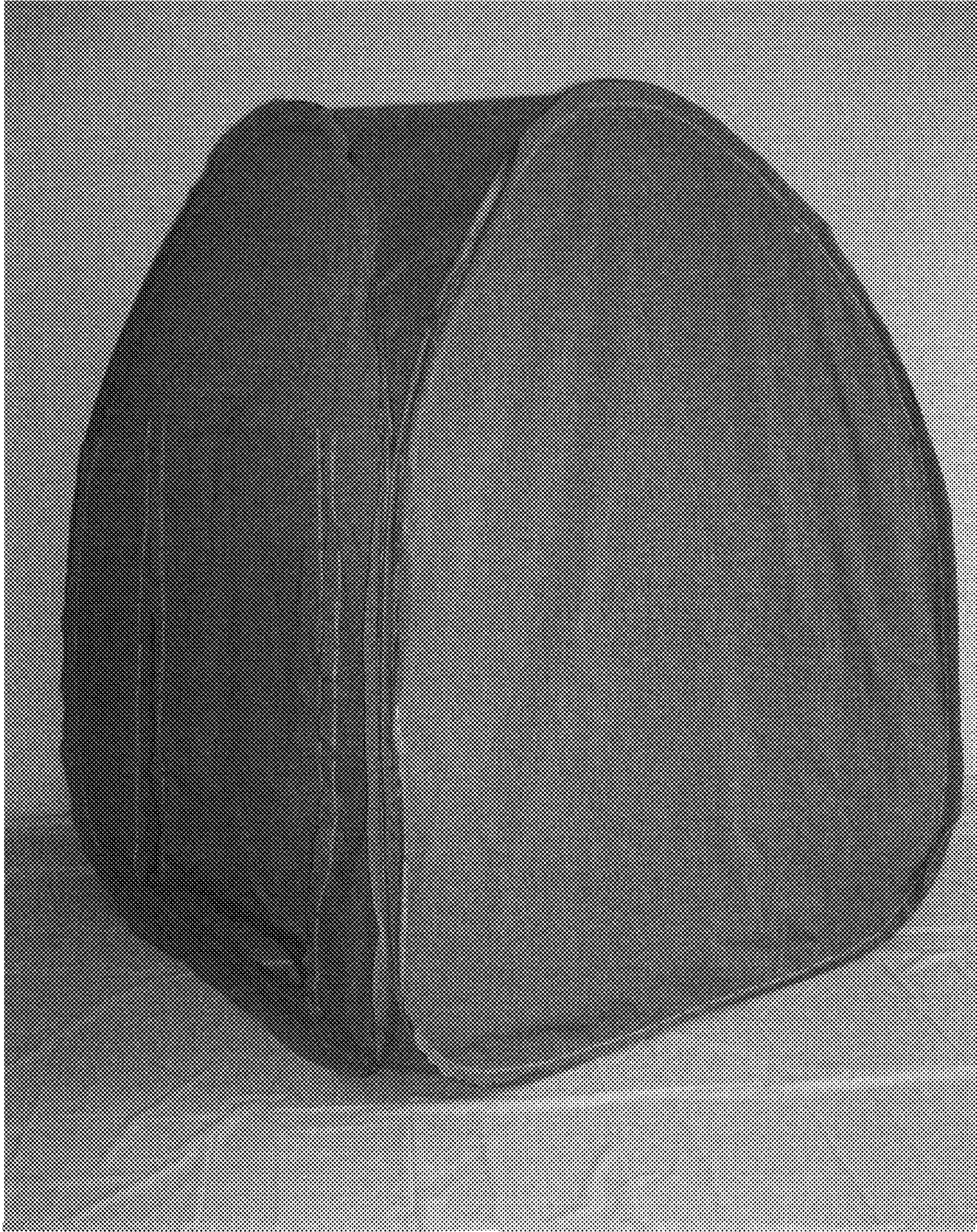

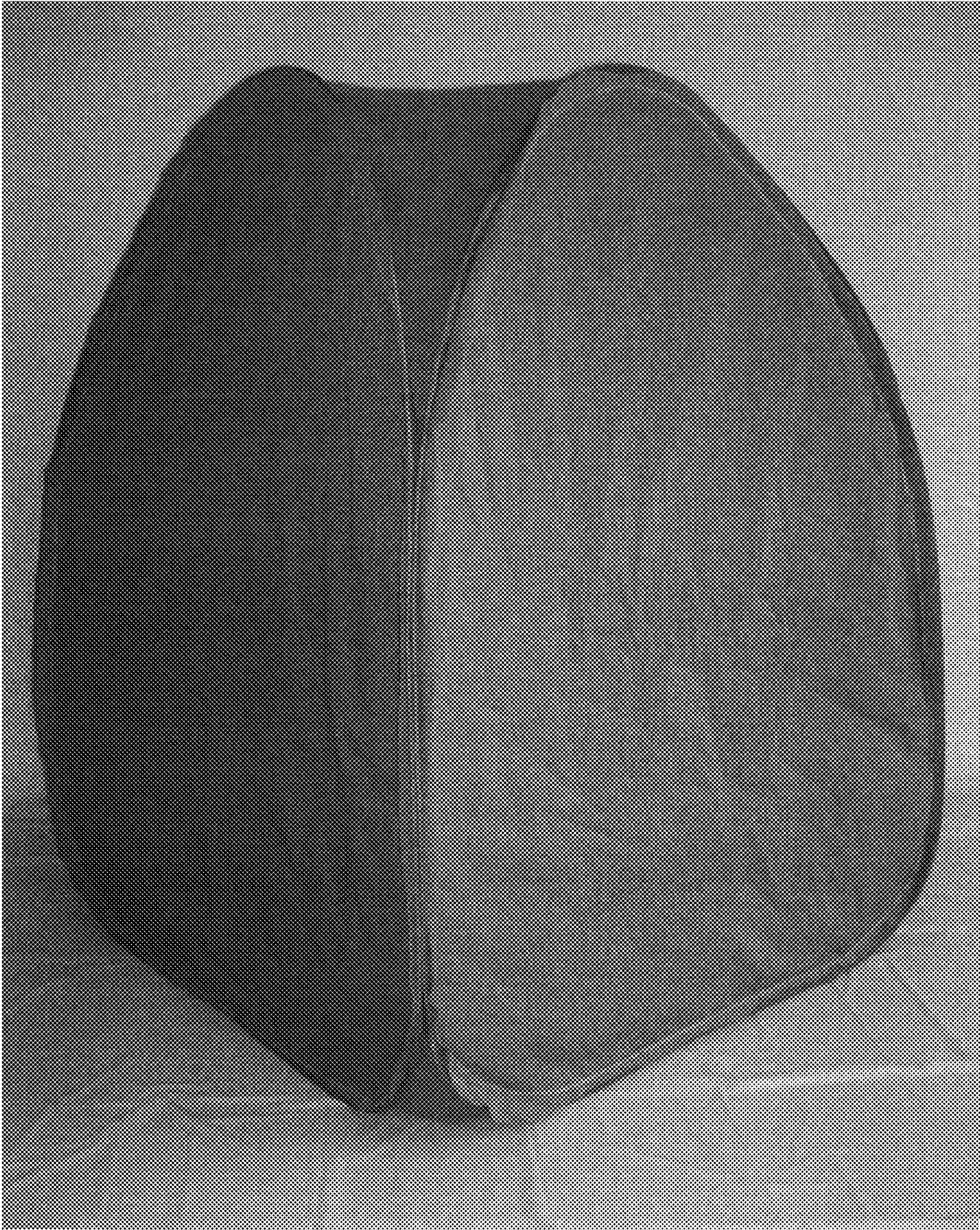
