(57) **CLAIM**

The ornamental design for “serrated sabot,” as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the serrated sabot from the top; FIG. 2 is a front elevation view of the serrated sabot, the back view, the left side view, and the right side view being mirror images thereof;

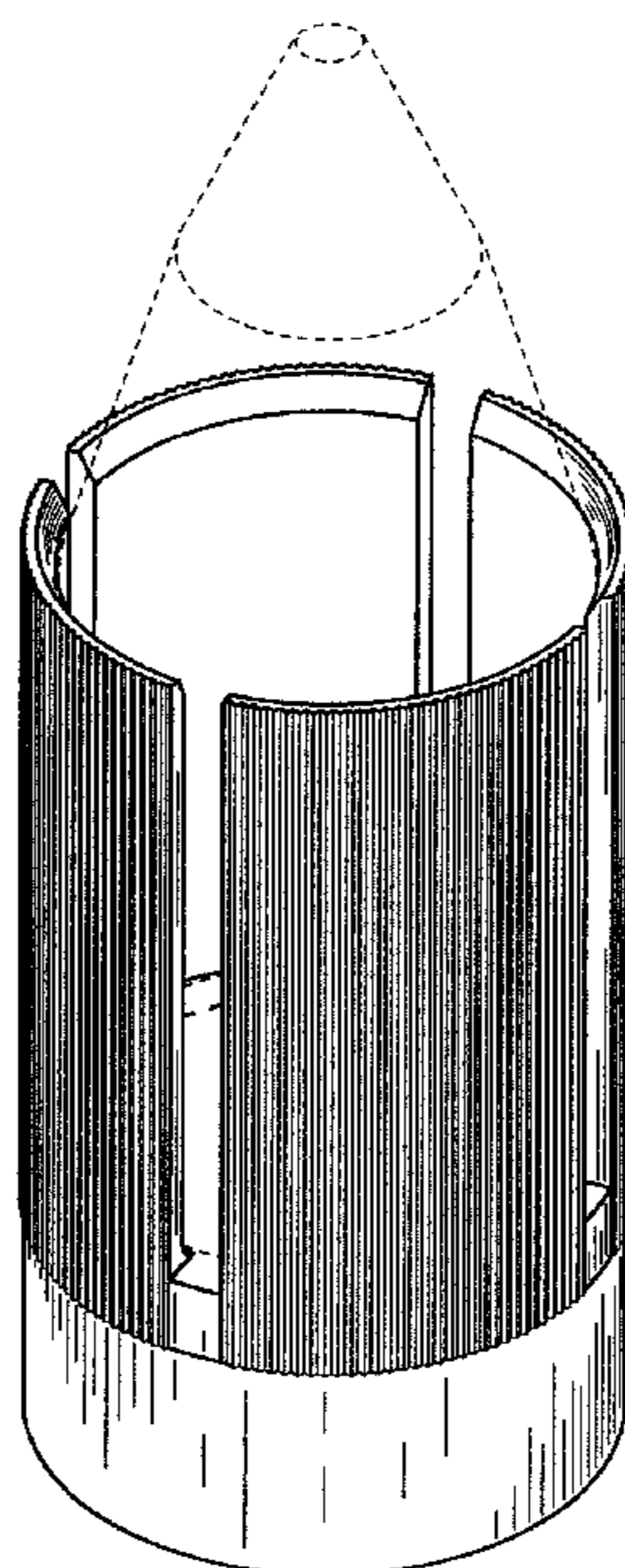
FIG. 3 is a top plan view of the serrated sabot

FIG. 4 is a bottom plan view of the serrated sabot; and,

FIG. 5 is another perspective view of the serrated sabot from the bottom.

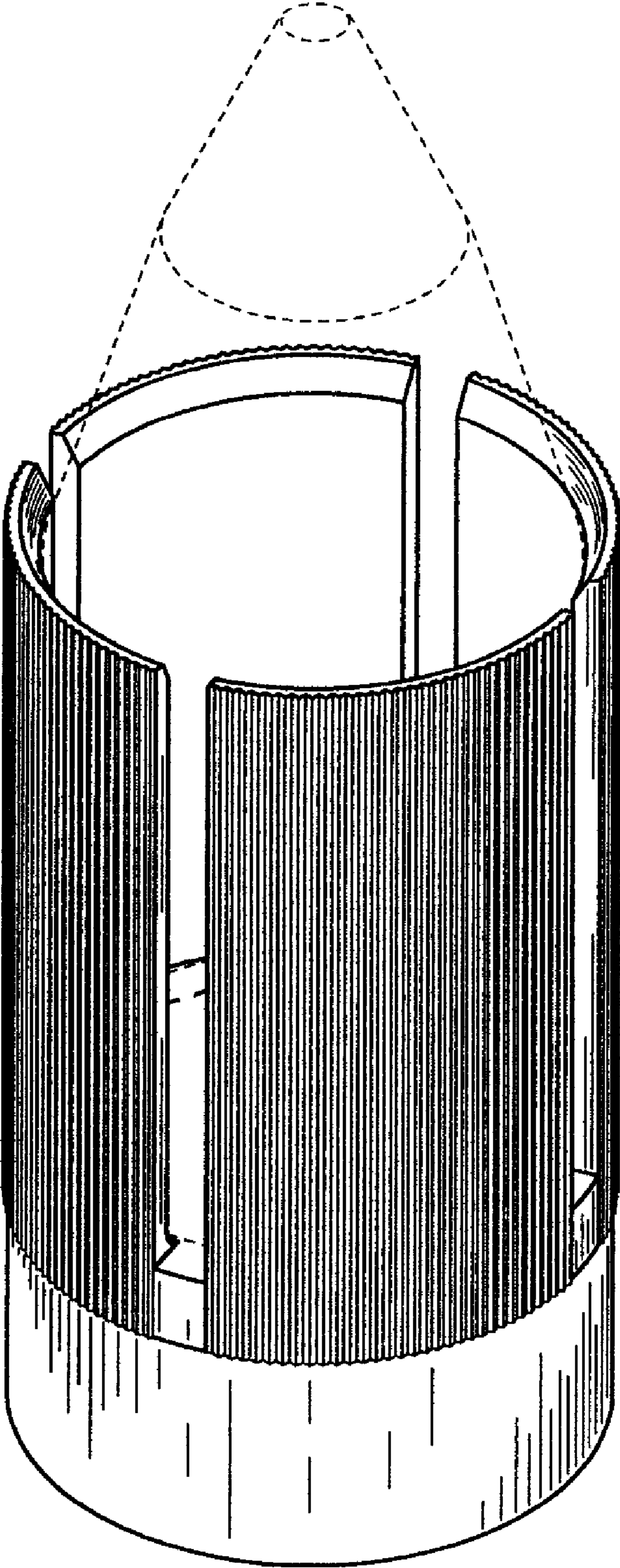

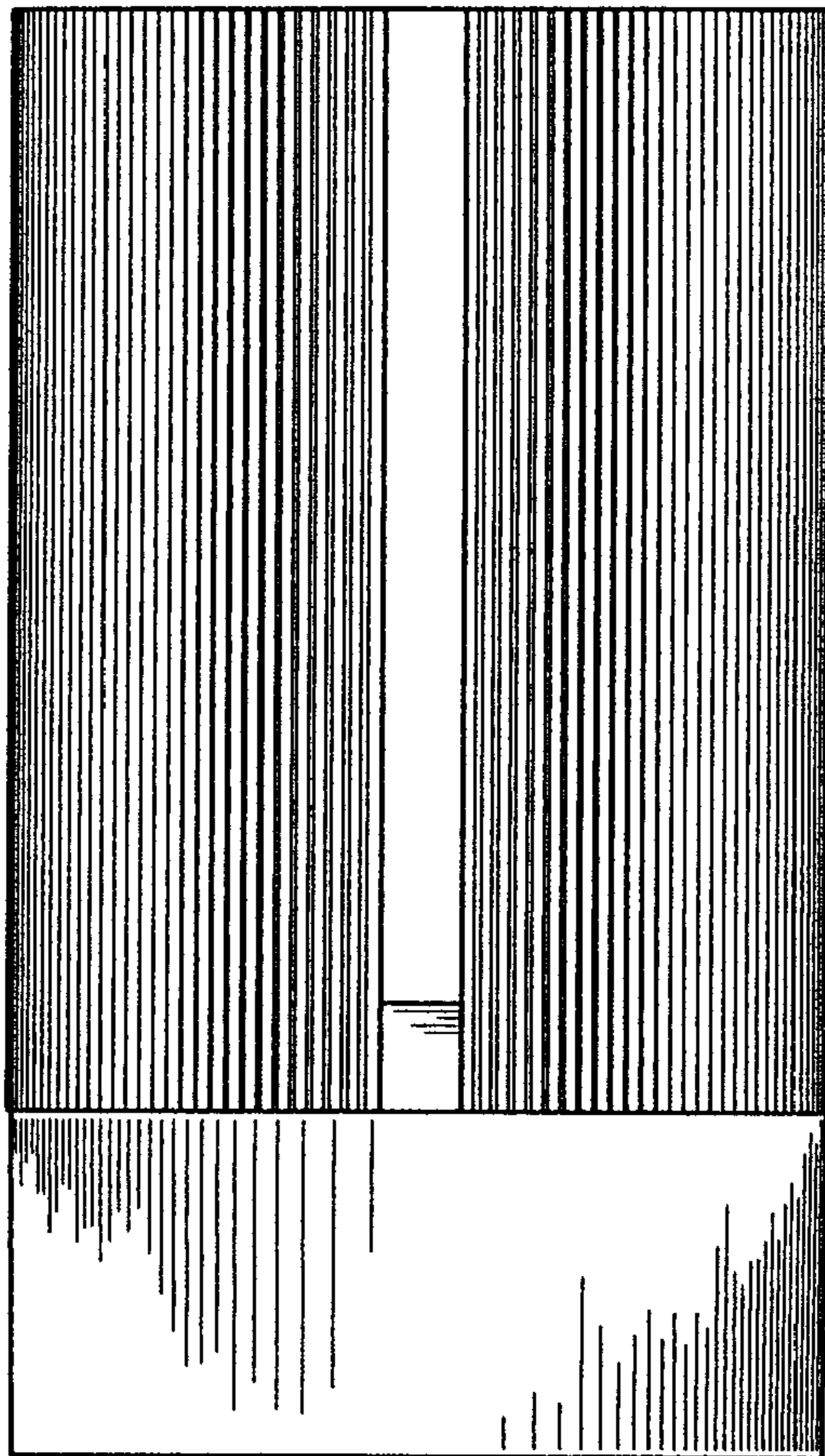

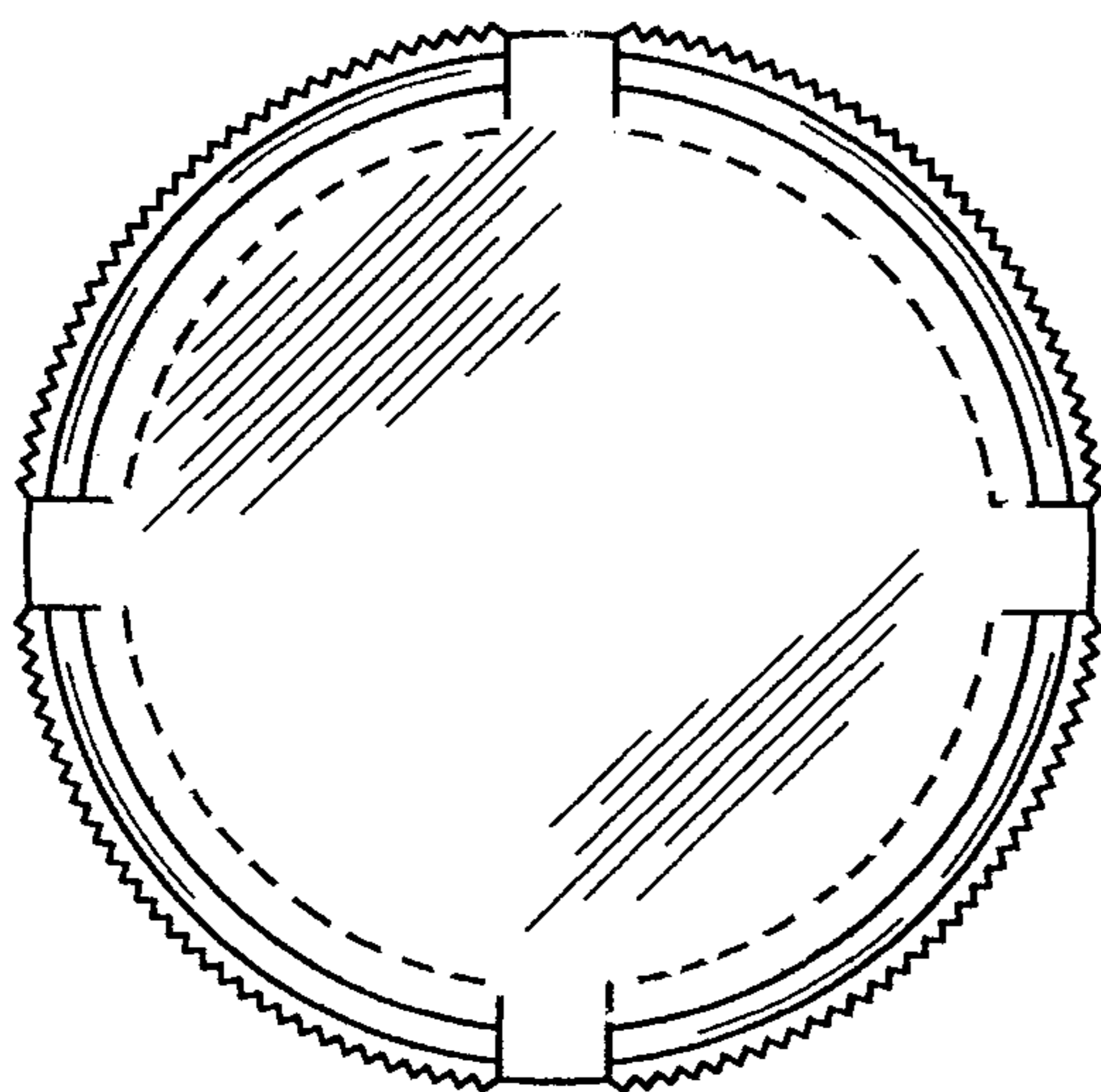

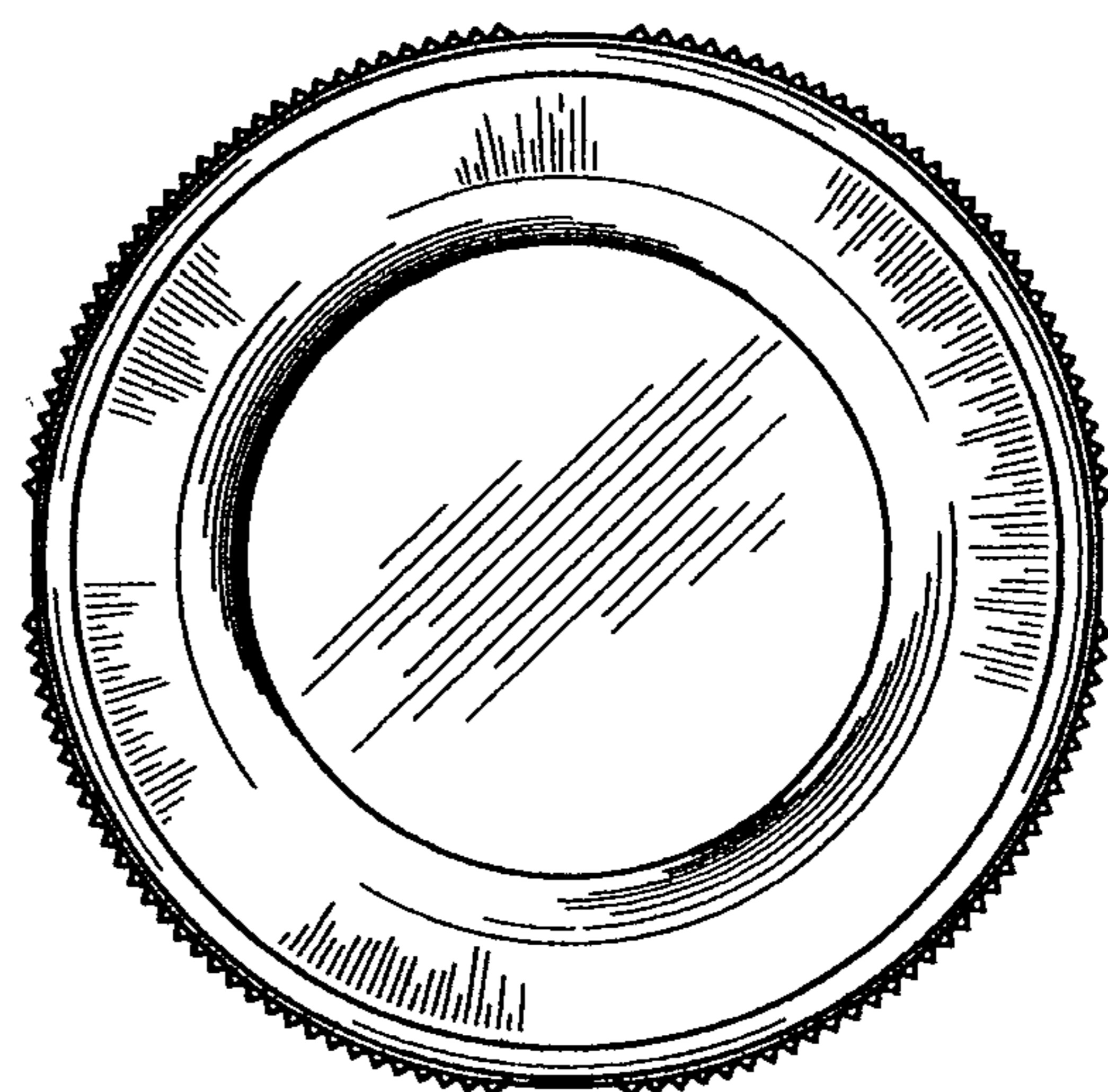

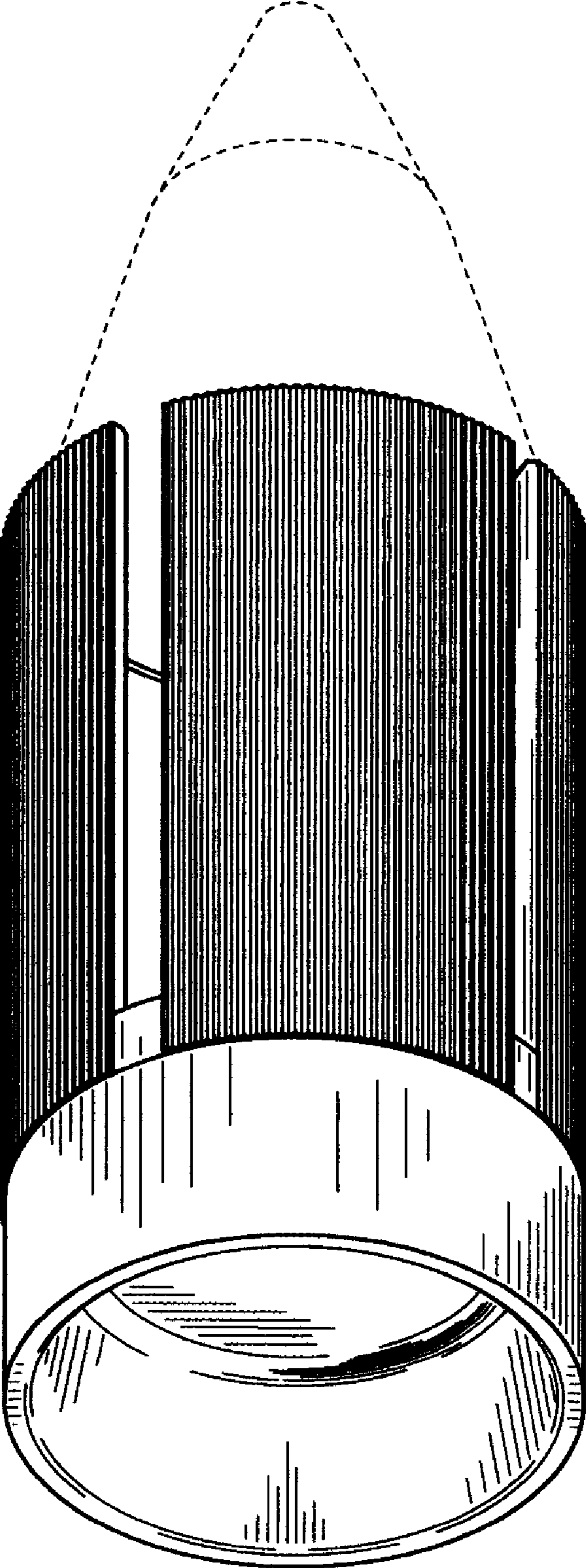
