(57) **CLAIM**

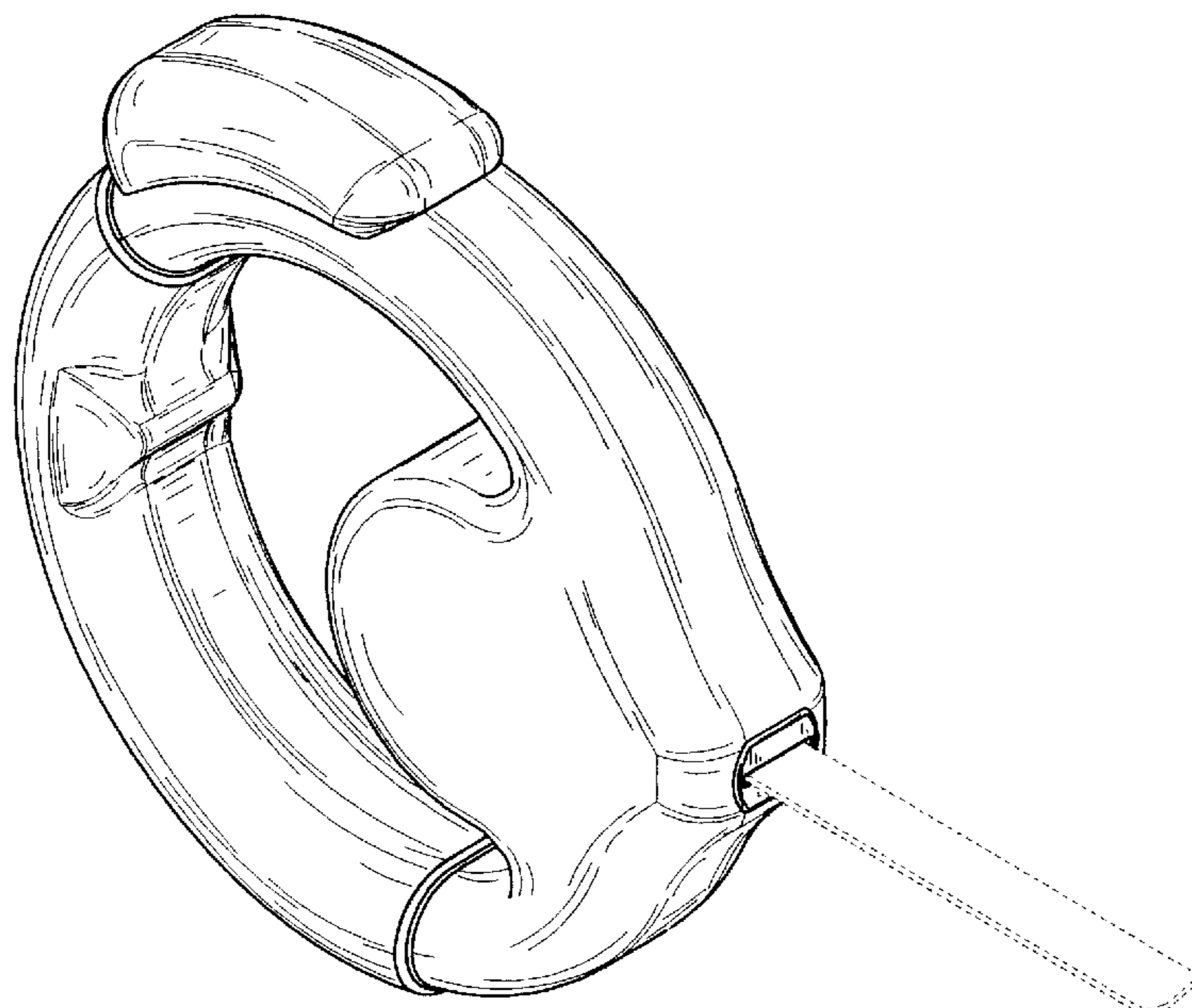
We claim the ornamental design for a ring-shaped retractable pet leash, as shown.

DESCRIPTION

FIG. 1 is perspective view of a ring-shaped retractable pet leash in accordance with the present invention;
FIG. 2 is a side view of the retractable pet leash of FIG. 1.
FIG. 3 is a front view of the retractable pet leash of FIG. 1.
FIG. 4 is a top view of the retractable pet leash of FIG. 1;
FIG. 5 is a bottom view of the retractable pet leash of FIG. 1; and,
FIG. 6 is a back view of the retractable pet leash of FIG. 1.
The broken line showing of a leash strap is for environmental illustration and is not claimed.

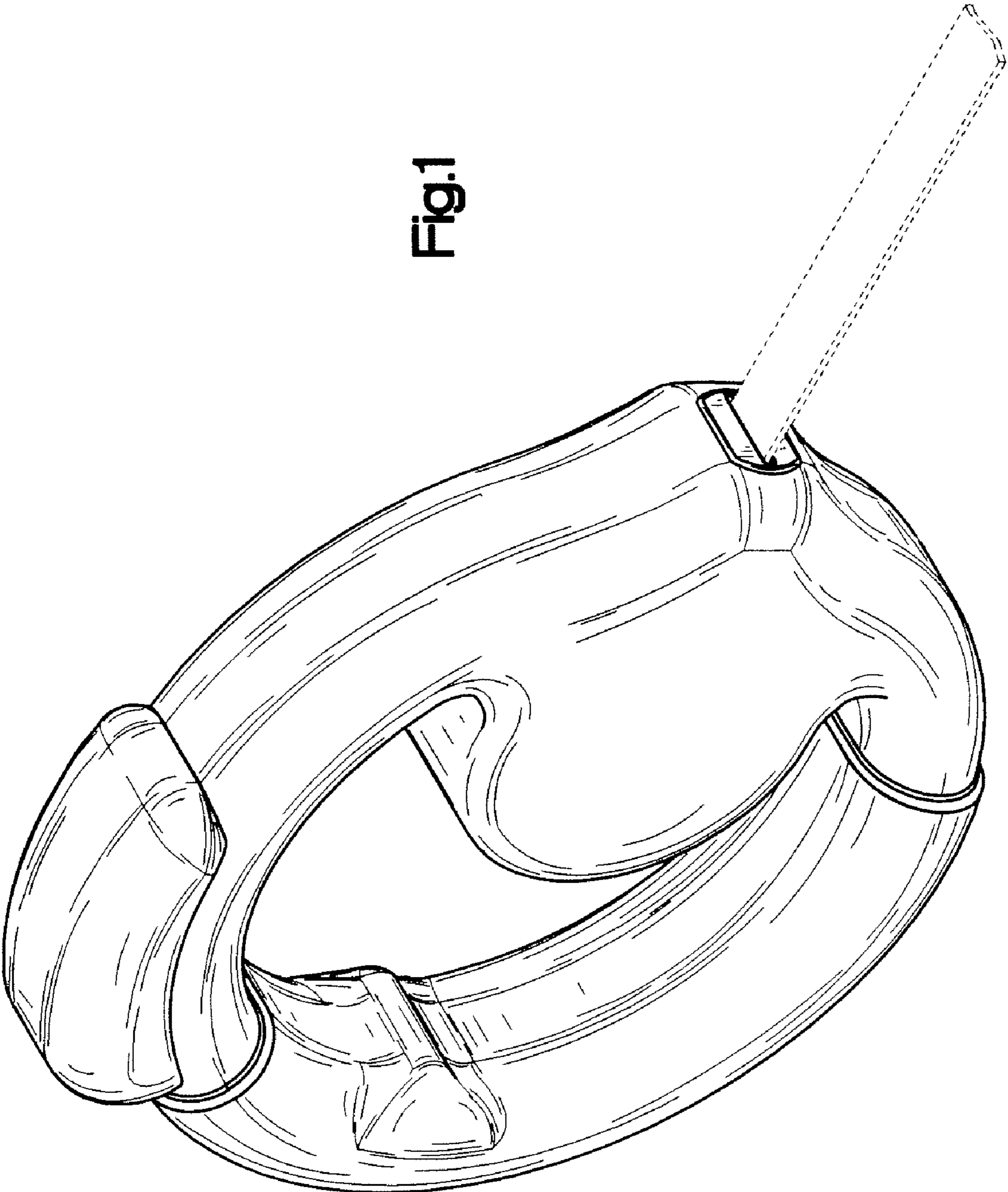

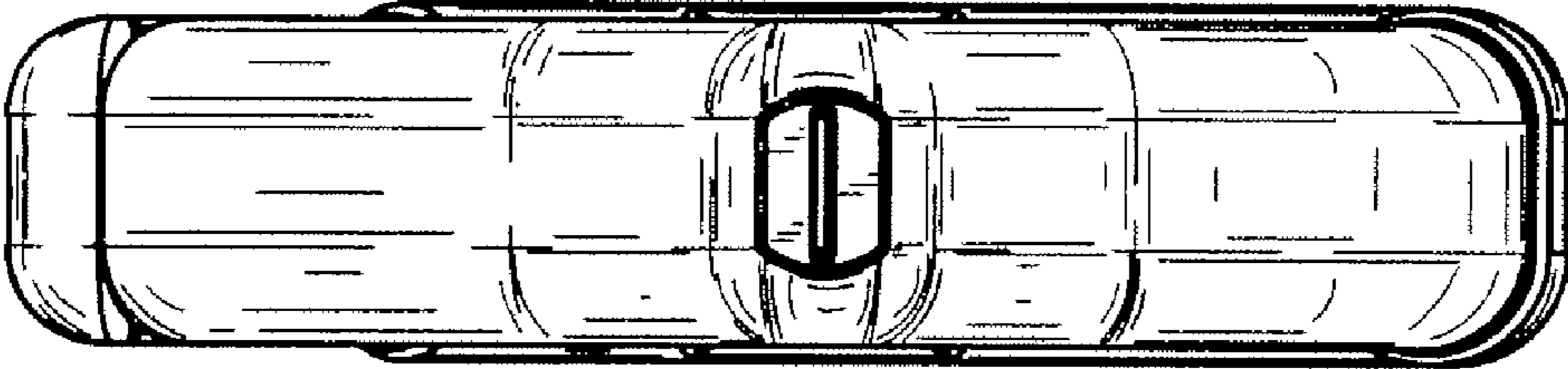

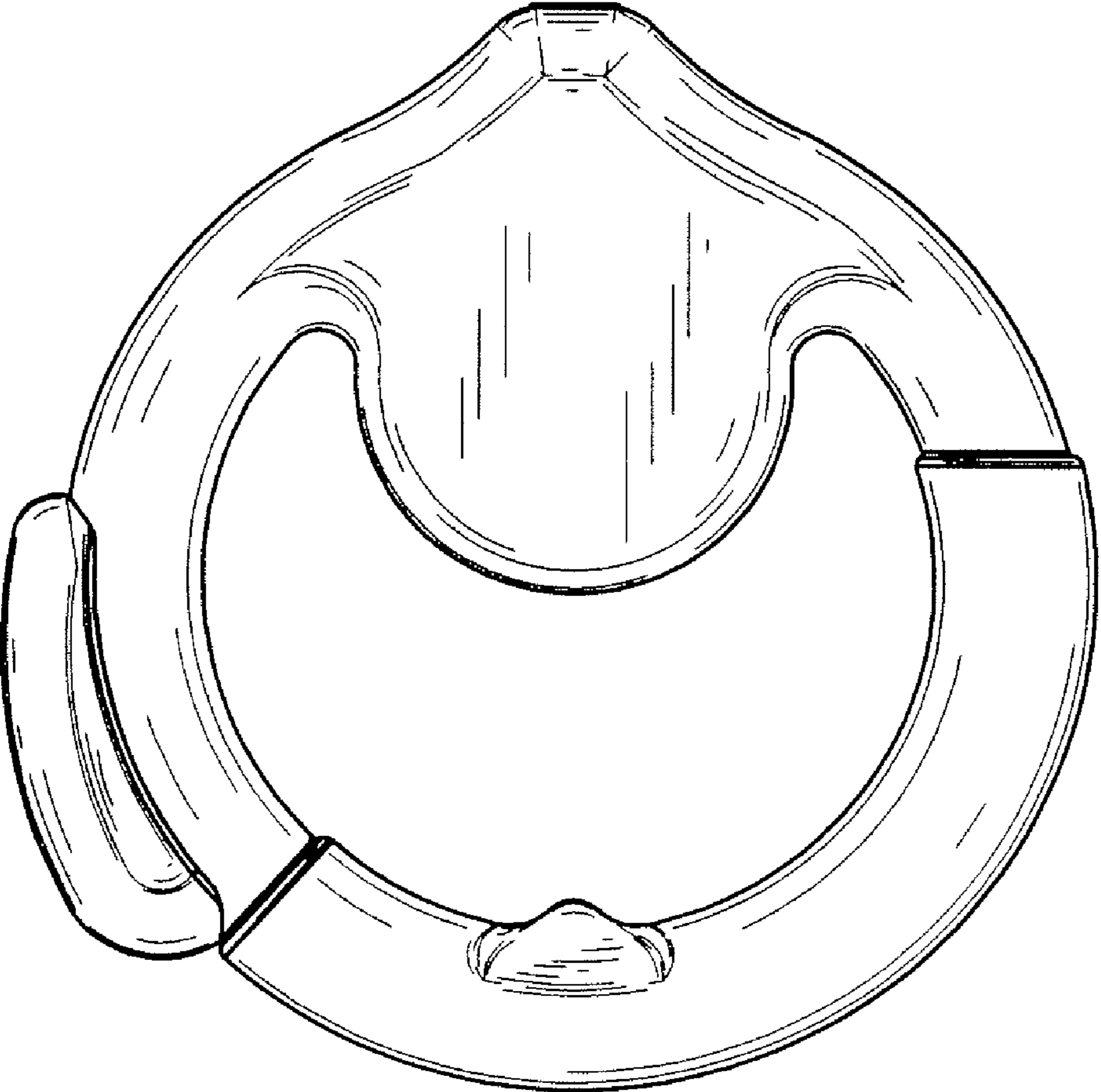

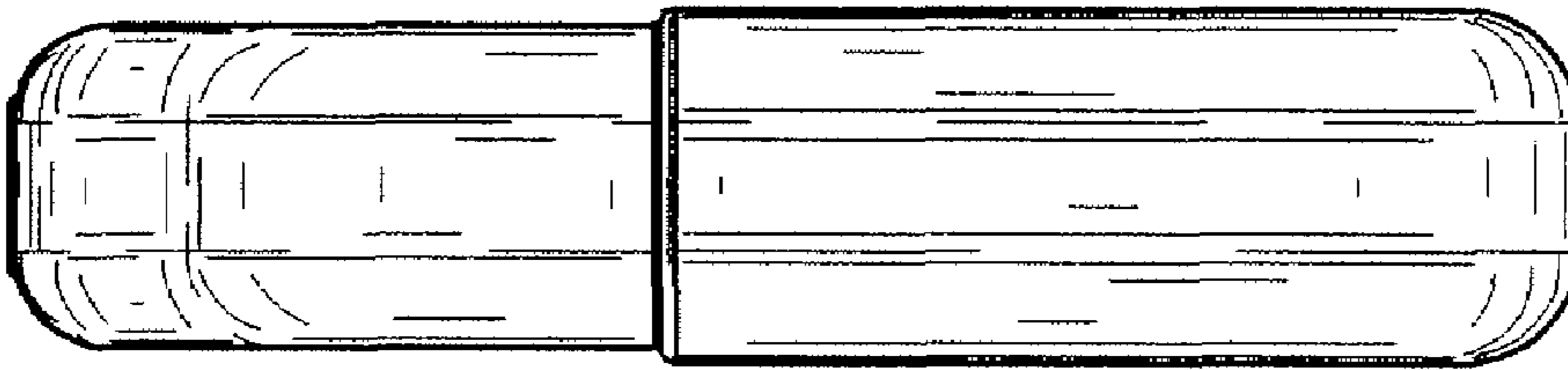

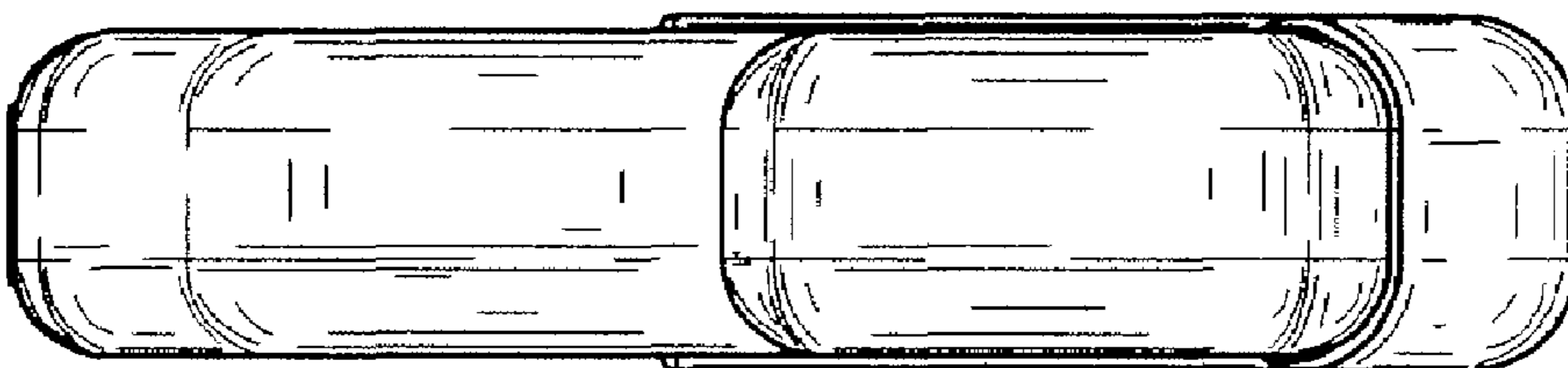
