(57) **CLAIM**

The ornamental design for a waistband extender strip, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the waistband extender strip, showing my new design;

FIG. 2 is a rear view thereof;

FIG. 3 is a rear perspective view thereof;

FIG. 4 is a front perspective view thereof;

FIG. 5 is a front perspective view thereof shown in a bent orientation;

FIG. 6 is a rear perspective view thereof;

FIG. 7 is a top view of FIG. 1; the bottom view being a mirror view thereof;

FIG. 8 is a side view thereof, the other side view being a mirror view thereof; and,

FIG. 9 is a top view thereof, shown in a bent-over orientation.
