FIG. 1 is a perspective view of a portion of a shoe showing my new design;

FIG. 2 is a side of the portion of a shoe shown in FIG. 1;

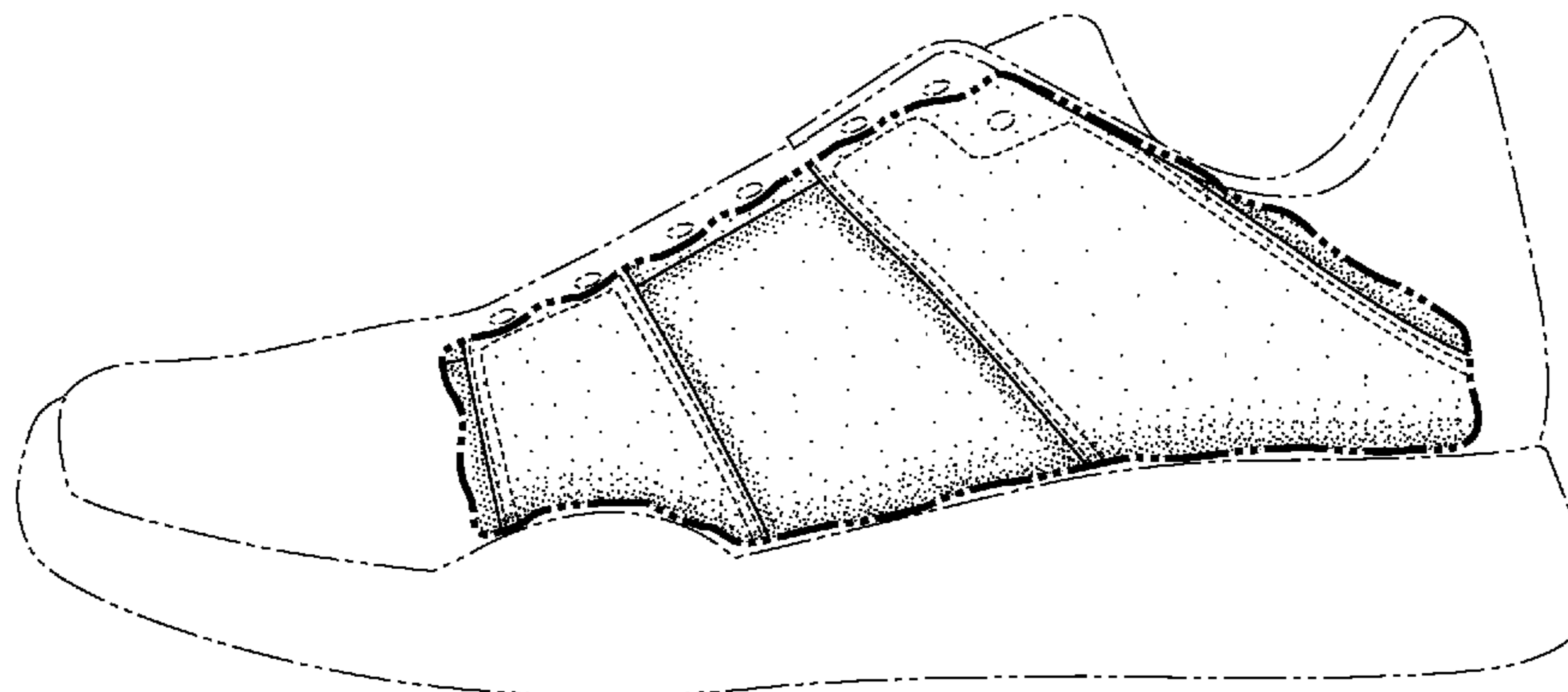
FIG. 3 is a front view of the portion of a shoe shown in FIG. 1;

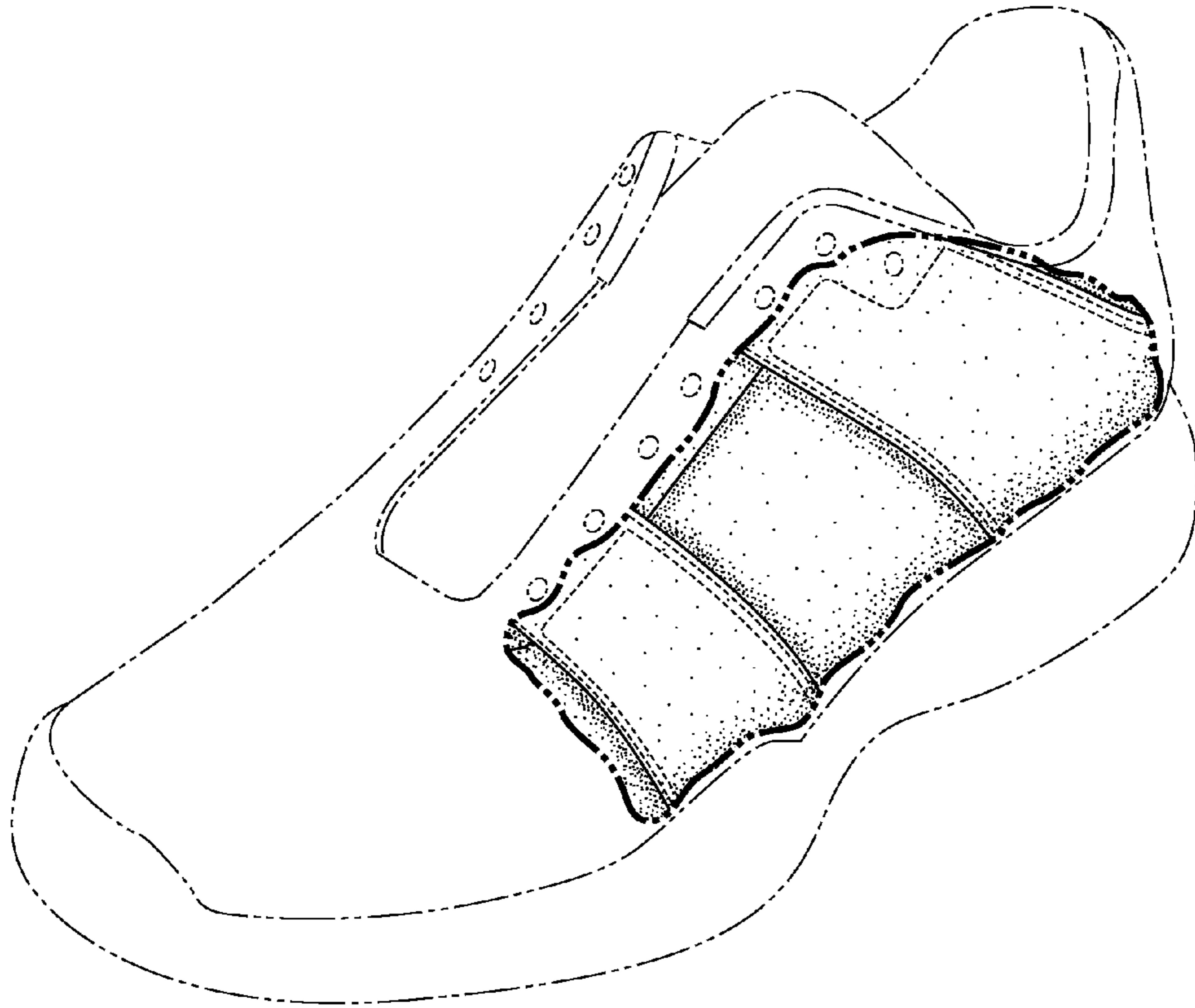

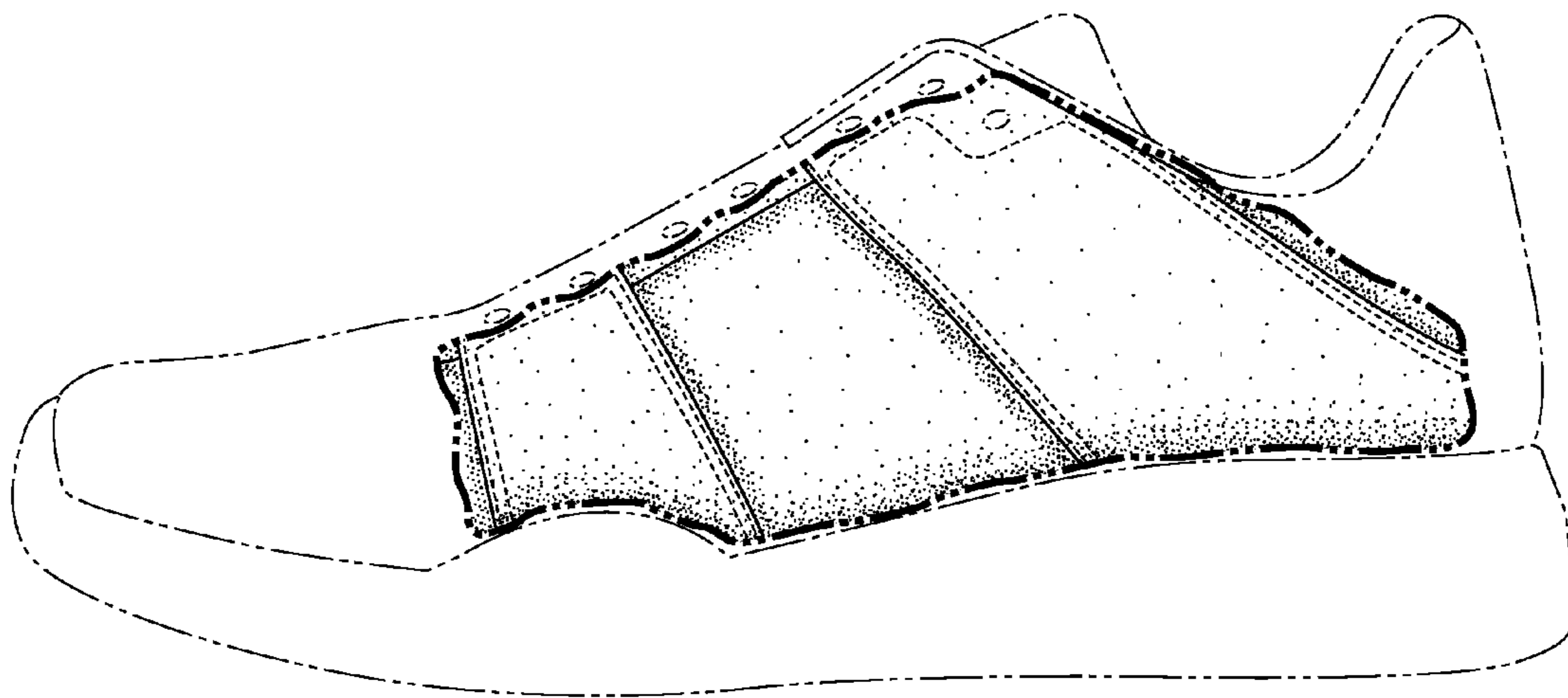

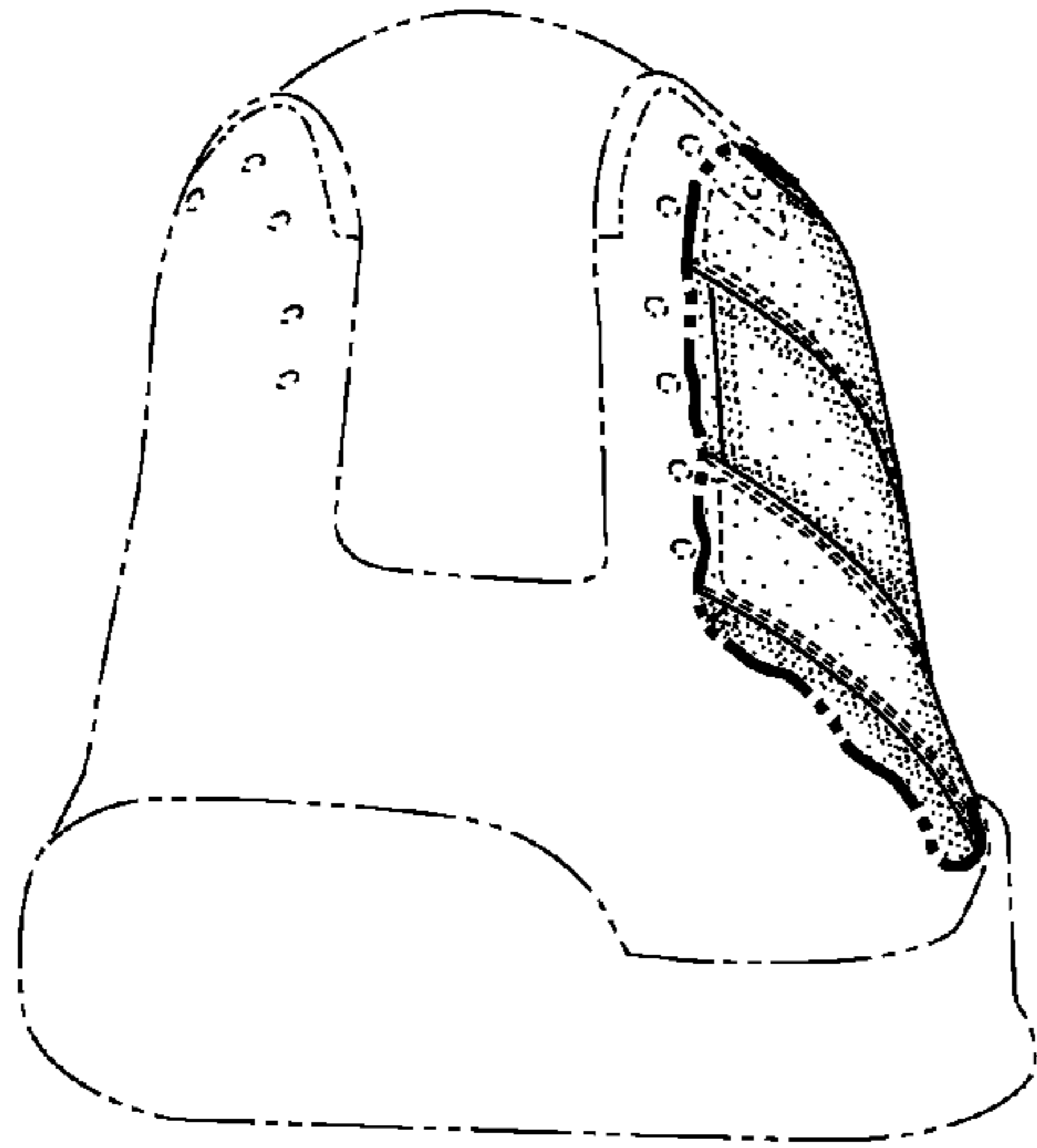

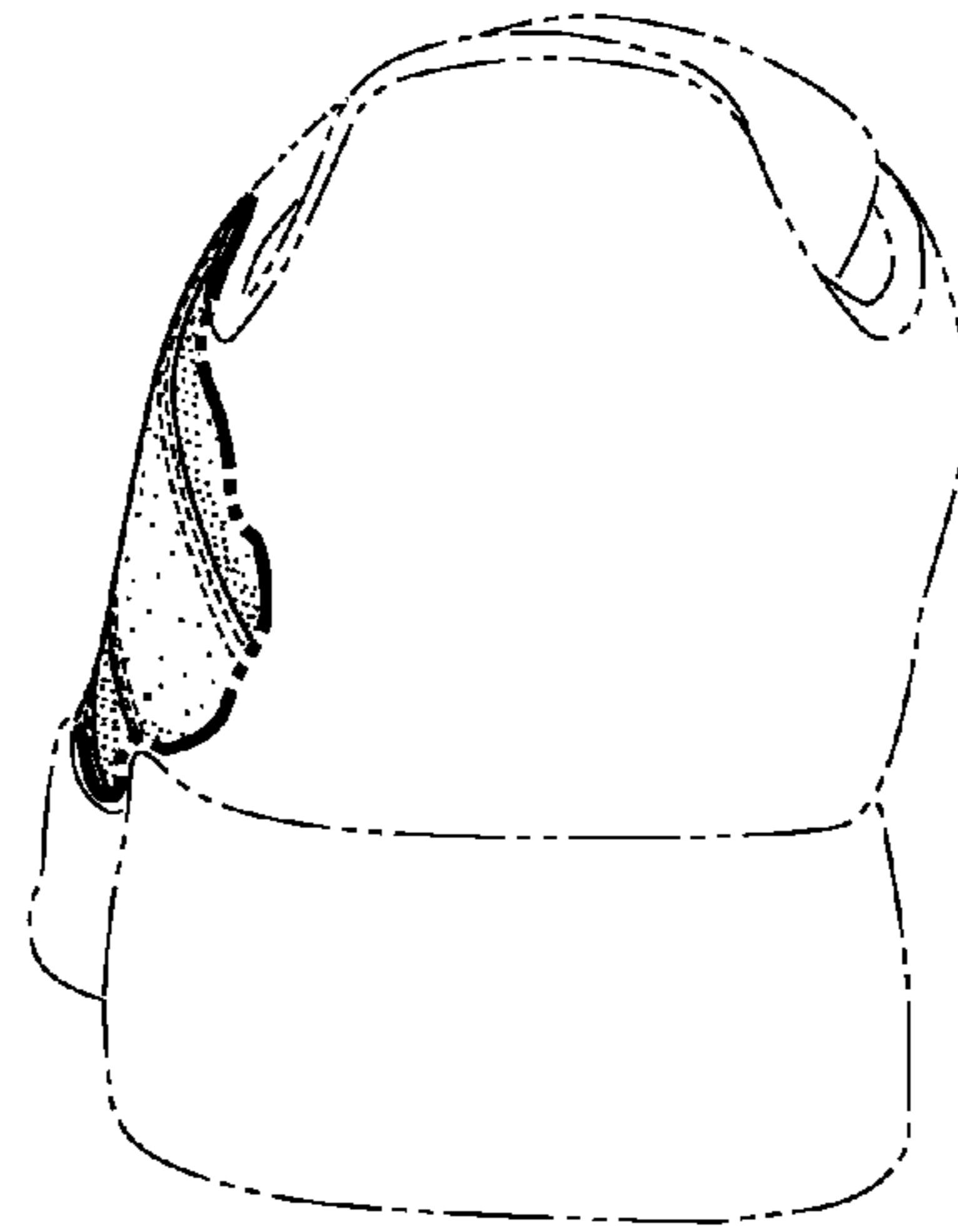

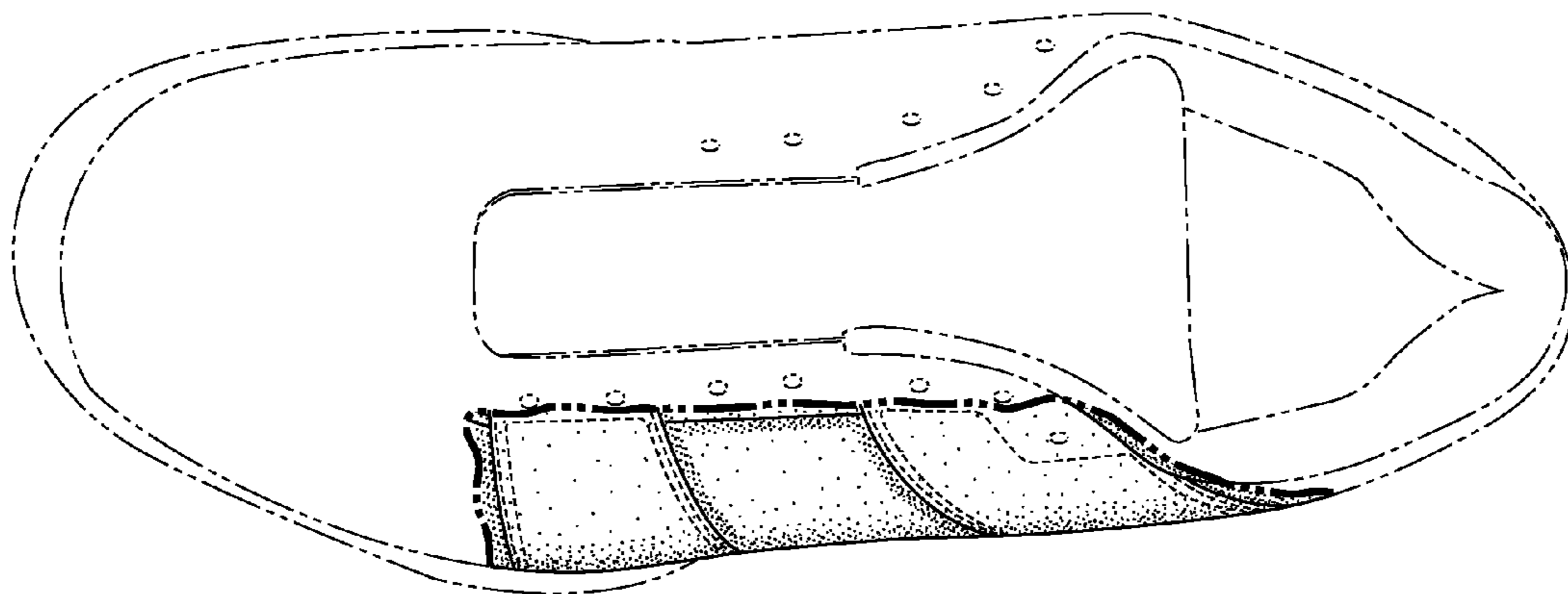
