FIG. 3 illustrates a top plan view of the support post shown in FIG. 2.

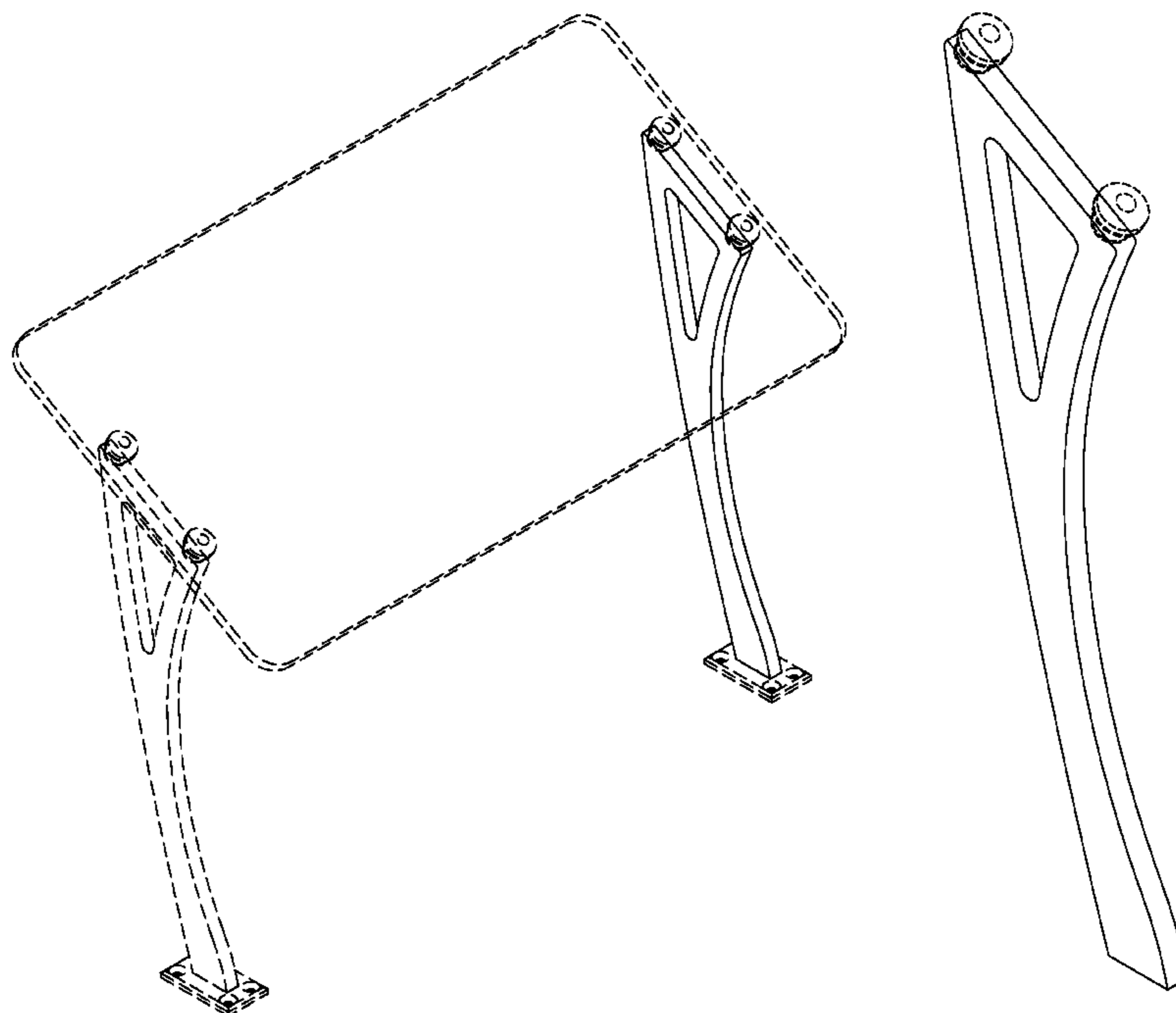
FIG. 4 illustrates a side plan view of the support post shown in FIG. 2.

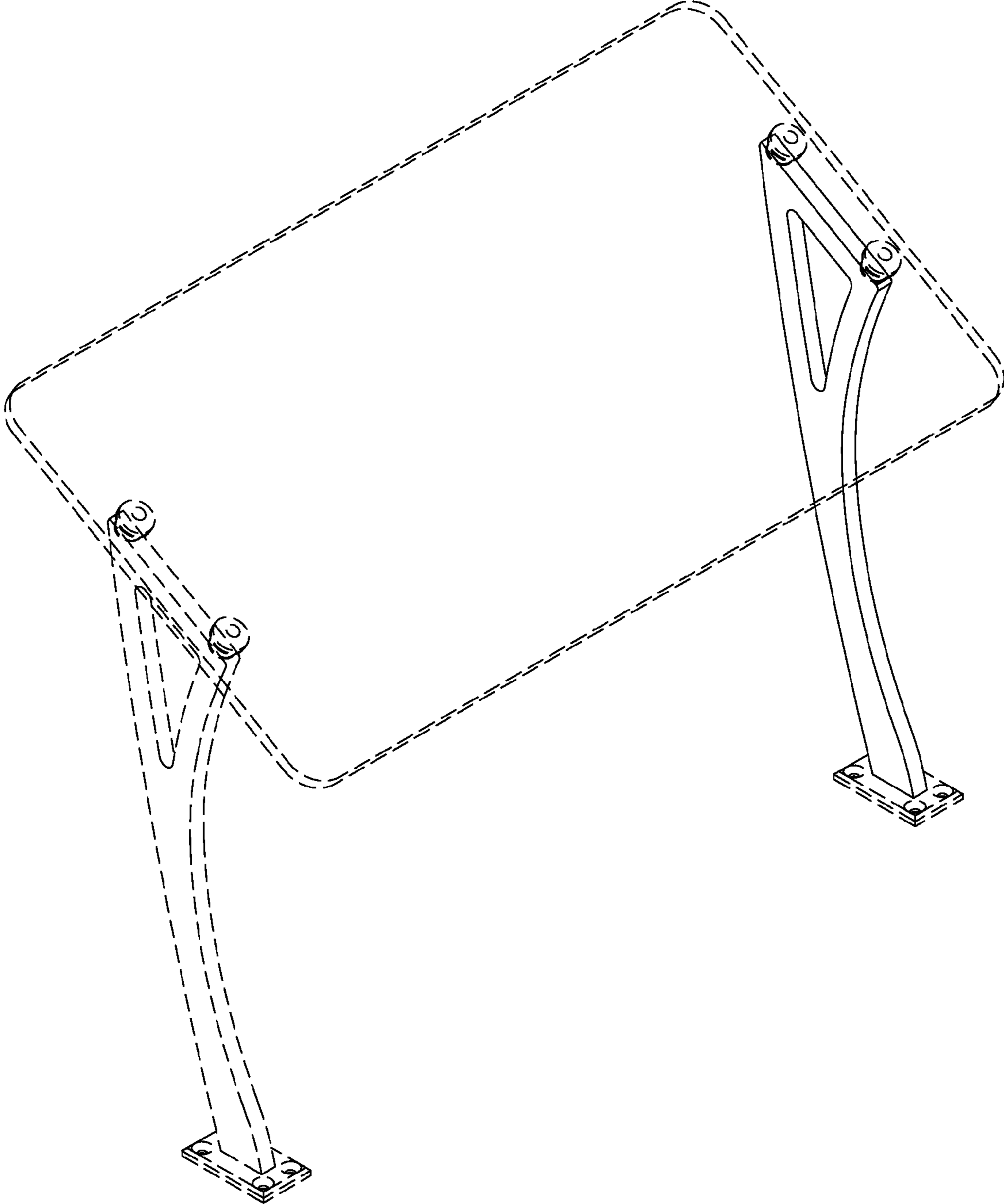

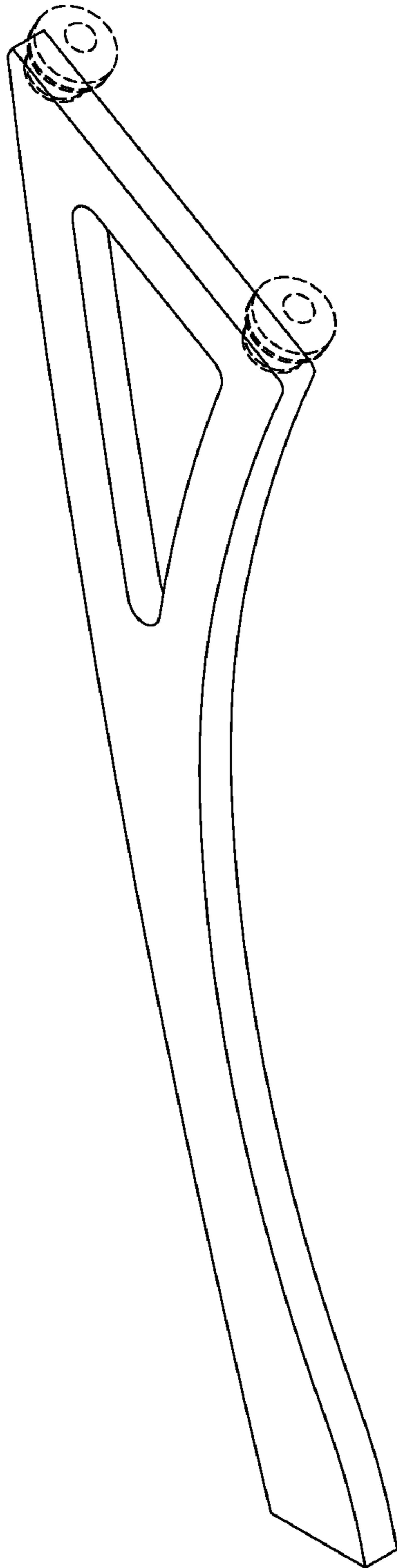

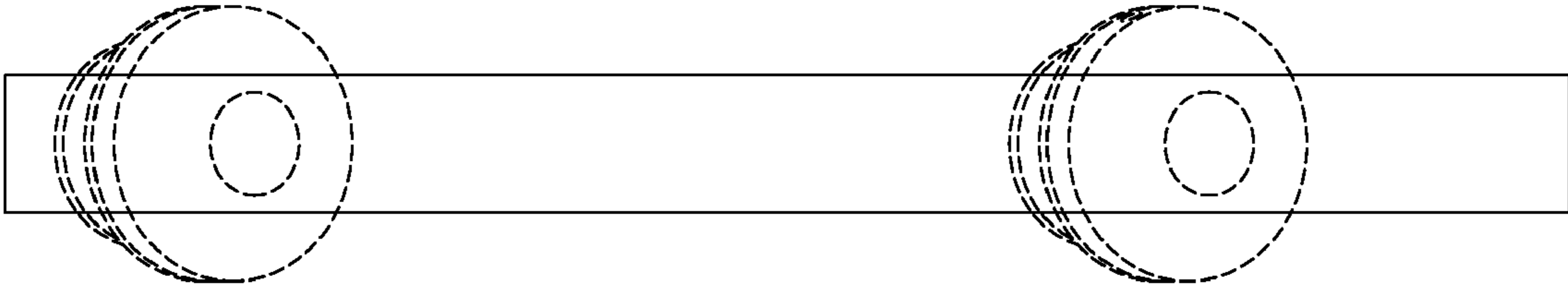

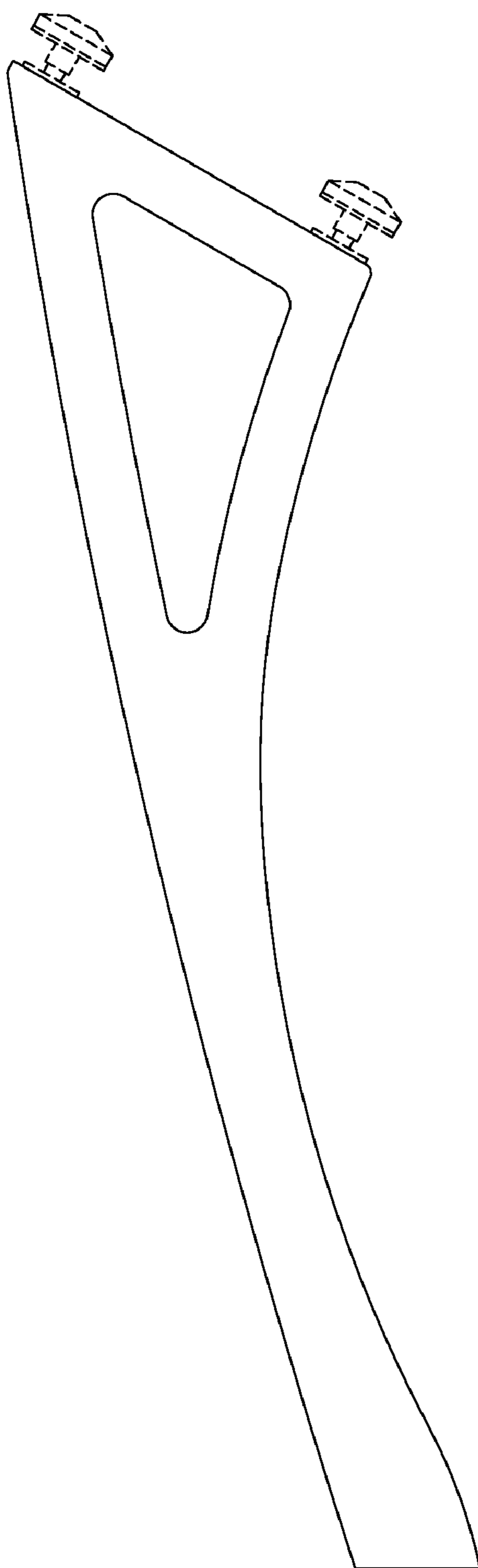

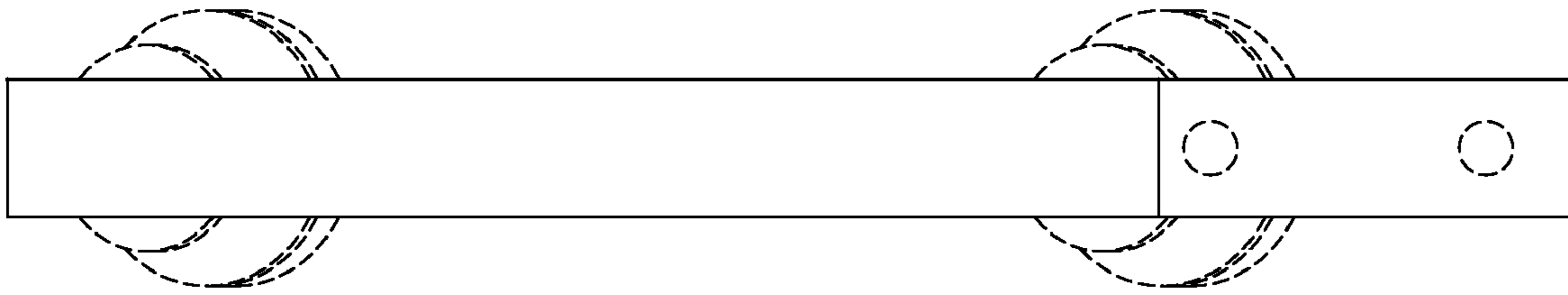

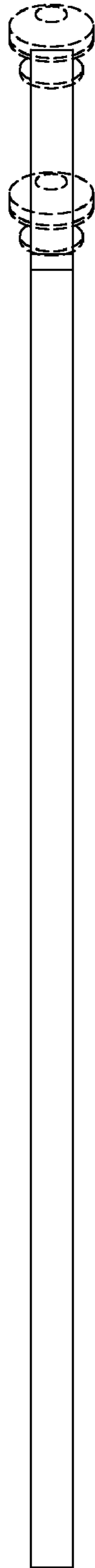
