FIG. 10 is a top plan view thereof;

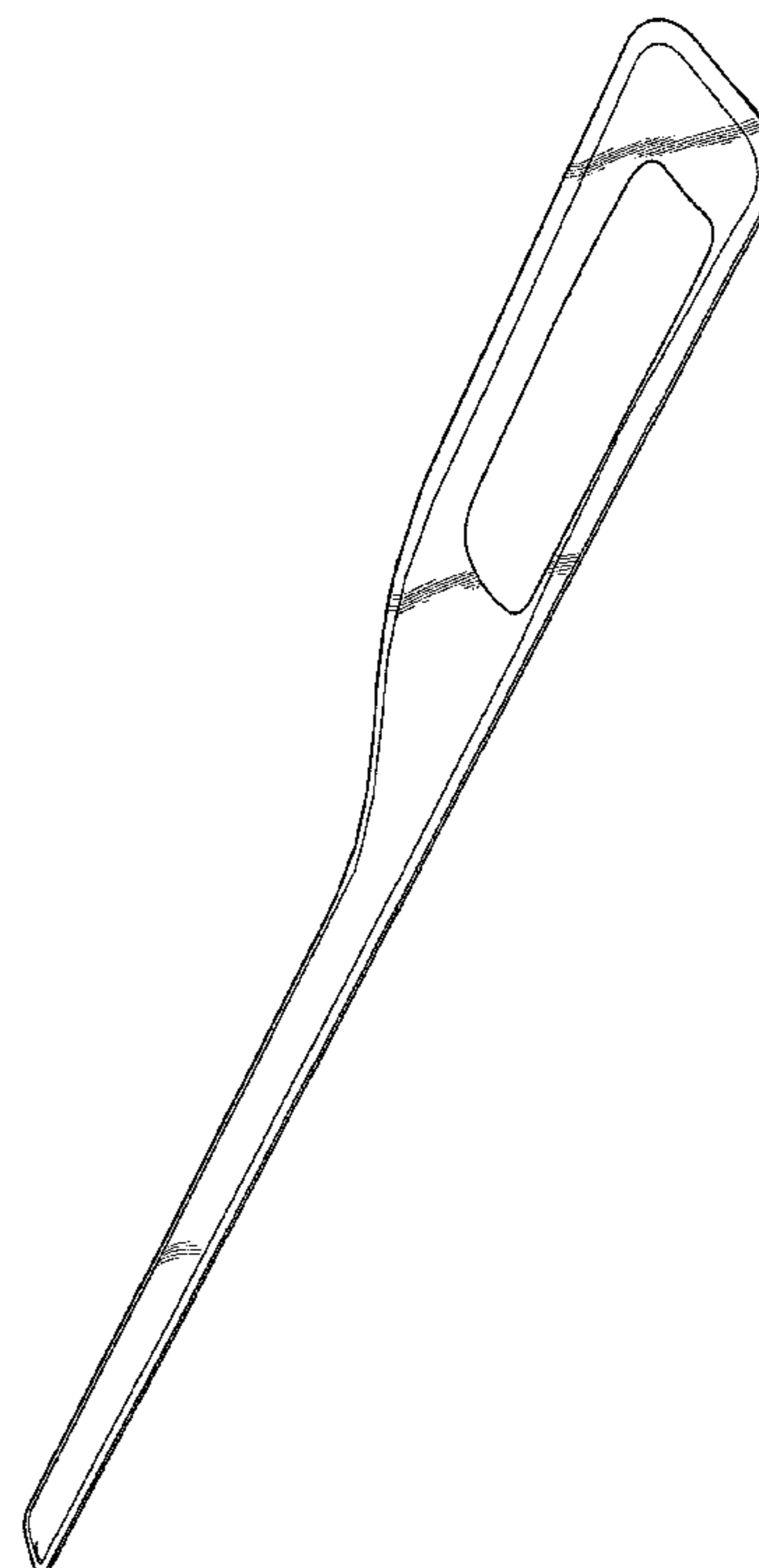
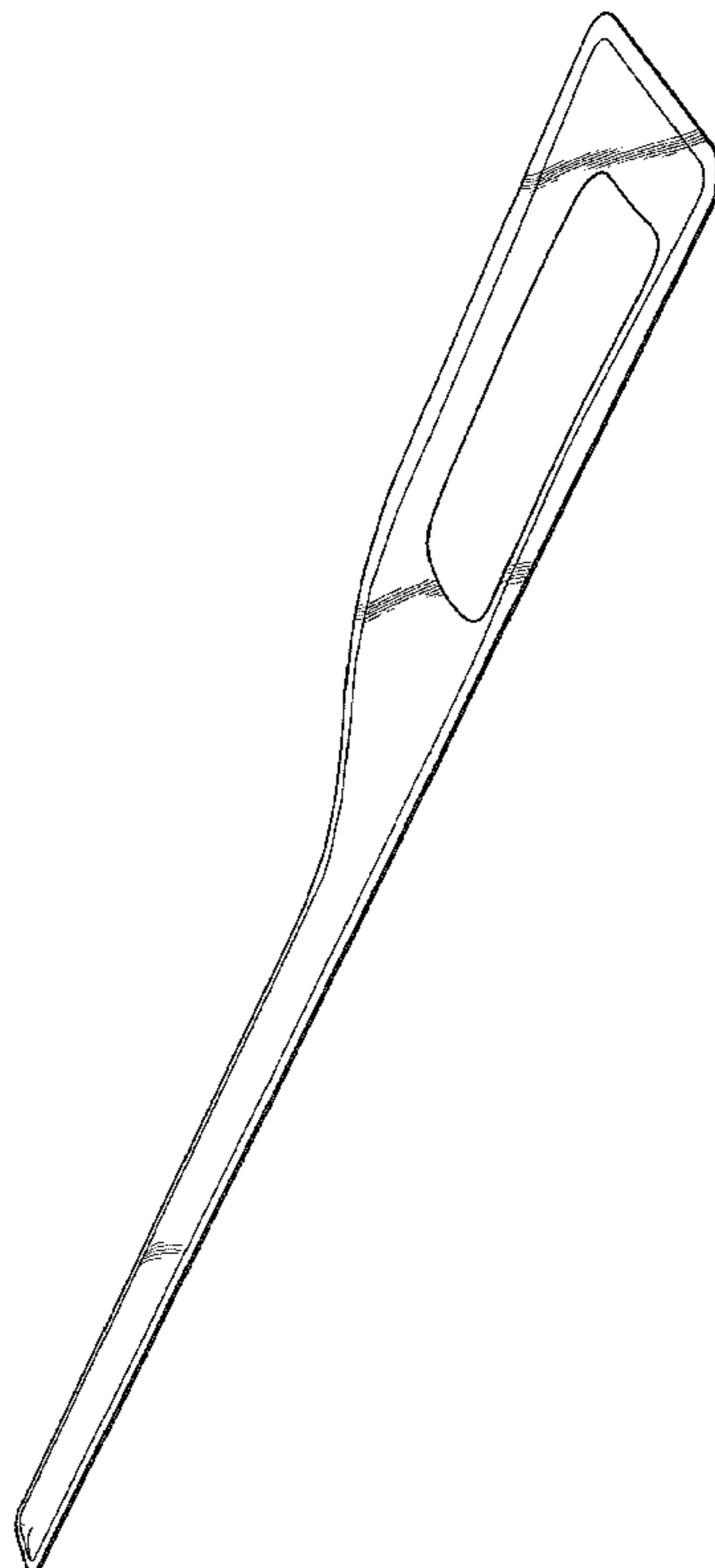
FIG. 11 is a right side elevational view thereof,

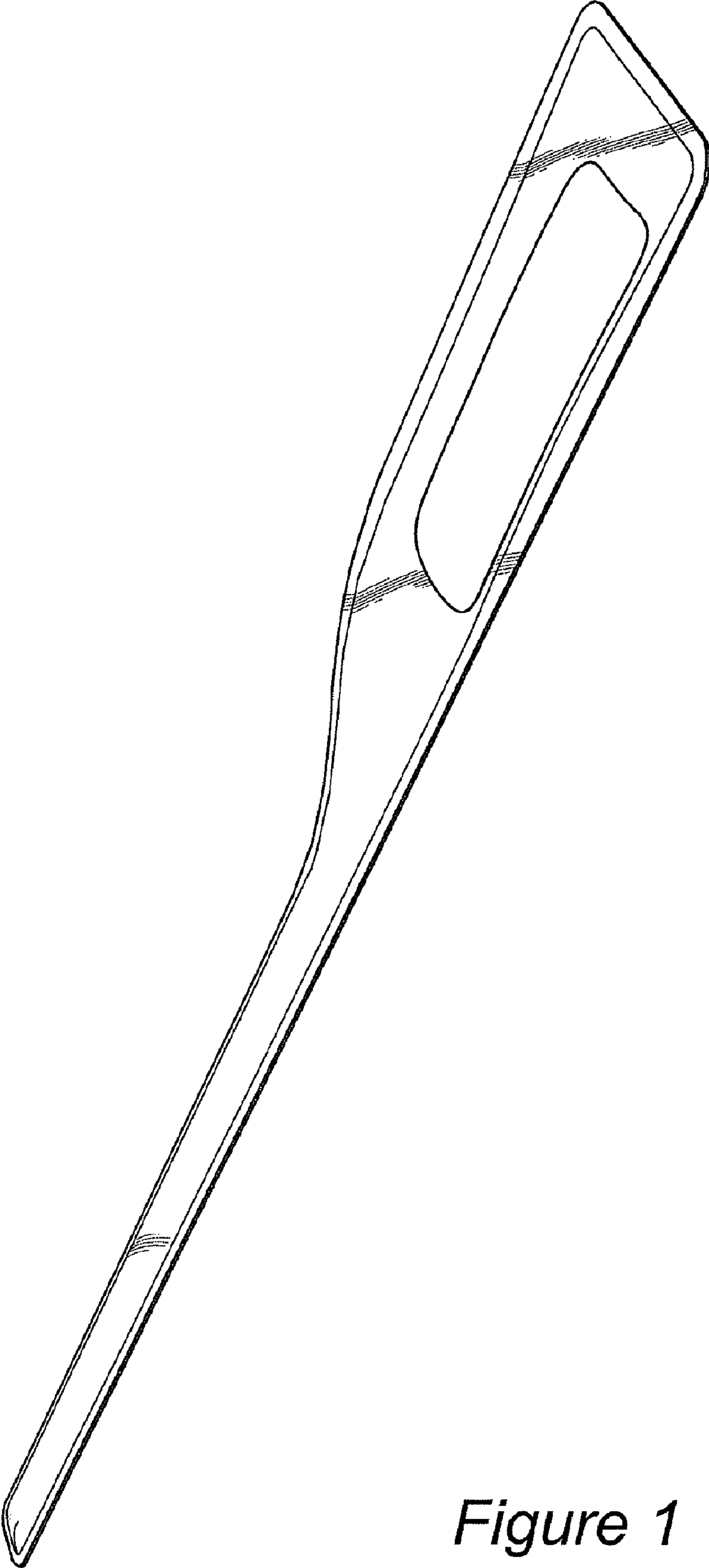

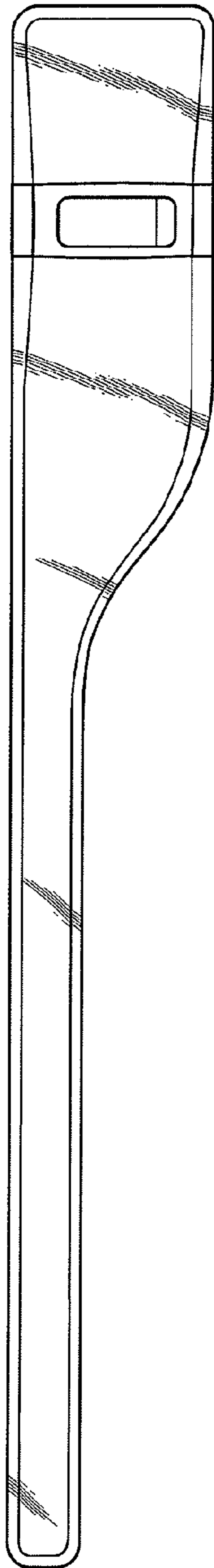

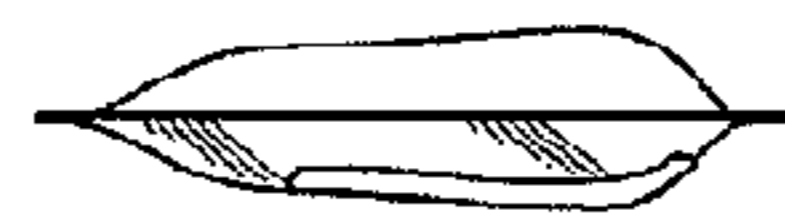

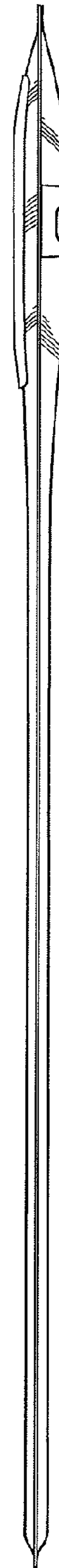

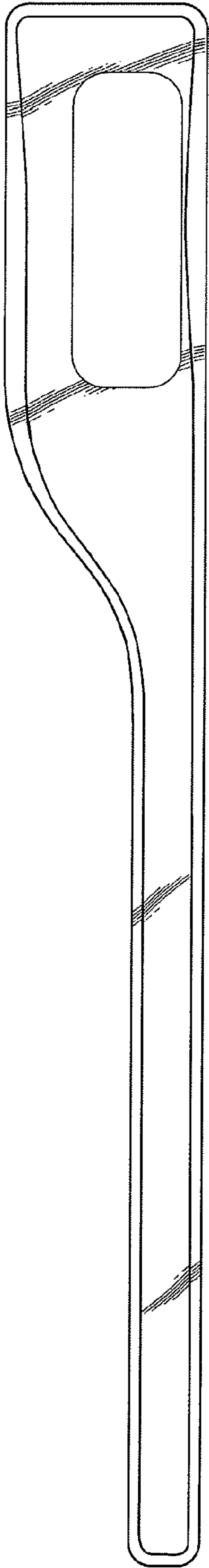

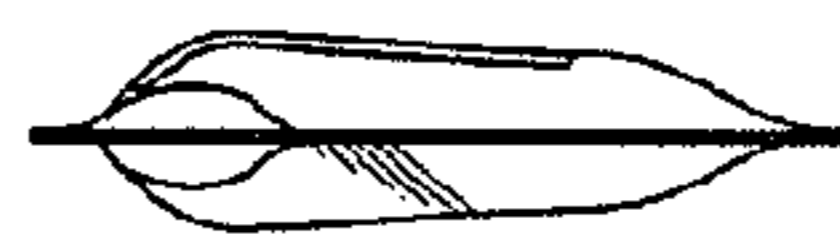

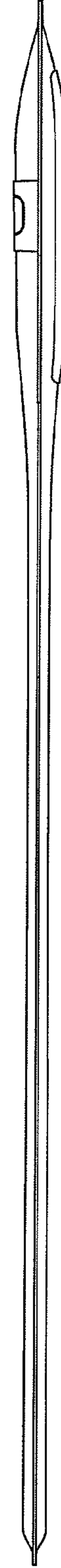

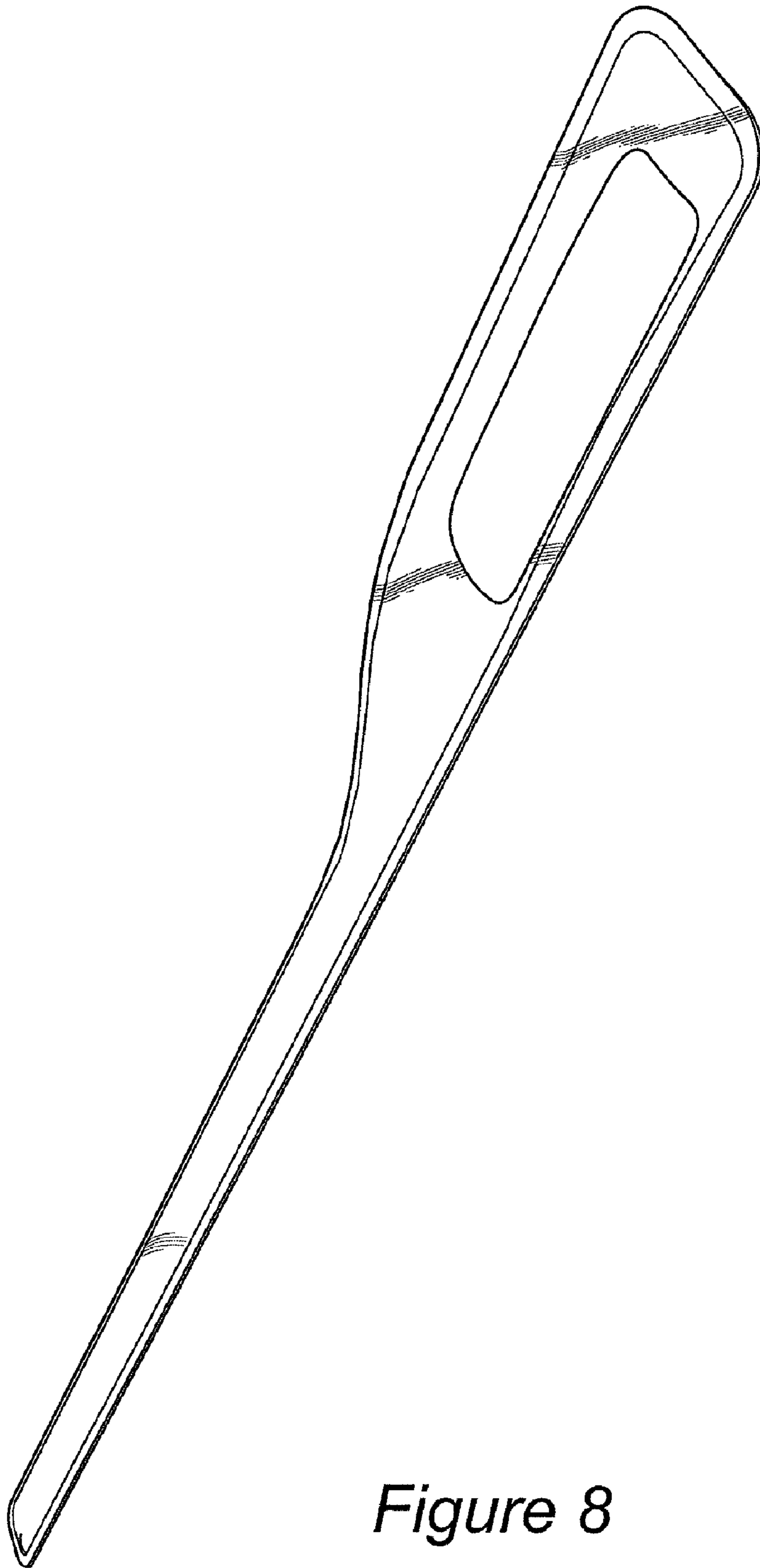

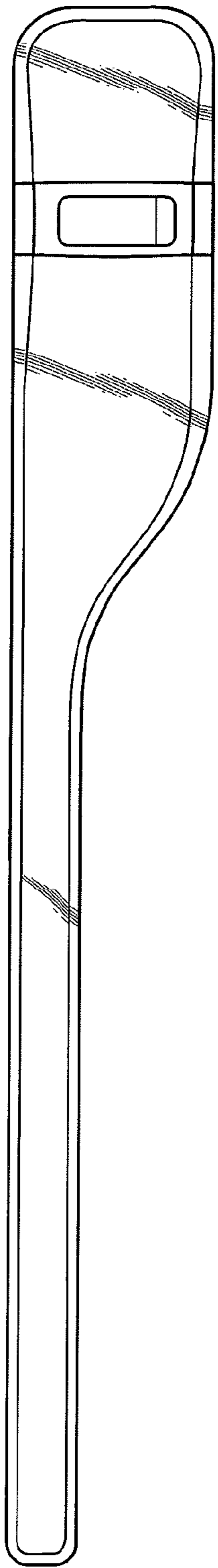

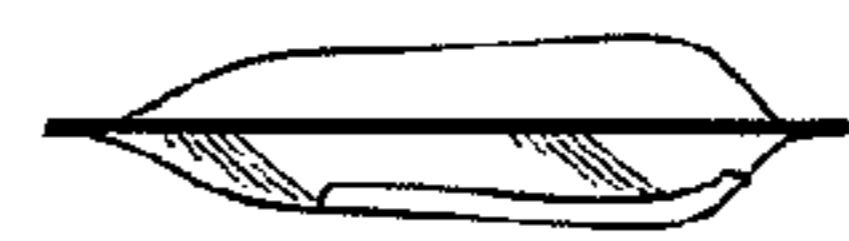

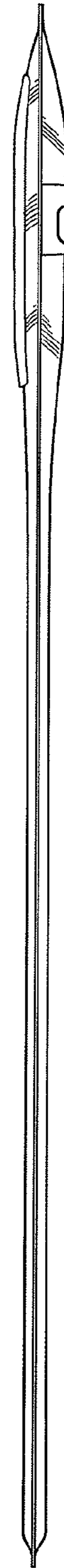

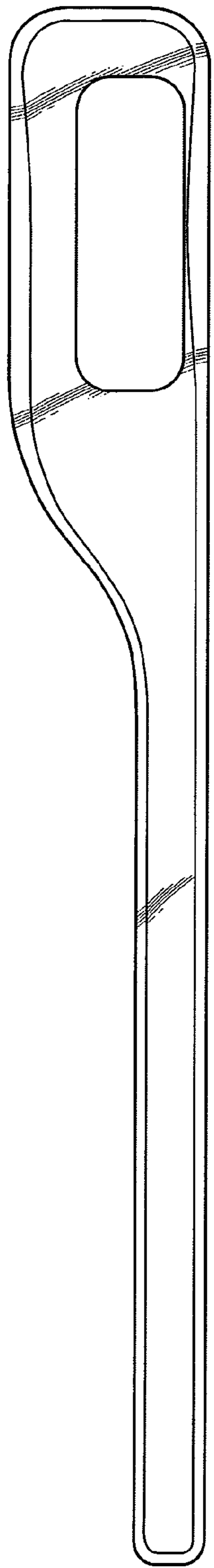

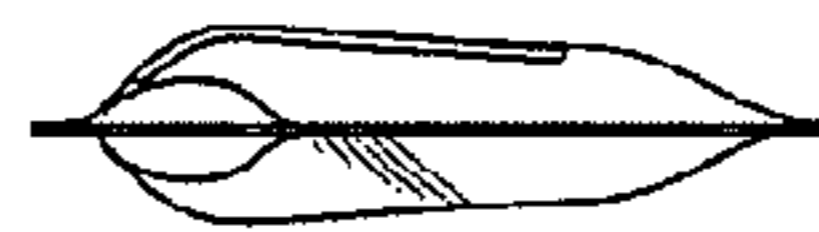

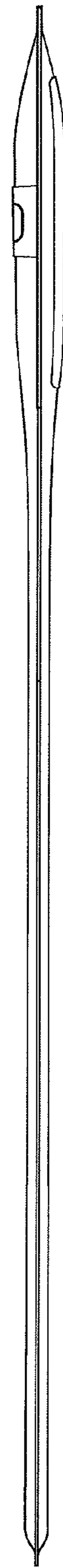
