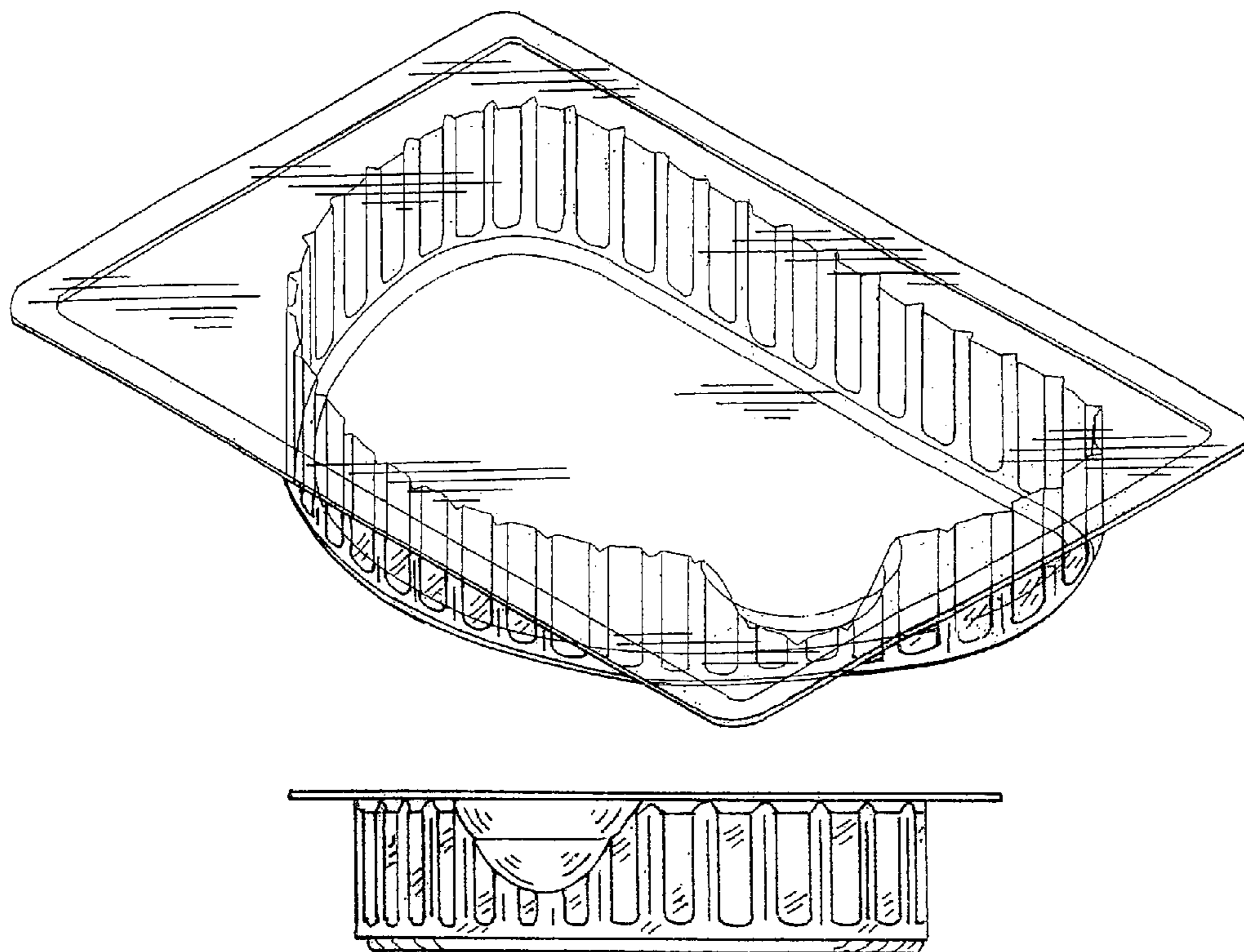
(57) **CLAIM**

The ornamental design for a packaging container, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the packaging container.
FIG. 2 is a first end view of the packaging container.
FIG. 3 is a second end view of the packaging container, opposite of the end view of FIG. 2.
FIG. 4 is a first side view the packaging container, opposite of the side view of FIG. 2.
FIG. 5 is a second side view of the packaging container, opposite of the side view of FIG. 4.
FIG. 6 is a top view of the packaging container; and,
FIG. 7 is a bottom view of the packaging container.

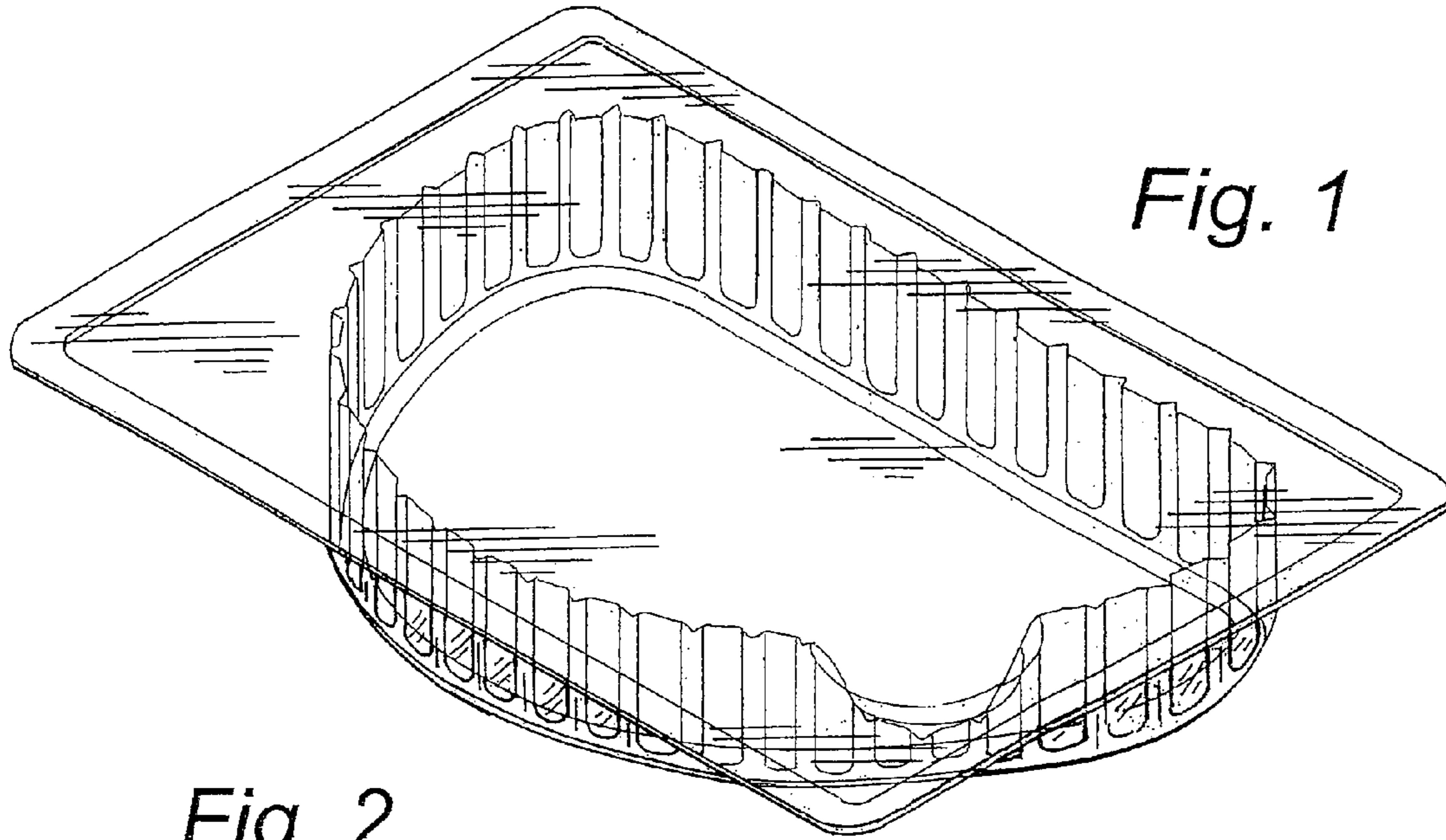

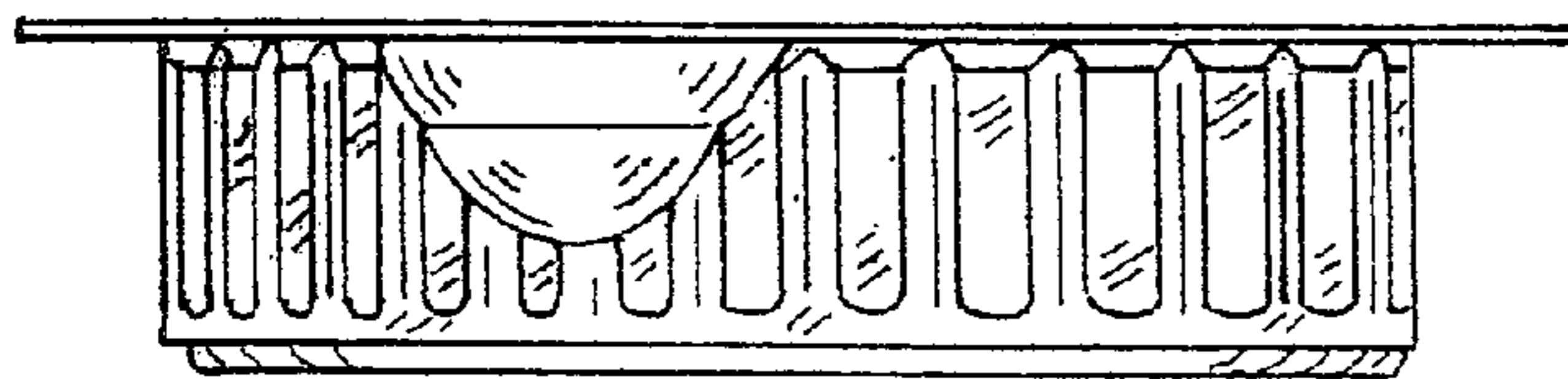

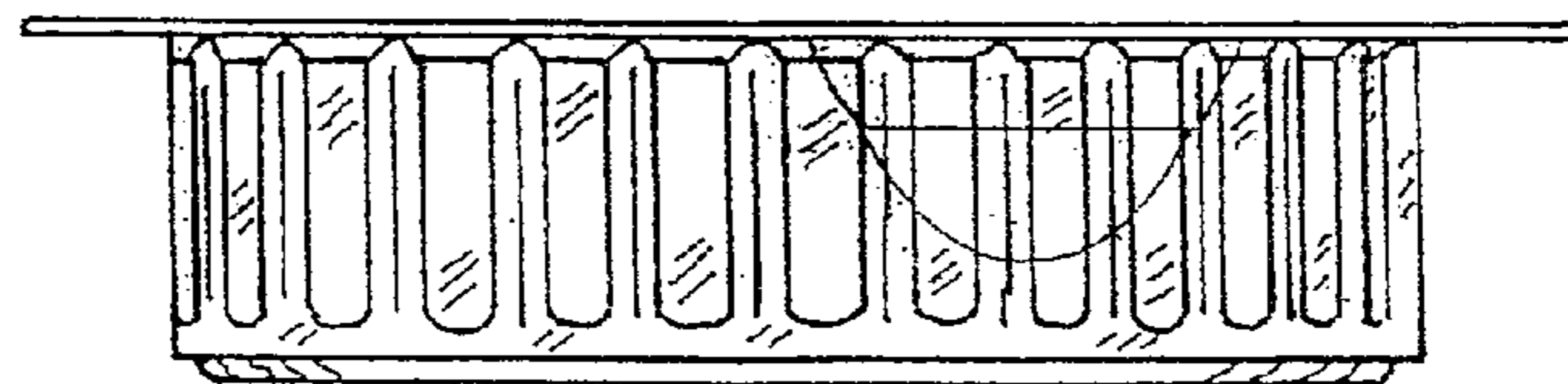

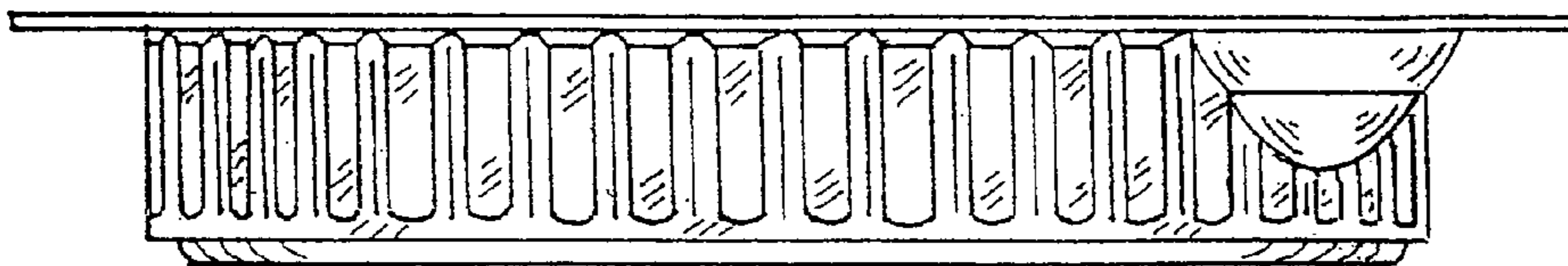
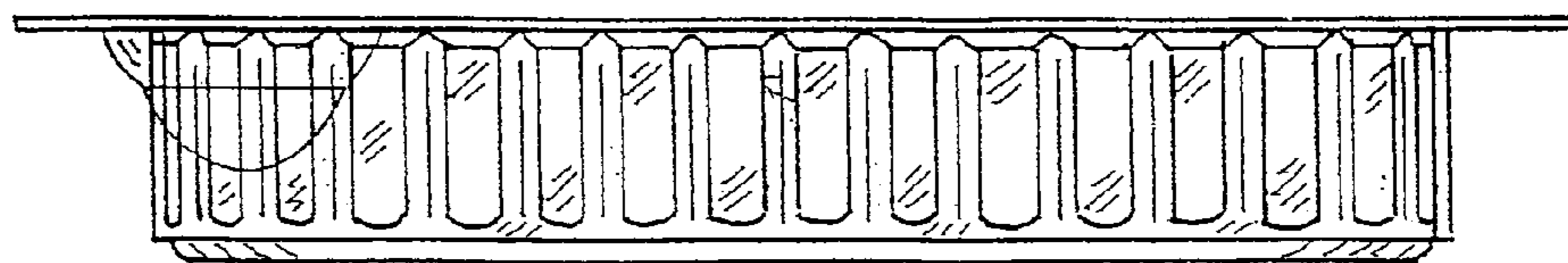

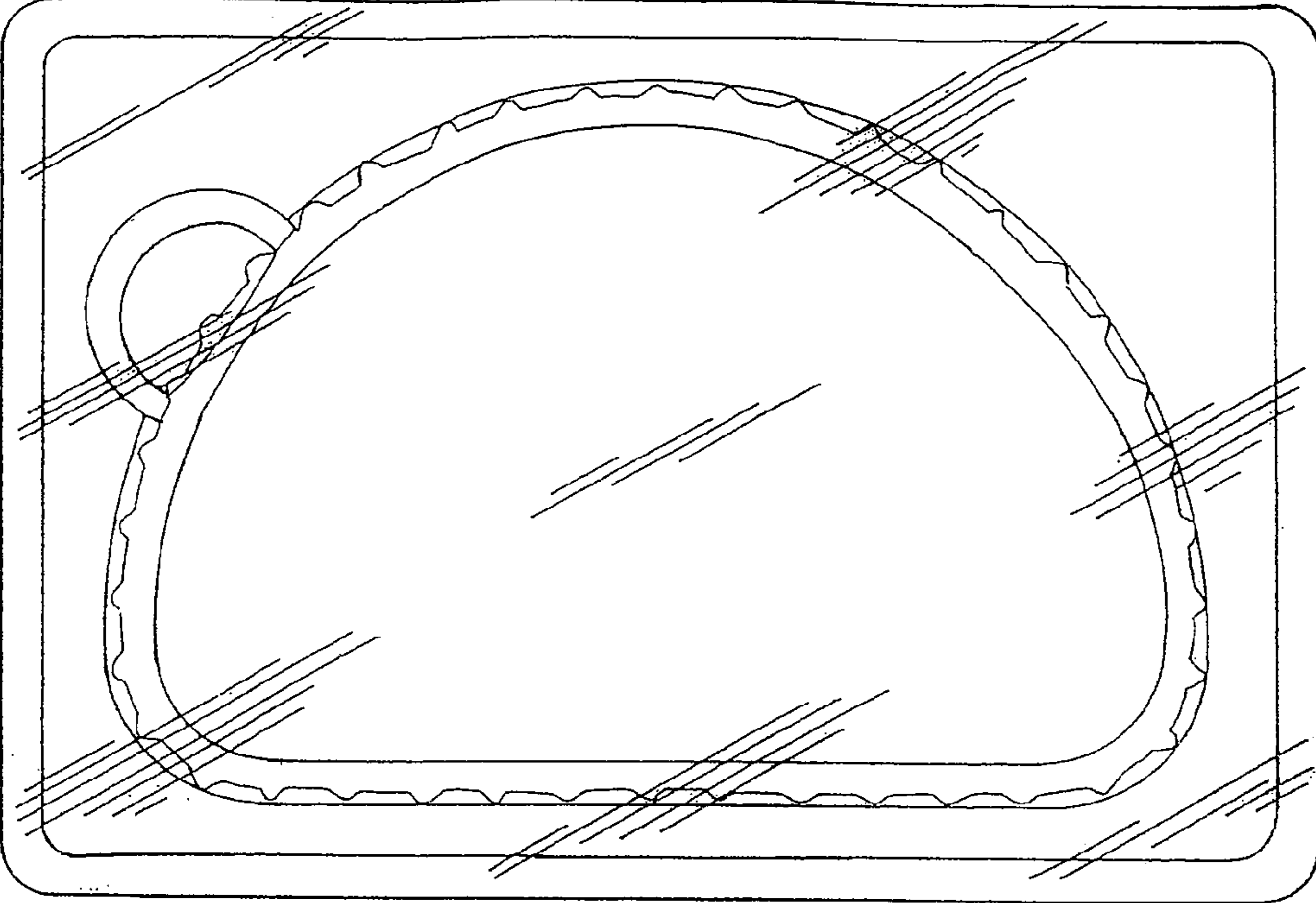

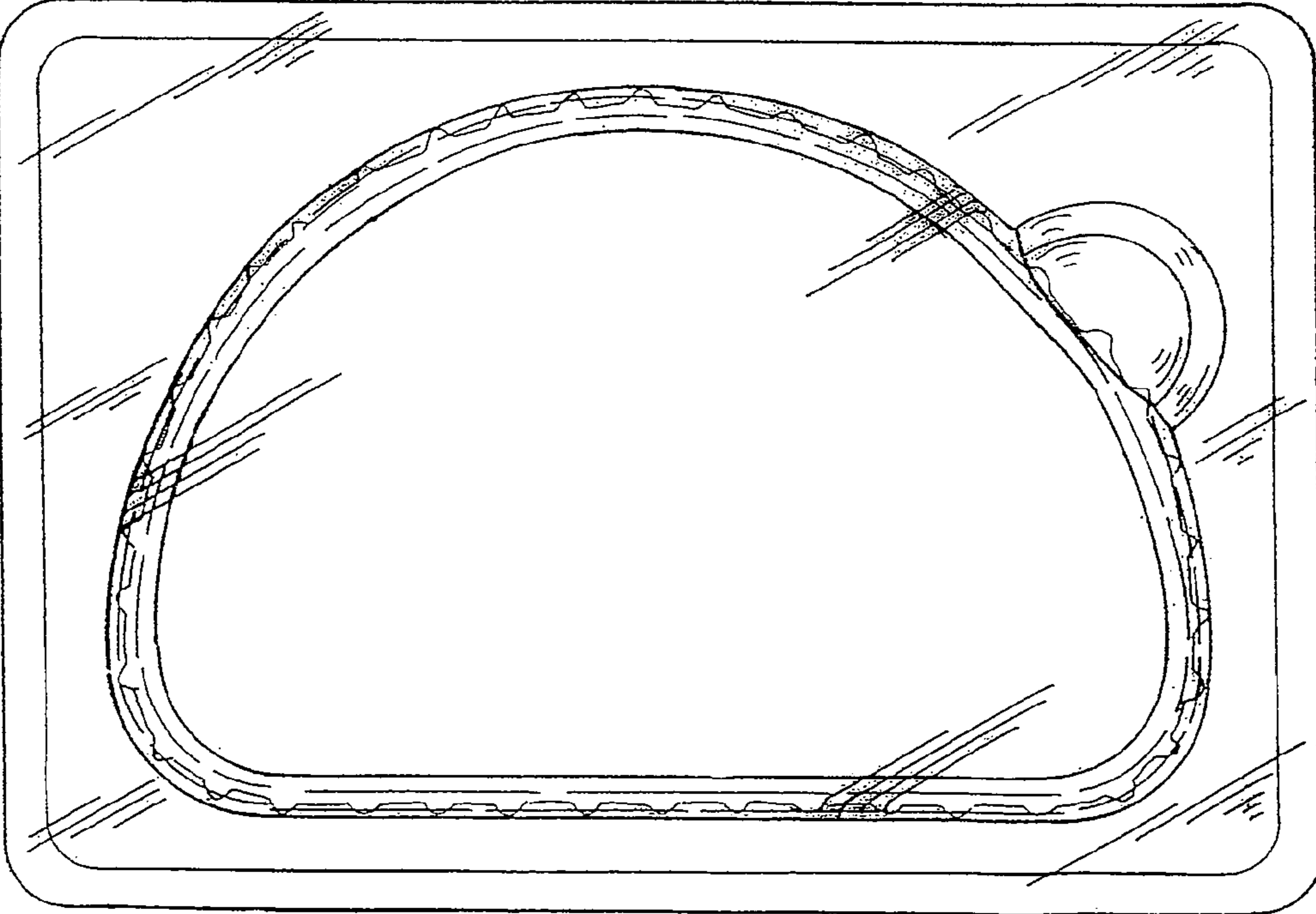
