(57) **CLAIM**

The ornamental design for a packaging container with surface ornamentation, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a packaging container with surface ornamentation embodying our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a left side view thereof;

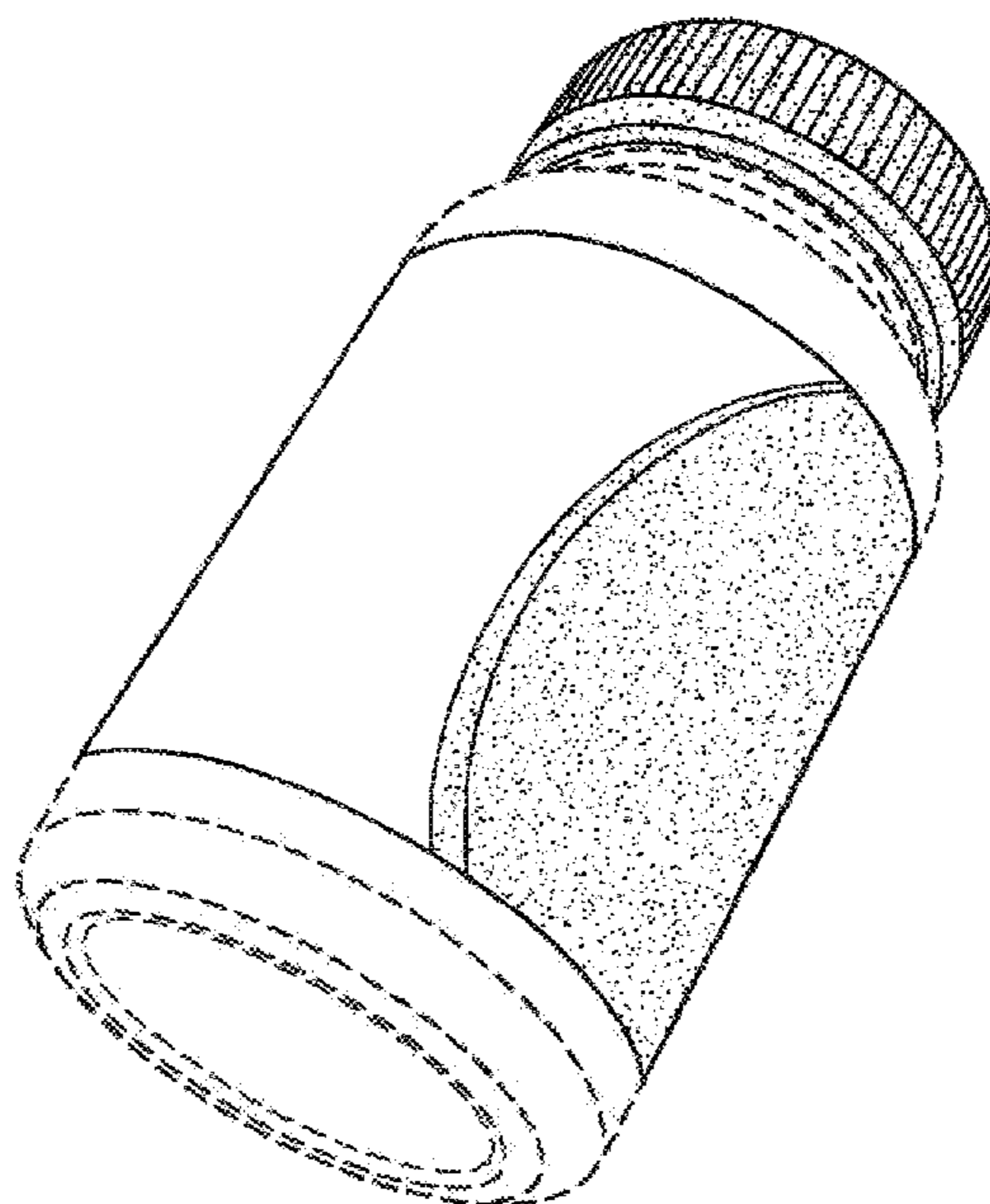
FIG. 5 is a right side view thereof;

FIG. 6 is a top view thereof; and,

FIG. 7 is a bottom view thereof.

The stippling on the surface ornamentation of the packaging container and/or cap can indicate one or more colors, shades or intensity of colors, but not a particular color or colors. Broken lines are included herein to depict environment only and form no part of the claimed design. Stippling is included herein to denote contrast but not a particular color.

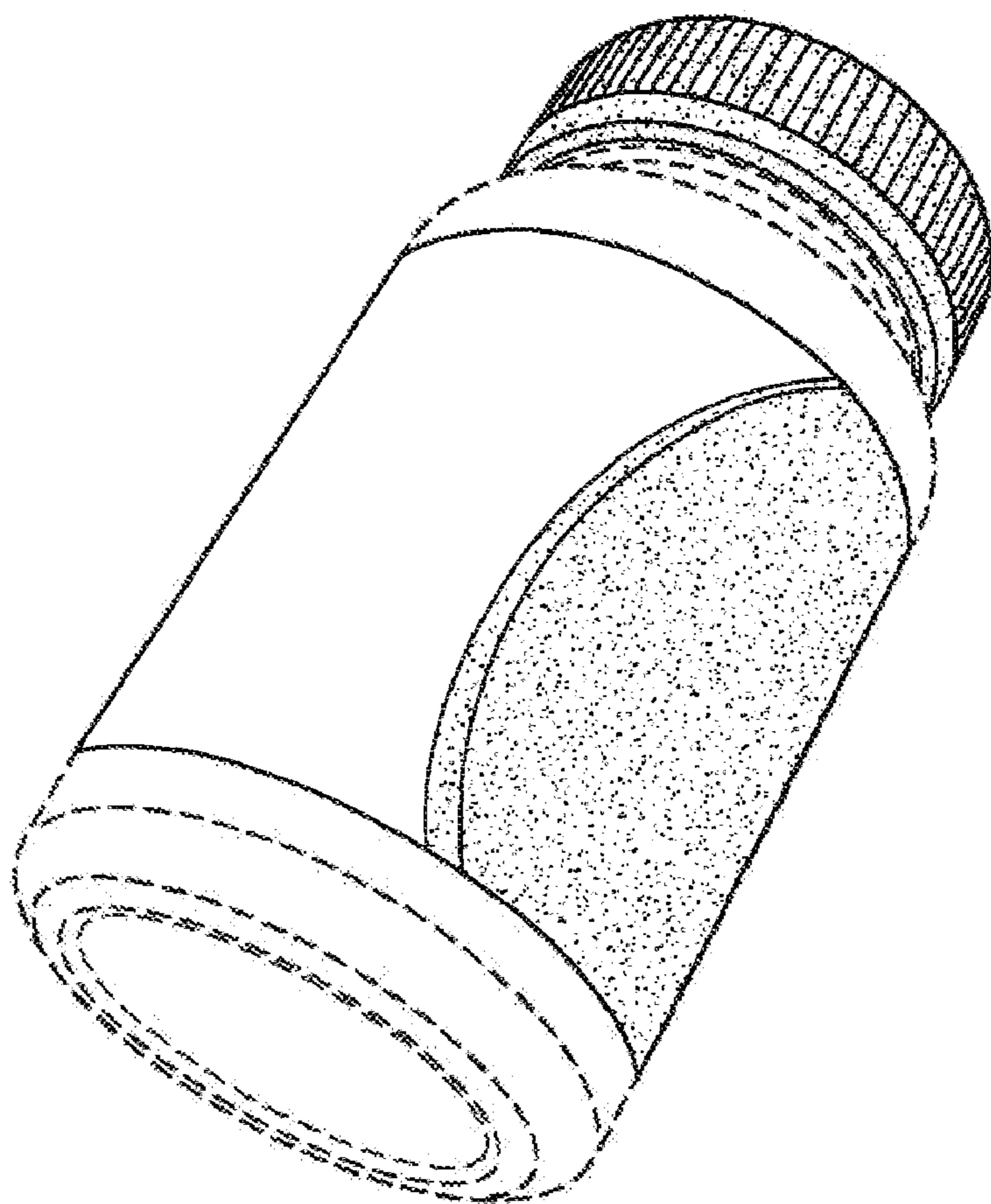

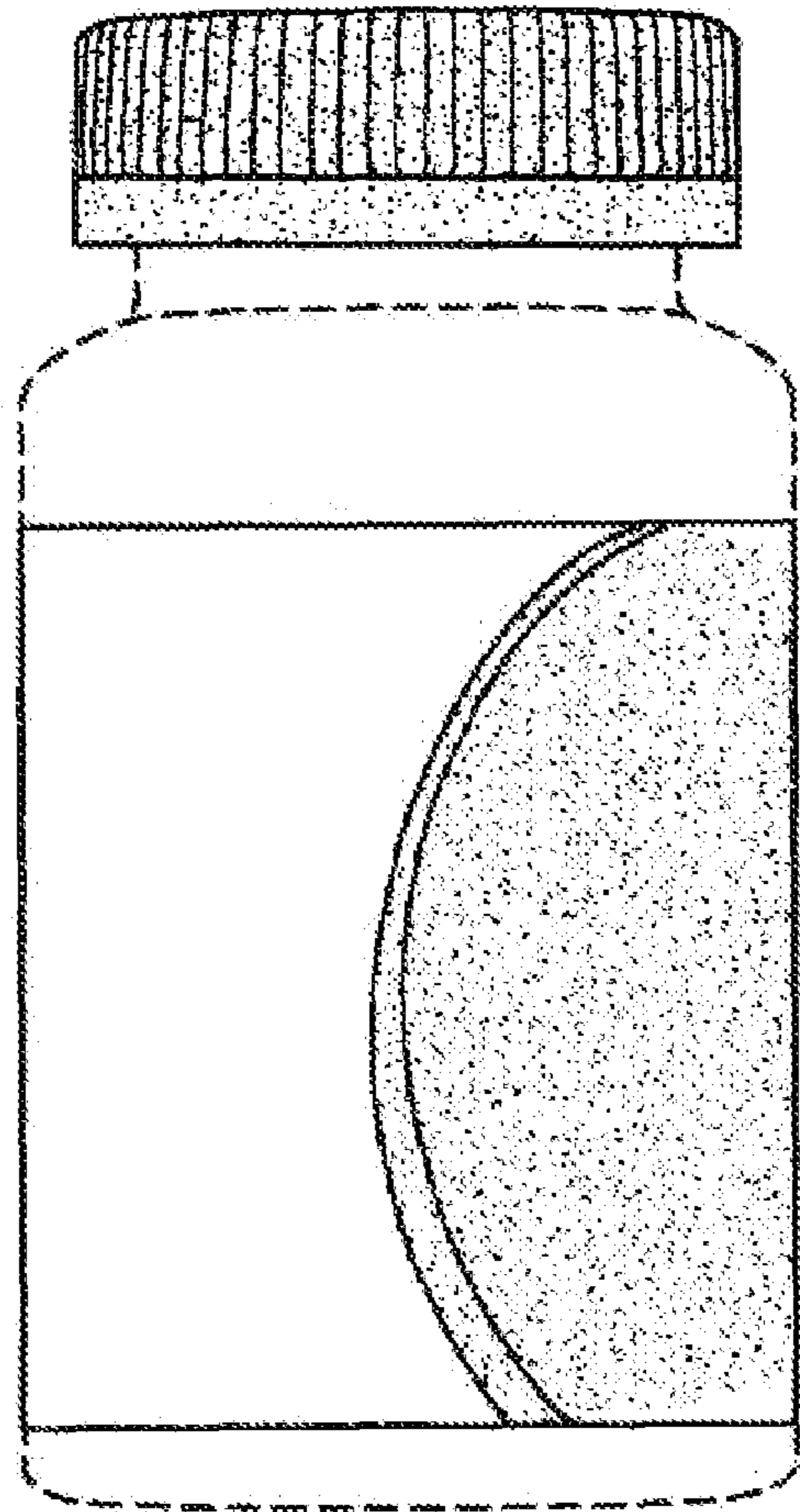

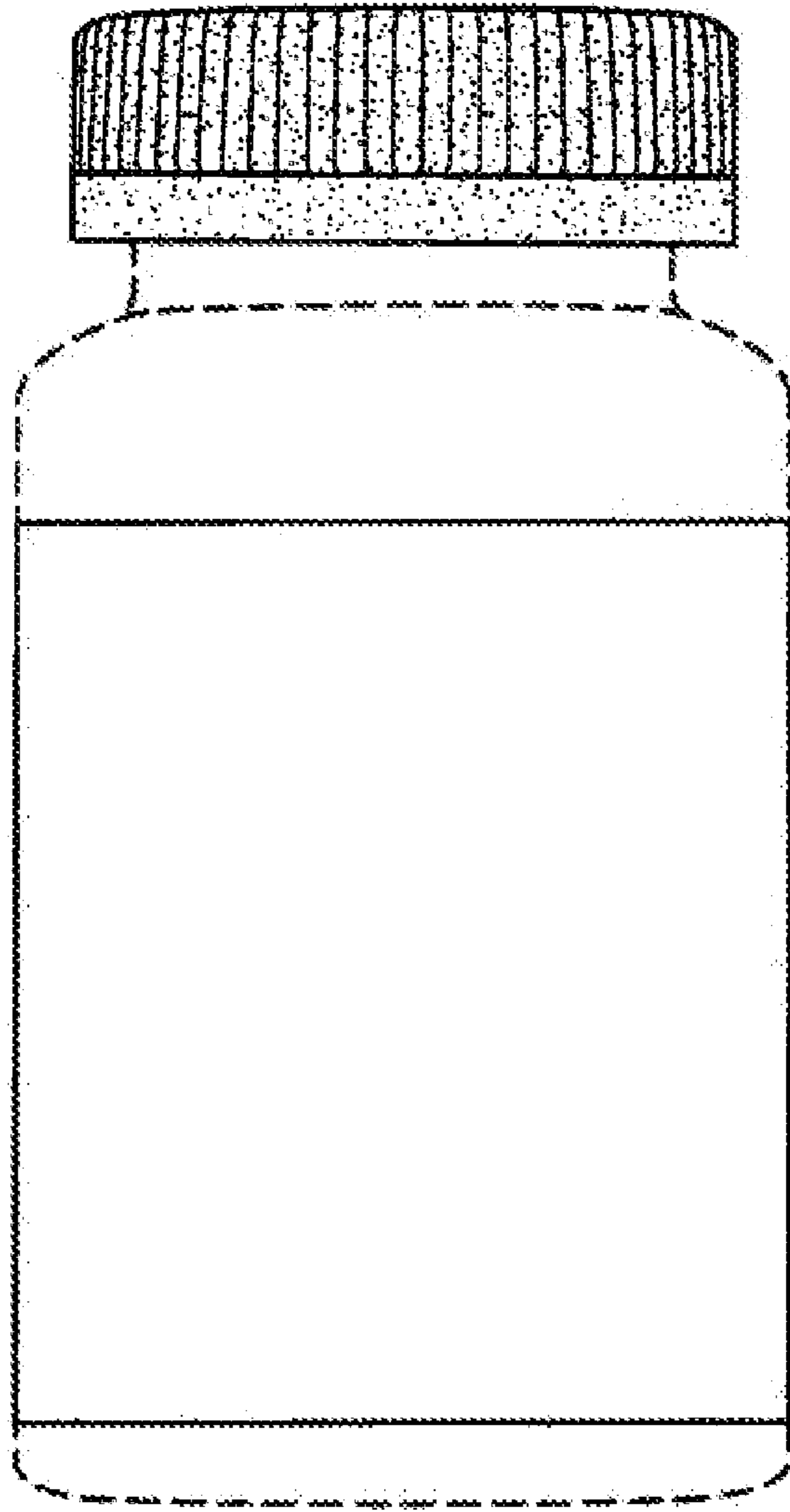

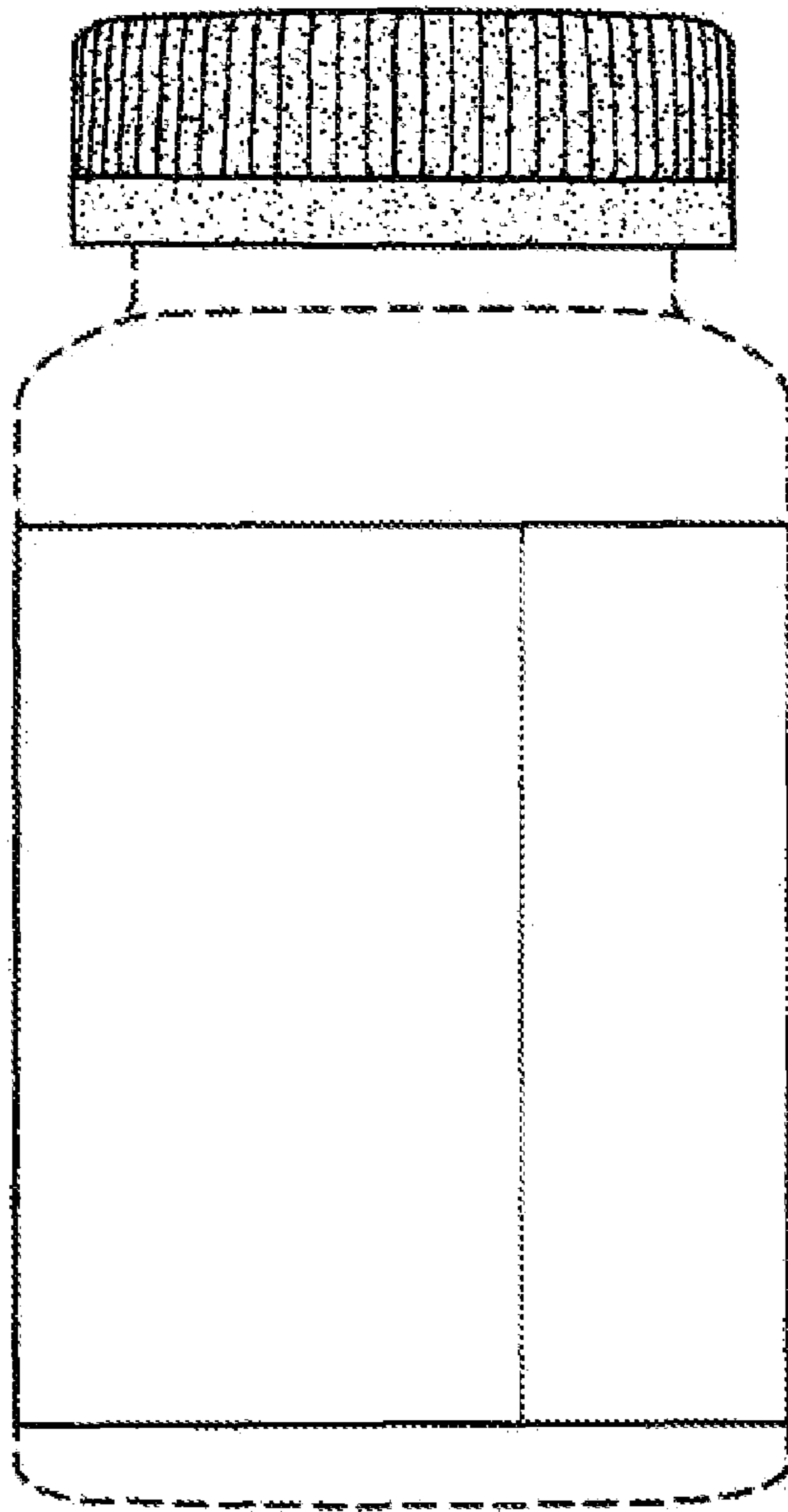

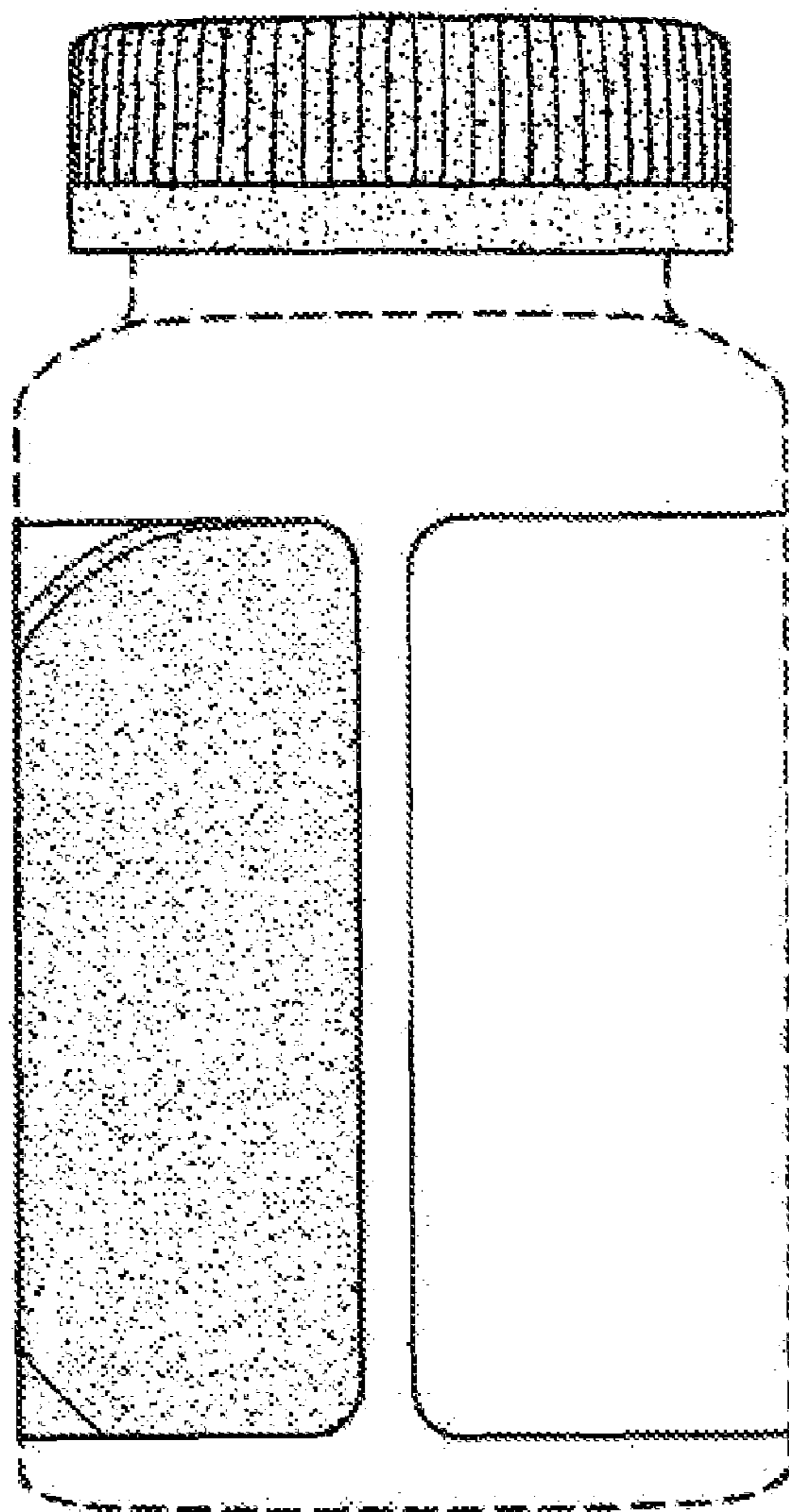

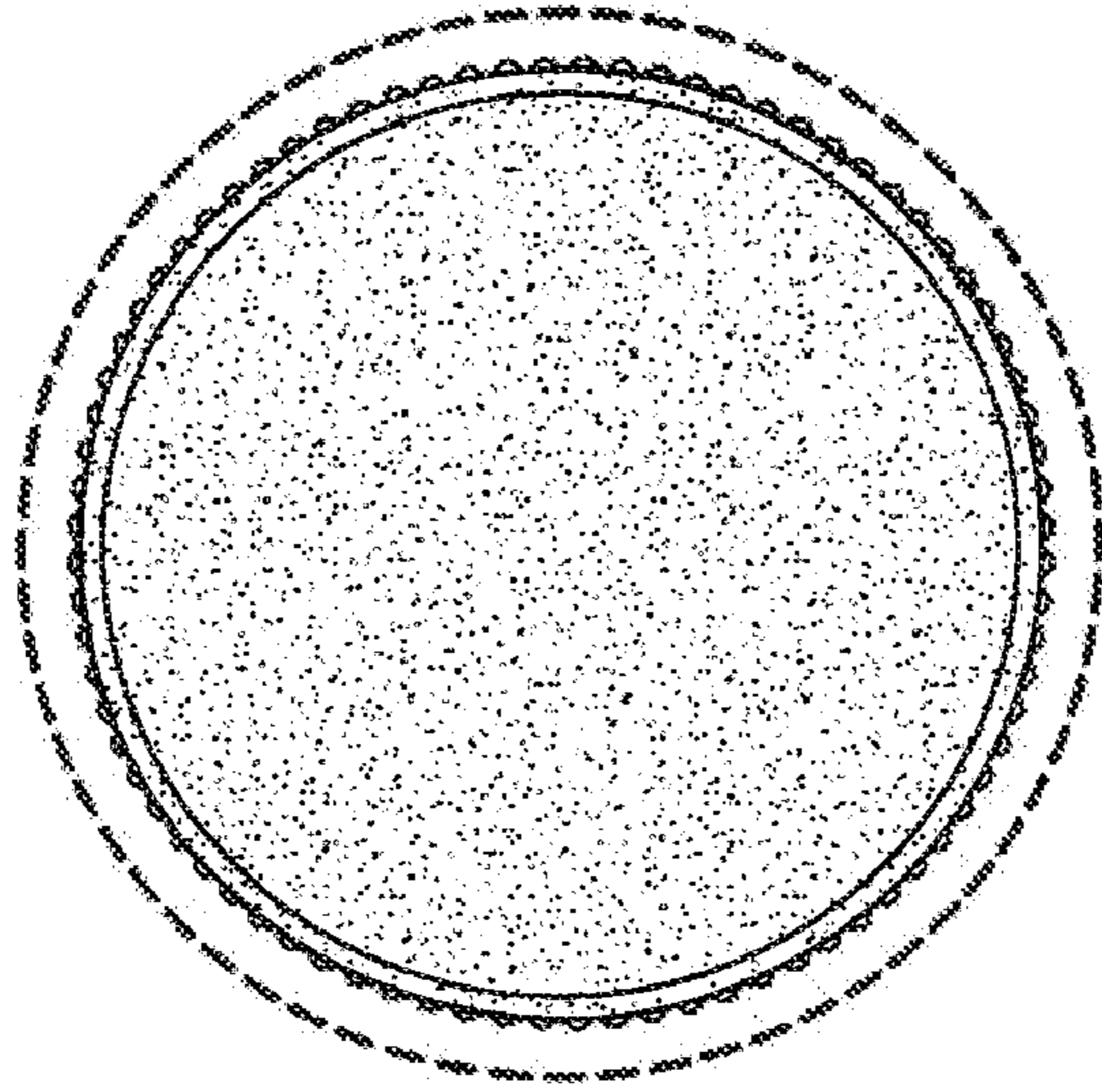

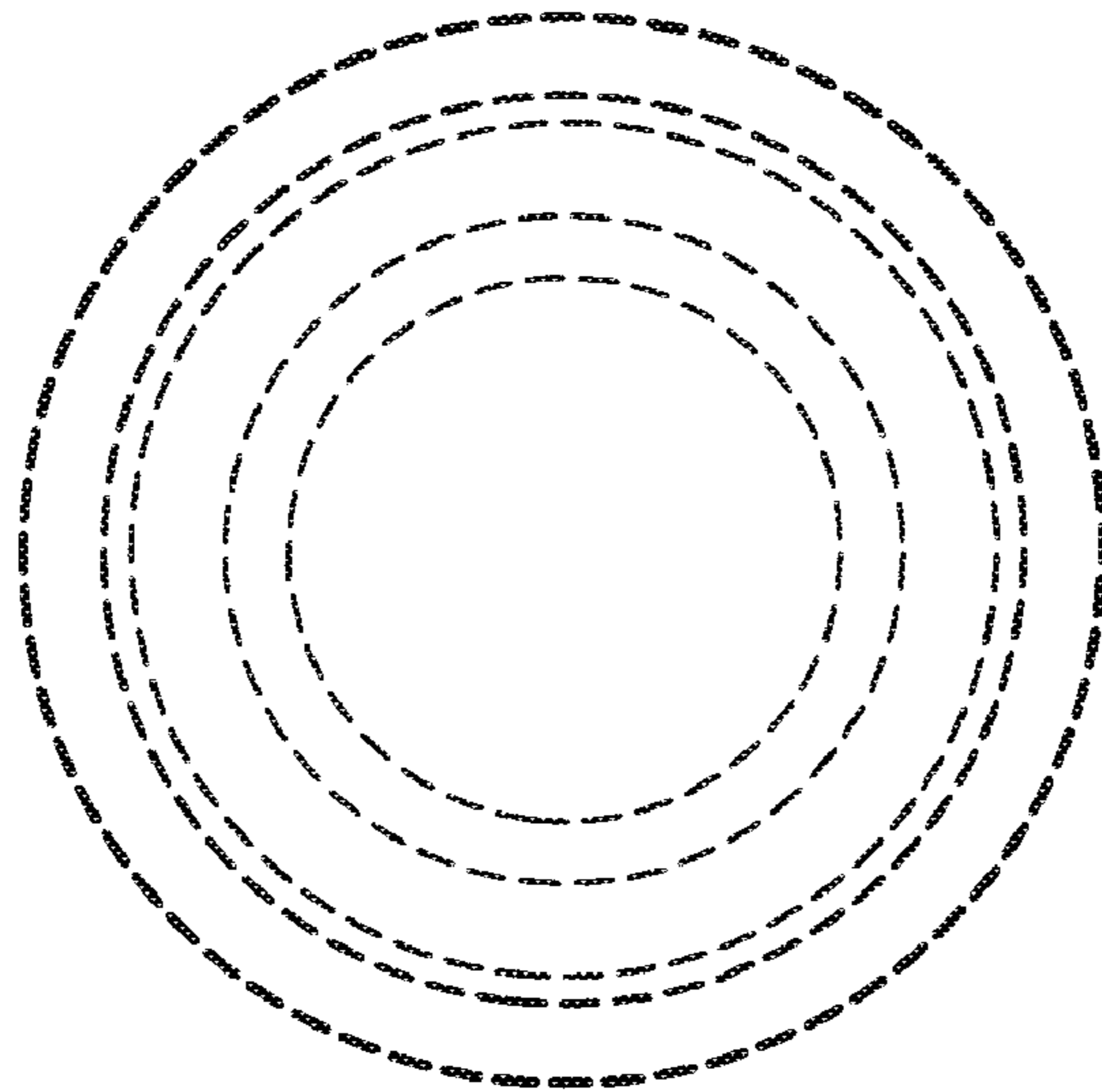
