DESCRIPTION

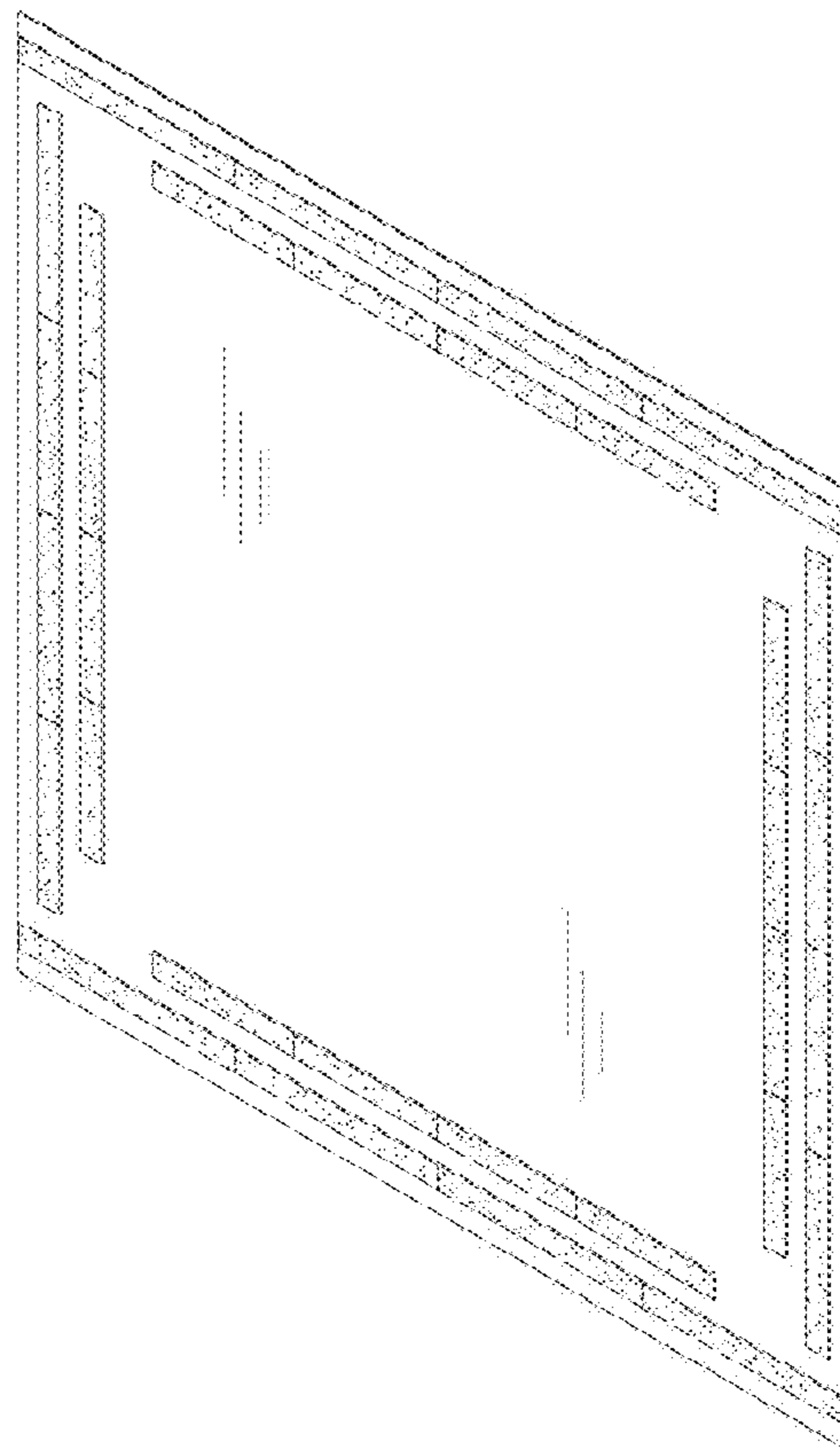
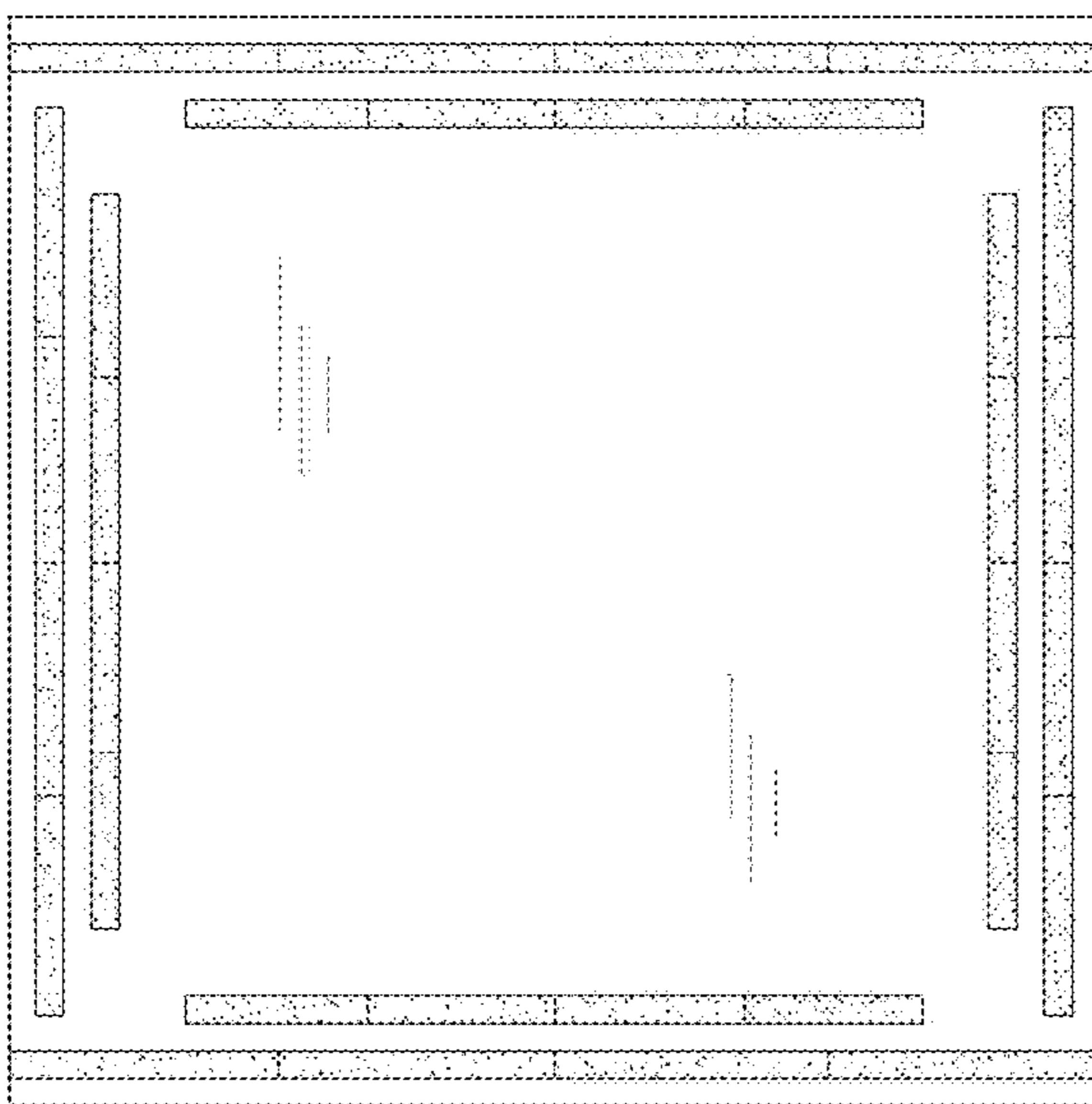
FIG. 1 is a front view of the wrapping paper with built-in adhesive strips.

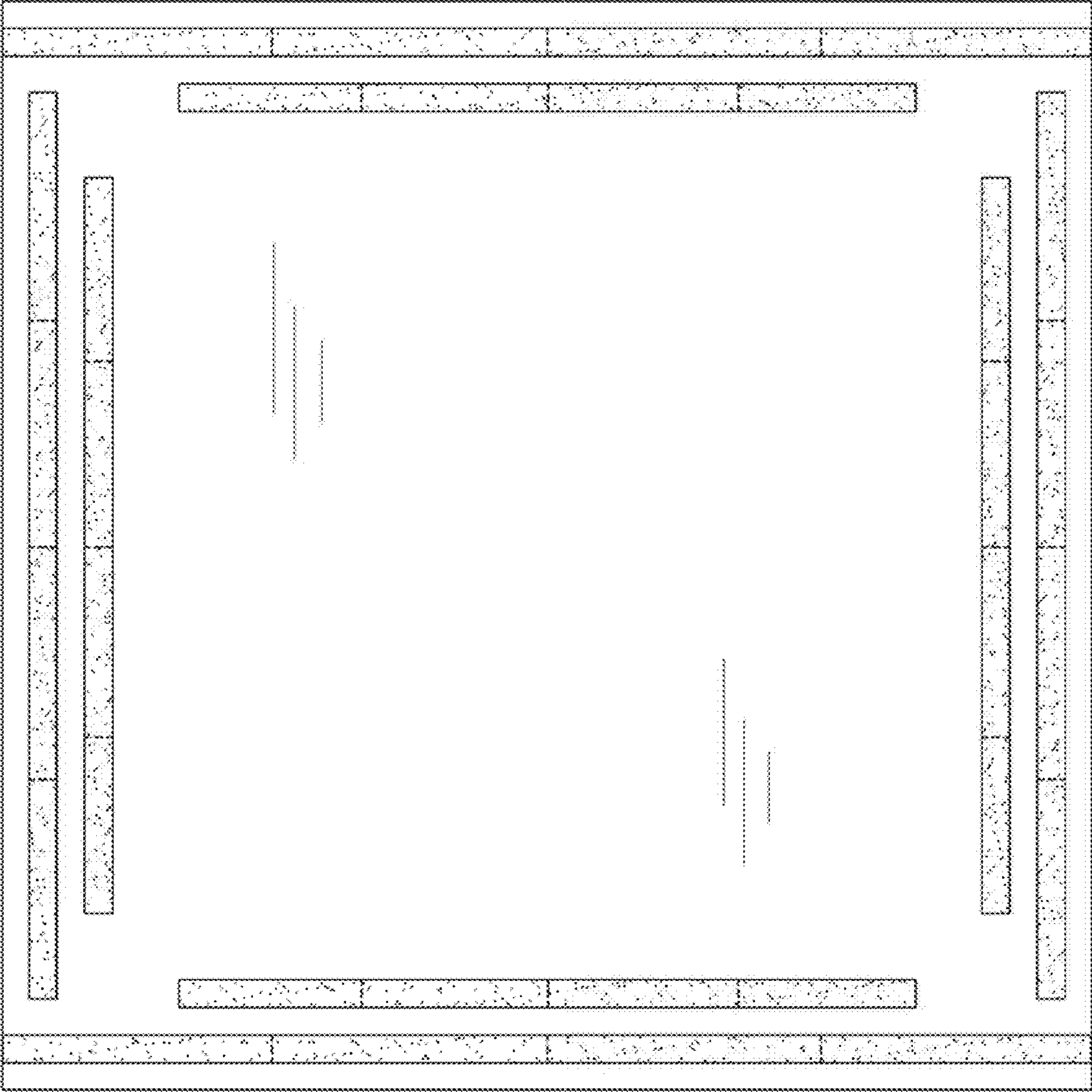

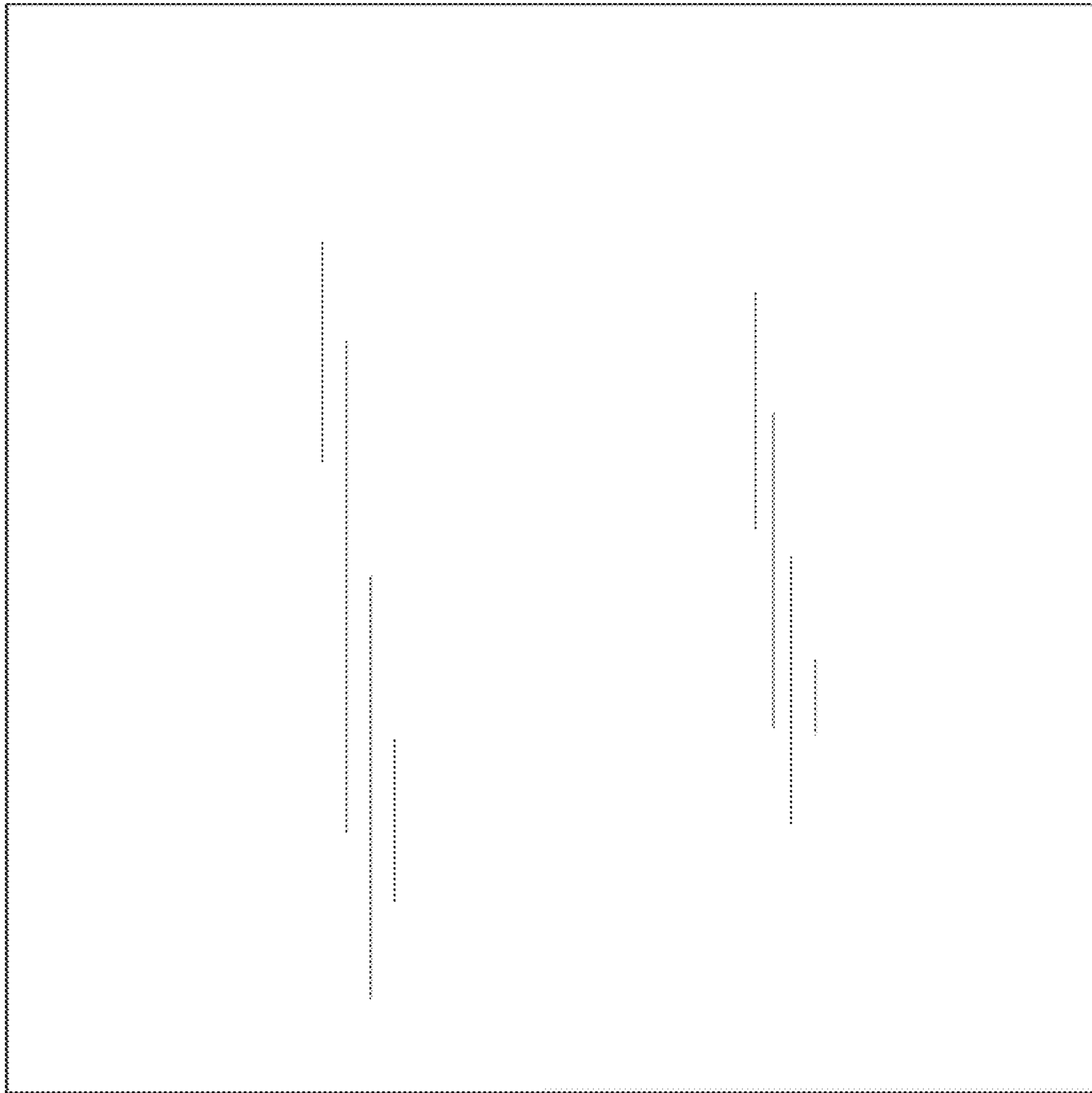

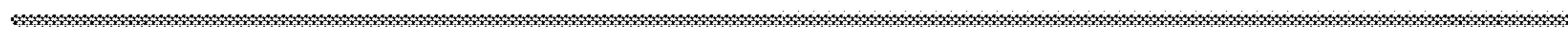

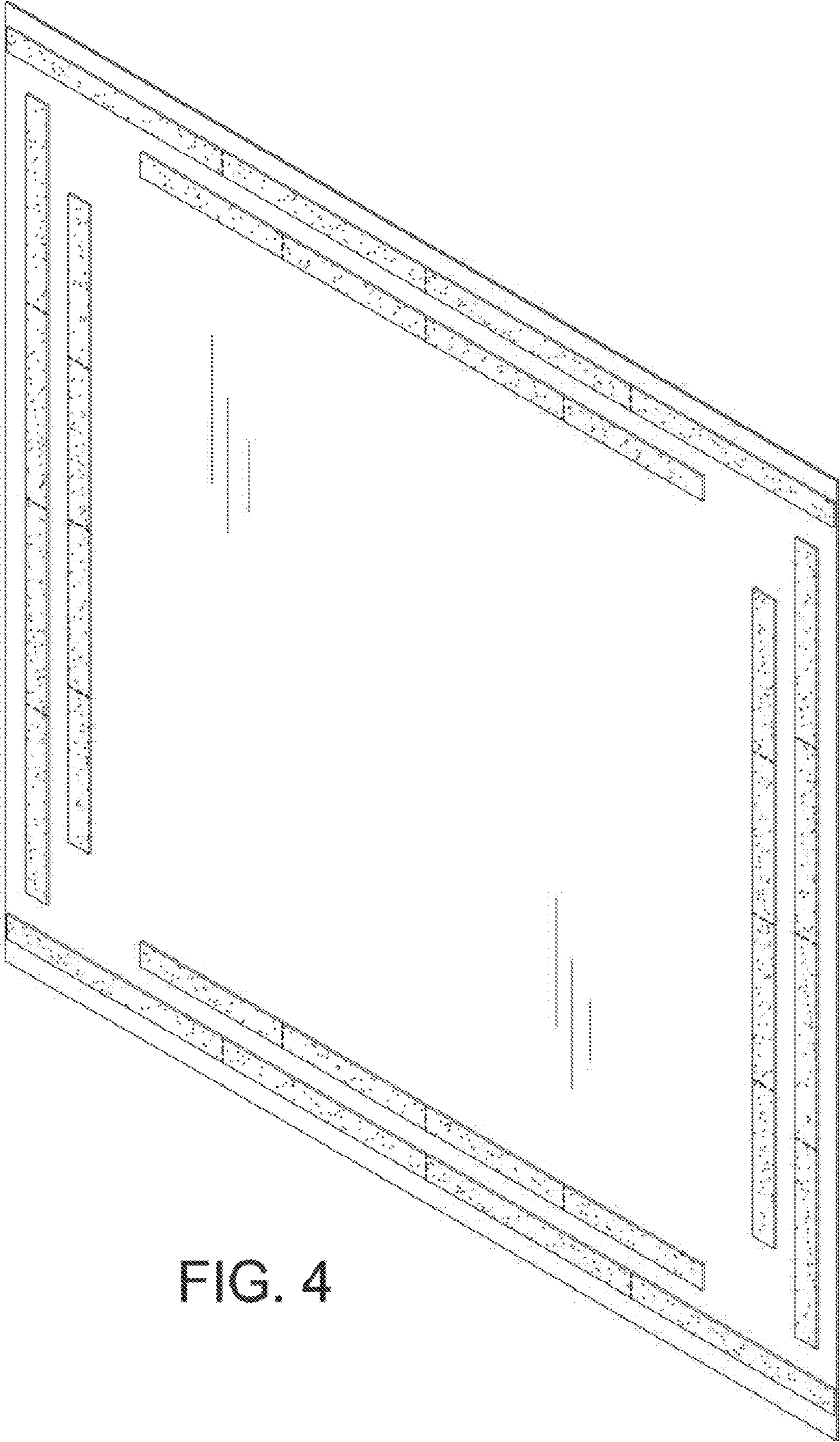
