bumper cover;

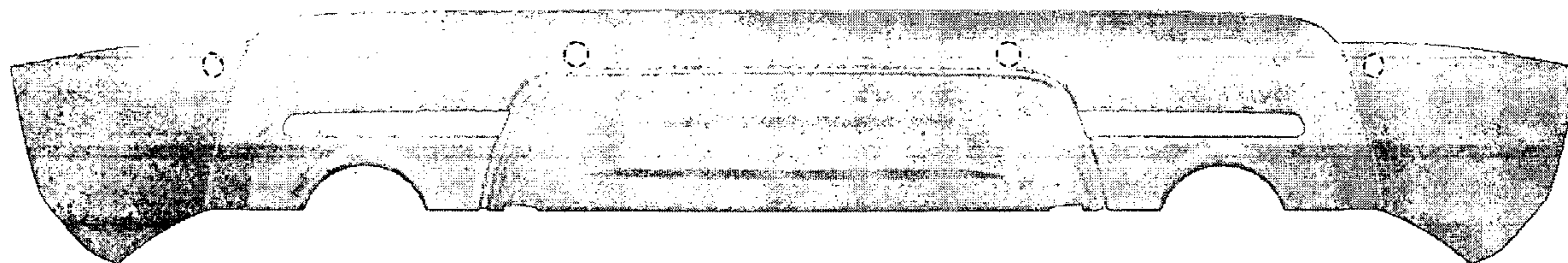
FIG. 4 is a left side elevational view of the vehicle lower rear

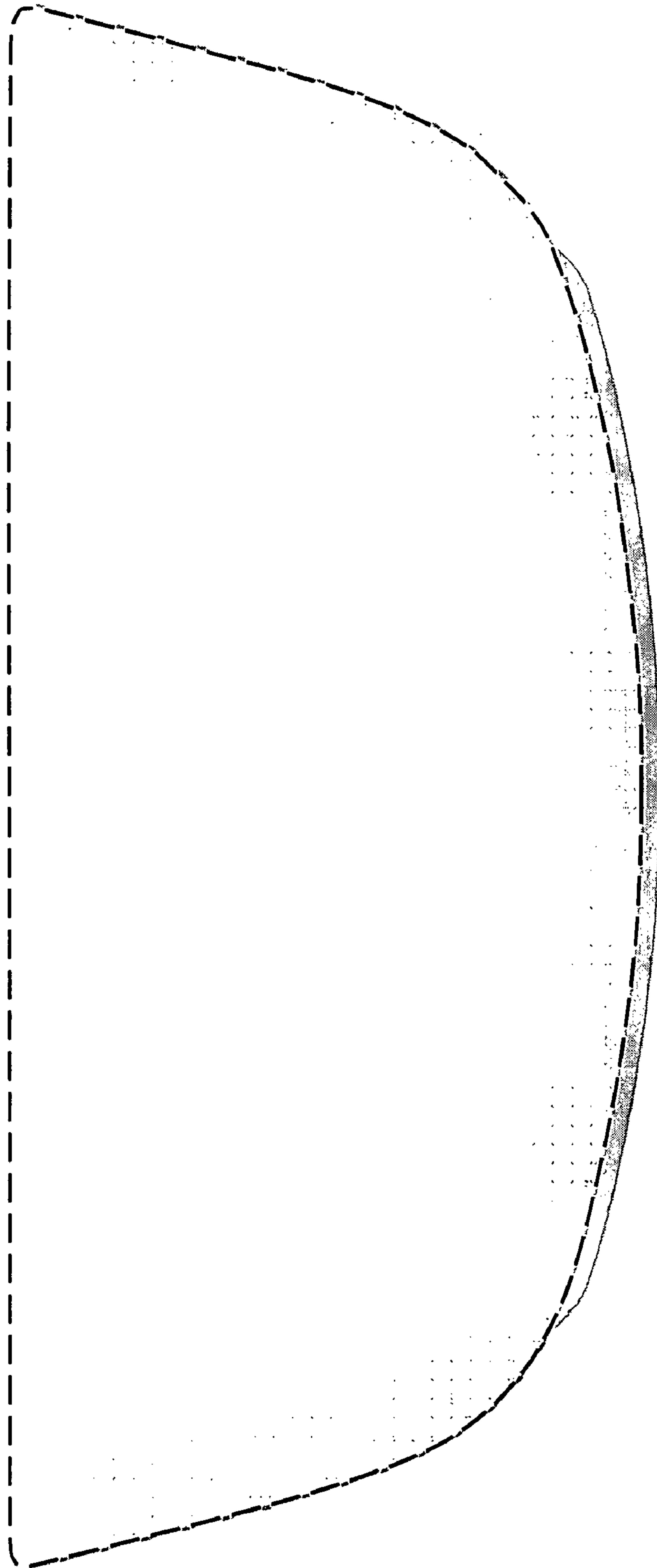

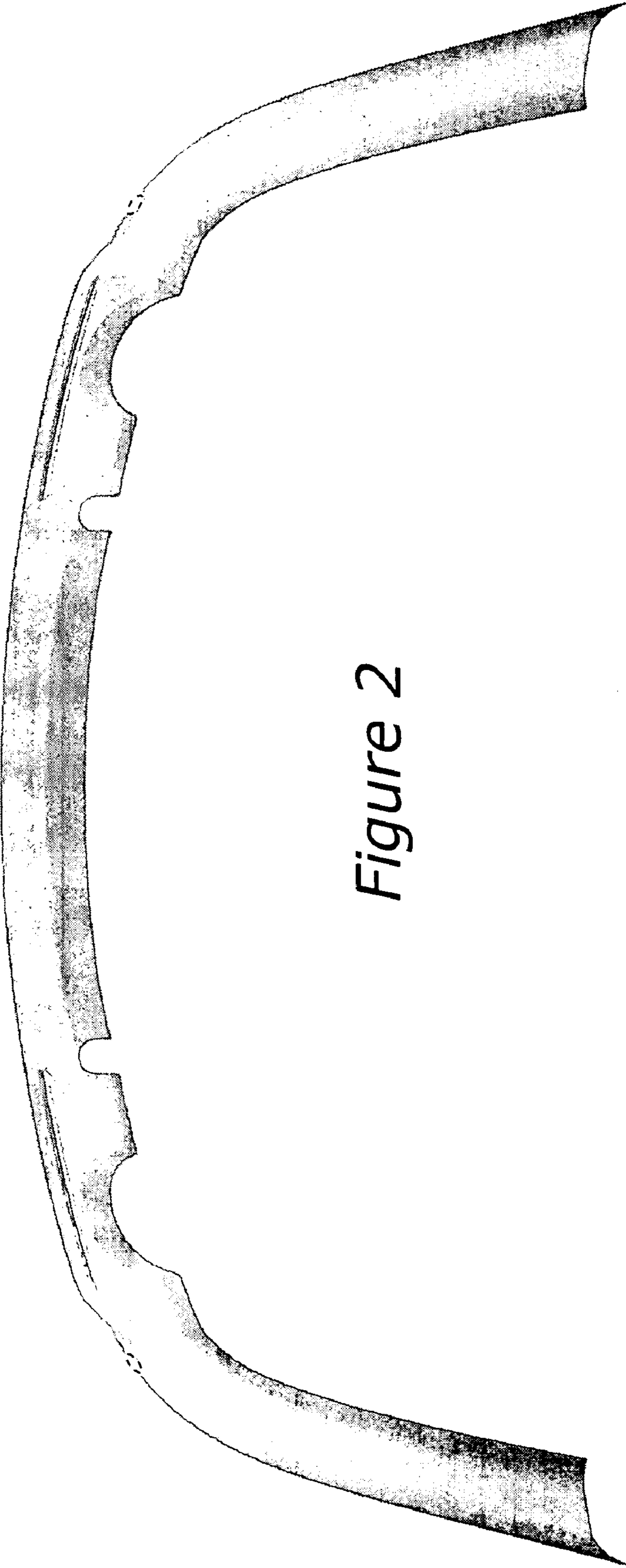

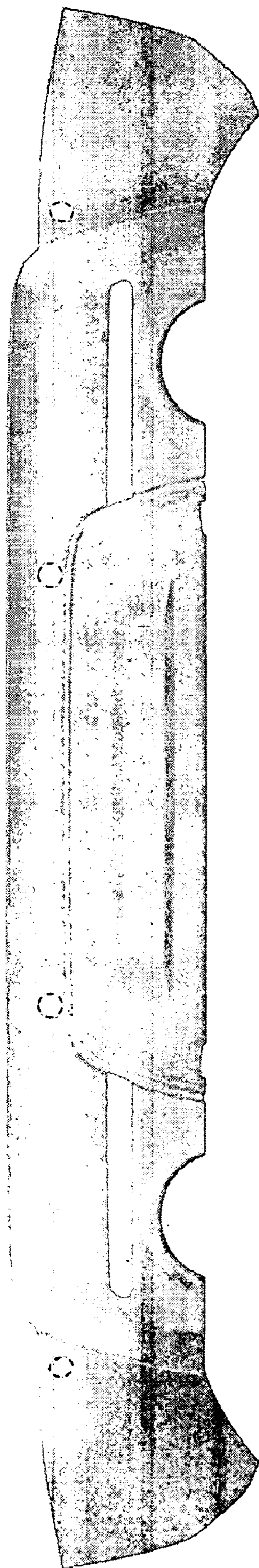

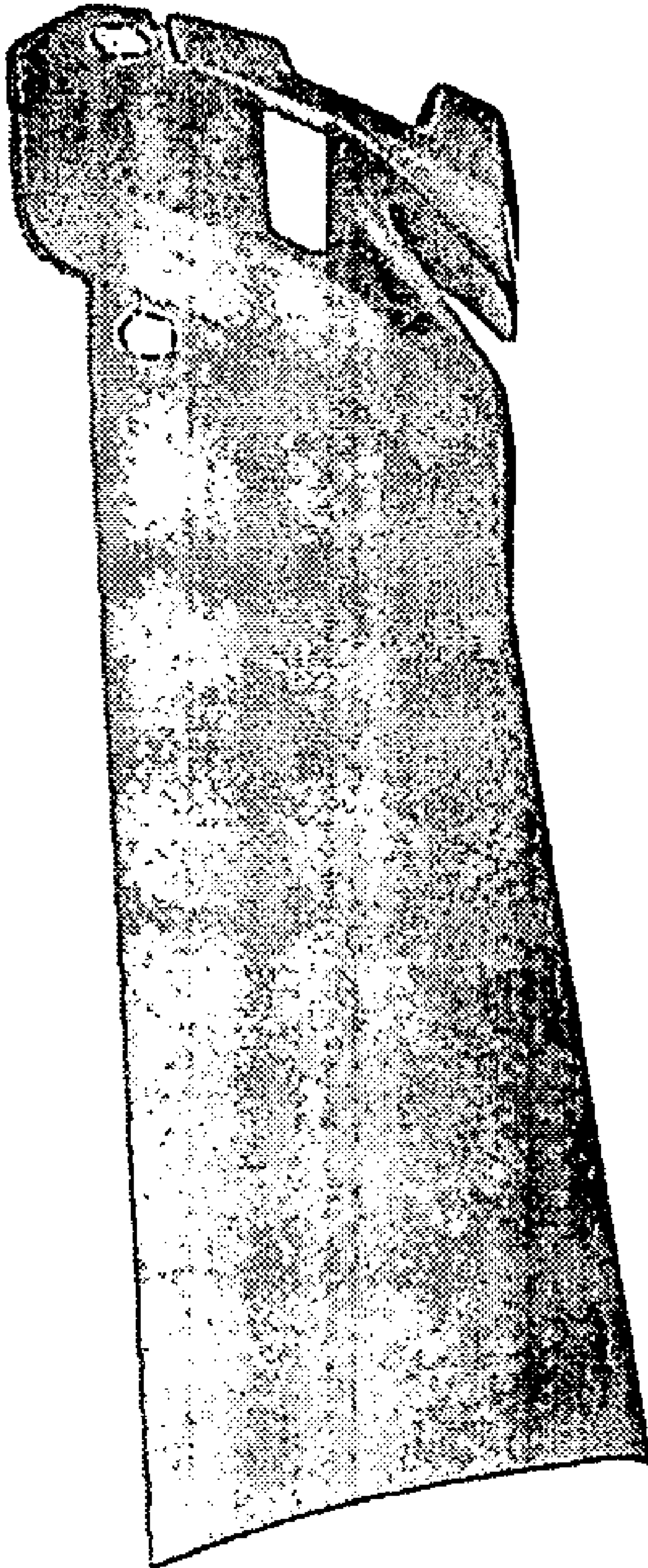

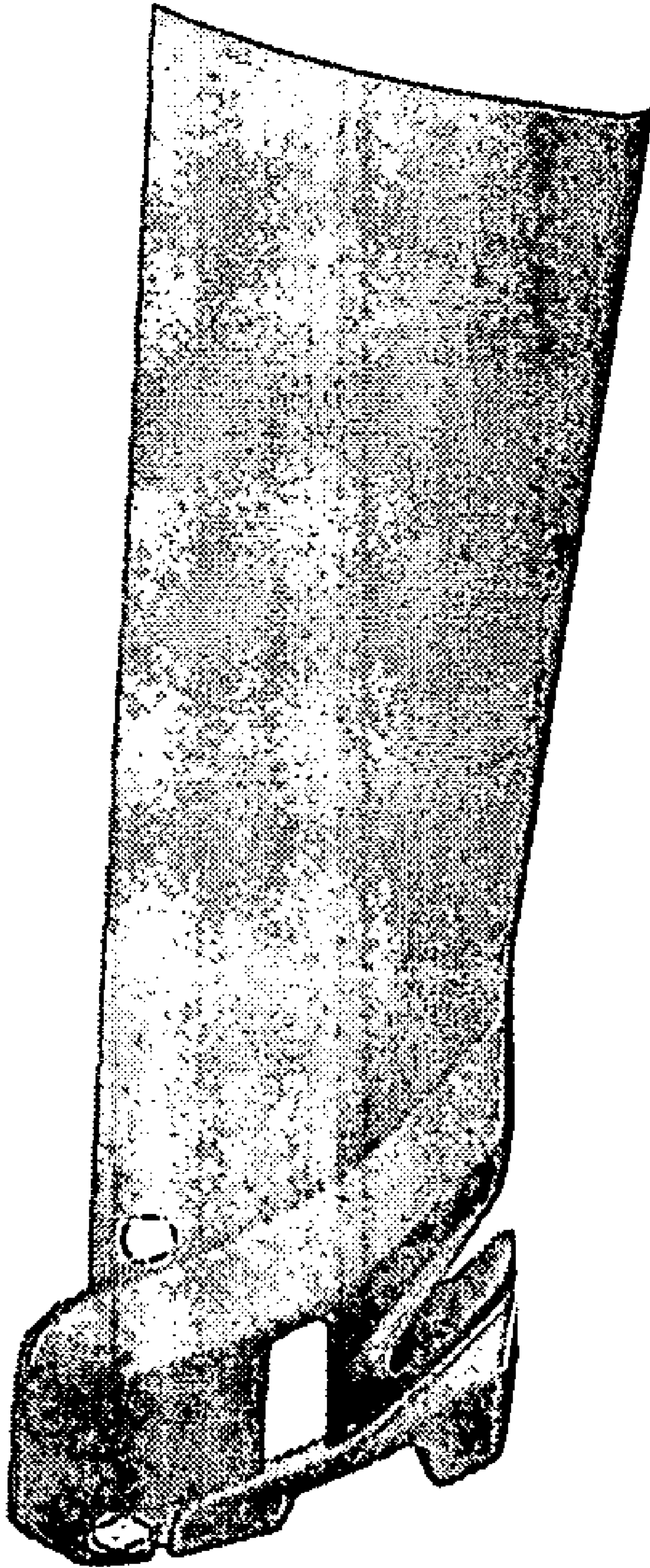

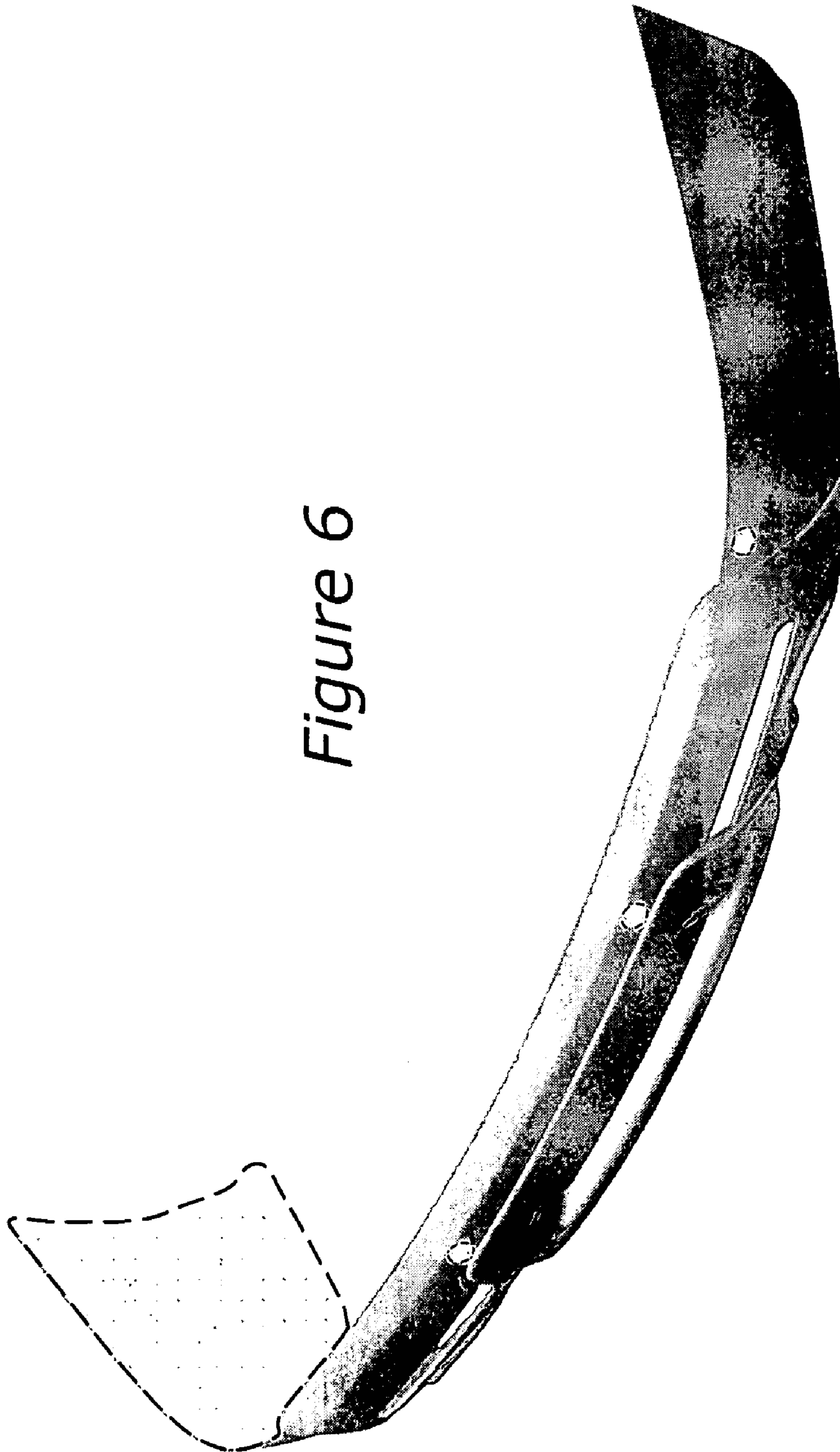
