FIG. 4 is a back view of the media player shown in FIG. 1;

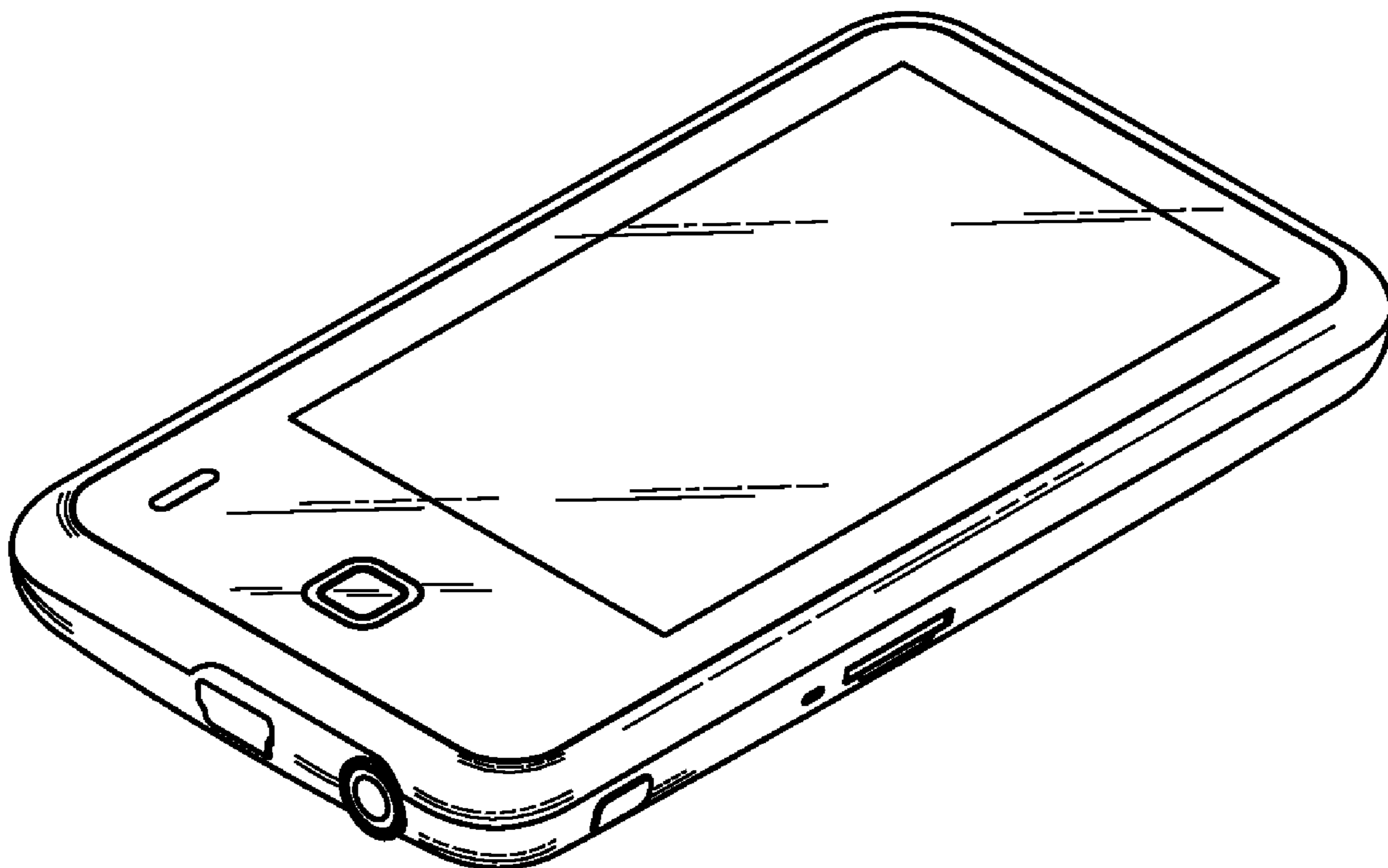
FIG. 5 is a left view of the media player shown in FIG. 1;

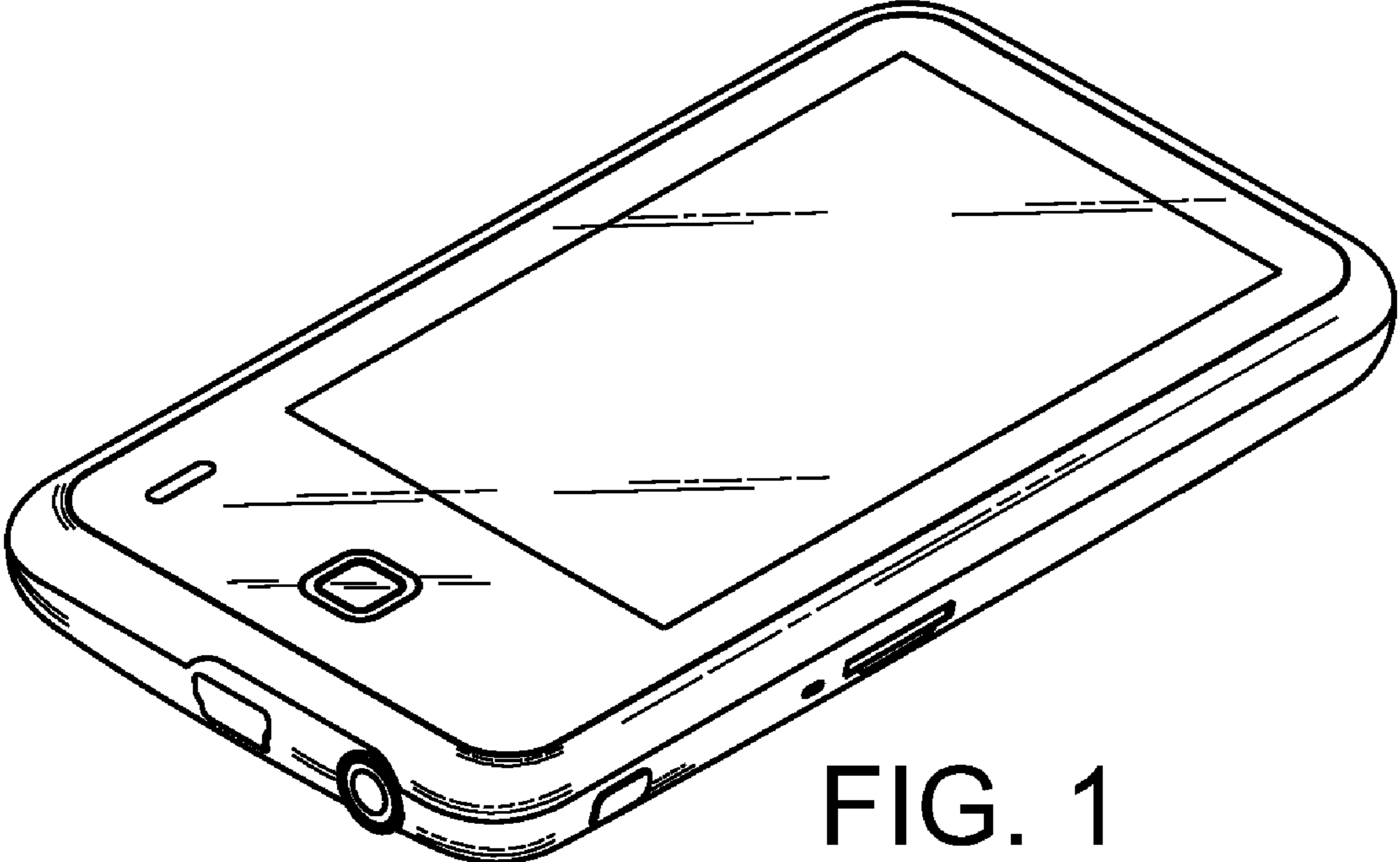

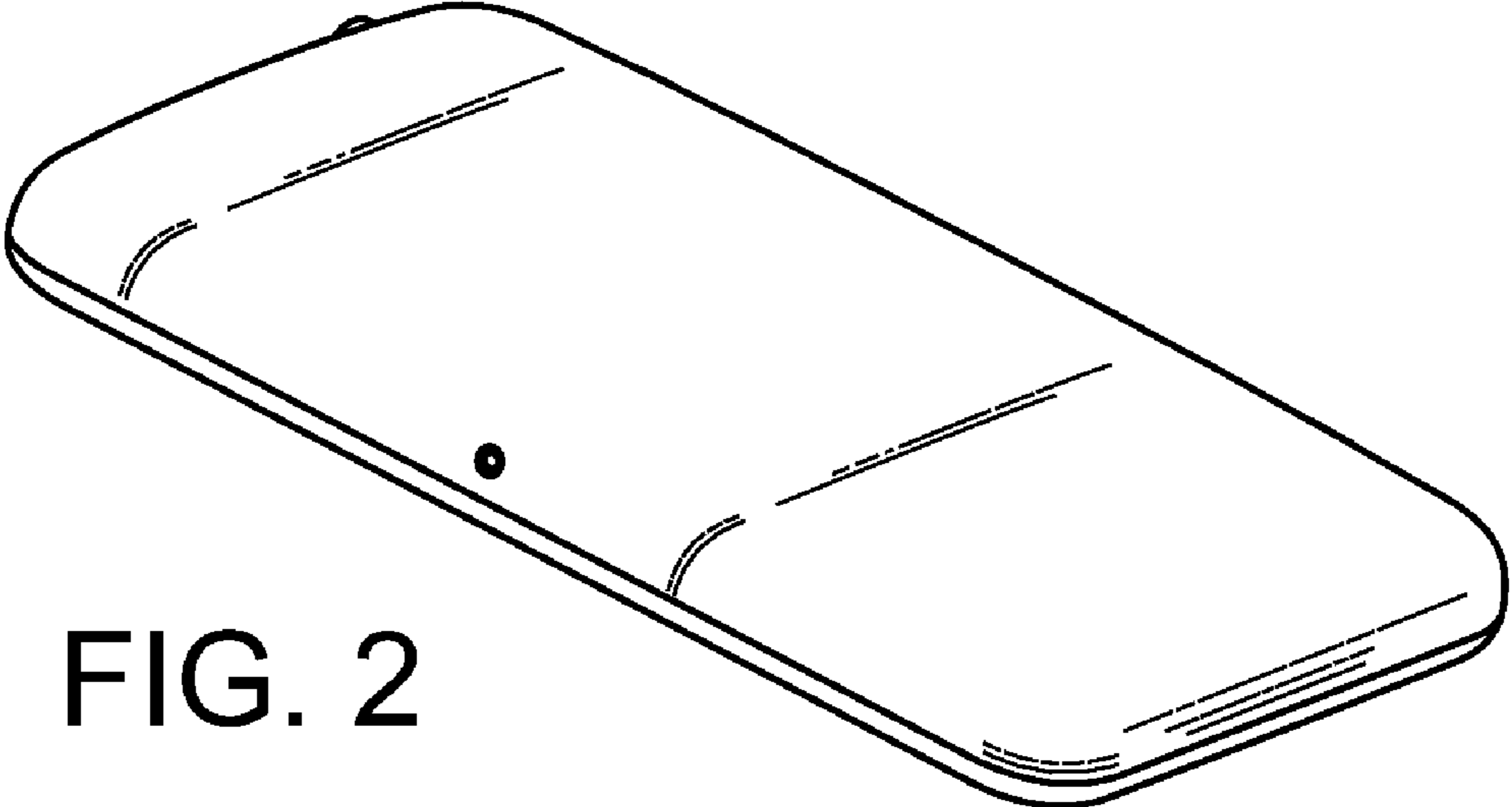

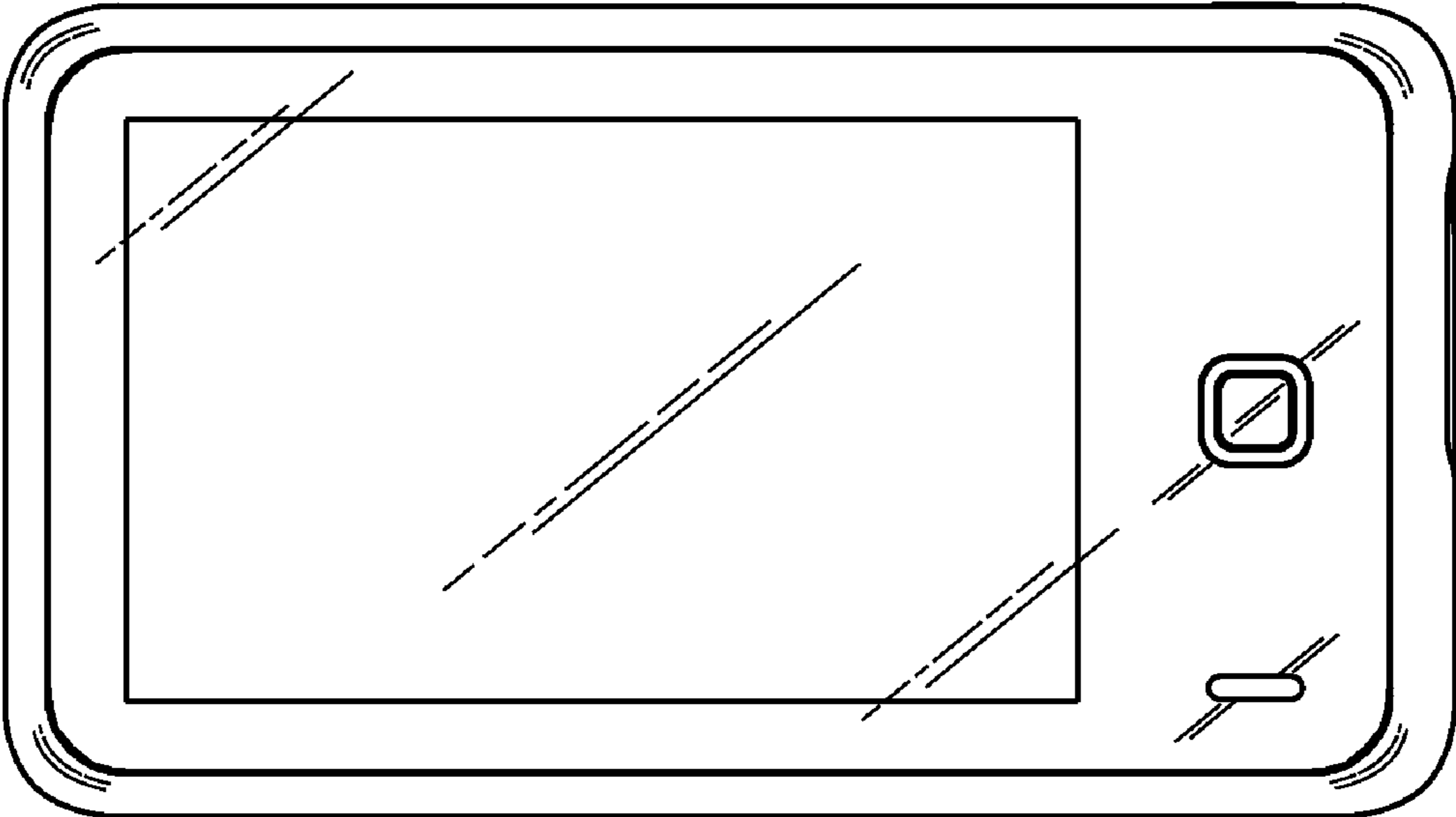

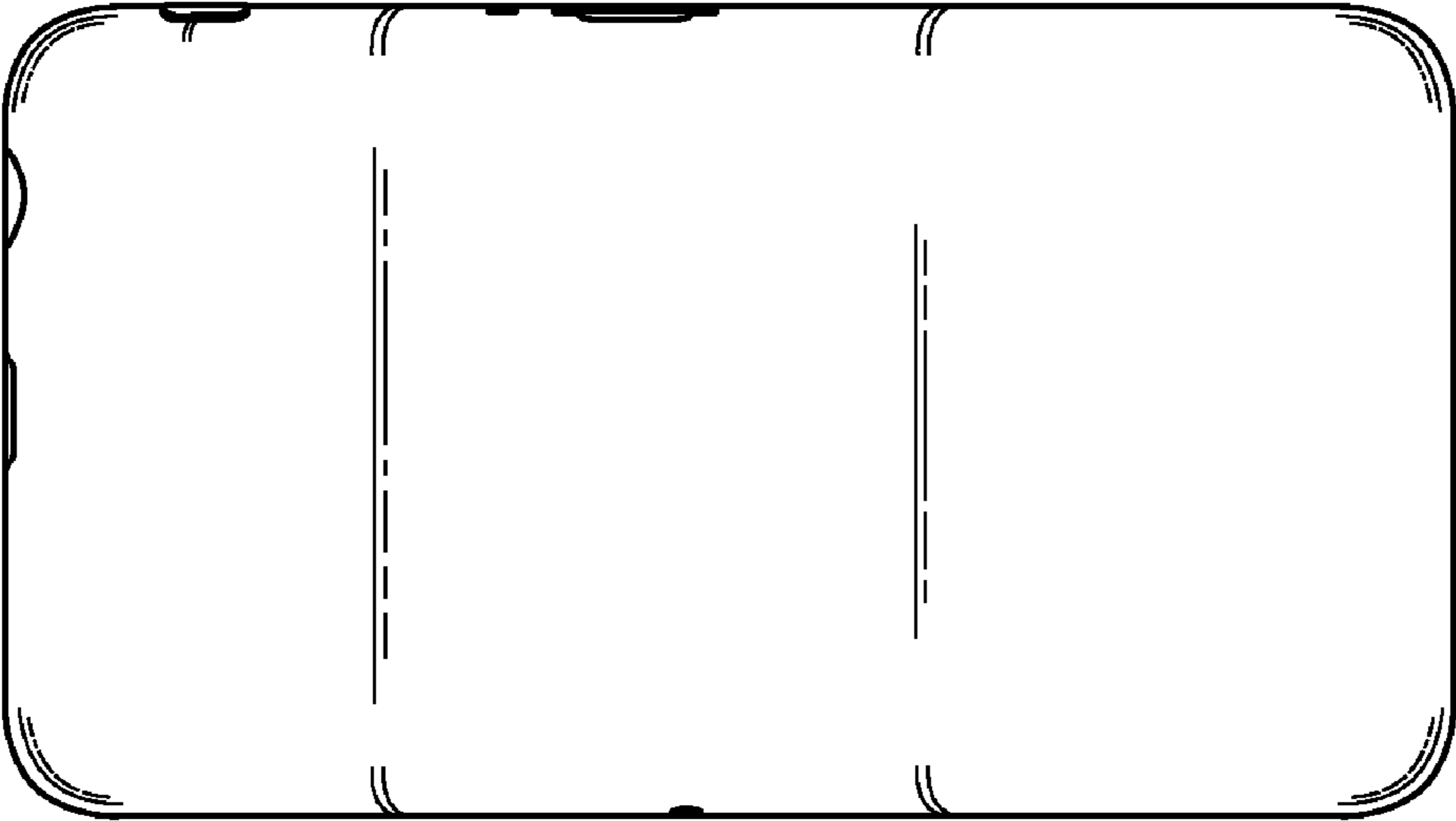

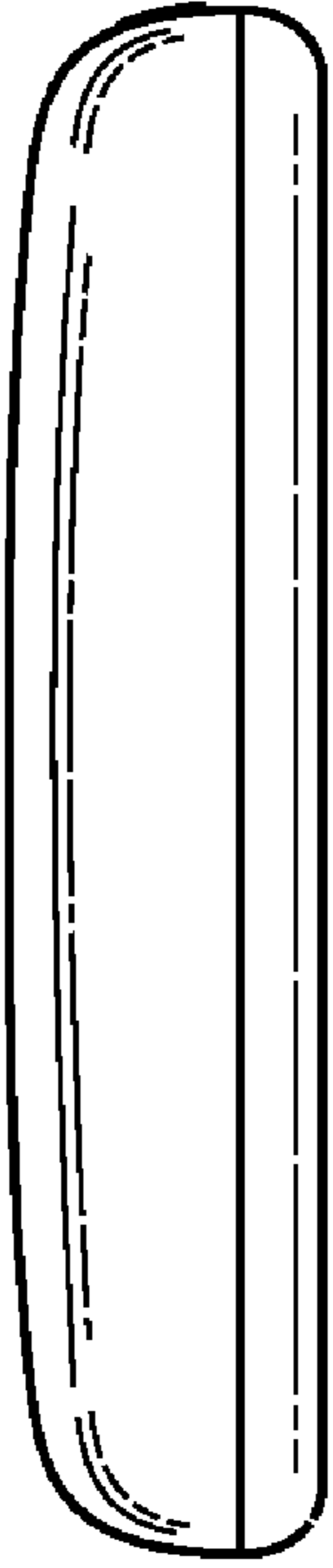

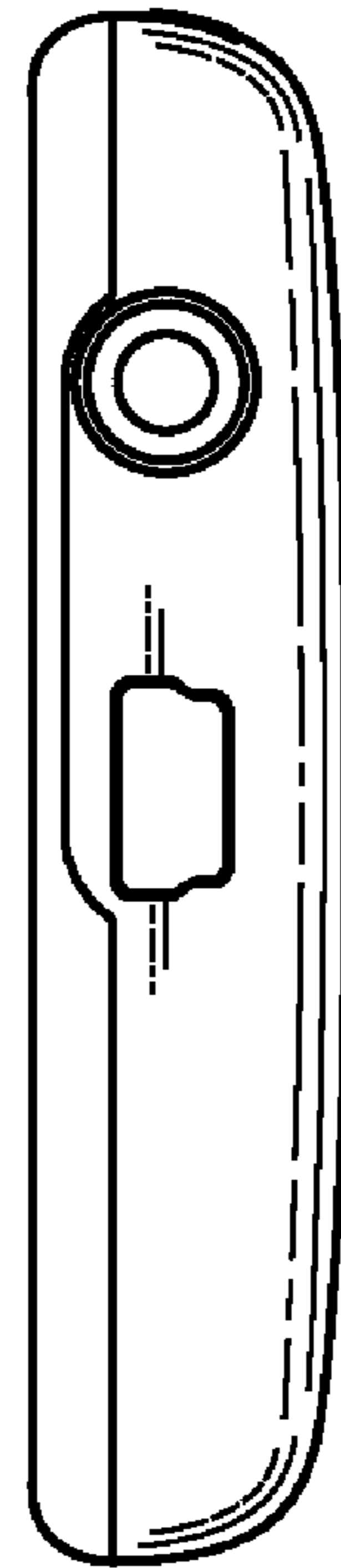

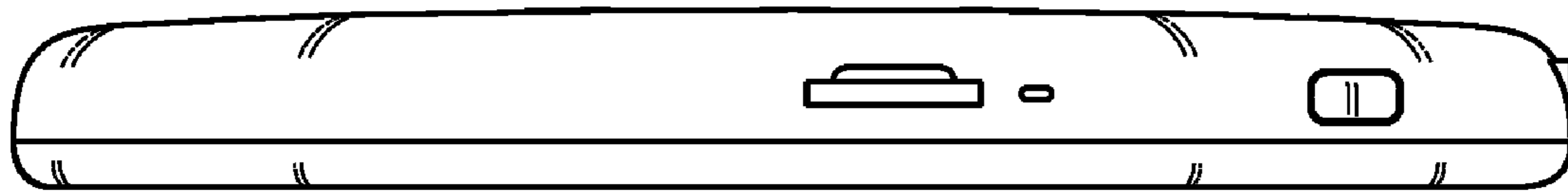

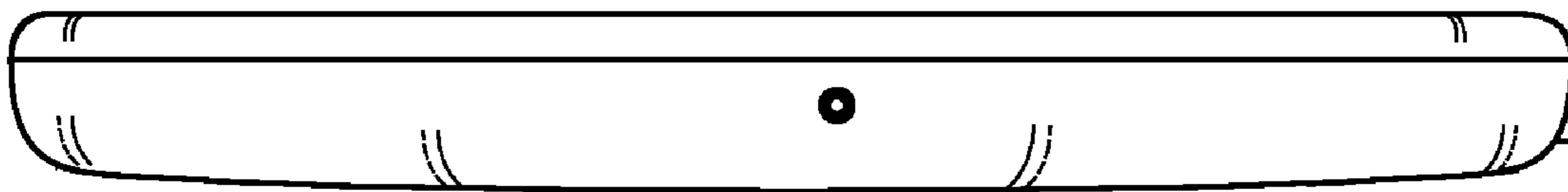
