DESCRIPTION

FIG. 1 is a top, front perspective view of the audio mixer according to the present invention;

FIG. 4 is a left side elevational view thereof;

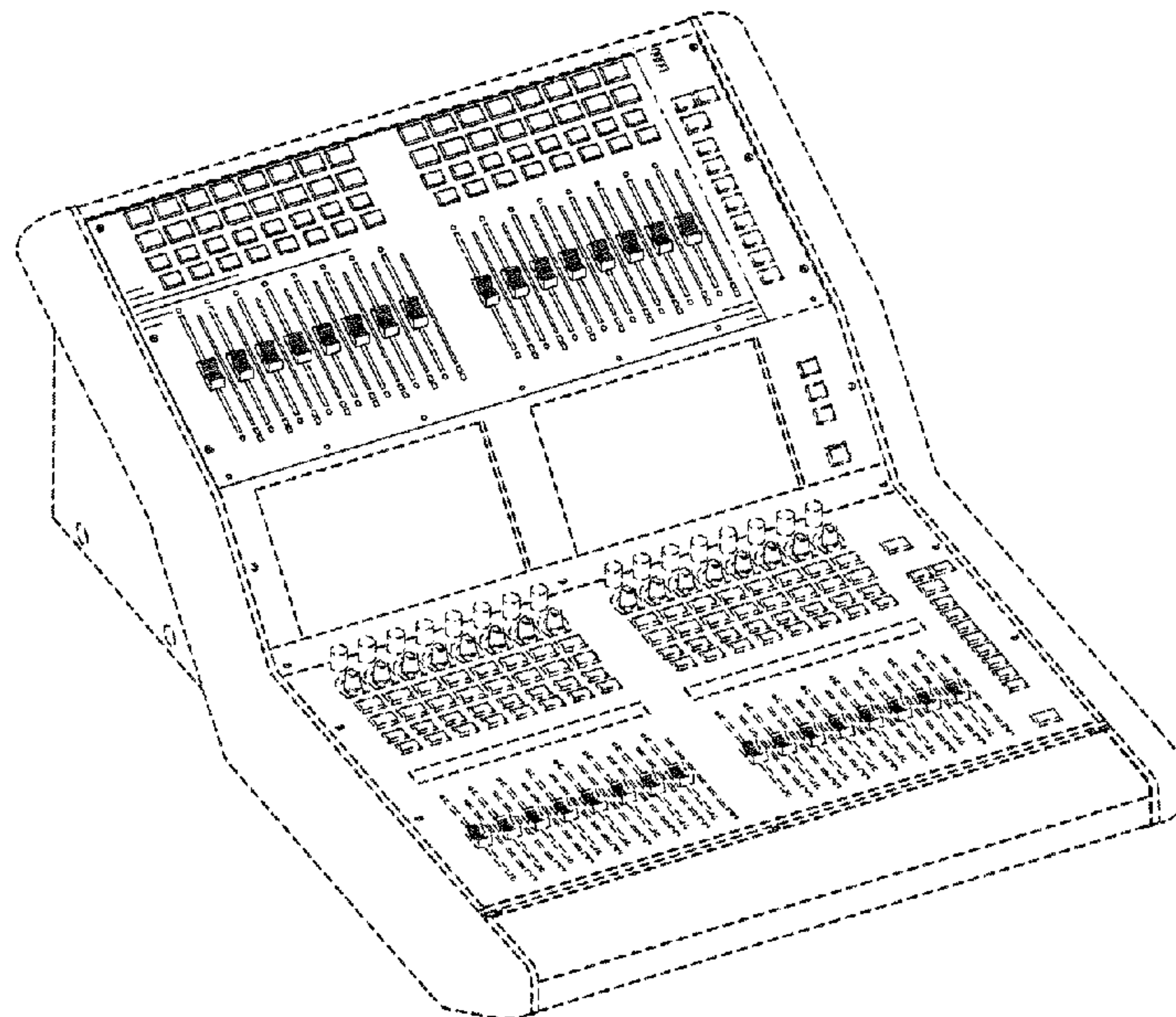
FIG. 5 is a right side elevational view thereof;

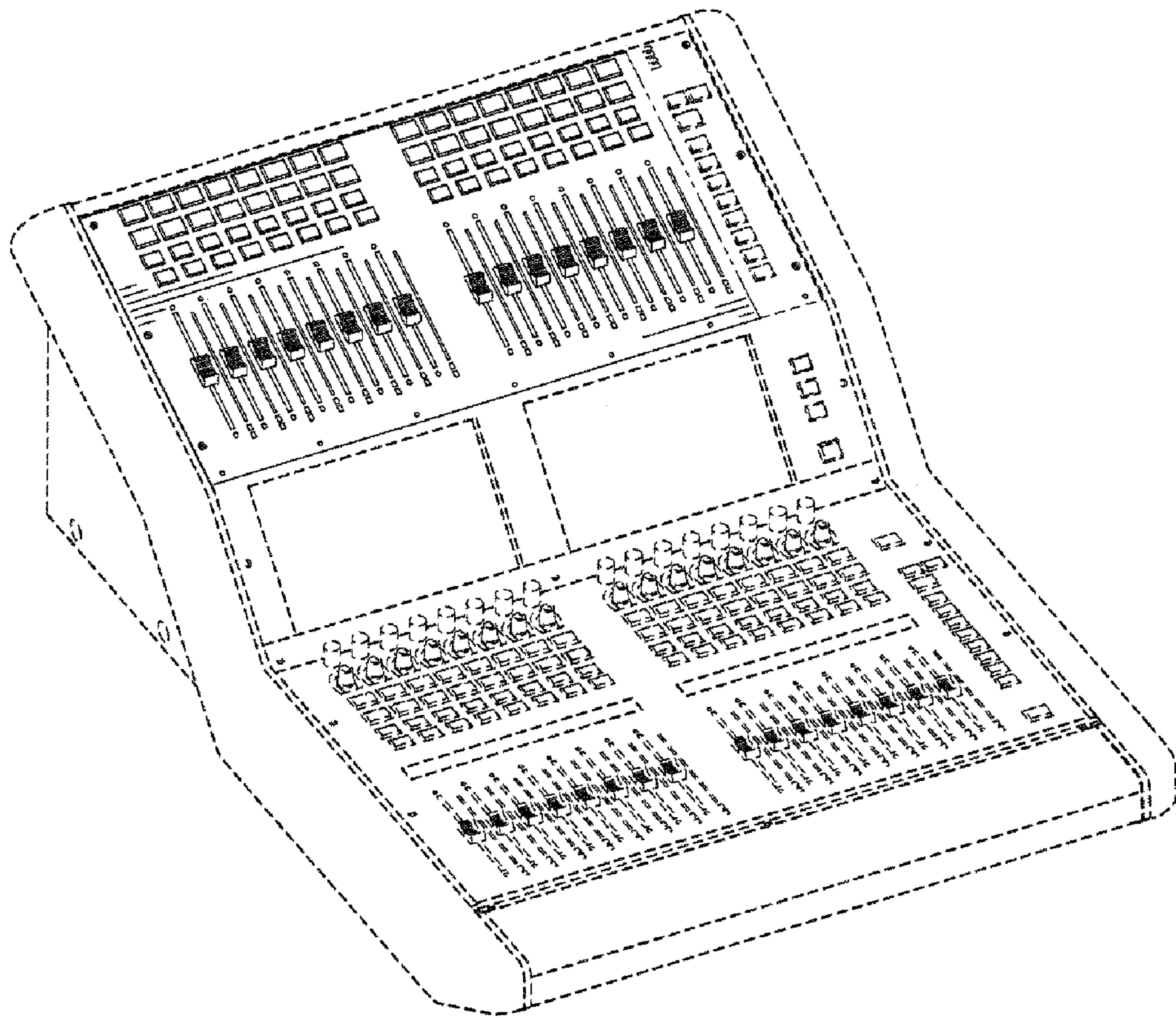

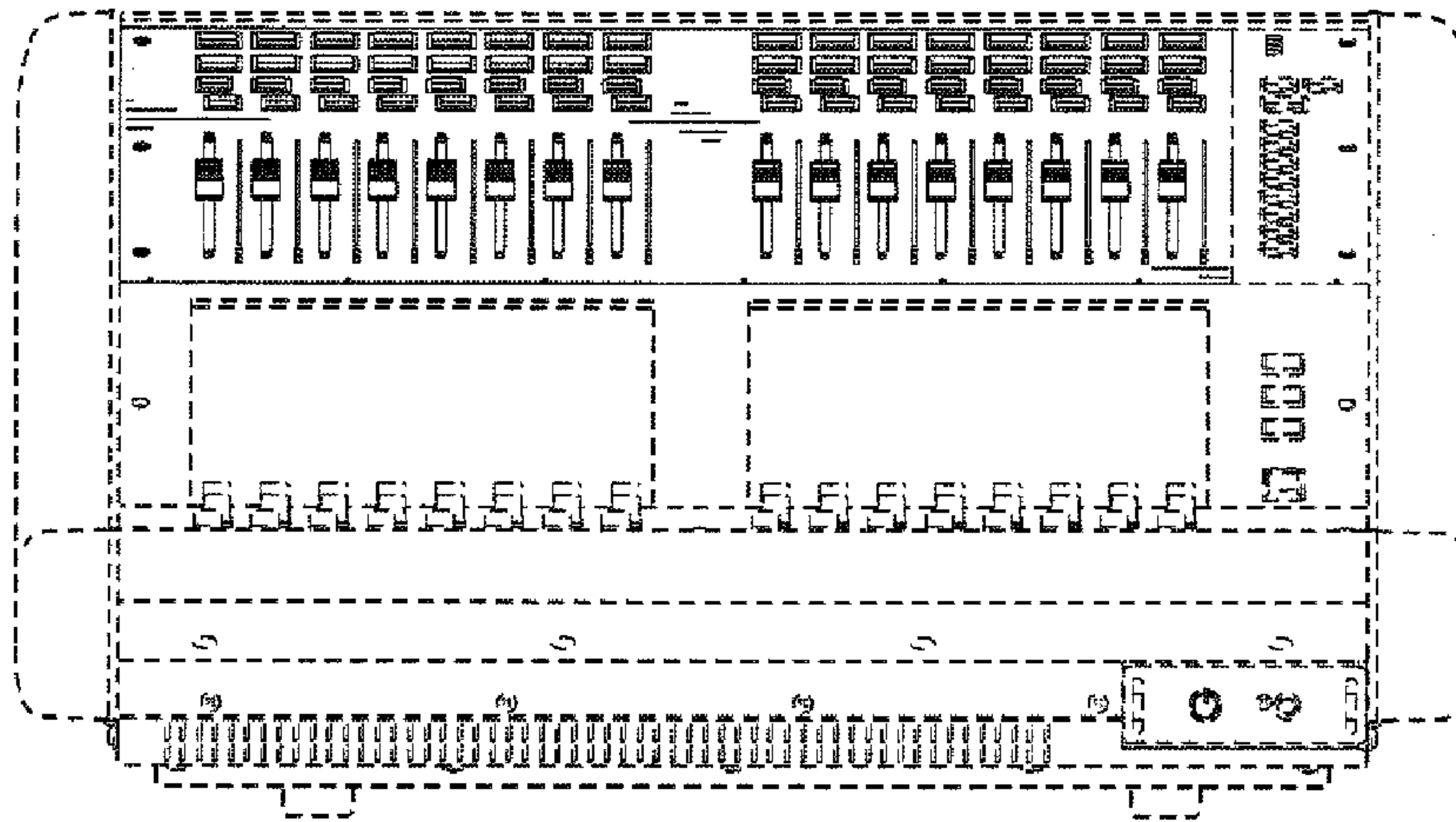

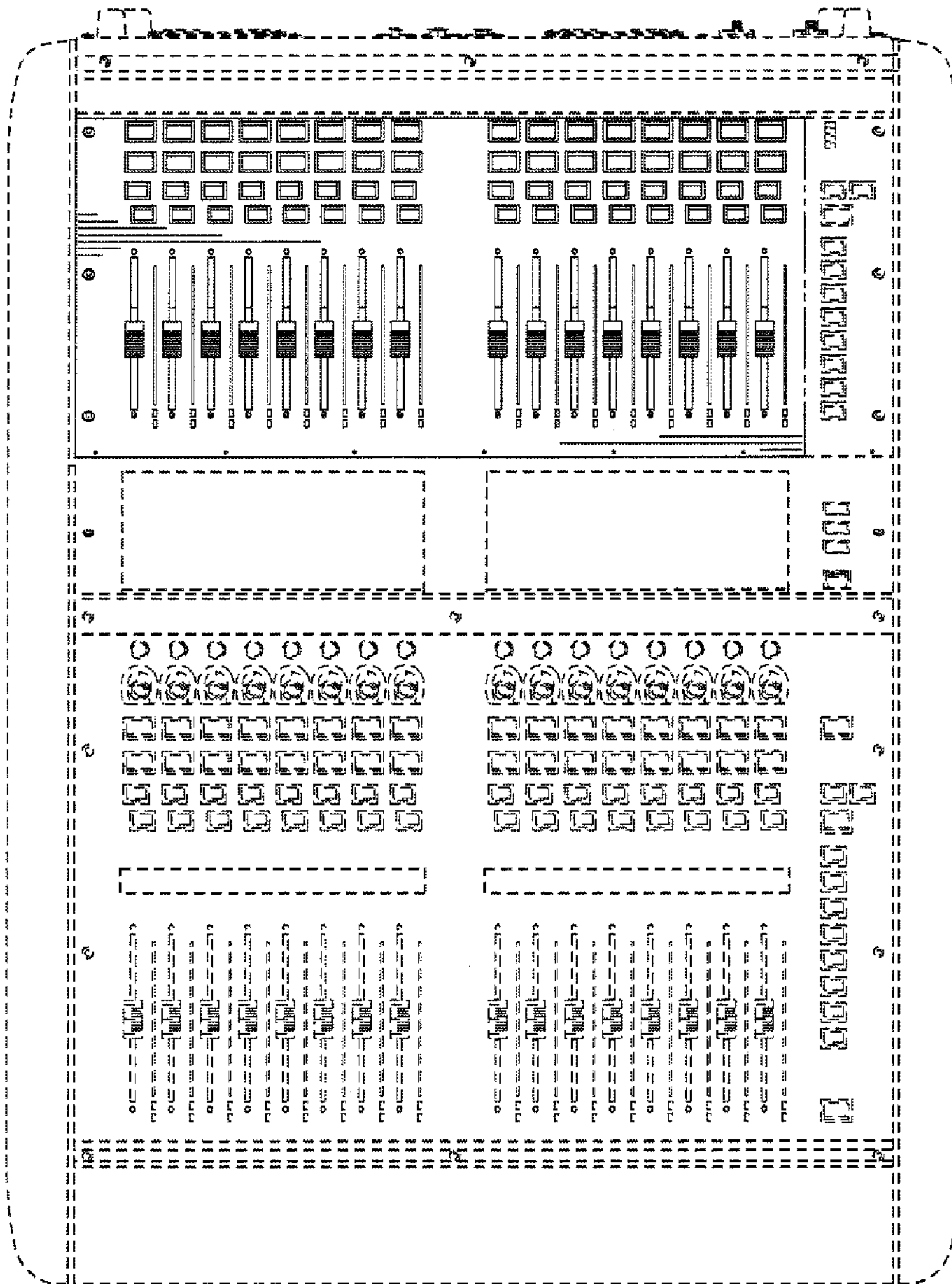

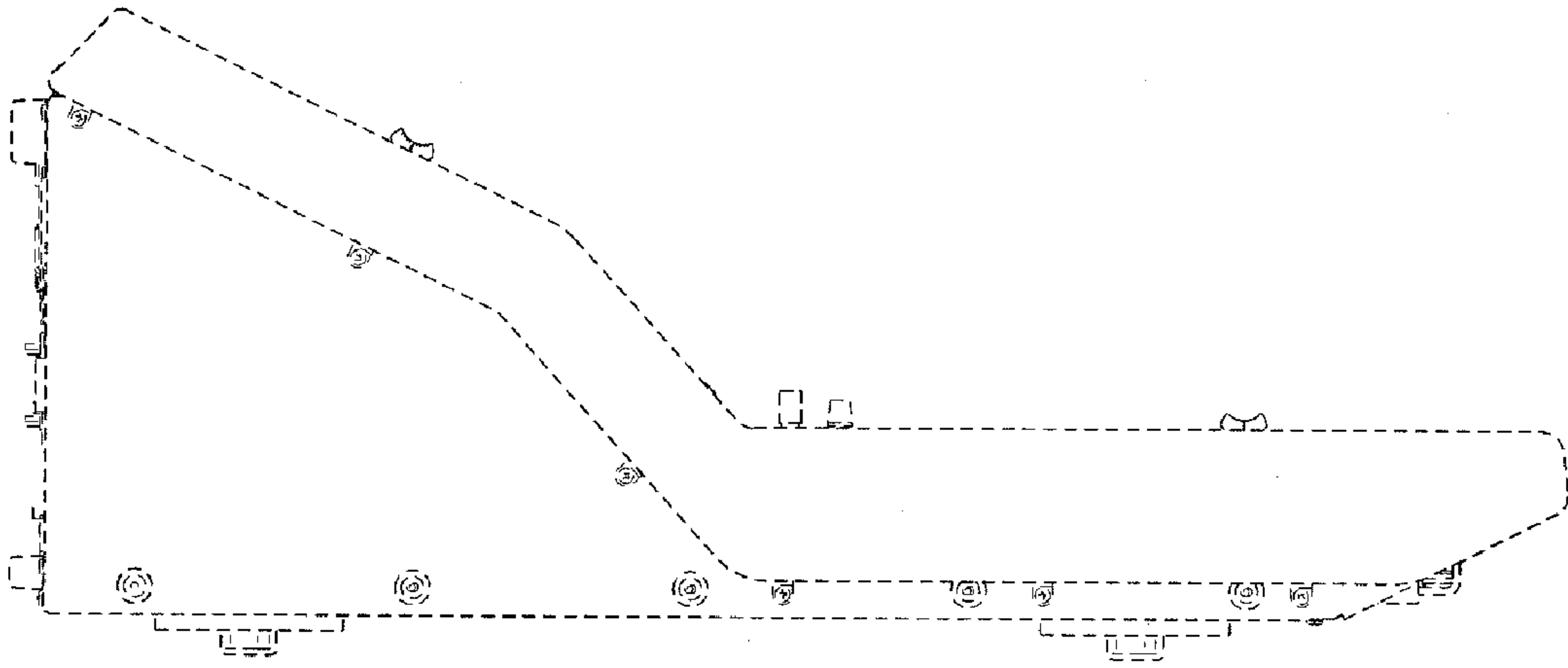

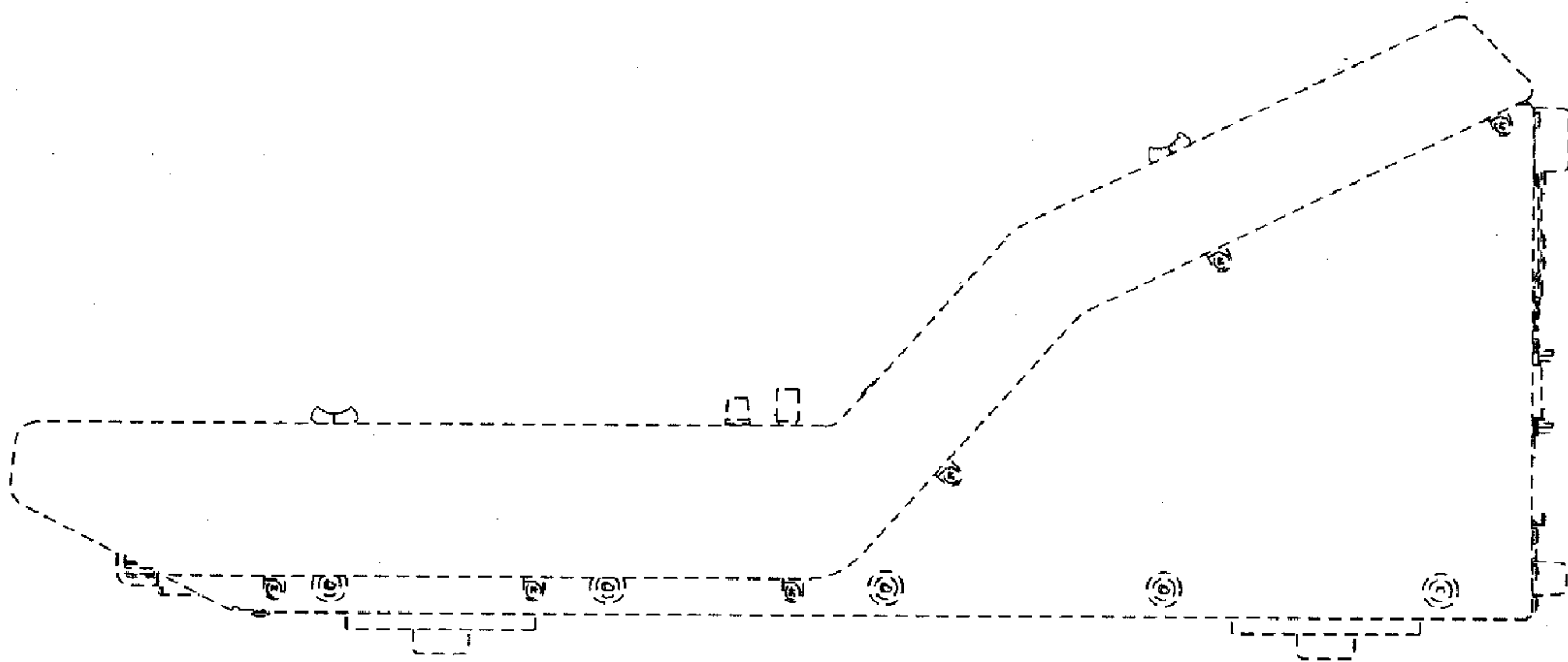

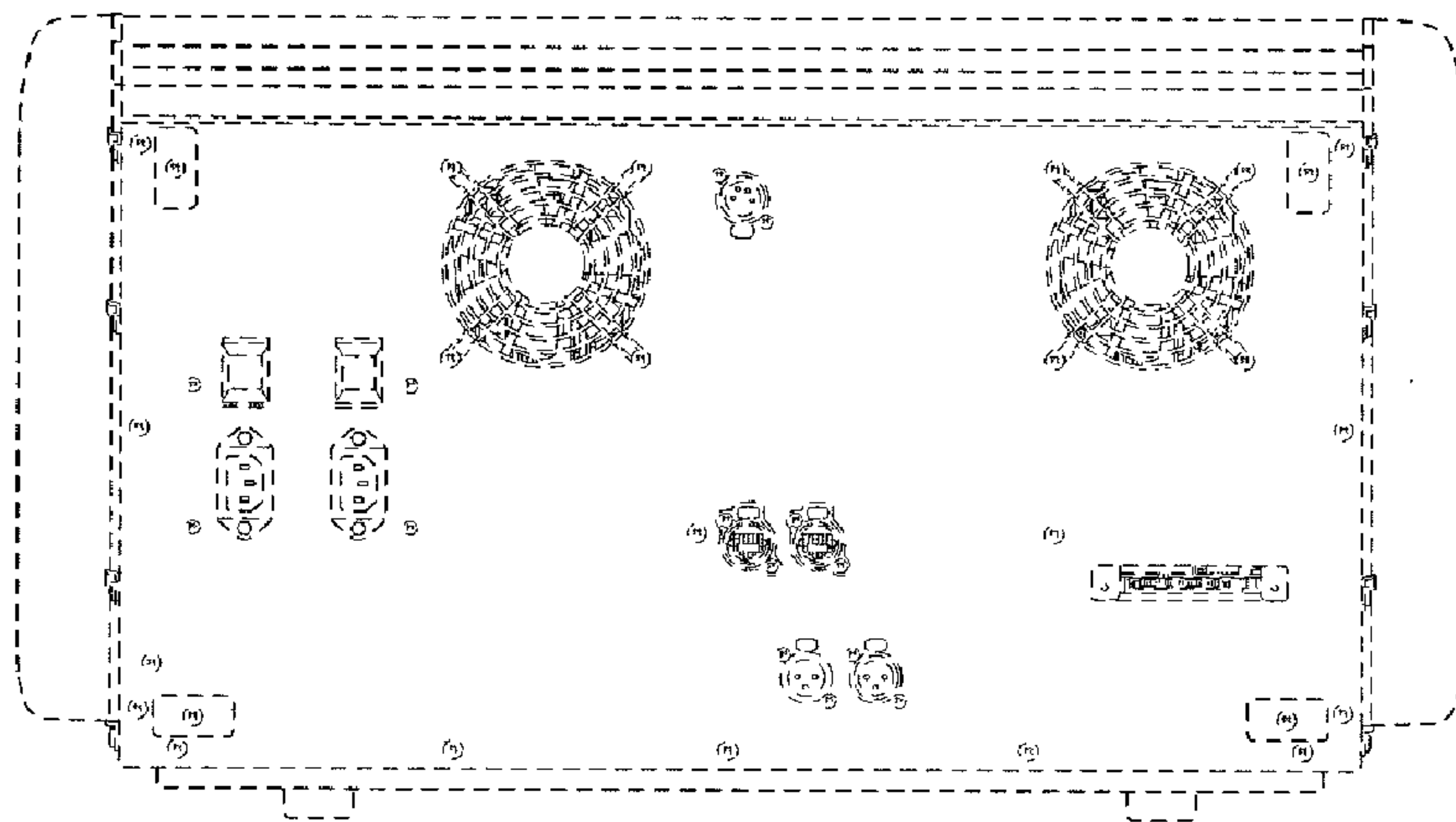

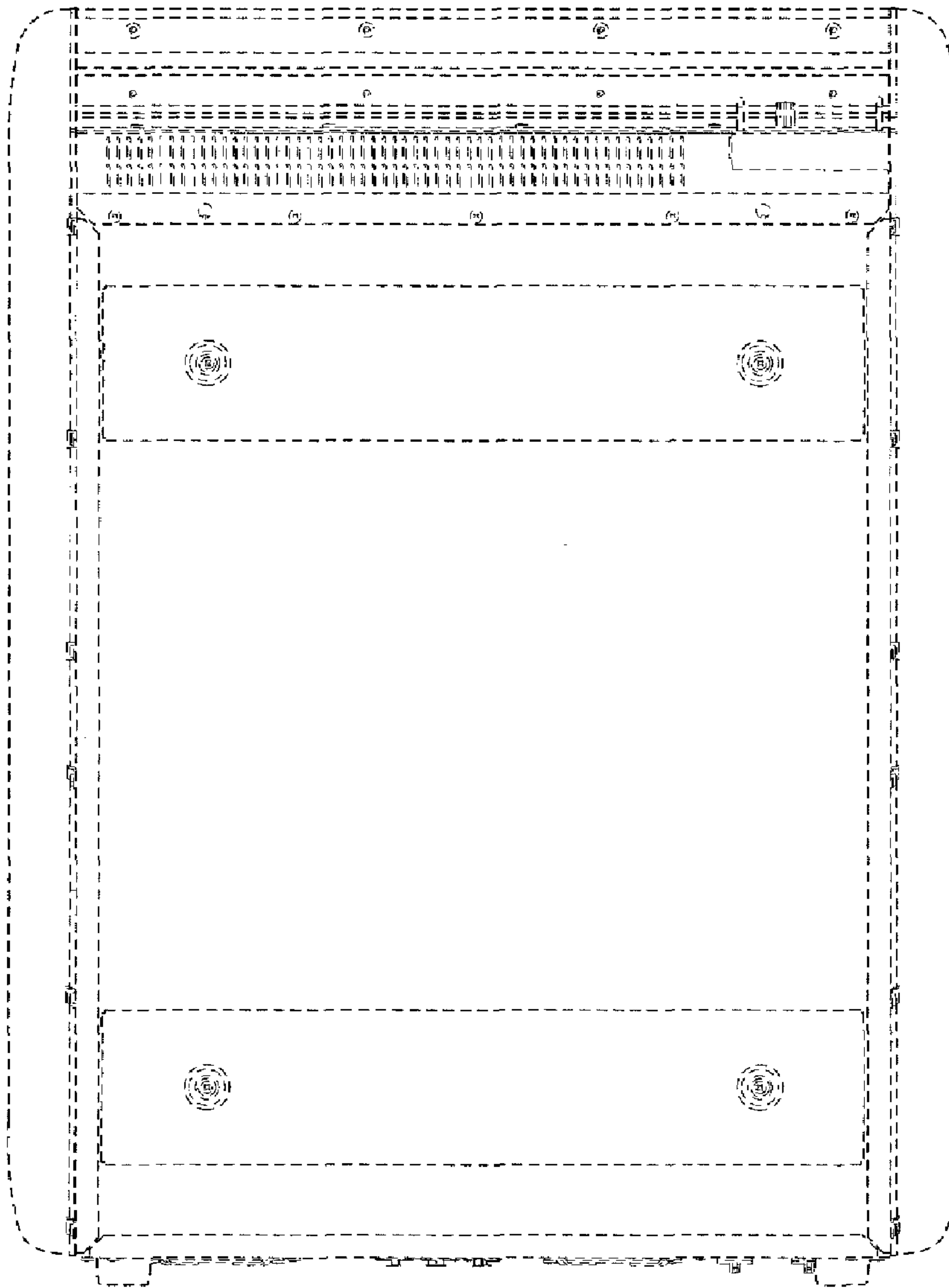
