FIG. 4 is a left side elevation view of the claimed design.

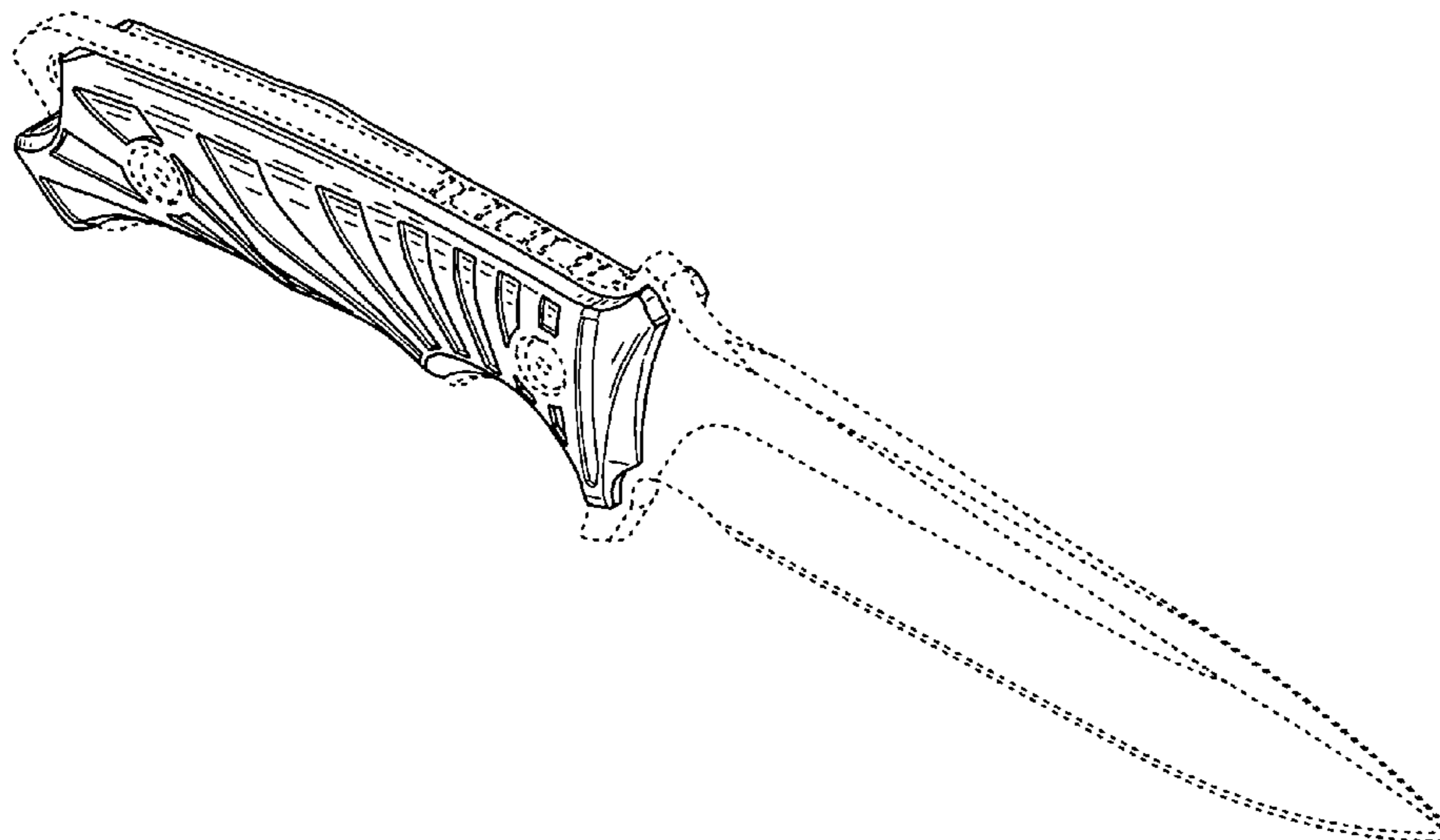
FIG. 5 is a top plan view of the claimed design.

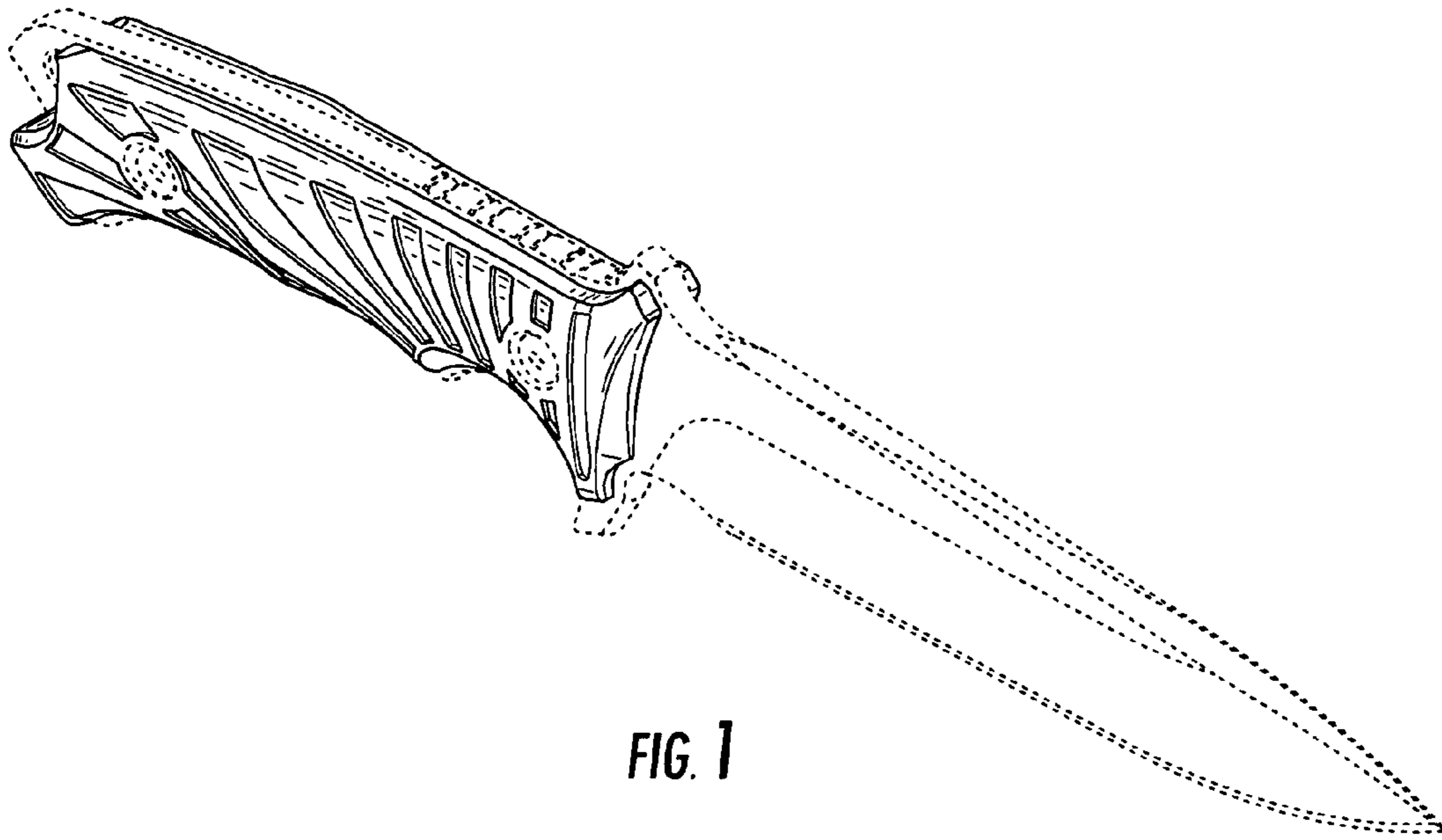

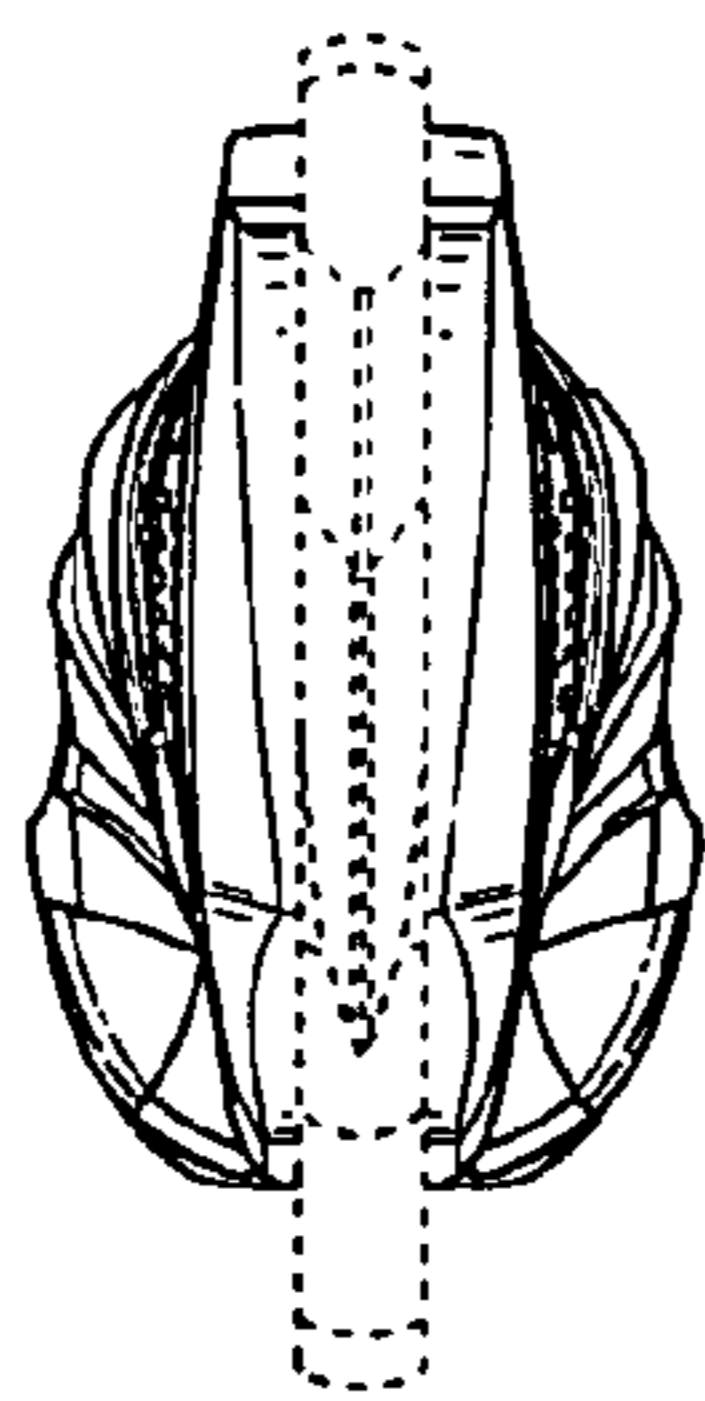

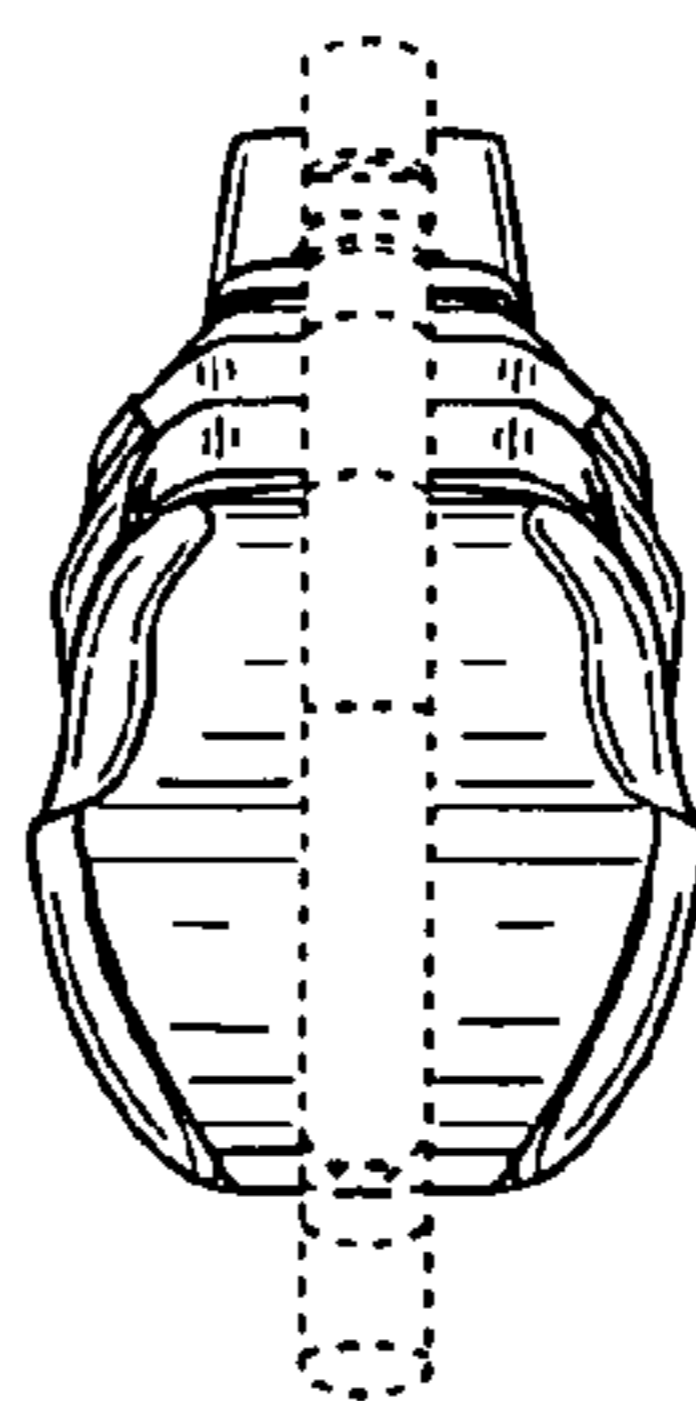

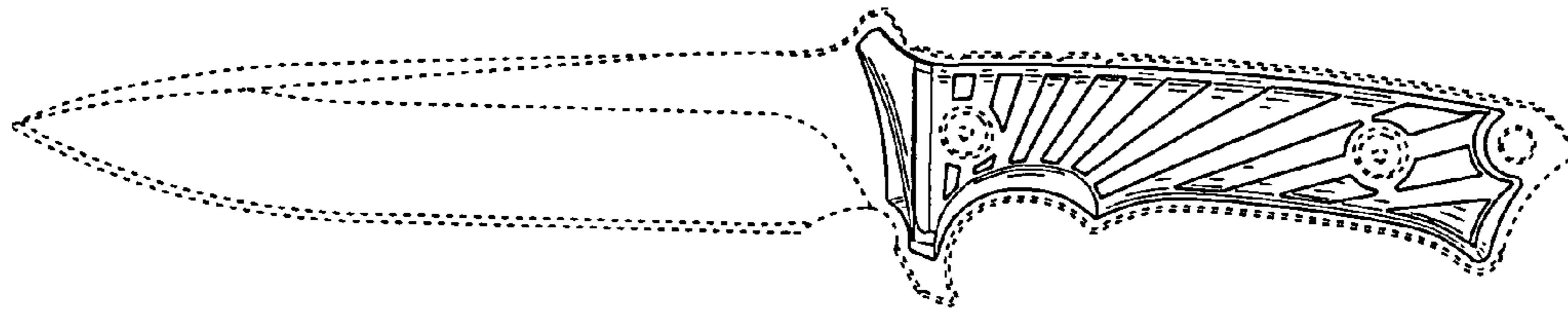

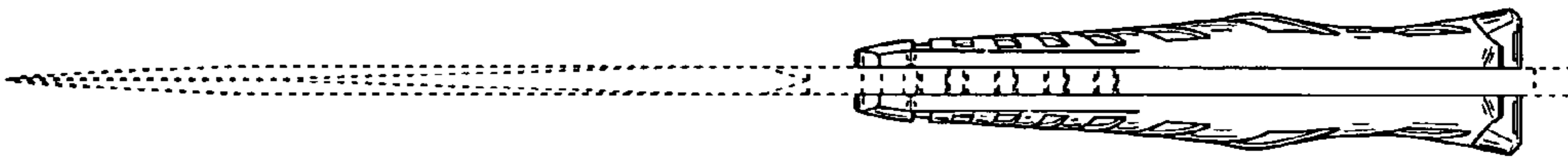

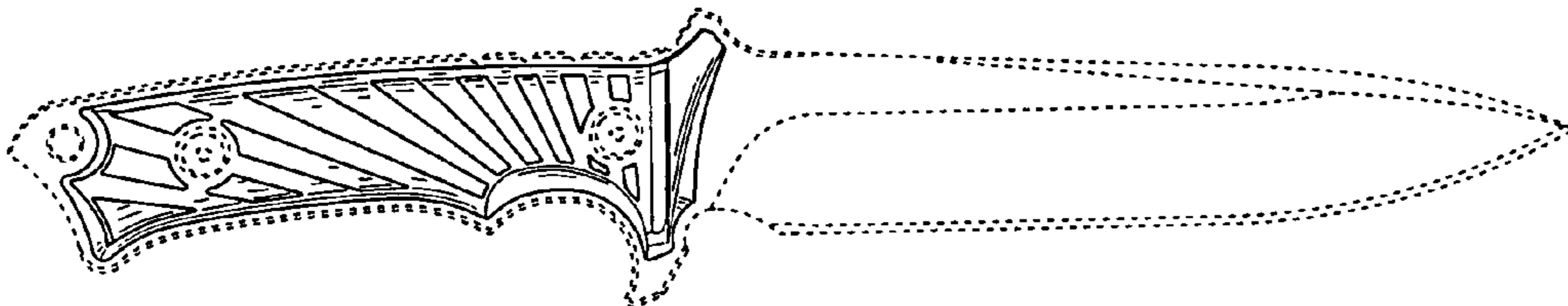

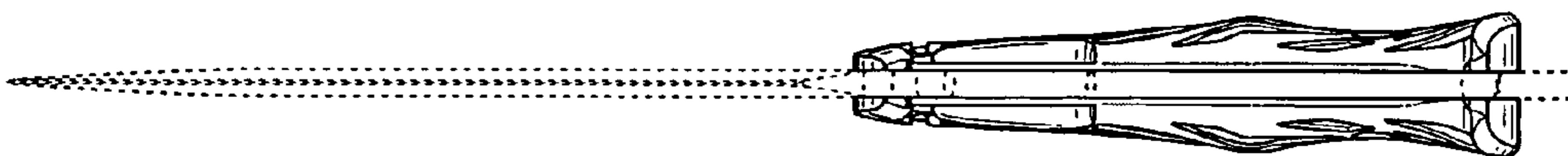
