I claim the ornamental design for a medical clamp, as shown and described.

DESCRIPTION

FIG. 1 is an left isometric view of a medical clamp showing my new design;

FIG. 7 is a right side elevation view thereof;

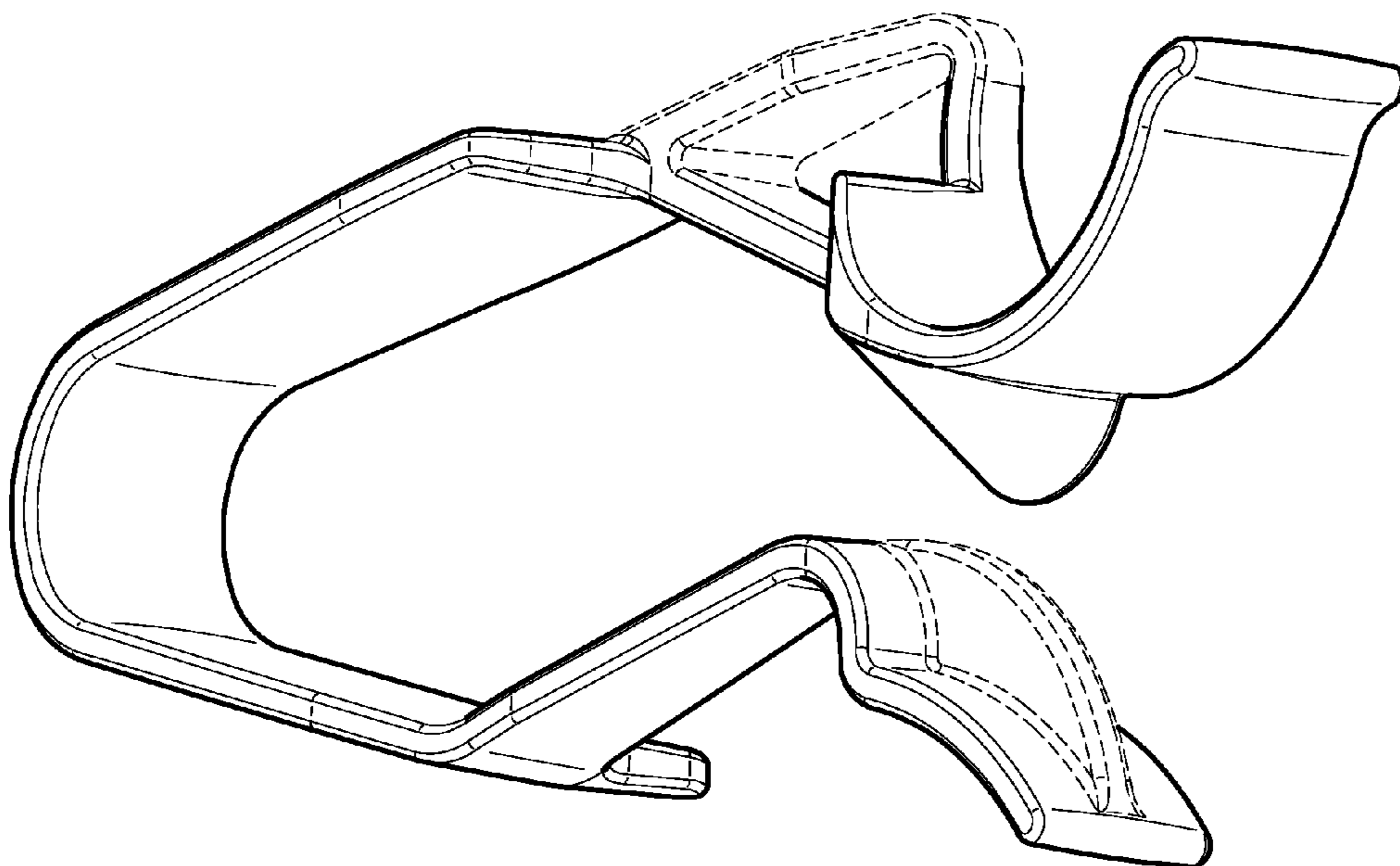
FIG. 8 is a left side elevation view thereof;

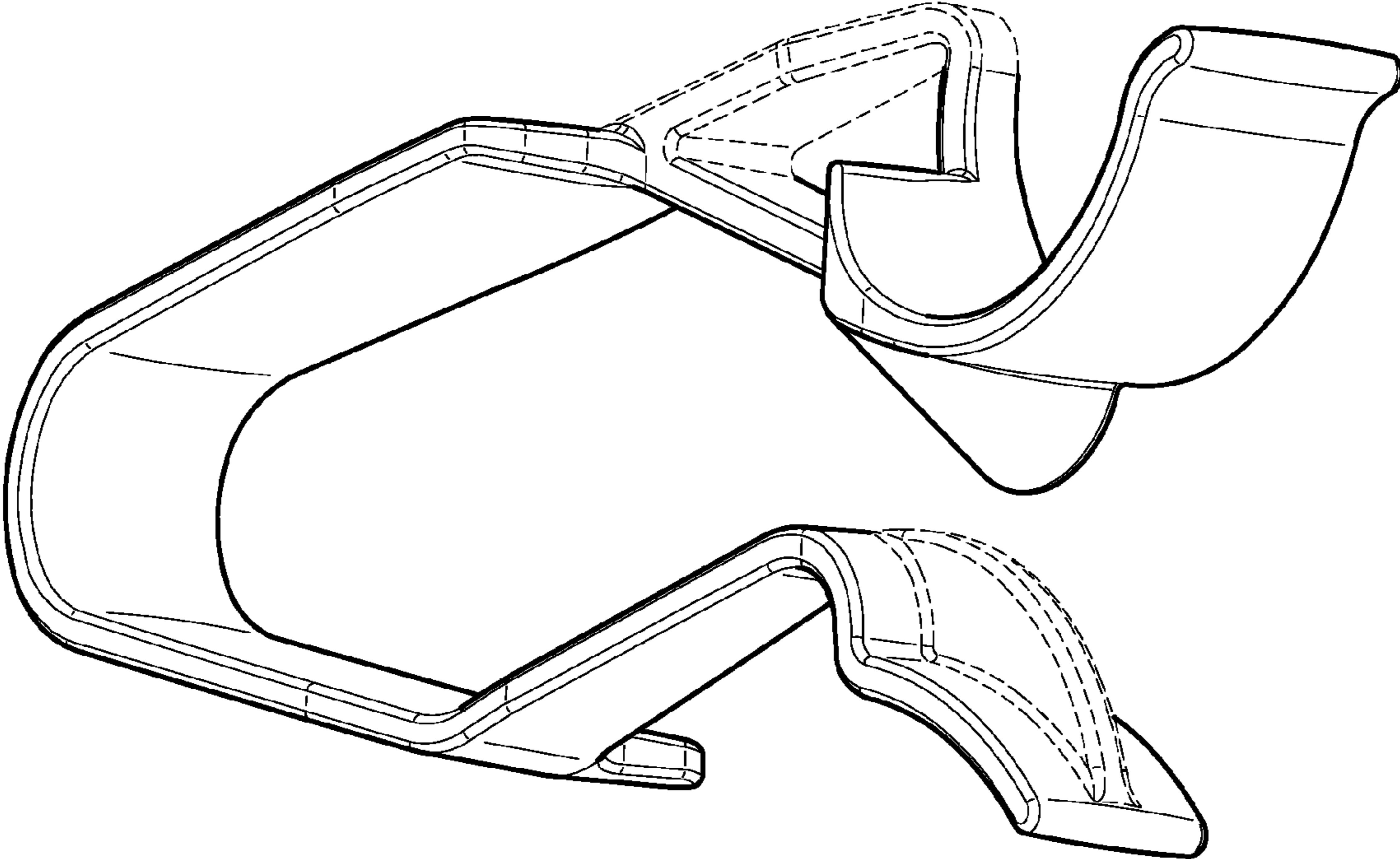

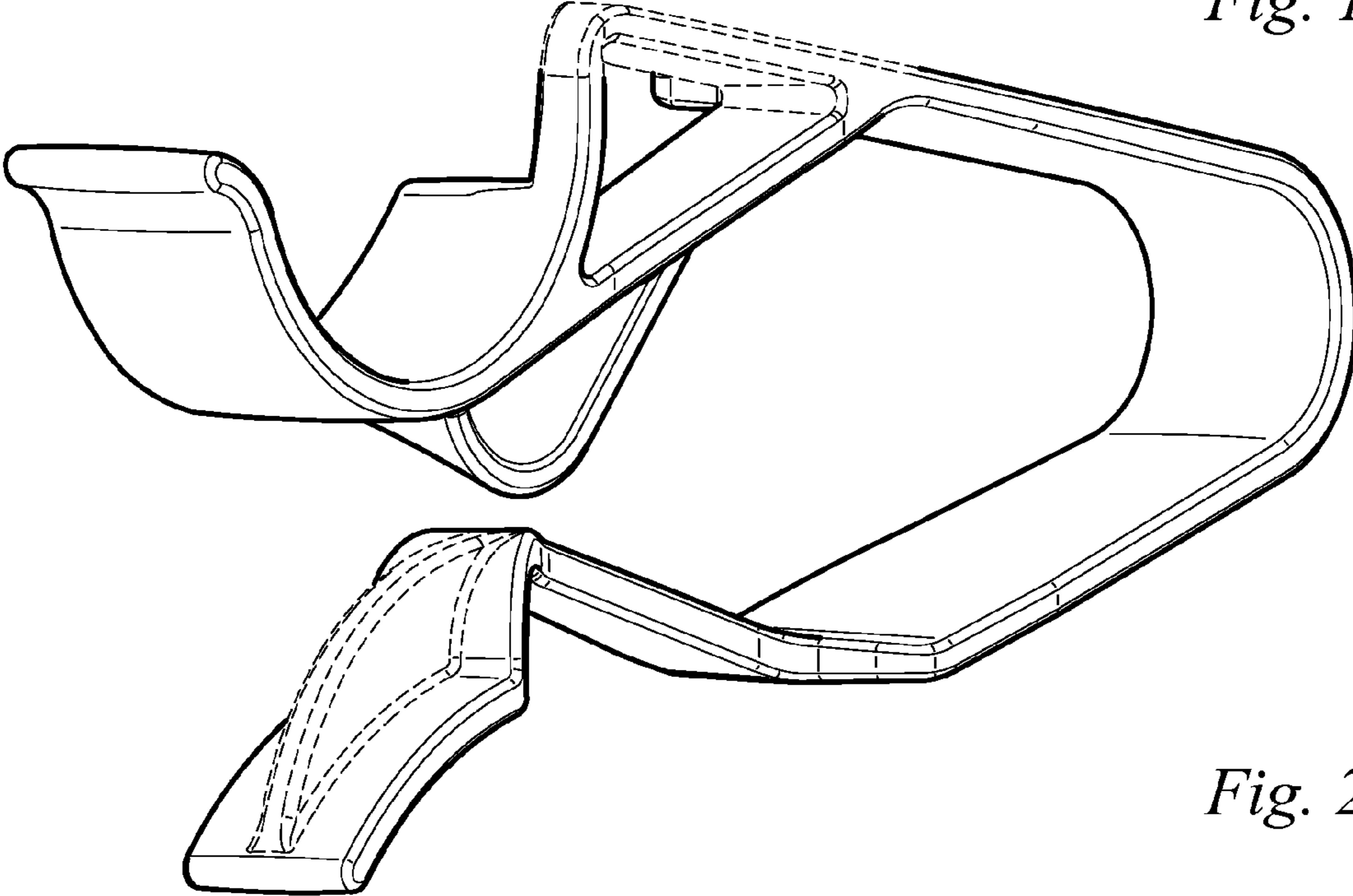

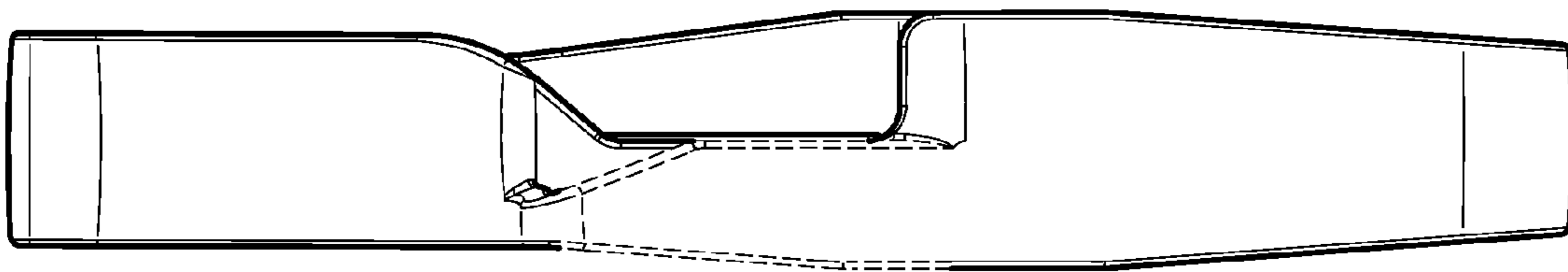

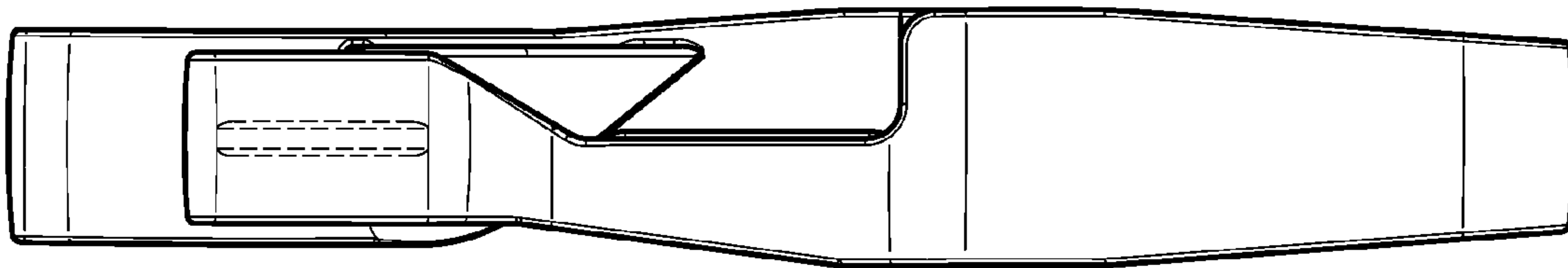

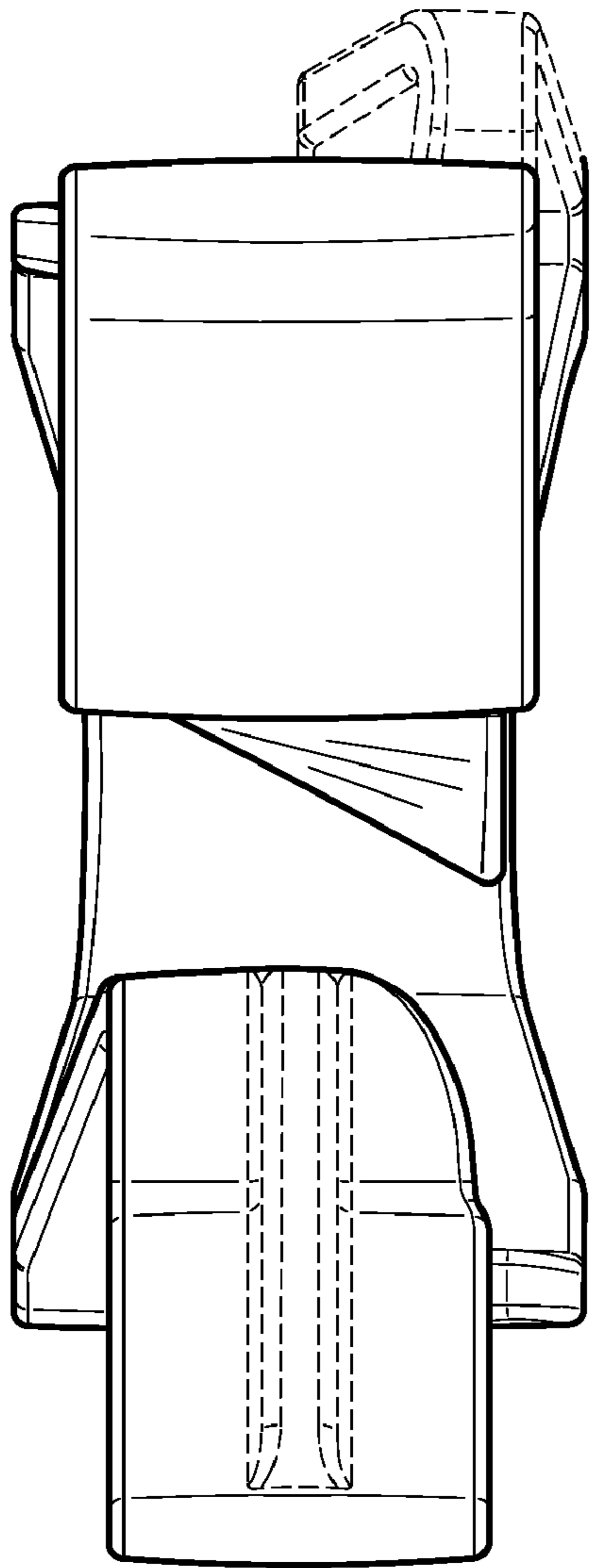

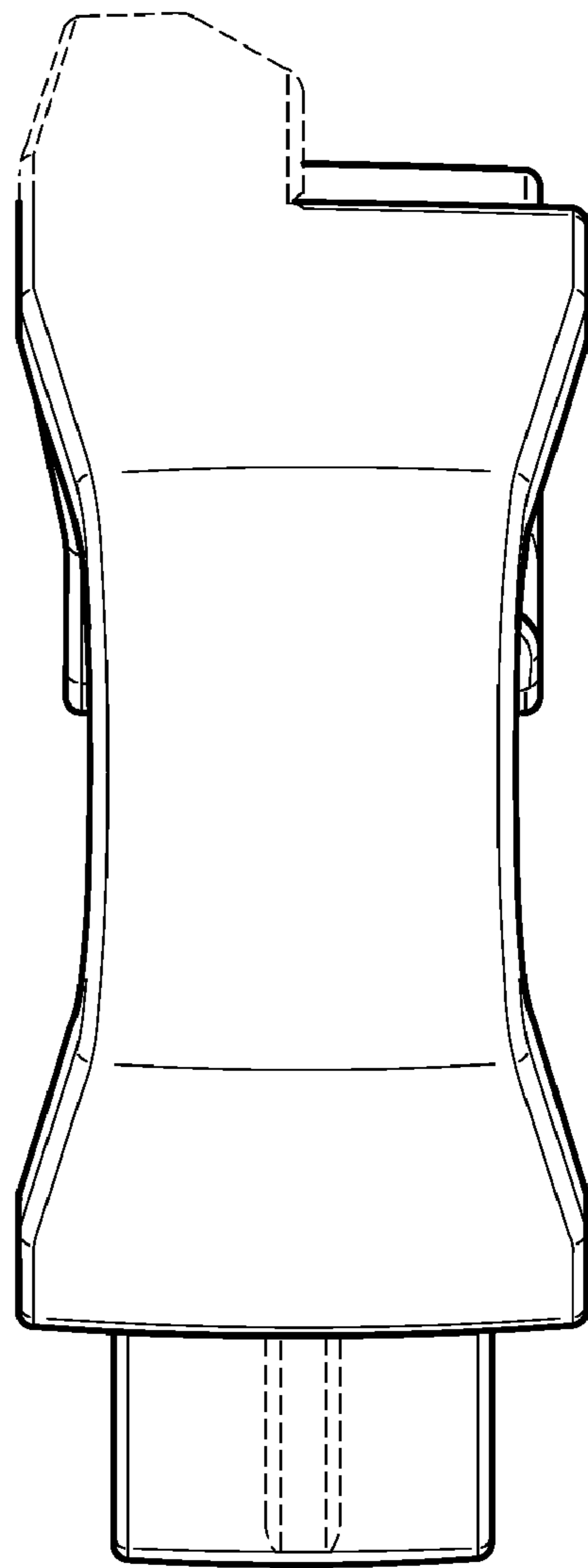

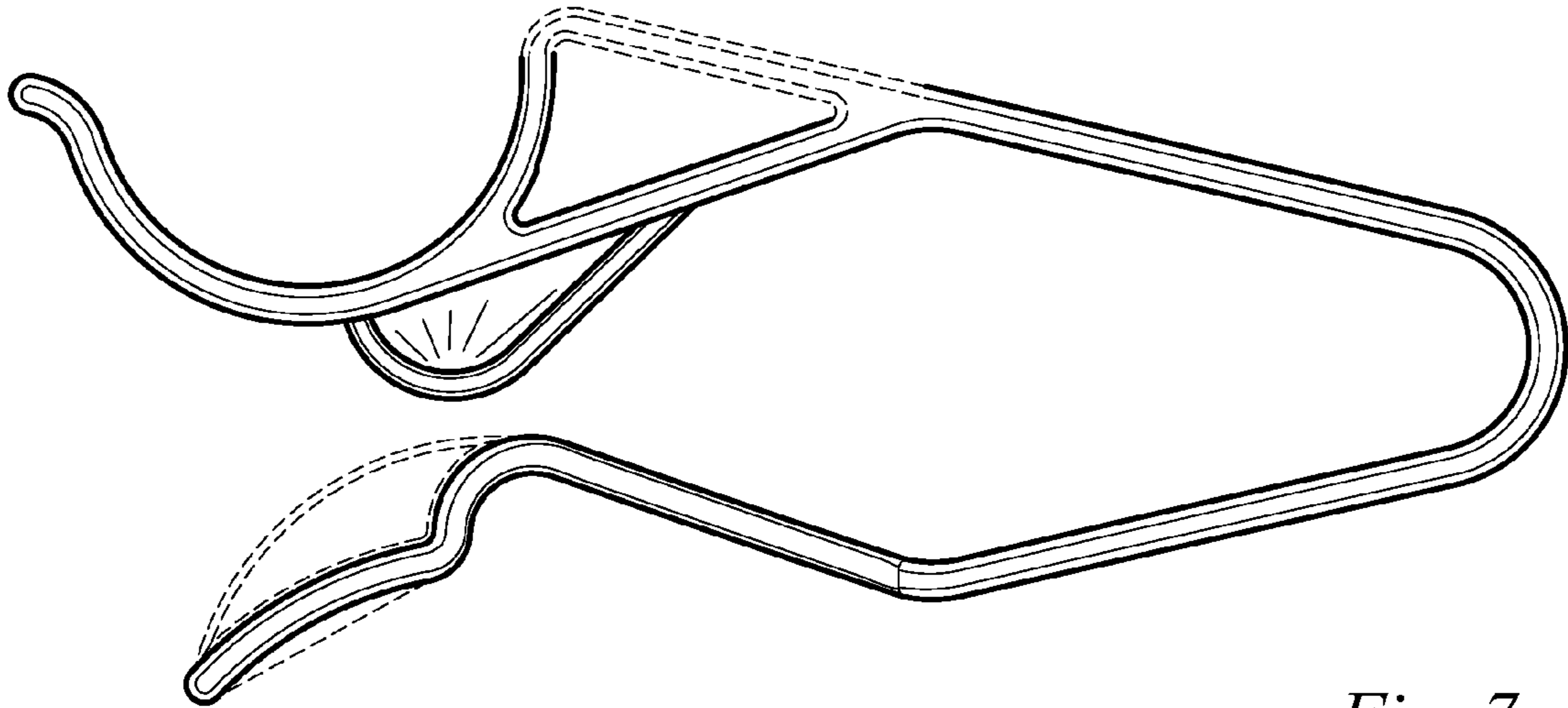

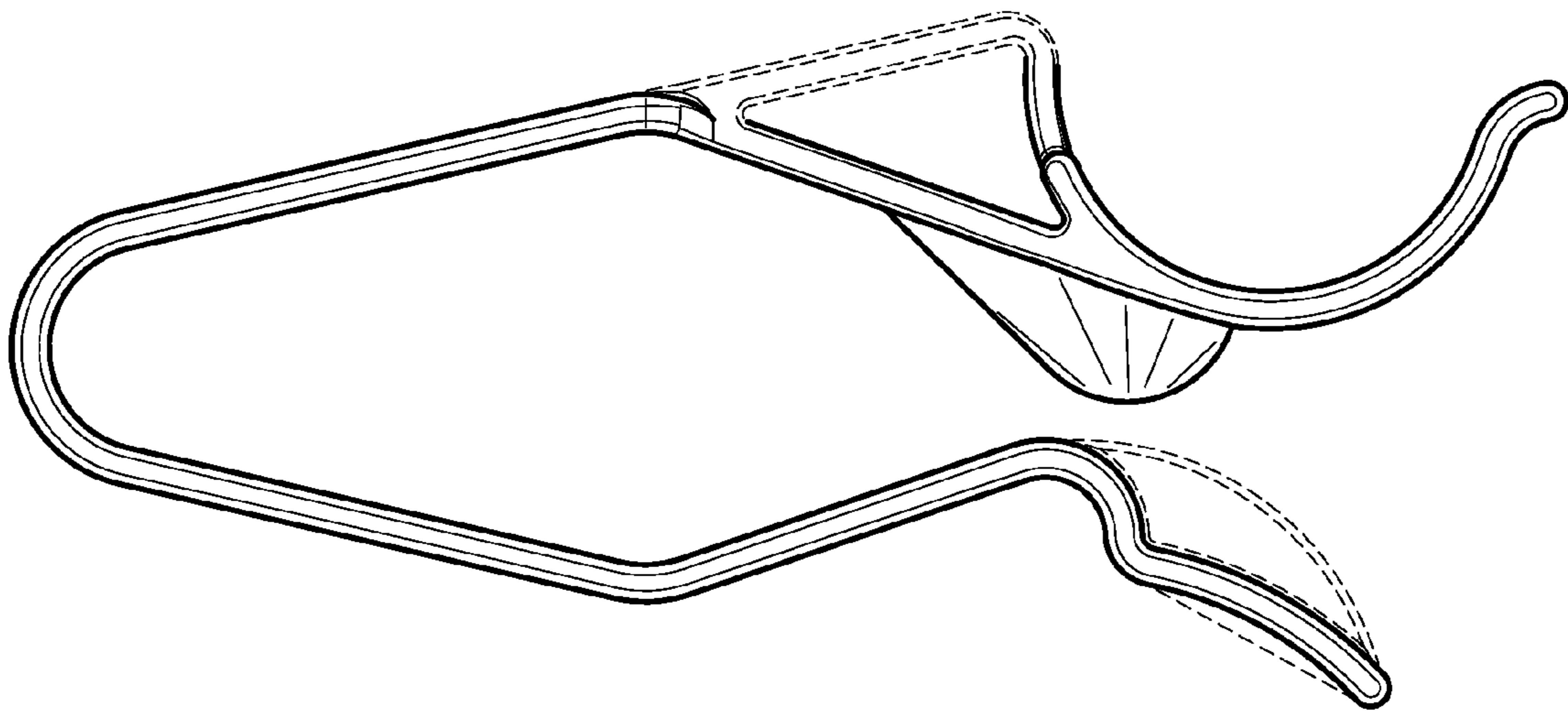

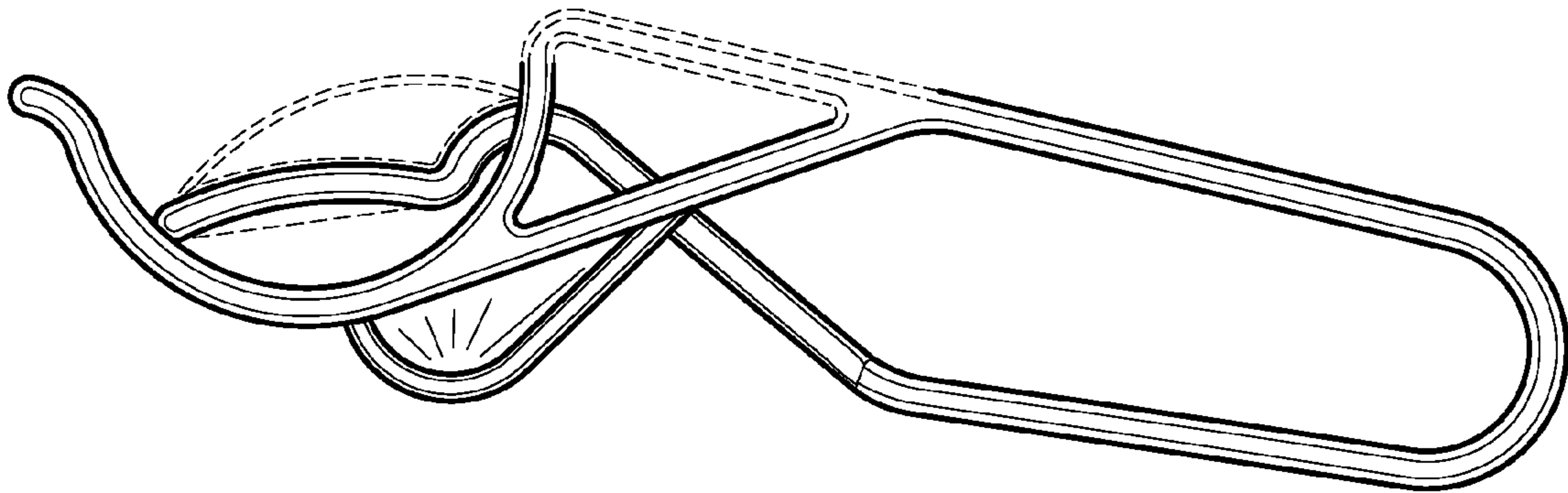

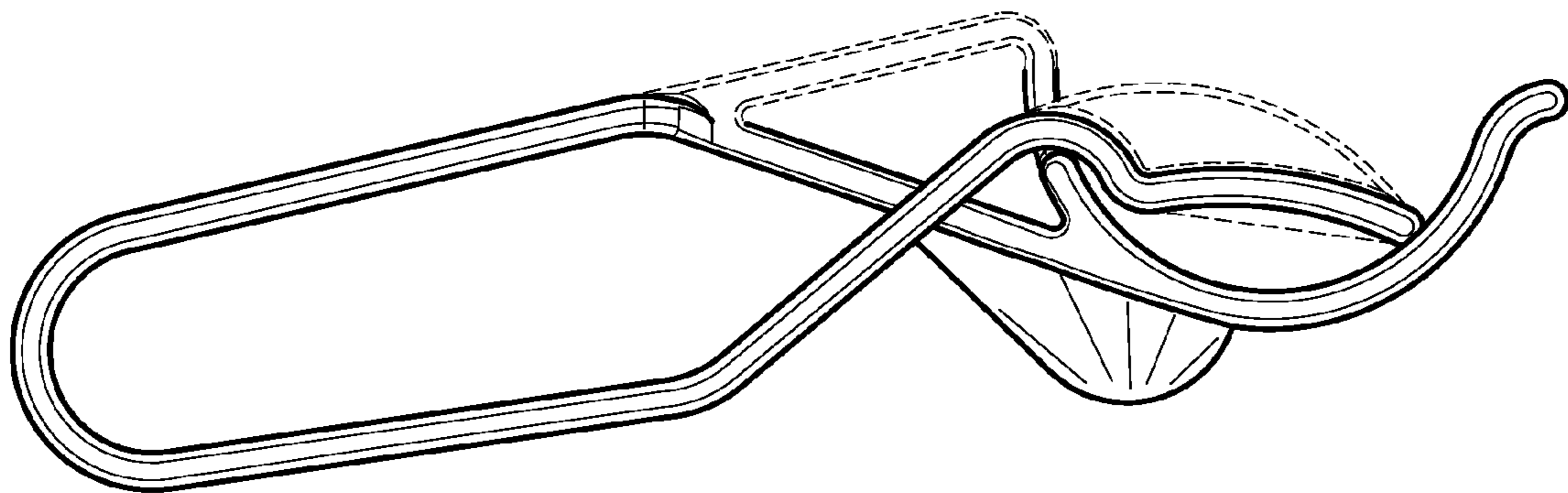
