FIG. 4 is a right side view of a flashlight in accordance with the present design;

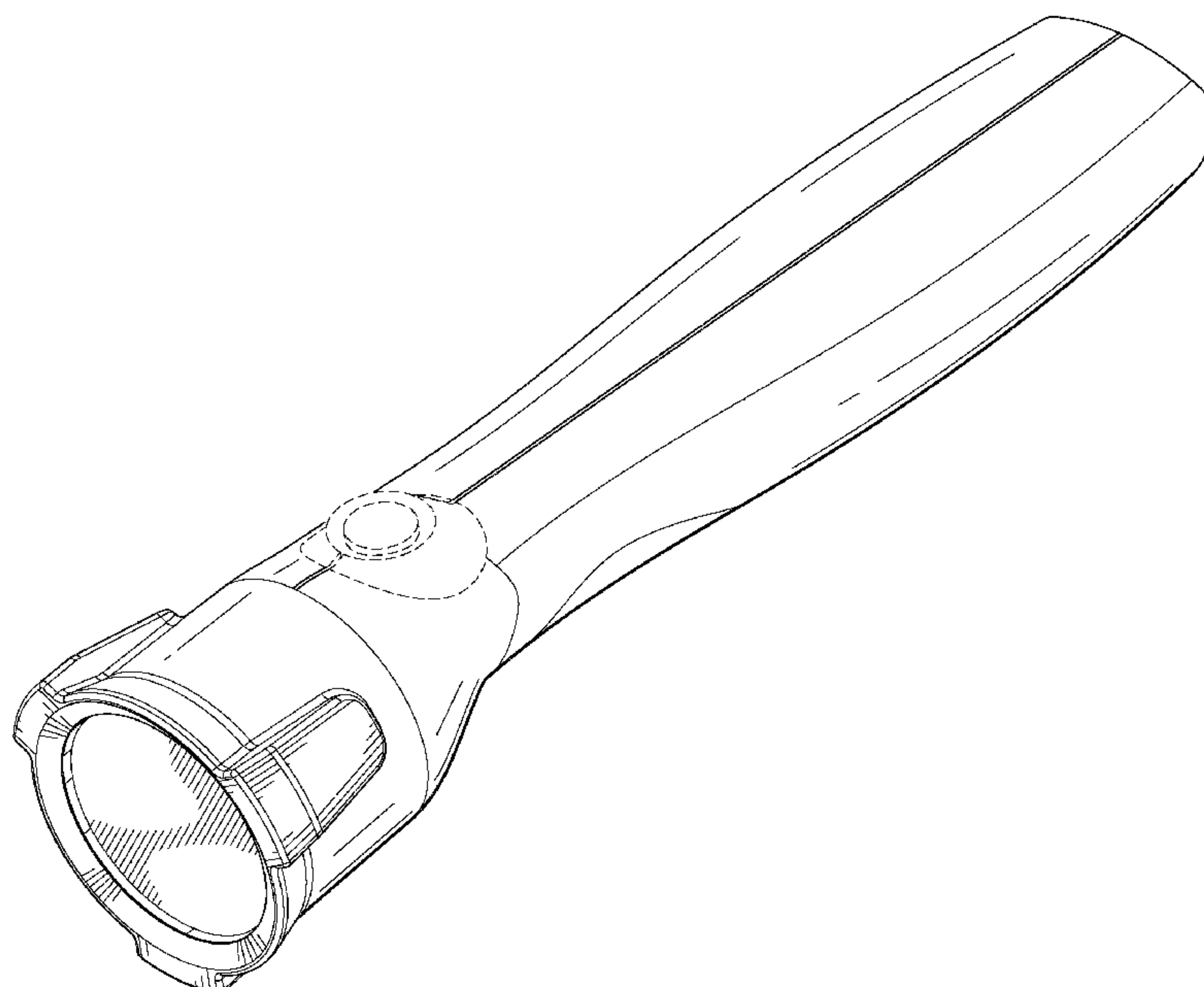
FIG. 5 is a left side view of a flashlight in accordance with the present design;

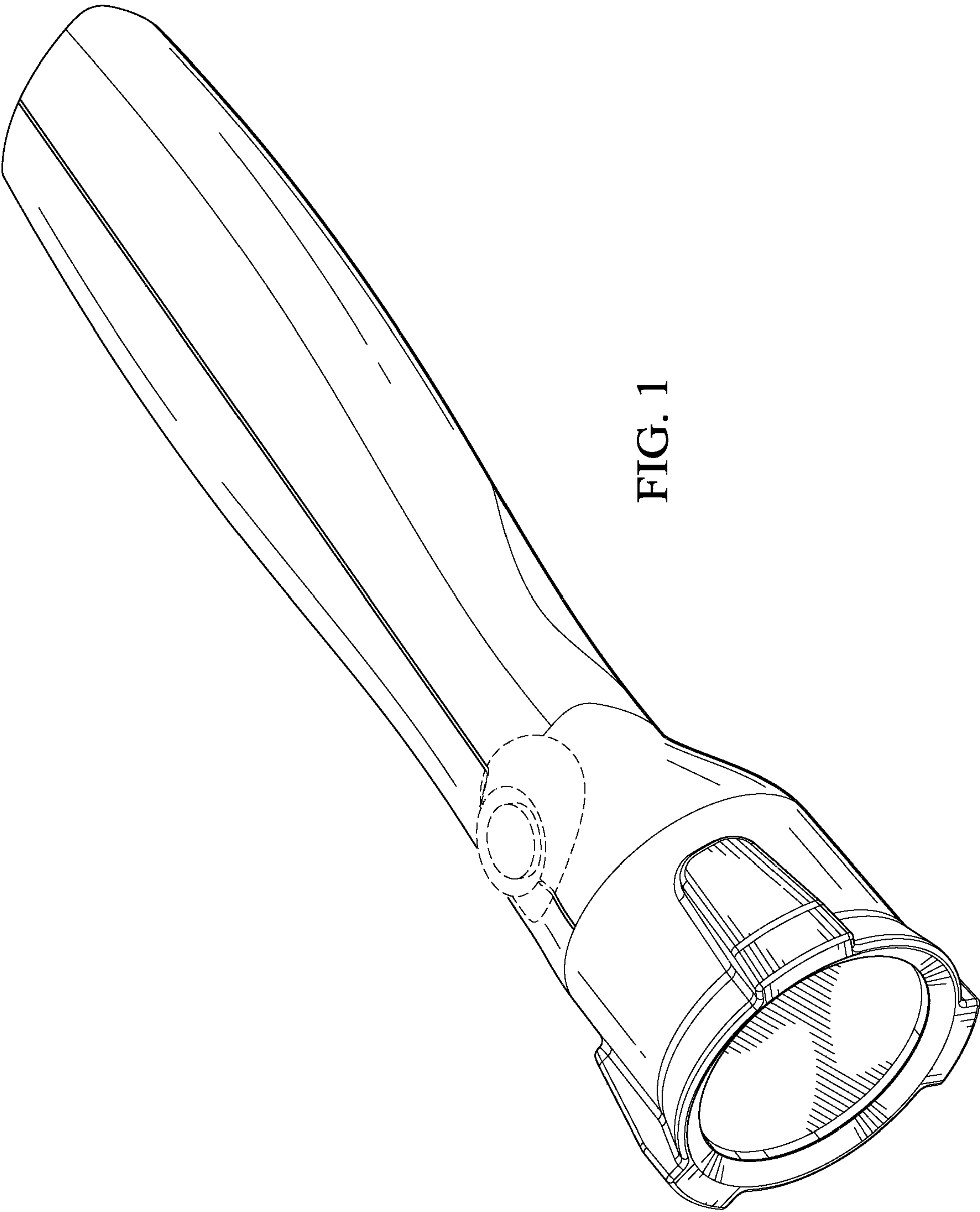

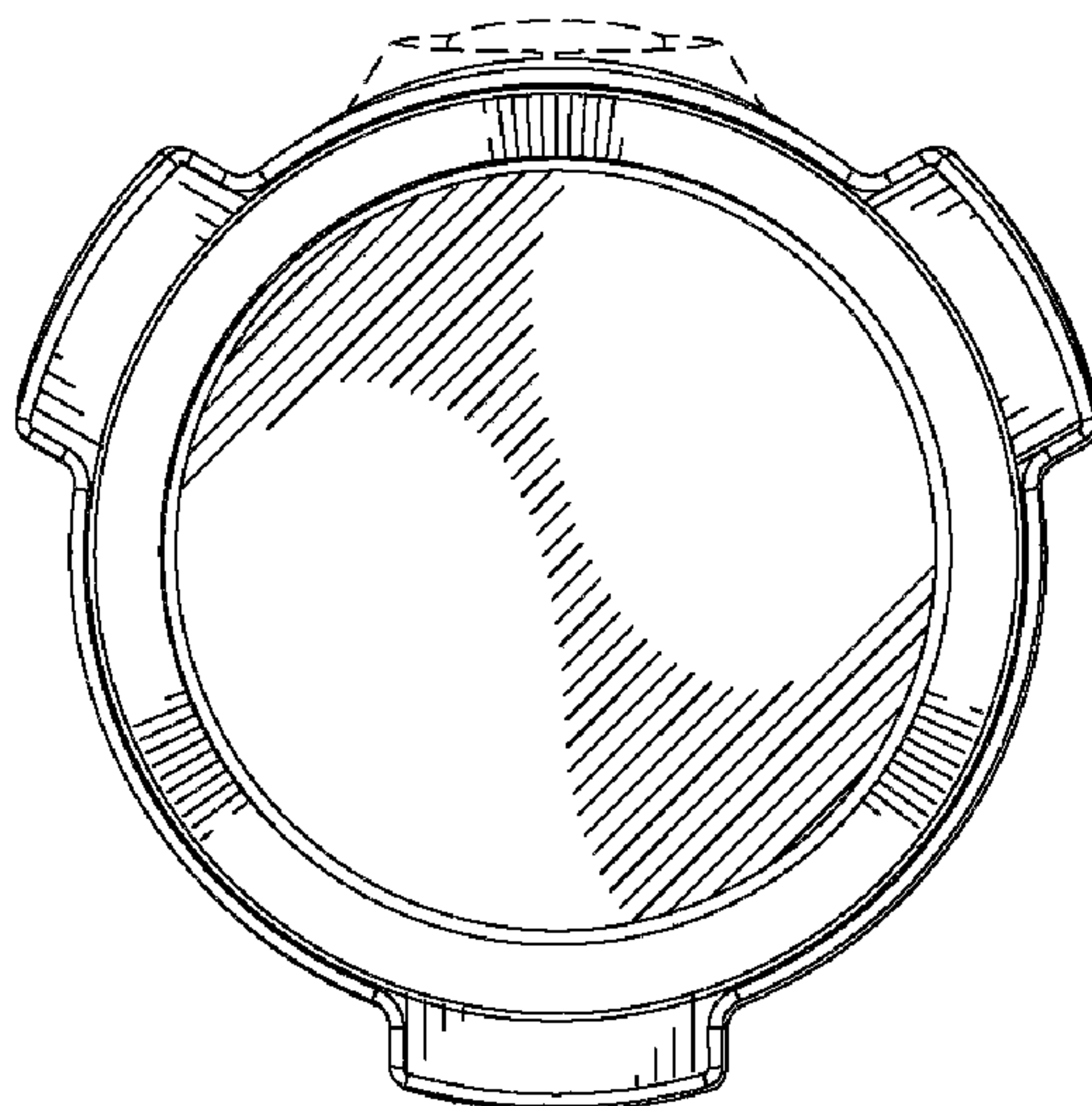

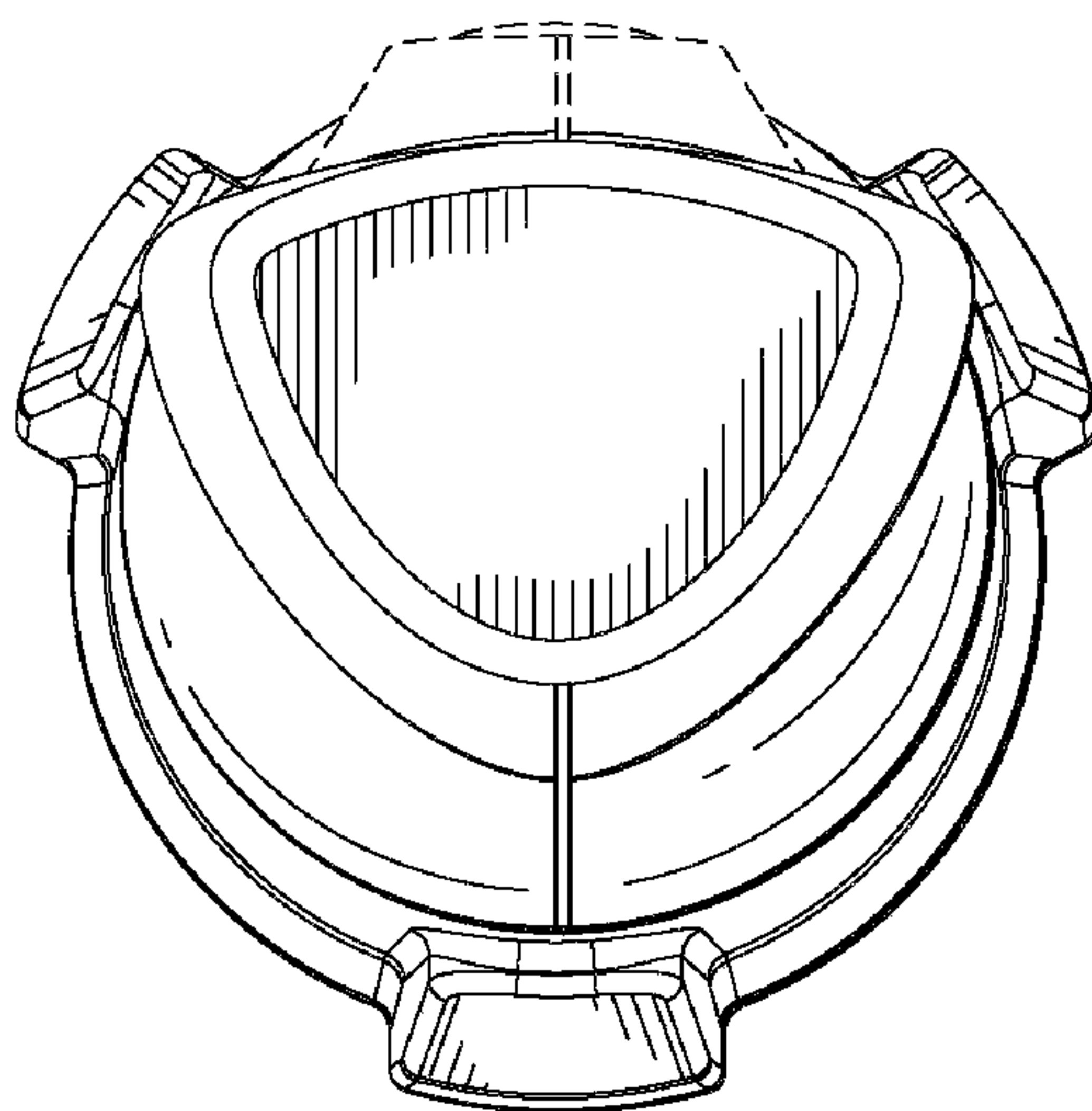

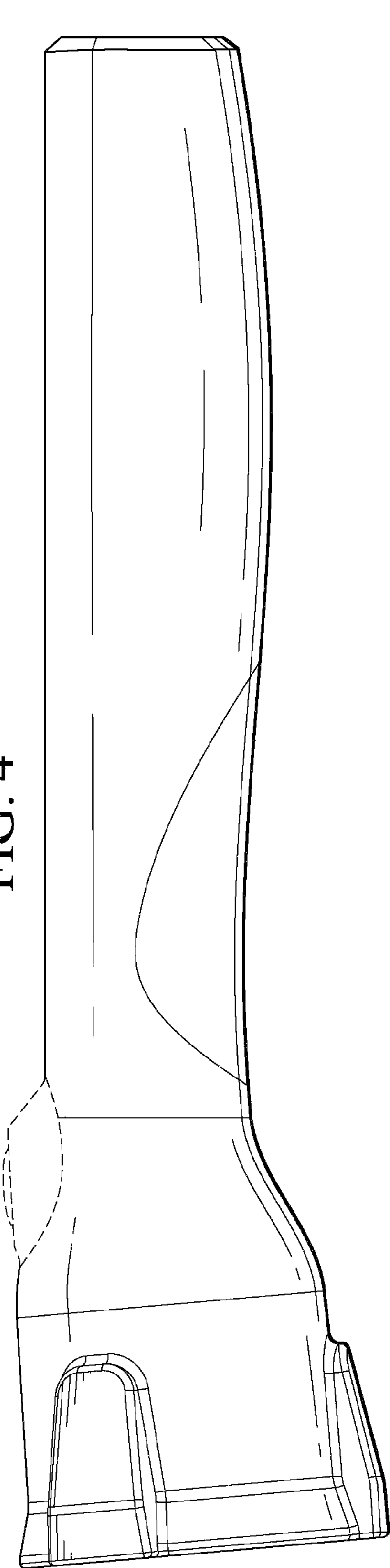

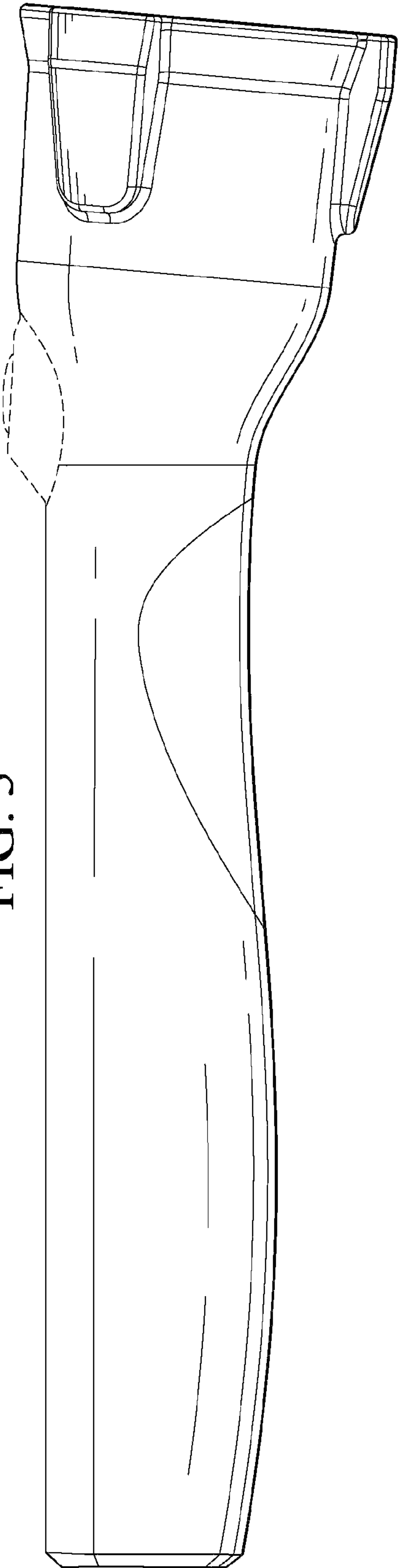

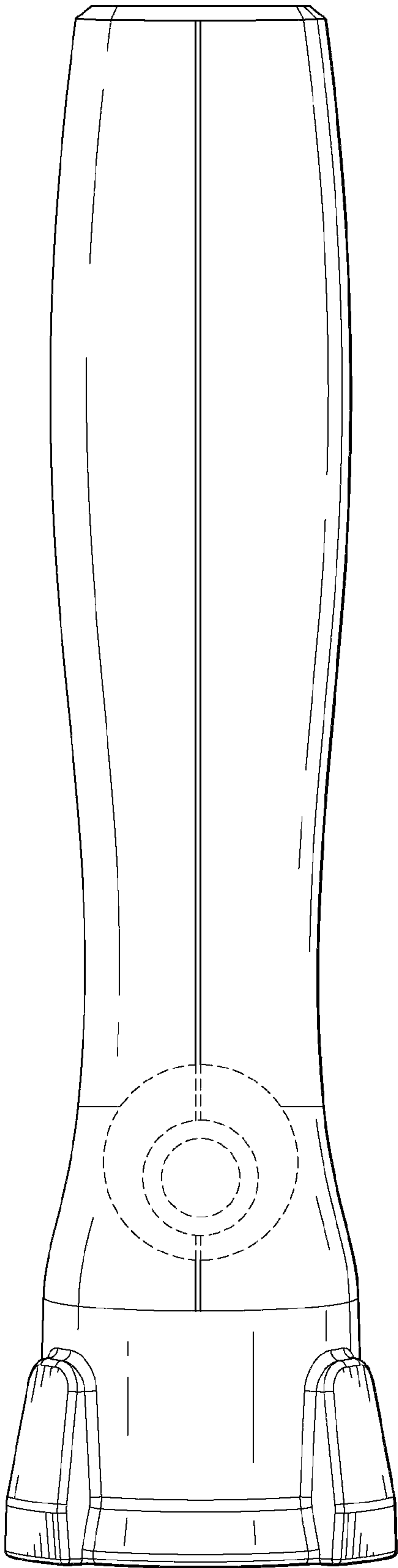
