DESCRIPTION

FIG. 1 is a top, front, right side perspective view of the water fountain light;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

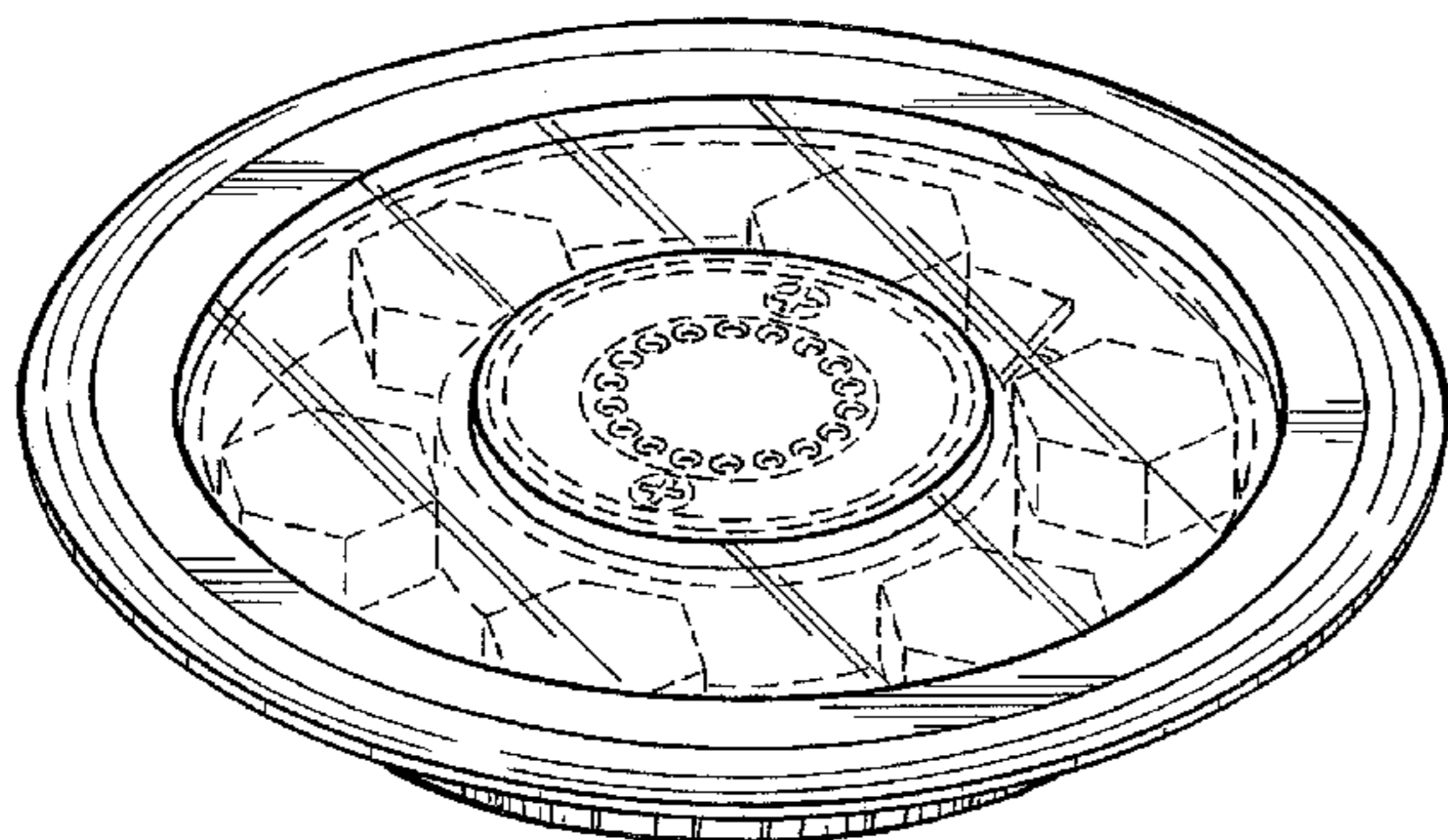
FIG. 4 is a front elevational view thereof;

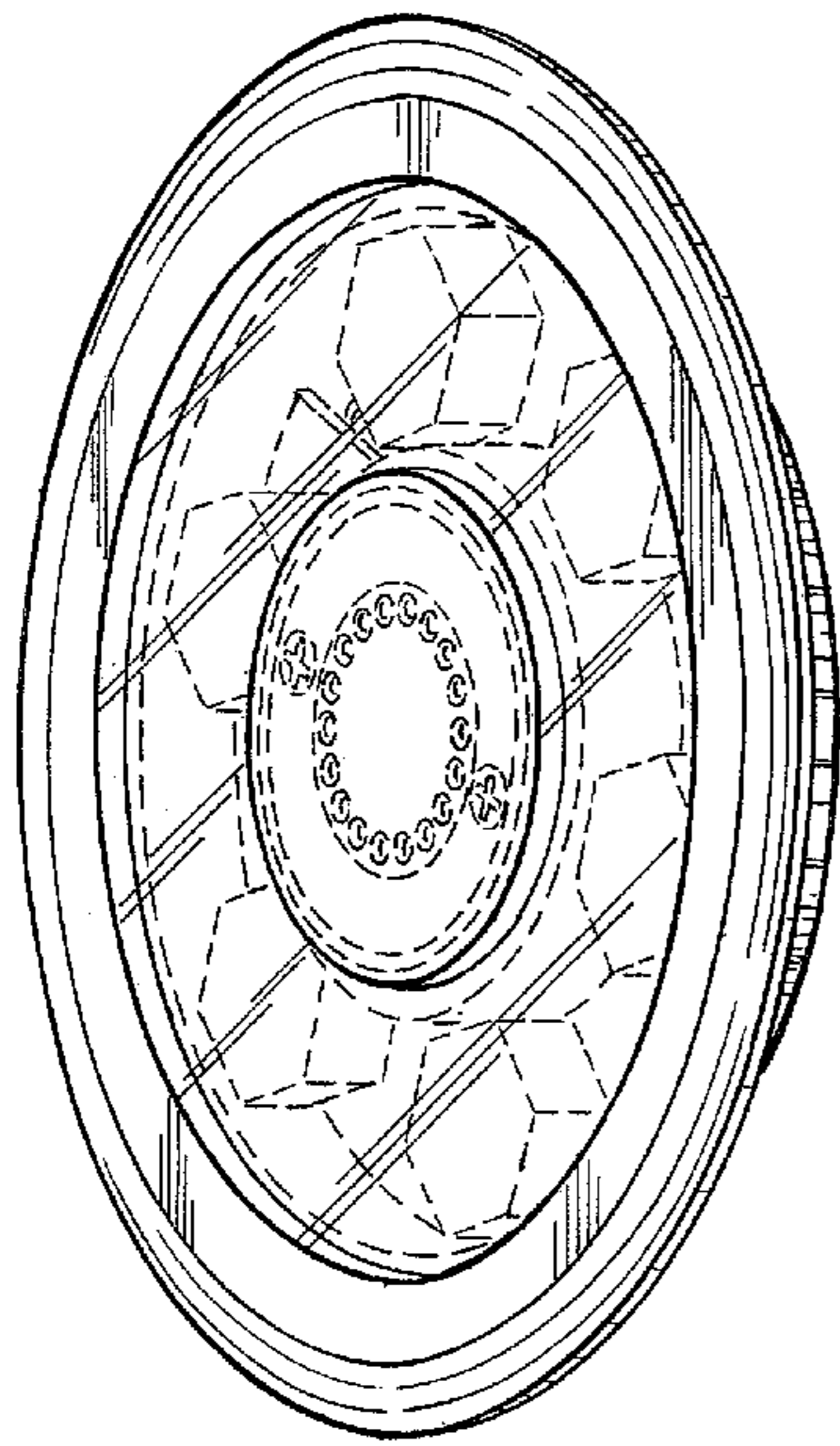

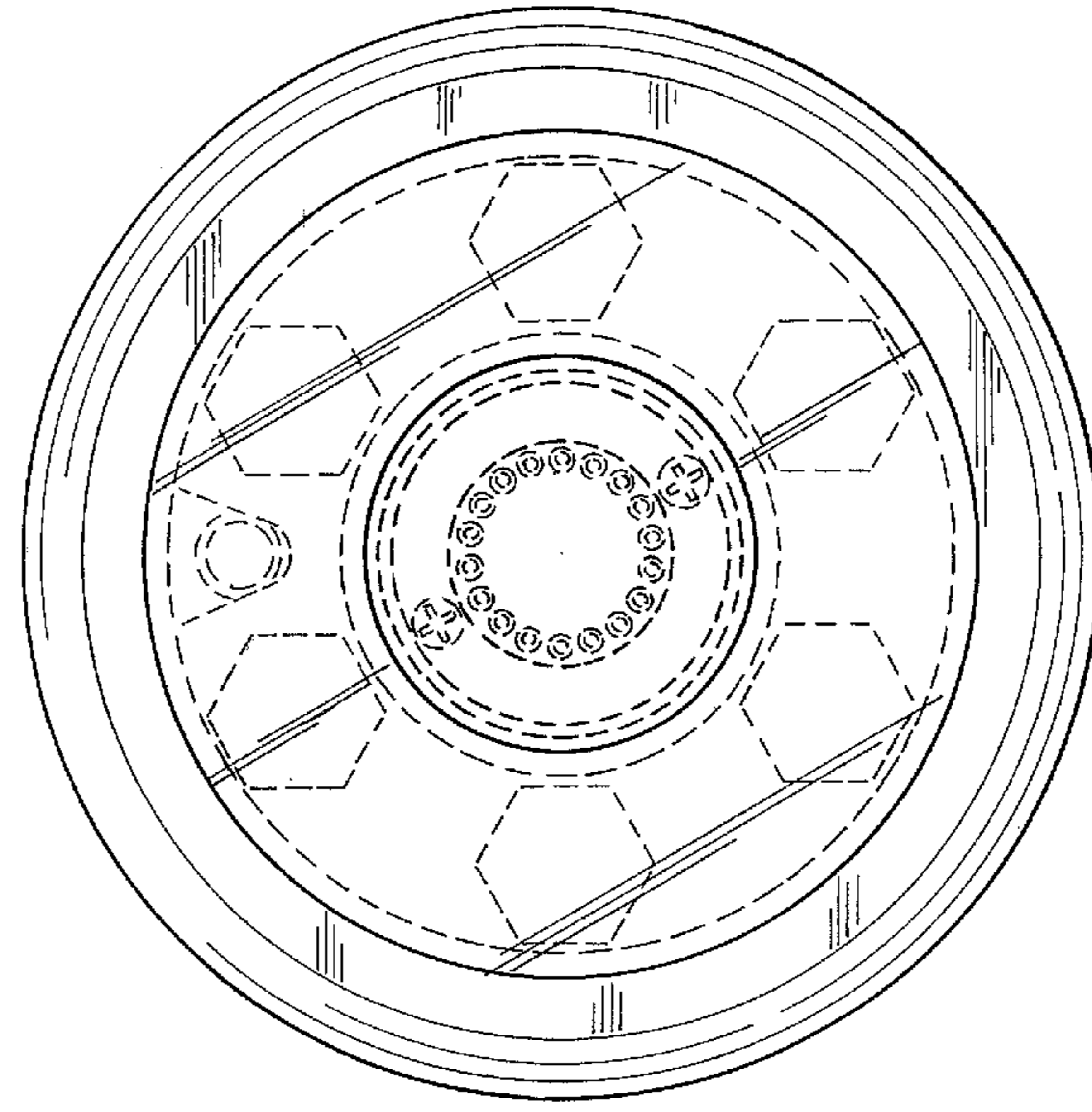

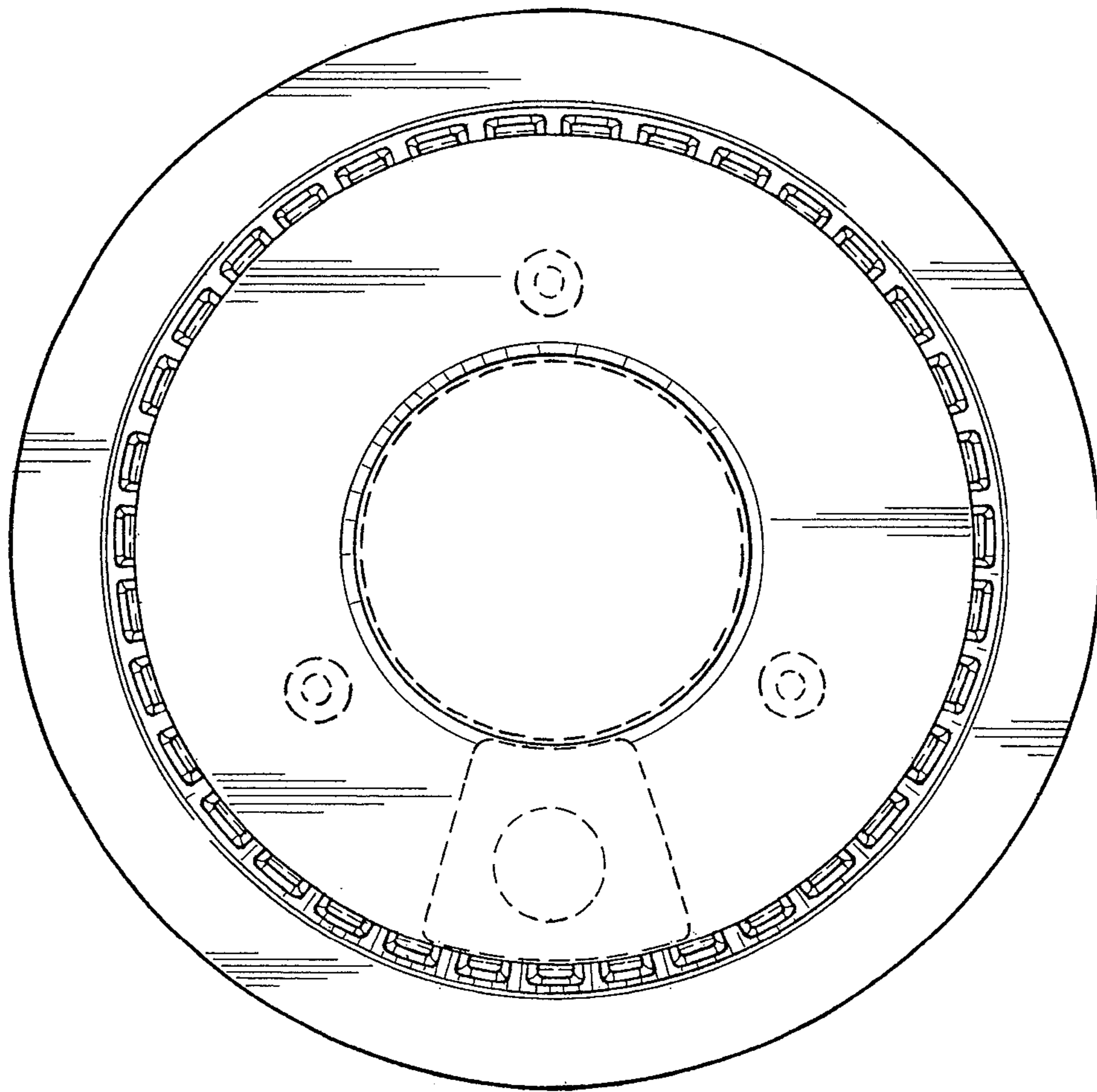

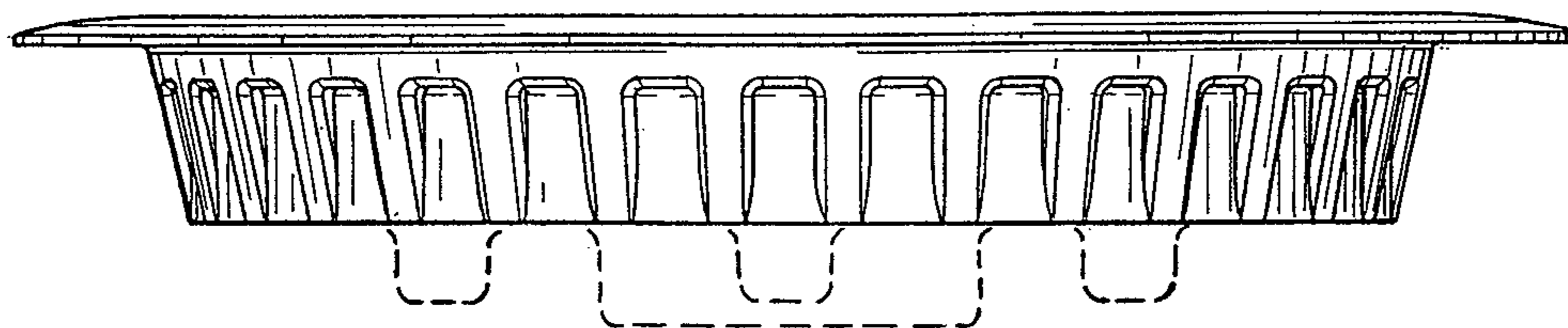

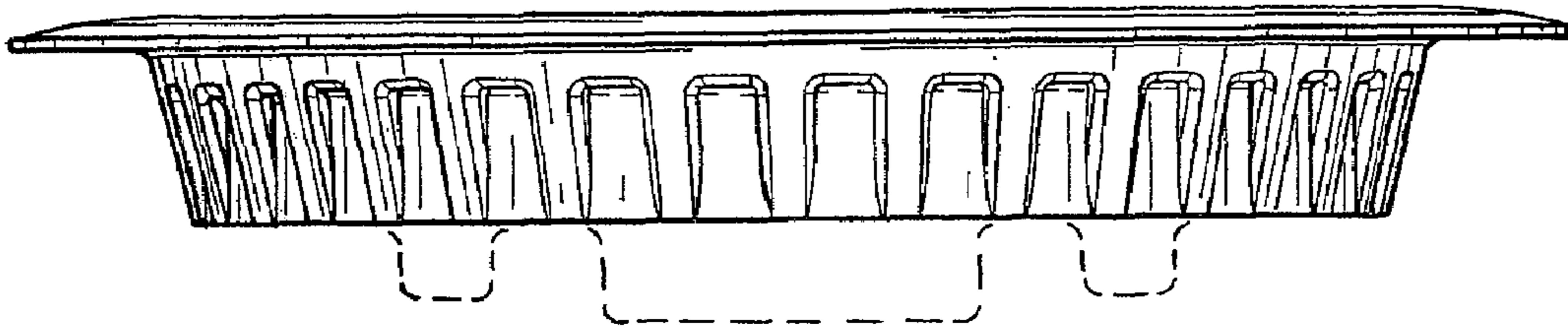

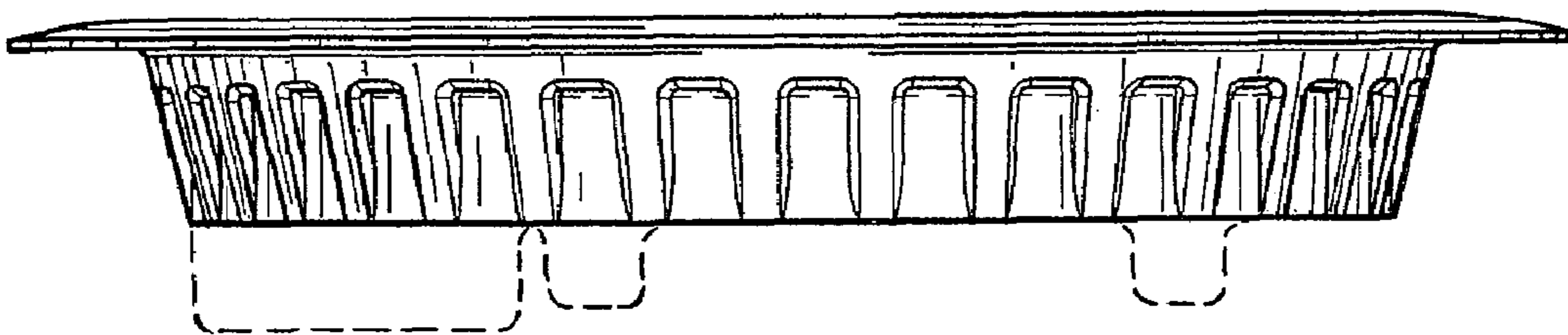
