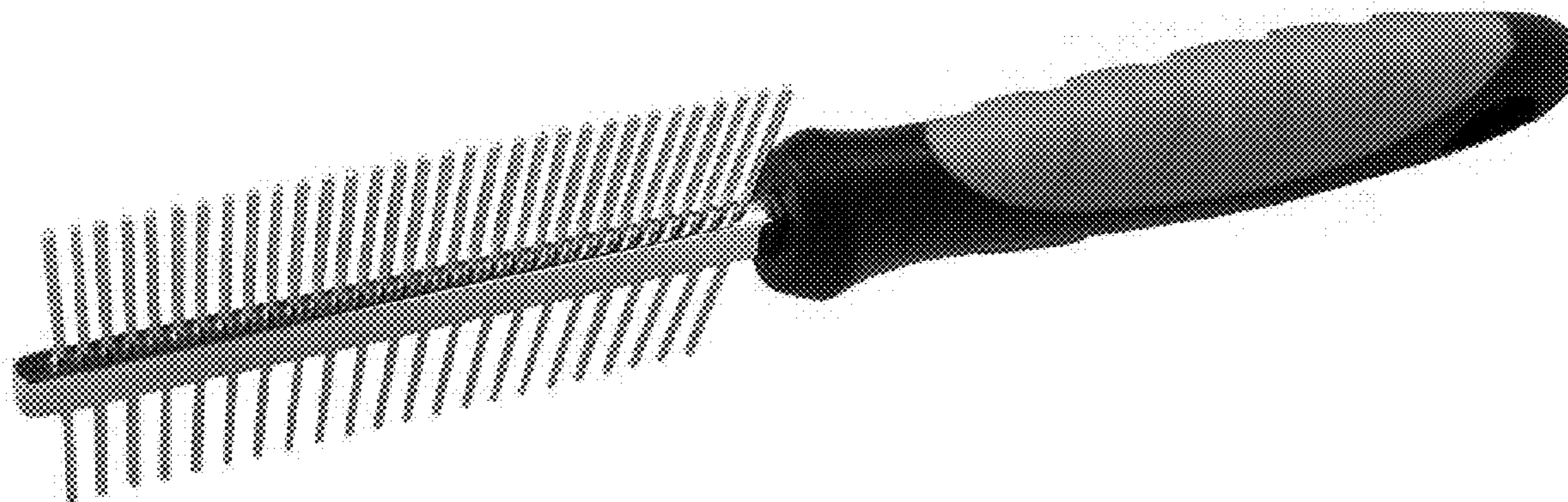
(57) **CLAIM**

I claim the ornamental design for a pet comb, as shown.

DESCRIPTION

FIG. 1 is a perspective view of the pet comb in accordance with the embodiment of the claimed design;
FIG. 2 is a right side elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a left side elevational view thereof; and,
FIG. 7 is a rear elevational view thereof.

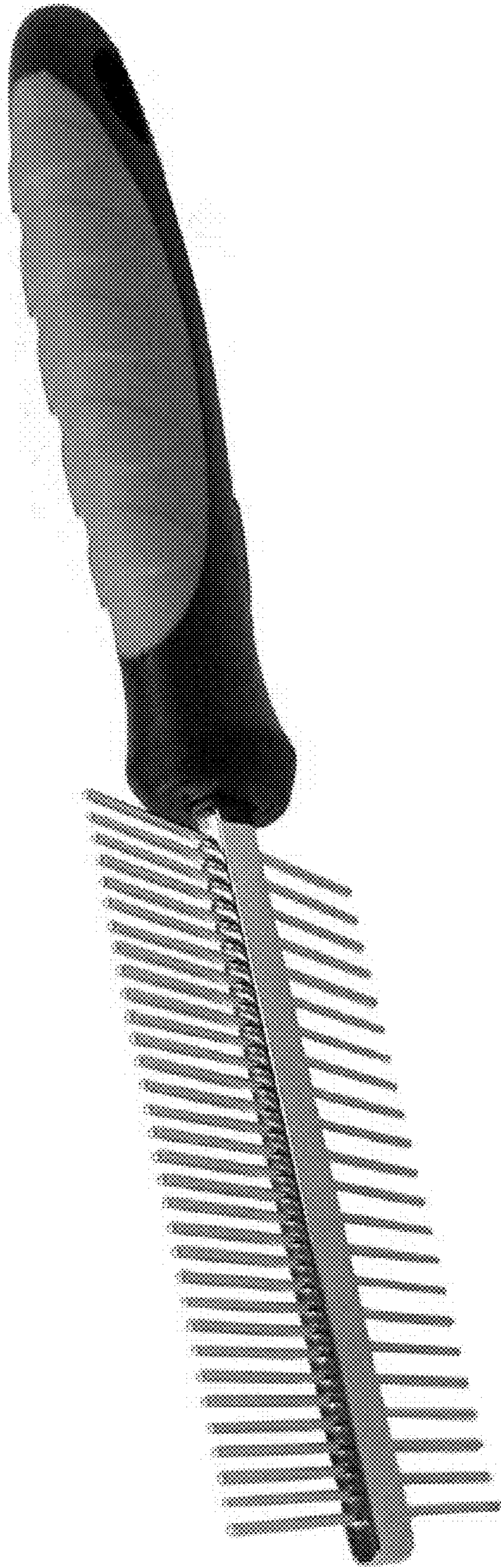

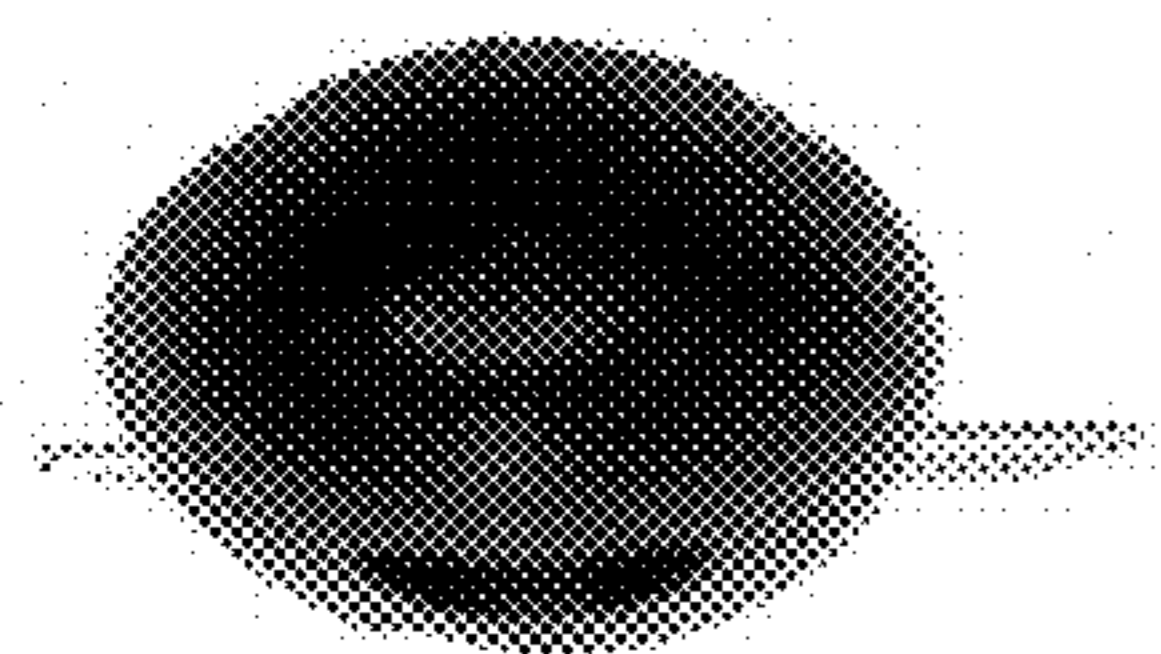

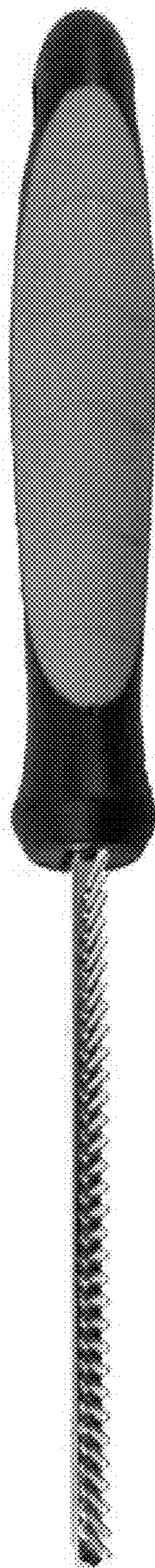

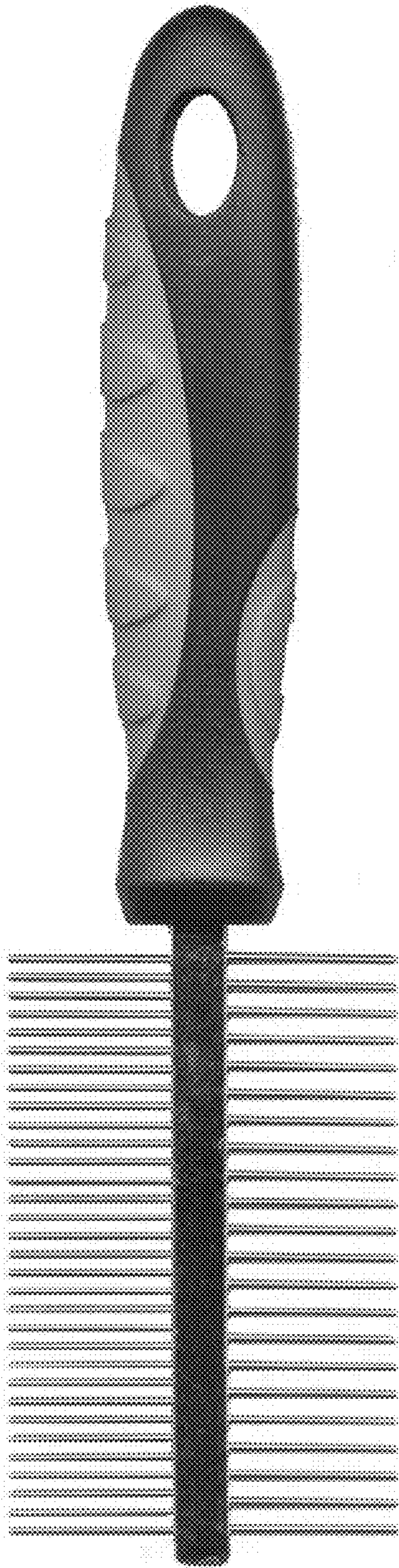

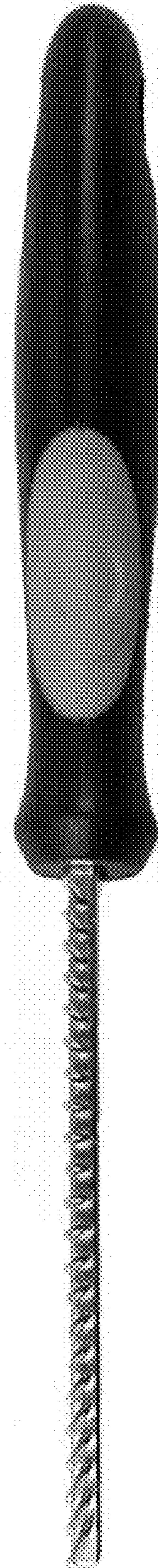

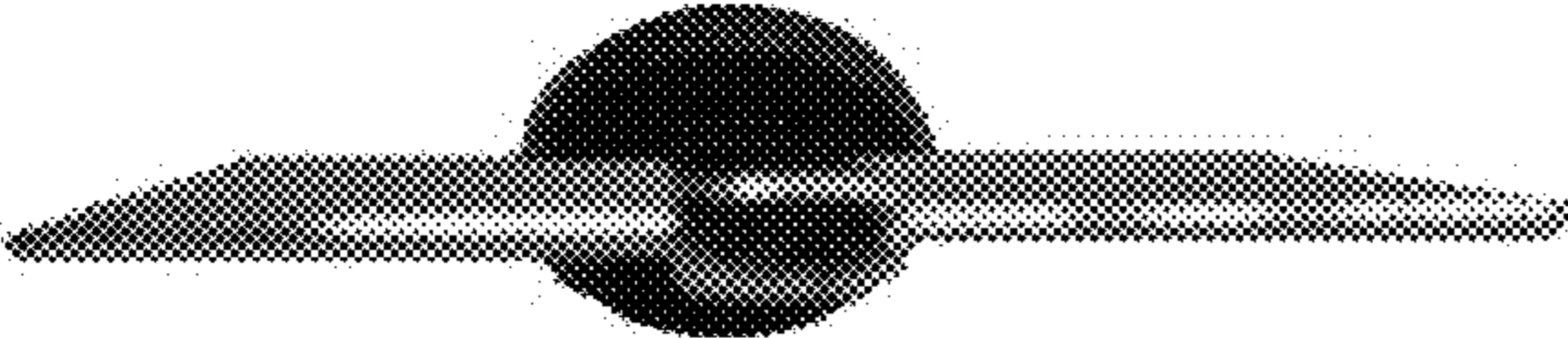

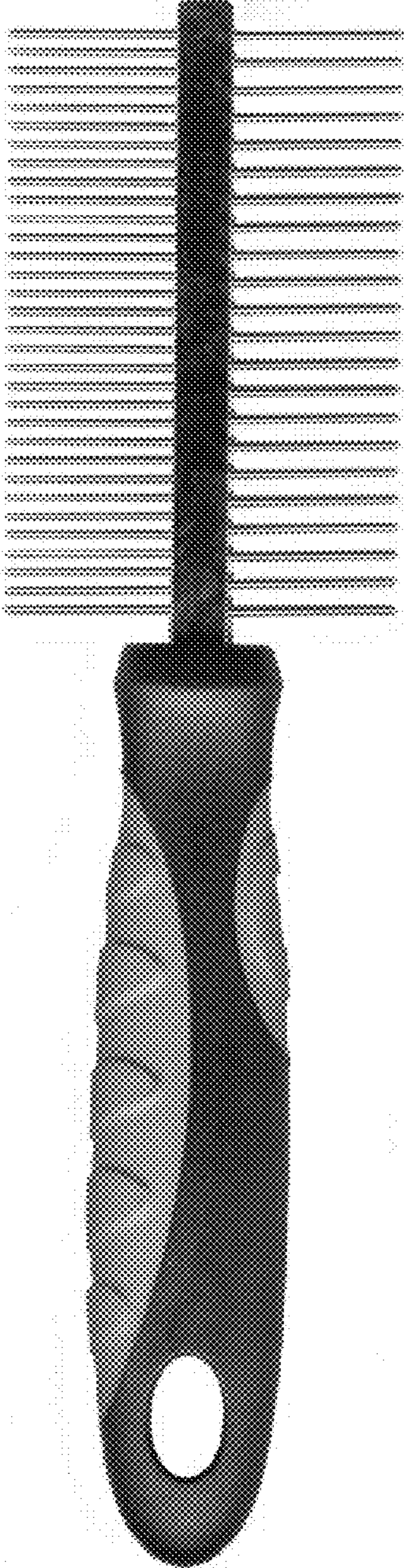
