FIG. 4 is a bottom view of the organic matter digester;

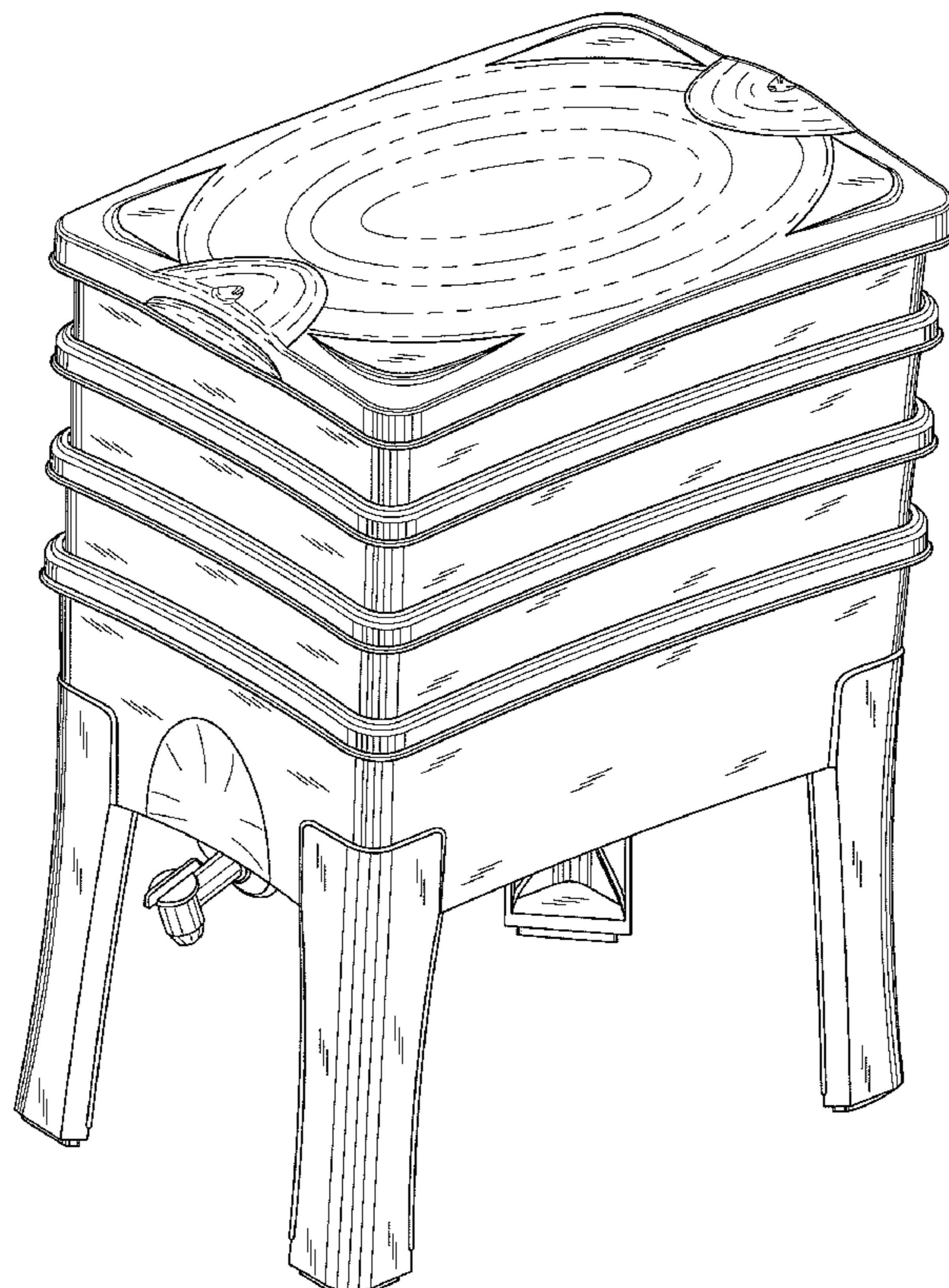
FIG. 5 is a front elevation view of the organic matter digester;

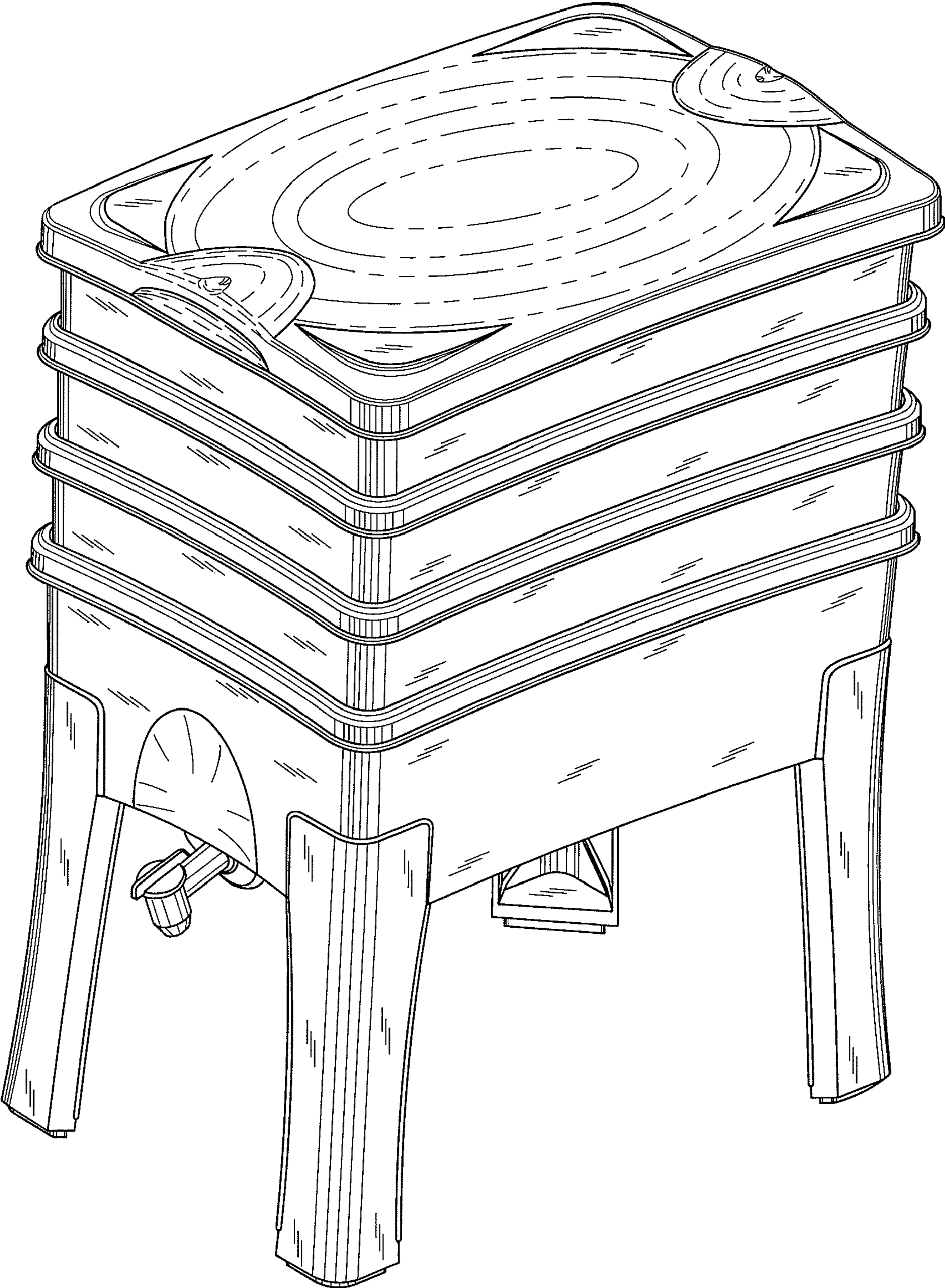

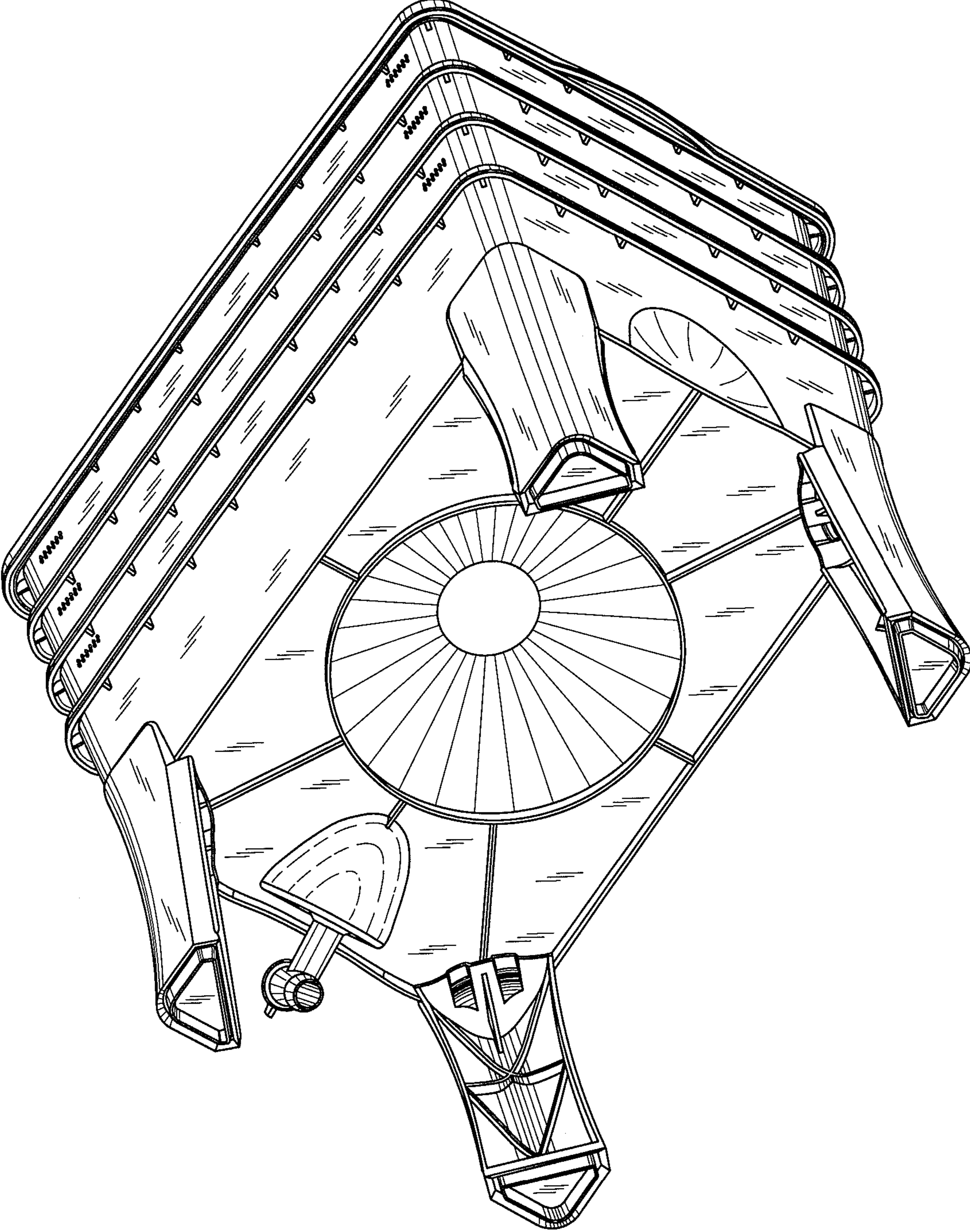

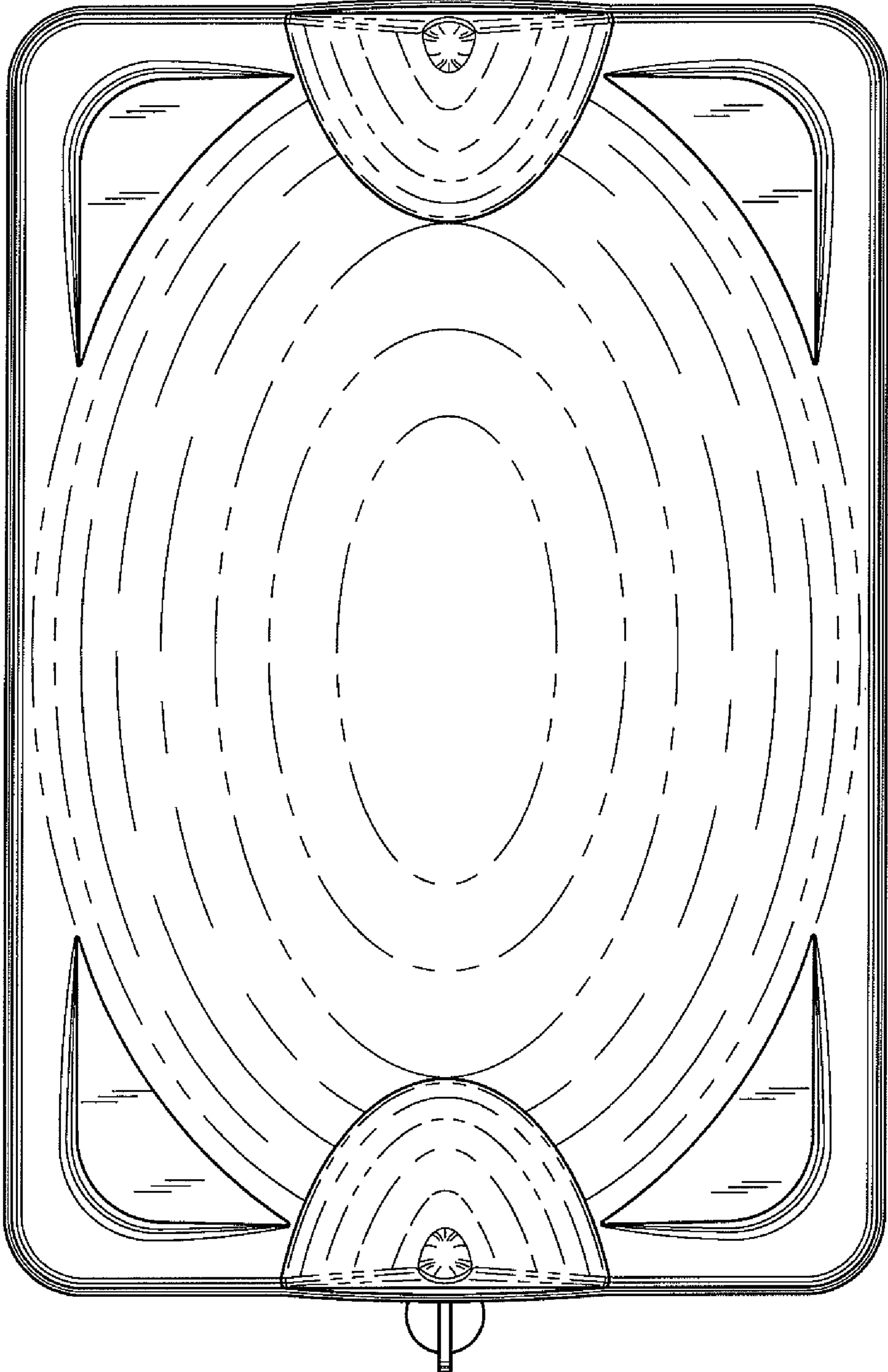

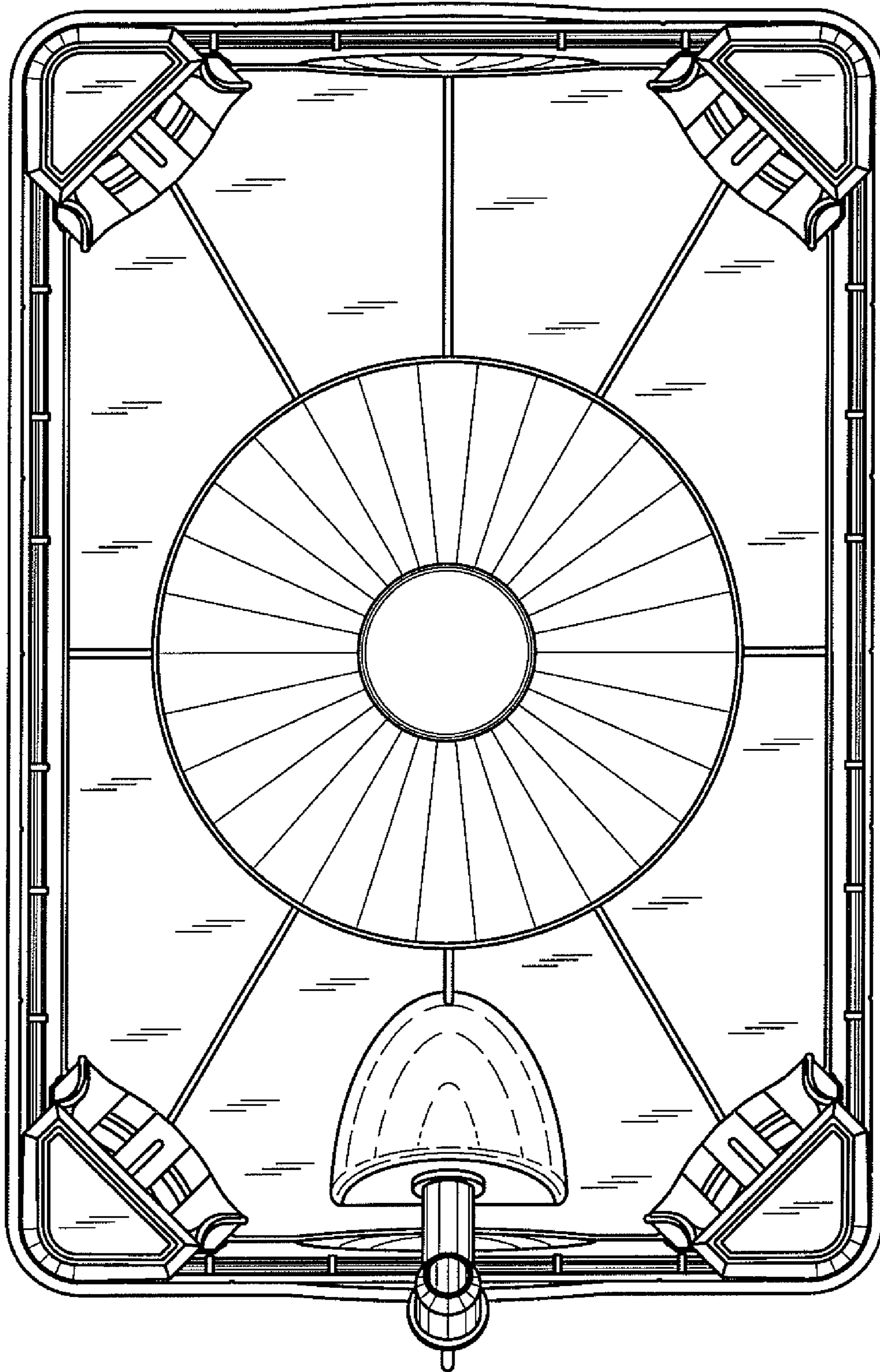

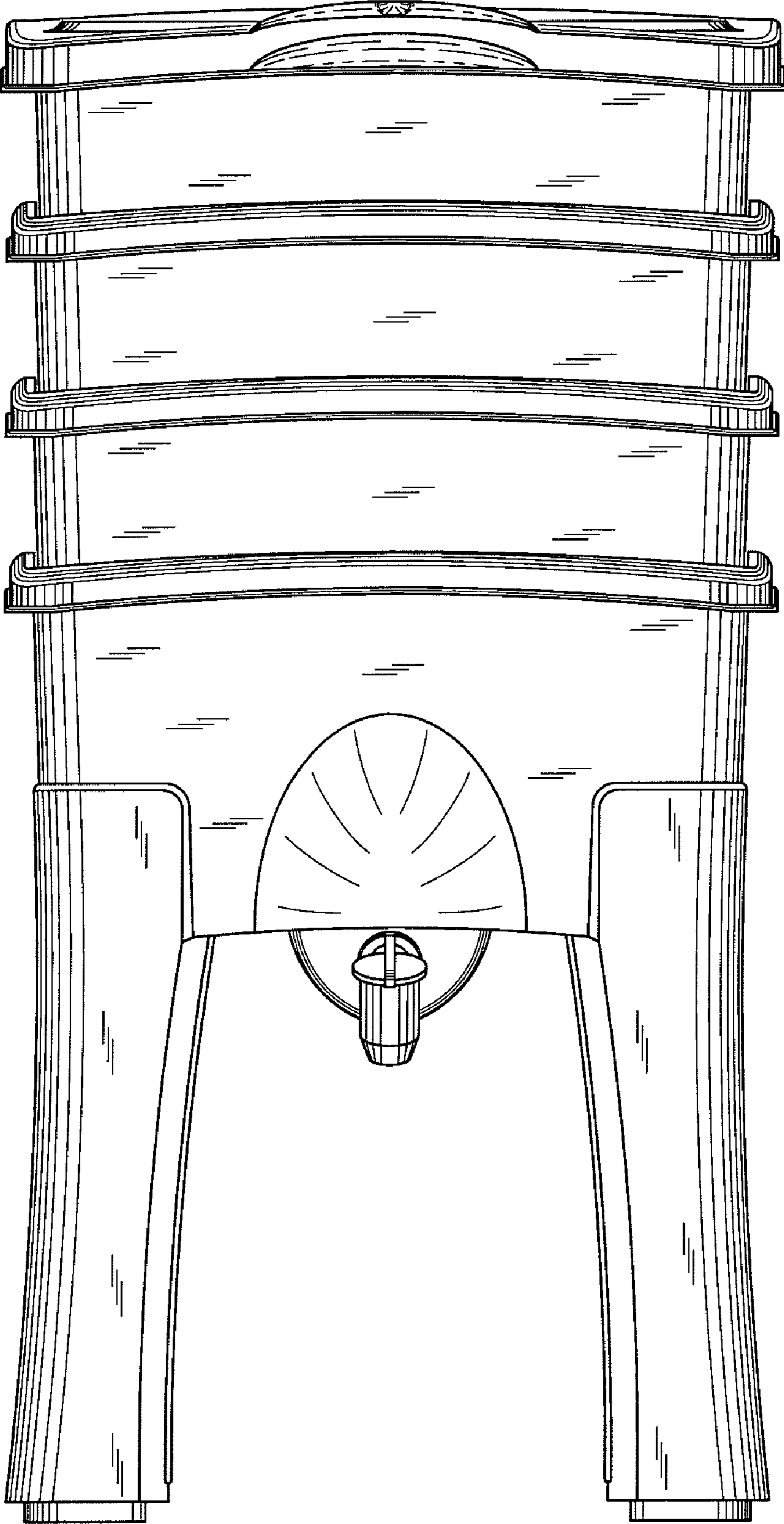

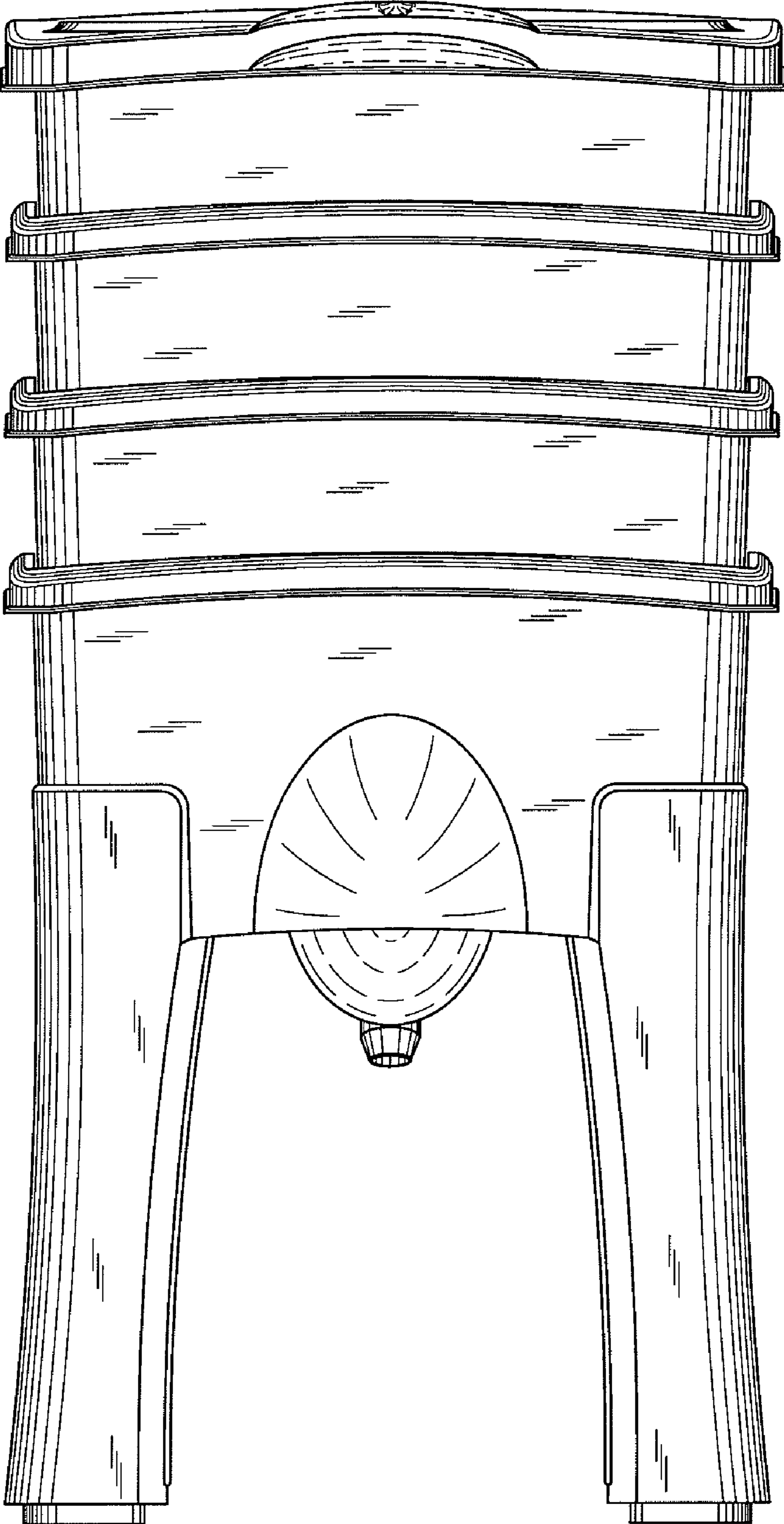

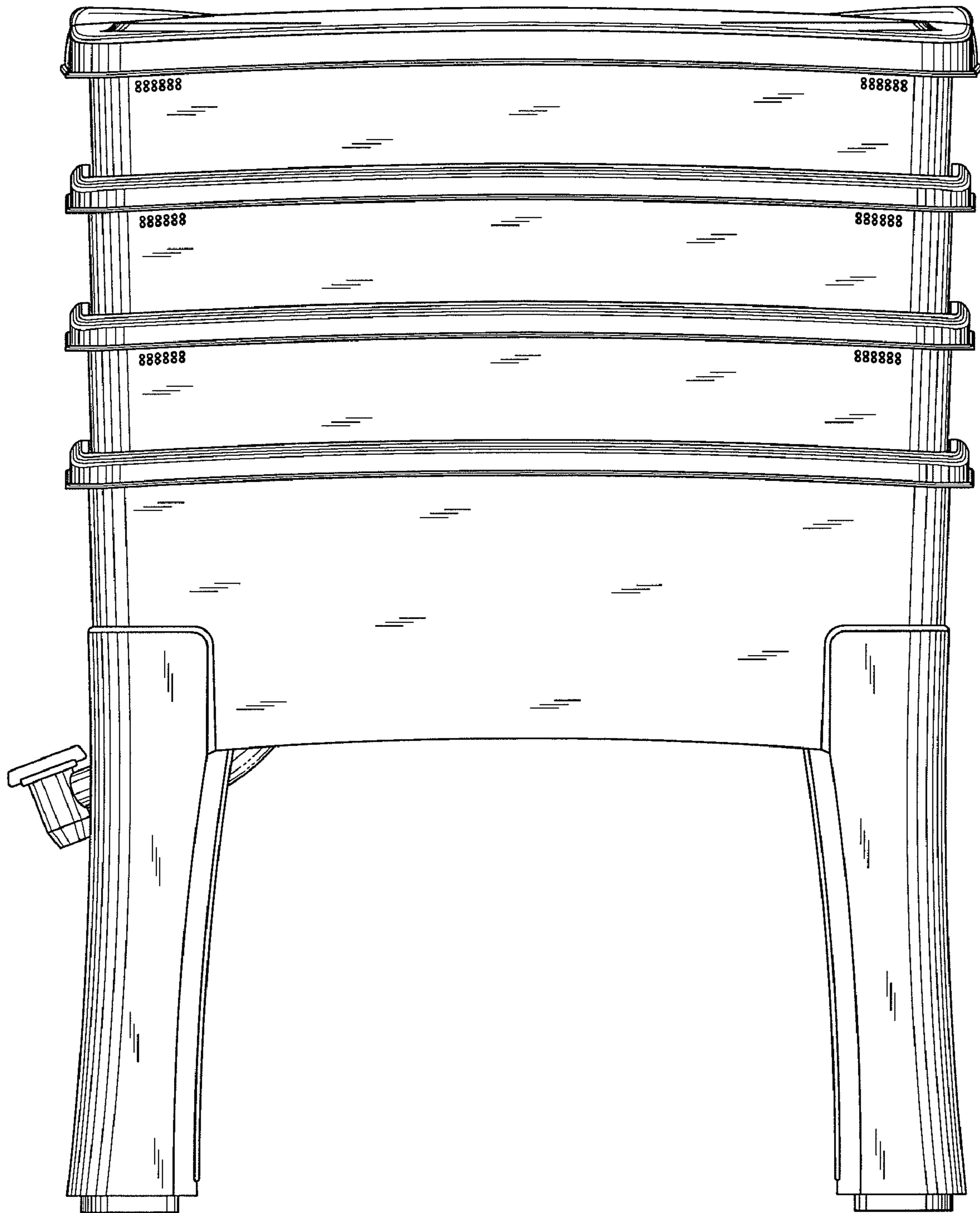
