DESCRIPTION

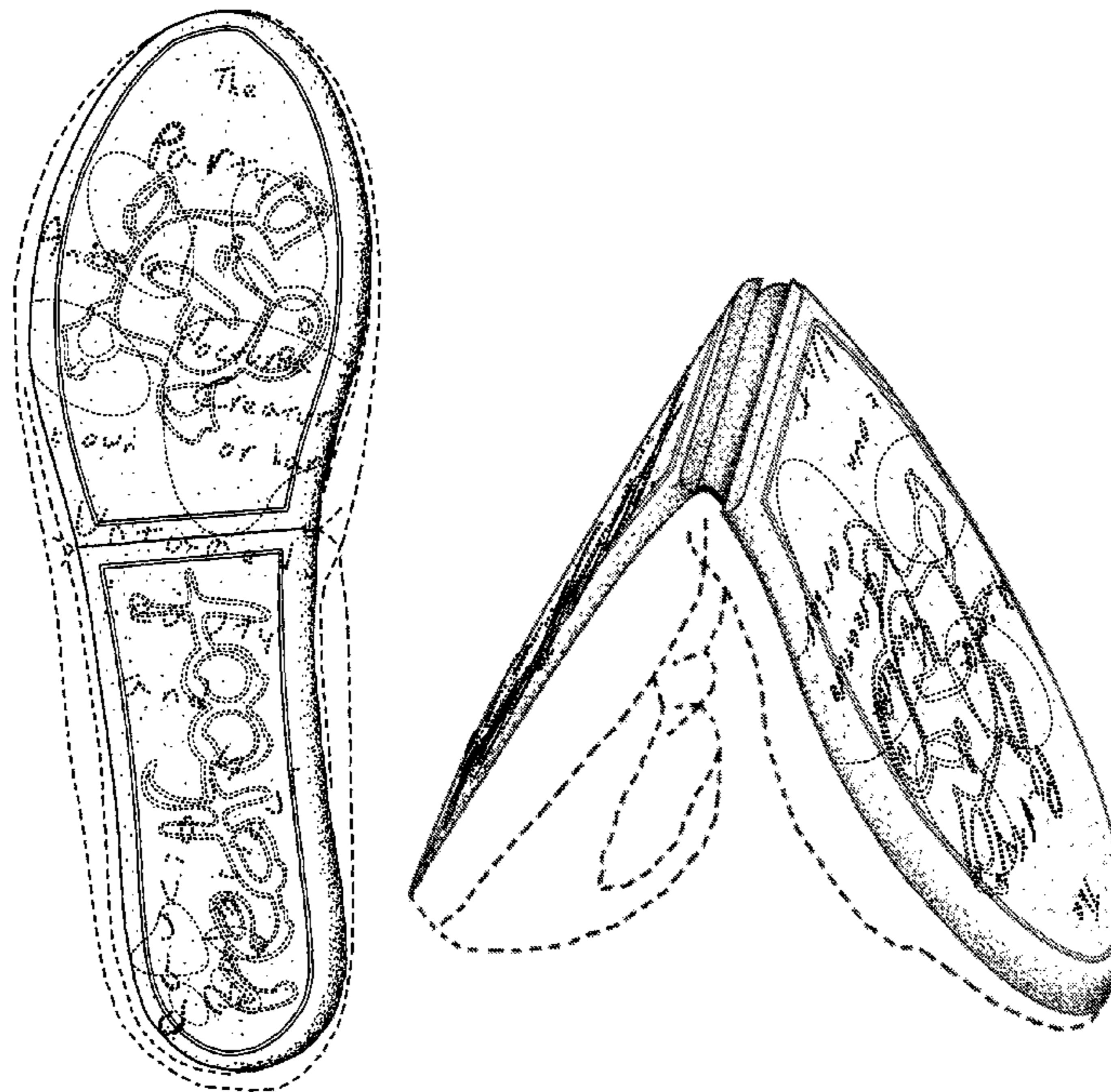
FIG. 1 is a bottom plan view of footwear, embodying my new design;

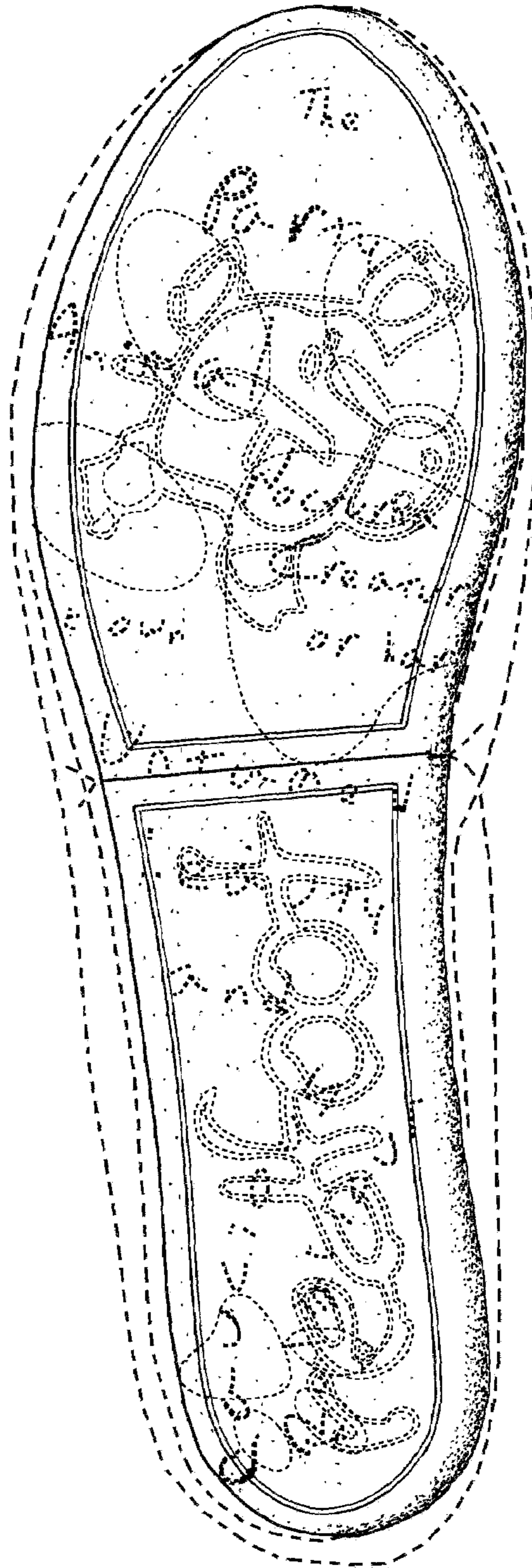

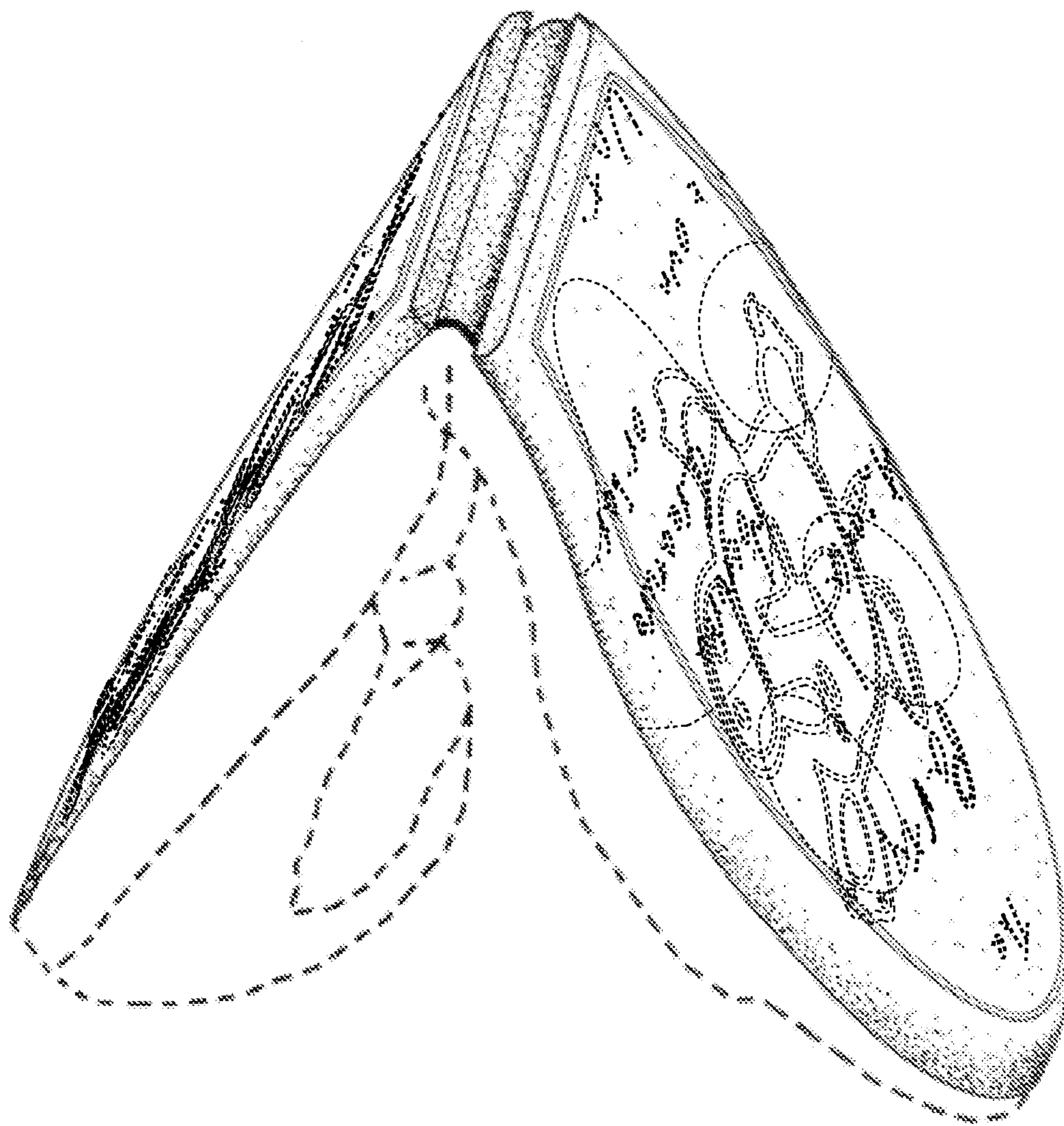

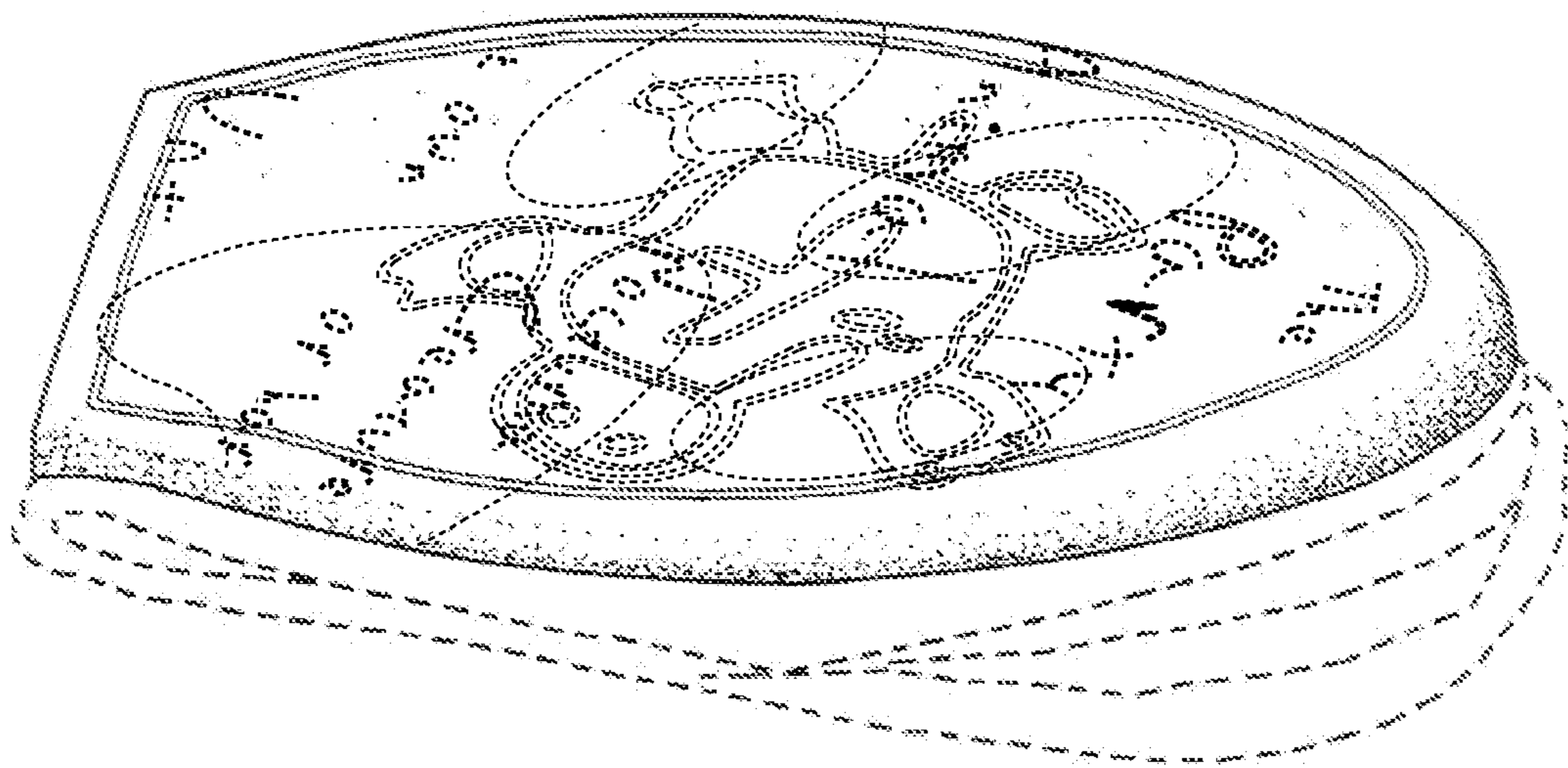

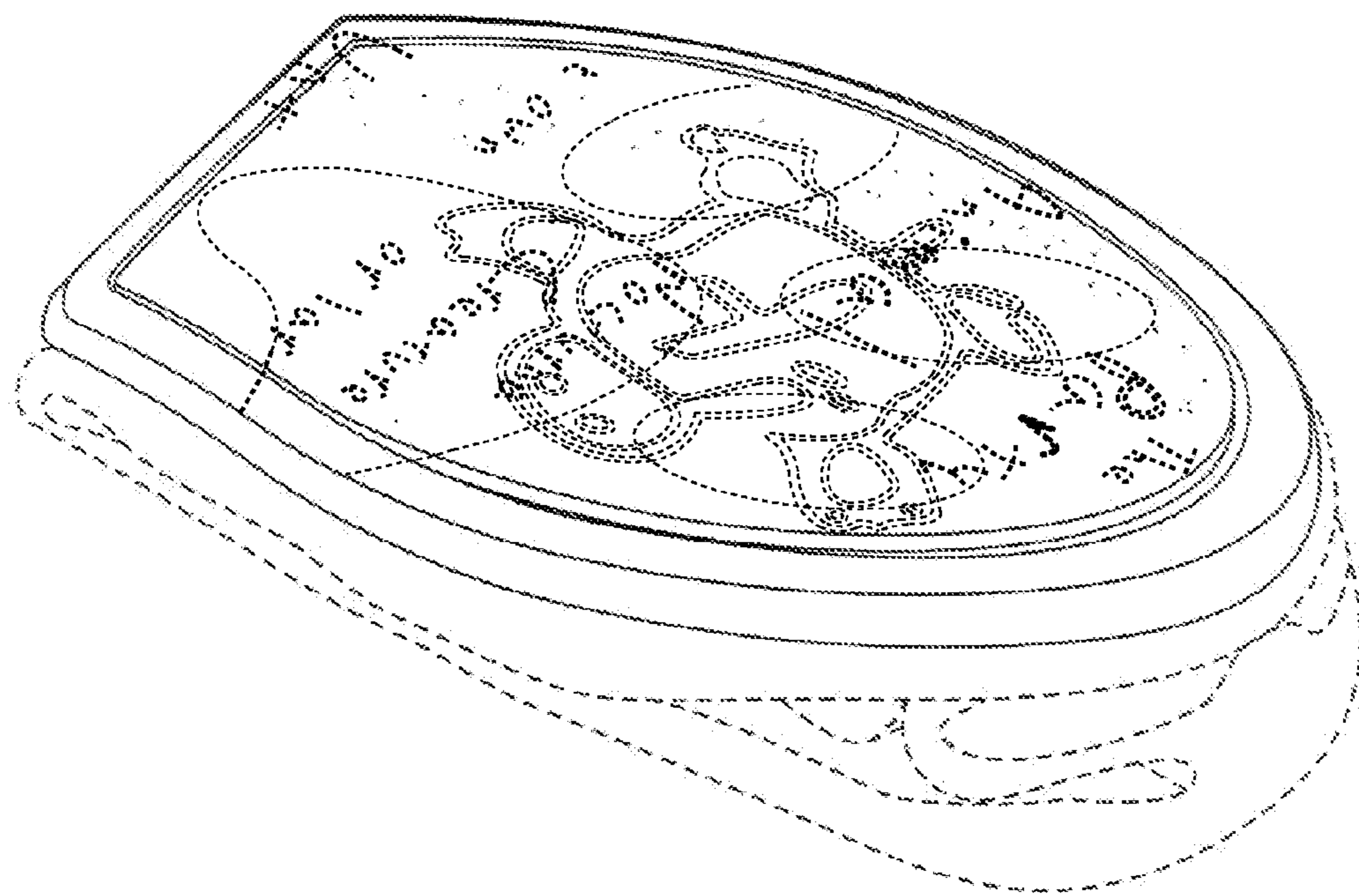
