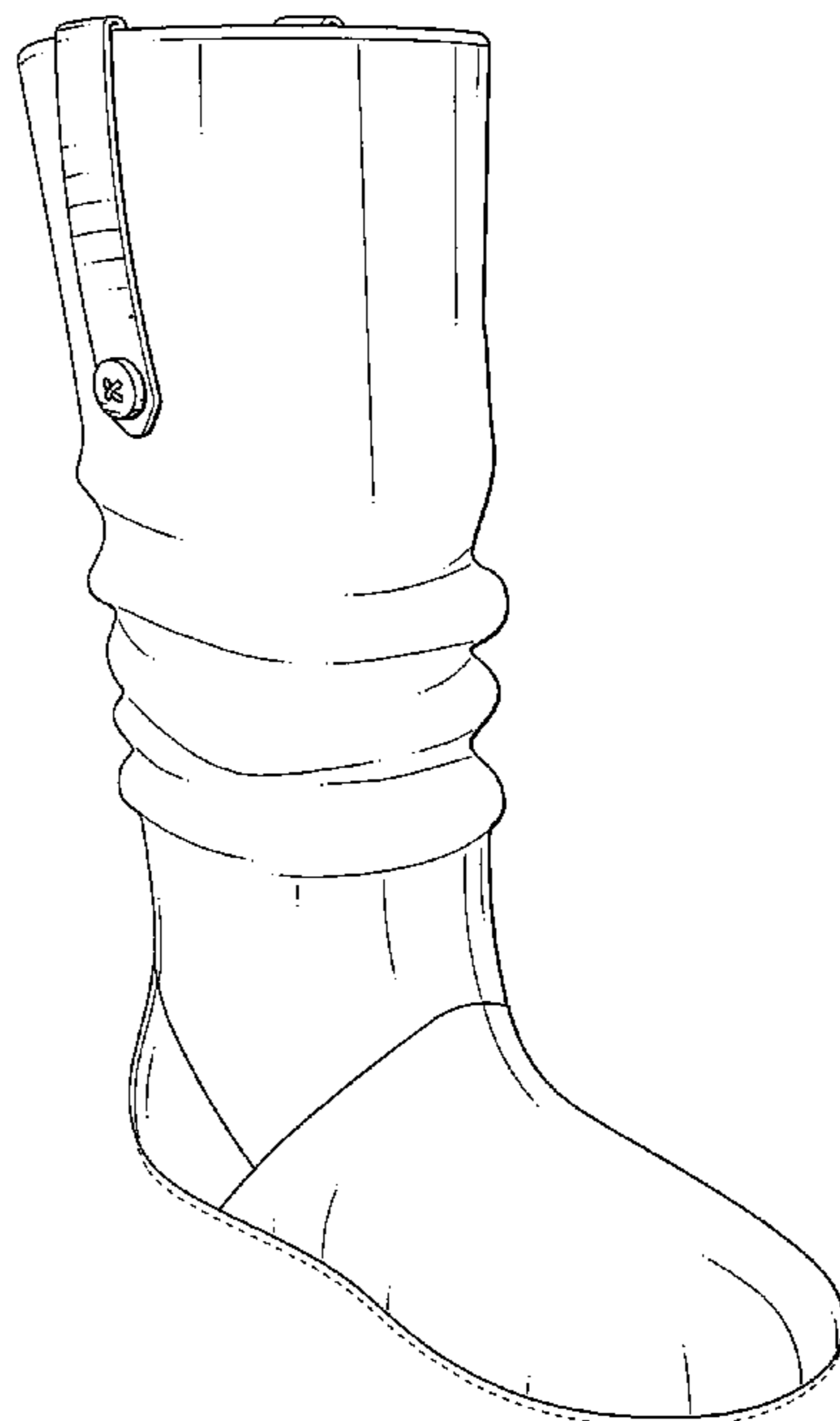
(57) **CLAIM**

The ornamental design for a footwear upper, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a footwear upper showing my new design in a first position;
 FIG. 2 is a side elevational view thereof;
 FIG. 3 is an opposite side elevational view thereof;
 FIG. 4 is a front elevational view thereof;
 FIG. 5 is a rear elevational view thereof;
 FIG. 6 is a top plan view thereof; and
 FIG. 7 is a bottom plan view thereof.
 FIG. 8 is a perspective view of a footwear upper showing my new design in an alternate position;
 FIG. 9 is a side elevational view thereof in the alternate position;
 FIG. 10 is an opposite side elevational view thereof in the alternate position;
 FIG. 11 is a front elevational view thereof in the alternate position;
 FIG. 12 is a rear elevational view thereof in the alternate position;
 FIG. 13 is a top plan view thereof in the alternate position; and,
 FIG. 14 is a bottom plan view thereof in the alternate position.
 The broken lines in FIGS. 1-14 represent portions of the footwear that form no part of the claimed design. The broken line in FIGS. 6 and 13 define the bounds of the claimed design and forms no part thereof.

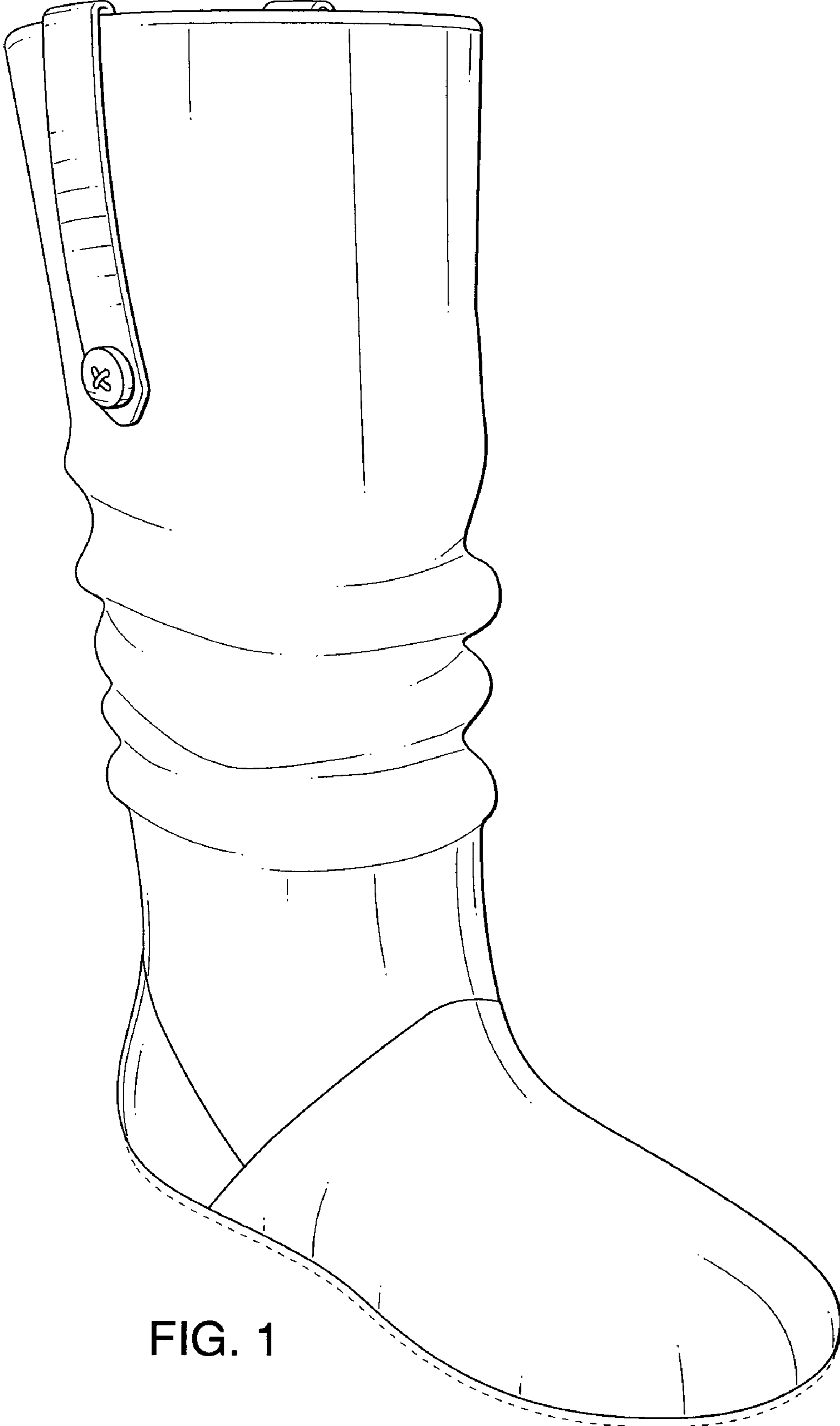

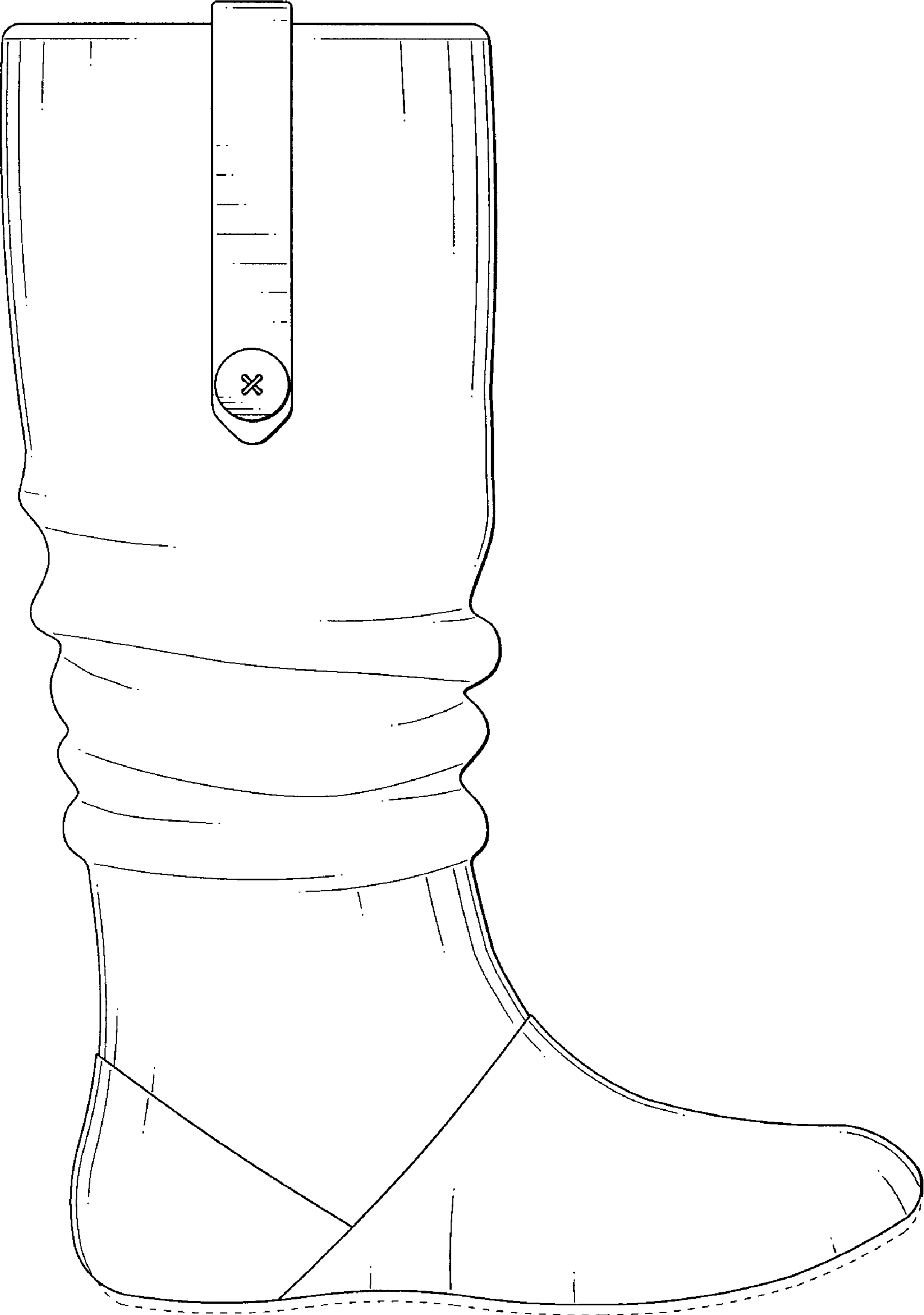

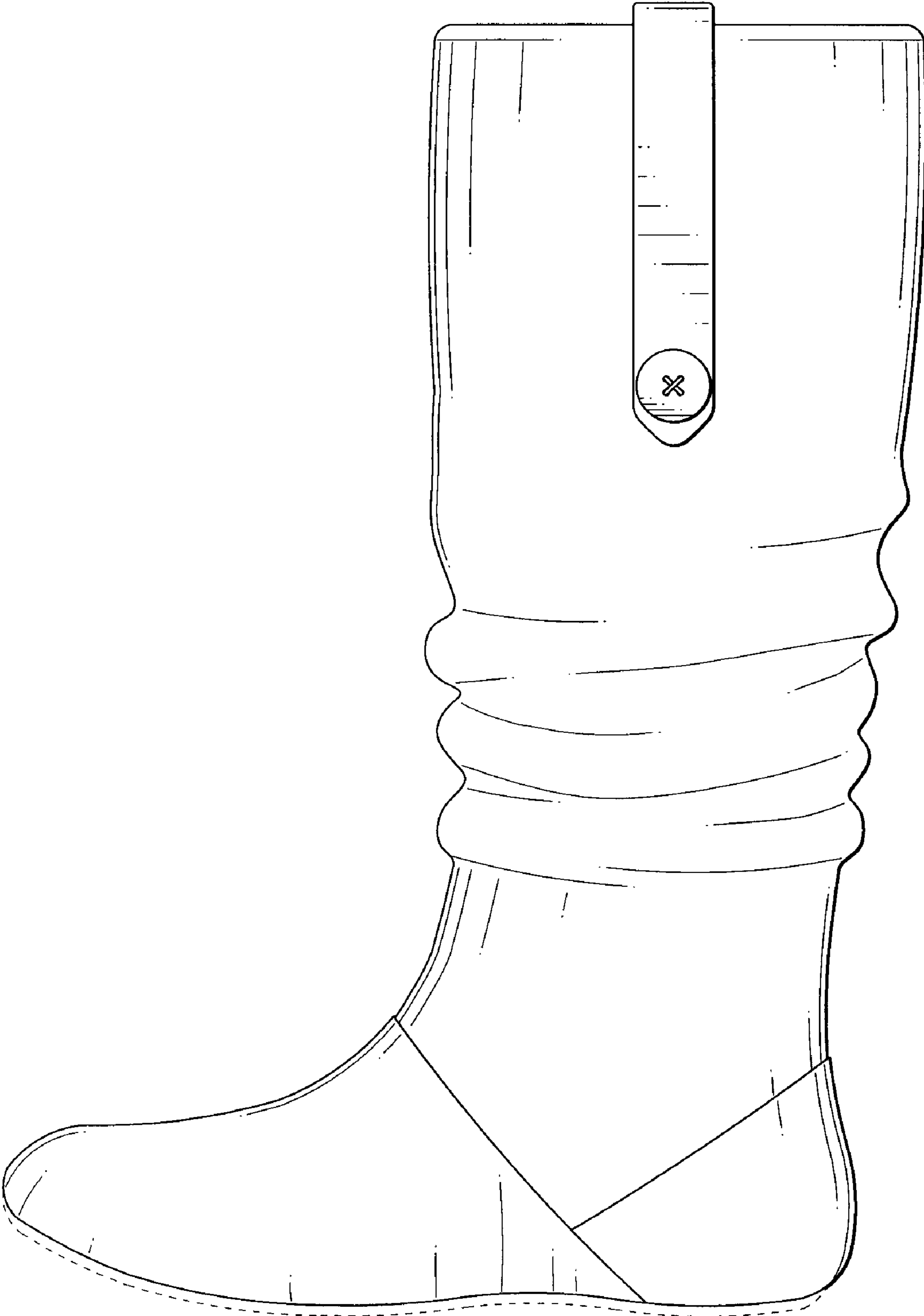

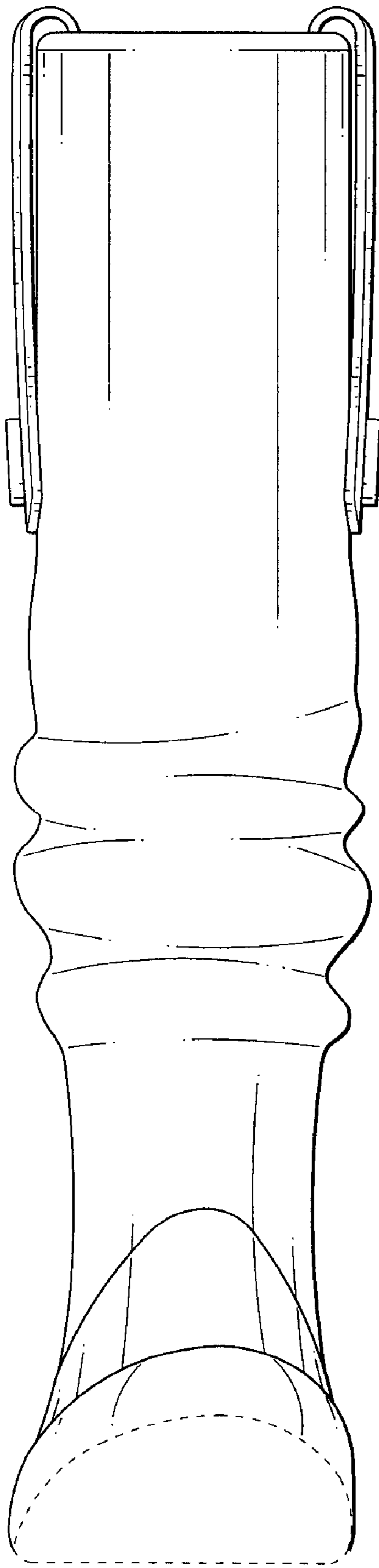

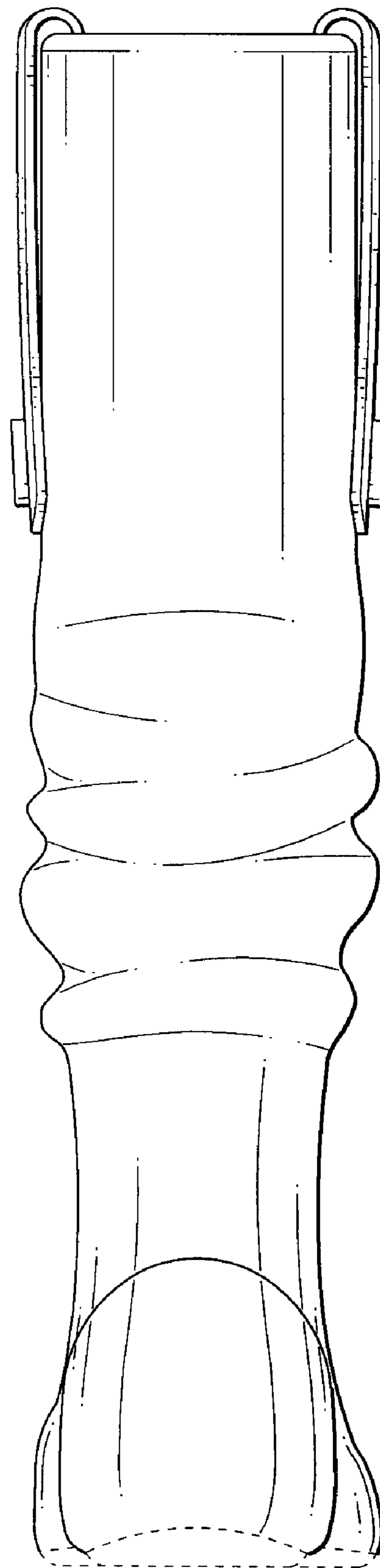

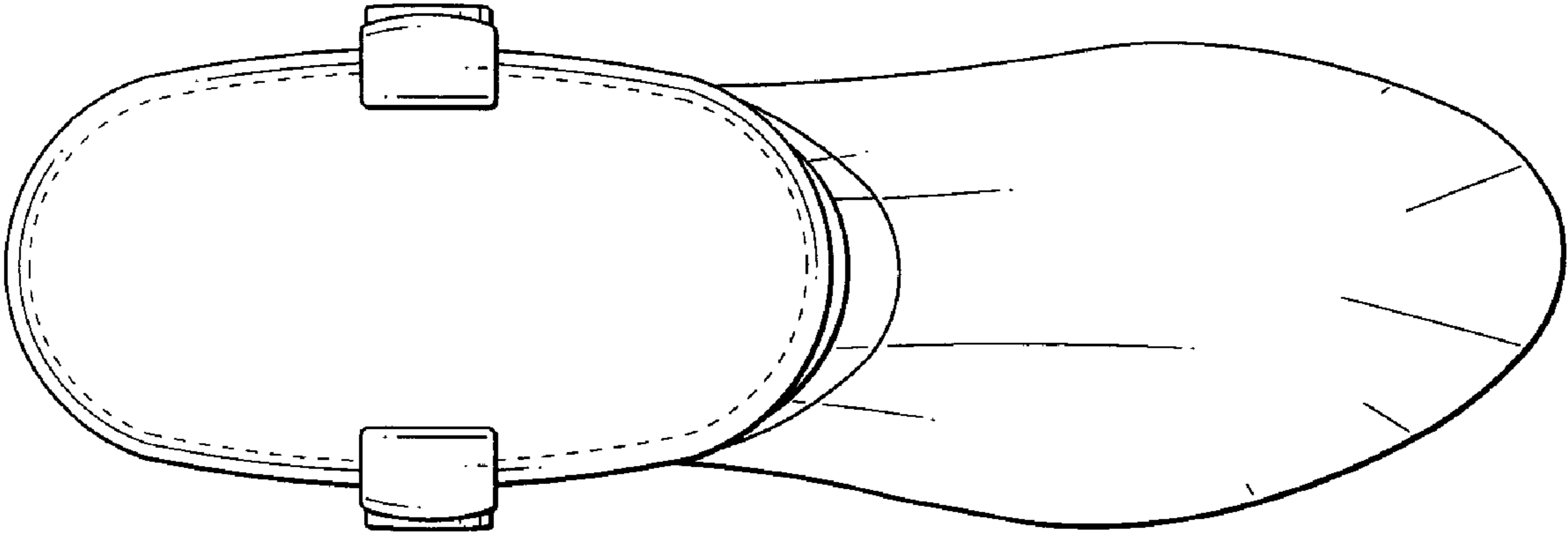

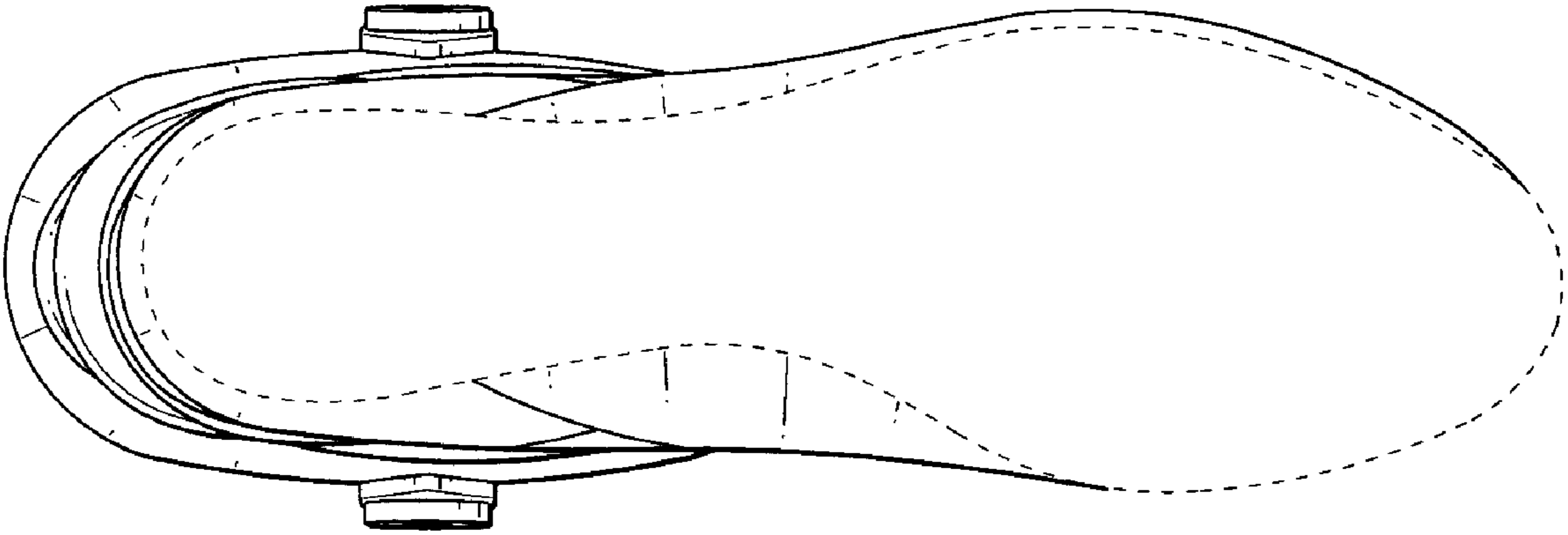

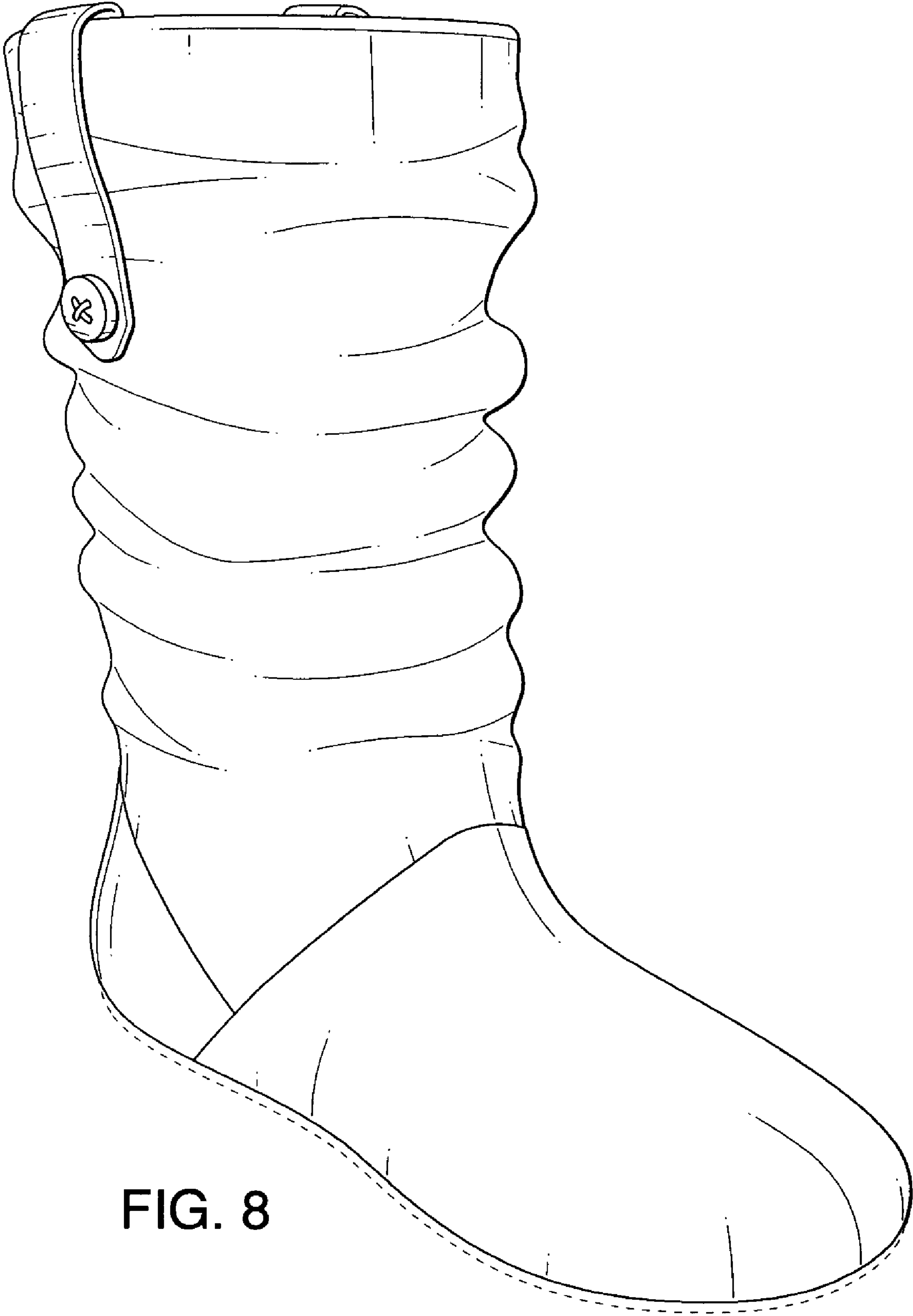

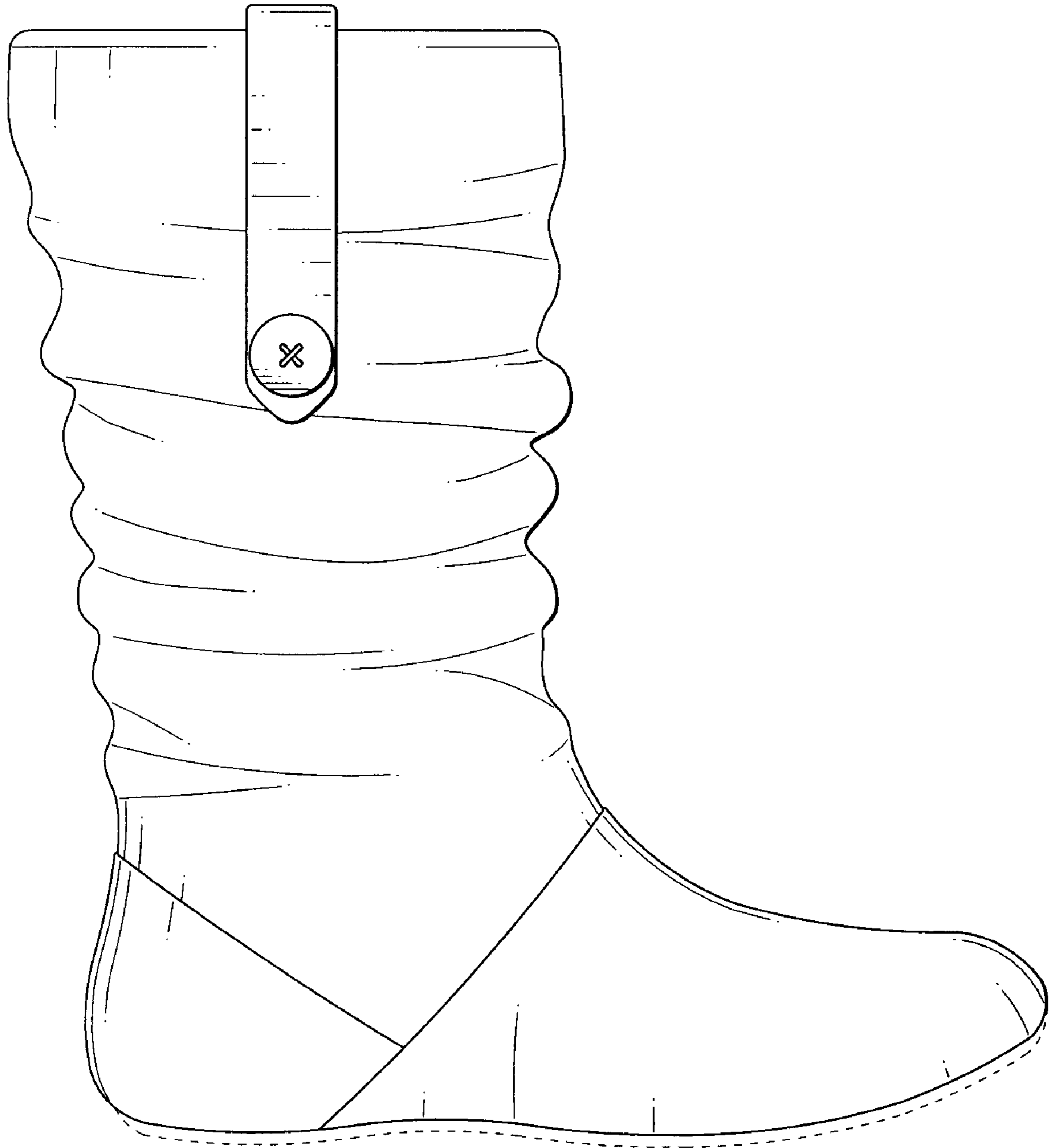

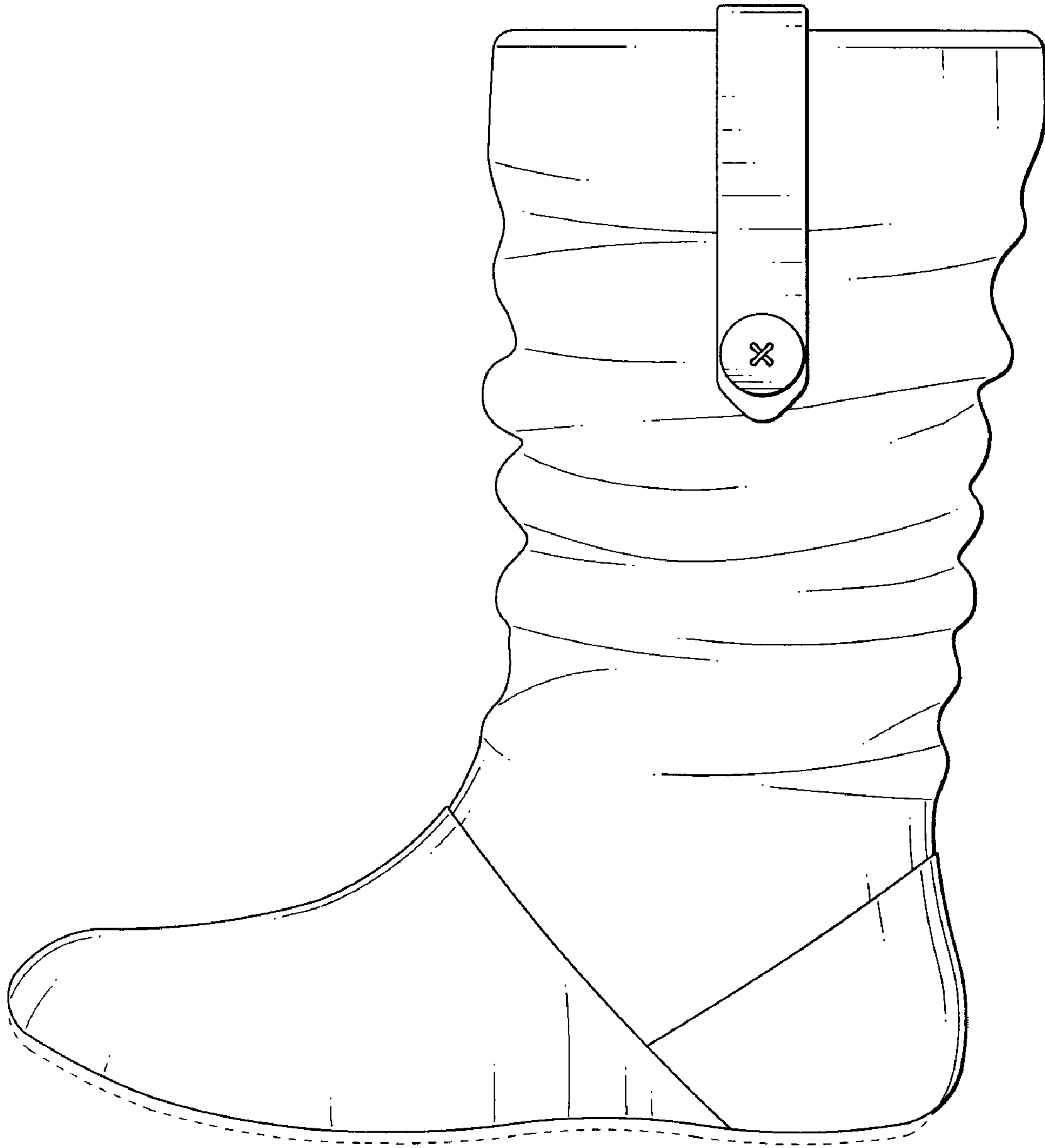

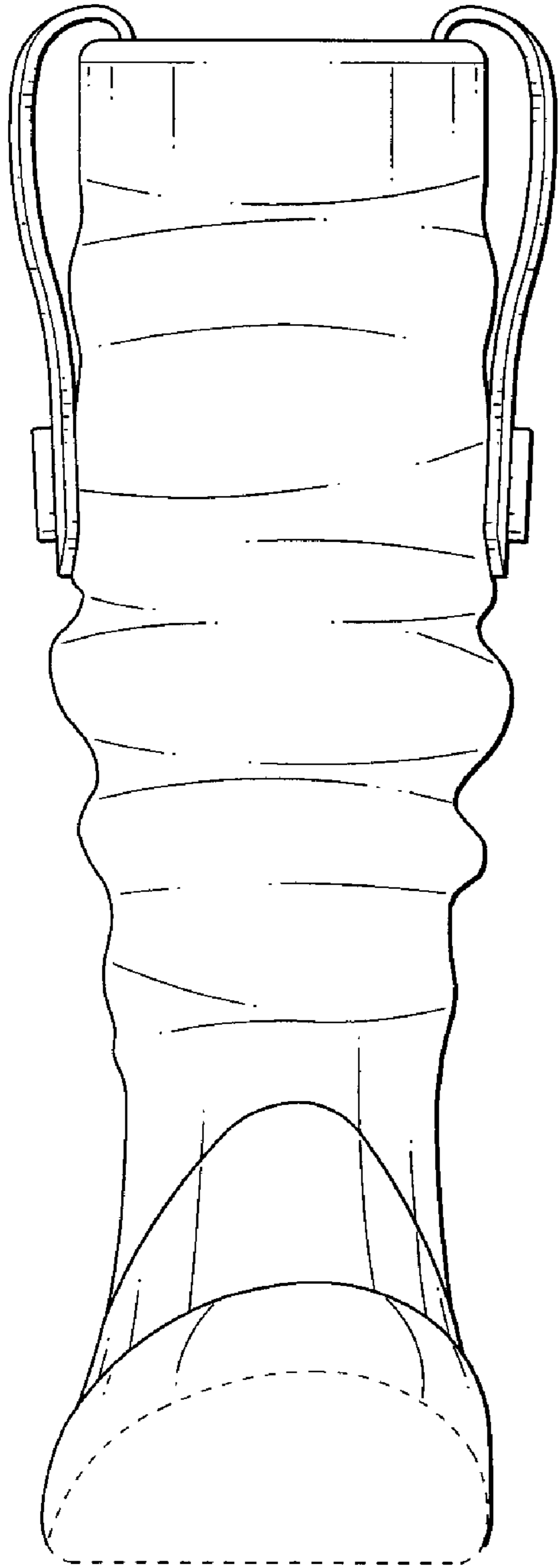

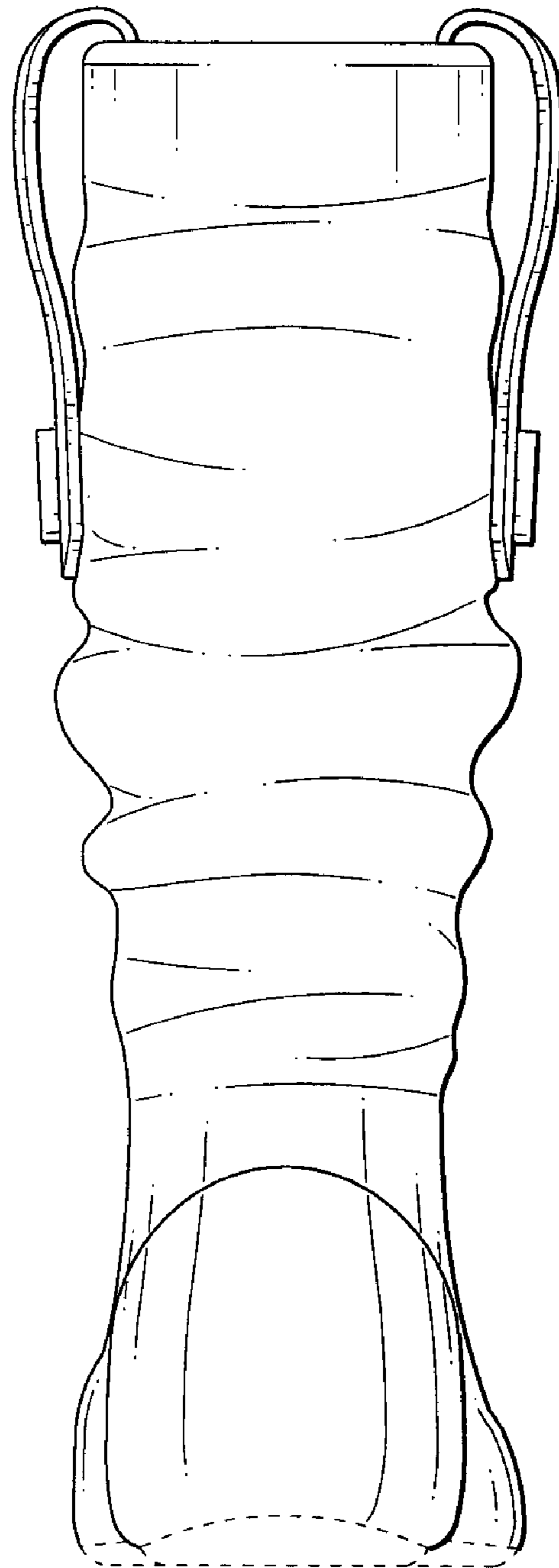

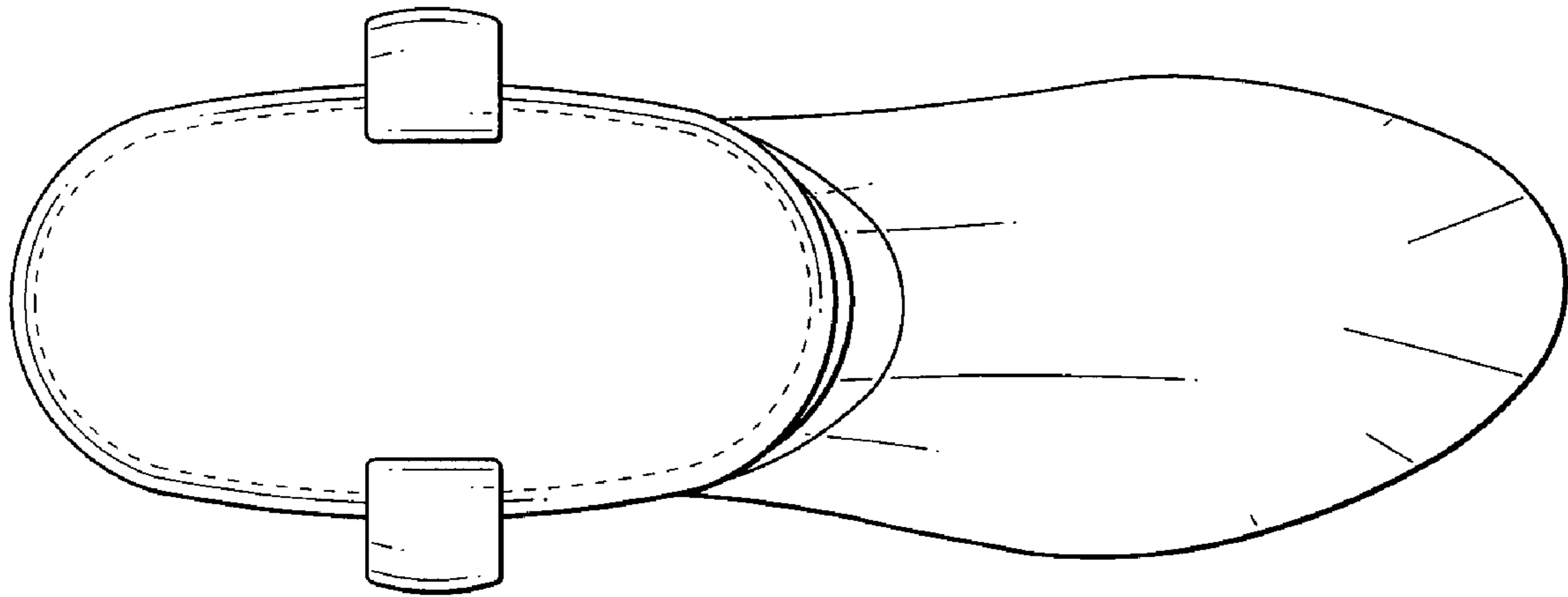

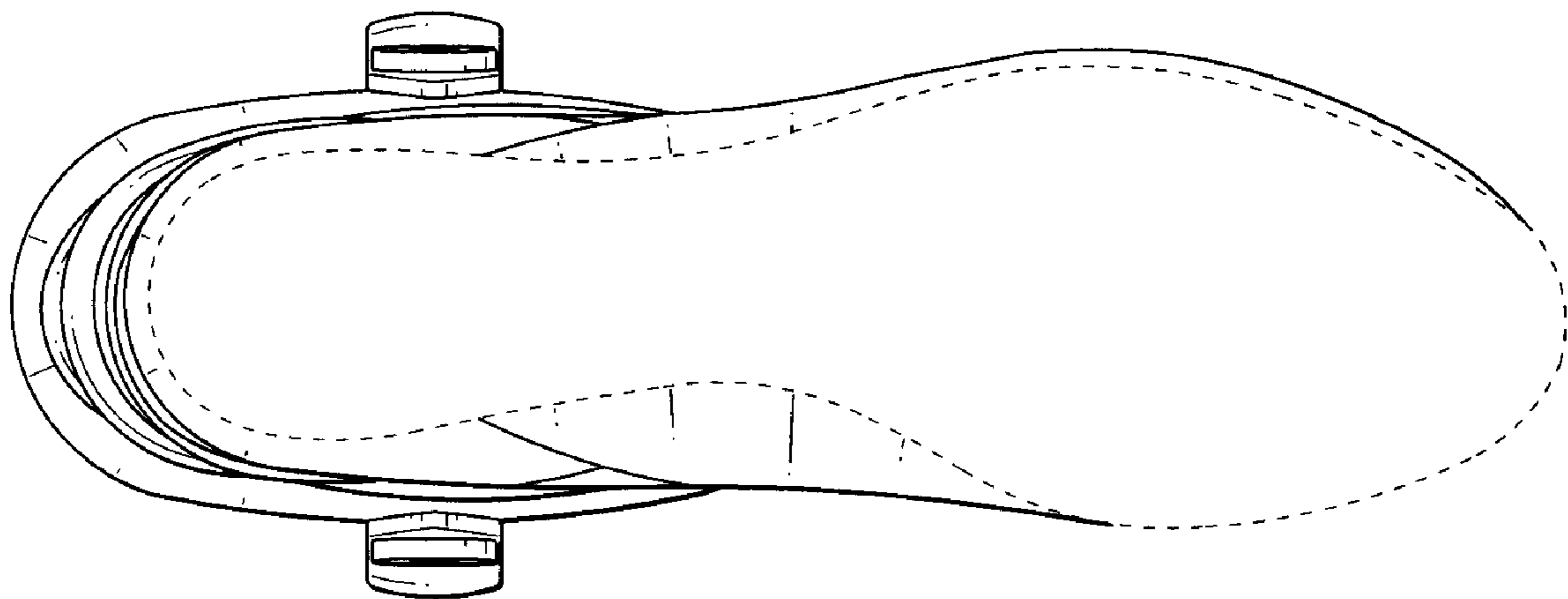
