disclosure.

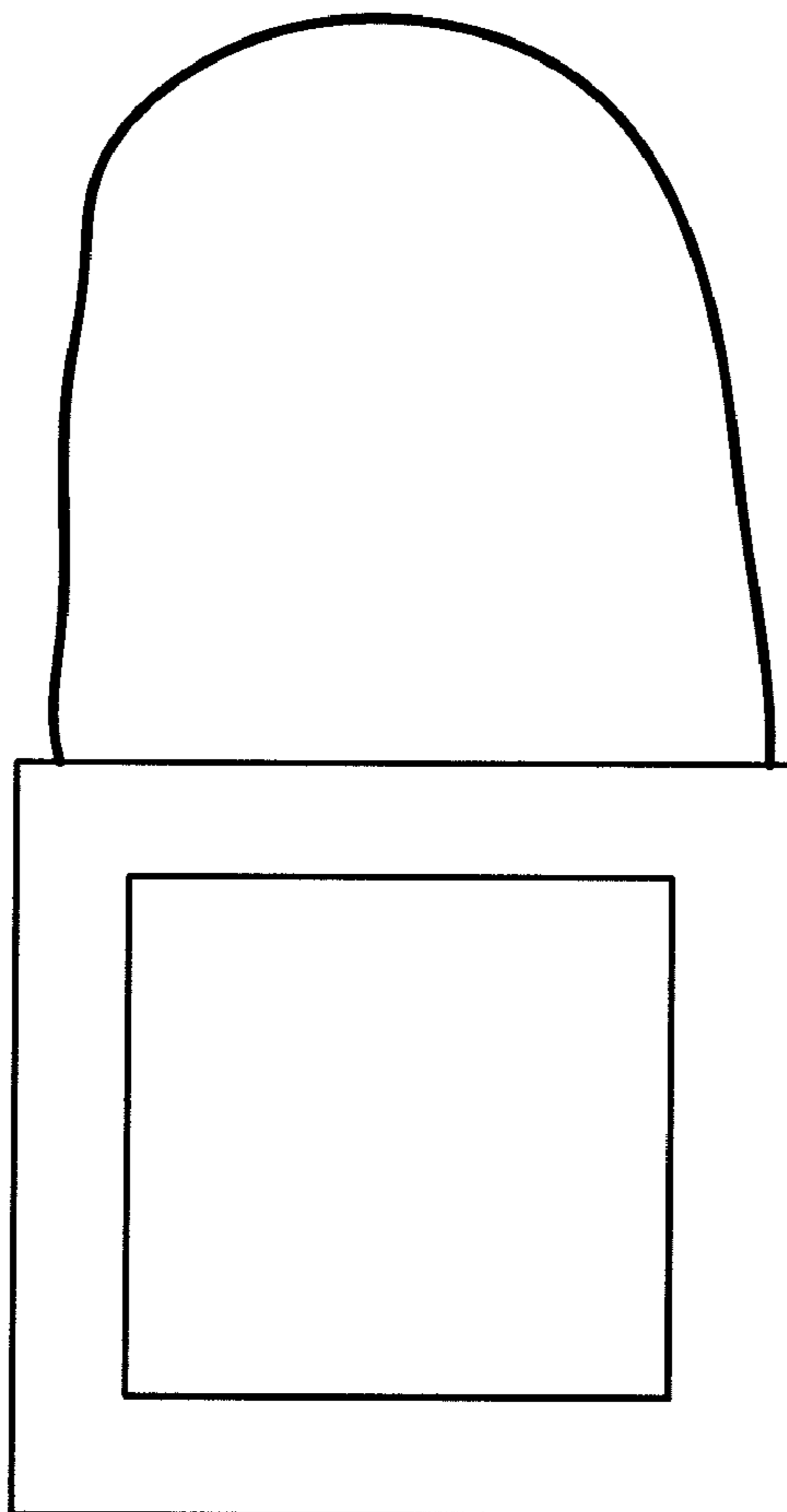
FIG. 2 is a front perspective view of the photo frame of FIG.  
1.

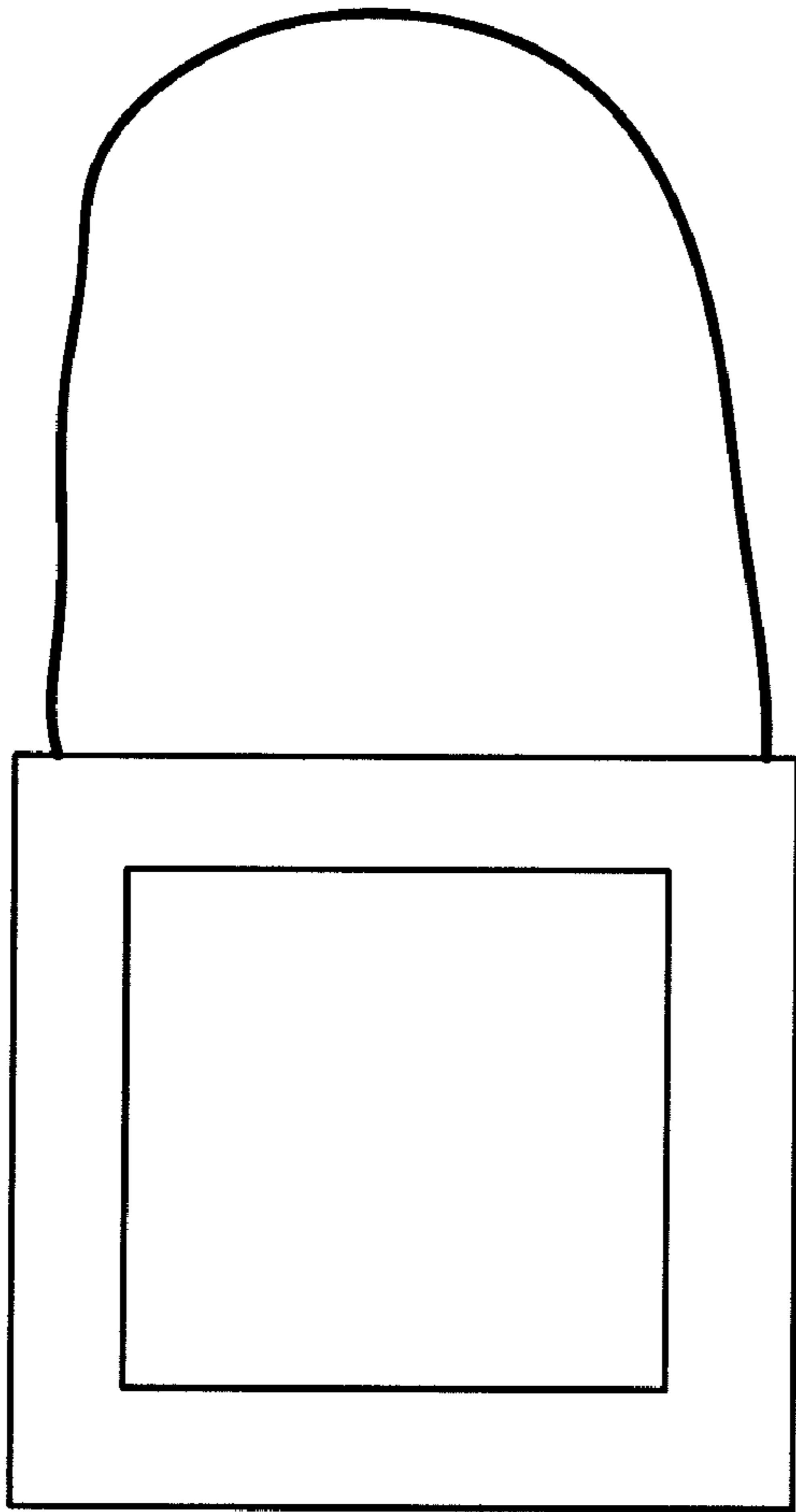
FIG. 3 is a top plan view of the photo frame of FIG. 1.

FIG. 4 is a rear plan view of the photo frame of FIG. 1; and,

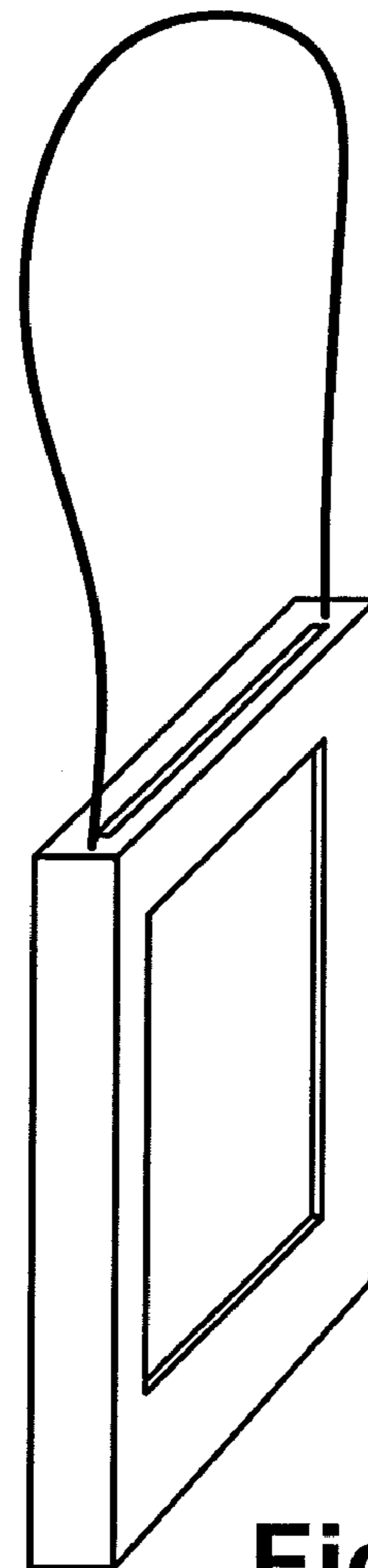
FIG. 5 is a bottom plan view of the photo frame of FIG. 1.

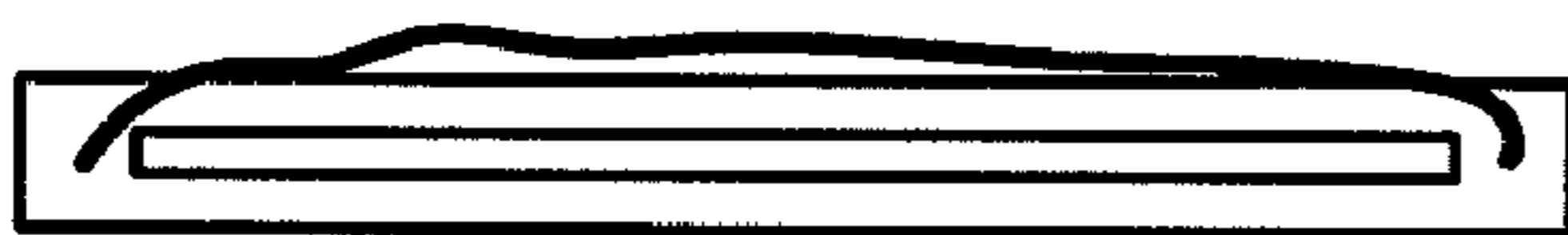




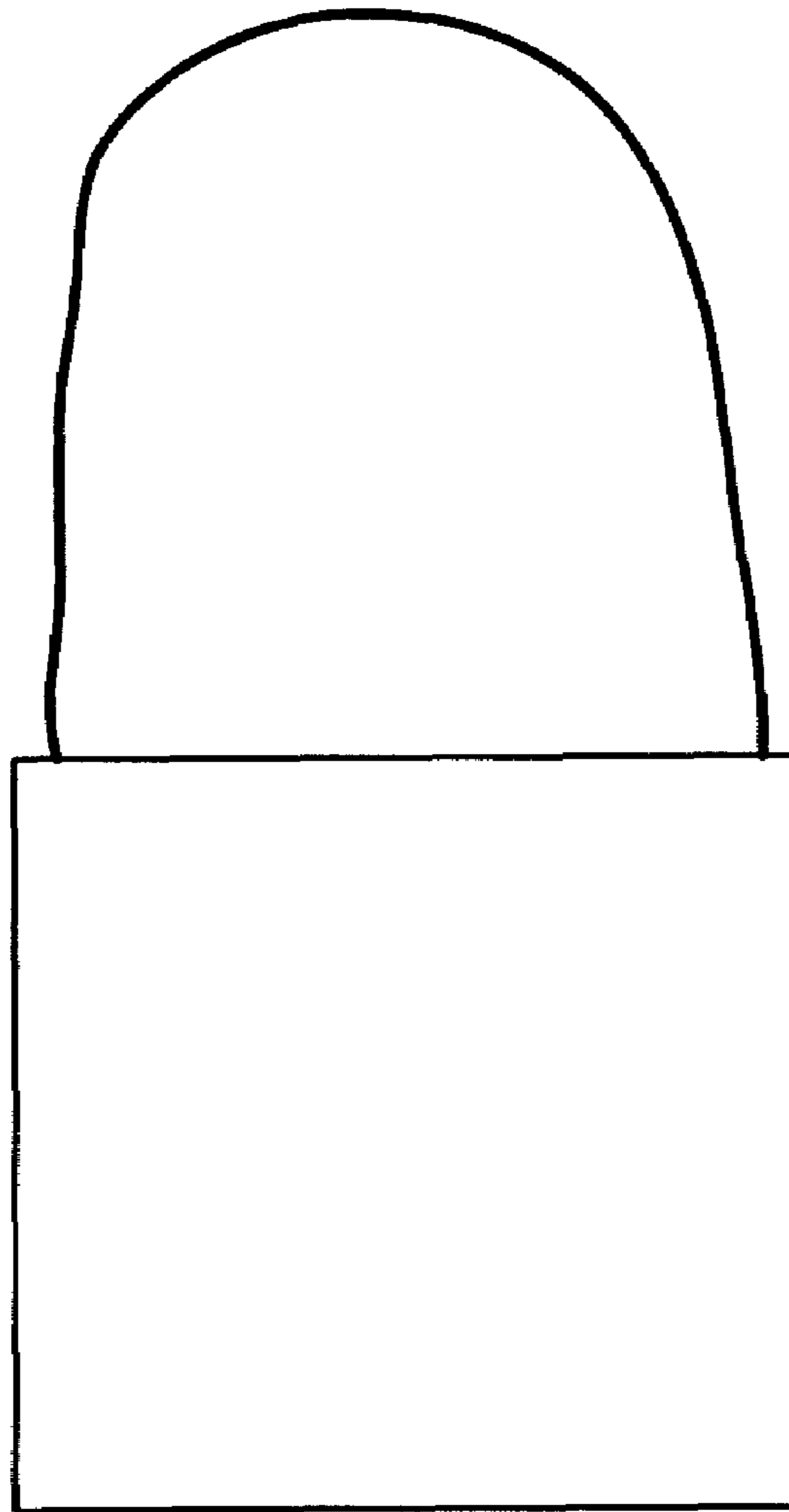
