FIG. 2 is a perspective view of the chair of FIG. 1;

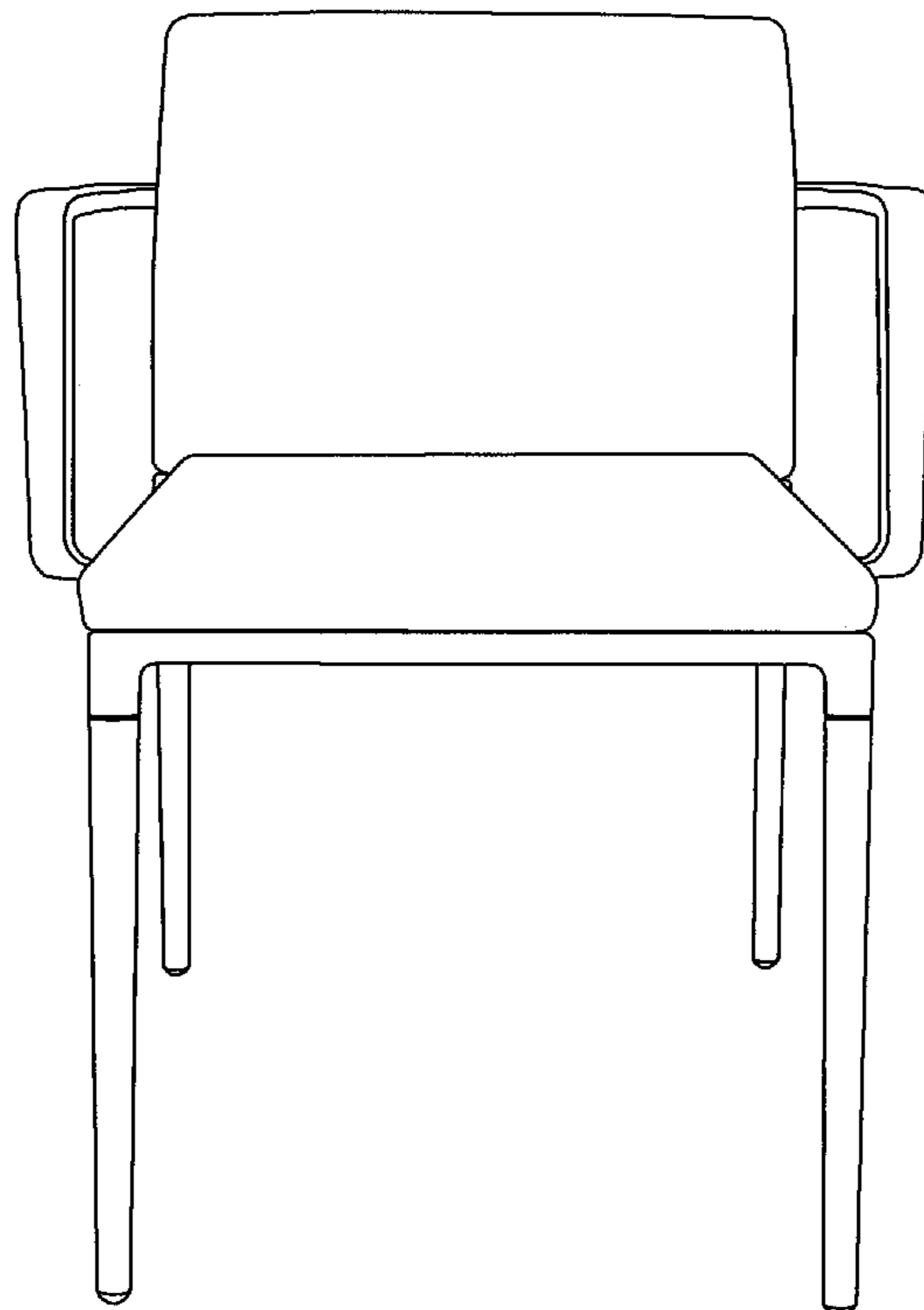
FIG. 3 is a left side perspective view of the chair of FIG. 1;

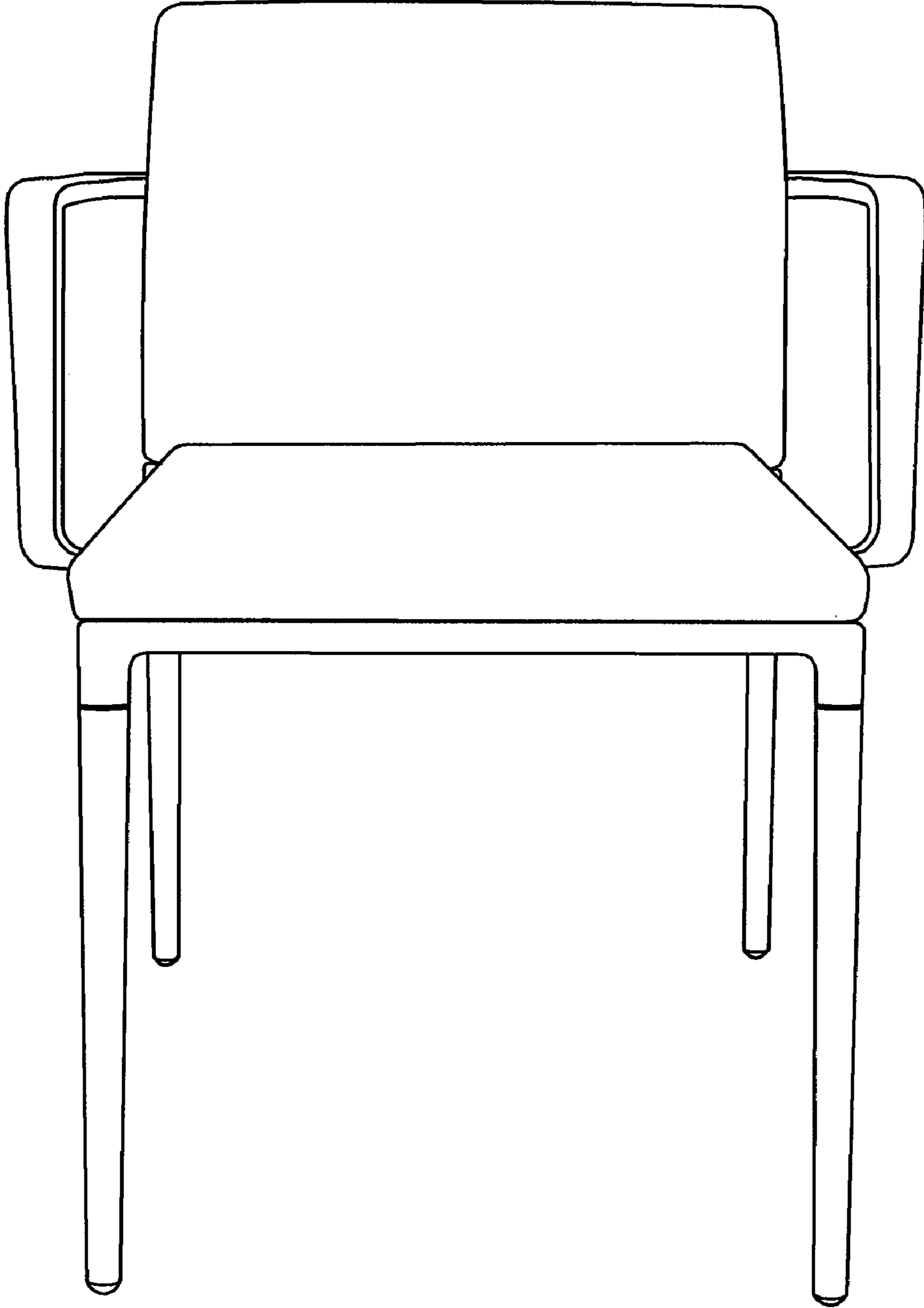

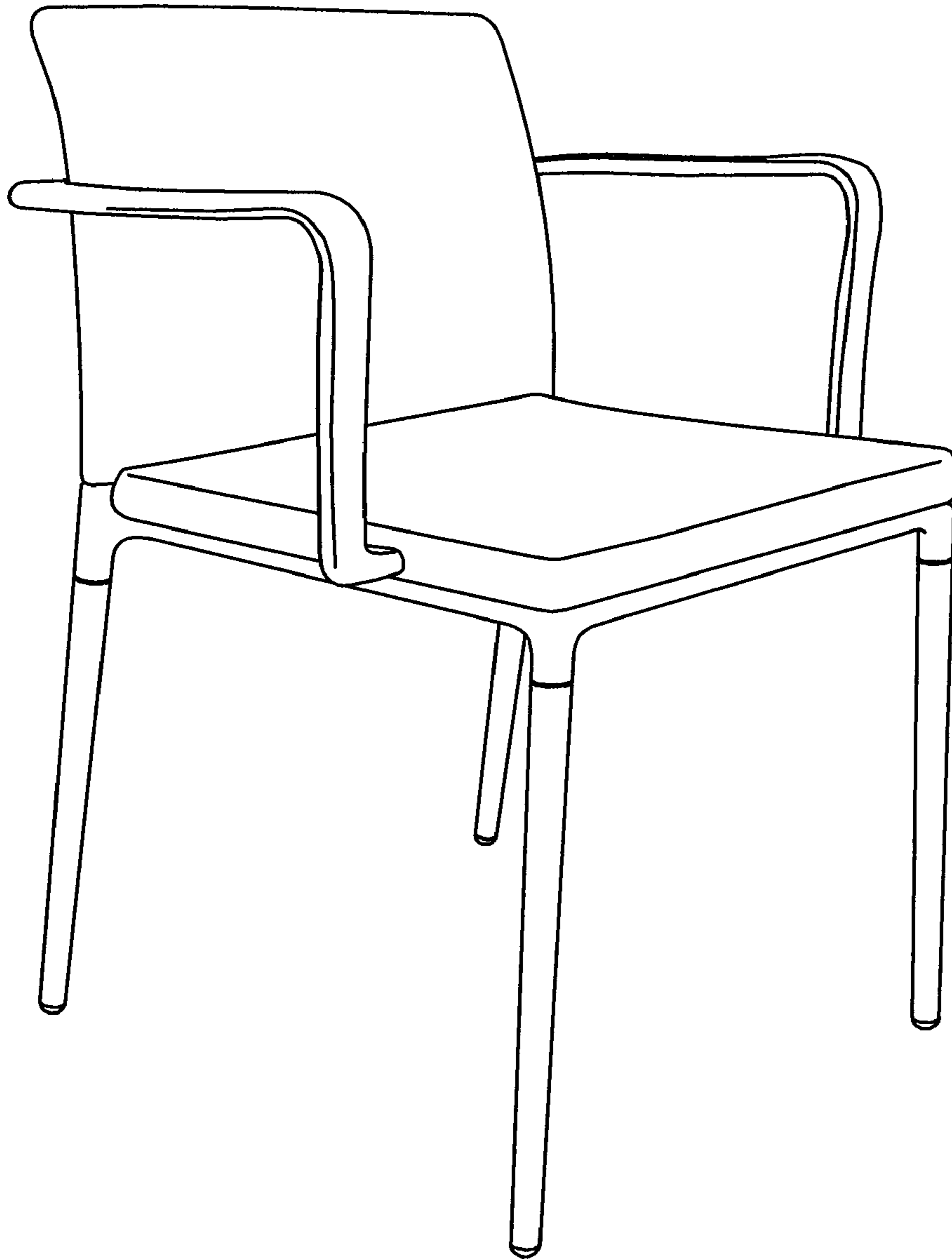

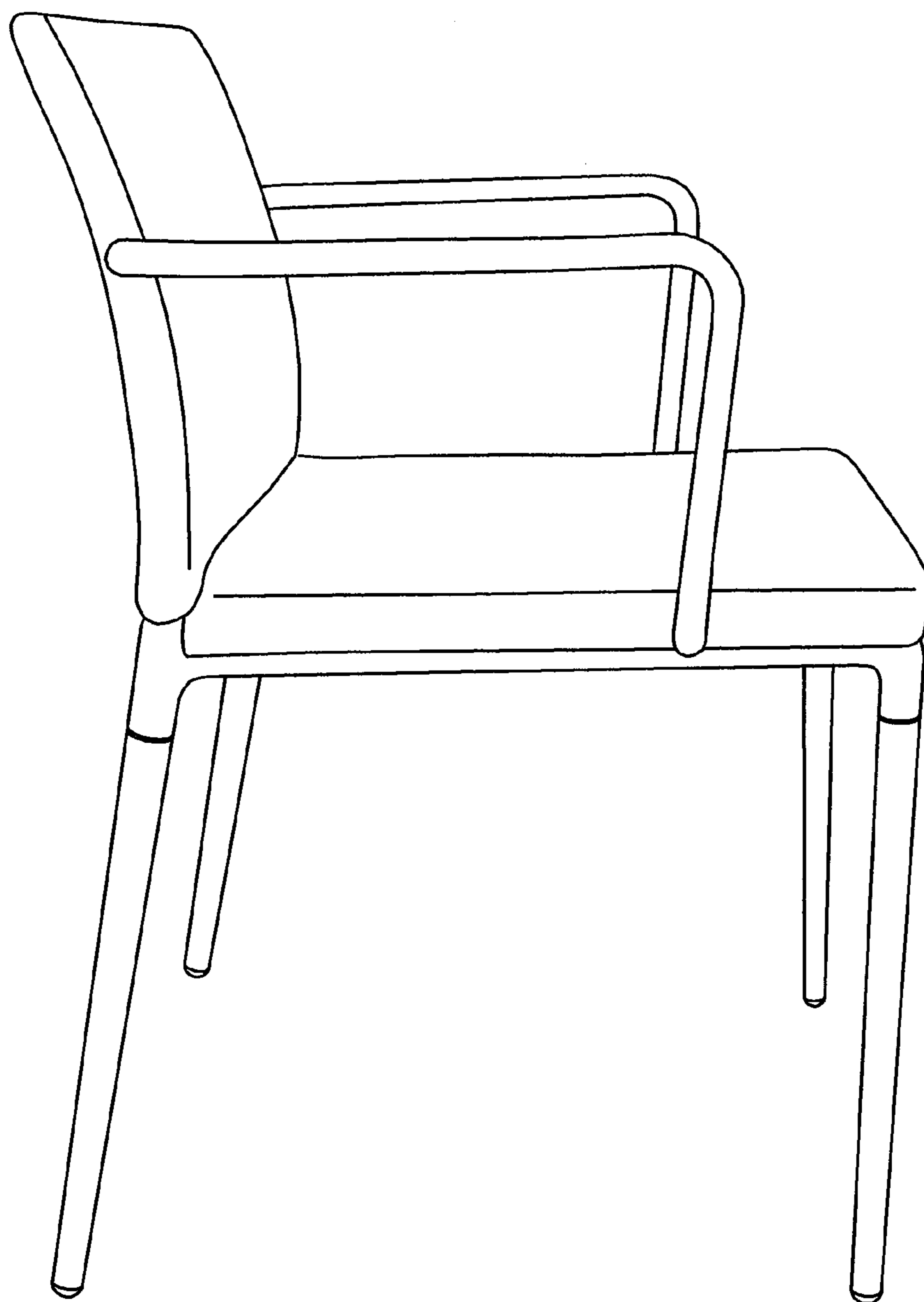

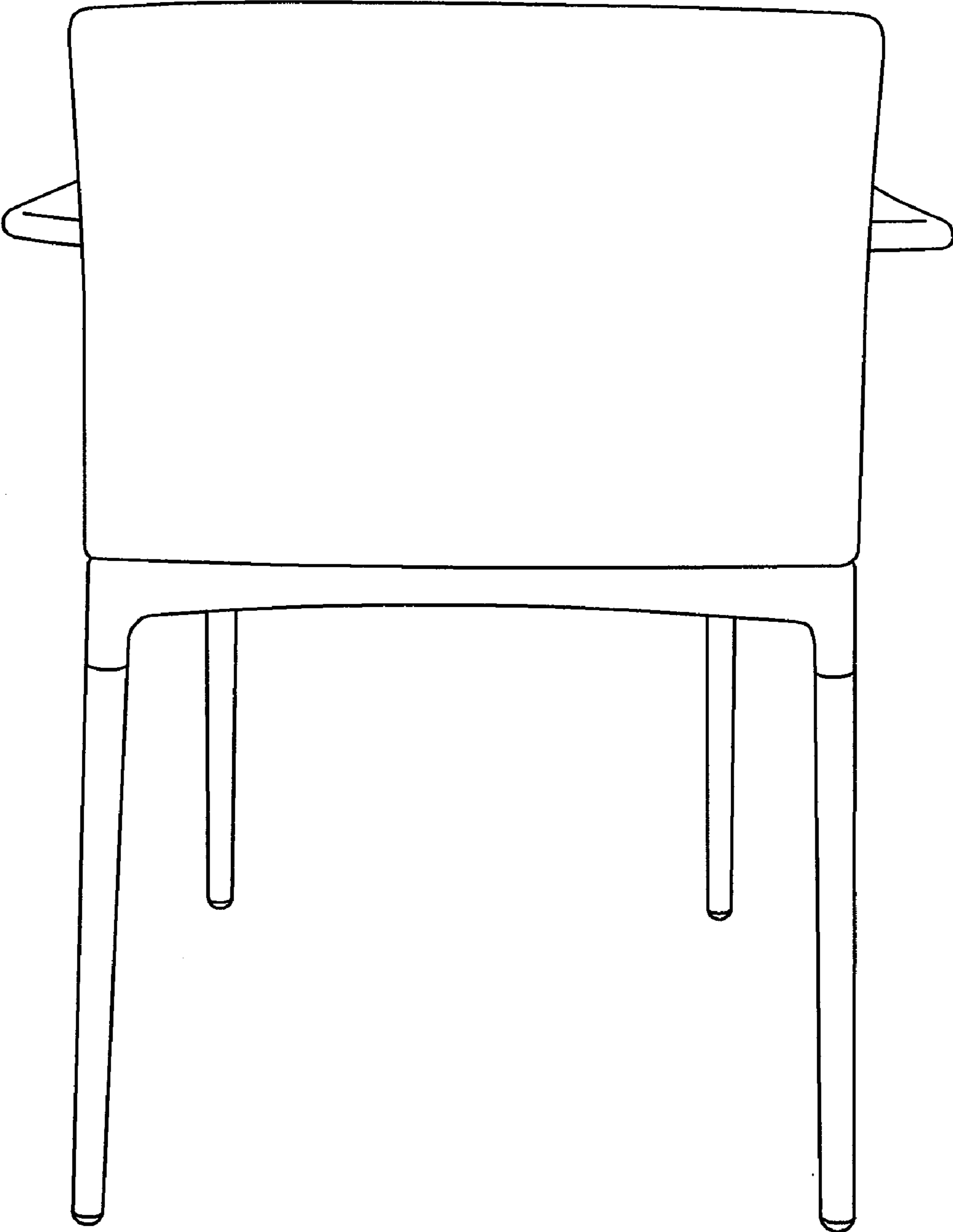

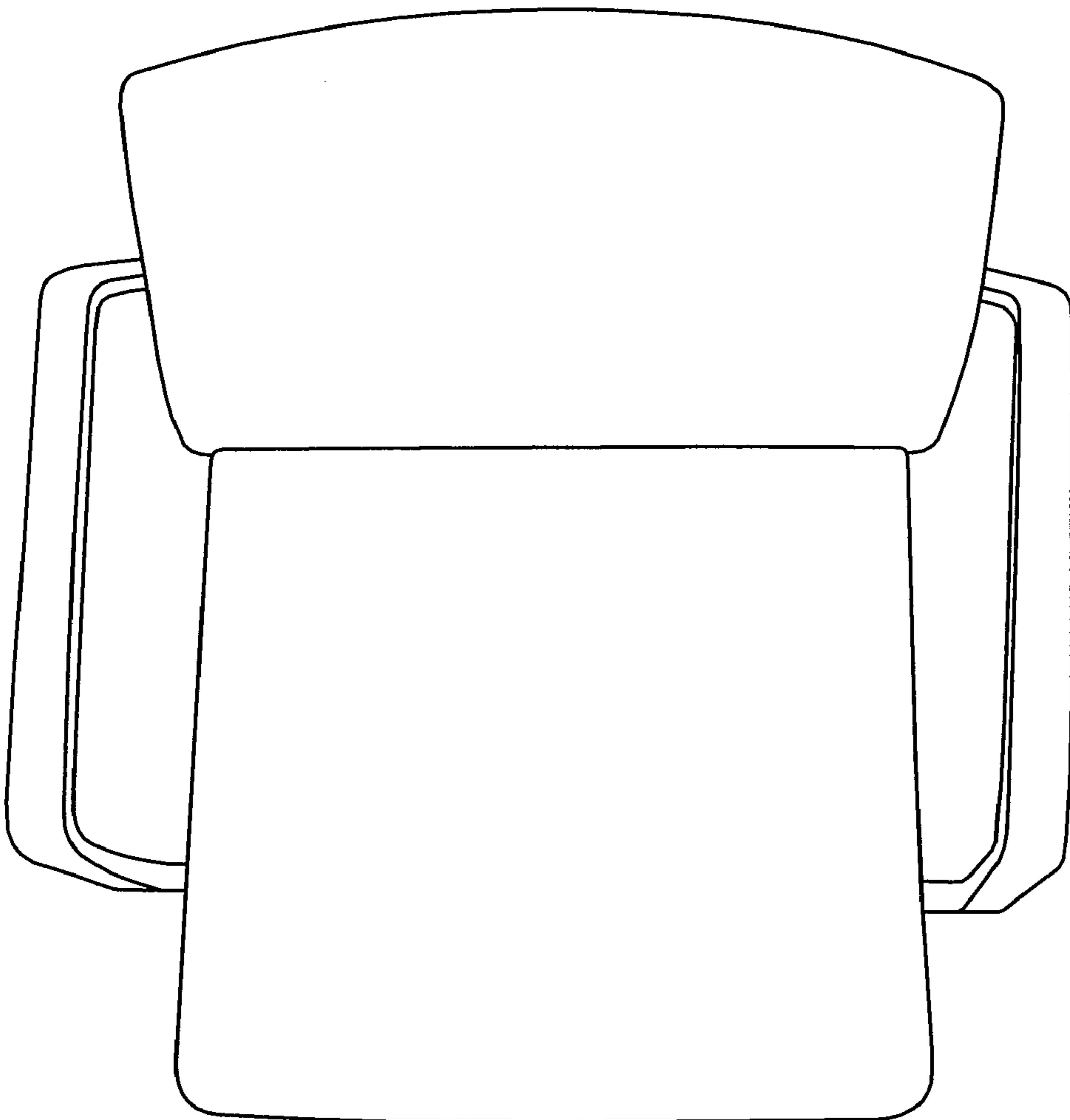

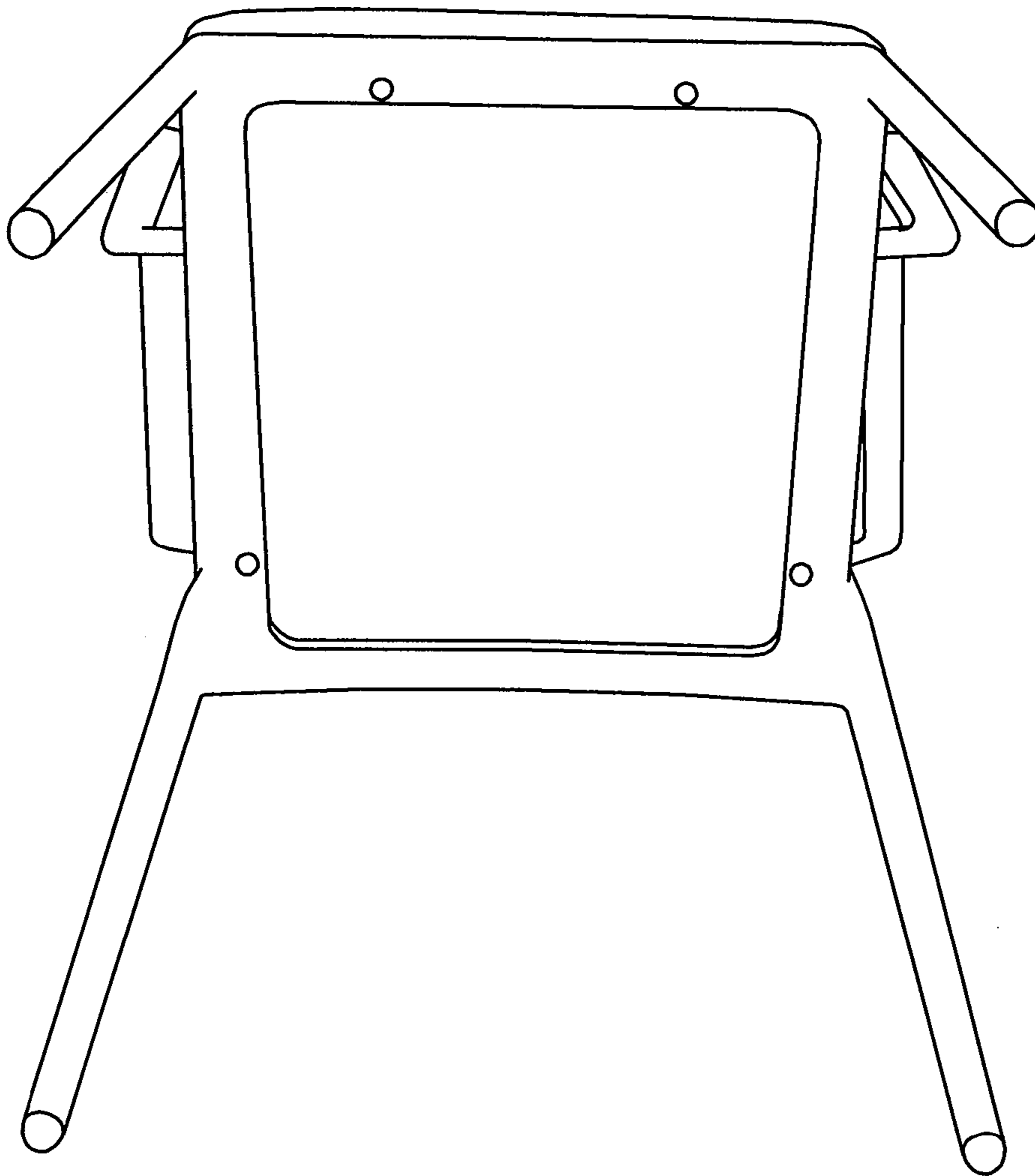
