**DESCRIPTION**

9;

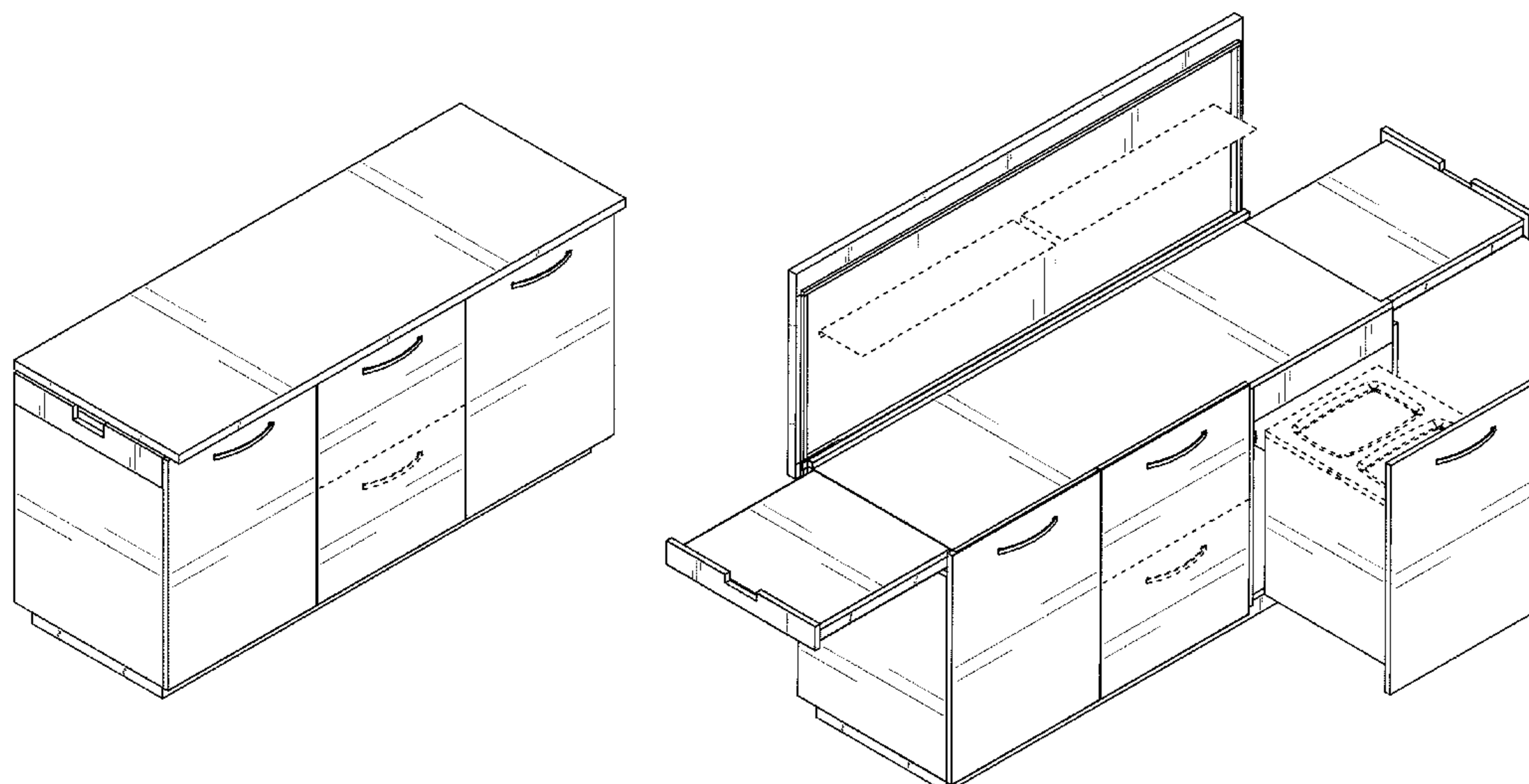
FIG. 14 is an opposite side elevation of the food service

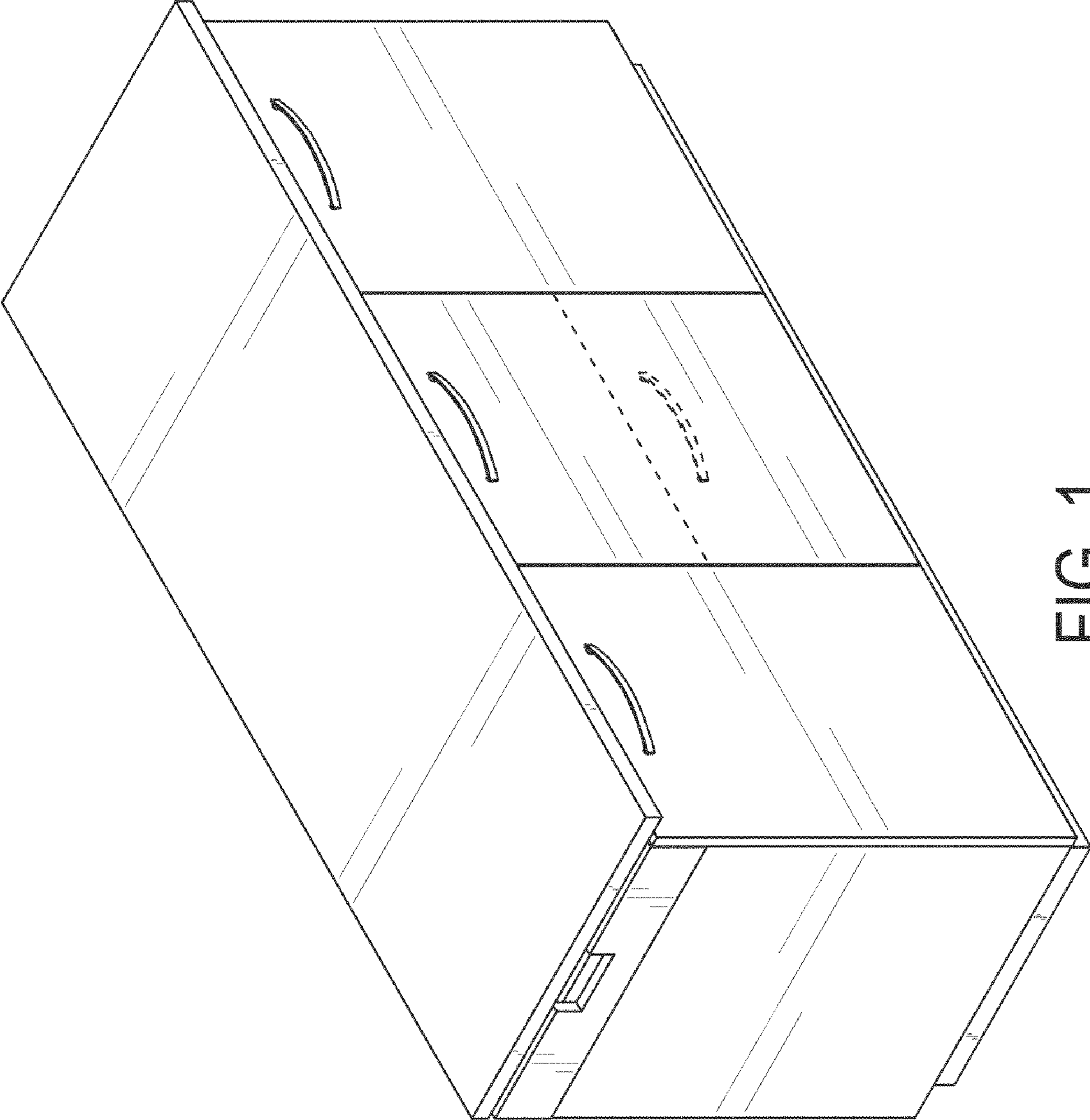

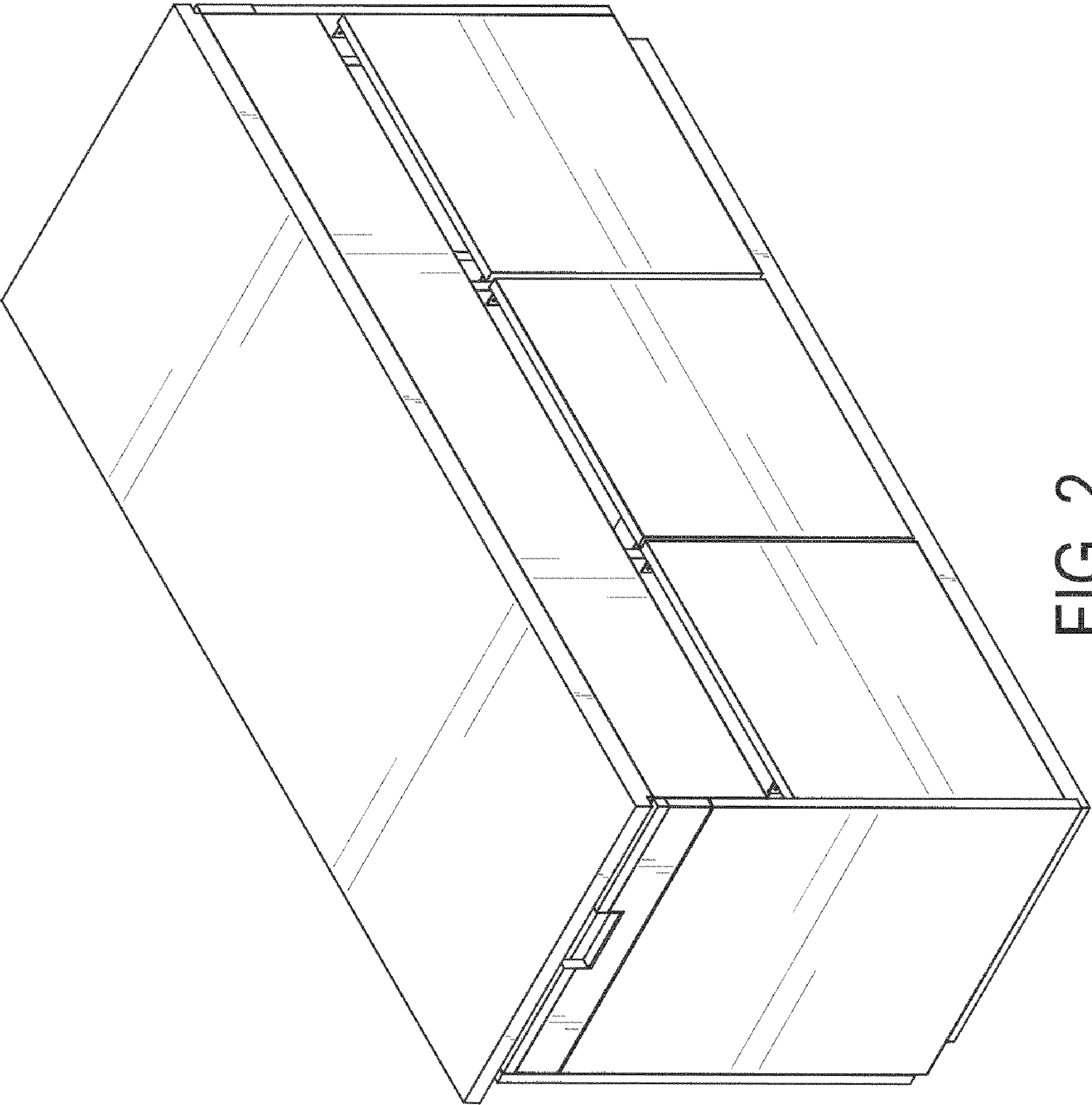

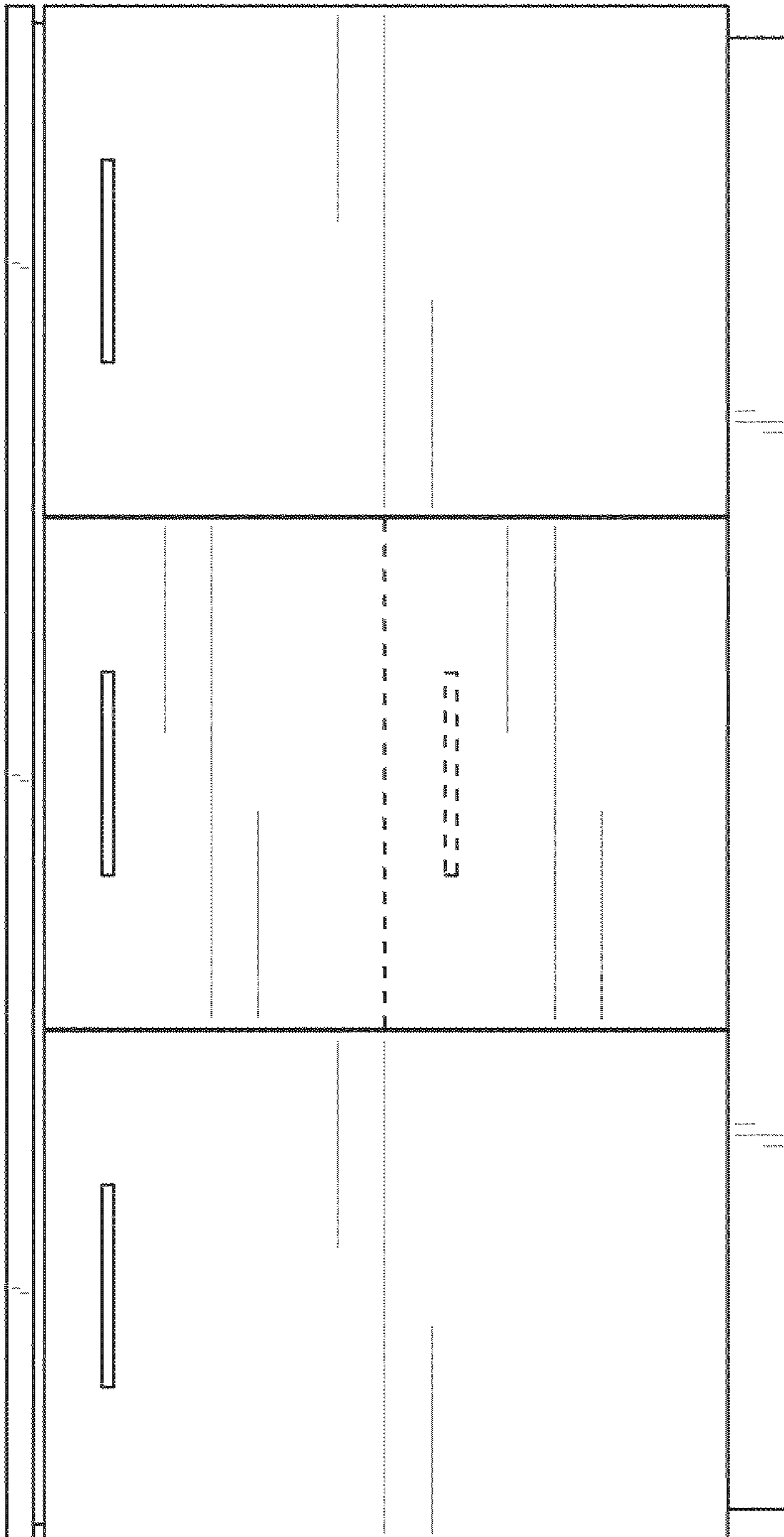

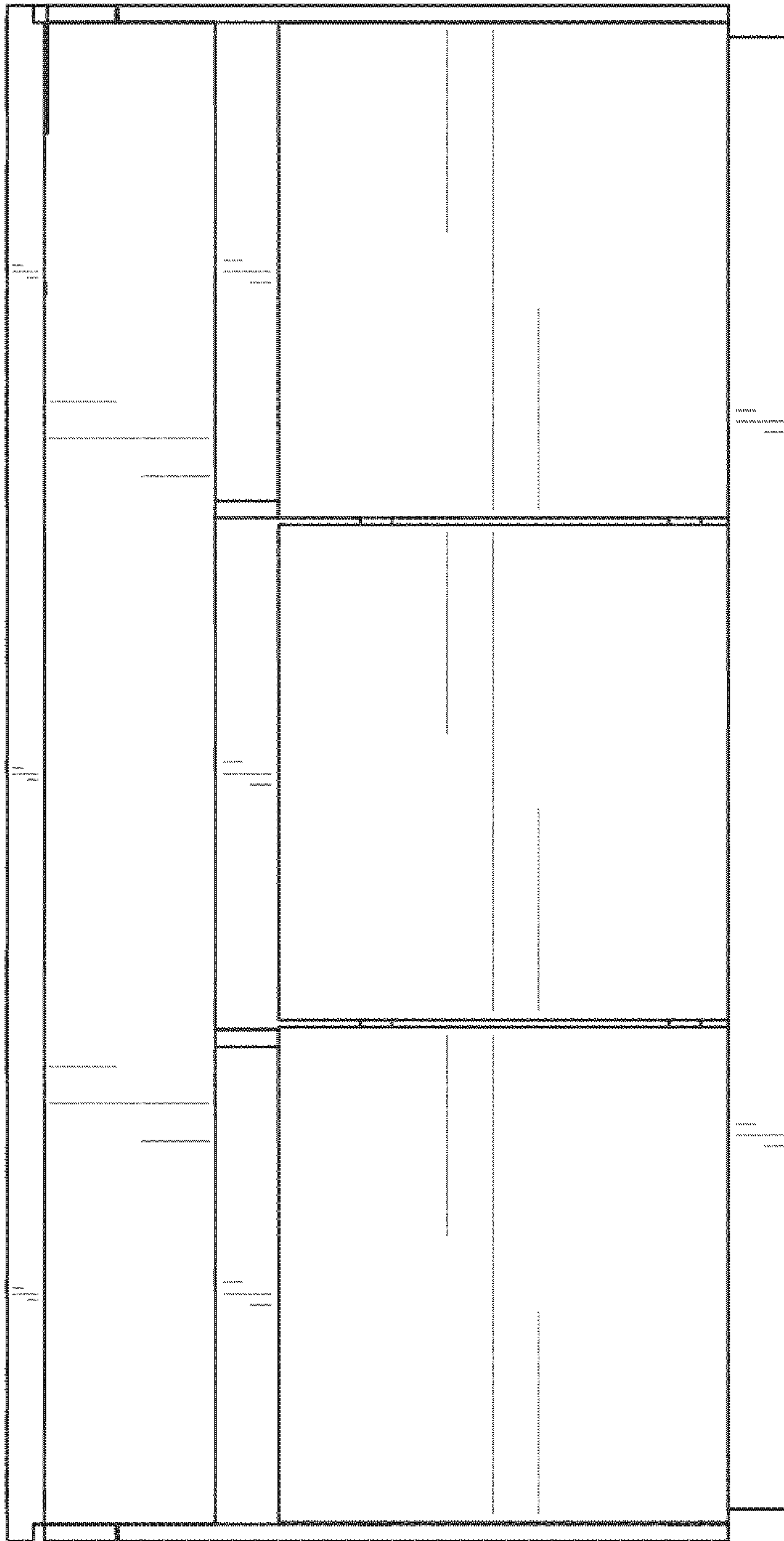

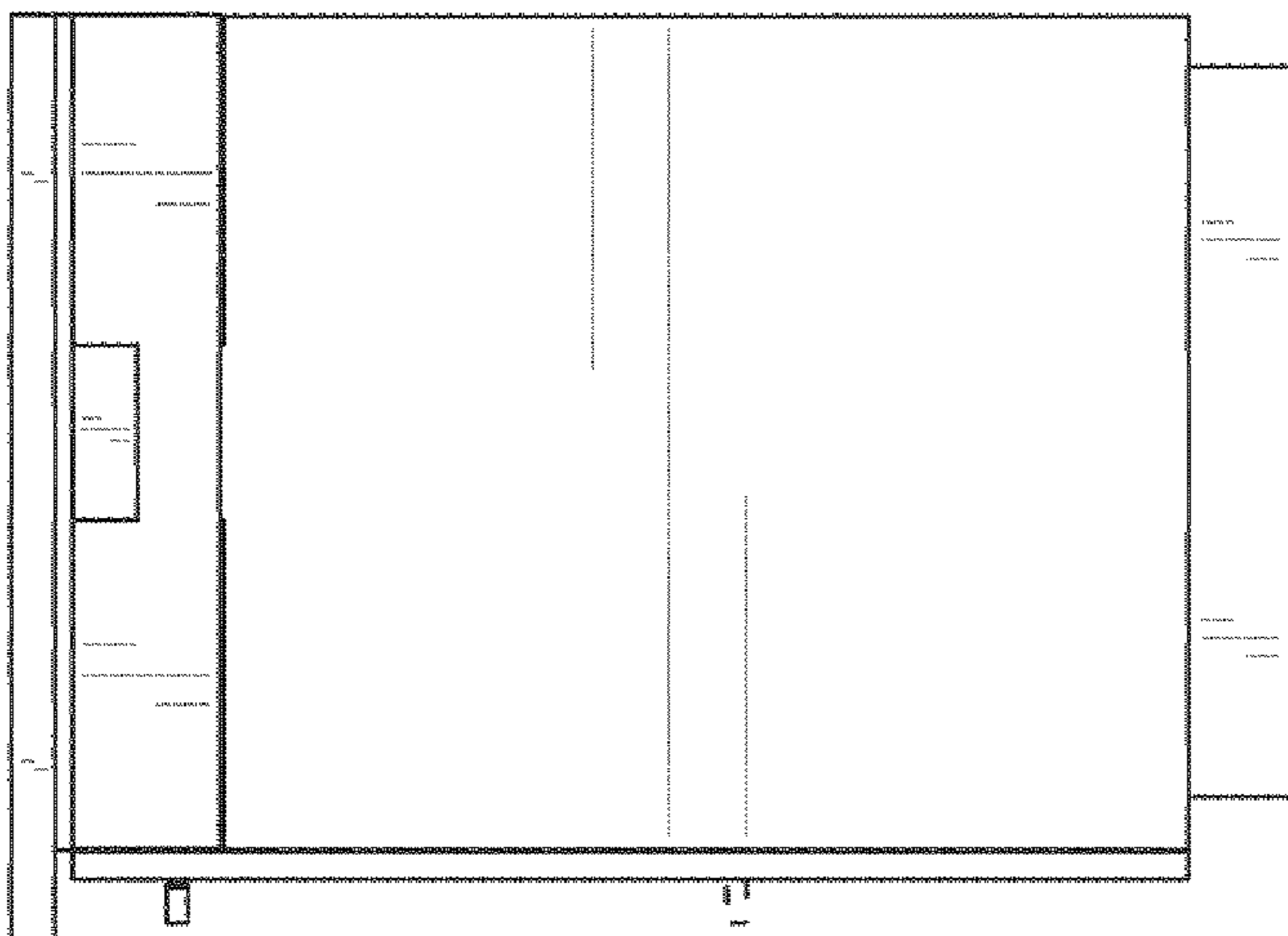

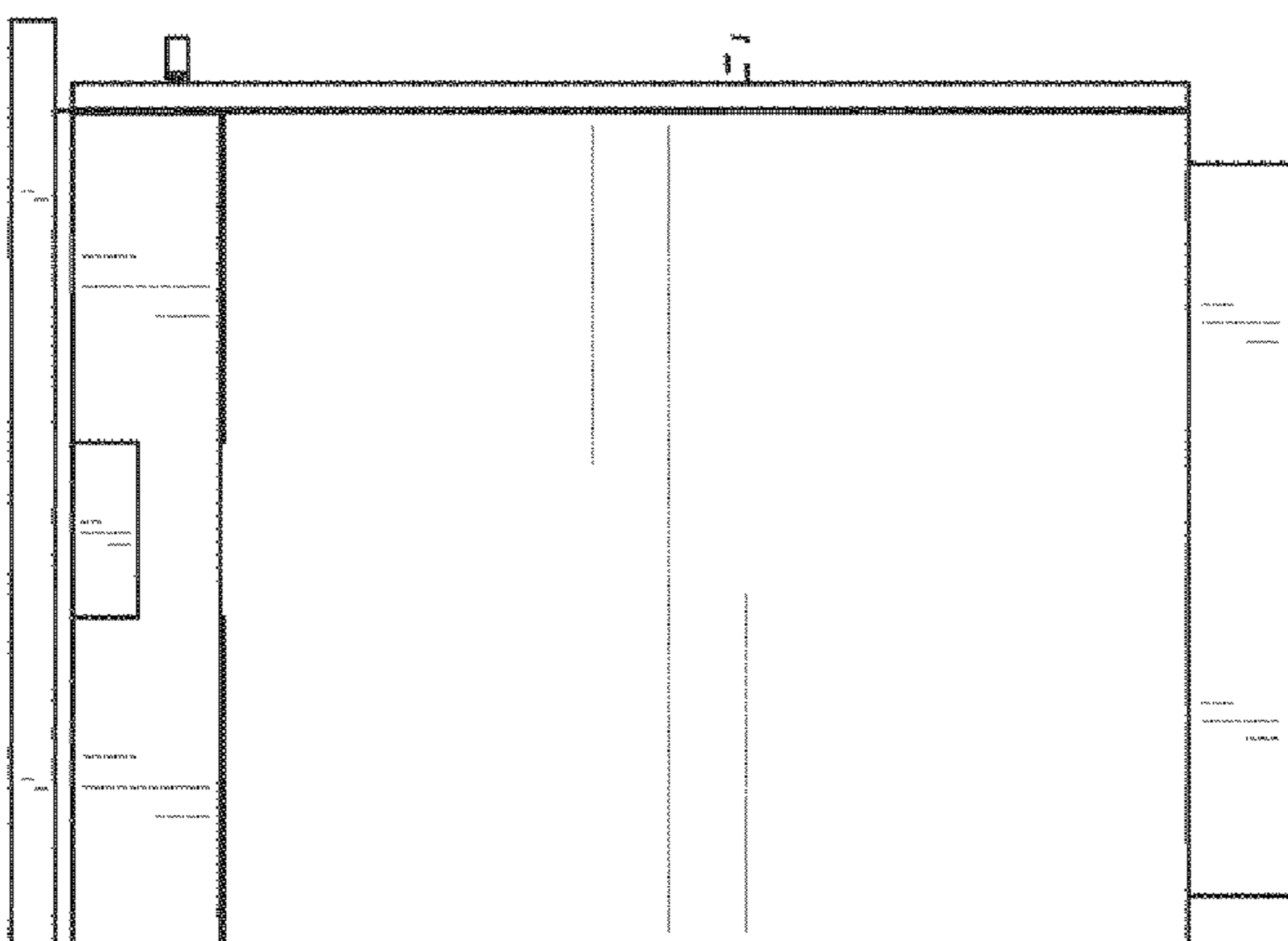

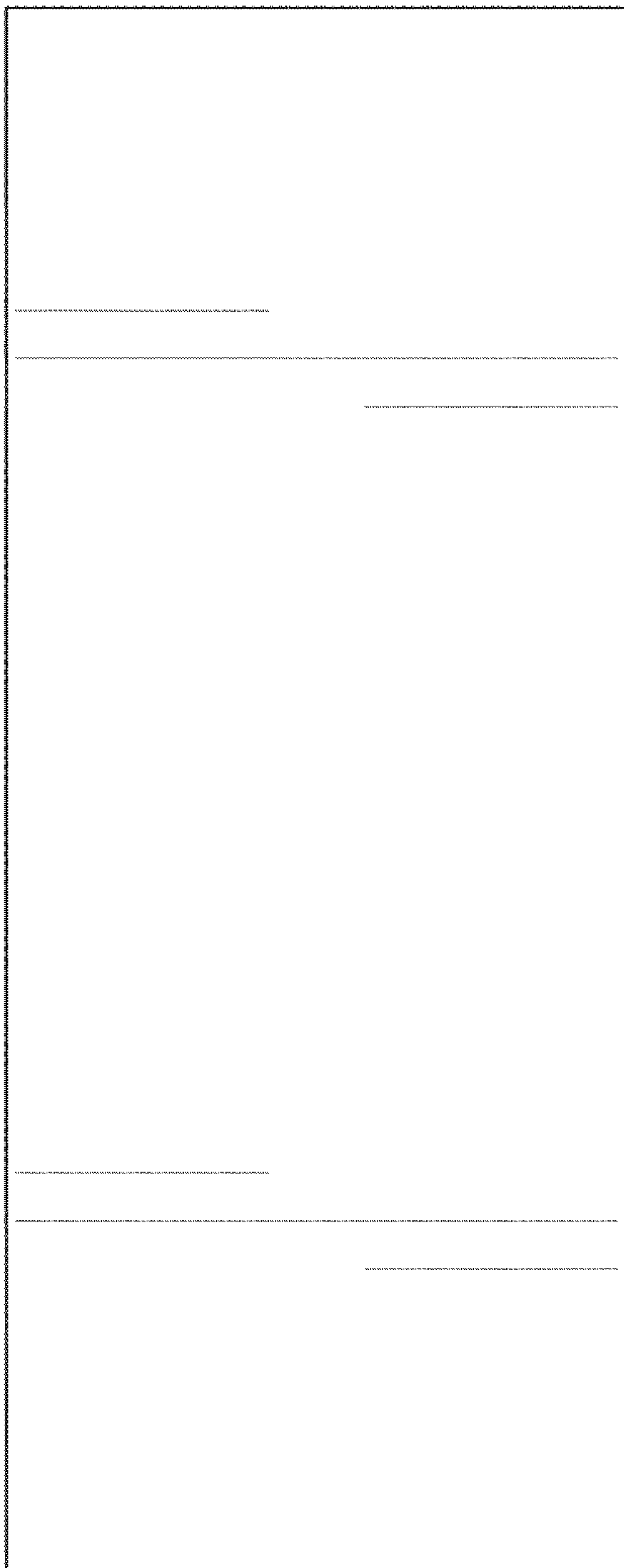

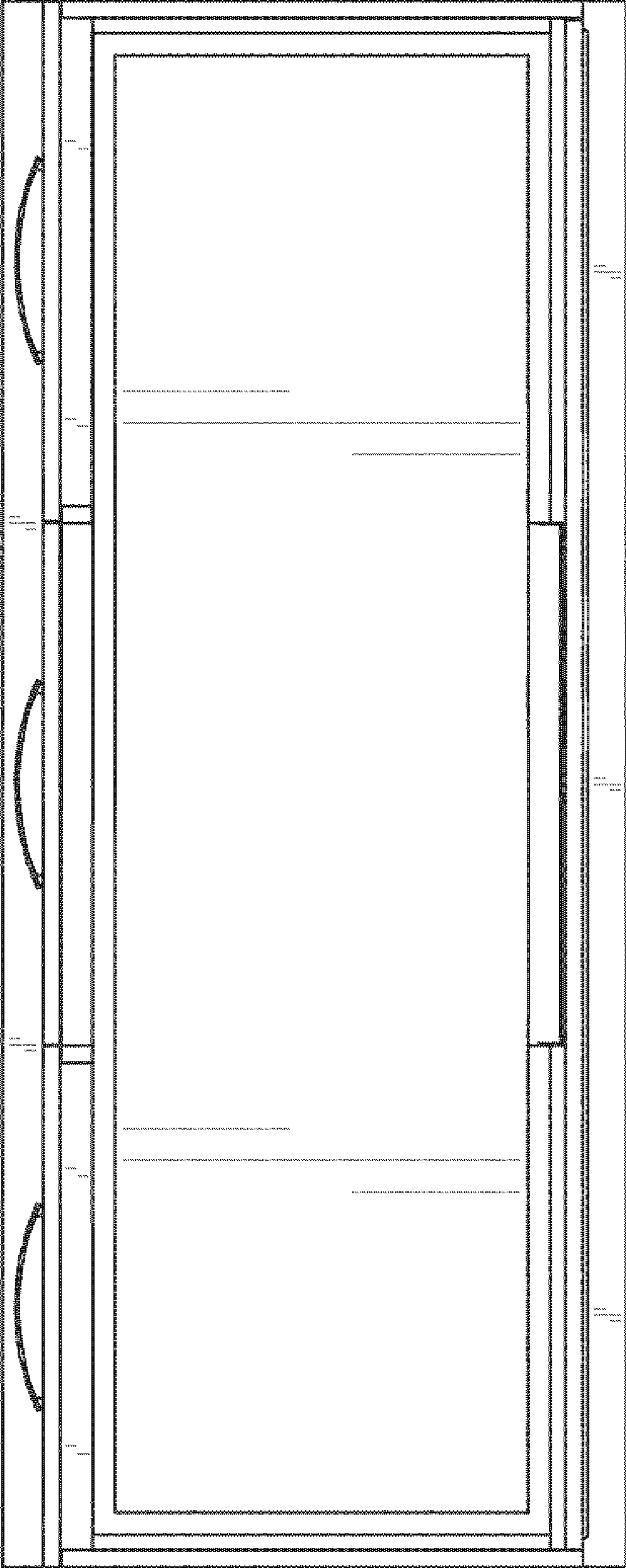

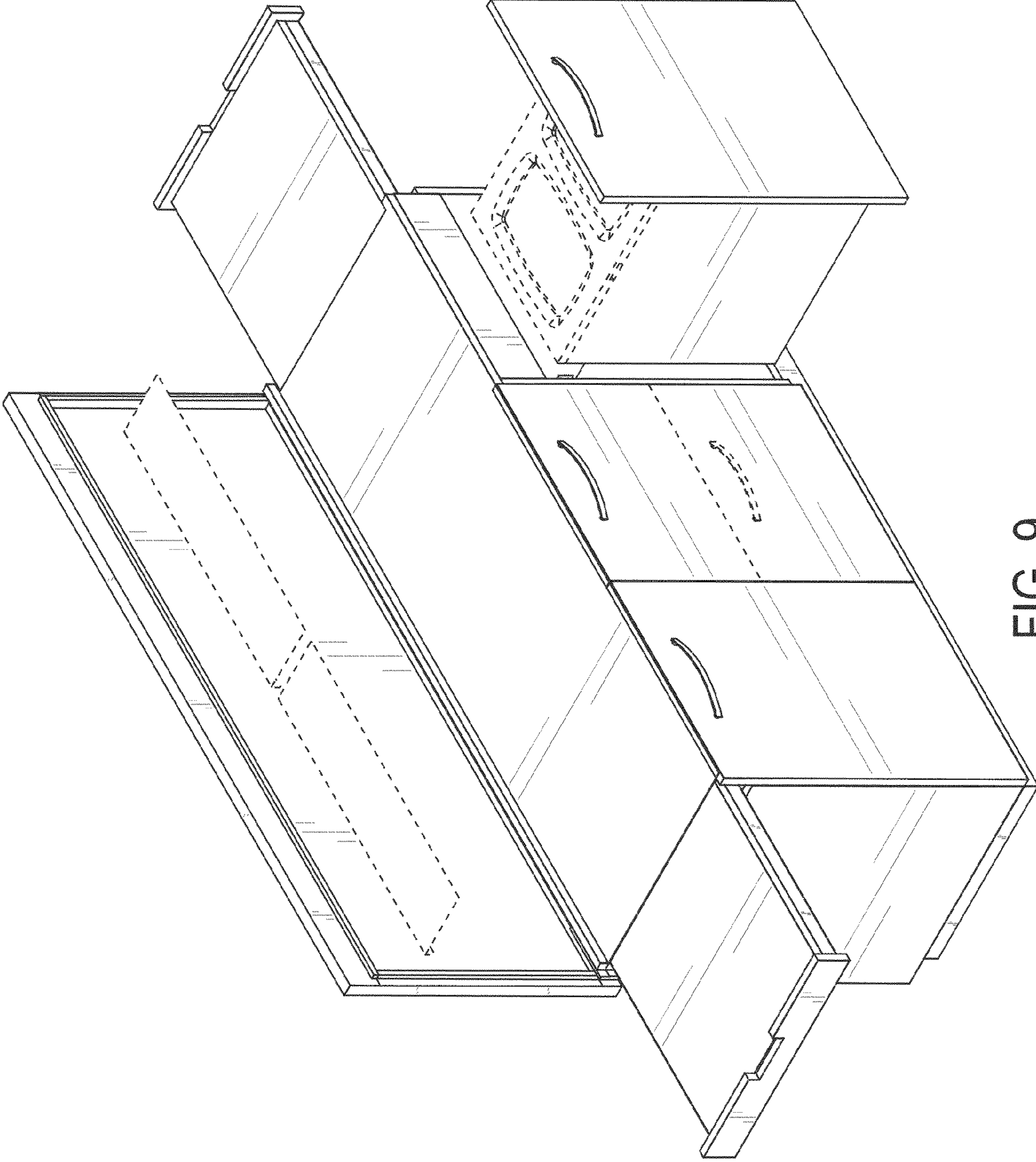

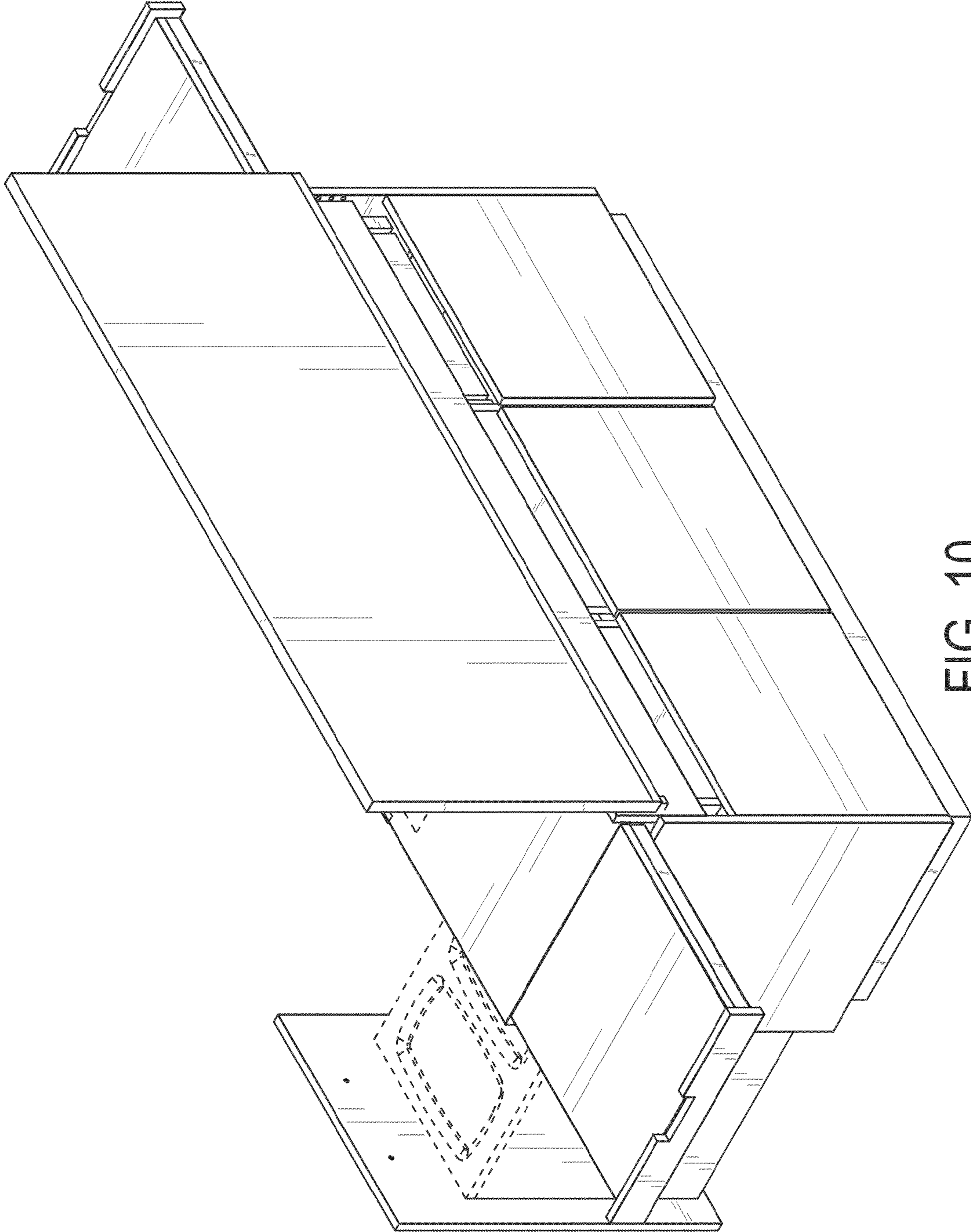

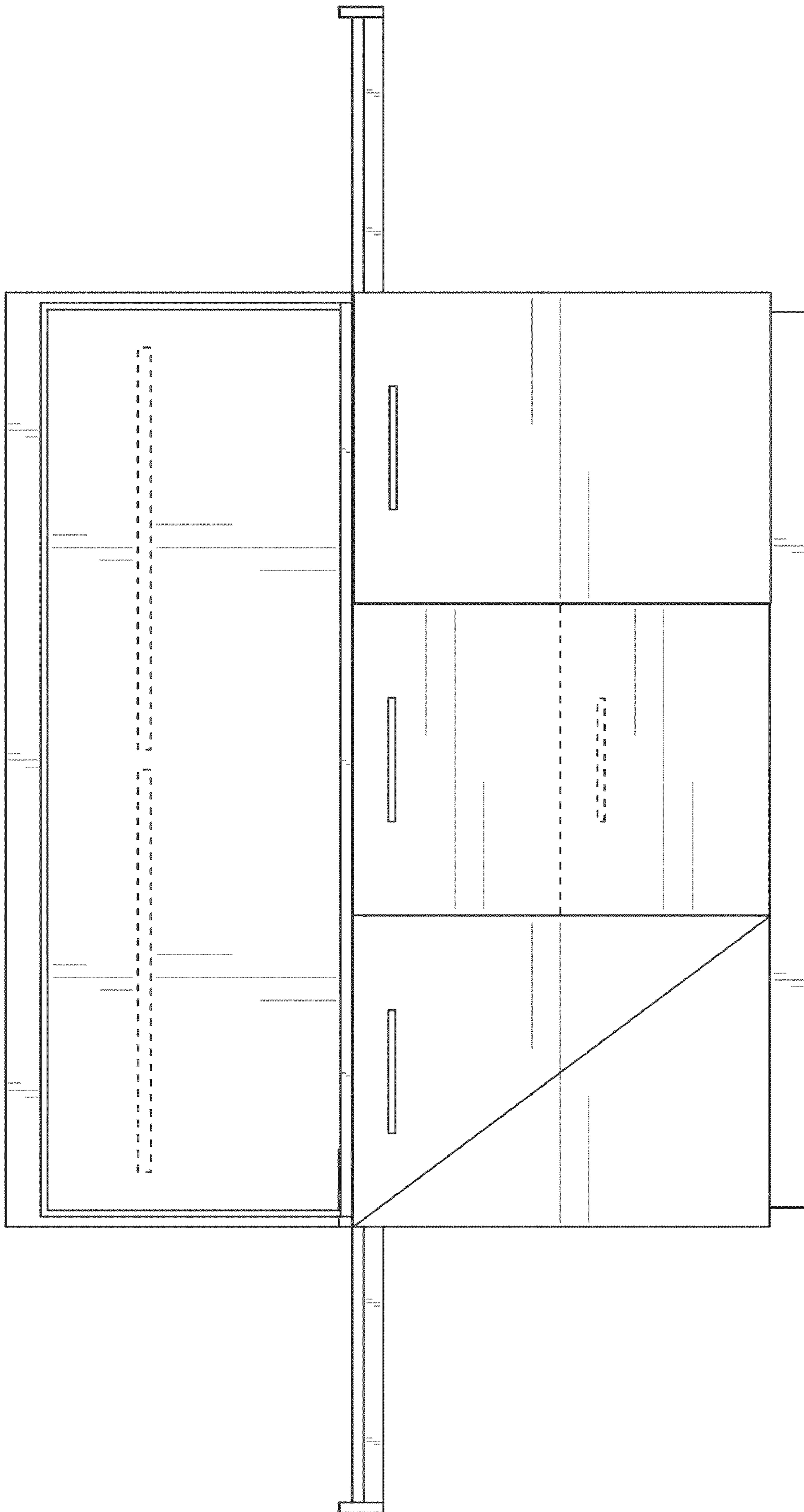

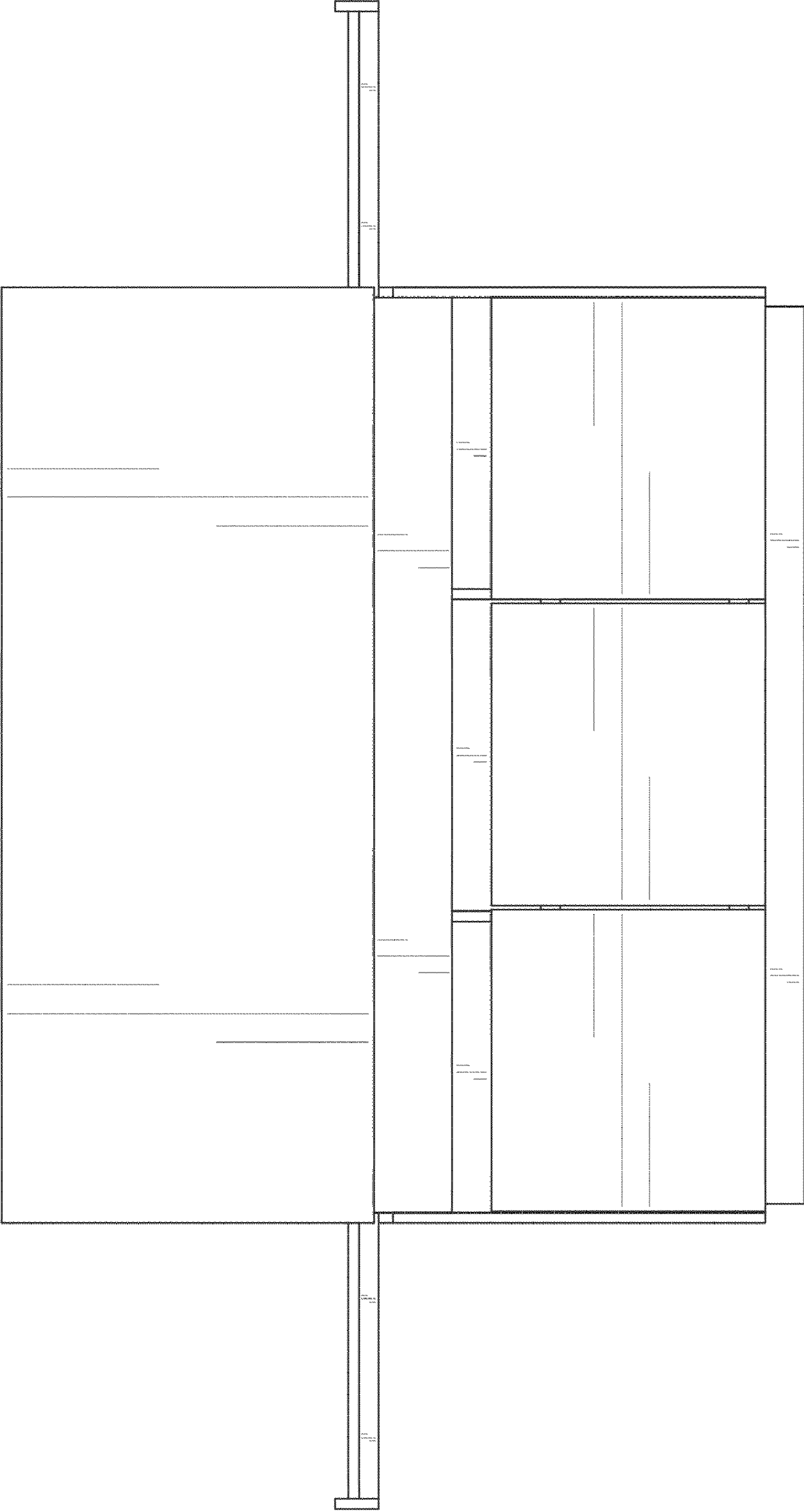

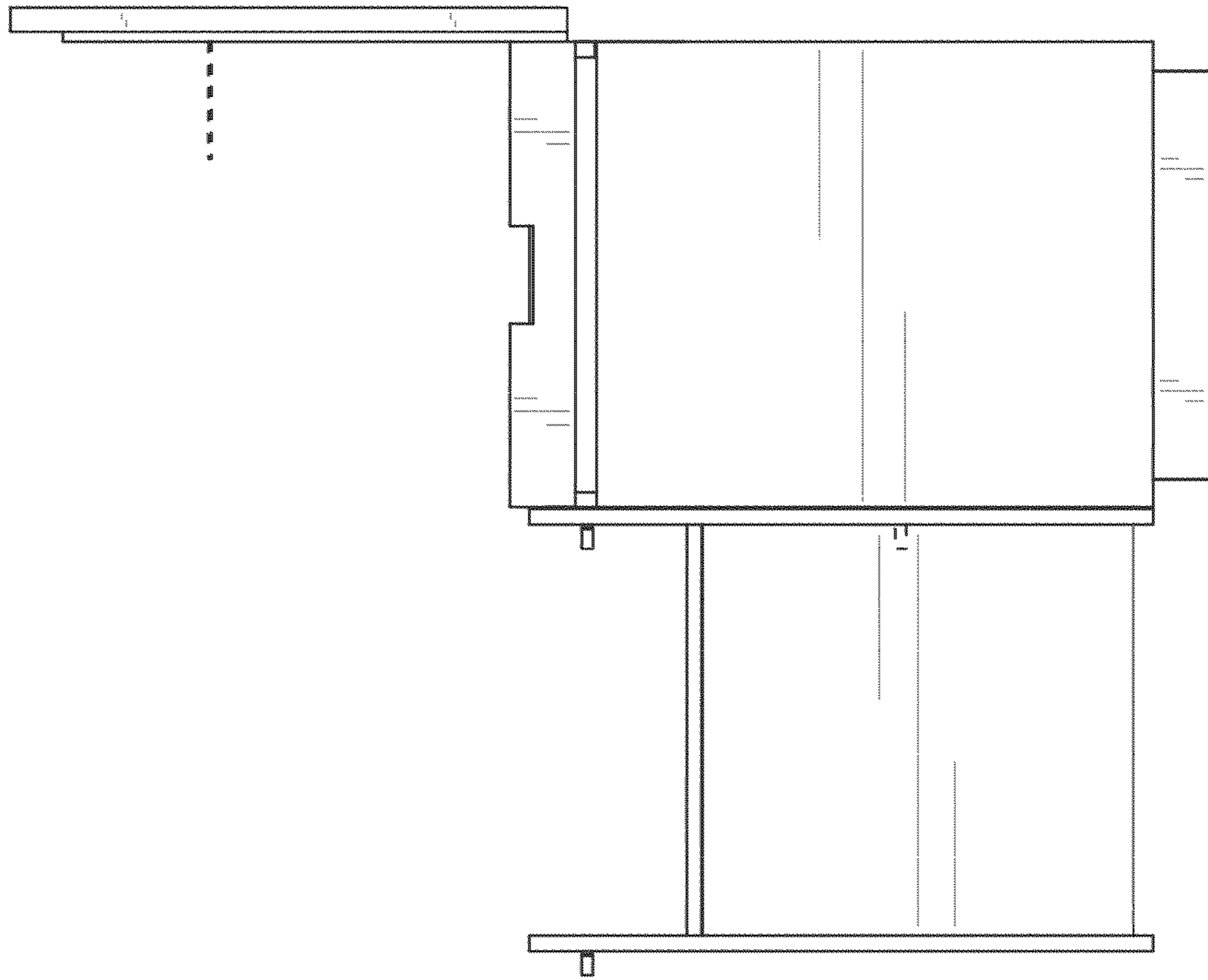

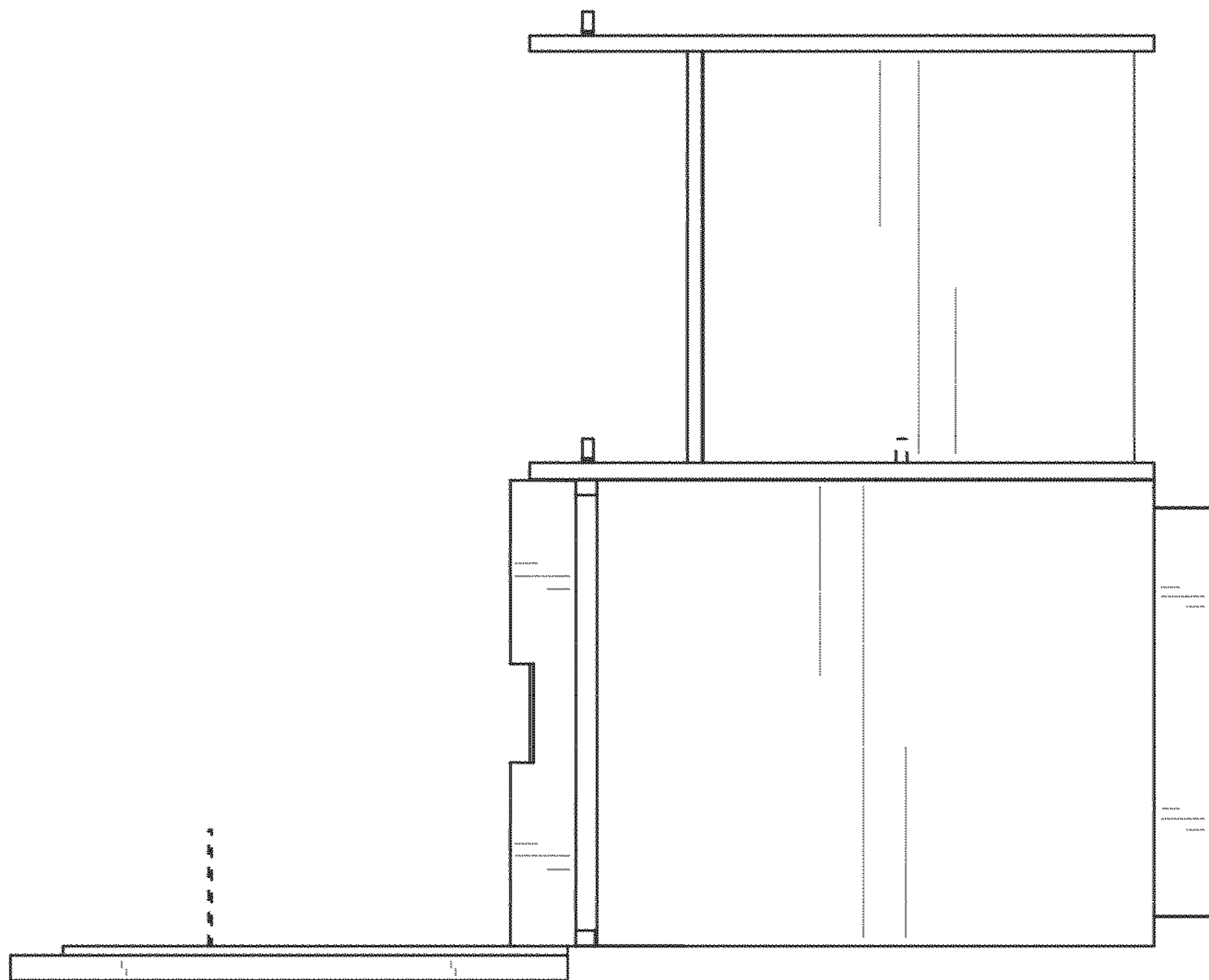

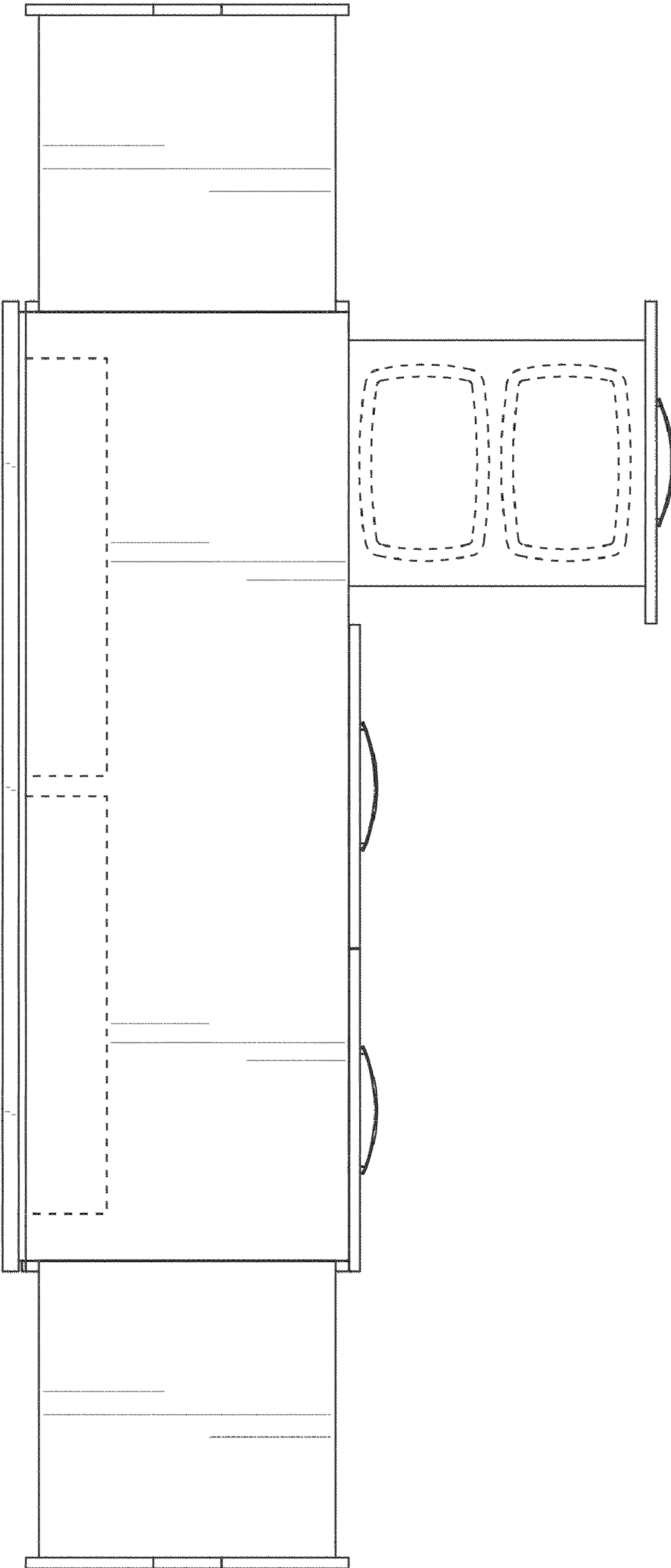

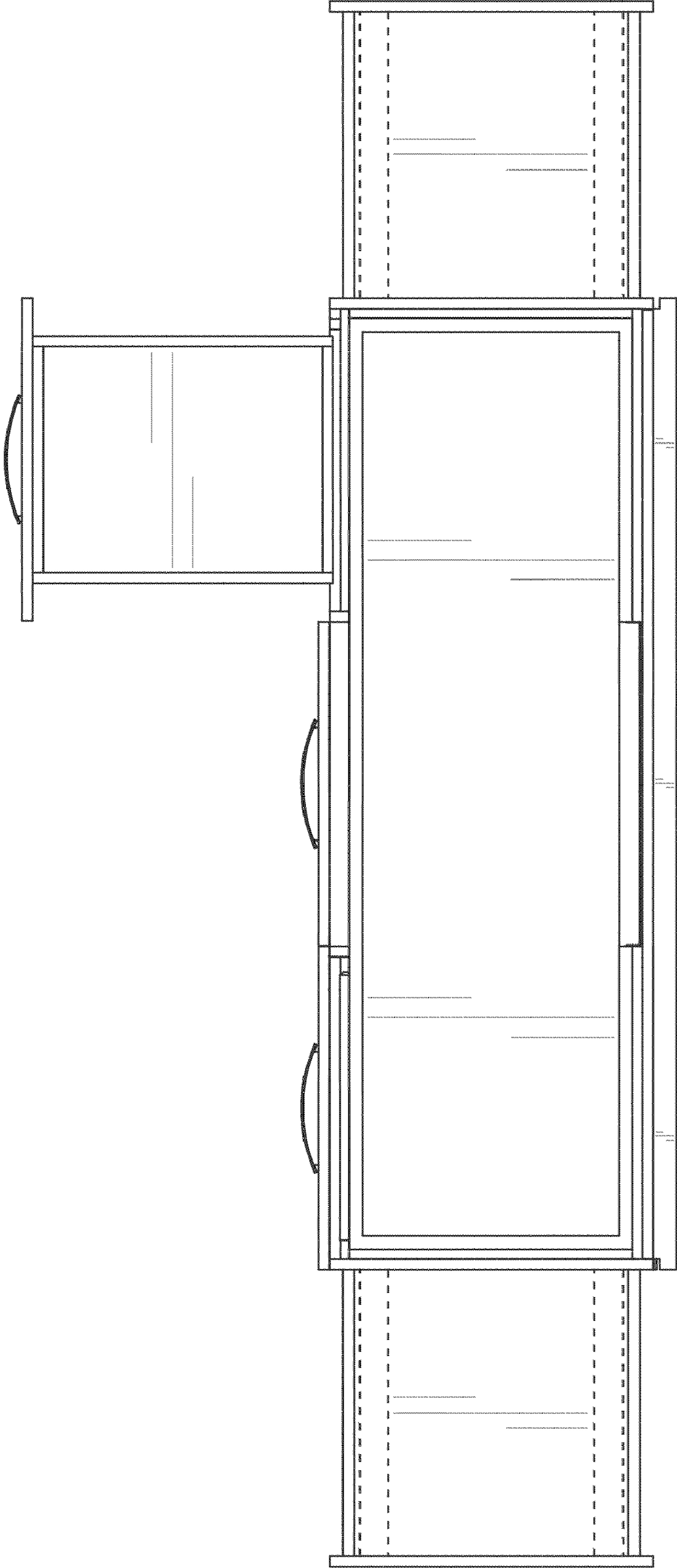
