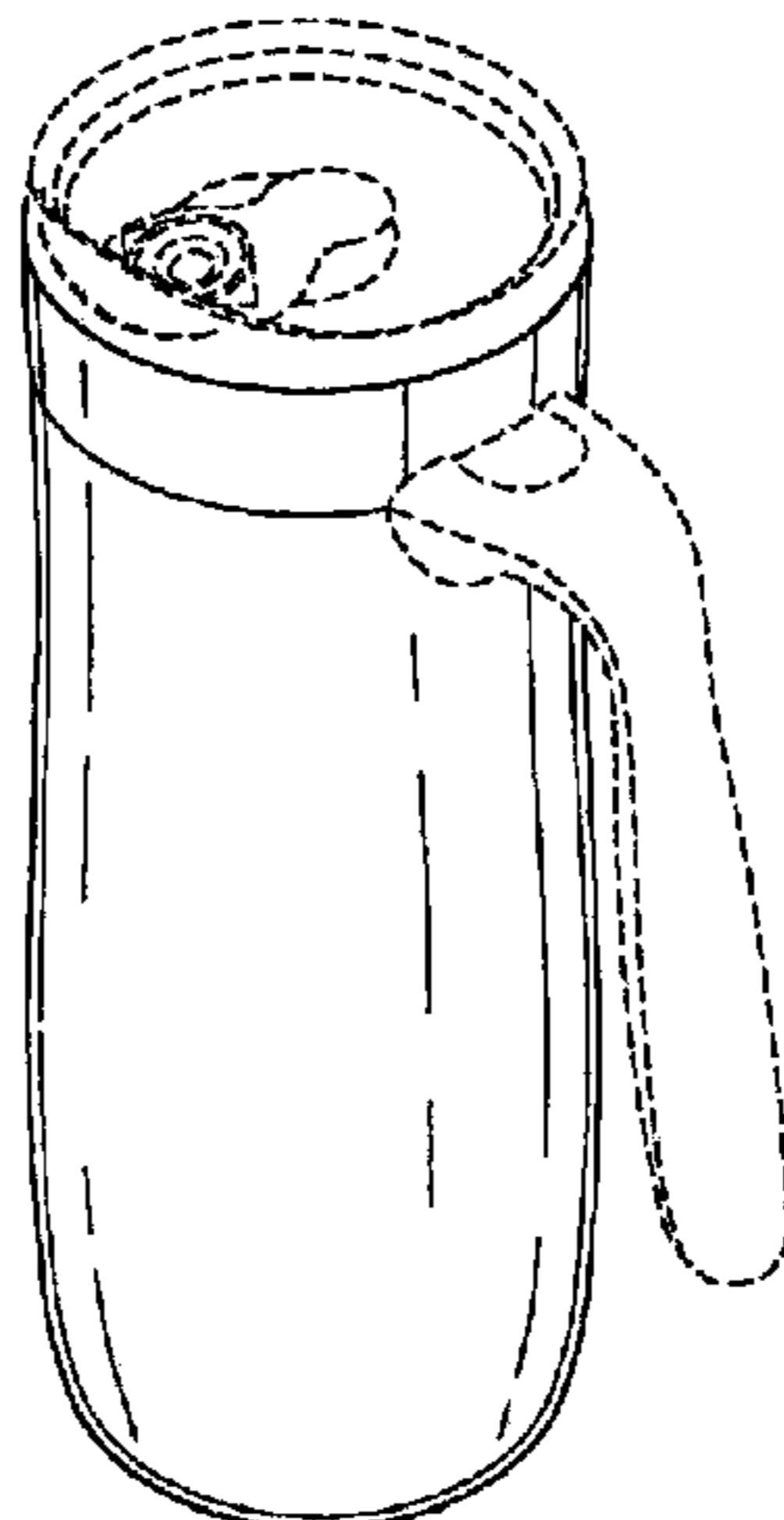
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top right side isometric view of a beverage container showing our new design.
FIG. 2 is a front elevational view thereof.
FIG. 3 is a rear elevational view thereof.
FIG. 4 is a right side elevational view thereof.
FIG. 5 is a left side elevational view thereof.
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

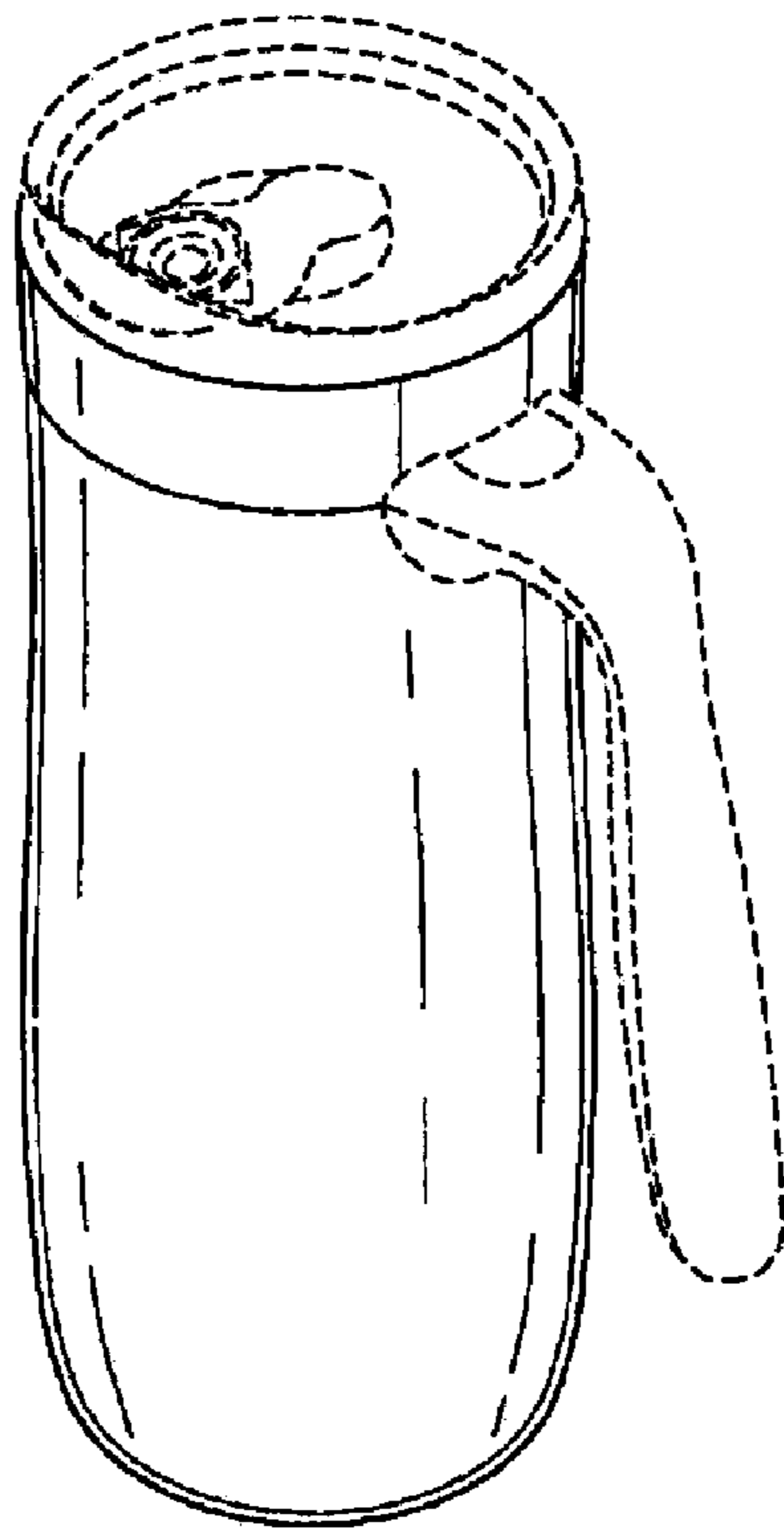

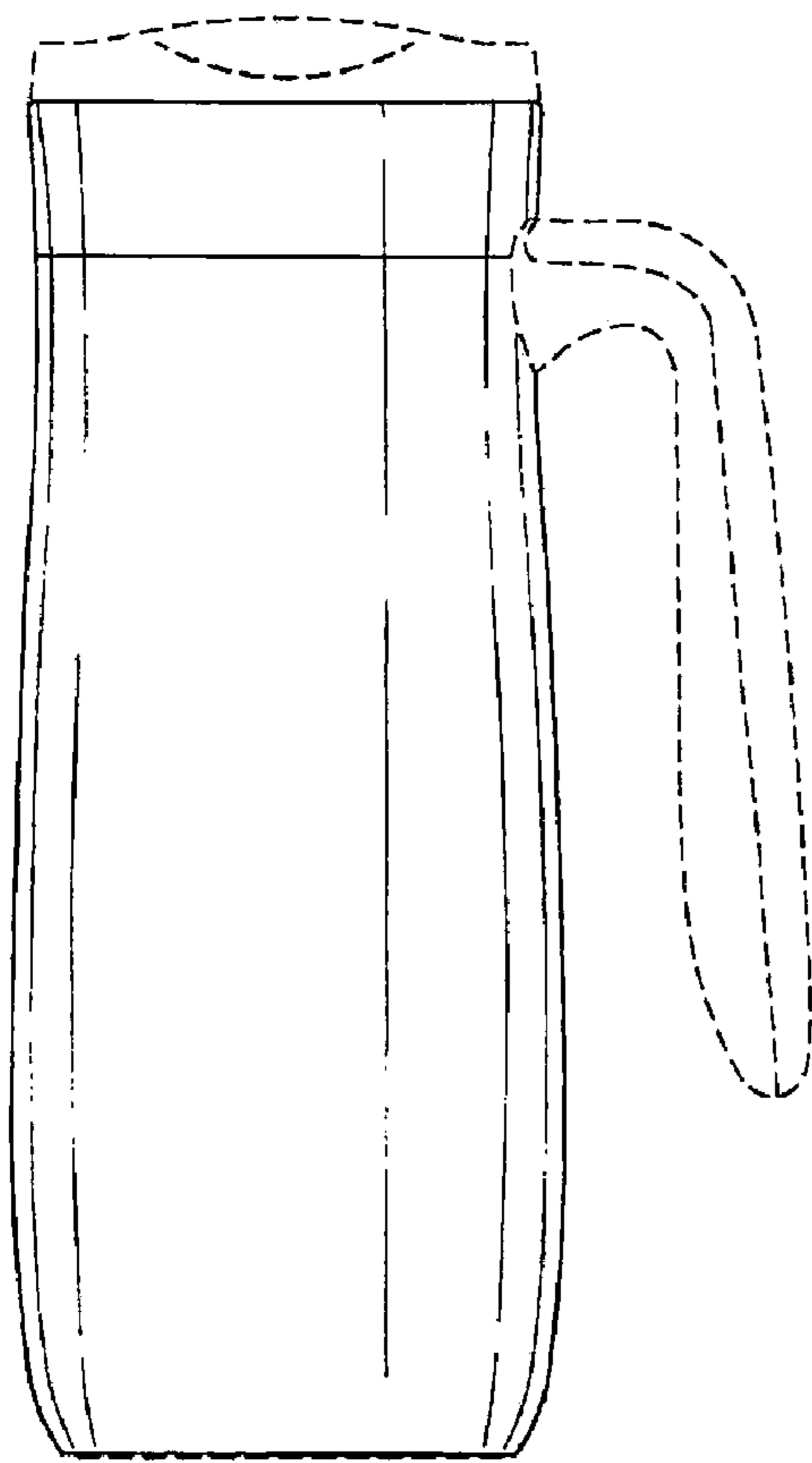

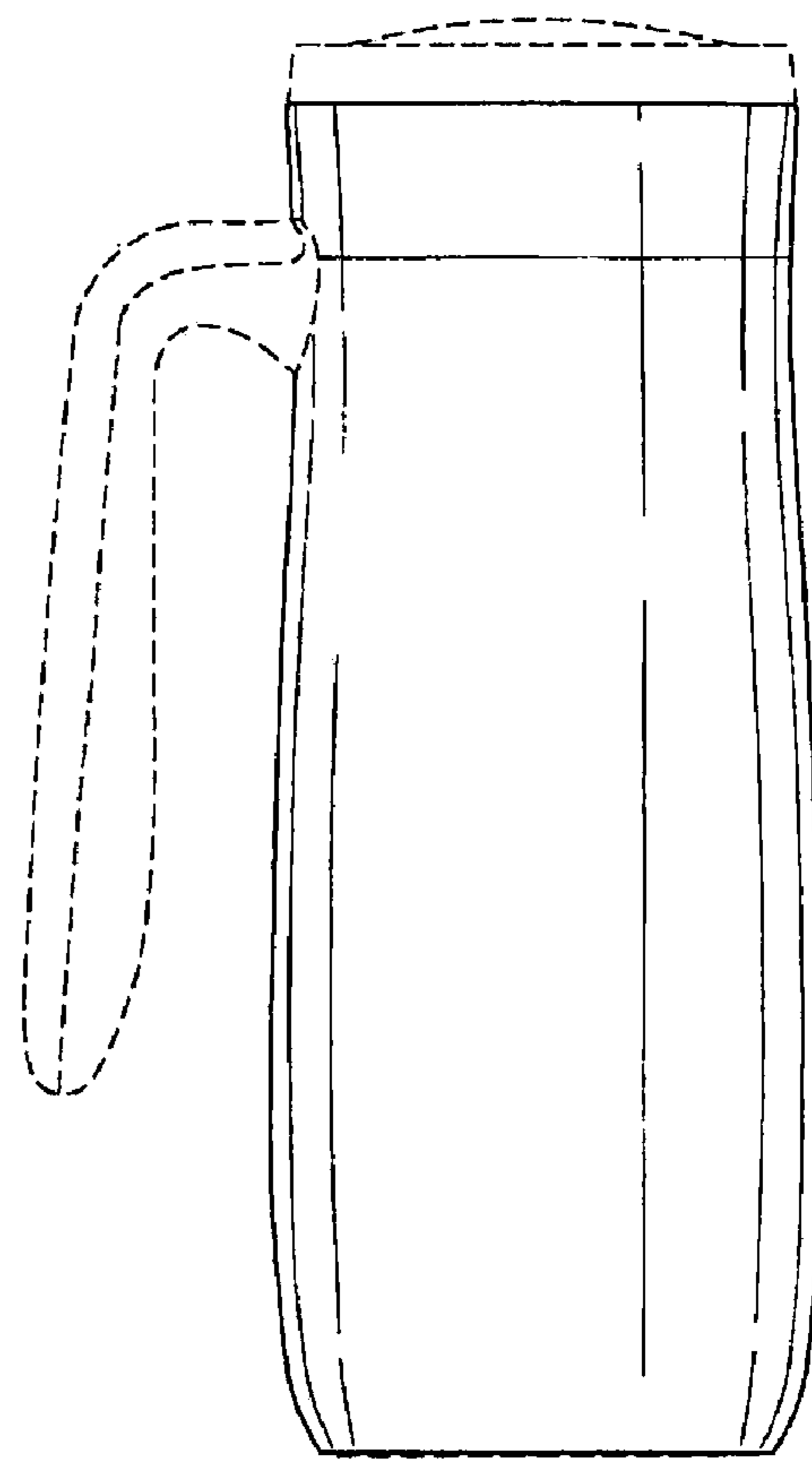

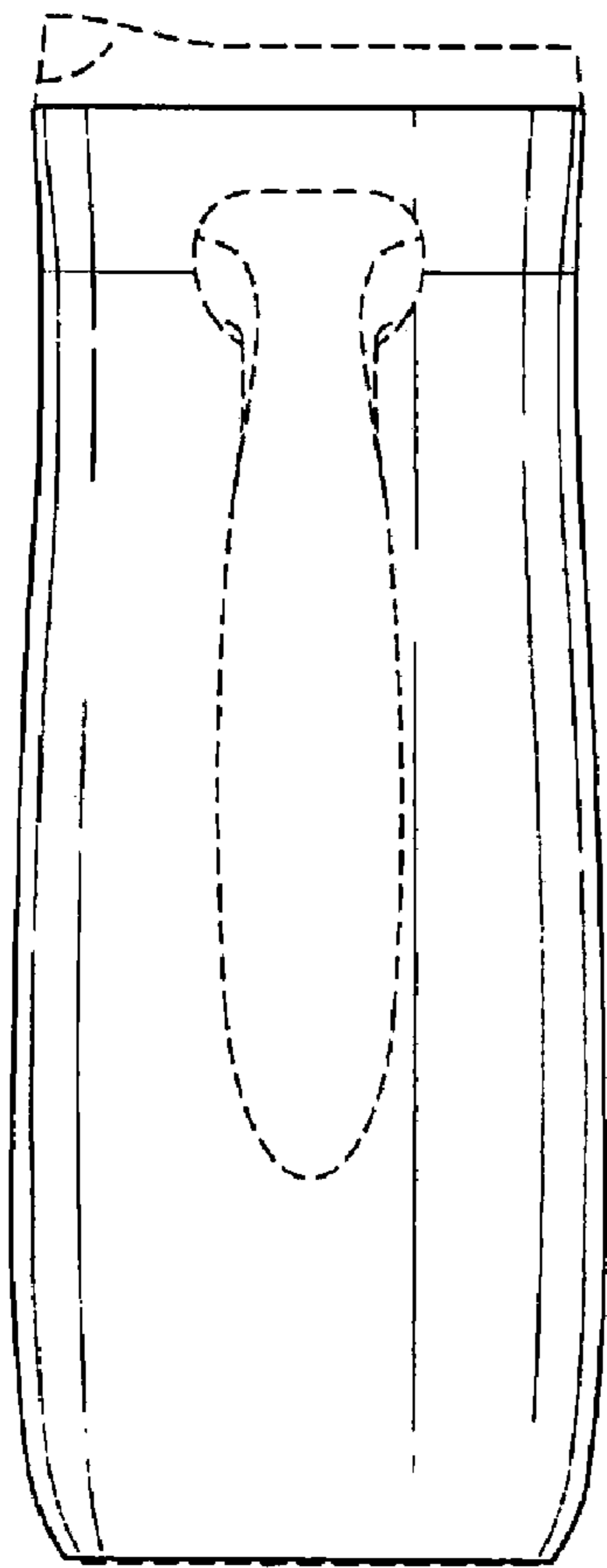

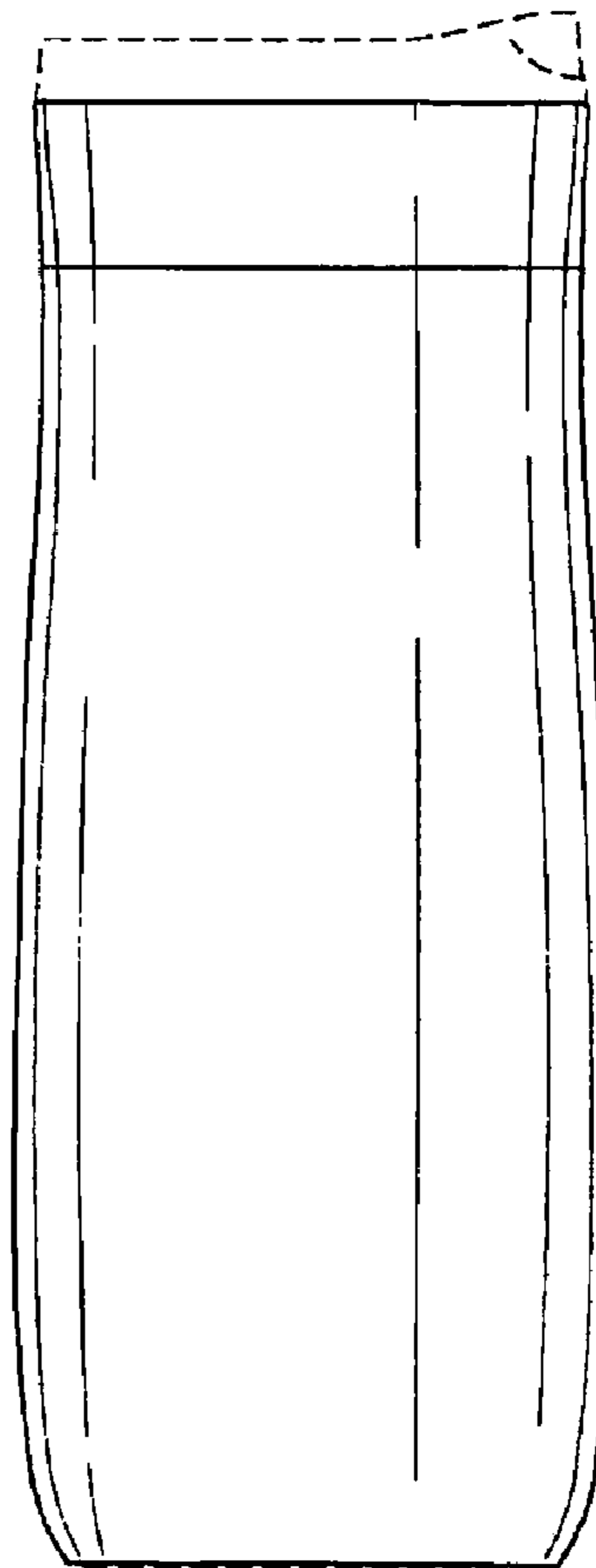

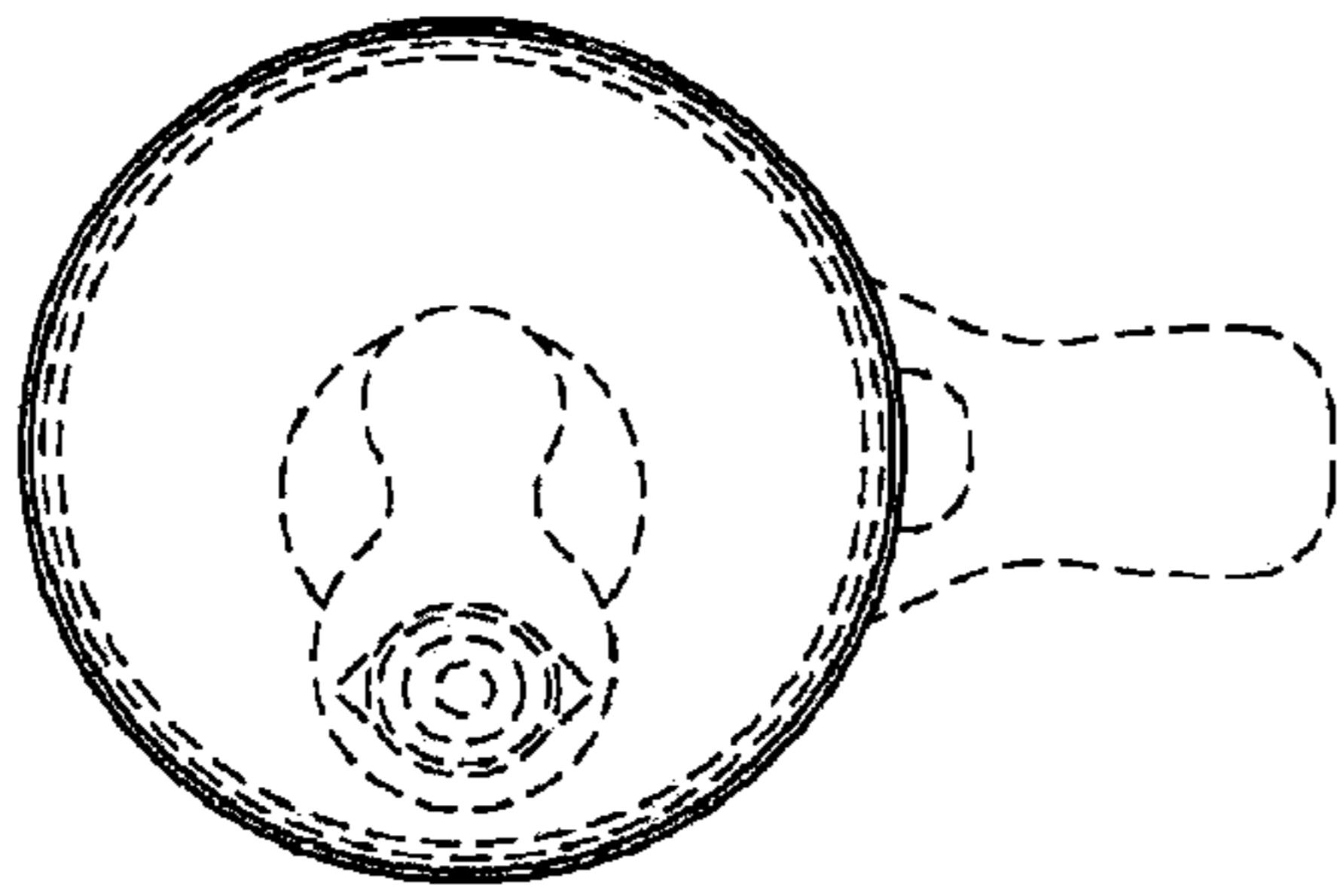

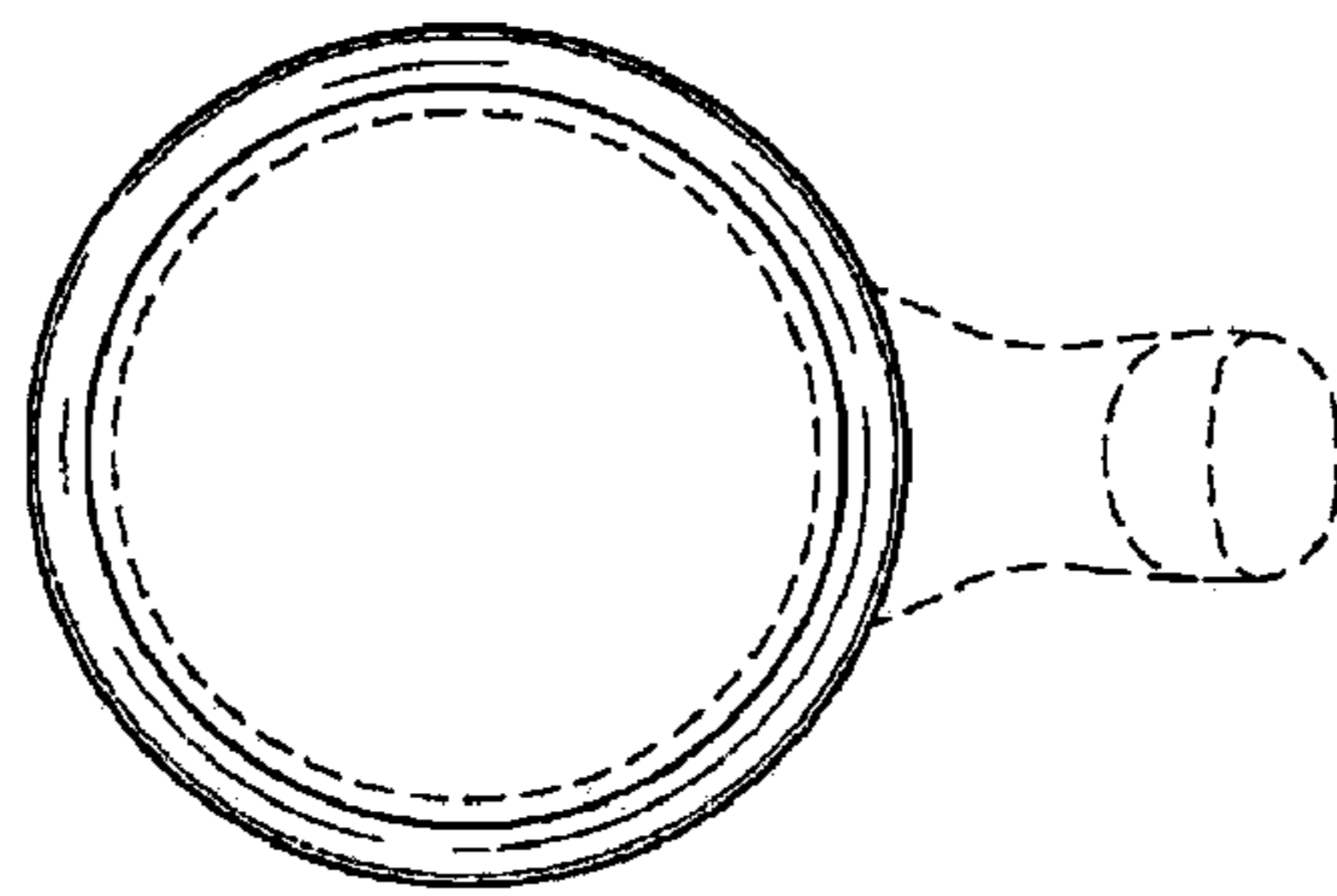
