DESCRIPTION

FIG. 1 is a perspective view of a lock latch that illustrates the novel design;

FIG. 2 is a top view of the lock latch of FIG. 1;

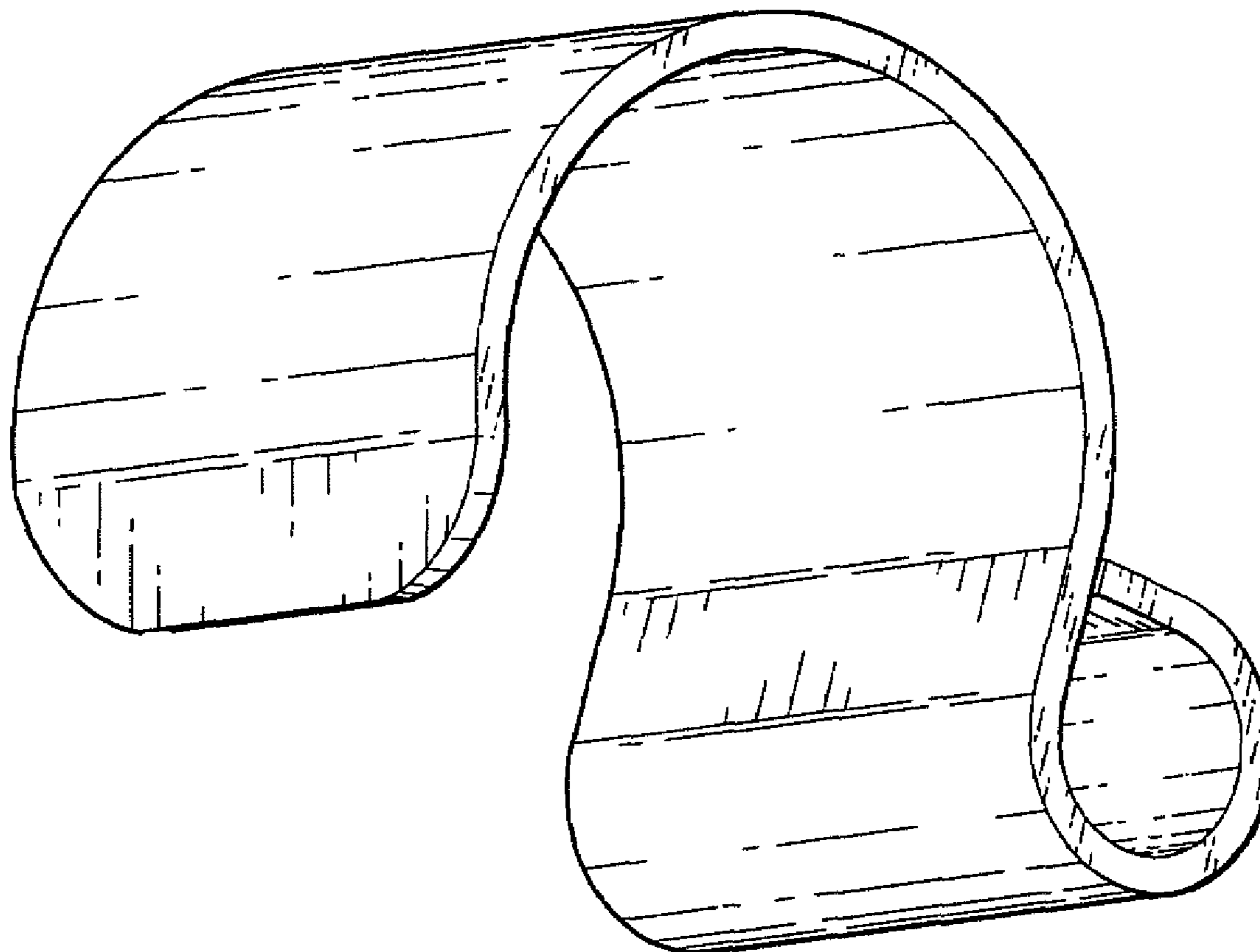
FIG. 3 is a right side elevational view of the lock latch of FIG. 1;

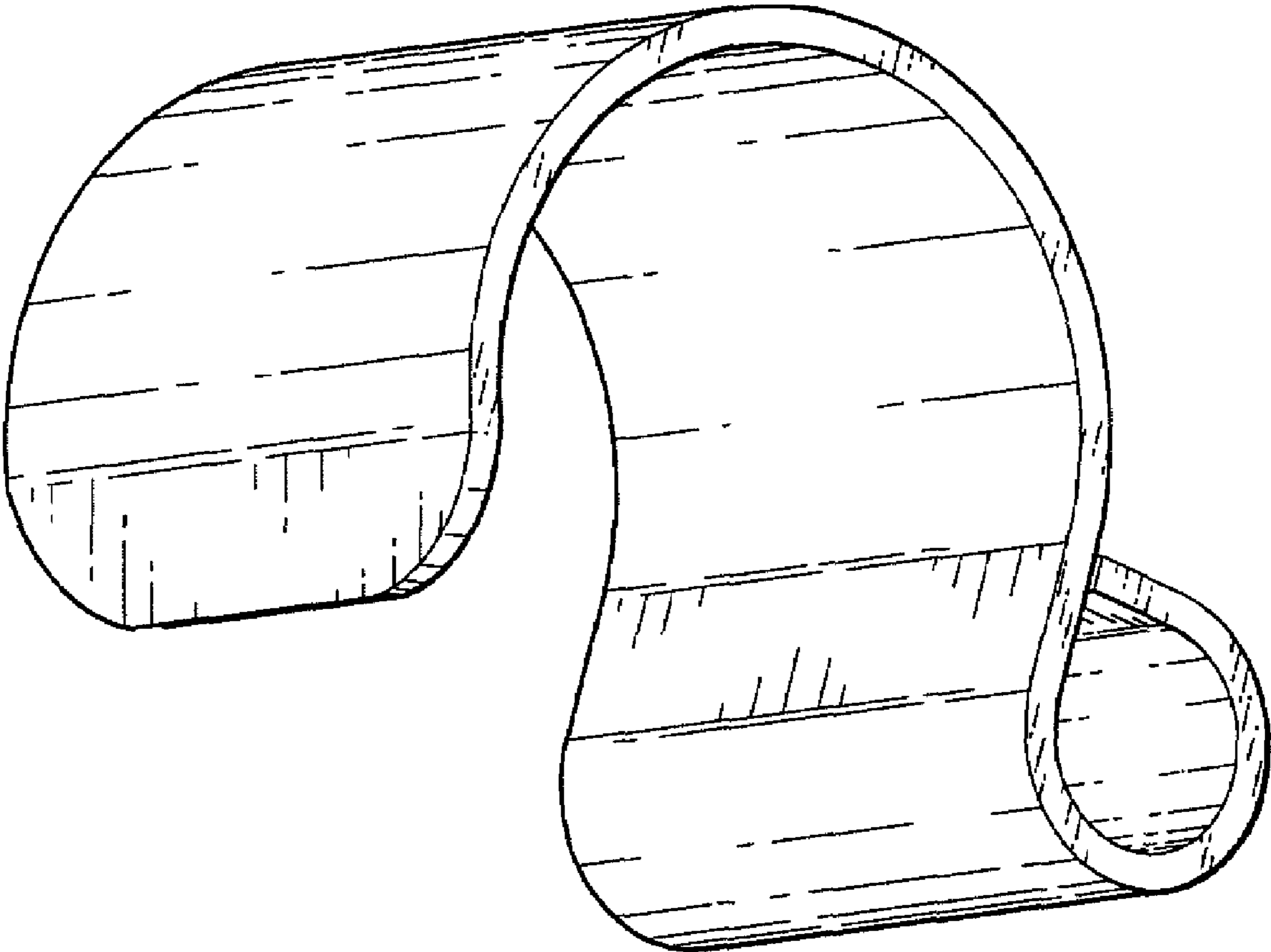

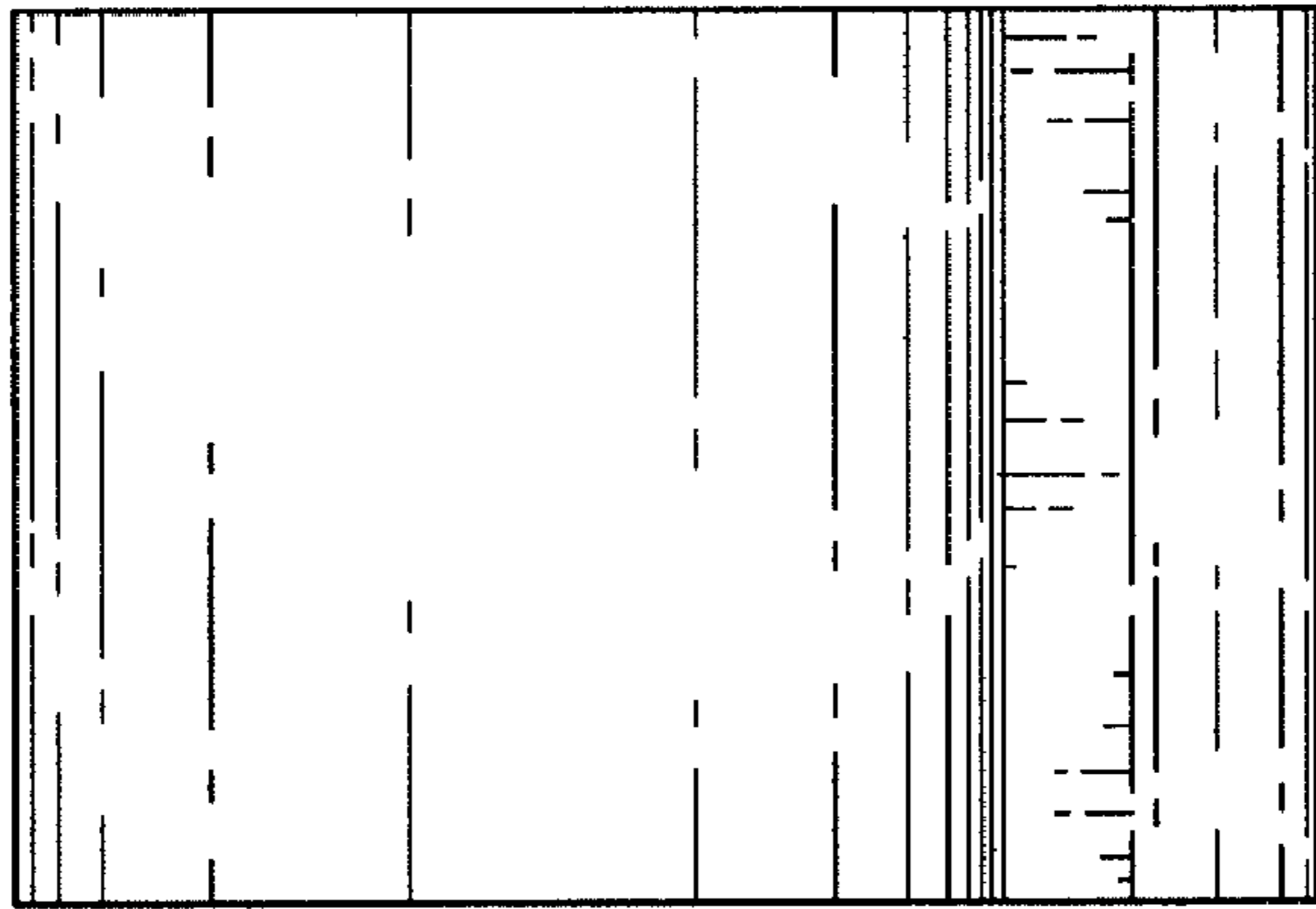

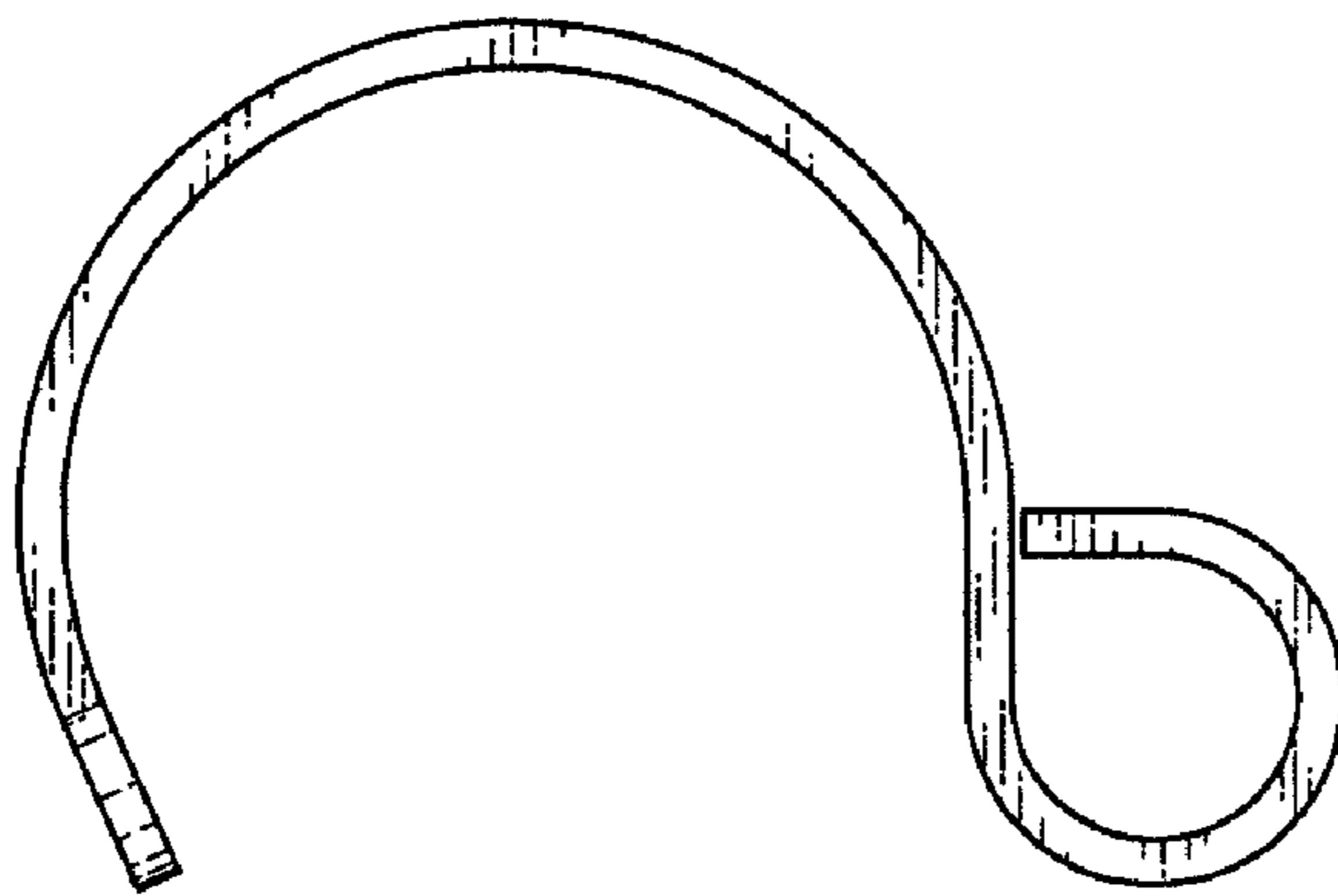

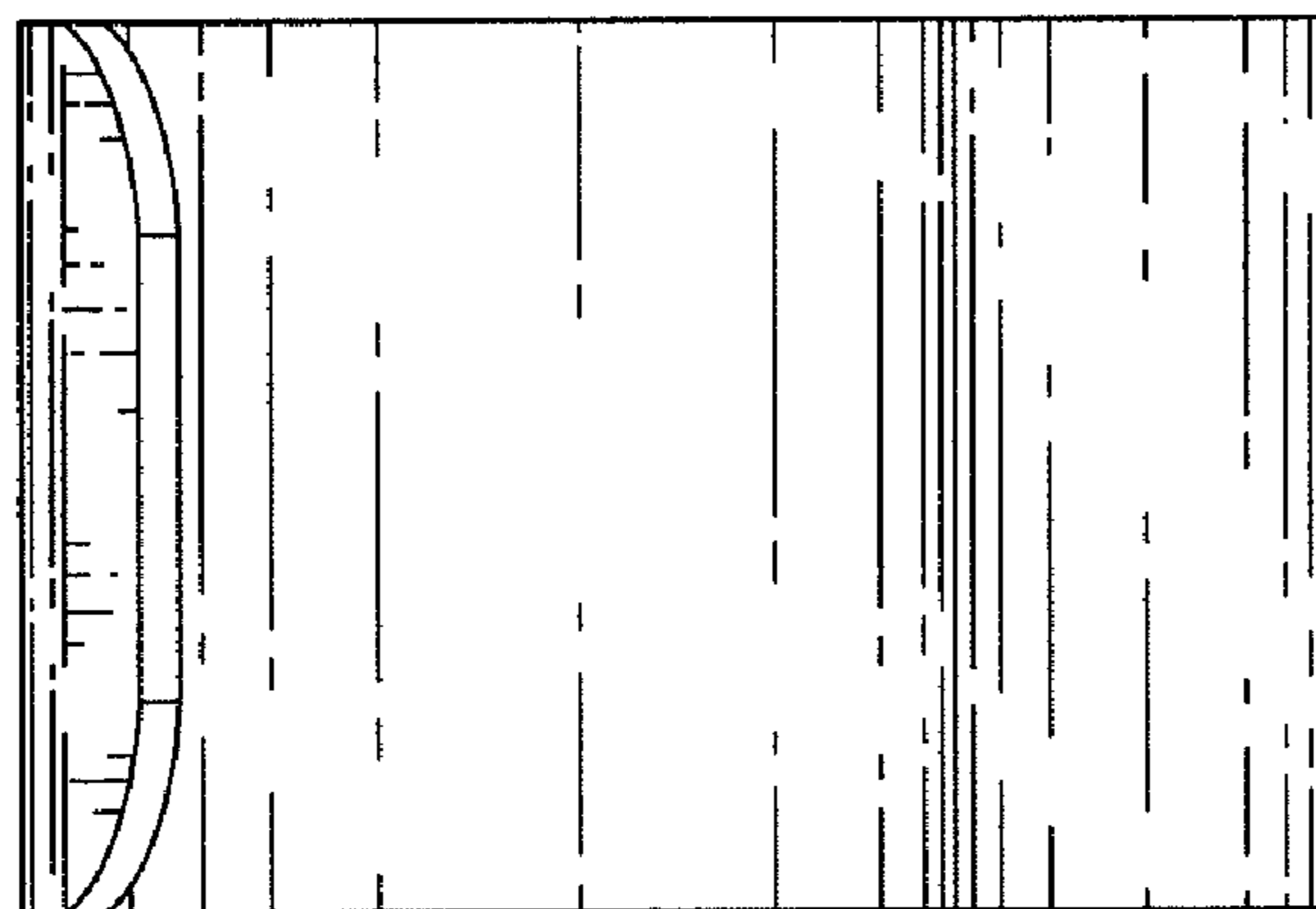

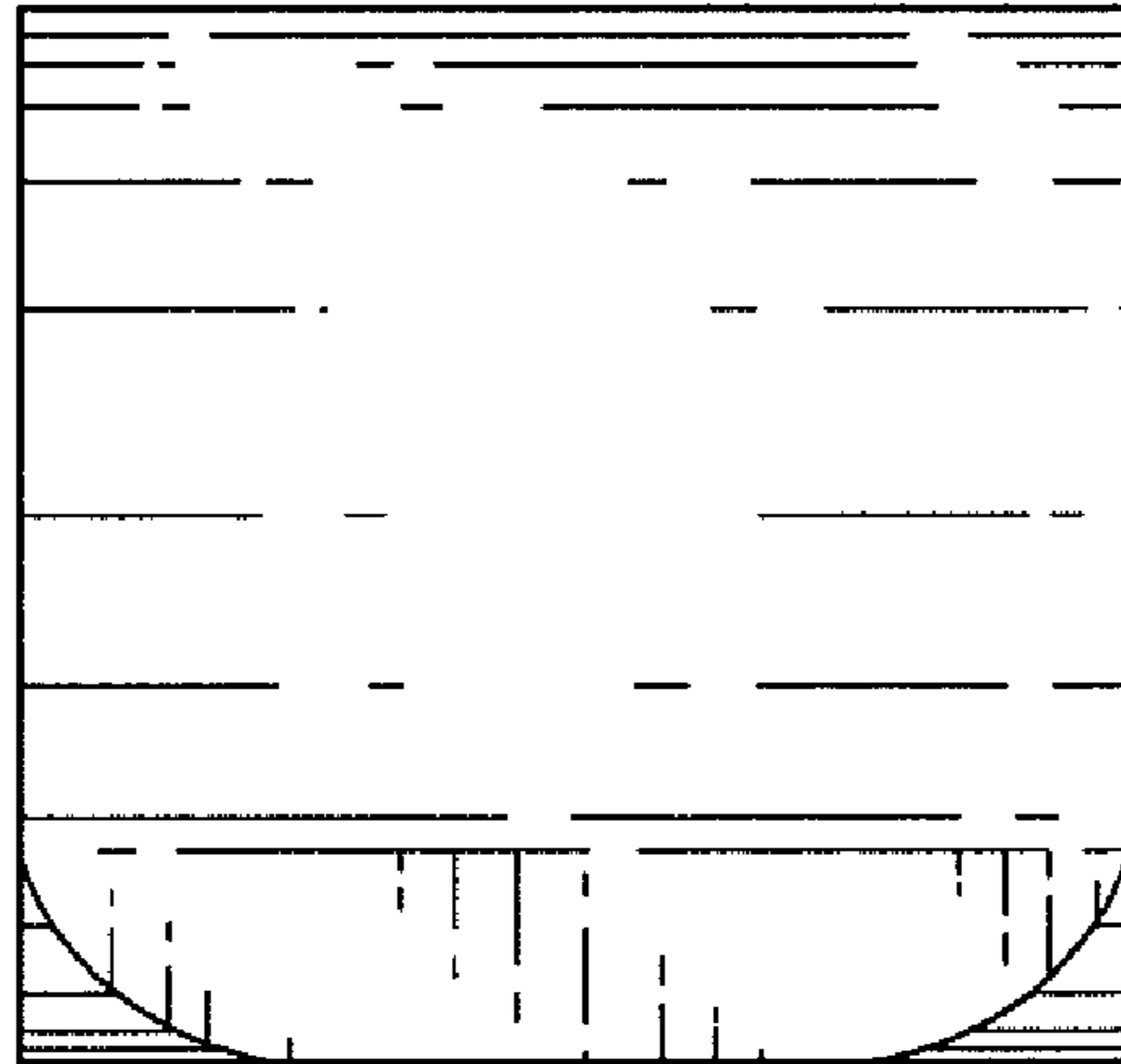

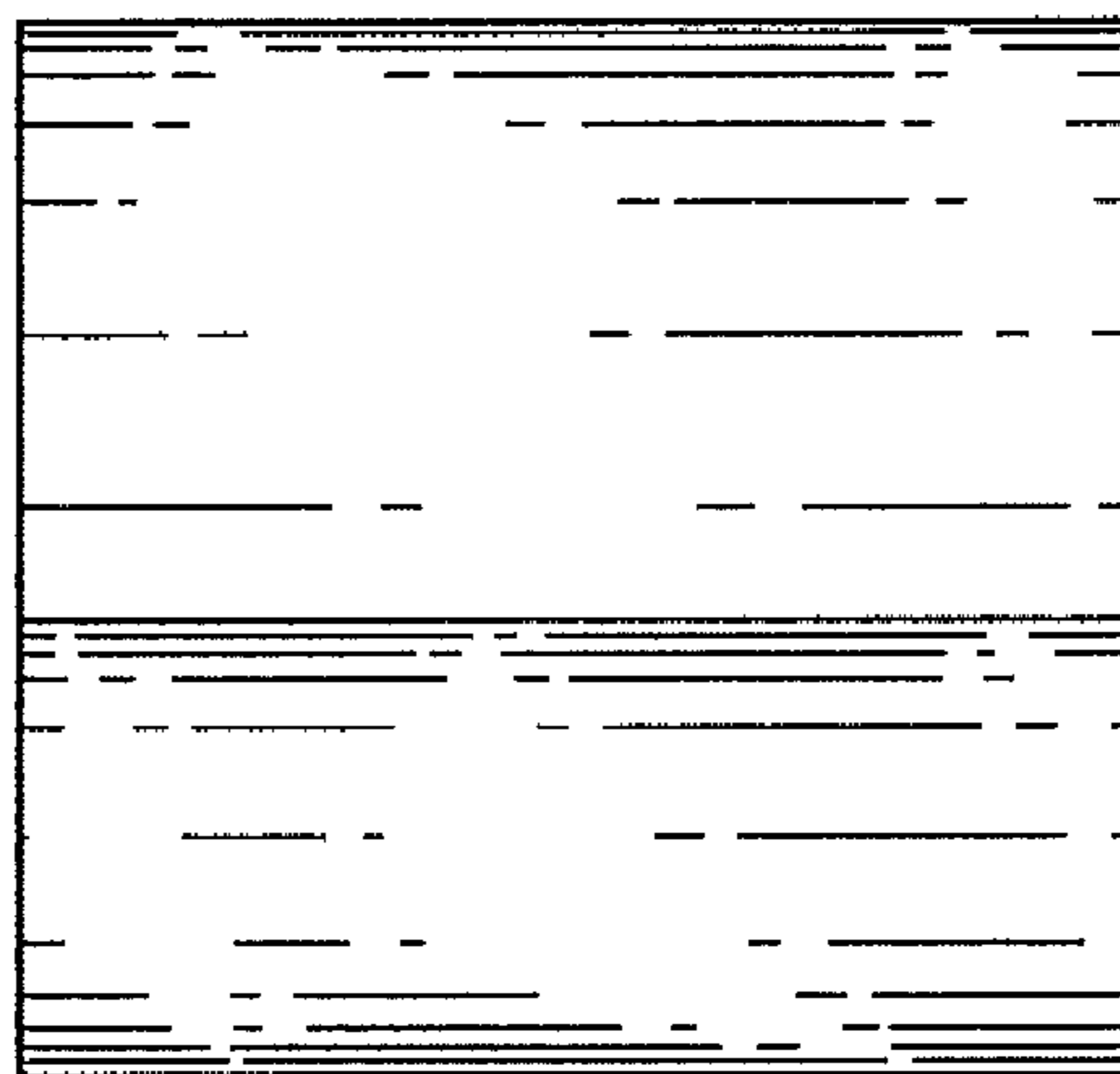
