The ornamental design for a packaging label on a bottle, as shown and described.

FIG. 2 is a rear elevation view thereof;

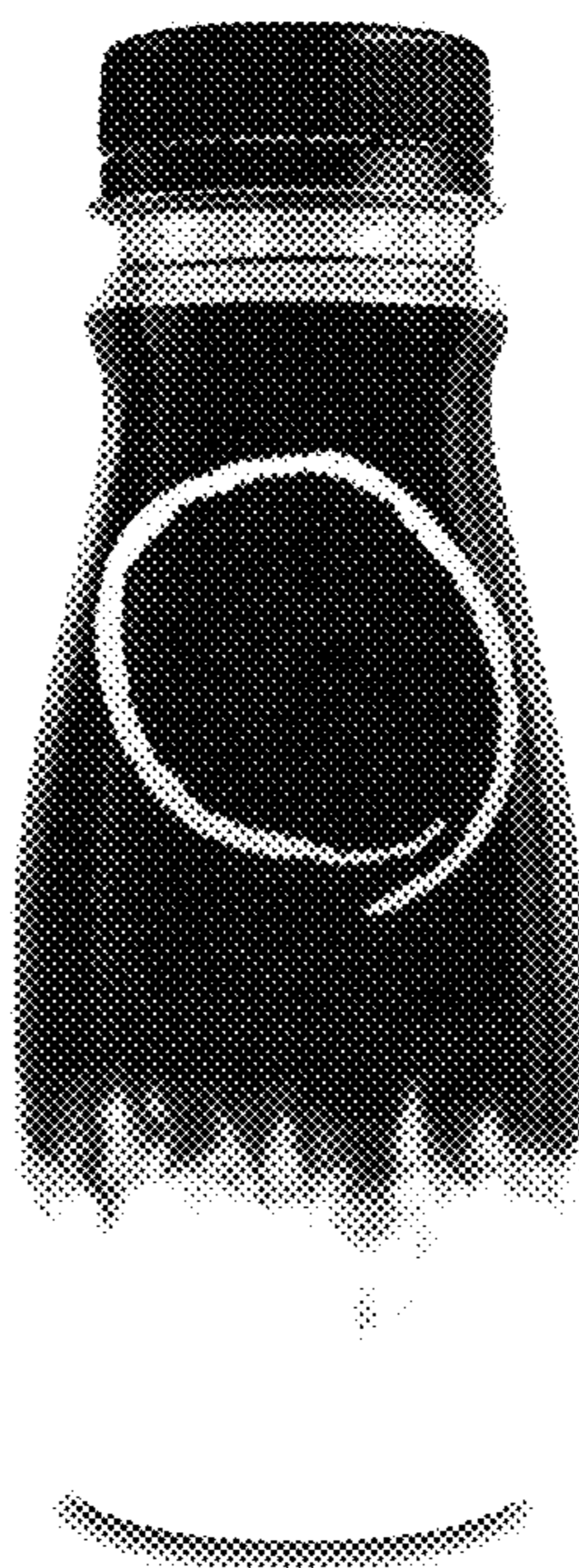
FIG. 3 is a front elevation view of a second alternative embodiment of the packaging label on the bottle;

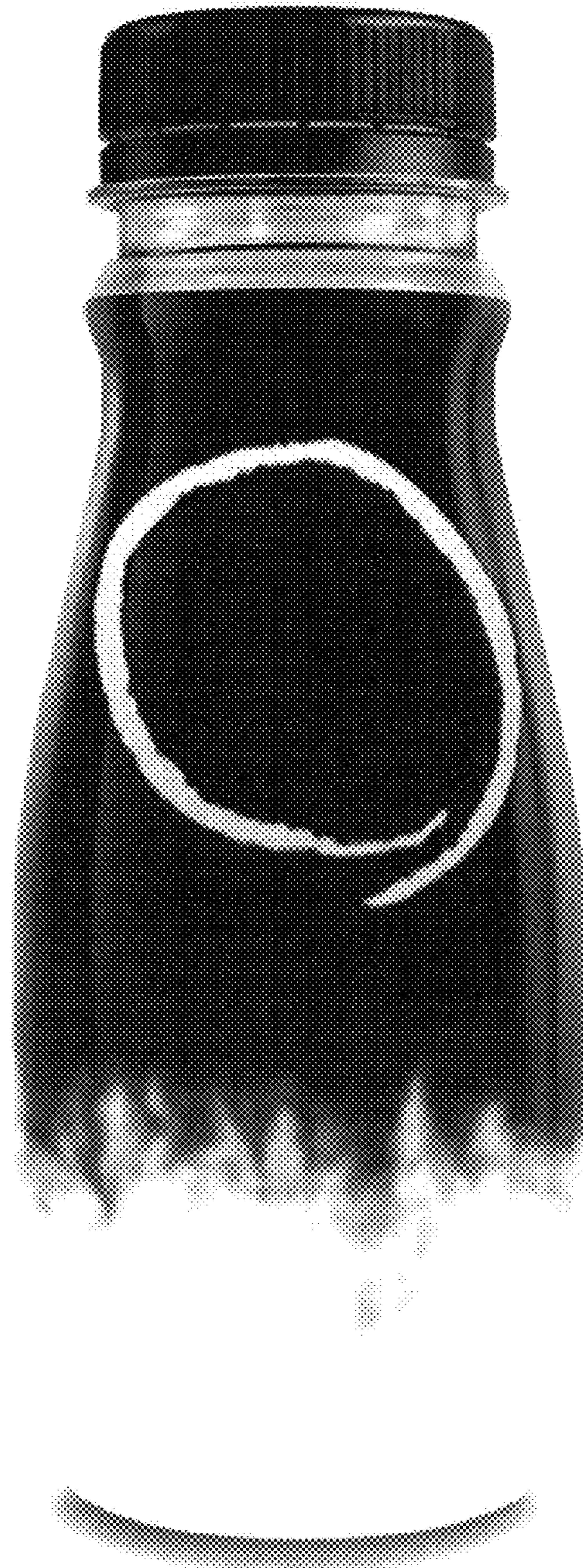

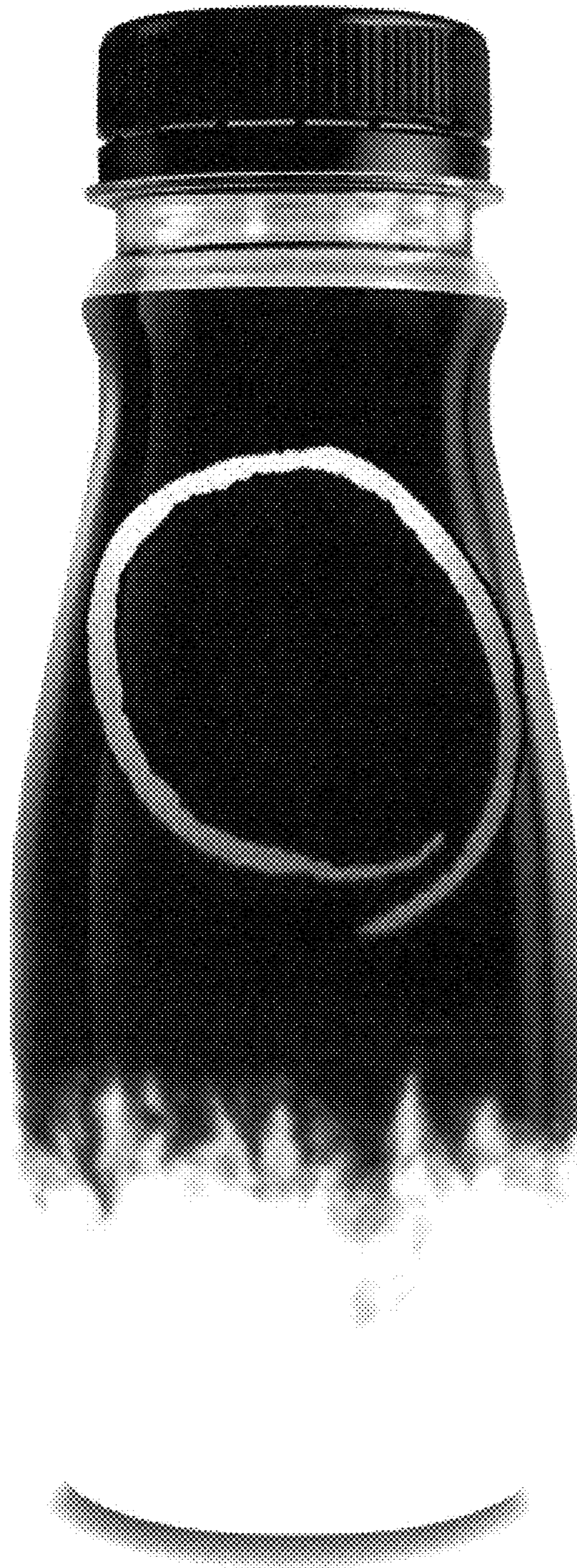

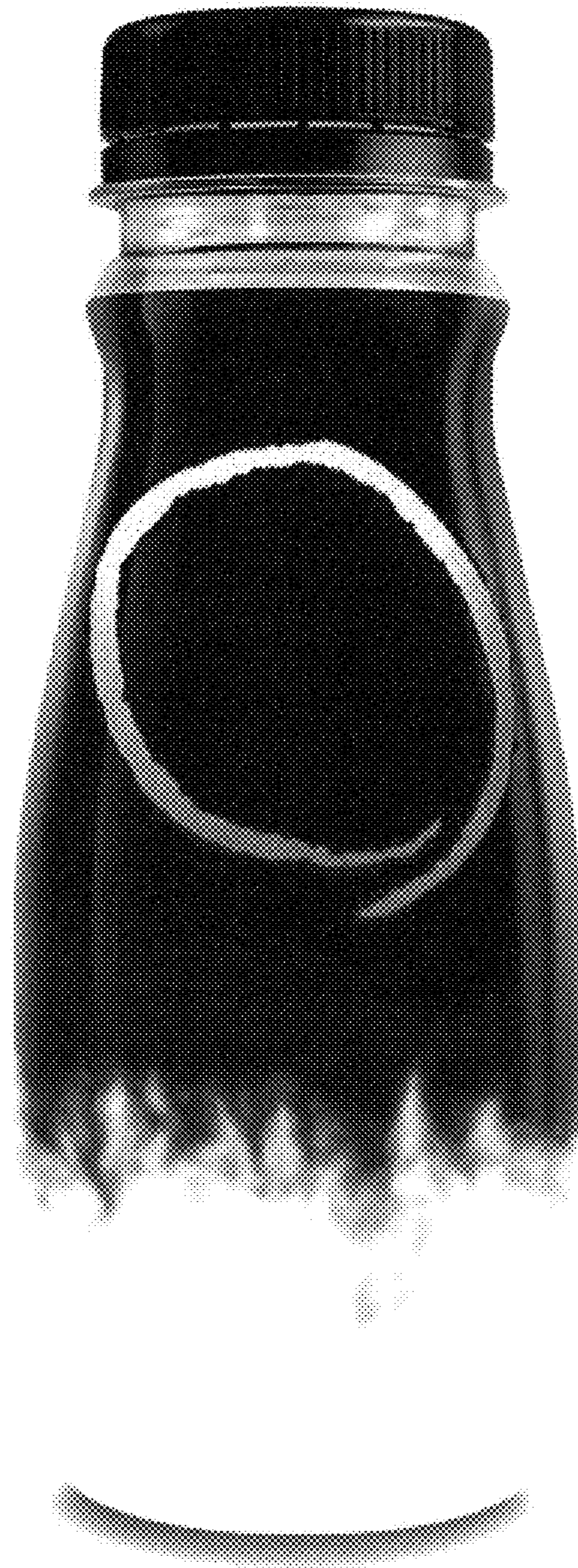
