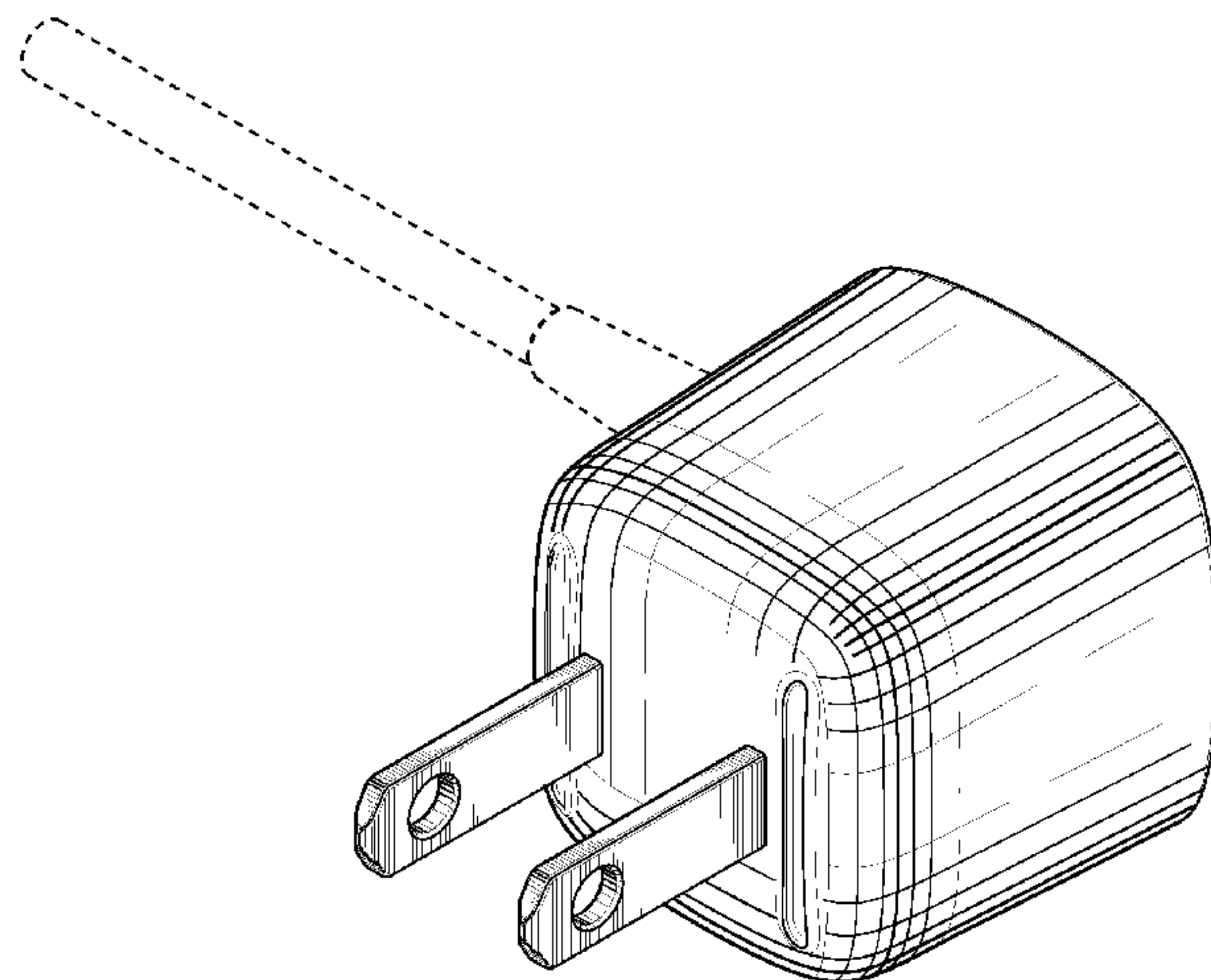
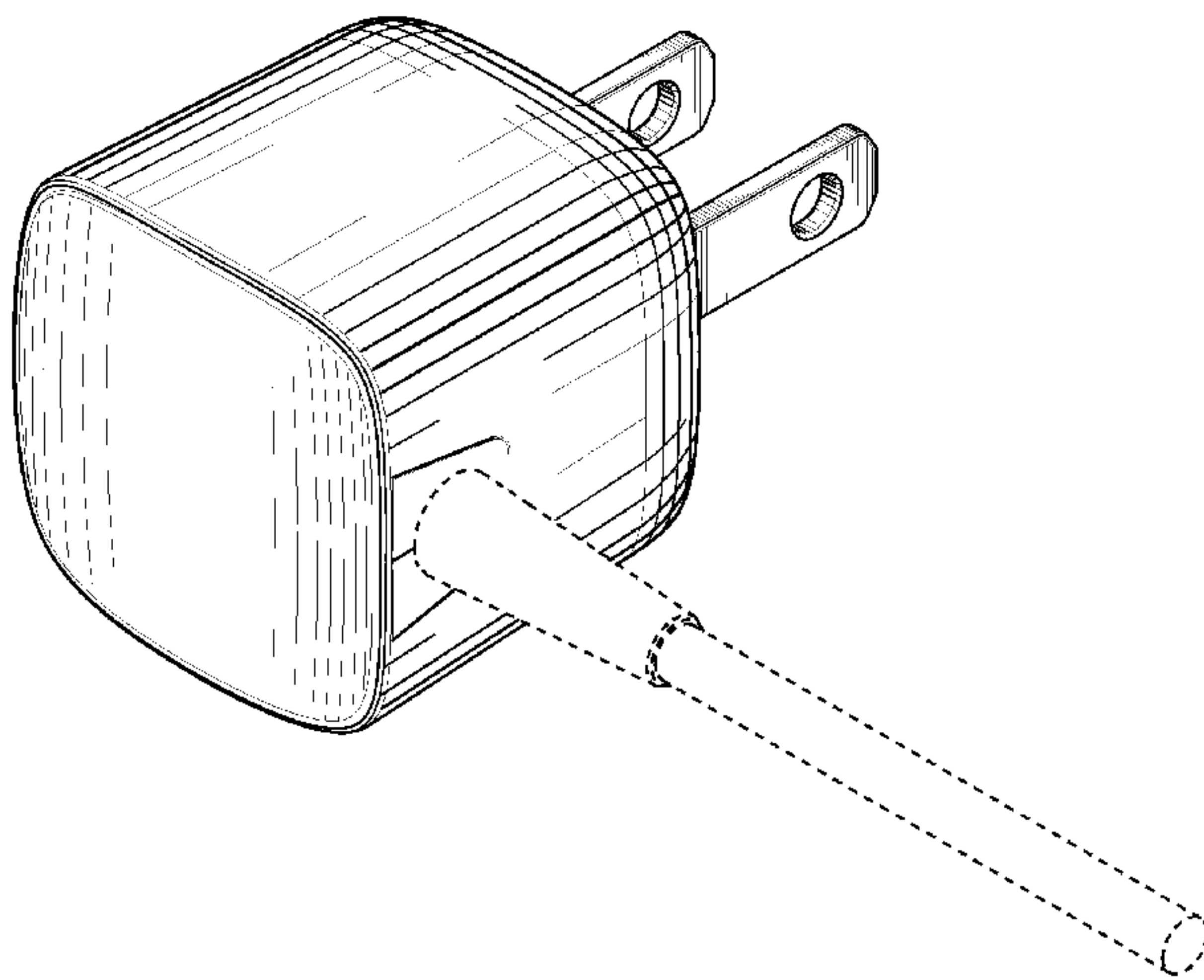
We claim the ornamental design for a plug, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a plug;  
FIG. 2 is a back perspective view of the plug;

FIG. 5 is a left elevational view thereof;  
FIG. 6 is a right elevational view thereof;

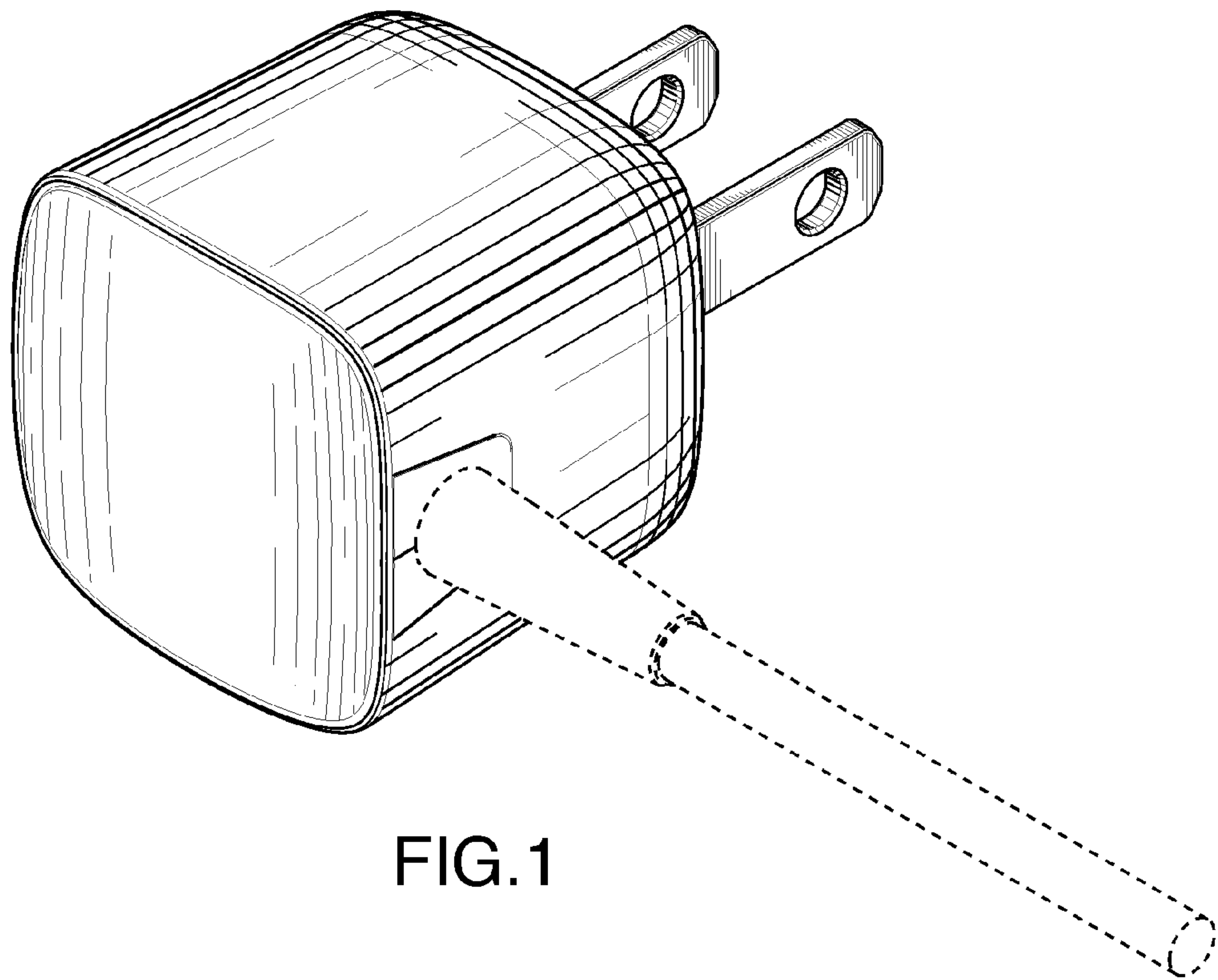

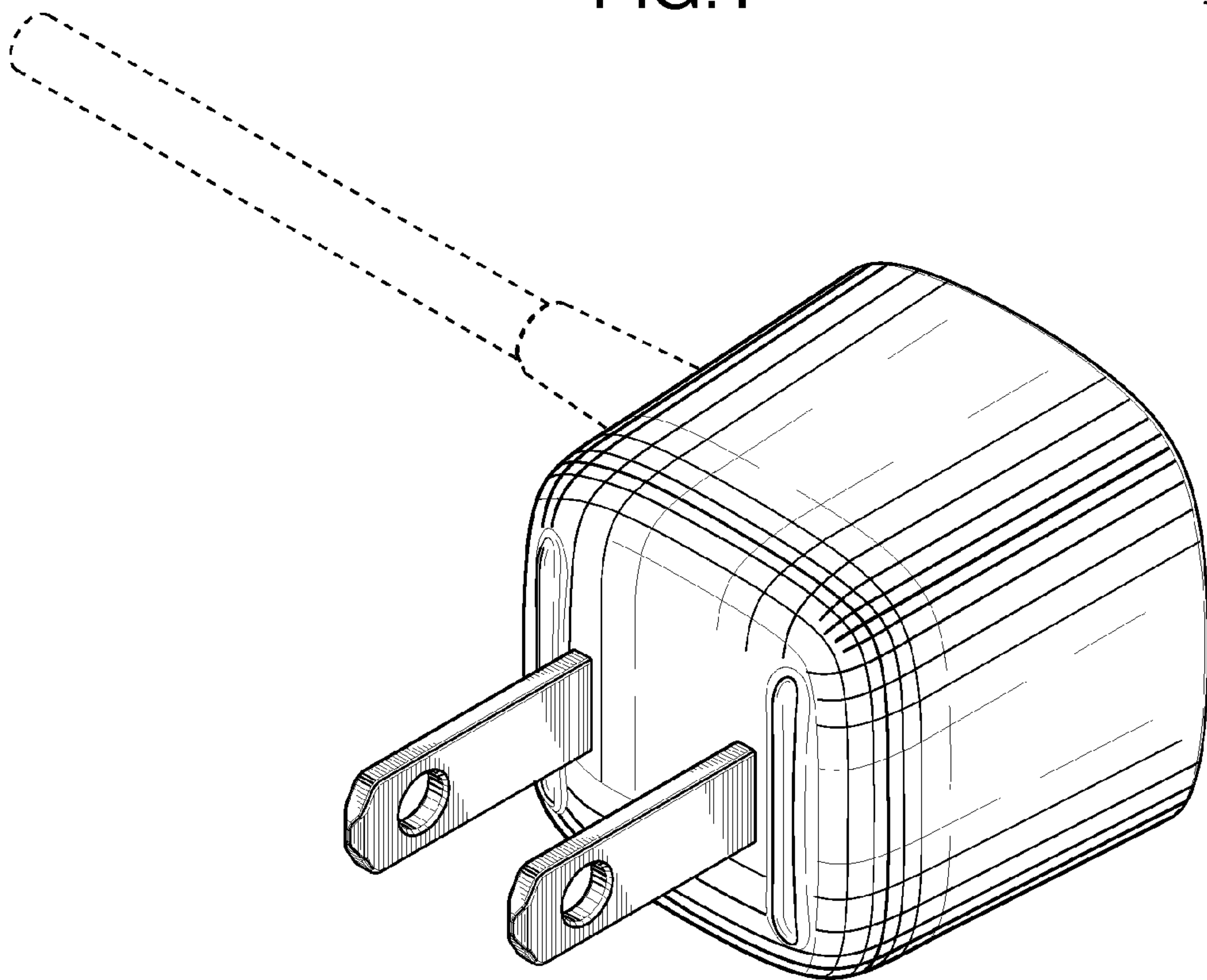

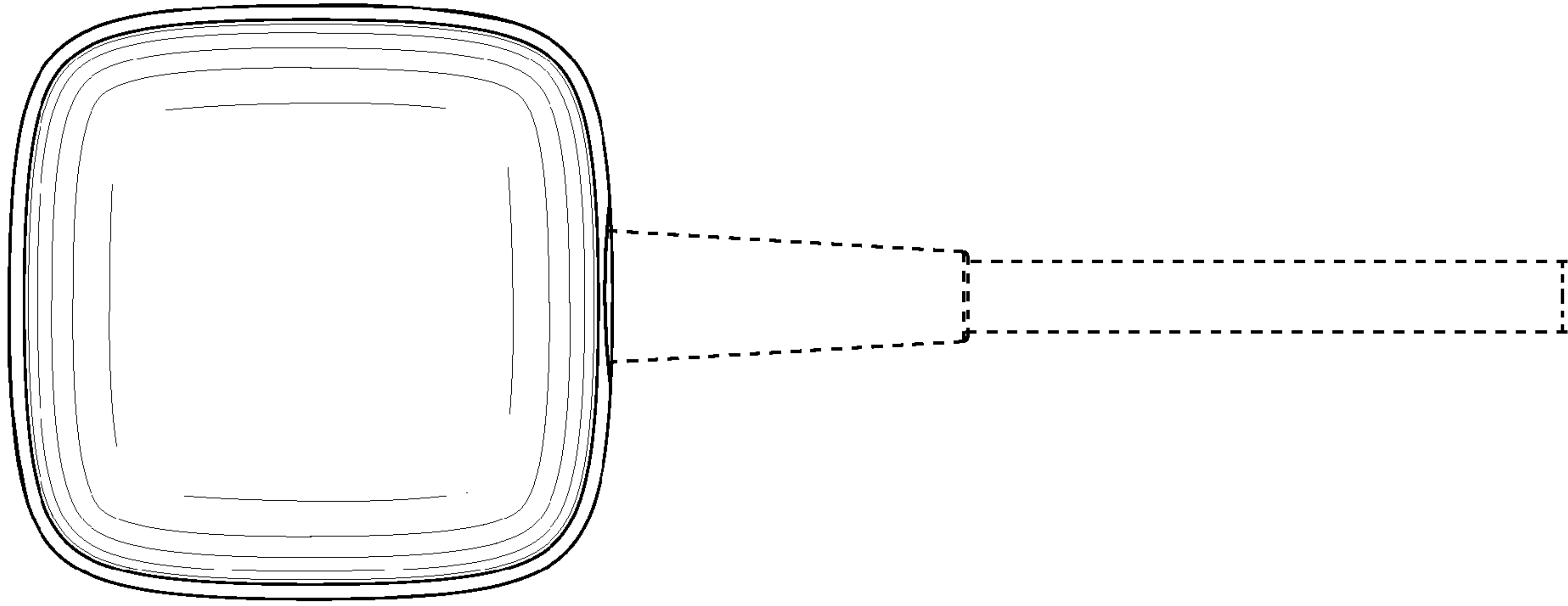

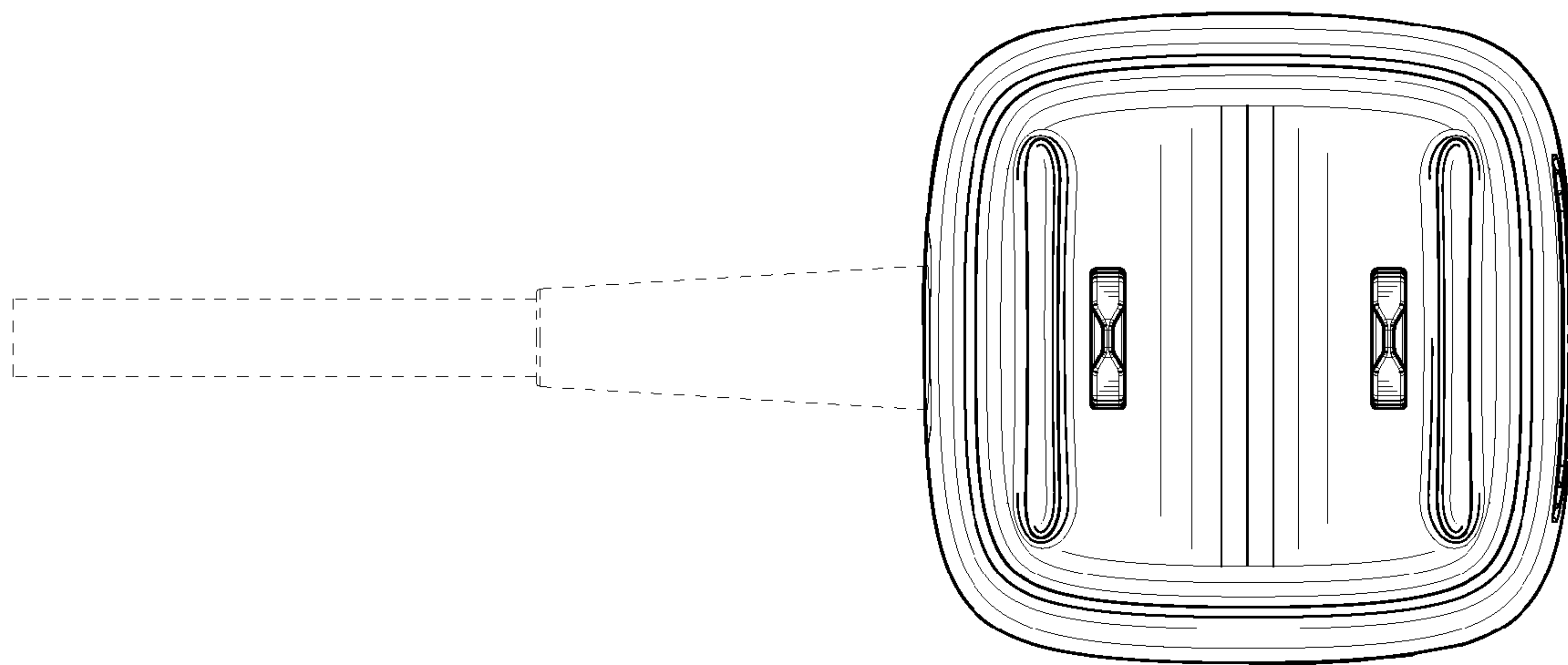

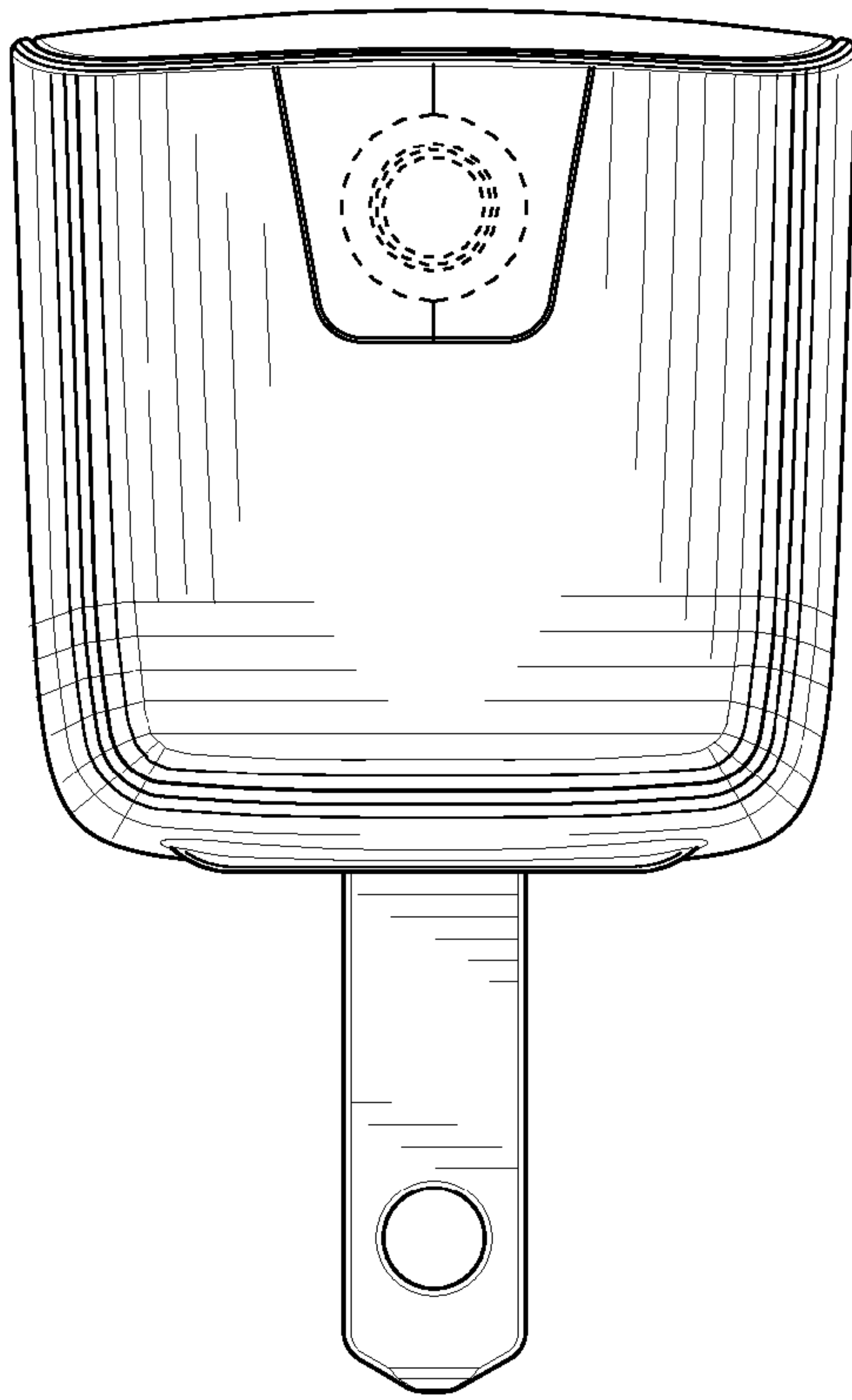

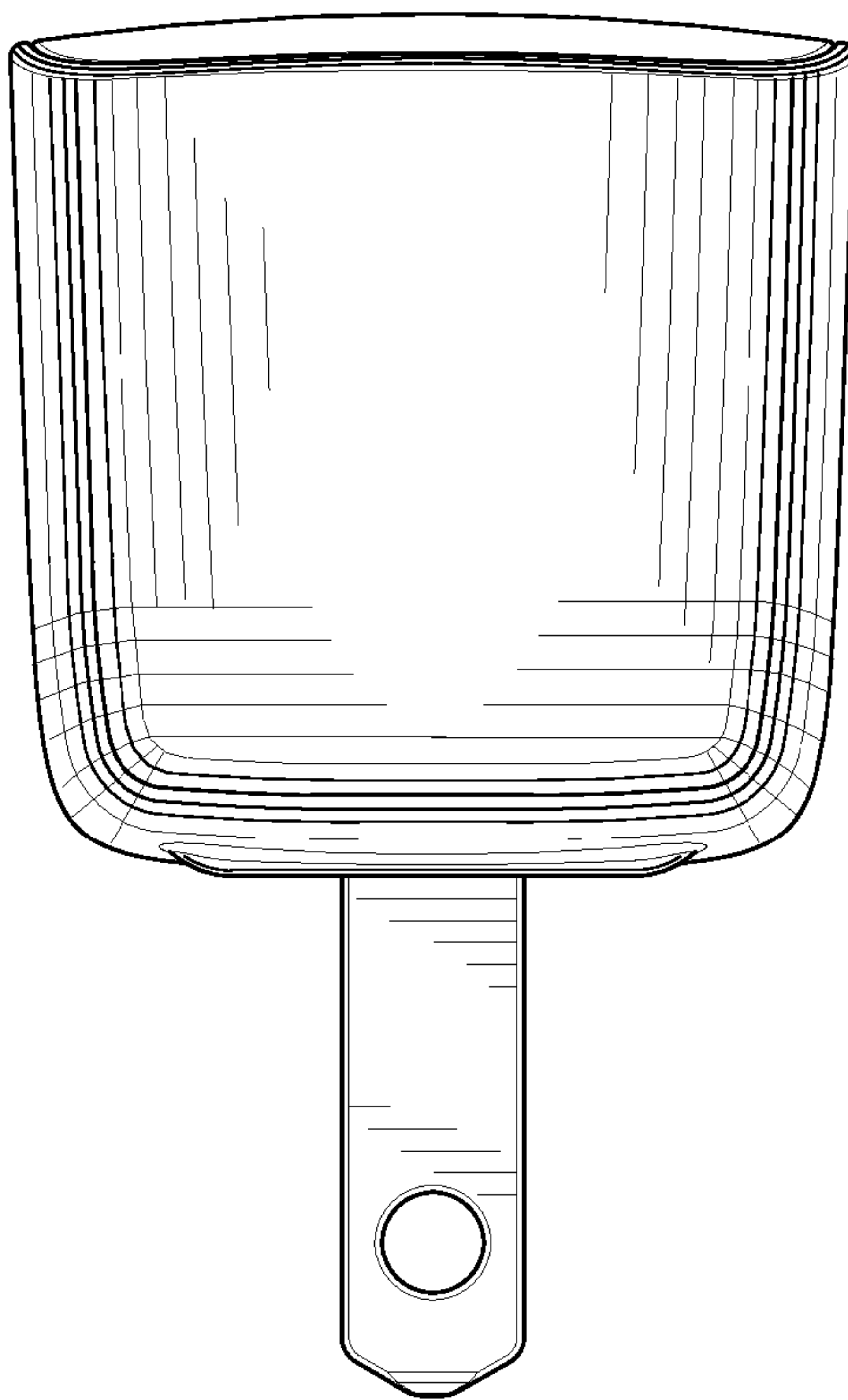

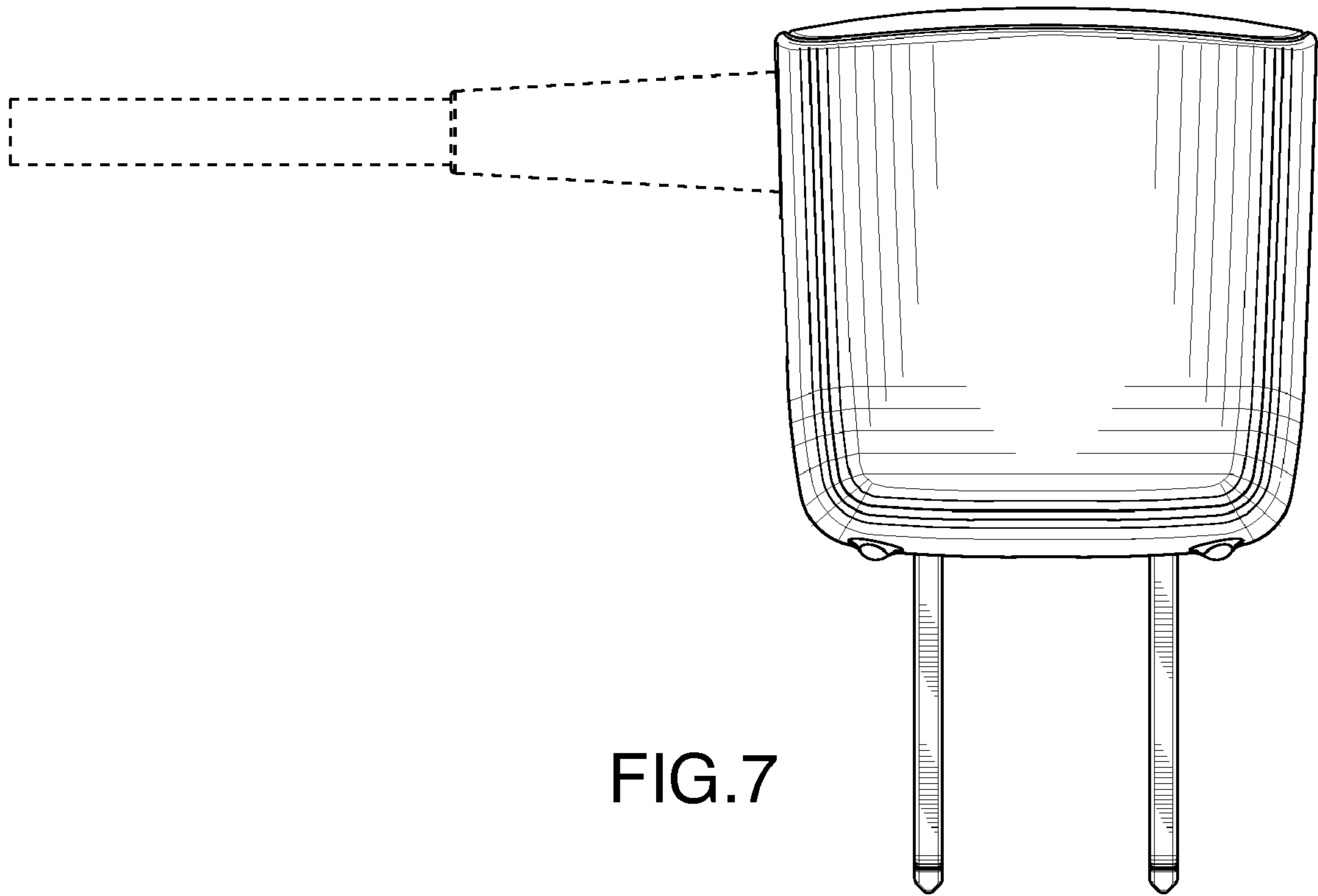

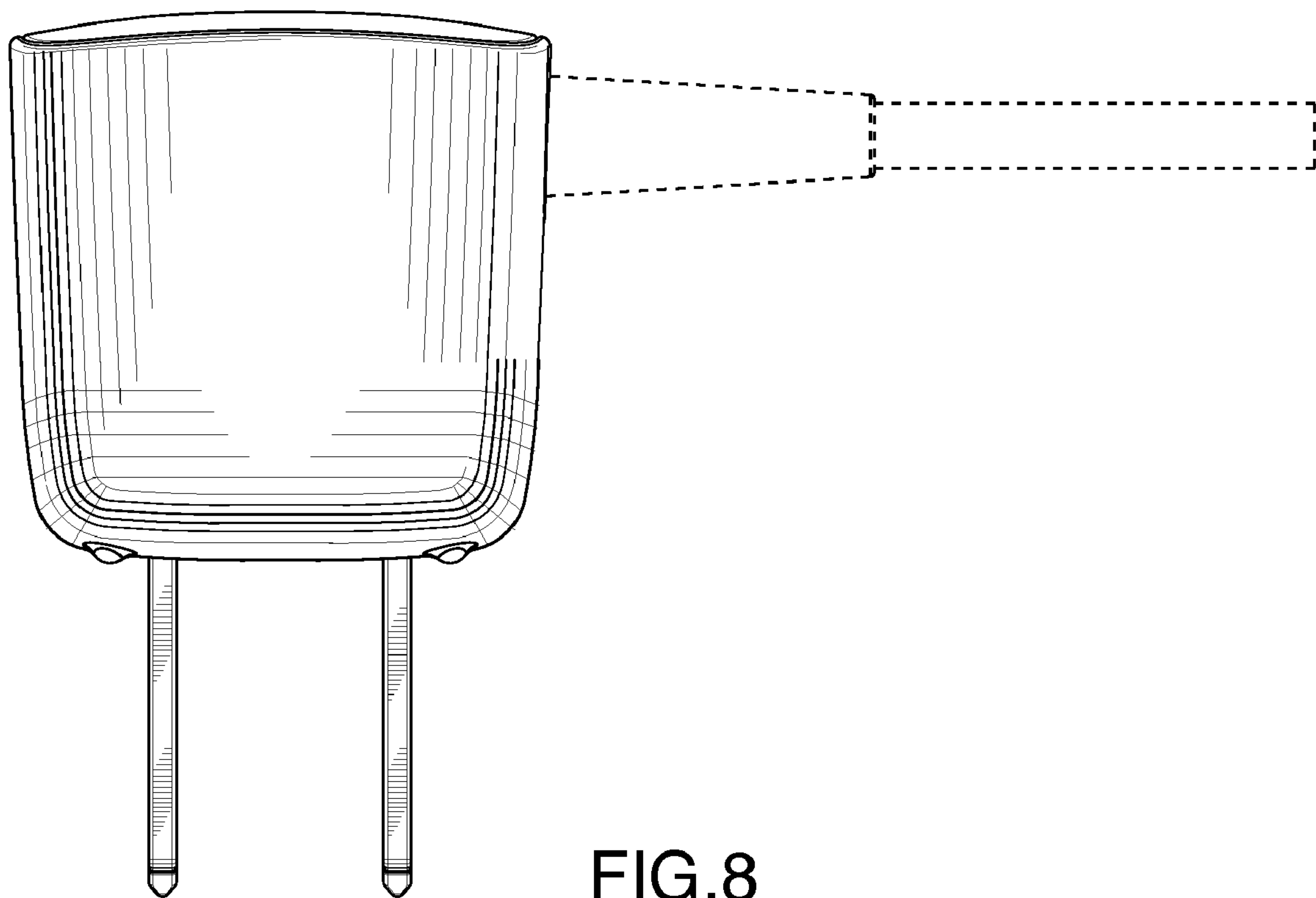
