DESCRIPTION

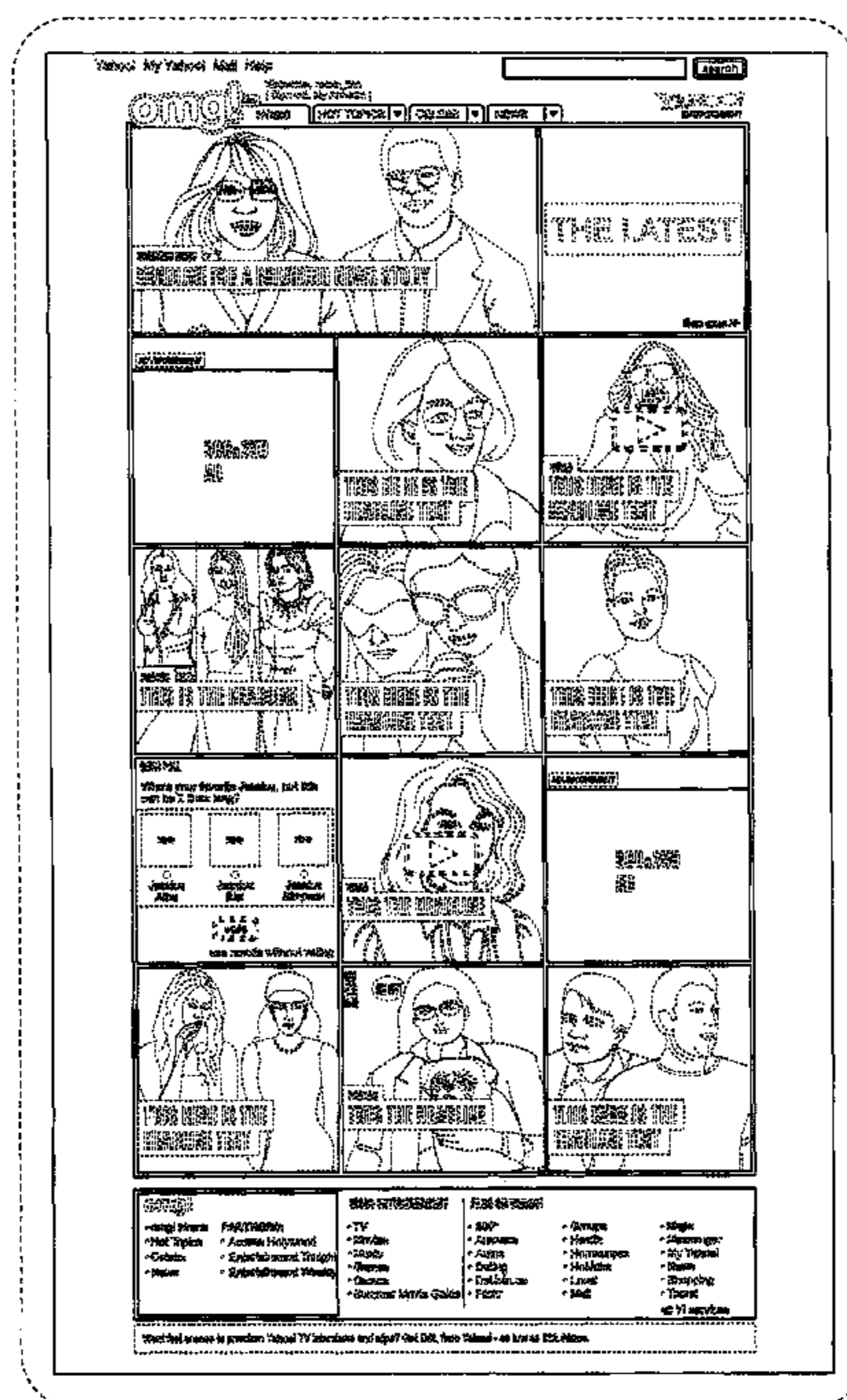
The present application is related to U.S. application Ser. No. 11/810,198, filed on Jun. 4, 2007, the content of which is incorporated herein by reference.

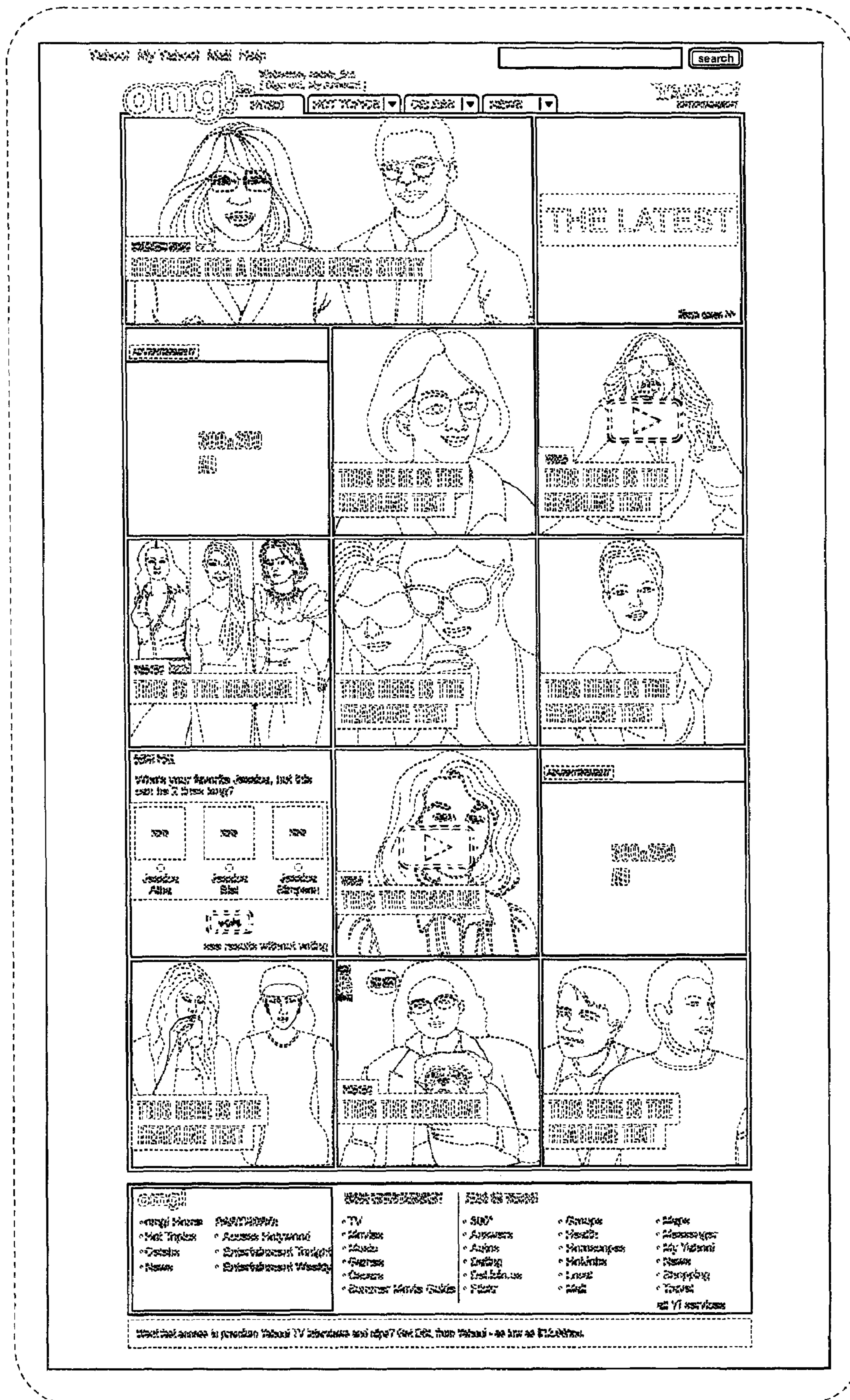

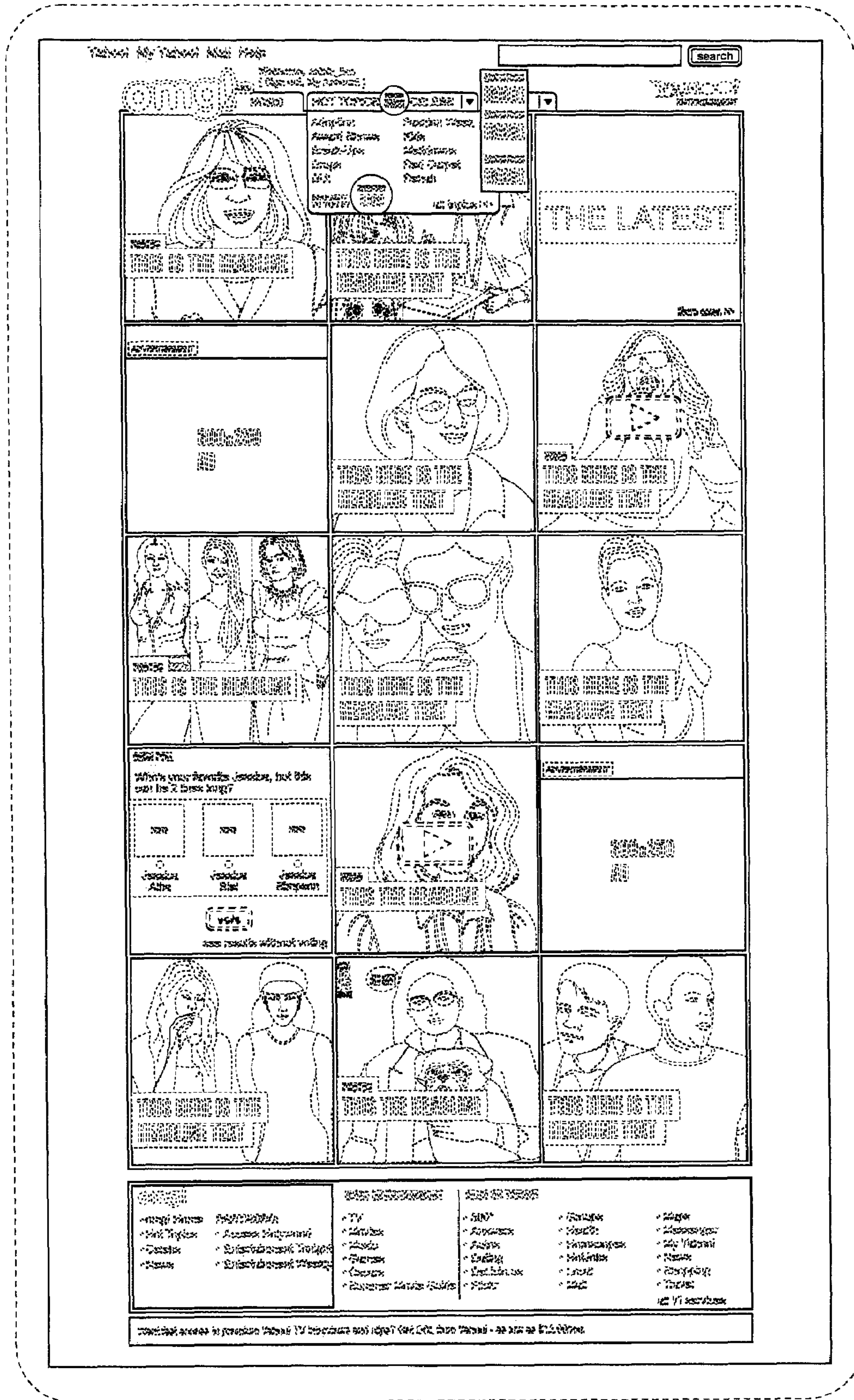
