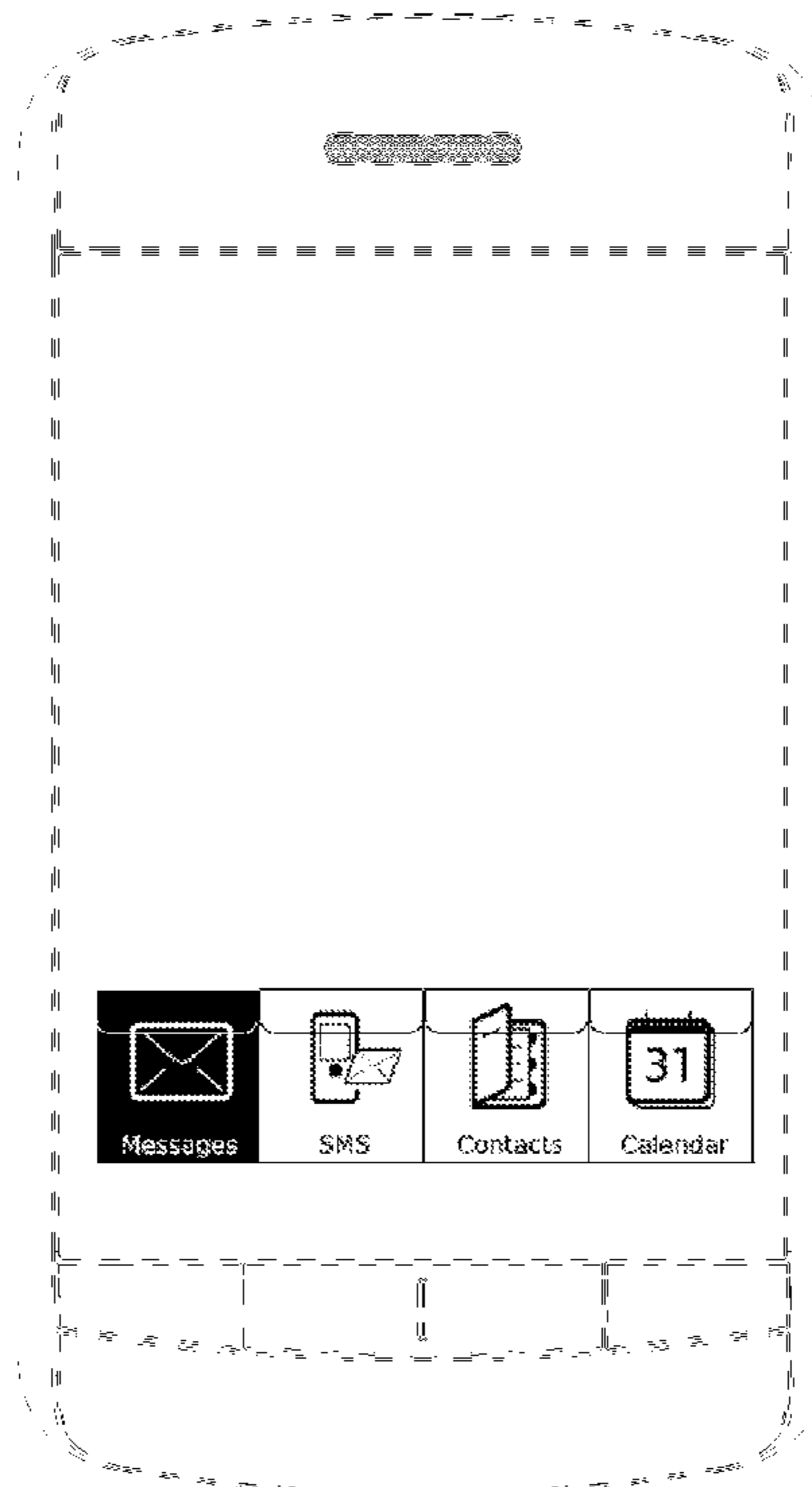
We claim the ornamental design for icons for a hand-held electronic device display, as shown and described.

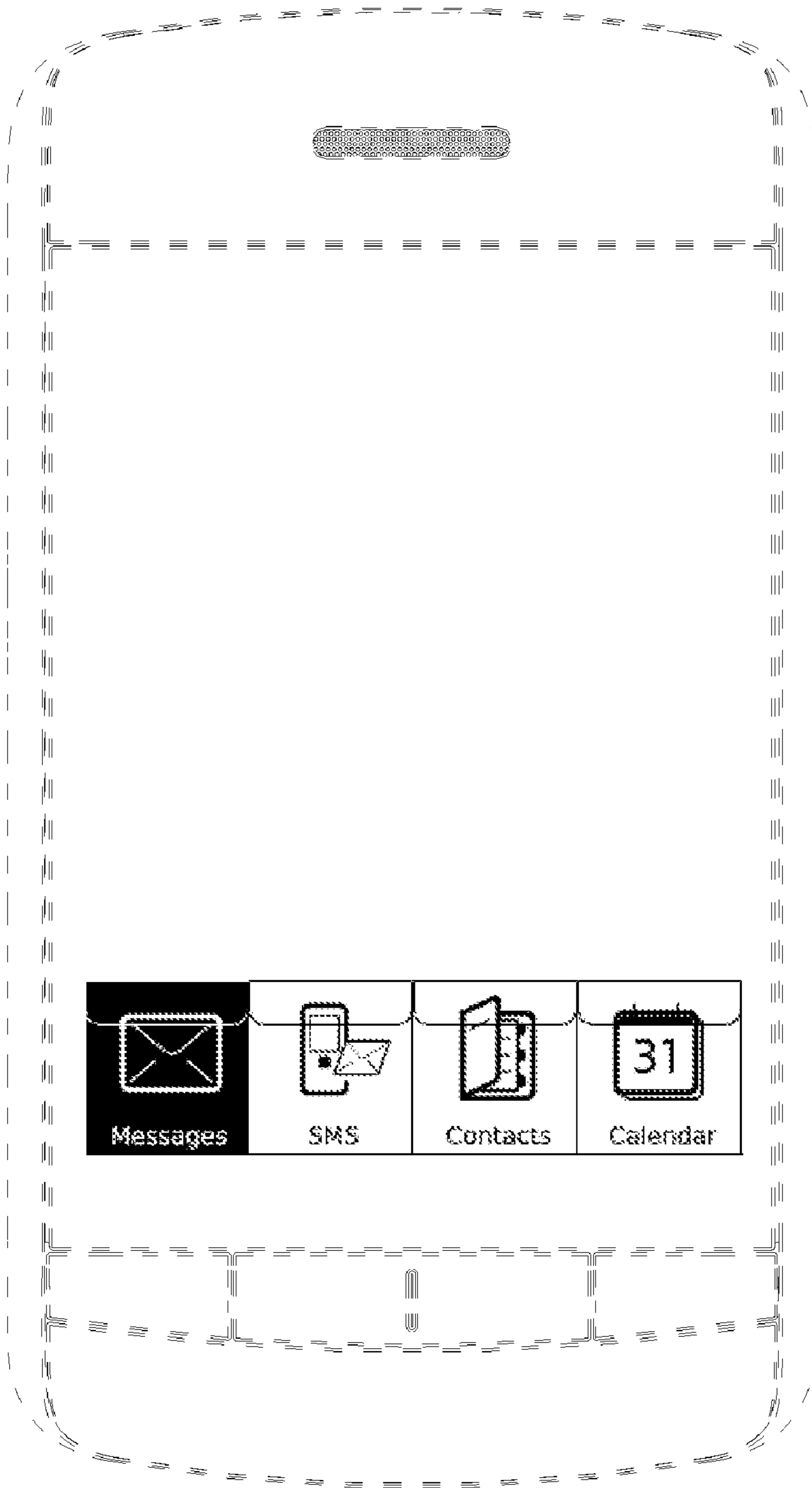
DESCRIPTION
