The ornamental design for a spray controller, as shown and described.

DESCRIPTION

FIG. 8 is an enlarged bottom view thereof;

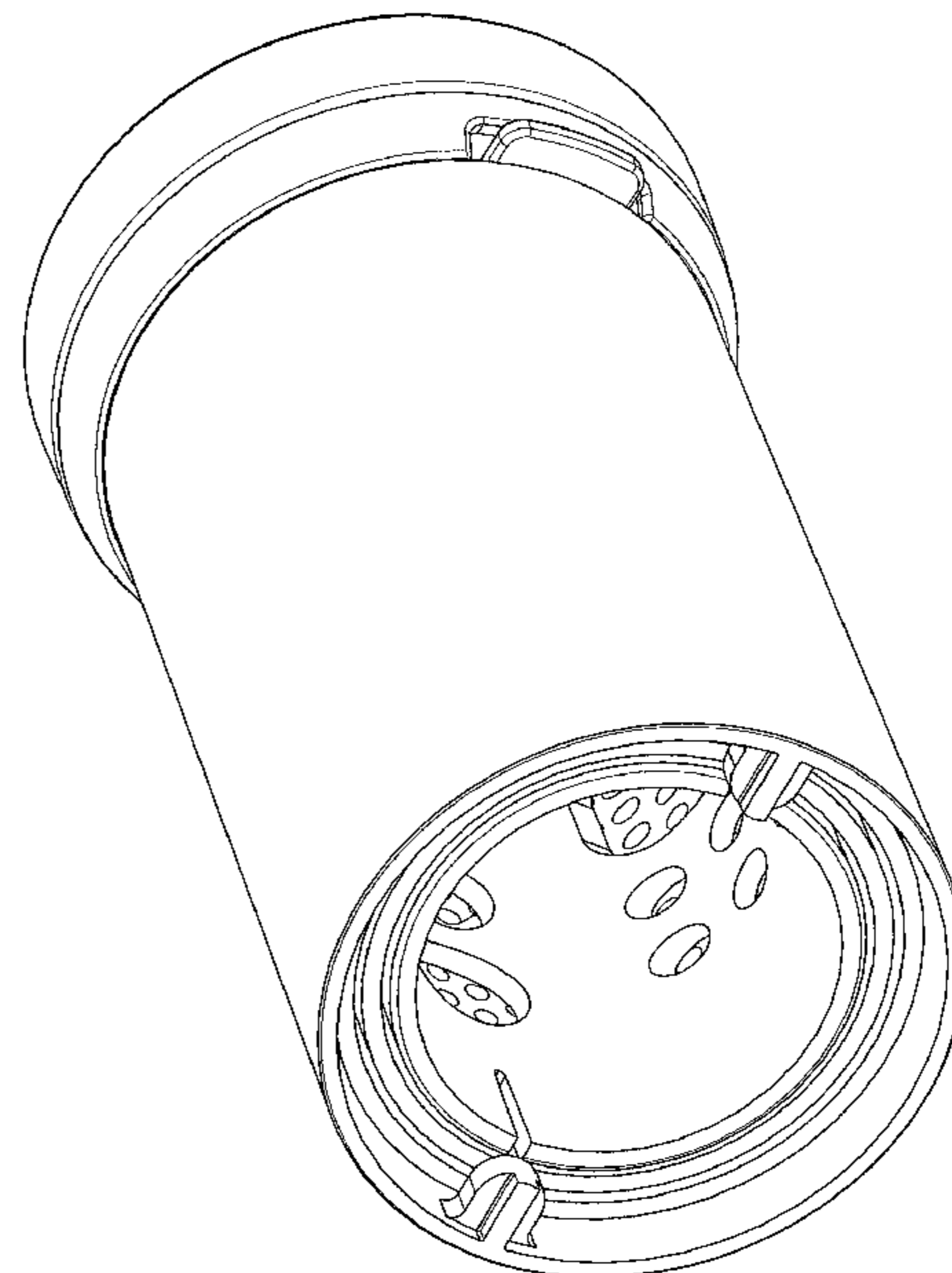
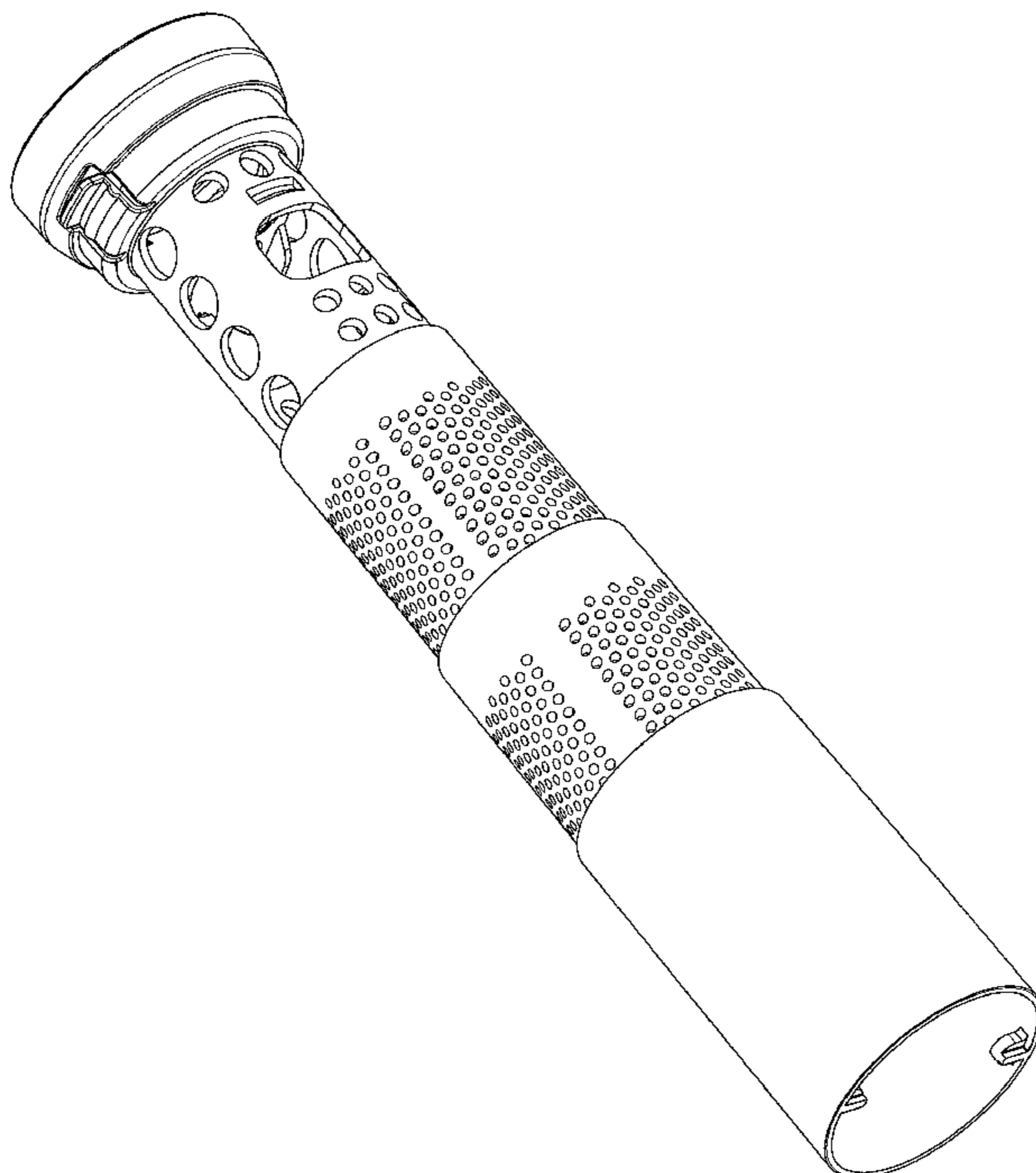
FIG. 9 is a top perspective view of the spray controller showing our new design in a collapsed condition;

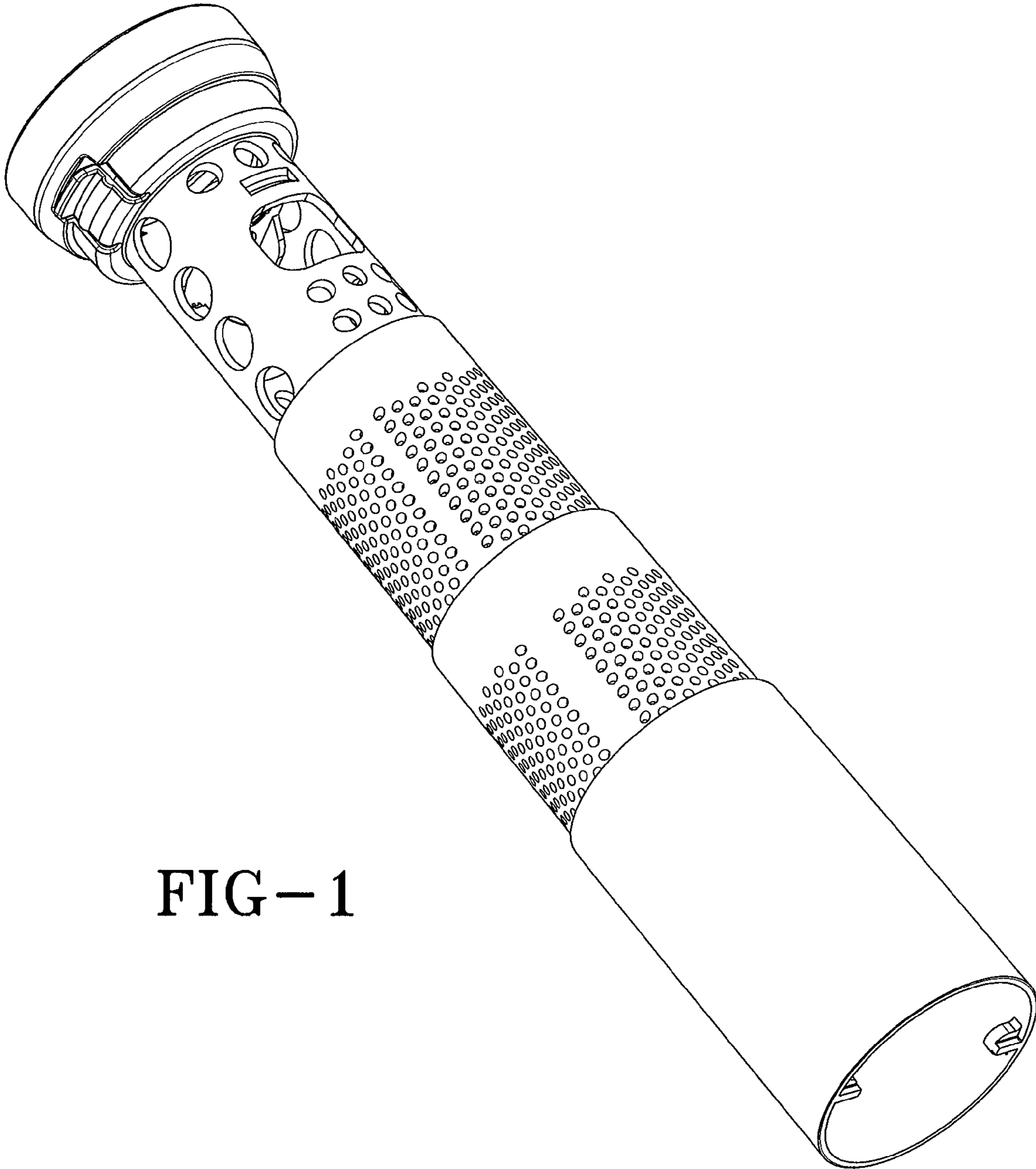

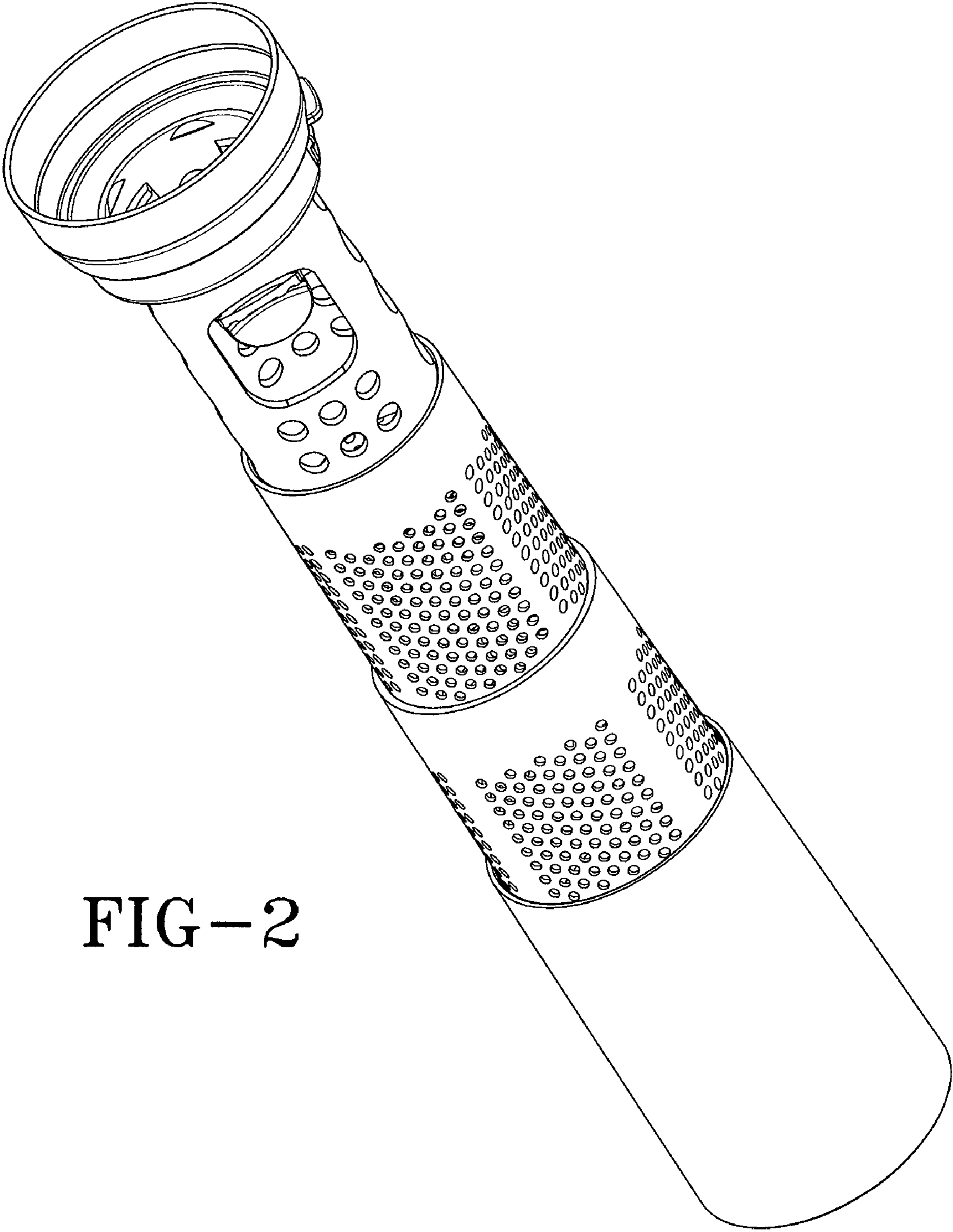

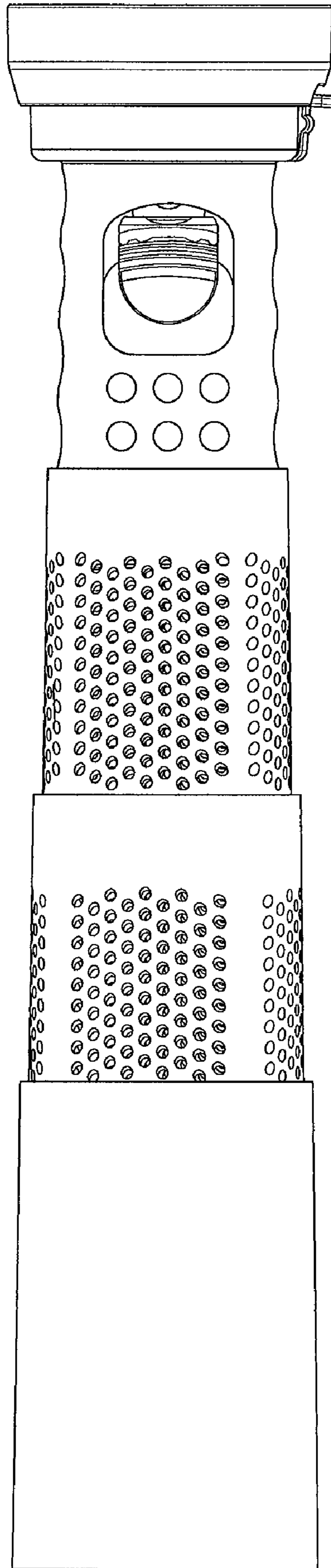

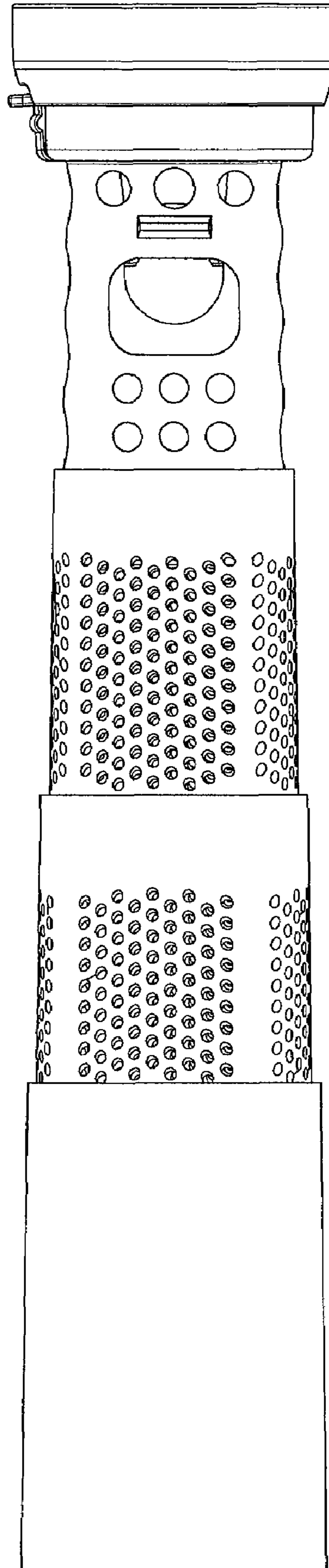

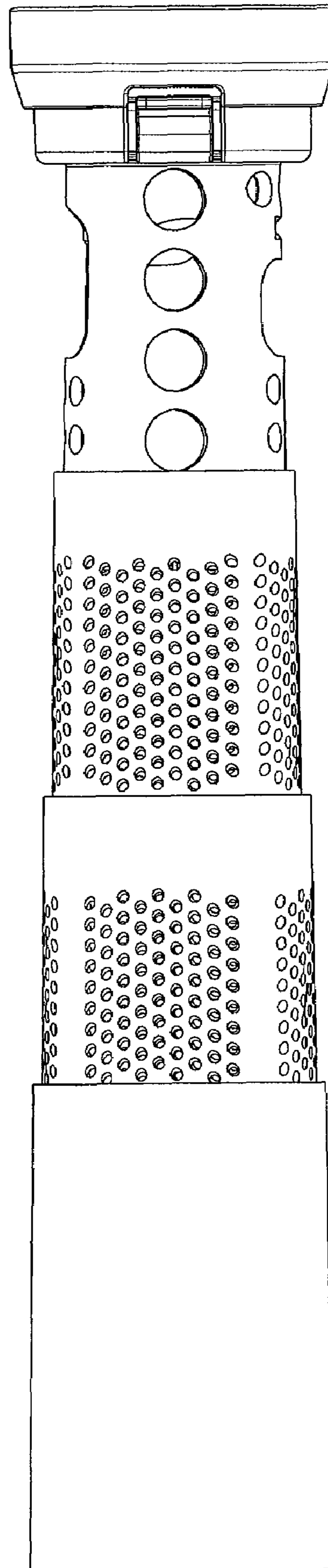

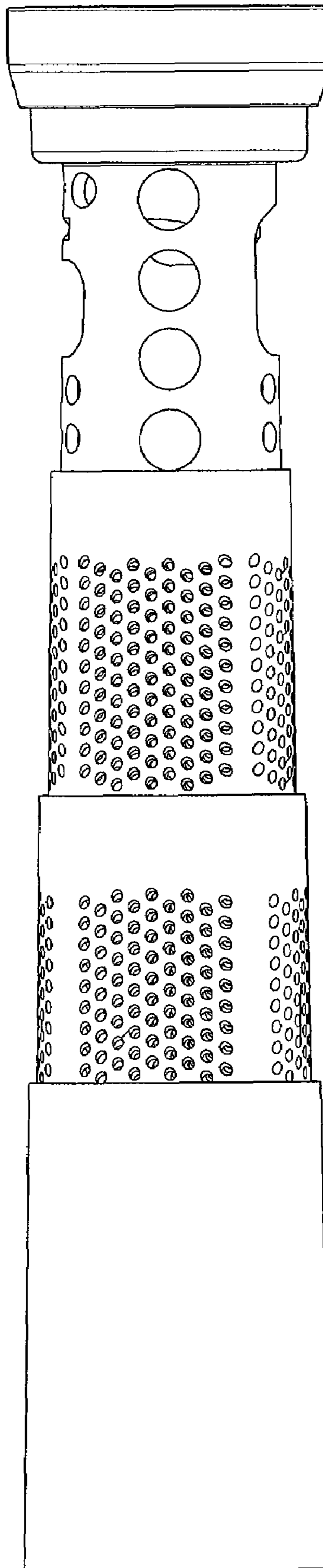

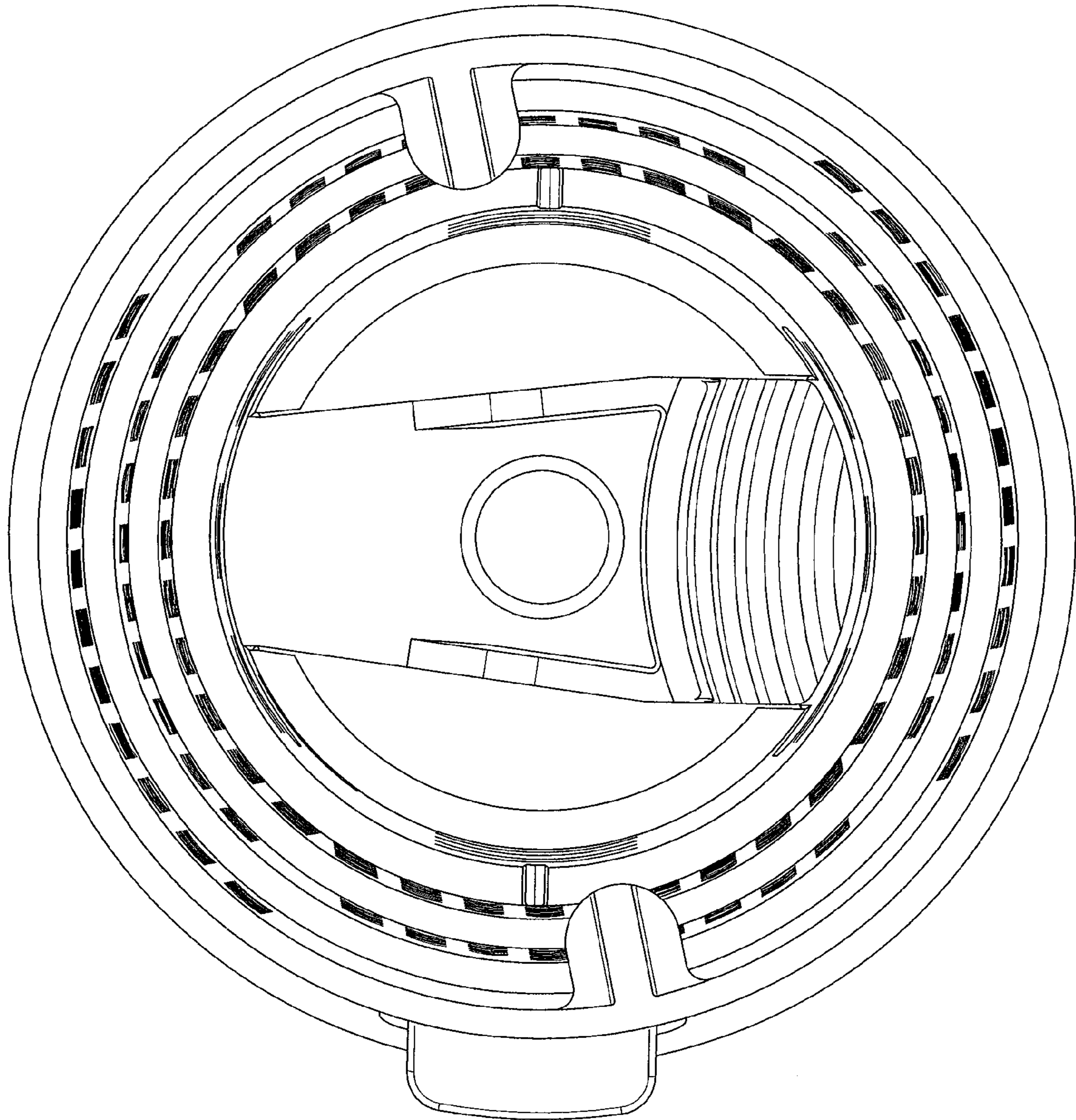

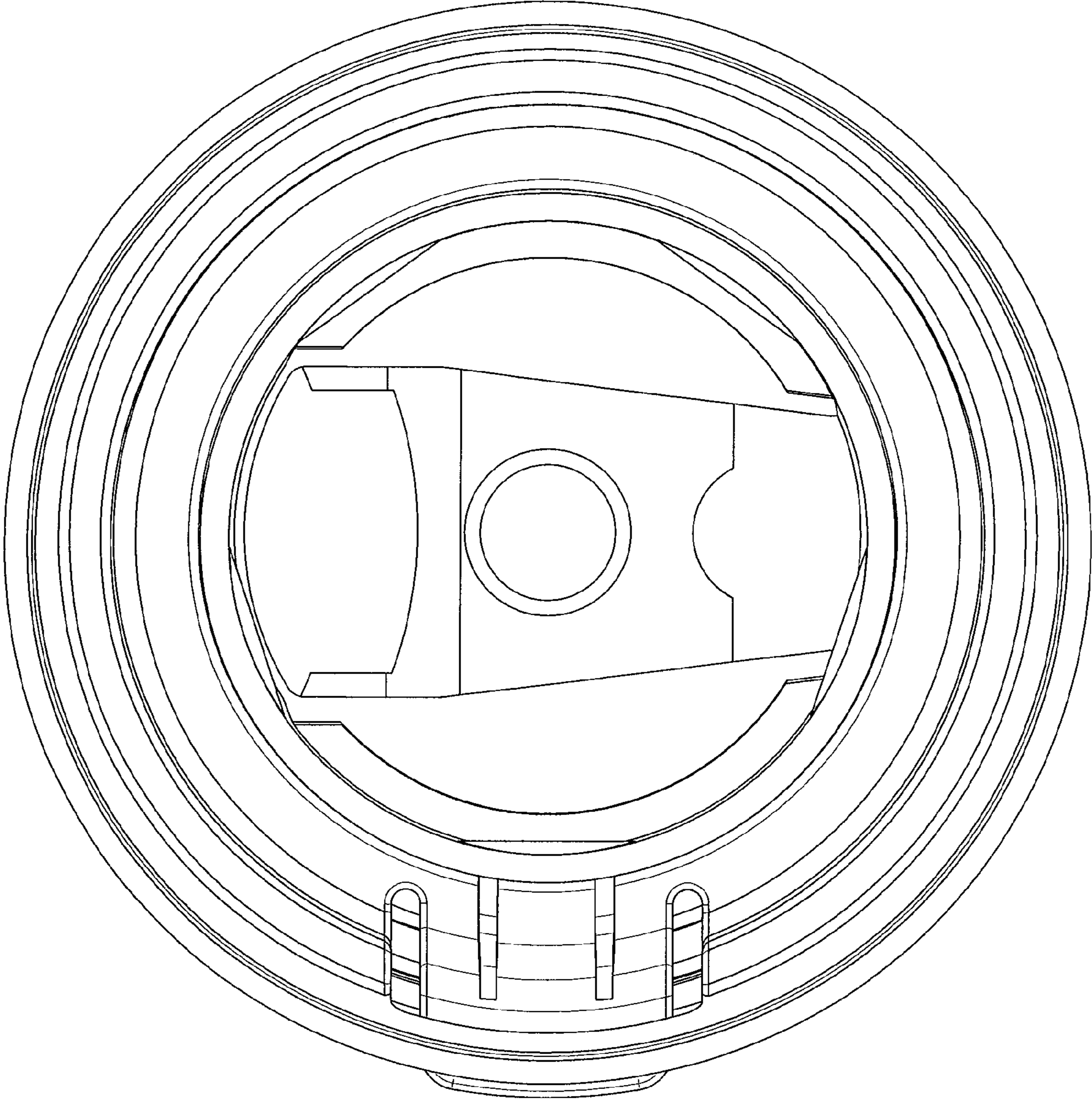

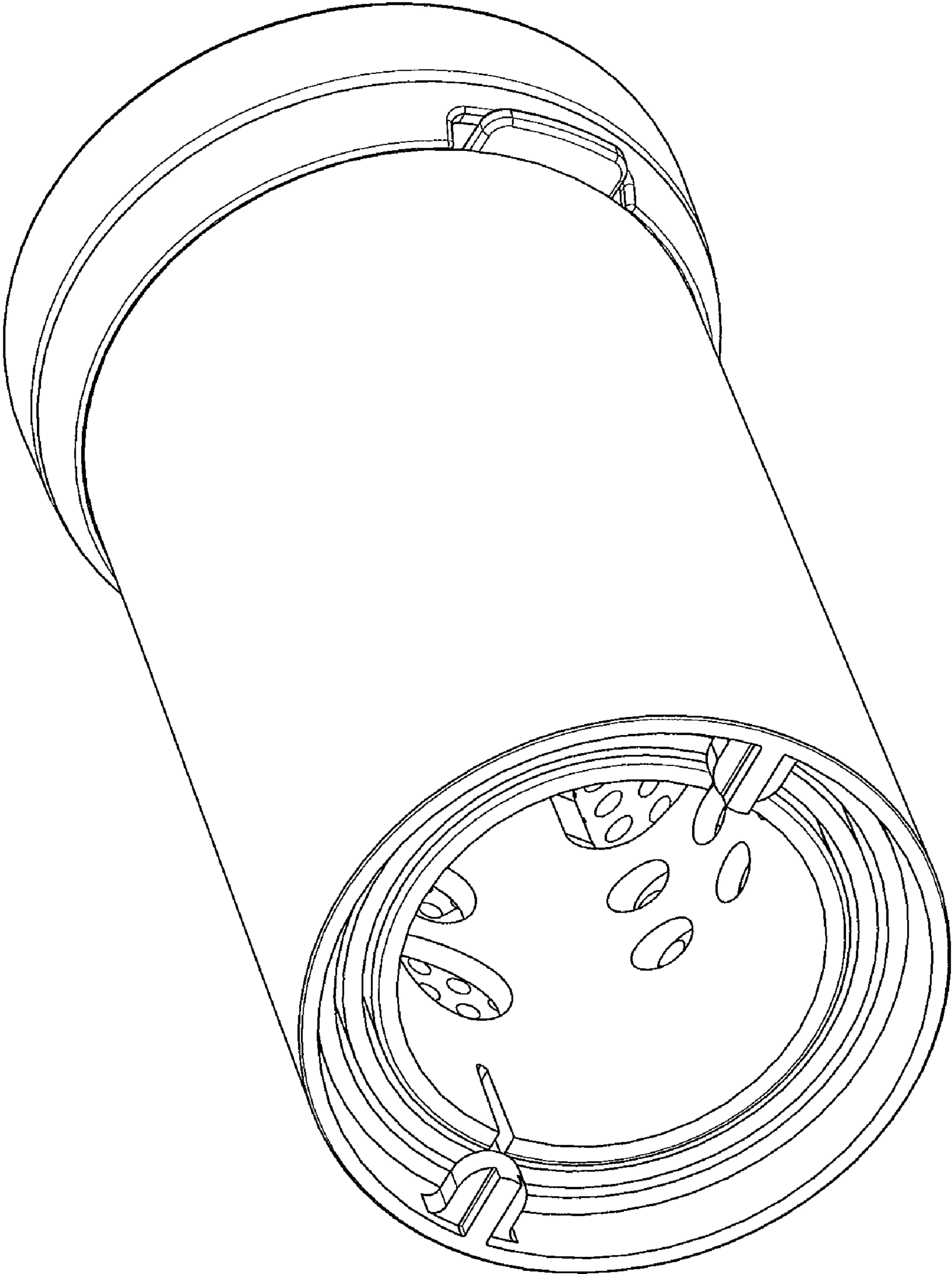

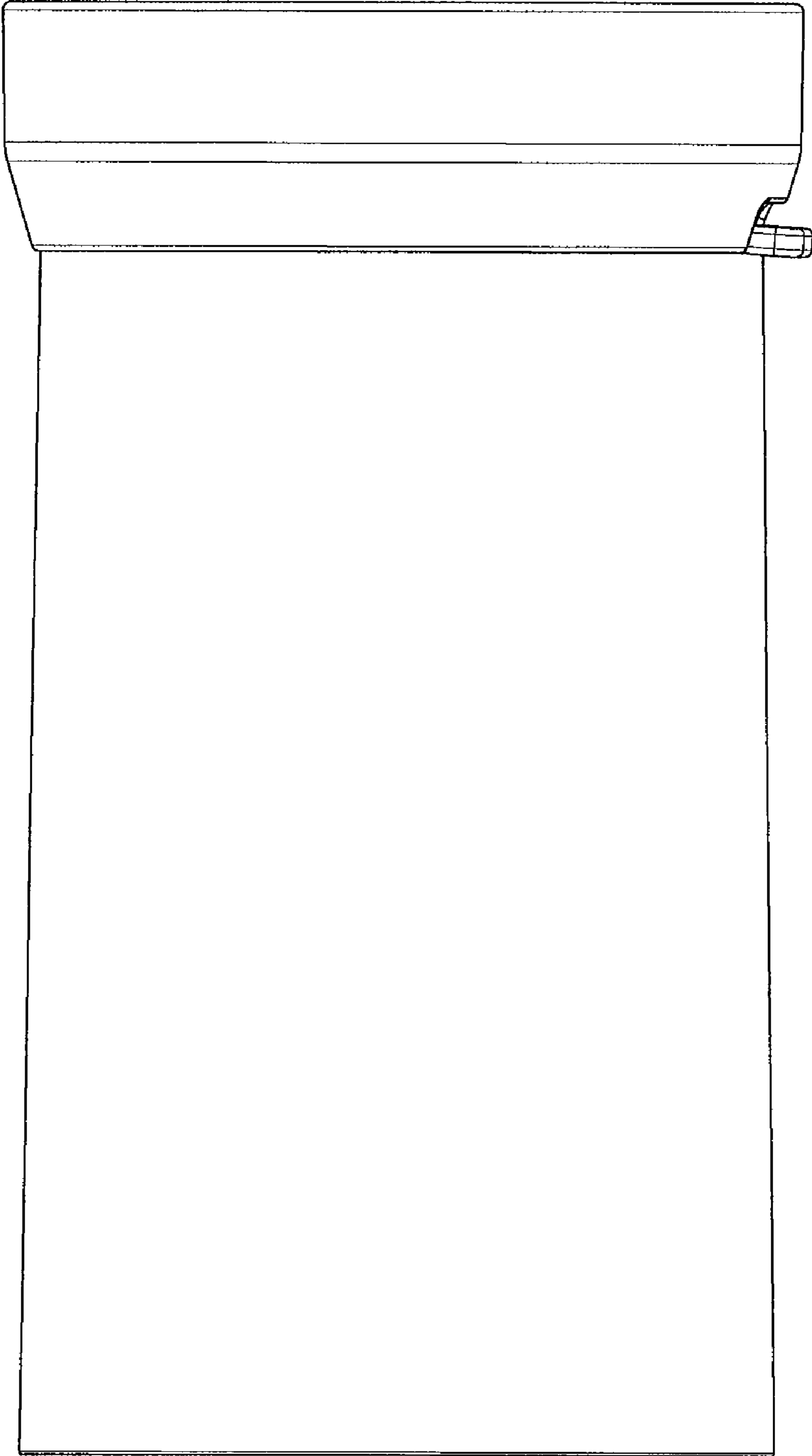

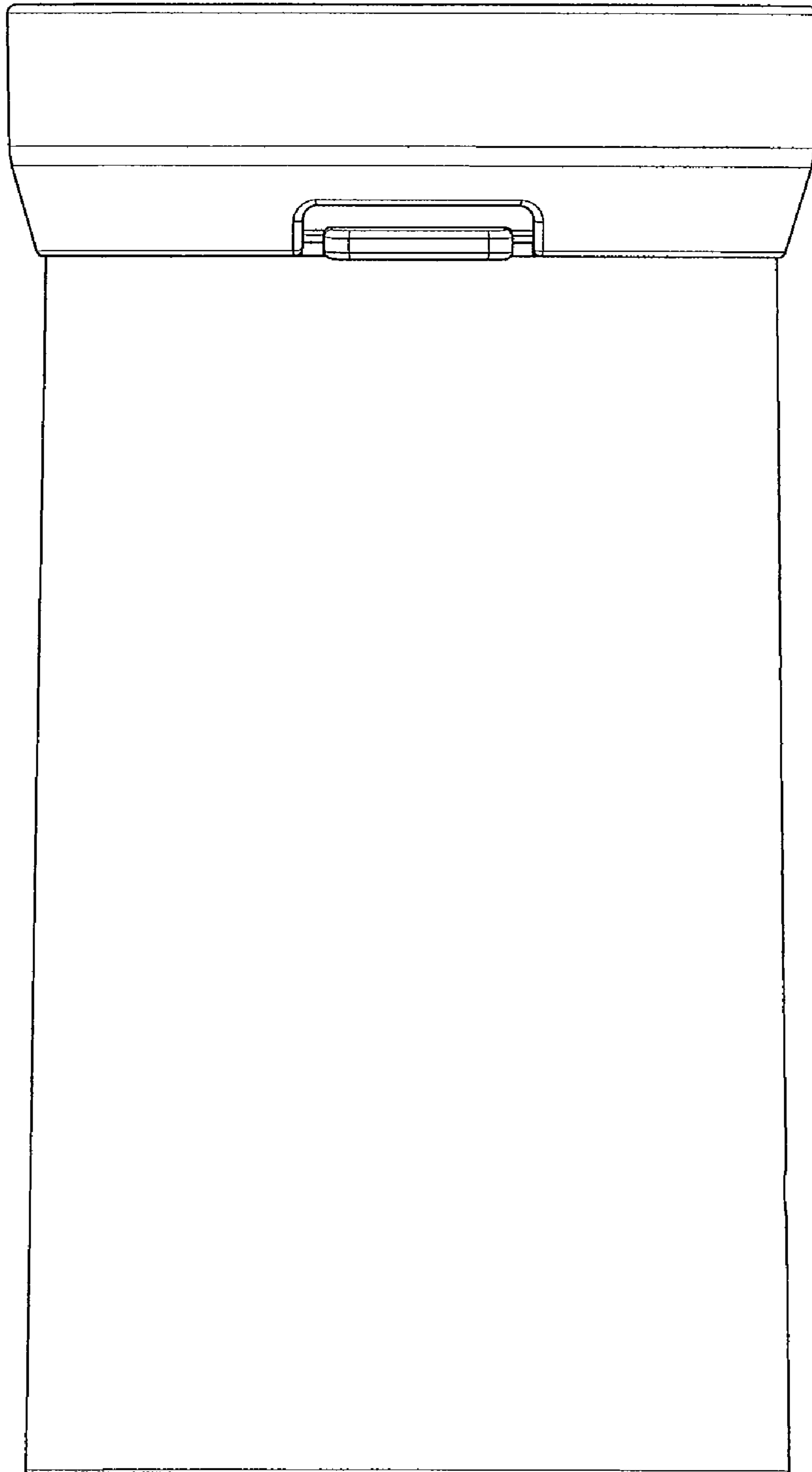
