(57) **CLAIM**

The ornamental design for the outside of an upper portion of a pivoting ankle brace, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of the outside of an upper portion of a pivoting ankle brace showing our design;

FIG. 2 is a right side view thereof;

FIG. 3 is a left side view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a top view thereof;

FIG. 6 is a bottom view thereof; and,

FIG. 7 is a front view thereof.

The broken lines show portions of the ankle brace that form no part of the claimed design.

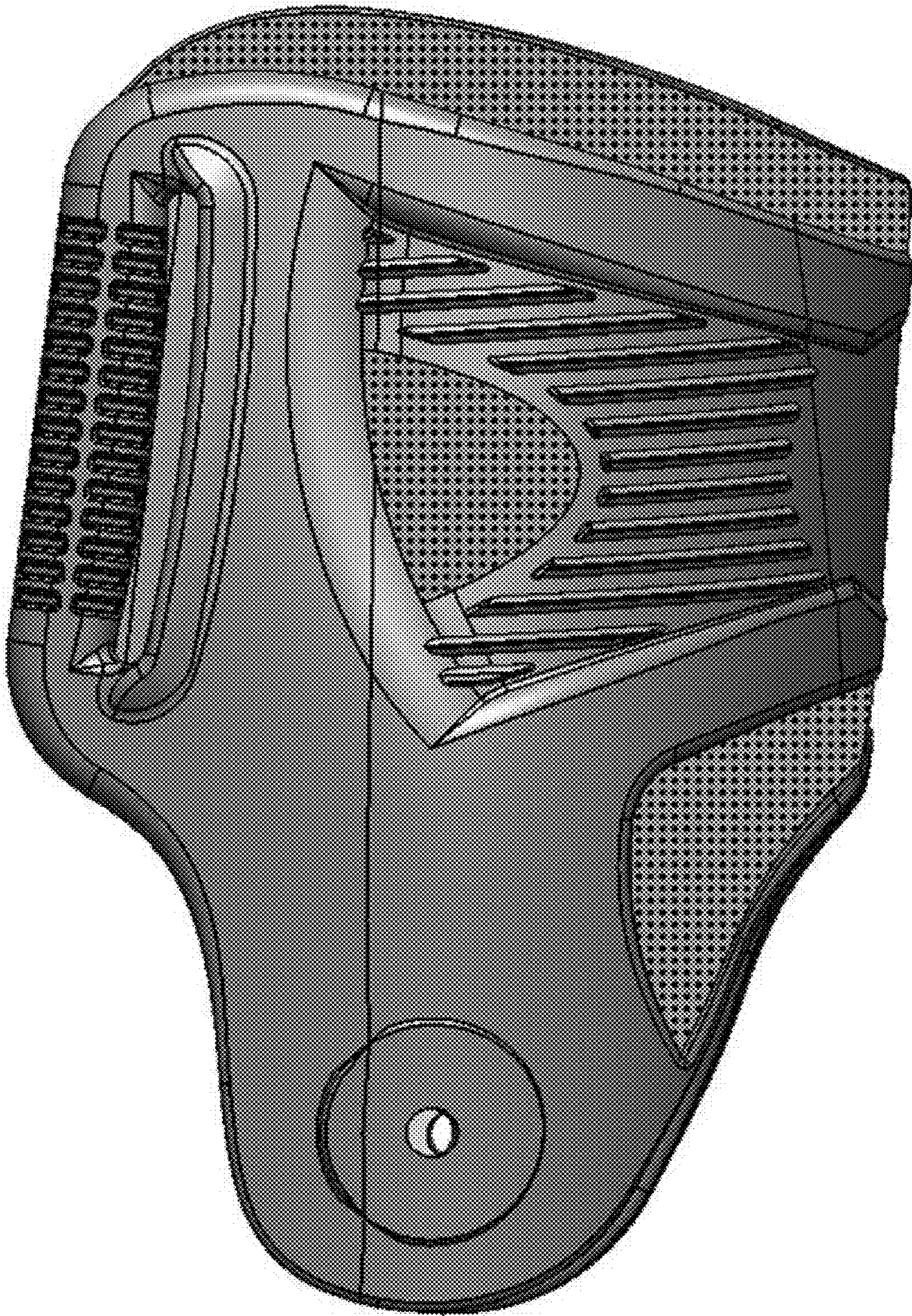

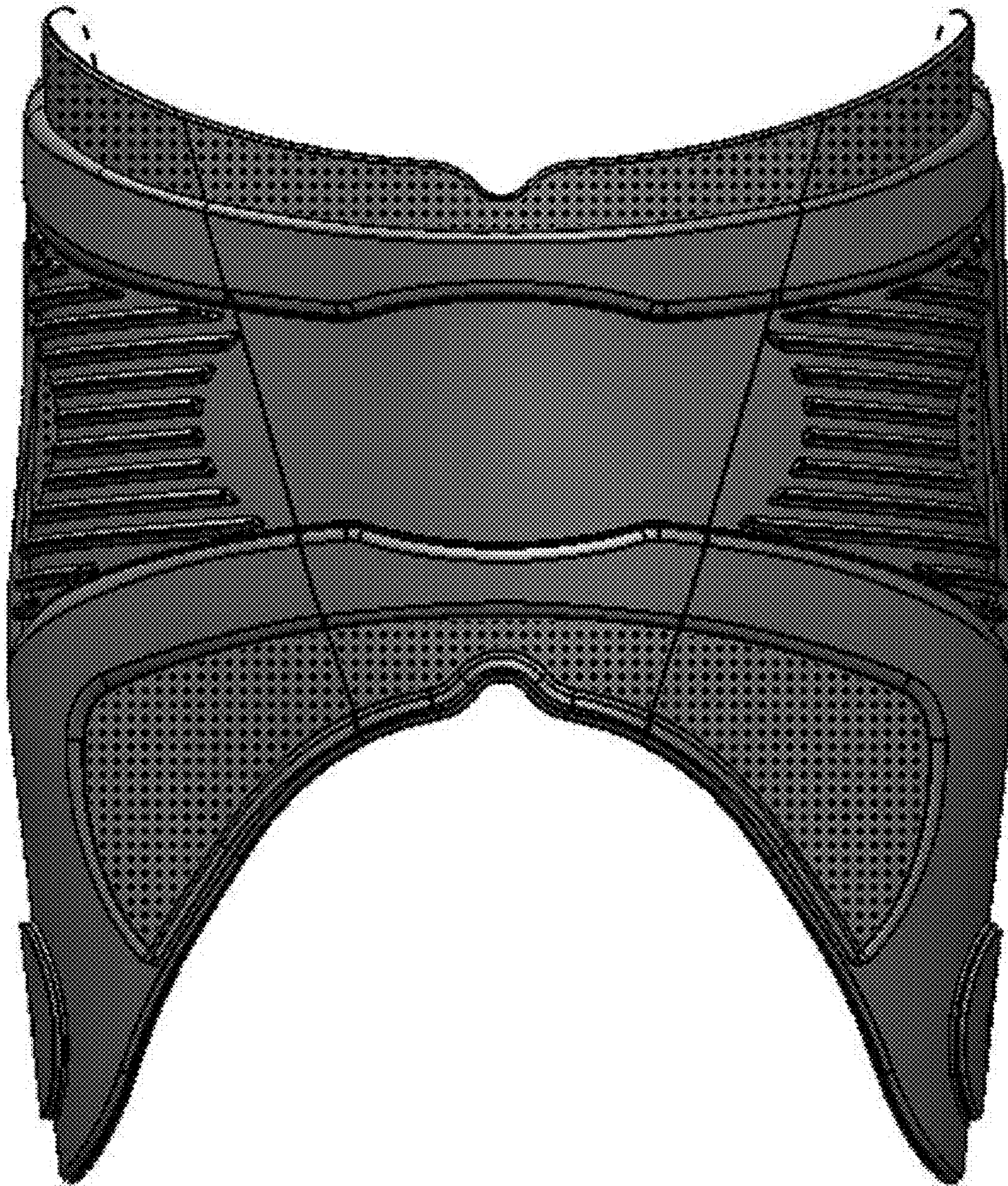

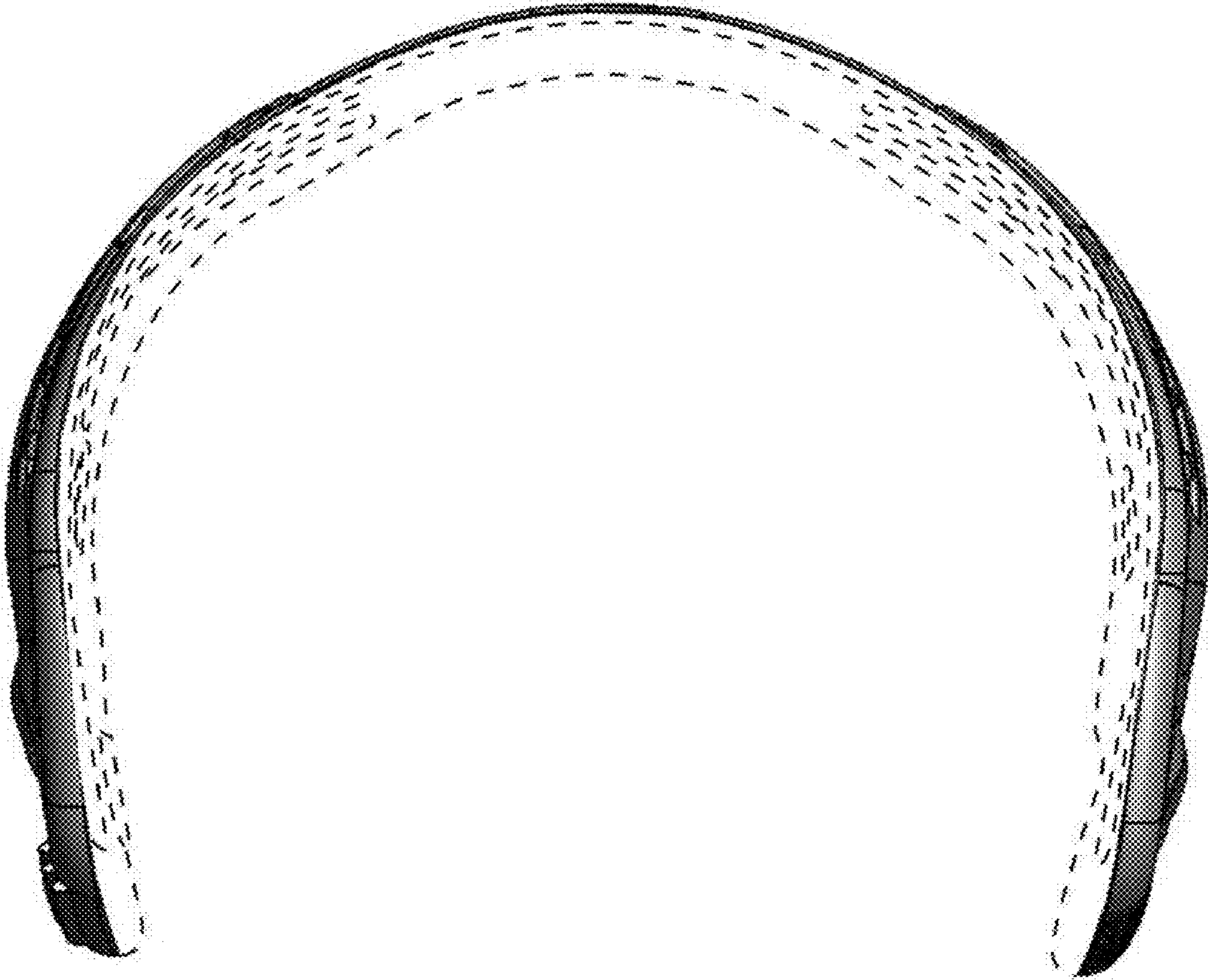

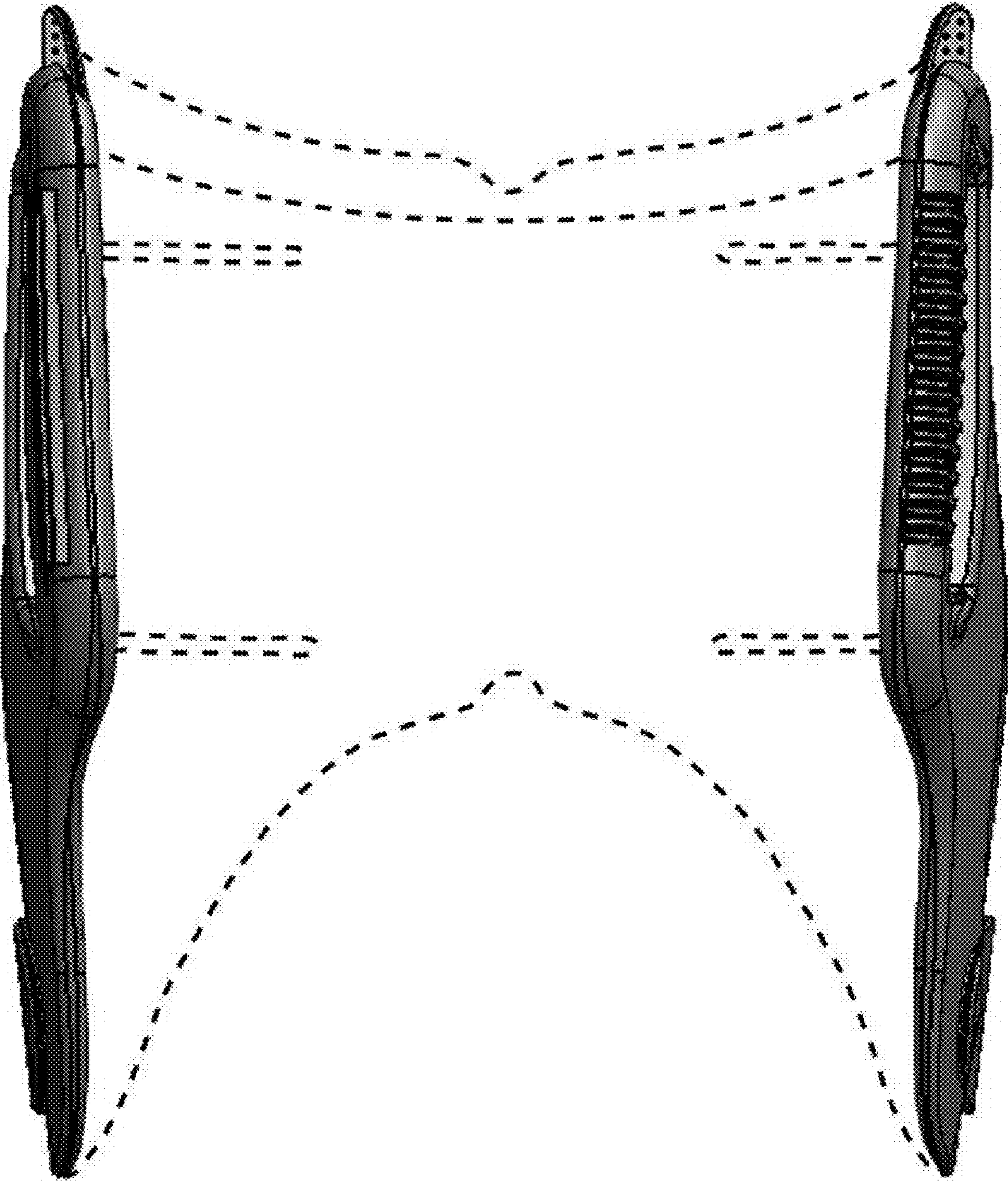
