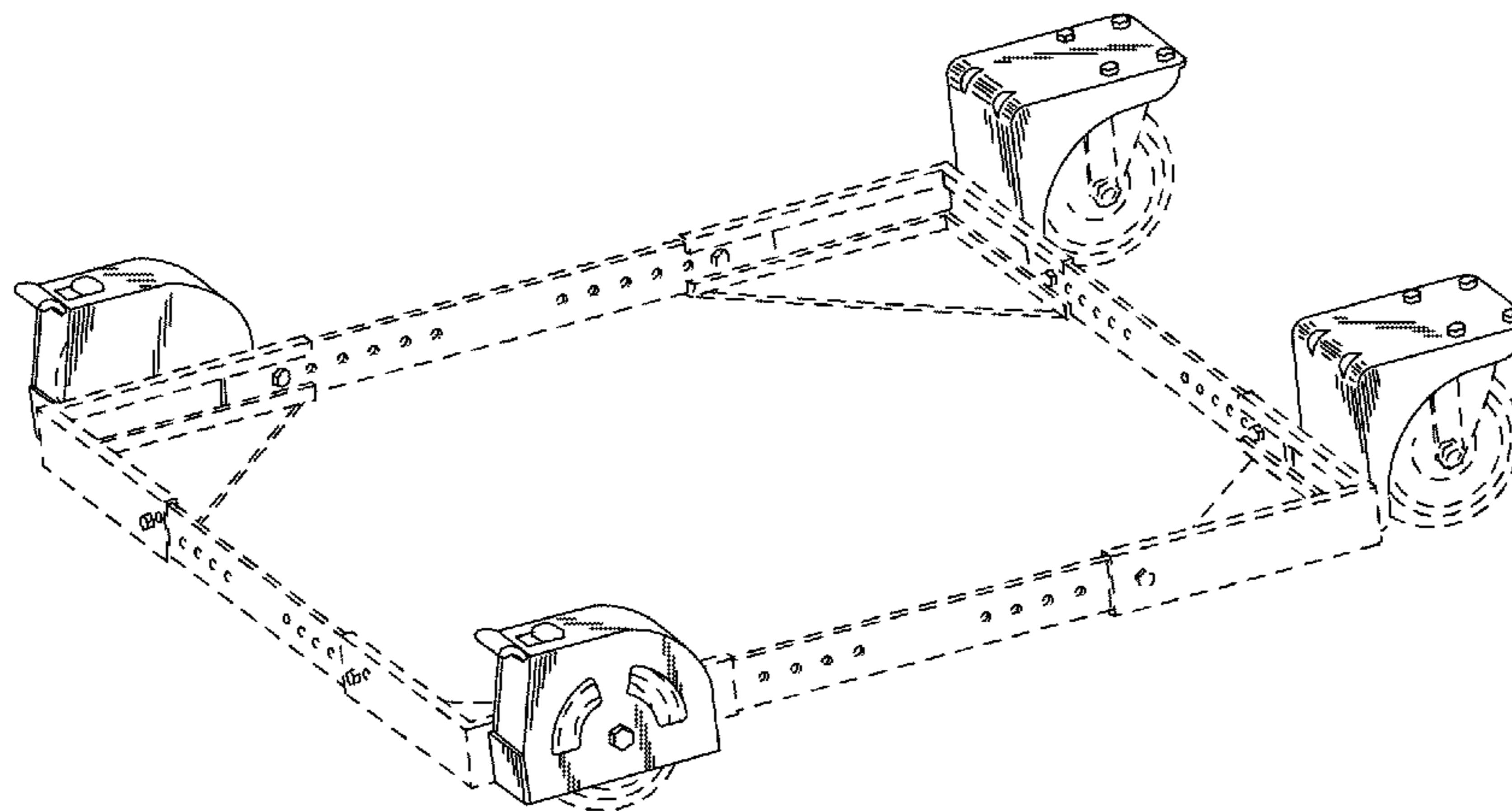
The ornamental design for a mobile base, as shown and described.

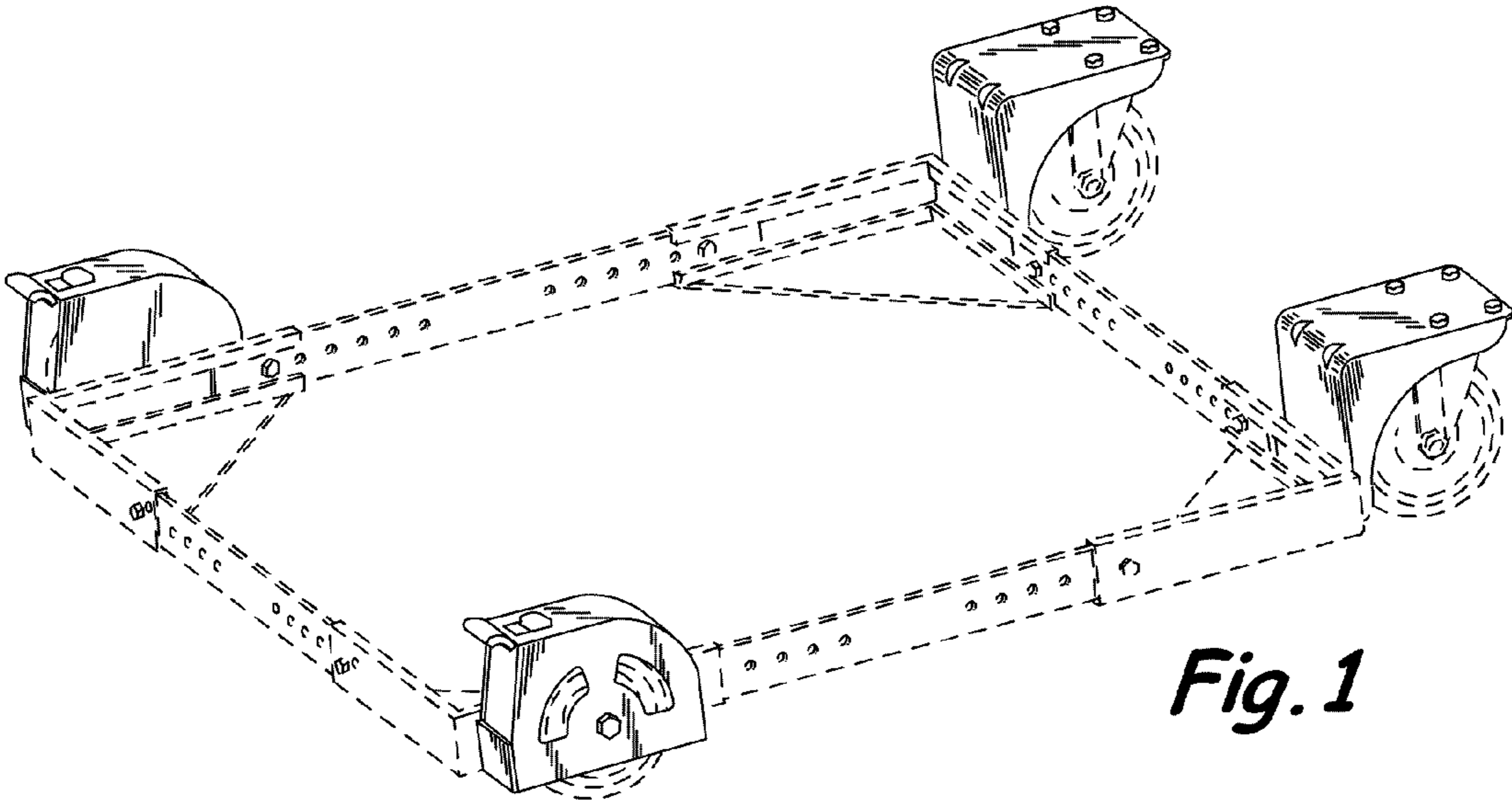
DESCRIPTION

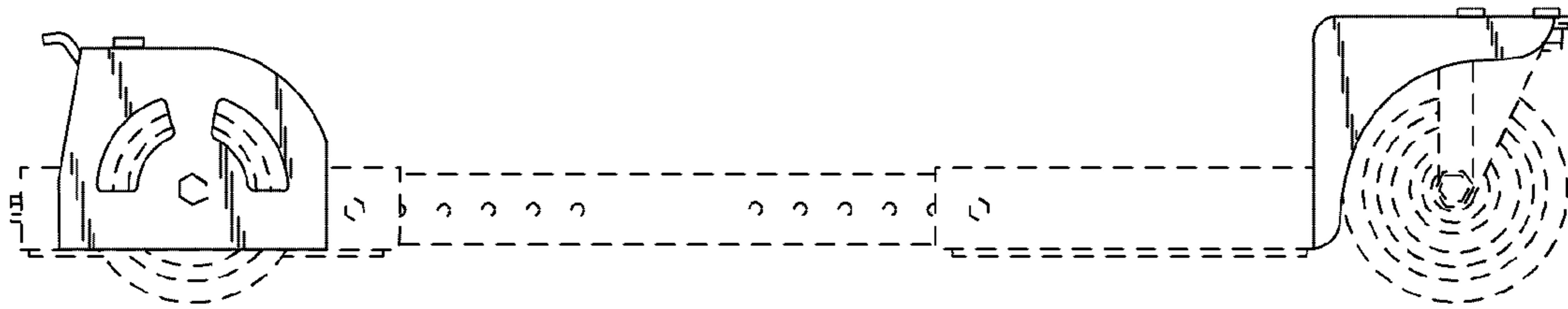

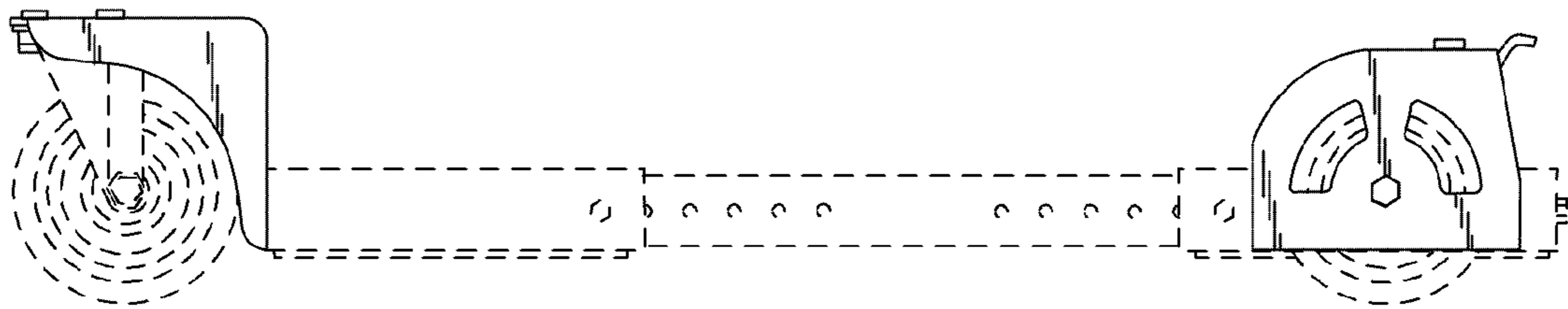

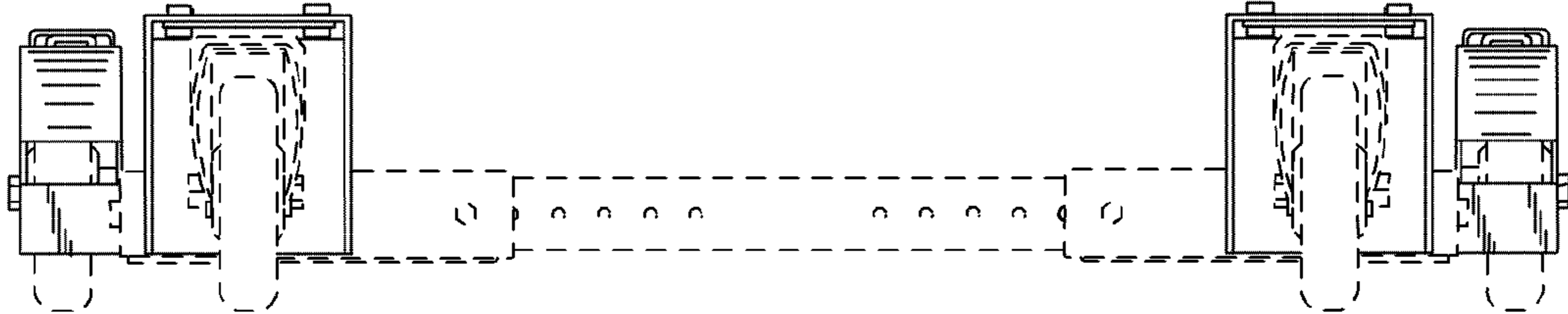

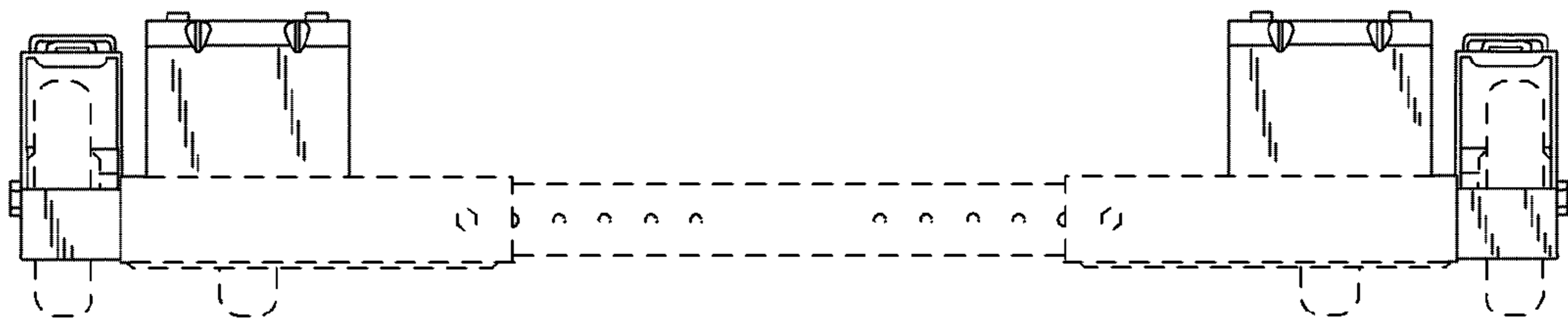

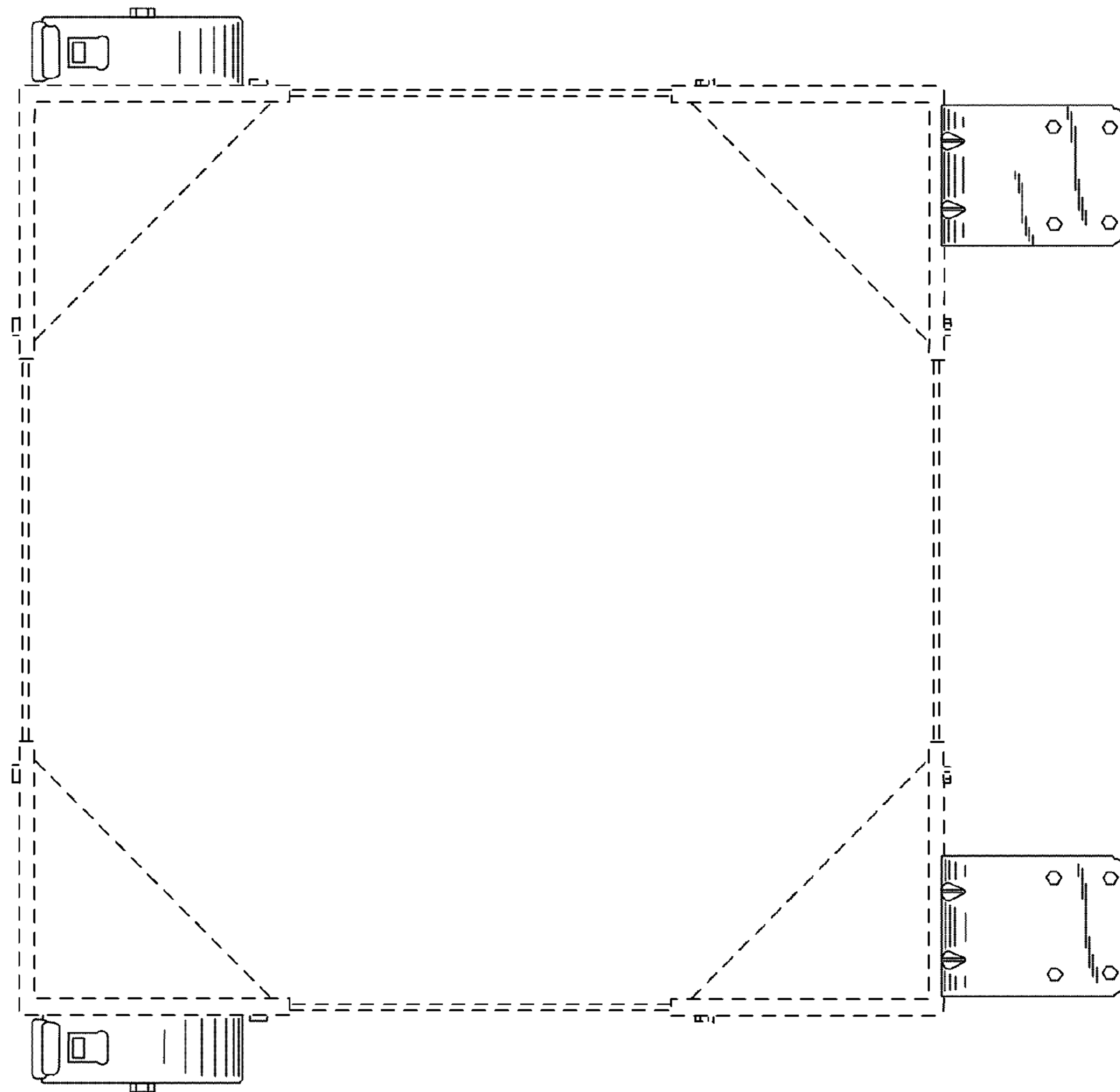

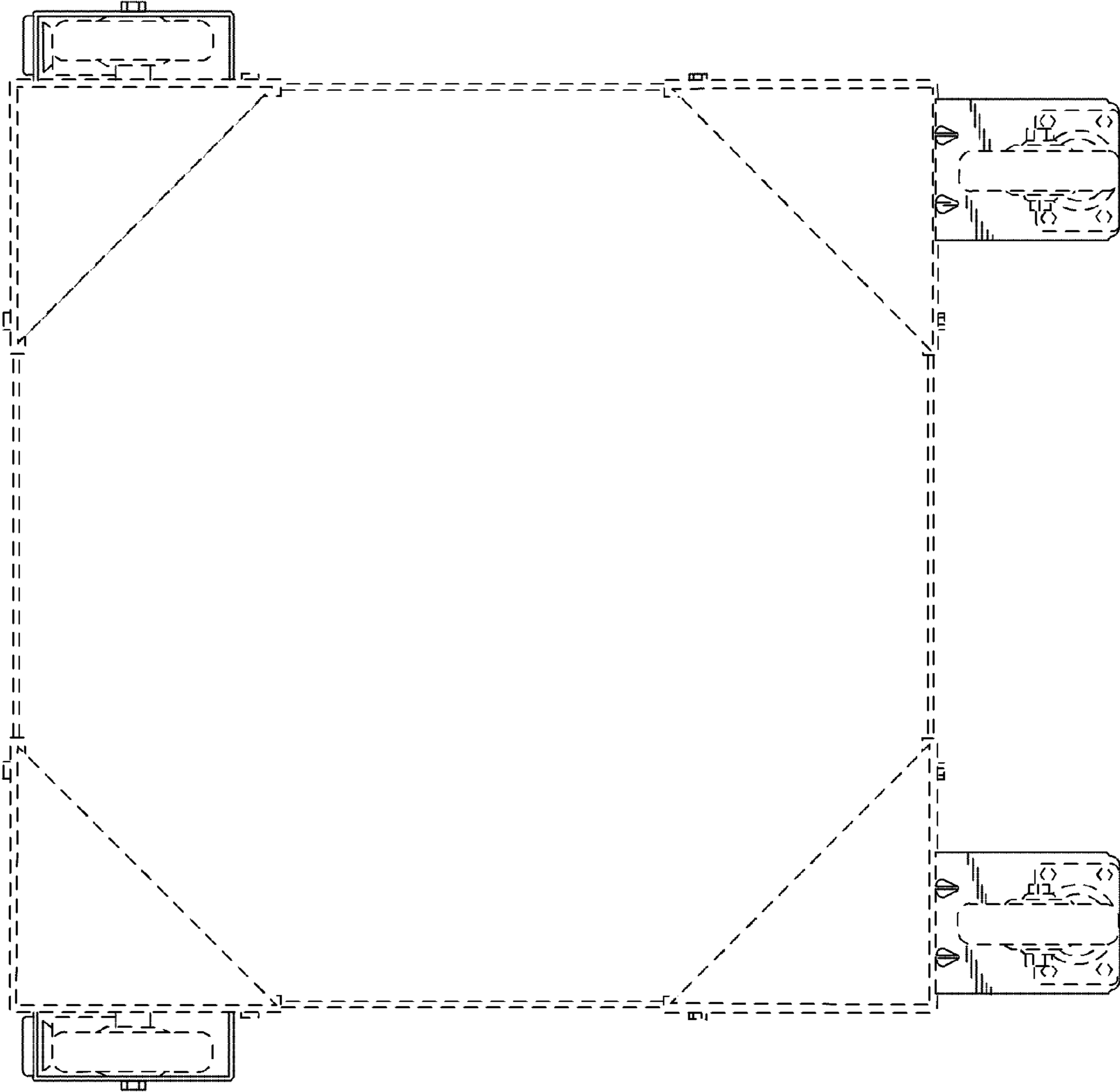
